UNIVERSITY OF FINDLAY COLLEGE COURSES OF-FERED AT WAYNE TRACE HIGH SCHOOL

The Wayne Trace Local Schools will be providing our students an extraordinary college opportunity beginning with the 2007-08 school year. Students will have an opportunity to take college courses through the University of Findlay. Over the course of two years, a Wayne Trace high school student could earn up to 16 semester hours of college credit.

College courses planned for the 2007-08 school year include Calculus, Psychology, Physics, Spanish IV, and American History to 1865. Qualified Wayne Trace teachers will receive college training from the University of Findlay and will become adjunct faculty of the university. Students with a 3.2 GPA or above (or with teacher/counselor recommendation) are eligible to take selected college courses and earn university college credit. Classes will be taught at Wayne Trace High School during regular school hours. The full cost of each course is substantially reduced by the University of Findlay in order to make this program available and affordable to high school students. These classes will be accepted by any state college in the country and reportedly accepted by many private

The recyclables are delivered to Koharts Surplus and Salvage. Koharts weighs and tracks the amount of recyclable material Chuck brings from the Antwerp recycling Between August, 2006 and February 2007, the following was reported: 7,056 pounds of newspapers; 450 pounds of tin cans; 360 pounds of pop bottles; 252 pounds of colored plastic; 216 pounds of milk jugs; and 1,116 pounds of glass. That is a total of 9,450 pounds of material that did not end up in local landfills but rather will be reused for many products.

On Sunday, March 18, 2007, the Rotary Club sponsored a bowling tournament at the Antwerp Alleys to raise money for the continued maintenance of the recycling trailer. Many people participated and \$577.75 was raised for needed repairs to the recycling trailer.





US 24 PROJECT BIDS ANNOUNCED

COLUMBUS-Four bids Inc. Troy, Michigan, \$77.7 were submitted for the construction of four-lane US 24 between US 127 in Paulding County to Ohio 424 in Defiance County, said Tim Burkepile, Ohio Department of Transportation District I deputy director.

The bids were disclosed today at the Ohio Department of Transportation central office in Columbus.







New Ohio Sunshine Law Takes Effect By Sam Shawyer, Marietta

Times This month a new state law takes effect, making it mandatory that most elected

officials be certified in the Ohio Public Records Act, more commonly known as the Ohio Sunshine Law. Some days are longer than

others for Brenda Wolfe and the staff at the Washington County Clerk of Courts of-"Sometimes it seems like

all we're doing is running for records," she said. "When the weather gets nice, we seem to get a lot of people coming in to research genealogy. I sometimes dig up information from the 1800s in dusty old volumes upstairs."

Wolfe said the office has domestic, civil and criminal case records going back as far as 1788, the year Marietta was founded.

"They're all public records available to anyone," she said. "Unless they're courtordered to be sealed, anyone can read, takes notes, or have copies made from these re-

The clerk of courts staff is among Ohio's public records gatekeepers, people who receive request daily for information on anything from real estate transfers and death certificates to campaign finances and criminal

Now all elected officials will also have to be qualified to properly handle public records requests.

House Bill 9, aimed at providing better service for those seeking access to public records, was signed by former Gov. Bob Taft on December 29, and becomes effective March 29. The law mandates that

most elected officials, or their designees, receive and maintain up to date training on the provisions of the state Sunshine Law. Some elected officials are

excluded from the revised open records law, including the chief justice or a justice of the Ohio Supreme Court, a judge of the court of appeals, court of common pleas, municipal court, county court, or a clerk of any of those

As a deputy in Washington County Clerk of Court's office, Wolfe is not required to take the training, although

she provides access to public records every day. We all wait on the public,

and we all need to know what can and can't be handed out,"

The legislation requires state auditors, during annual audits, to ensure that public offices are complying with the open records legislation. The goal of the training

is that our elected officials become knowledgeable about the state public records act," said Susan Burkhart who coordinates training for Washington County government. 'Elected officials or their

designees have to be trained on the law after September 29. If they receive training before that date, they will not be certified to disseminate public documents," she said. She explained that the 2007 Yellow Book, contain-

Dann's office to set up the training for local officials. These will be five or six three-hour training sessions provided through a collaborative effort of the county, cities of Marietta and Belpre, villages, school boards and townships," Burkhart ex-

plained. 'We're trying to establish several dates so that everyone, can participate," she said. "And there will be at least one session dedicated to the general public."

The training will be provided for 44 Marietta officials and employees, 20 Belpre officials, 88 township trustees, 50 Washington County workers and elected officials, 35 local school board representatives, and eight officials $from\ each\ village\ \bar{t}hroughout$ Washington County.



NEW LEADERSHIP CAN RESTORE CONFIDENCE IN THE JUSTICE DEPARTMENT

The Congressional Report By: Congressman Paul Gillmor

For sometime now, a pattern of mistakes has been uncovered at the Department of Justice including the latest stories regarding the firing of eight U.S. Attorneys. I was one of the first Republicans to express my disappointment with this situation and I would like to take a moment to explain my thoughts on this very serious situation. I am disappointed that

these mistakes happened and disagree with the way in which they were handled. Because U.S. Attorneys are both marshals of the law and political appointees, it is customary for Presidents to replace all 93 at the start of the Presidency or the start of a second term. The manner of removing eight U.S. Attorneys recently, while legal, was handled in a way that would lower people's confidence in the administration of justice. I am more concerned

about the abuse of National Security Letters by the Department of Justice. This law enforcement tool was broadened after September 11th to aid terrorism investigations by enabling the FBI to obtain documents such as telephone, correspondence and financial records of people on the basis they may be foreign agents. These letters, which have increased in use a hundredfold, are issued without the supervision of a judge. Unfortunately, the FBI's Inspector General found that between 8-10 percent of National Security Letters have been issued with serious er-

After September 11th, it became obvious that our intelligence community needed more tools to identify terrorist plots against America. I have supported the broadening of power; however, as Congress has given an inch, the Department of Justice has taken a mile. With significant risk of abuse, the Justice Department cannot be given carte blanche authority in its investigations.

As a result of very public errors, Attorney General Gonzales has become a lightning rod and has distracted from the mission of the Department of Justice. Given the totality of the circumstances. I think it would be better for the President and the Department if the Attorney General were to step down. However, I am disappointed that Congressional Democrats have chosen to value the media circus over the need to correct broken policies.

Senator Chuck Schumer, the head of the Democratic Senatorial Campaign Committee, questioned U.S. Attorneys at a committee hearing only to use their answers hours later in a fund-raising pitch. I believe this discussion should focus on justice and policy, not political points. If Attorney General Gonzales does leave office, I look forward to the President's appointment of a steward of the Constitution.







GILLMOR'S SHAREHOLDER RIGHTS LEGISLATION AD-VANCES TO HOUSE FLOOR

WASHINGTON, DC-Being in the minority has not slowed down Congressman Paul Gillmor. Two bills authored by the Fifth District Congressman are headed to the House floor after his House Committee incorporated them into legislation which was given swift approval this week. Gillmor's legislation to require greater disclosure by public companies and enhance shareholders rights passed the Committee in Financial Services yesterday and earned him the praises of the Committee's Chairman. These amendments were included as part of H.R. 1427, legislation to provide new regulation of Fannie Mae, Freddie Mac and the Federal Home Loan Banks. Supported by Congressman Gillmor, H.R. 1427 passed the House Committee by a vote of 45 to 19.

The first of Gillmor's amendments was accepted by the Committee in the 109th Congress and would require Fannie Mae and Freddie Mac to disclose significant charitable contributions to their shareholders on an annual basis. Gillmor's second amendment requires Fannie Mae and Freddie Mac to disclose in their annual reports the

the Internal Revenue Ser-

"With over 100 million Americans currently participating in our capital markets, it remains critical that shareholders are given accurate information about the companies they own. While most gift-giving has a legitimate purpose, corporations should have nothing to hide by disclosing those gifts. On my other amendment, I am hopeful that comparing the level of income reported to the IRS with that reported to the SEC, can give shareholders a more complete picture of a company's health," Gillmor said. "Both of my provisions will benefit shareholders and make Fannie and Freddie more transparent," Rep.

Gillmor added. Gillmor has separate legislative proposals which would apply to all public companies. His legislation to require disclosure of charitable contributions (H.R. 1208), as well as his bill to require all public companies to disclose the level of income reported to the IRS (H.R. 1341) remain active in the House. Chairman Barney Frank, during consideration of H.R. 1427, stated that he intended to hold a hearing on Gillmor's Honest Income Disclosure



ANTWERP HISTORY

The above picture is a caricature drawn by Doctor Caine about and given to William Woodcox. Dr. Caine was good friends of the Woodcox family and maybe here is one of the reasons. For years Bill's late wife worked as a waitress in Ray's Restaurant and Doc would visit with her there. But you see, she was from England also and they would visit quite a bit. Bill loaned this picture to me, but I understand that drawing was one of of Doc's sidelines.

Here is a nice two page letter that I received from Joanne and Lee Overmyer. They were Antwerp people, but now live in Bluffton, Ohio. I know you will enjoy the letter like İ did.

"Dear Stan,

My name is Joanne Overmyer (AHS '49). I am married to Lee Overmyer (AHS '47). My parents were Chester & Caroline Snook Hawkins.

"I have a couple of corrections - I was raised in Chicago and Indianapolis. At the early age of 37- my father (AHS '22) died in 1941 in Indianapolis. My mother (AHS '24), sister Jeanne and I moved back to Antwerp and lived with my grandparents, the H.T. Snooks, on their farm across the river from Antwerp.

"At the time we moved back, Mother bought the house at the corner of Main and Woodcox so she would be near her sister, Inez Long, who lived in the small house on Woodcox. The yellow house had belonged to my great-grandmother, Mrs. Joseph T. Snook, but Inez died before Mother could move and we lived with my grandparents as long as they lived. Mother rented the house to the Ryan family. When my grandparents died, Mother, my sister, Jeanne and Jeanne's husband, Claude Pepper moved to town. Jeanne taught at Antwerp, I think 2nd. Grade for a number of years. Then Claude decided to go to school in Wisconsin and Mother then moved into the small yellow house that she had inherited. "A couple of notes on Dr.

Caine:

"When I was in Jr. Hi. Penicillin had first been "invented", at least for public use. I came down with strep throat and the penicillin had to be administered every 3 hours. Dr. Caine knew it would be a real hardship on my mother for me to have to be in the hospital so he moved me into his home and made me a bed in their living room. Mrs. Caine administered the penicillin and gave me my meals. Mother was working in Ft. Wayne and she would drop me off early in the AM and pick me up after 10:00 PM for about 5 days. Mrs. Caine was an angel. They had the most interesting chair with people carved into the back of it.

"When Mother lived in the house on the corner (she was still working in Ft. Wayne) she would get up very early in the AM to get ready for work. Dr. Caine would see her lights on and just walk in for a fresh cup





from the service and before he started to college he came down with polio. At that time all there was to fight the polio was gamma globulin, which was very scarce. Dr. Caine had Lee come in and gave him a shot of it. I always gave credit to Dr. Caine for Lee not being crippled by the

"He always said if you were a good Republican you never had to stop for a red light. I always wondered if he changed the name of the party depending on whose house he was having coffee at?? I also remember him singing in church, he bent the cover of the hymn book.

"The Flora Tubbs you mentioned was an aunt by marriage to my grandfather, H. T. Snook. She had been married to a Peter Lamb. Evidently, never had children. My grandfather looked after her and was executor to her estate. I have a chair in my home that was Aunt Flora's.

"Kenny Boland was a life long friend of my father's. He was best man when my father married my mother and Kenny's wife Francis-a cousin to my grandfathertaught piano lessons. My sister took lessons from her.

"Another correction, Lee tells me Warren Sesler was always known as J. Warren

"Dear Stan, What I remember best about Doc. Caine:

gust or September of 1944, Grace and I were asleep up stairs. We were awakened by this loud wailing and crying. When we came down stairs there sat Mom in her rocker with her apron up over her face weeping. In the south west corner sat Alta Seslar, due south sat Doc. Caine, in the south-east was Anna Waters, due east was Grandmau Sarah Jordan (who was in her late 80's), next to her

was Ida Carr. "Mom was finally able to tell us that Jack was missing in action. The telegram had came in. The man who worked there (I just remember him) saw Doc on the street and Doc delivered it.

"First he stopped and got Alta, who had lost Max. Then he got Mrs. Waters, who had lost Dorsie. He himself had lost his son, William.

"Grandmau Jordan heard the noise and started down the sidewalk. Ida Carr seeing her, helped her down to our house.

"Stan, to the day I die I will still remember that day. I have a lump in my chest

"Doc had lived through this himself as did the ladies. Doc knew Mom would have support that she needed.

People loved each other back then and bore each others burdens.

"Doc was a man who drew other's respect just looking at him. A man among men.

PAULDING COUNTY COM-**MISSIONERS**

The Paulding County Commissioners met in regular session on Wednesday, March 21 and Monday, March 26, 2007.

The Wednesday meeting included the monthly meeting of elected officials. The monthly meeting is used for communication among the officials and a review of the county general fund. It was noted that the sales tax revenue for the month of March was higher than recent months. Although not as healthy as the receipts for the same time in 2005, the receipts for the sales tax so far in 2007 are better than the same time period in

The census came up again at the Wednesday meeting. A reporter called the Commissioners with questions about a population estimate released by the Census Bureau. The Commissioners noted that they were being asked questions about the estimates and the methodology of the Census Bureau without the benefit of ever seeing the material. Between the reporter and the Commissioners it was realized that the Census Bureau sends their estimates to the press but ignores local governments. Then, at the Monday, March 26 meeting the Commissioners again received a mailing from the Census Bureau. This mailing invited representatives to a regional meeting to provide the Census Bureau help in finding all addresses for the eventual mailing of the census forms. The Commissioners decided to assist with this request and will be sharing the invitation with other county officials.

The Monday meeting included an annual report by Dave Cline, the County Dog Warden. Cline reported his statistical data for 2006 in comparison to 2005. Cline was excited to report, "in 2006 we were able to adopt out 99 dogs, a large increase from the 33 adopted out in 2005. In turn," Cline continued, " we had to euthanize only 166 stray dogs in 2006 because of the successful adoption efforts of many individuals. This is a large reduction from the 234 dogs we had to destroy in 2005." Cline further reported that many individual county residents have helped with the successful adoption program. These include, among others, Lynne Mansfield, Brenda Smith, Mandy Lichty and Ronnie Landfair. Other 2006 statistics include 2832 dog tags sold (2798 in 2005), 83 kennel licenses for five dogs or more (79 in 2005). 68 lost dogs recovered (66 in 2005), and responding to 19 dog bites (36 in 2005).

The Dog Warden's tasks include operating the dog pound, managing the dog tag registration program, picking up stray dogs and assisting dog owners with returning lost dogs and even putting pets to sleep at the request of the owner. The office also must decide if a stray might be adopted and works with area residents to connect the dogs and possible owners. One unfortunate task of the office is to euthanize stray dogs that are not claimed or adopted.

Cline also noted his plan

to begin spot checks around the county to insure that dogs have the required tags. Dog tags can be purchased at the County Auditor's Of-

The Monday, March 26 meeting also included another in a series of meetings with a committee representing county offices to discuss operation of the health insurance policy available for county employees. The committee is reviewing ways to make the health care insurance affordable for employ-

The Monday session concluded with one of the last construction meetings at the new jail. The Commissioners observed cleaning crews removing all final construction material and carefully cleaning all surfaces. The general contractor noted

The several contractors and Sheriff's Office staff discussed the final wiring of phone lines. The Sheriff's Department is working on the complex transition of 911 and the dispatch center from the old facility to the new one without any disruption of service.

As always, citizens with questions are encouraged to contact the appropriate office for information. The Commissioners office is available for assistance in deciding which county office to contact with questions.

The Paulding County Commissioners meet in regular session from 8:00 a.m. to the close of business on Mondays and Wednesdays.

"Everv advance we made as a result of the 2001 and 2003 tax cuts including the doubling of the child tax credit to \$1,000, reducing the marriage penalty and the lowering of every single tax rate will come to an end as a result of the Democrat Budget."

"Just three months into the 110th Congress, Democrat leaders are showing a very low regard for fiscal restraint. COLUMBUS—To help serve the transportation needs of the elderly and individuals with disabilities, Ohio Department of Transportation (ODOT) Director James G. Beasly has announced \$1,974,393 in Federal Section 5310 Program funds for Ohio's Specialized Transportation Program (STP). These federal funds are being distributed to 48 non-profit agencies and six Coordination Program projects in the state. A list of the agencies with their locations, vehicles and equipment awarded can be accessed at the Office of Transit's website www.dot.state.oh.us/ptrans. This Federal Transit Act, 49

USC Section 5310, authorizes capital grants for the purchase of vehicles and equipment by private non-profit agencies or state approved coordination projects to meet the special



transportation needs of elderly individuals and individuals with disabilities where existing transportation services are unavailable, insufficient or inappropriate. Section 5310 funds pay 80 percent of the vehicle and equipment costs and the local agency pays 20 percent.

The goal of STP is to increase personal mobility for elderly individuals and individuals with disabilities and allow them to continue being productive members of their communities by offering safe transportation alternatives. Increased mobility options improve their quality of life by providing access to medical appointments, employment, grocery shopping, banking and other services.

The Wayne Trace Local Schools were notified by the United States Department of Education that they have been selected for high-quality professional development that will provide our staff with techniques and strategies that parallels our district's curriculum mapping process. USDE's Carolyn Snowbarger, who works with Secretary of Education, Margaret Spellings, informed us that "we are doing great things district wide in the areas of unified curriculum alignment and curriculum mapping." The United States Department is impressed with how the staff, in a district covering 179 square miles with its elementary schools 20 miles apart, is working together to align their curriculum and want to use Wayne Trace as a model for other rural schools nationwide.

The visit from the United States Department of Education is scheduled for April 11 and April 12. A lot of planning and coordination has taken place between the United States Department of Education and the Wayne Trace Local School District. Since the notification of their visit, a USDE Planning Committee was established to determine goals and objectives to be accomplished. The teachers, administration, and USDE worked together to create a Needs Assessment. Each teacher in the district completed the Needs Assessment. This was done to determine Professional Development topics. There were 30 possible high-quality professional development sessions to choose from. As a group we narrowed that list to 8 high-quality professional development

The results from the Needs Assessment were sent to Washington D.C. Carolyn Snowbarger, who works directly with Margaret Spellings, Secretary of Education, used the data to create a proposal for our school district. The United States Department of Education's proposal included four highly qualified



SCHOOL CONSTRUCTION

HOUSE BILL 114 OF-

Everyone can agree that a good education is important to the future success of our children. Equally important, however, is ensuring that the buildings used by students are safe places for them to learn, grow, and gain the skills and tools they will need to compete in our rapidly-changing Building and renovat-

ing school facilities to make them safe and up-to-date for students is the responsibility of the Ohio School Facilities Commission (OSFC). The OSFC was established in 1997 to provide technical and management assistance to school districts with school construction projects. Since 1998, Ohio has spent more than \$7 billion constructing or renovating hundreds of buildings, many right here in Northwest Ohio.

Recently, the OSFC adopted new guidelines regarding the contracting process for school building projects. These new rules require school builders to use experienced personnel and pay into employee medical and retirement plans and also lifted the restrictions on the hiring of builders that pay prevailing wages. Ohio's prevailing wage law requires union-scale wages to be paid on construction projects involving public funds, even when non-union workers are hired.

In addition, builders may also be required to certify they have not violated prevailing wage laws more than three times in a two-year period during the last 10 years and have not had any Fair Labor Standards violations in the last five years. Previously, districts were required to accept the lowest responsible bid and school facility projects were exempt from Ohio's prevailing wage law.

I believe these new rules will significantly add to the cost of school building projects, making it harder for districts to update or replace facilities in a timely, cost-effective manner. As a result of this decision. I have introduced House Bill 114, which would require the OSFC to reduce the state funds contributed to a school district's facilities project by 20 percent if the district requires the contractors to pay the prevailing wage.

Ohio spends more than \$3 million a day on school construction projects and it

is important to ensure the money is spent wisely. Although the new guidelines do not require districts to use prevailing-wage labor, this provision could be a factor in choosing a contractor for a building project. If a school district chooses to use prevailing wage, it is their decision; however, the rest of the state and other school districts should not pay for such decisions. Further, I believe people should know how their elected school board members have chosen to spend taxpayers' hard earned money.

30TH ANNIVERSARY CEL-EBRATED BY DCGS

The Defiance County Chapter of the Ohio Genealogical Society celebrated the 30th Anniversary of the signing of it's Charter in March 1977. The five Charter Members in attendance were David Bennett, Gladys Donson, Diane Hill, Sue Lafountain, and Caroline Zimmerman. Each Charter Member was presented a red carnation with their Charter Member nametag attached. The original Charter and several DCGS Chapter scrapbooks were displayed. Punch and 30th Anniversary cake was served at the end of the meeting to forty DCGS members and guests.

Speaker for the evening was Samuel Schmitz from Celina, Ohio. His presentation was entitled "German Genealogy using the Family History Center". Mr. Schmitz has been a volunteer for 9 years at the Lima Family History Center. He explained how to search the online website www.familysearch.com, which is free, but emphasized that only a small portion of the records from the Family History Center are online. He explained two types of information can be found on the website, submitted and extracted. Extracted information is very creditable because it came from official church or civil records that were copied by the volunteers at the main Family History Library located in Salt Lake City,

Utah. Submitted information is less creditable because it is data reported by the general public and their sources are unknown and questionable. The type of data is clearly reported on the record sheets so researchers need to watch for these two data designations.

Mr. Schmitz said a greater number of records are available via microfilms which can be loaned to the Family History Center's branches. The website has all the microfilms cataloged. Branches in our area are located in Wauseon, Findlay, Perrysburg, and Lima. There is a small fee charged for the microfilms.

The fee is reasonable considering how much it would cost to travel to a foreign country or even Salt Lake City to search for and read the records. These microfilms are kept in the local family history center branch for three months, paying another fee can extend that time three more months. Mr. Schmitz recommended obtaining a detailed Atlas for Germany or any Country where your ancestors lived to better know which town's microfilm to order. He also assured everyone that even though the records are in a foreign language, most people can learn the few basic words needed to read records. Word guides are available for a vast number of languages and can be obtained through the local Family History Centers for a small fee. In closing he encouraged genealogy researchers to make use of the local Family History Center branches because the volunteers are very helpful and will guide you through the process of ordering films or any information to help with genealogy searches.
