

We are often asked to vote in a new levy for all kinds of "feel good" reasons. Here is one: "Do it for the kids". HMMMM. Are you forcing me to sell my children and my children's children into bondage or servitude? If you think I am exaggerating, look at how long some of these levies last. We are forcing some people who have not even been born yet to pay a tax at a future date, a tax they never voted on. Talk about taxation without representation! The founding fathers of this country sure felt strongly against it. You have heard the phrase "Life, liberty, and the pursuit of happiness"? It comes from the United States Declaration of Independence. But did you know the phrase is based on the writings of John Locke, who had expressed the concept of "life, liberty, and estate (or property)". The phrase "life, liberty, and property" was used during the War

documented accounts of colonists who became the king's revenue collectors being forced by the patriots to denounce their collecting and shout "life, liberty, and property" loudly three times or face the consequences. If we want to do the best for the kids, then lets have them take a class their senior year that studies nothing but the founding documents of this country, using only the original writings of people who were there, instead of our views on the subject. Let the student draw their own conclusion of what this country is all about. I suppose if we did it for a generation, the need for this type of article would be gone. They might not be so quick to submit to bondage as previous generations have

The next thing to consider is the entire tax burden we keep placing on our land and our children's land may seem like a small amount compared to our current income. However, has anyone else noticed lately that good paying American jobs are getting harder and harder to come by? Seems like they have become our best export lately. You don't have to read the news long to see an article about a plant closing, downsizing, cutbacks, benefit cuts, or pay cuts. Do you ever consider what might happen should we have a severe recession or possibly a large-scale depression? What if there were no jobs for the taking, even at the fast food restaurant on the corner. Even if you are blessed/fortunate enough to have no loan on your property you could still lose your land due to property tax. Don't fool yourself into believing that if things got that bad, they would start to waive the property tax owed.

get done is the 'waving' the government eviction agent will do as you drive off your old property. If you still don't think it's true, maybe we need another little history lesson. Have you ever been to the Big South Fork National River and Recreation Area in Tennessee and Kentucky? If you love the outdoors, this is a must-visit place. No houses, few roads, a great river, horse trails, hiking trails and lots of wildlife. This summer I had just come off a great 3-day canoe trip with my boys and some other fathers and sons. We pulled out at the Blue Heron mining community, which is kind of an outdoor museum today. While spending a couple of hours visiting the area and reading the historical information I came across a board that described where much of the Big South Fork Area came from. Now you have heard of the Great Depression. During the Great Depression, many citizens and companies were 'kind enough' to sign over their land, in order to get out of property tax obligations on the land. The interesting part is the fact that the park service is proud of the land grab, because they put it up on a big board with lots of pictures and make it sound like it is for the good of us all (note: the communist think taking private property for the good of the whole is a good thing also). Now, mind you, I do enjoy National parks and preservation of our heritage. I believe the government should obtain land by paying for it, and not by taxing for

owner is selling of their own Do you still believe you own your land? Then try this experiment: stop paying your property tax and see who the true lord of the land is! I know you won't get to keep it for too

many years. Some of you are sitting back saying, "I don't own any land or a house" so it will not cost me anything. Better think a little deeper on this

Do you live somewhere? Unless you get to live there for free, you are still paying property tax. I am sure you know that when you rent, the landlord is in business to make a profit. So if his costs go up, you know what is going to happen to your rent. You pay your property tax when you pay your rent.

Do you ever desire to purchase a house or land? You may not own any now, but I would sure hope you could buy something in the future if you choose to. It is sad to hear of a newly married couple who find a house they think they can afford, only to find out the extra hundreds of dollars a month in property tax knocks them out of loan eligibility.

I do believe some (not all) of the programs/services funded presently with property tax are areas the government should oversee, and that the community has the duty to pay for them. But property tax should not be the method to fund these programs/services. There are other Constitutional methods for government to raise funds (example: excise tax and tariffs on imports), but massive

spending cuts should be at the top of the list. We ask the government to supply far too many programs and services that could be better provided by the private sector. There are two points I would like to make regarding the expectation for the government to do what we as individuals should do for ourselves.

First, if you are asking because you do not want to pay for it yourself, you are really asking your neighbor to pay for it for you. The government does not make money like you do when you go to work everyday; it only takes money from one person (who may not want to give it) and gives the money to another. When the government provides a service, like the road and highway system, which is utilized by everyone, the gasoline excise tax is a great idea. You pay in proportion to the amount of gas you purchase and therefore in proportion

to your road usage. If you had no children and a neighbor walked over to your house on a nice fall evening and demanded you pay the college expenses for his children, what would you say to him? It is one thing if you volunteer to pay the college expenses; it is a completely different thing for him to demand/force it. Yet, the largest portion of our property tax is used for school/sports funding and we force people who never send a child to a public school to pay for it all the time.

Secondly, whenever we ask someone to do something for us that we could do for ourselves we surrender some of our rights and freedom to the government. If one does not agree with that fact, then lets go back to the property tax issue. When we ask the government to provide all sorts of things in exchange for our property tax, it is not just

With that in mind when the dam on the Auglaize River was elevated 10 to 15 years ago. And the "pond" became deeper and the water backed

upstream farther. The reason for raising the dam was to rebuild and renew the old inactive "Power Dam". I used to farm land along Flat Rock and the "bottom ground" would sometimes produce a crop and would flood out at other times. At the same time my job required me to travel in the Auglaize

River area. In the spring the dam was opened to allow people to clean up drift wood and debris from the channel. When the dam was open we could take a 3" rain with no flooding. When they closed it, a 1" rain would cause a flooding in the "bottom ground". Now that the dam height

has been raised and remains closed to generate electricity for the city of Bryan, Ohio all the bottom ground along the Flat Rock grows in weeds and The way to control flood-

ing is to control the "Dam". Maybe Bryan, Ohio could be paid to lower the water level during high water times. The web site claimed they generated 4 to 5% of the city's power needs from the dam. One more observation: the

Flat Rock and Blue Creek both flow to the Auglaize. Blue Creek has been cleaned and dredged. Flat Rock has had very little attention. There are two very nice homes along both creeks with water prob-

Point: we need an outlet not a deeper pond.





Remember, when the voter enters his/her polling site, they must state their name and current address, and must provide identification. Many forms of identification will be accepted; Ohio Driver's License; or Ohio photo identification; bank statement; utility bill; paycheck; and any government-issued document showing your current address.

Also, any registered voter may vote by absentee ballot. You no longer have to state a reason for requesting an absentee ballot. 

PAULDING PUTNAM BOARD COMPLETES RATE RE-STRUCTURING

The Board of Trustees for Paulding Putnam Electric Cooperative, Inc. completed the second phase of their rate restructuring project at their board meeting held on October 9, 2007. Board President, Dr. John Saxton commented, "The membership was very concerned about the rising cost of electricity and I believe this board acted to address those fears and to insure financial stability for our future." Most members will see a slight decrease in their monthly bills, based on the utility company's estimates.

The electric cooperative instituted the fist step in the rate restructuring process in July of this year by adding a Wholesale Power Cost Adjustment to all member bills. This adjustment follows the increases or decreases in the actual price Paulding Putnam pays for wholesale electricity from its providers. Members saw between 14% and 17% increase in rates with the addition of the Wholesale Power Cost Adjustment. George Carter, CEO, stated "By using this two-step process we were able to spread the rate increase over several months, lessening the rate shock to our members." Mr. Carter continued by adding, "We were loosing nearly a cent for every kilowatt hour (kwh) sold prior to this change, so it was absolutely necessary for our future."

The cooperative has aggressive construction plans for the future. These plans call for the rebuilding of utility lines throughout the service territory, three (3) new or upgraded substations in the next 3 years, and the installation of new "Smart Metering" for all members. President Saxton called the construction plans, "extremely ambitious" for a small utility, but he added "Excellent service is our top priority and we can not achieve that goal without upgrading our electric facili-

Mr. Carter said that the new rates would become effective on January 1, 2008 and all members will receive notice of the increase in future mailings. The company's CEO stated that "after this change cooperative members will still be paying \$10.99, per month, less than the average Investor Owned Utility customer and nearly \$5 less than other cooperative members in the State." He also pointed out that the Cooperative's rate schedules are available for viewing on the company's website, www.ppec.coop.

Paulding Putnam Electric Cooperative, Inc. is a Touchstone Energy Cooperative. The coop serves nearly 13,000 members in Ohio and Indi-





SEN. BUEHRER URGES CONGRESSIONAL SUPPORT FOR CHILDREN'S HEALTH **INSURANCE WITHOUT RAISING TAXES**

COLUMBUS-State Senator Steve Buehrer (R-Delta) recently joined fellow Senators in passing Senate Concurrent Resolution 19, which urges the United States Congress to reauthorize the State Children's Health Insurance Program (SCHIP), but to do so without increasing taxes on working families. Additionally, Buehrer voted to defeat an amendment which would have urged Congress to increase taxes to pay for an expansion of the federal bureaucracy.

'We all want to ensure Ohio children have access to affordable health care, but not at the expense of imposing higher taxes growing the size of government," Buehrer

In June, Senator Buehrer supported the state budget bill, which expanded health care coverage to 24,000 additional uninsured children in Ohio through SCHIP. Ohio's SCHIP program is run through Medicaid and relies upon a federal match to cover Ohio's neediest children. Due to the responsible manner in which Ohio has structured its program, it is sustainable at current funding levels for the short-term; however, for Ohio to continue the program into the future, Congress must reauthorize federal SCHIP funding.

Senator Buehrer noted that unlike the proposal being debated on the federal level, Ohio legislators took a more fiscally-prudent approach and required newlyeligible families to pay an affordable monthly premium and thereby, share in the cost and responsibility of meeting their children's health care needs. This approach helps to off-set the cost of the program so that it is sustainable in the long-run. In contrast, the proposal Congress passed and President Bush subsequently vetoed, would expand coverage, but proposed paying for it with increased taxes.

"Many Democrats are pushing for a veto override and trying to turn health care for children into a political issue. In fact, we heard this mantra from the Ohio Senate Democrats yesterday during our floor debate. Make no mistake about it, what they are calling for means higher federal taxes," Buehrer said. "The resolution I supported urges our representatives in Congress to put politics aside and look to what we did on the state-level as proof that we can provide health care to more uninsured kids without overburdening taxpayers in the process."


