#### WACHTMANN ANNOUNCES **PASSAGE OF CASTLE DOC-TRINE LEGISLATION**

State Representative Lynn Wachtmann (R- Napoleon) today announced the Ohio House of Representatives approved Senate Bill 184, legislation that updates Ohio's self-defense laws.

law-abiding "Assuring citizens can defend their families in their homes and vehicles is the right thing to do," Wachtmann said. "Additionally, the bill contains improvements to Ohio's concealed carry law that benefit and respect Ohio's citizens."

Under current law, a person who is attacked in their home has no duty to retreat before using deadly force in defending themselves or their family. Senate Bill 184 creates a presumption that victims acted in self-defense unless proven otherwise in a court of law. This places the burden on the intruder to prove they were not there to cause harm. The bill also grants individuals who were found to have acted in self-defense civil immunity from being sued by the perpetrator at a later date.

In addition, Senate Bill 184 contains several changes to Ohio's concealed carry law. The legislation would permit a person who does not possess a concealed carry permit to transport an unloaded firearm in a motor vehicle as long as they are not carrying the firearm on their person. It also prohibits landlords from barring firearms within a tenant's apartment.

Wachtmann also announced the House approved House Bill 529, also known as the Uniform Anatomical Gift Act (UAGA). This legislation, which is the first update to Ohio's organ donation laws in 40 years, streamlines organ donation laws among individual states and makes

it easier for families and individuals to donate organs. The UAGA establishes standards for donor registries and provides procurement organizations with better access to those registries in order to more quickly determine if a person has chosen to donate their organs. It also improves cooperation between procurement organizations and medical examiners to allow for organ donation when the medical examiner has jurisdiction over a body.

"Thousands of people in Ohio and across the country are waiting for an organ transplant that would bring them a better quality of life, Wachtmann said. "This bill will improve the organ donation process in our state so that more individuals can be helped."

The bill also recognizes the right of individuals with health care directives requesting the withdrawal or withholding of life support to donate their organs. The UAGA permits measures to ensure the suitability of organs prior to the removal of life-support systems. In addition, the legislation makes intentionally falsifying documents related to making or refusing organ donation a felony. Similar legislation has been passed by 27 states and has been introduced in nine others.

House Bill 529 was approved by a majority vote and now moves to the Ohio Senate for further consideration.

### WEEKEND HEAVY STORMS CAUSE DAMAGE IN PAULDING COUNTY



Strong storms cause damage at Uncle Fudd's

Friday evening began with scattered showers across the readership area. Later in the night heavy storms moved into Paulding County with destruction mainly in the southern part. Some of the areas hit include Melrose, Scott, Ottawa, Glandorf and others in between.

Towns and villages in the area had their tornado sirens sound around midnight as the Nation Weather Services issued warnings. Uncle Fudd's restaurant in Melrose, was damaged with their roof being torn off and some of the 2x4 framing was ripped up. The wood that was destroyed looked like it was broken in half like toothpicks. The construction crew was already

there on Saturday working to get the building back in shape.

While some places were damaged by heavy winds or tornadoes, others had flooding. Several places along SR 613 had high water signs warning motorists to watch for flooding. Towns in the path of this storm also had to deal with loud thunder. Near the library in Antwerp a tree had been struck directly by lightning causing it to splinter apart.

### The Enemy

Before Andrew Jackson became the seventh president of the United States, he served as a major general in the Tennessee militia. During the War of 1812 his troops reached an all-time low in morale. As a result they began arguing, bickering, and fighting among themselves. It is reported that Old Hickory called them all together on one occasion when tensions were at their worst and said, "Gentlemen! Let's remember, the enemy is over there.

Confusion exists as to the identity of our TRUE enemy. It is often the case that people who should be fighting on the same side against the real enemy are often ound fighting each other instead. For clarification purposes, let us ask ourselves, "Who is our real enemy?"

The Bible answers: "Satan." The Apostle Peter warns: "Be sober, be vigilant, because your adversary the devil walks about like a roaring lion, seeking whom he nay devour" (1 Peter 5:8).

While we were enjoying our salads, that nice lady reappeared. She was holding high above her head a huge plastic tray that held our

steaks hot off the grill. With a big friendly grin she placed our steaks in front of us; my grin left my face in a tenth of a second. Julie saw the look on my face, and I think she knew what was coming. Jeff tore into his steak, oblivious to what was brewing at his table. I took one look at the charred lump of charcoal on the plate in front of me; turned around and looked at the picture of what was supposed to be the same steak as I had ordered. They looked nothing alike. I went off! I stood up and walked to the counter and I held up the substance on my plate, so I could see it a little closer to the picture. Maybe it was my eyesight that was the problem. Nope, it wasn't my eyes, it was the steak. The same nice girl who'd served us saw the look on my face and hear the tone in my voice. Her nice pretty smile dissolved into a look that seemed to say, "Please sir, don't kill me, I only work here!" She offered to get me another steak. I refused. I asked her, "does this look anything like that picture?" Even she couldn't

pretend that it did, though all she could do was shake her head no and say she was sorry. I knew it wasn't her fault so I went and sat down with Julie and Jeff. I went off for another 20 minutes or so, as long as it took them to finish their meal in silent horror at my behav-At one point during our

visit I ranted about seeing the manager. After a few minutes another lady came out of a back office; clearly the manager had heard the ruckus and came out to investigate. She took one look at me, heard what I was saying about match what's on the "plate"? her product and the company she worked for; turned on her heels and walked right back into her office and closed the door. No doubt to call the cops. I'm sure my new bride had visions of spending the first night of her honeymoon in the Buffalo city jail. Jeff was just laughing at me. Finally as we were ready to leave, that same very nice, long suffering lady who'd greeted us seemingly a life time before came bravely to our table. She wasn't the manage, she had no authority there what so ever, but it was she who quelled the fire in me that night. She did the only thing she could think of. She bravely walked over to me; with her little hands shaking said, "Here's a comment card sir." I took it from her hand, and in the last burst of my dying anger I said, "one isn't gonna do it!" She returned with a handful of them. Even I laughed a little at that. I filled out a three or four page complaint to the owner of the steak chain, in it pouring out my displeasure at how I had now eaten at his establishments in two states and found his food to be sorely lacking anything even approaching what they were advertised to be. I'm sure my complaint cards didn't make it any further than the nearest trash can, or police evidence locker should the need arise! All I wanted was a little honesty from them, a little truth in advertising for crying out loud! All they had to do was show me a picture of what their steaks actually looked like, and then I could've made an honest assessment as to whether or not to eat this food. Then if I went in, paid good money, and ate the food anyway, it would be my fault when my steak looked like it


was carved from an old gym shoe. Why couldn't it just be true to what it was? Where was the beef? I don't know, because it sure wasn't on my plate.

Now we have truth in advertising laws. That means that the products sold actually need to do or be what the advertisements say they do/are. yet, we still need to be sure that what is advertised on the outside matches what's really on the inside. There's an old Latin saying, caveat emptor - "buyer beware." It's a warning to those buying as well as to those selling.

This is some advice that would do well for the church to hear today. Is what we're "packaging and selling" today really what Jesus would have us do? Does the "outside" match the "inside" when it comes to what we're doing in His name? Are we more than a vision and mission statement? Are we more than just programs designed to entertain, and pacify men? Programs are fine if they ultimately lead to the giver of life - Jesus Christ. When people come to our buildings on Sunday and see our signs advertising what's going on inside, does it match? And more importantly, does it match what Jesus is having us do? Does His Holy Spirit inhabit and empower what's going on? Is Christ's life being manifested here? Does His living water flow, when the ads and the flyers, and websites say it does? Because if it doesn't, what's going to happen when those who are thirsty and hungry from their journey come in to get that which they need, and don't find it? What happens when the "picture" doesn't

They won't come back! It's been almost 17 years, and I've never gone back to that restaurant chain since. I still won't darken their doors. Now, I haven't quit eating steak, not by a long shot! But they have lost me for good. And if they keep doing what they were doing they'll eventually lose enough business that they won't be there anymore. But that's just economics, the price of doing business in a free market. You either change with the times and appetites, keeping the food quality number one or you don't make it. Eventually those employed there will find other work and the world will go on, then more steak joints will come along and take their spot in the market place.

But, Jesus isn't a steak joint franchise. There's only one Jesus. And only one church (I'm not talking about denominations here; I'm talking about the one universal church through whom Jesus works). When someone doesn't find "truth in advertising" at one church, it's not like a steak joint. This dissatisfied "customer" may not go down the street and try the other "steak joint". They may stop "eating meat" all together. We're all in this together; we're all that "chain". Ănd we're all bound to ensure that what is on the sign is what is on the plate. We're here to ensure that Jesus is the One we're pointing everyone and everything to. This doesn't mean that we'll always do things perfectly. But when we strive to present to others the love, life, and grace of Jesus above all else; then we've fought half the battle. When someone asks us, the church, "where's the beef?" it had better be on the plate.

It was 1884. The New Orleans Cotton Exposition desperately wanted to be the biggest and best convention of all. And so the committee members worked very hard to come up with new and fresh exhibits and ideas never seen before.

And New Orleans did come up with something never seen before. It was a rare and unusual flower, beautiful in appearance and heavenly in fragrance. This exotic water flower with its orchid-like bloom came from Venezuela and was called a "water hyacinth".

All the ladies oohed and ahhed with thousands of them secretly sneaking little slips of the plant into their purses. They took them home, hoping and praying they would take root and grow in some spot in their own damp Louisiana yards.

Their wishes came true. The lovely water hyancinths DID survive. But little did people anticipate that these beautiful flowers would also eventually take over every water channel in the South! Soon rivers and canals were solid water hyacinths from bank to bank.

A little too late, horticulturists discovered that each plant produces a thousand little water hyacinths every two months! And because pieces break off and float down the river, they can even transplant themselves with no help at all.

That decision by those many women at the 1884 New Orleans exhibition has produced a problem throughout this entire region that has taken on colossal proportions in terms of headaches, frustration, and money.

What a profound parallel to the way sin enters into our lives. The amazing way that little decisions have a way of snowballing into patterns and problems of huge proportions.

A simple phone call. A drink at a party. Growing resentment over a tiny offense. A hasty comment made in a moment of anger. Such small, insignificant things. But how they can take root and multiply.

#### PAULDING VILLAGE COUN-CIL MINUTES FROM MAY 5, 2008

Paulding Village Council met in Regular Session on May 5, 2008, at 6:30 p.m. in Council Chambers at the Municipal Building. Mayor Greg White called the meeting to order.

Finance Director Tope called roll call with the following members present: Barb Rife, Roger Sierer, Randy Daeger, Sam Jeffery, and Kim Sutton. Administrator Wiebe and Solicitor Jones were also present. Councilman Ronnie Breedlove was absent. not to exceed \$285,000 portion of Series 2008 various purpose improvement notes to be issued in anticipation of the issuance of bonds for the purpose of making improvements to the Village's sewer system.

Wiebe requested the Finance Committee's report be presented before the first reading of Ordinance 1377-08, 1378-08, and 1379-08. Rife presented the Finance Committee's May 1<sup>st</sup> report. The following information was presented:

was presented: \*\*\*A grand total of \$372,431.99 is available for debt reduction.

\*\*\*\$155,000 is to be paid down on the principle of the current note. The 2008/2009 note issue will be \$990,000.

\*\*\*Recommendation to transfer \$372,431.99 from the Income Tax Fund (#102) to the Water and Sewer Capital Improvement Funds (#603 and 604 respectively).

\*\*\*Potential sewer rate increase was discussed. The proposed increase would add approximately \$2.50 per month to the sewer portion of resident's bills. The issue was tabled for further discussion.

Sutton motioned to approvetransferring\$372,431.99 from the Income Tax Fund (#102) to the Water and Sewer Capital Improvement Funds (#603 and 604 respectively), seconded by Rife. Vote: all yea.

Ordinance 1377-08 re: An Ordinance to Provide for the Issuance of \$277,500 Notes in Anticipation of the Issuance of Bonds for the Purpose of Improving the Village's Sewer System and Waterworks System, each together with all necessary Appurtenances thereto, and Declaring an Emergency, was read for the first time. Sierer motioned to suspend the rules and declare an emergency, seconded by Rife. Vote: all yea. Sierer motioned to approve the legislation, seconded by Rife. Vote: all yea.



Mayor Henke explained to council that they couldn't accept the minutes of the special meeting held on 5/14/08 because he failed to get the clerk all paperwork needed to process, therefore this will be done at next meeting.

Fire dept. gave report and it is on file. Kenny Thomas had a few extra things to add to report. He wanted to say that he was ready to get started on the process of his new truck. Phil made a motion to pass resolution 08-R-05, for the fire dept. to continue with the purchase of Brush Truck, Jake seconded, all in favor. Kenny wanted council to know that he gave the two Cadets permission to use the fire truck for the prom. 



#### **PAULDING COUNTY FAIR** PAST AND PRESENT: **PAULDING COUNTY4-H**

The first 4-H club was formed as a pig club in 1919. In 1920 there was one pig club and five food clubs.

The first 4-H Camp was held in 1924 with 28 members. In 1925 there were 25 clubs with 23 boys and 267 girls.

By 1935 club membership had climbed to 282 boys and 429 girls with 65 advisors in 37 clubs. Almost the entire agriculture hall was turned over to 4-H clubs at the fair. The livestock barns were so crowded that stalls had to be constructed in the dairy barn for foals.

In 1950 the Junior Fair Livestock Building was constructed for \$3,000 raised by the Paulding County Agricultural Council, fair board members and 4-H Club members.

In 1972 there were 668 boys and girls in 4-H. There are nearly 200 projects for members to select from.


Some of the highlights of the 1948 Fair included were entertainment by 4-H Club Talent, pony race for youngsters, pet show, Horse Pulling Contest. Possibly the greatest kick the audience got out of 'Pioneer Day' was the argument a couple of old settlers had over the date of the 'Big Wind'.

A Conservation with George Reinhart: In the 100 years of The Paulding County Fair there has been many ups and downs. To run a fair that only last a few days out of the year takes many weeks of work by the fair board and much is left to the Secretary. George Reinhart was on the board for many years. His position was speed Superintendent.

In the year 1936 the financial condition was such that the commissioners decided not to have a fair that year. George and his friend, Jim Johnson, then the County Extension agent who had charge of the 4-H kids who had already had their projects ready decided there must be a way out so a meeting was called with the Chevrolet dealers of the county: Leinard of Antwerp, Shisler of Oakwood, Wetli of Payne and Reinhart of Paulding and they decided to put on a 4-H Fair, with George as chairman. The schools then went in, also grange and before they knew it, they decided to put on the whole fair, races and all. After some problems they were able to get rides and were able to give away a '36 two door Chevorlet, a living room suit

Ohio 500 between Ohio 49 and the state line - Tile work will reduce traffic to one lane through the work zone. Work is being performed by Paulding County ODOT.





#### SENATE OFFERS CONCUR-RENCE ON BUEHRER LEG-ISLATION TO ESTABLISH OHIO CASTLE DOCTRINE

The Ohio Senate this afternoon (May 29,2008) voted to give final approval to Senate Bill 184, legislation sponsored by State Senator Steve Buehrer (R-Delta) that would make needed, common-sense reforms to Ohio's self-defense law to affirm the right of every Ohioan to use force to defend themselves and their family from violent attack in their home. While under consideration in the Ohio House, the bill was amended to clarify several confusing provisions in the state's concealed carry law that have placed an unintentional burden on lawful gun owners.

"Importantly, while SB 184 has undergone several changes over the last few months, the bill that was sent to the Governor today meets the goal of allowing people to feel safe in their homes and communities," said Buehrer. "I would like to thank all those who worked on the bill, and I urge the Governor's support for this very important measure."

SB 184 builds upon a belief rooted in the Middle Ages that "a man's home is his castle," and he has the right to defend it and the people inside from harm. Known as the "Castle Doctrine," the bill passed the Senate in April with unanimous support and received strong bipartisan backing in the House yesterday. Under current Ohio law, if a homeowner uses force to protect himself or family members from attack in a home or car, the civil and criminal burden is placed on the homeowner to prove in court that he was acting appropriately to defend from serious harm. SB 184 makes two necessary changes to the law to remove this unfair burden on Ohioans, who are forced to defend themselves. First, the bill would shift the burden of proof from the innocent victim and onto the perpetrator.

This "rebuttable presumption" means if a criminal forcibly enters or intrudes into a person's home and that person chooses to act to protect themselves from harm, they would be legally presumed to be acting in self-defense.

In addition, the proposal would grant a victim civil immunity if it is proven that he or she acted in self-defense. Under current state law, even after a legal finding of self-defense, the victim still faces the possibility of being held liable for damages in a civil lawsuit. The bill, therefore, will prevent any person who is committing a felony or a misdemeanor crime of violence from seeking civil recovery.

"We thank Senator Buehrer for his hard work in leading the effort to reform and modernize Ohio's firearm and use of force laws," said Jim Irvine, Chair of the Buckeye Firearms Association. "Ohio's Castle Doctrine is about helping crime victims, by shifting the focus of our police and prosecutors back on the criminal where it belongs."

Also, during deliberations in the Ohio House, SB 184 picked up several amendments that help ease enforcement and strengthen the effectiveness of Ohio's concealed carry laws.

"The changes made in SB 184 to clarify Ohio's concealed carry laws are meant to help lawful Ohioans more easily exercise their Second Amendment rights," said Buehrer. "These folks deserve to have a common sense law that they can understand and follow."

#### NEW CONSTRUCTION PRO-GRAM II

Whenever a change is made to a property – either remodeling an existing building, adding a new structure, removing a structure, or if a structure is damaged – the law requires the property owner to report that change to the county auditor.

The County Auditor, Susan K. Simpson, is in the process of completing the yearly new construction program which helps to assure that ALL parcels of real property that have structural changes are appraised (or "valued") at their current fair market value and then assessed at 35% of that value. This method is established by Ohio law. New buildings in a taxing district also generate "new tax money" for that district.

Yearly inspection of building additions and removals keeps the tax burden equitable for everyone in the county. Otherwise, a property with a new building might not pay taxes on that structure for several years or the next revaluation. On the other hand, a property with a destroyed building could be paying taxes on a non-existing structure for many years if not reported.

Depending on your taxing district, you are required to either obtain a building permit from your zoning inspector or the county auditor's office. It is the property owner's responsibility to notify the County Auditor of any new, destroyed or damaged structure. The Ohio Revised Code (section 5713.17) states "Upon the discovery of a building... the auditor shall appraise it... together with a penalty equal to 50% of the amount of taxes that would have been charged... from the date of construction to the date of discovery ... " therefore, it is very important that you obtain a building permit and contact your county auditor's office to report any change in structures on your property.

A field technician or appraiser will inspect your property that has been reported, either new construction or building destruction, and record relevant information for the County Auditor. If no one is home, the appraiser will make what they believe to be the necessary changes to the property record card in the auditor's office. You may call or visit the County Auditor's office to review your property record card's information at anytime. You can also access this same information via the county auditor's website at www.pauldingcountvauditor. com. If you believe your information is insufficient, call the County Auditor's office at 419-399-8205. There are three steps that you can take to discover whether or not you believe your property's estimated market value is reasonable: First, check the replacement cost your insurance company has on your home (without the contents). This will give you an approximate idea of your home's value. Then add the value of your land to that number. Second, check the local newspaper and realtor advertisements for sale homes in your area. Be sure the homes you are checking are very similar in size, design, rooms, materials, and lot size

to yours. On average, most realtor-sold properties actually sell for approximately 15% less than the advertised asking price.

Finally, visit the County Auditor's office, either in person or on-line. Check your property record card to be certain all the information is accurate. If something is incorrect, call the auditor's office and ask to speak to a real estate staff person.

Ohio law requires each property to be valued at what its most probable estimated appraised price would be if it were on the market.

Over time, market value changes even if no "improvements" (appraiser's jargon for structure or building) or changes are made to a property. Many people sell their homes for much more (and, sometimes less) than they paid for them years earlier. Ohio law requires that property be periodically reassessed and revalued to maintain realistic market values and treat all taxpayers fairly.

If you still disagree with your property value you may wish to file a Complaint Against The Valuation Of Real Property (DTE Form 1) with the Auditor's Office. A complaint for the current tax year must be received by the County Auditor's office from January 1-March 31 of the following tax year. If the form is not filed timely, or completed accurately and according to State guidelines, it will be dismissed. These complaints are then scheduled and fulfilled through a hearing process by the Board of Revision. However, it is the responsibility of the complainant to provide to the Board of Revision all information and evidence that affects the real property in question. Under Ohio Law, the burden of proof is on you. You must prove, with the evidence you present, that the value you have requested is the fair market value for the property.

Your tax bill may be based on funding requests made by schools, libraries and government agencies as well as on levies that are passed by the voters. If funding requests decrease in a taxing district, or if a tax levy expires, your property taxes could drop – even though your property's market value may have risen. Same is true for the opposite if a new levy goes on or funding requests increases.

Differences in taxes can be due to several items such as a Triennial update (required by the State), special assessments (charges added on your tax bill for ditch maintenance, sewer costs, lighting, etc.) a levy added or change in millage, a property change use (such as commercial to residential), loss of a tax exemption or tax credit, the State may have changed the CAUV land values or land no longer qualifying for CAUV. Ohio law outlines the conditions under which the County Auditor can make changes to a property record. Ohio law is also very specific as to the requirements the County Auditor must follow as to when and how valuation changes are made. When you think of Relay For Life, you often think of lacing up your shoes and taking to the track, but for the second year you can take a seat to fight cancer. The "Chair" ity For Life rare chair event and auction presented by First Federal Bank and Butler-Mohr GMAC Real Estate will again be part of the Relay For Life of Defiance on June 13-14 at Ayersville High School.

Brandon Retcher just graduated from Grinnell College in Iowa with Chemistry as his major. He is now ready to go out and make his mark on the world. He has committed to two years in the Peace Corps.

He wants to meet the needs of people in different cultures by helping them make a difference in their lives. He wants to be exposed to other cultures and get the different perspectives-how they live and the differences between the different countries.

Brandon went to the Netherlands last summer to do Chemistry research through an exchange program with the college. He spent 10 weeks there and had his research paper published. He said things were pretty different.

The Peace Corps provides trained men and women to countries that express a need. Antwerp's regular council meeting was held on Mon., May 19 at 6:30 p.m. All were present.

Visitor Rick Weaver from Poggemeyer Design Group, Defiance, Oh explained the problems with the water lines in front of Kammeyer's and different solutions to handle the problem.

Police Report: Chief Clemens reported 139 calls for service and 61 offenses for April. It was brought up that a prisoner agreement be signed with the Paulding County Jail that Antwerp Village would pay \$40 a day for prisoners taken in custody.

It was mentioned again from the Finance Committee that any organization asking for donations must be able to prove non-profit status with all the legal paperwork entailed. The Village must be kept informed of the monies collected. This is for property owned by the Village.

Administrators Report: Sarah Keeran announced that the farmer's well was repaired and that the farmer's appreciate very much the use of it.

Curtis from the Utility Department took and passed the pesticide exam, Jeremy took the water exam and will find out in June how he did. He will take the sewer exam in November.

Utility Department has been very busy trying to catch up on all the projects needed done in town. Parts for the pumps are here and both pumps are operating and two new pumps have been ordered (announced at last meeting).

It was announced that the A.C.D.C. should know by the end of this week if assistance for the Depot project has been awarded. Suzanne Rister has also filed grants for this project.

Cameras for the traffic lights were discussed.




