
Mike was the best friend anyone could ever ask for. He was always willing to help when help was needed. Therefore, we feel honored to



A meeting will be held Tuesday, October 14 at 7:30 p.m. at the Extension Building 503 Fairground Drive, Paulding County. The Paulding County Commissioners have agreed to discuss the concerns over the decision to eliminate the 4-H program if the operating levy does not pass. This meeting is open to the public, everyone is welcome. There will be a platform for which questions can be answered. If interested in this issue, come and give a voice to those who sometimes go "invisible" when political decisions are being madeour children.

GO GREEN FOR 4-H

A group of concerned citizens met together at the Oakwood Fire Station to kick off the "Save Our 4-H" green ribbon drive. The purpose of these ribbons is to make the county commissioners aware of how much 4-H means to the community. This is in no way an attempt to encourage people to vote for or against the levy, this group feels this program should not be conditional based on the outcome of the levy. They are simply asking Paulding County residents to tie green ribbons on their car antennas, mail boxes, trees, etc, to show their support.

GRAIN HARVEST

Harvest is a busy time for farmers. Proper harvest ensures more efficiency and reduces yield loss. A timely harvest schedule means more income when it comes to yield and reduced operating cost; however, time also en-

sures safety at harvest. The extra time it takes to perform a task properly can determine whether the job is completed at all.

Harvest is the payday for farmers. By the time the crop is mature, farmers have incurred most of the expense of producing the crop, but there is no return to labor and management until the crop is safely harvested, stored, and marketed. This is why harvest is very important. We need to understand the importance and value of harvest and that transporting equipment from field to field or from field to the elevator is part of the harvest process.

Harvest begins after the crop reaches maturity. Corn reaches maturity when the black layer is formed and corn moisture content is about 30 - 32%. The starting harvest moisture varies from geographical location, hybrid maturity and growing season. The typical combine harvest moisture for corn in our area is around 20%. It is very expensive to dry corn to 15%, which is needed for storage, but can be more expensive to wait for field dry-down due to natural losses. Farmers do not know when weather conditions, like high winds experienced last weekend, can cause stalk lodging, thus making harvest more difficult and increasing harvest yield loss.

Soybean harvest usually begins when seed moisture drops below 15%. By this time, the leaves have completely dropped. Sometimes the plant stem remains green, making harvesting very difficult or the soybeans dry down too fast, going below 12% moisture, causing an increase in shattering harvest loss.

In order to minimize losses and maintain harvest efficiency, farmers will strive to complete harvest in a safe and timely manner. This efficiency improves income potential



and reduces harvest costs. In order to accomplish this task, farm equipment will be on our area roads. Let's keep in mind that combines, trucks, and tractors pulling wagons have many blind spots for the operator to see properly so keeping a proper distance,

slowing down, or by even getting off the road momentarily, can help farmers greatly when transporting equipment over the road. The fall harvest will be

upon us soon. Let's all work together for a safe and productive harvest season.

UNITED WAY HELPS FAMI-LIES COVER PRESCRIPTION COSTS

If you don't have health insurance, or need medicine not covered by your insurance plan, you need a FamilyWize prescription drug discount card being distributed by United Way of Paulding County. This card could lower the cost of your medicine by an average 35%. United Way of Paulding County is providing these cards free-of-charge to everyone in our community. There are no age restriction, no income restrictions, no limit on how many times you can use it and no waiting to get a card. In fact, you can cut this one out and use it today.

People with Internet access can go to www.FamilyWize.org to print a card, look up drug prices, and get a list of participating pharmacies.

FamilyWize cards also can be obtained from all Kmart Pharmacies, Rite Aid Pharmacies, the Village Apothecary of Paulding, Antwerp Pharmacy, or by calling United Way of Paulding County at 419-399-5300. The Paulding County Health Department, Paulding County Job and Family Services, Paulding County Senior Center and the Paulding Chamber of Commerce will also have cards available for customers and the public at all of their locations. Local businesses and employers can also get cards to give all their employees.

United Way of Paulding County has joined more than 675 United Ways in all 50 states to save people \$25 million in the next year on the cost of their medicine. The goal of this Partnership is to save \$100 million over the next 4 years. So far, more than 6 million cards have been distributed. There is more information on the program's website at www. FamilyWize.org, such as a tool to look up drug prices, participating pharmacies and print additional cards for family, friends and coworkers. The FamilyWize cards are accepted at Rite Aid Pharmacies, the Village Apothecary of Paulding and the Antwerp Pharmacy. Most pharmacies here and throughout the United States accept the Family-Wize prescription drug discount cards. "It's truly amazing what we can accomplish when we all work together. So many people and organizations have joined together to make this possible," said Nancy Hessler, Director of the United Way of Paulding County.

VANTAGE BOARD MEETS **AT WAYNE TRACE HIGH** SCHOOL

The Vantage Board of Education held their October meeting in the lecture hall at Wayne Trace High School on Thursday, October 2, 2008. They were welcomed by Principal Kevin Wilson.

The treasurer's report included the approval of the September 4, 2008 regular board meeting minutes and the financial statements for the month of August 2008. The board passed resolutions to approve the five year forecast, amend appropriations and revenues, and increase ABLE Instructor's hourly rate to \$20.00 for FY09. The board also passed a resolution to approve the underwriter for the sale of OSFC and other bonds.

Superintendent Staci Kaufman provided the board with updates on the ballot issues campaign, statewide open enrollment, the anticipated merger with Auglaize and Mercer Counties' ABLE program, and TB testing requirements for new staff members at Vantage. sponded that he was a barber. It was as a barber that he had supported his family prior to coming to the Academy.

Devastated, Eisenhower returned to his room. He retold the incident to his roommate, confessing, "I've just done something that was stupid and unforgivable. I just managed to make a man ashamed of the work he did to earn a living." In his autobiography Eisenhower wrote that, for him, this was a lesson about "the lack of consideration for others." In his room that day, Eisenhower vowed never to demean another individual again.


It was a promise he kept through this life, even as Supreme Allied Commander during the Second World War and as the thirty-fourth President of the United States. He became an encourager and it

Mayor would like to suspend the reading of the minutes, Councilmen made motions to approve the minutes, all agreed, motion passed.

Councilman stated, Chief Carpenter was unable to attend; he is in dog training. He was given a Dutch Sheppard and it's being trained to work with him. This will be the City's dog and the dog fund will be used for necessary items for the dog. Chief Carpenter had 141 runs for August. Ryan Walls presented the agreement between the City and Customized Power Services for Annual maintenance on the generators. Councilmen made motions to accept the agreement for another year, all agreed, motion passed.

Residents at 23012 Woodburn Road are requesting permission to straighten their driveway. Ryan will check into. Councilman will check if Melvin Gerbers has given permission for the equipment parked west of his station. Councilman spoke with the State and fixing the curbs in front of the Bowling Alley is still on their agenda.

He presented his proposed salary increases for elected officials and hired employees. He recommends a 1 1/2 percent raise for the Mayor and Clerk Treasurer, with 30% taken from the General Fund, 35% taken from water and 35% taken from sewer. libraries are experiencing a dramatic increase in library card registration. According to a new Harris Poll from Harris Interactive, released September 22 during Library Card Sign-up Month, 68 percent of Americans have a library card, up 5 percent since 2006.

Survey results indicate that this is the greatest number of Americans with library cards since the American Library Association (ALA) started to measure library card usage in 1990.

In-person visits also are up 10 percent compared with a 2006 ALA household survey. Seventy-six percent of Americans visited their local public library in the past year, compared with 65.7 percent two years ago. Online visits to libraries are up even more substantially - with 41 percent of library card holders visiting their library Web sites in the past year, compared with 23.6 percent in 2006. This finding complements the ALA's 2008 Public Library Funding & Technology Access Study, which found that public libraries have significantly increased the Internet services available to their communities - including online homework help, downloadable audio and video, and e-books.

"I think most that walk through our doors are pleasantly surprised by the variety of free services libraries offer," said ALA President Jim Rettig. "The poll has confirmed what we have been hearing from our members from the start; 'libraries have become family destinations, technology hubs, cultural centers – basically the pillar of most of the communities they serve."


Libraries provide programs and services for people of all ages, but the poll finds certain groups are more likely to have a library card than others – women over men (73 percent versus 62 percent); and Midwesterners (72 percent) and Westerners (71 percent) over Easterners (65 percent) and Southerners (63 percent).

The poll also found that 39 percent of card holders visit the library to borrow books from the library; 12 percent take out CDs, videos or computer software; 10 percent use a computer to see what the library has available; 9 percent use reference materials; and 8 percent go to the library for Internet access. 


Americans (59 percent) are extremely or very satisfied with their public library and an additional more than one of five (22 percent) are somewhat satisfied.

STAN AND SUE WITH THE WOODBURN FIRE DEPART-MENT

Sue and I talked to Mike Martin a couple of weeks ago about the Old Woodburn Fire Department. He had some old pictures but they were too big to use in this report.

Up until 1903, Woodburn didn't have an organized fire unit. They had two 36' ladders one 20' ladder and one 18' ladder with a goodly number of buckets.

In 1910 some of Woodburn governing body sat out to get some more up-to-date fire fighting equipment. They bought a Howe Pumper of 850 gal. per minute capacity. This was mounted on a wagon with about one thousand foot of hose. At this time, there was about one half dozen 6-inch wells drilled around parts of the city for water supply. I don't know if there were any cisterns or not.

In 1916, at a special meeting of citizens and merchants met to have an organized fire department of 13 men and a Captain. R.E. Cairns was the first Captain.

All this equipment was used until 1926 when it was returned to the Howe Co. and repaired and mounted on a Chevy truck of 1926 vintage. Then in 1939 after talking about maybe some country fire runs they would need some bigger equipment with more water and a higher volume pump. This 450 gal. per minute pump and 250 gal. water tank was used until 1955. At that time they purchased a John Beam pumper of 800 gal. per minute and a 450 gallon tank. For years, the telephone operator sounded the alarm siren. Now the alarm is dispatched by the Allen County Police Dispatcher. Over the last few years, the Woodburn Fire Department has advanced so much with new and bigger equipment, more technology and a brand new fire house. It is an up-to-date first class department, second to none. They have kept up to date on all the training programs. I really don't know much about the EMS.

I remember back in the 1960's and 1970's, Antwerp would come to the Woodburn Day's Parade and the Woodburn would travel to Antwerp for their Firemen's Day. That way you learn about the boys on each department. I even participated in a water ball contest in Woodburn one time.

The Woodburn Department is very active in a lot of affairs, other than fire runs. This makes for a better department and better relations with the community. I'm proud to say that I know some of the boys on the Woodburn Fire Department.

Here is a semi-true story about our Antwerp's Firemen's Day Parade. I have used it before, but my Woodburn friends have not heard it.

On the last Firemen's Day Parade in Antwerp, our son, Gale, and I were doing the P.A. System work from the speakers stand. In a lull in the activities, I saw an old school chum of mine, Helen Green, standing in the shade across the street with some of her friends. I hadn't seen this girl for many years and I wanted to go meet her.

Well, after the parade was over, Gale tore the P.A. System down and picked up all the cables and amplifiers and speakers and took it to the fire house to use with the kid contests later on so I could go talk to Helen Green.

As I was getting off the stand my wife came along and said, "Let's go down to the lawn of the Masonic Temple and get some BBQ chicken. I told her I wanted to go over and talk to my old school chum, Helen Green.

Pauline said if we wait too long we will have to stand in line in the hot sun. So she went on down to get a place in line.

I journeyed across the street where my old friend was talking with some people and she had her back to me. I tapped her on the shoulder and when she turned around, I was so surprised I didn't know her at all. I stuttered and stammered around and finally got it out. I said, "You look like Helen Green!" She said, "I know it and I don't look any better in blue either!'

Pastor Dave Dignal and the congregation at the Edgerton Wesley Church in Edgerton, IN are wonderful caring people who want to serve in the Paulding and Allen County and surrounding areas. So when Kara came to them with the idea of a Dav Care Ministry, it took off. Since there is not a lot of daycare in Paulding County they felt they could best serve by providing a safe place for parents to leave their children.

state regulations for fire. They have fire drills once a month and have a plan for evacuation. The Fire Marshall's have inspected and will continue to inspect the premises. The Indiana Bureau of Child Care will also hold inspections.

The trained and experienced staff's main concern is the children's health and safety. The children will also be provided care in a Christian environment.

The children's day is routine and scheduled which provides the children with a sense of security. Daily story times, outside playtimes, dramatic and creative play, arts and crafts, song and music daily, educational activities with puzzles and games, learning time along with one on one time, social behavior emphasized along with muscle/motor development are provided for all children. Sign in/sign out procedure is used for the children's safety.

"FROM THE VANTAGE POINT": USING SKILLS IN THE "REAL WORLD"

Last spring, Vantage Health Careers was asked to help the local school nurses perform hearing and vision screenings for students from kindergarten through high school. All students must be tested by November 1 and the job is overwhelming for one nurse. The Ohio Department of Health came to Vantage last spring to train the Health Careers students on how to complete these screenings. Vantage students were trained on how to use the audiometer to test hearing and the Snellen charts for vision screenings. They also test for color blindness. So far, the senior Health Careers students have helped with the Van Wert kindergarten screenings, the Crestview Elementary and the Lincolnview screenings.

In addition to the hearing and vision screenings, the Vantage students also help take and record the height and weights of the elementary students. This experience for the Health Careers students is not without its' challenges. One of the biggest challenges has been helping the elementary students who do not speak English as a primary

GUEST COLUMN FROM STATE REPRESENTATIVE LYNN WACHTMANN

Last year, there were more than 325,000 vehicle crashes in Ohio, according to data compiled by the Ohio State Highway Patrol. While the vast majority of these accidents did not result in injury, there were still 1,200 fatal crashes in 2007.

Regardless of where or when an accident occurs, when a person is injured it is essential for law enforcement and medical personnel to know who to contact. In many cases this is easily accomplished - people often have emergency contacts stored in their wallets, cell phones or in their cars. However, if a person has no relatives in the area or has a different last name than their immediate family, it can be difficult for first responders to know who to contact.

This type of situation occurred to two central Ohio families last year. Their relatives were fatally injured in separate incidents, but authorities were unable to contact nearby family members because they had different last names than the victims. Because of this unfortunate delay, the families had less time to spend with their loved ones at the hospital.

To help other Ohio families from experiencing these types of tragedies, my colleagues and I in the Legislature passed House Bill 392, which makes it easier for a person to designate an emergency contact. The bill was sponsored by Representative Jim McGregor (R- Gahanna). House Bill 392 gives individuals with a valid Ohio driver's license, commercial driver's license, temporary permit or identification card the option

of providing the name and information of a contact person they wish to be notified in the event the individual is involved in an accident or emergency. The contact person does not have to be the next-of-kin – it could be a nearby friend, relative or coworker.

The Bureau of Motor Vehicles (BMV) is responsible for storing the contact information in a database, which can only be accessed by BMV employees and criminal justice agencies. House Bill 392 recently became effective Ohio law, and I am pleased to say that Ohio is only the second state to create and maintain a centralized database of contact information for residents.

If you would like to sign up for the next-of-kin database, you can fill out and submit a form online at www.bmv. ohio.gov. You can also obtain the form at your local deputy registrar's office. These forms can also be used to update an emergency contact's information or to remove a person as a contact.

Although we can never completely avoid being involved in an accident or emergency situation, we can ensure that our families are notified of our situation as quickly as possible. Through the creation of a centralized database of contact information for Ohioans, we can help save valuable time when trying to reach the family and friends of an accident victim.





PROGRAMS AND SERVICES PROVIDED BY THE PAULD-ING SOIL AND WATER CONSERVATION DISTRICT

The Paulding County Soil and Water Conservation District (SWCD) is one of 88 conservation districts in Ohio and one of nearly 3000 nationwide. The district is led by five dedicated local residents who are elected to a three-year term as Board Supervisors and volunteer their time. Our agency is an independent subdivision of the State of Ohio, associated with the Ohio Department of Natural Resources- Division of Soil and Water Conservation, and Funded by Paulding county and state taxpayers monies.

The primary purpose of our district is to bring people, governmental agencies, and private interest together to manage our natural resources and environmental challenges.

What does the soil and water conservation district do? The Paulding Soil and Water Conservation District helps implement many United States Department of Agriculture farm bill programs and provides many services to the county. These programs and services include the following:

-Administers Lake Erie Conservation Reserve Enhancement Program (CREP) to set aside crop land acres next to ditches or streams to control erosion and runoff from cropland while also enhancing wildlife habitat.

-Promotes and administers the Agricultural Link Deposit Loan Program which provides reduced interest rate on farm equipment that improves water quality.

-Assist the Natural Resources Conservation Service in surveying, designing and overseeing the construction and installation of Environmental Quality Incentive Program (EQIP) projects that include: liquid fertilizer secondary containment facilities, mortality composting facilities, tile shut-off's, Comprehensive Nutrient Management plans, livestock fencing, manure storage facilities and many other items.

-Surveys and design for erosion control structures such as: grassed waterways, rock chutes, berm drain, drop box, culverts

-Surveys and design pollution abatement practices for producer's to help them reduce pollution from affecting our natural resources.
