
Christopher P. Boesch, 46, of Antwerp, passed away Thursday, March 5, 2009 in Indianapolis.

She was born in Payne on March 24, 1923, the daughter of the late Elden and Blanche (Skinner) Gernhardt.



Donations of clothing, including purses, shoes, hats, belts, and scarves will be accepted and can be brought to the church. All items must be clean with no rips or dirty spots.



Without hope, one is miserable. Suicide is primarily caused by people seeing no hope for a bright future. But let the Bible speak about hope. Hope is a desire of some good with expectation of obtaining it, Acts 16:16-19; Notice this is a lady who was possessed with a spirit of divination who was being used by her two masters to make much gain in her soothsaying. Paul in verse 18 asks the spirit to come out of her and her master's saw the hope of their gains disappeared. Their hope was in something that won't last, using someone else to their advantage. Author Steve Farrar relates the story of a guy who once played basketball at UCLA for the legendary coach, John Wooden. UCLA had a lock on college basketball from 1964 through 1975. During that eleven-year span, the Bruins won the NCAA basketball title nine times.

This ball player was recounting his first day of practice under Wooden. Everyone was awed by the presence of this living legend, but they were completely shocked when he came into the locker room and spent several minutes showing these high school all-Americans the proper way to put on their socks and lace up their shoes.

They thought Wooden was nuts. They knew how to put on their socks and tie their shoes! They weren't a group of kindergartners; they were a group of talented college freshmen. Why would a legend like Wooden be concerned about socks?

The answer was simple. If a player gets blisters from socks that are not smooth or shoes that are not correctly fitted, then that player cannot play up to his ability. Wooden didn't overlook anything. Not even blisters.

A successful man makes sure that there are no emotional blisters developing in the lives of his wife or children. He is there to smooth things out and to offer strong support. LETTER TO THE EDITOR

I am writing this letter as Chairman of the ACFCC (Antwerp Community Fellowship and Care Campus, fka The 'old' Antwerp School) and also as a member of the Antwerp community. Recently there was a Letter to the Editor concerned, and rightly so, about the future of the Otto E. Ehrhart Museum. This is not a current event. Let's back up a little, because I do not think that the general public is aware of the longevity of this project.

The City Council, as I have been informed, had asked that the museum be moved in March of 2005, four years ago. The Village is in need of the space that the museum currently occupied. The museum itself had been closed already. It originally was planned to move the artifacts to what was the Ehrhart Photo Studio. I believe once the building was inspected, it was found to be more expensive to renovate the studio building than was financially feasible, by all parties involved.

The A.C.D.C., led by Kirk Hopkins, was in on that potential move, offering man-

power to move the exhibits, to help refurbish the building, and do whatever was needed to keep the museum open to Antwerp residents and travelers, alike. A year later, at our October 2008 meeting, Kirk approached the ACFCC and Ohio Indiana Development Corp. and asked for our help in saving the Otto E. Ehrhart Museum, in whatever capacity we were able.

We offered then, and the offer stands to date, to help move to and store at our campus, and find a new facility to house whatever part of the museum's exhibits that are safe and salvageable. We sincerely want, as the A.C.D.C. does, to save this wonderful part of Antwerp nostalgia, for generations forward to enjoy.

In truth, the village has been patient in waiting for this much needed new space, and the Otto E. Ehrhart Museum needs a new home. A building large enough for visitors to come and view the ENTIRE collection, which now is not possible in it's small location. Much of the items at the current location are not in sight; stored in boxes, bags and drawers. Like so many others, as a child, I too, spent many afternoons after school in the museum. It was dark, crowded and hard to maneuver in, when more than a couple people were inside visiting. I would love to be able to take my children through the museum, in a different setting. Wouldn't it be awesome to have a new building designed exclusively for exhibiting the entire collection?! We are painfully aware that we will not be able to save the collection in it's entirety, as much has deteriorated. It is our hope, as it was in Mr. Seslar's editorial dated March 4, 2009 in the West Bend, that we can save as much of this unique collection as we are able and ensure it's future, while enhancing our village's efficiency with much needed room.

We welcome any help, encouragement, and prayers in this endeavor.

SHOOTINGS AT THE OK CORRAL

Reams of paper have been written about this gun fight. I have a lot of information about that stretch, how many hours were involved and so on. But I'm going to tell it to you like I understand the happenings, as factually as I can.

The Clantons had been drinking all night and morning and causing all kinds of trouble for the Earps along with a lot of insinuations and threats of bodily harm to them.

He had with him Billy Clanton, Frank and Tom McLaury, Billy Claiborne and Sheriff John Behan. Clanton and The Cowboys had Sheriff Behan in their pocket, he was on the take, so to speak.


On the Earp's side was Marshall Virgil Earp and Morgan Earp who were paid full-time lawmen. Wyatt was a temporary deputy with not much power. Doc Holliday who was a good friend, wanted to be in the fight. The Earps needed and wanted him also.

If you wanted, you could just say all these people wanted to fight, to have a showdown because they all hated each other and probably with good reason.

Virgil Earp was the only one of these participants who had any experience in gun fighting. He was in the Civil War. Some of the others were in altercations but not of this size

I don't know if they walked down Fremont Street like the movie shows, but I know Holliday did have on a long coat and he carried a sort of sawed off shotgun under his coat. It was a cold day with a skiff of snow on the ground and about 3 o'clock in the afternoon.

Ike Clanton, brother Billy, Frank and Tom McLaury, Billy Claiborne along with Sheriff Behan walked forward toward the Earp's gang. It was in the empty lumberyard close to the OK Corral. guess the sides were at very close range and Virgil Earp commanded the Cowboys to



Billy Clanton shot at Wyatt. The next shot was Tom McLaury hit Morgan Earp in the back. Then Tom turned to run and Doc Holliday fired his shotgun, both barrels, into Tom McLaury's side. He went a few feet and fell dead. Doc threw aside the shotgun

and drew his six guns. The fighting continued with Billy Clanton and Frank McLaury both wounded but still firing. One of them hit Virgil in the calf. Frank and Doc squared off and Doc got hit in the left hip but his holster deflected most of the power of the shot.

The firing continued with both Doc and Morgan firing at Frank. Both claiming they fired the killing shot.

The shooting kept up until Billy Clanton finally went down with a shot in his breast. He was crying out for more cartridges when he died. Virgil thinks he fired the fatal shot.

Folks figured that about 30 rounds were fired in about 18-20 seconds and the killing was over.

In the middle of the fray, Ike Clanton hollered that he was unarmed and Wyatt said to "get out or get to firing." Billy Claiborne also claimed he was unarmed and left the scene. Whether these men were unarmed or not is still debatable.

On The Cowboys side three men were killed: Frank and Tom McLaury and Billv Clanton. On the Earp's side, Morgan had been shot through the back near the shoulder blade and Virgil had been shot through the right calf.

Following the battle there was an inquiry hearing about the Earp's, a lot of testimony and hair splitting on the legality of the Earps. Many accusations and even fabrications of the truth according to whose side you were on. You see, most people backed the Earps, but a lot of the town folks and businessmen liked The Cowboys. At the end of the Spicer Hearing the Earps were acquitted. This didn't set well with the Clantons or The Cowboys.

A few weeks after the hearings, Virgil Earp was shot by some hidden assailants at night, wounding him in the right arm and it was rendered useless from then on.

Then three months later, Morgan Earp was murdered by a shot in the back from some men hiding outside in the dark.

After these incidents, Wyatt and Doc and several friends went on what was called Earp's Vendetta Ride. They took a few weeks and lived in The Whetstone Mts. And chased down and killed everyone who was suspected in the shootings of Virgil and Morgan.

After the Vendetta Ride, which some folks claimed was nothing short of murder, the Earp Gang split up.

Doc Holliday died of TB in Glenwood Springs, Colorado.

Virgil Earp served as a Town Marshall in Colton, California. He served very well even though his one arm was useless.

Wyatt Earp traveled over the country as a professional gambler. He spent a lot of time with the movie makers. He died of infection in 1929 at the age of 80.

Johnny Behan never got re-elected for Sheriff of Cochise County.

Billy Claiborne got shot by Frank Leslie in the streets of Tombstone following an argument.

Some people still take sides in this affair just like the Civil War.

SPRING INTO GARDENING PART I

By: Jim Lopshire, Extension Educator

With temperatures reaching 60 plus degrees this past week, spring will soon be here. But, we all know that we are still in winter and that as quickly as it gets warm on a winter day, it will just as quickly turn cold again. So what is a gardener supposed to do when they are just itching to get outside? Well, now is the time to plan for the coming growing season.

Rosie Lerner, Extension Consumer Horticulture Specialist at Purdue, suggests a stroll through garden catalogs with all their promise of gardening to prepare for the growing season. She has put together a list of a few new seed company offerings for 2009 to review below. Each letter following the explanation identifies the company seed catalog with the new variety.

Basil 'Cardinal' is a strikingly handsome addition to the herb garden, with spicy, fragrant foliage crested by tightly packed clusters of deep cardinal-red flowers, resembling Celosia. Plants reach up to 2.5 feet in height. (B)

Beet 'Chioggia Guardsmark' has striking, alternating spiral stripes of bright magenta and white, forming a bull's-eye when cut in cross section. Promising sweet, mild flavor, hybrid vigor and large, 3-3.5-inch globular roots. 60 days. (P)

Cabbage 'Caraflex' is a unique, pointy-headed compact early selection. Cucumber 'Iznik' is a new hybrid "lunch-box"-sized cucumber, reaching just 3-4 inches long. Plants are compact vines with small leaves, perfect for container and raised-bed gardening. (C)

Eggplant 'Gretel' is a follow up to the 2008 awardwinning 'Hansel.' 'Gretel' is the earliest of the white eggplant, bearing clusters of glossy mini-fruit (3-4 inches). Gretel' plants are relatively small, about 3 feet wide and tall, making them well adapted to container gardening. 55 days. All-America Selections 2009 (Jo, P)

Watermelon 'Snack Pack' is a "personal-sized" watermelon of 3-4 pounds, about the size of a large muskmelon. Thin, dark green outer rind surrounds a bright red, crisp and juicy, seedless flesh. 75 days. (B)

Melon 'Lambkin' was selected for its early production of outstandingly sweet, aromatic, white, juicy Christmas-type melons. Each ovalshaped fruit weighs between 2-4 pounds with a thin yellow skin with green mottling. Ready for harvest up to a month before other Christmas-type melons. 65-75 days. All-America Selections 2009 (Ju, P, S)

Melon 'Twice As Nice' is a new sort of dual-purpose melon. You can harvest a bit early when the rind turns a distinct dark yellow and enjoy the crisp, sweet white flesh. Or, allow the fruit to stay on the vine another week or two and enjoy a softer-textured, juicier melon. 78 days. (B)

Onion 'Deep Purple' is a dark red bunching- (scallion) type onion that colors up early and holds its color into warmer weather. 60 days. (Jo) (B) Burpee Seeds, http://

PASSENGER RAIL ON TRACK TOWARD DISASTER

Guest Column From Representative Lynn R. Wachtmann

With the recent passage of the state transportation budget bill from the Ohio House of Representatives, there has been much discussion about the merits and drawbacks of the governor's proposal. As your elected state representative and your voice in state government, I will continue to represent the interests of the 75th House District in all deliberations and proceed-

ings The transportation budget encompassed a wide range of issues, including the establishment of an automated speed enforcement system and a primary seatbelt law. However, none of the bill's provisions have drawn the amount of controversy and debate as the governor's plan for a high-speed passenger rail that would connect Columbus, Cincinnati and Cleveland. The "3-C Corridor" is the most denselypopulated region in Ohio, with nearly 60 percent of Ohio's population residing in this stretch of land. The \$250 million plan would work in conjunction with Amtrak to revive an industry that has been dormant in Ohio for almost 40 years. Currently, Amtrak is in the process of conducting a survey on the potential costs and ridership, which is expected to be completed in August. My fellow Republican representatives and I had serious concerns with the governor's original proposal, which cre-

ated the rail system without looking at the results of the study. We agree with the importance of keeping Ohio a competitive market and the goal of job creation in the state. The question is whether our state should spend such an exorbitant amount of money without knowing if a passenger rail system would

be a profitable endeavor. Ohio is facing an enormous budget deficit during the upcoming fiscal years, and everyone from state agencies to families will feel the effects of budget cuts and increased taxes and fees. The passenger rail would require an ongoing state subsidy, but my colleagues and I aren't yet sure of how steep the subsidy would be or what effect it would have on taxpayers. We advocated that instead of jumping blindly into an irreversible project, we wait until we have all available information to make an informed decision. With the financial amount that we are asking our constituents to sacrifice, embarking on a multi-million dollar project without adequate study would be shortsighted and reckless.

The transportation budget did pass the House with the stipulation that a study on the rail system be conducted first. Unfortunately, the governor has found a way to push the 3-C rail plan into effect regardless of the state legislature's decisions. Members of the Ohio House and Senate traditionally have deliberated on all large financial decisions in which funds are drawn out of the state treasury, which provided opportunity for public input through the committee process. However, the governor has given the State Controlling Board full authority to approve of the rail system without the approval of the legislative bodies. The Controlling Board, which is Democrat-controlled, is a small quasi-legislative board that handles minor financial transactions of the state, but it was not designed to make decisions regarding sizeable appropriations. This tactic would allow the governor the ability to bypass a House or Senate vote and avoid public involvement in the decisionmaking process.

We as state legislators have a responsibility to provide our constituents with transparency and accountability in every decision we make, because in the end it is the taxpaying citizen who ends up paying the price for our poor decisions. I hope to one day see Ohioans connected by an efficient, statewide rail service, one that would produce growth in many local communities. However, without Amtrak's preliminary analysis figures that show a positive return on the project, I am not willing to use my constituents' hard earned money to gamble with Ohio's future. Furthermore, the process should be conducted within the public forum of the General Assembly. As always, I welcome your views on all state issues. 

LET'S HEAR IT FOR 1944!

Paulding County Auditor, Susan K. Simpson wants to recognize everyone born in 1944. She also wanted to remind all Paulding County homeowners born in 1944 to sign up for the Homestead Exemption program.

In 2007, the new expanded Homestead Exemption program became law. The law provides additional property tax relief to homeowners age 65 and older, and to permanently and totally disabled Ohioans. In the past, the homestead exemption was open to only those senior citizens that met a specific income test, but that income test has been eliminated. Also, if you missed filing last year, you can file a previous year application and current year application.

You can receive an application by calling the Paulding County Auditor's Office at 419-399-8205. An application may be mailed to you or you can stop in and pick one up at the courthouse. Office hours are 8:00 a.m. - 4:00 p.m., Monday through Friday (Good Friday closing at noon and closed Memorial Day).

If you are a Paulding County homeowner born when the cost of a gallon of gas was 15 cents, a loaf of bread was 10 cents, the average cost of a new home was \$3,450, and sunscreen was invented, you may be eligible. It was also the year WWII: Battle of Normandy began. Operation Overlord, code named D-Day, commenced with the landing of 155,000 allied troops on the beaches of Normandy in France which signaled the end of the war. Šo, remember if you were born in 1944 you may be eligible to apply for the new Homestead Exemption program, signup deadline is June 1, 2009. Sign up today!

OSU EXTENSION REORGA-NIZES

By: Suzanne Steel, Communications and Technology

Due to state budget reductions, Ohio State University Extension is reducing its workforce and reorganizing operations.

"Despite a proven track record of serving Ohioans effectively for 95 years, OSU Extension must reduce its workforce and expenses to align with declining state and local revenues. We know this loss of income in no way reflects our value. Yet, given the incredibly difficult economy, we, too, are called to sacrifice," said Keith Smith, director of OSU Extension and associate vice president of agricultural administration at Ohio State.

The reorganization will be based on a strategic plan OSU Extension completed in 2008, but will be implemented with fewer people than originally intended.

We set out to reorganize our work in a way that ensures we can continue providing high-quality services throughout Ohio, and be positioned to succeed when the economy improves," Smith said.

Extension is key to economic development and job creation throughout the state, Smith said. As noted in a 2005 Battelle study, OSU Extension plays a critical economic role, applying the latest research to Ohio's most important industry, the AgBiosciences. According to the study, every one percent increase in agricultural production as a result of Extension programming brings \$149 million worth of output to the state, and creates 2,712 jobs. Extension itself helps create more than 1,900 jobs, \$64 million in income, and \$4.8 million in state taxes annually.

"We maximize food production and safety and stretch precious health care dollars efficiently through special prevention efforts, and we protect and improve the environment in literally every county," Smith said. "We serve 320,000-plus 4-H youngsters in cities and villages across the state, improving their educational outcomes to increase their chances of attending college. In fact, by grade 8, 4-H youth are 1.6 times more likely to attend college than their peers."

The reorganization pools resources into nine areas in the state and deploys technology to increase efficiency. County-based Extension educators will now serve Ohioans

will recognize our critical economic impact and protect us from additional cuts as they finalize the next biennial budget," he said.

USDA WILL RESTORE AND PROTECT FLOOD-PRONE LANDS IN OHIO WITH ECONOMIC RECOVERY FUNDING

U.S. Department of Agriculture (USDA) Natural Resources Conservation Service (NRCS) will provide up to \$30 million to eligible landowners in Ohio through the floodplain easement component of its Emergency Watershed Protection (EWP) Program, State Conservationist Terry Cosby announced March 10, 2009. The funds will be used to restore frequently flooded land to its natural state and create jobs.

Cosby also announced that eligible landowners can sign up for these easements from March 9-27, 2009, at their local USDA Service Center NRCS Office.

"We will be working with landowners who voluntarily agree to restore the floodplains to their natural condition by placing their land into easements," Cosby said. "These easements will convert environmentally sensitive lands into riparian corridors and wooded bottomlands that are so vital for fish and wildlife habitat and to mitigate downstream flooding."

Cosby said green jobs can be created in rural communities across Ohio when landowners establish conservation practices on the land entered into easement. Jobs will be created mostly in the engineering, biology, and construction fields when trees and native grasses are planted and the hydrology of the floodplain is restored.

The funding, obtained from the American Recovery and Reinvestment Act of 2009, includes both technical and financial assistance to restore the easements. All funds will be spent on targeted projects that can be completed with economic stimulus monies. The goal is to have all floodplain easements acquired and restored within 12-18 months.

The EWP Program's floodplain easement component allows the NRCS to purchase easements on lands damaged by flooding. The restored floodplain will generate many public benefits, such as increased flood protection, enhanced fish and wildlife habitat, improved water quality, and a reduced need for future public disaster assistance. Other benefits include reduced energy consumption when certain agricultural activities and practices are eliminated and increased carbon sequestration as permanent vegetative cover is reestablished. 





PAULDING COUNTY HAS BEEN AWARDED FED-ERAL FUNDS UNDER THE EMERGENCY FOOD AND SHELTER NATIONAL BOARD PROGRAM

Paulding County has been awarded \$12,126 to supplement emergency food and shelter programs in the coun-

The selection was made by a National Board that is chaired by the Federal Emergency Management Agency and consists of representatives from the Salvation Army; American Red Cross; United Jewish Communities; Catholic Charities, USA; National Council of the Churches of Christ in the USA; and, United Way of America. The Local Board was charged to distribute funds appropriated by Congress to help expand the capacity of food and shelter programs in high-need areas around the country. A Local Board made up of Paulding County representatives will determine how funds to Paulding County are to be distributed among the emergency food and shelter programs run by local service agencies in the area. The Local Board is responsible for recommending agencies to receive these funds and any additional funds available under this phase of the program. The Local Board will meet Friday April 1, 2009 at the United Way of Paulding

County office.

Under the terms of the grant from the National Board, local agencies chosen to receive funds must; 1) be private voluntary non-profits or units of government; 2) have an accounting system, 3) practice nondiscrimination, 4) have demonstrated the capability to deliver emergency food and/or shelter programs, and 5) if they are a private voluntary organization, they must have a voluntary board. Qualifying agencies are urged to participate and must request an application by Friday March 27, 2009.

Paulding County has distributed Emergency Food and Shelter funds previously with Center for Child and Family Advocacy, YWCA of Van Wert, St. Paul United Methodist Food Pantry, Grover Hill Food Pantry, Pioneer Christian Ministries Food Pantry, Antwerp Christian Food Pantry, and Northwestern Ohio Community Action Commission participating.
