State Senator Steve Buehrer (R-Delta) issued the following statement in response to the passage yesterday of House Bill 1—the state operating budget for fiscal years 2010-2011.

"I voted against the state budget bill because of the broad language which will support Governor Strickland's expansion of gambling in Ohio. I think the Governor's plan to expand gambling is poorly constructed and bad for our

"Furthermore, this budget is bad for Ohio's schools in that it creates more mandates for local districts, relies too much on one-time money and makes future funding unpredictable for the state and local districts.

"Unfortunately, even in difficult times, the Governor's plan is not the budget to turn around Ohio and grow jobs."



BLOSSOM END ROT OF TOMATOES

Several vegetable gardeners have recently contacted our office with a tomato problem. They report that their

plants are growing well, with healthy green leaves. But, the fruit has a large brown to black rotten spot on the blossom end of the fruit. Welcome to the wonderful world of "blossom end rot." Blossom end rot is most

commonly found on toma-

toes, as well as zucchini and other summer squashes. Blossom end rot is caused by a lack of calcium in the fruit. More often, there is plenty of calcium in the soil, but it's the availability of calcium for uptake by the roots and transporting to fruit that is impaired. Calcium is an "immobile

nutrient" meaning that it does not move easily within the tomato plant. The slightest impediment to water movement within the plant will lead to limited distribution of this major element. Leaves are the primary location where water is used before it is lost through transpiration. Under high moisture stress, water containing calcium and other minerals moves rapidly to the leaves but not to the fruit.

This lack of calcium in the fruit results in a localized deficiency. So "blossom end rot" is a calcium deficiency in an area of rapid growth at the end of the fruit. This lack of nutrients causes cells to collapse and produce the sunken-lesion symptom of blossom end rot.

The symptoms begin as a water-soaked spots at the blossom end of immature fruits. These spots rapidly enlarge, becoming shrunken and leathery on the surface and dark brown to black in color. If you catch the fruit before secondary invaders take over or if they ripen before this occurs, the fruit are perfectly edible. Cut away the affected portions and make fried green tomatoes, or use ripe ones in any normal man-

Management of blossom end rot includes adequate and even moisture to the plants by watering or irrigating as needed and to consider mulching to conserve soil moisture. Take a soil test to determine if the calcium and other nutrient levels are adequate. If lime is required use high calcium lime, not high magnesium lime. If lime is not required, but calcium is low, gypsum will supply calcium without raising the pH. Grow vegetable cultivars that are tolerant of calcium deficiencies and less likely to show blossom end rot symptoms. Finally, the use of foliar applications of calcium, which are often advocated, are of little value because of poor absorption and movement of calcium within the plant and especially to the fruit where it

State legislators have heard your voice! Since June 19, the Ohio Statehouse has been inundated with calls from library supporters. Apparently, support for libraries topped any other issue that this legislature has seen in recent history. In a three day period, over 25,000 calls came into the switchboard overwhelming their phone capabilities. Library funding was cut, but not as much as the Governor had first proposed. It looks like the Public Library Fund (PLF) will take an 11% cut. This is in addition to the 20% cut that was announced mid-year due to projected lower revenue. What is very disturbing,

however, is the possibility that the library funding formula will be reduced from 2.2% of the General Revenue Fund to 1.97%. Although the word "temporary" has been used to describe this potential decrease, "temporary" has historically meant "permanent" when it comes to library funding. Our work is not over. The 31% cut still impacts Paulding County's libraries dramatically and has forced the Board of Trustees to make some tough decisions regarding library hours

The next step for advocacy on the local level will be helping the library get the word out about the fall levy. There will be a meeting of library supporters on Tuesday, August 11 at 6:00 p.m. at the main library in Paulding. This meeting will outline strategies for advocacy at the state level as well as answer questions about November's library levy. Passage of the levy will be crucial for the future of library service in Paulding County. All Paulding County citizens are invited to attend. If you love your Paulding County Carnegie Library system-with full-service locations in Paulding and the Villages of Antwerp, Oakwood and Payne—or can't imagine our county without a strong library system, please mark your calendar and attend this important meeting. The library needs your help today in order to insure a strong li-





BUDGET BAD FOR OHIO'S Future

Weekly Column by: Senator Steve Buehrer

On July 13, the General Assembly approved House Bill 1—the state operating budget for fiscal years 2010-2011. After weeks of negotiations and heated debate between the Governor, House and Senate about several key policy areas, as well as a proposal to put slot machines at Ohio's horse tracks, the budget was sent to the Governor. While I appreciate the hard work and long hours put in by many of my colleagues to reach a consensus, I voted against the bill, because I believe it is bad for our schools, bad for Ohio families and bad for the financial stability of

On June 19, Governor Strickland unveiled a "balanced budget framework" for fixing an estimated \$3.2 billion hole in state revenue over the next two years. The plan included \$2.4 billion in cuts to state programs and services and, despite his repeated opposition to gambling, an expansion of the Ohio Lottery to install video lottery terminals, or VLTs, at Ohio's seven horse-racing tracks to raise \$933 million. The controversial proposal led to a stalemate in the budget process that pushed negotiations past the June 30 deadline and forced the Legislature to pass

three seven-day continuing budgets to keep state government running.

The Governor insisted that he needed legislative approval to implement his VLT plan. Senate President Bill Harris, on the other hand, countered that any expansion of gambling in Ohio should go before voters, who have rejected gambling initiatives four times since 1990. However, President Harris maintained that if the Governor wanted to move forward with VLTs without a vote of the people, he had the authority to do it through executive order like he did when he expanded the Lottery last year to include Keno at bars and restaurants.

Concerned about the impact that the Governor's VLT plan could have on Ohio's schools and the future of our state's budget, the Senate organized public hearings earlier this month to gather information and study the issue. Testimony from the Strickland Administration, Lottery officials, horse track owners, representatives from the horse racing industry and other stakeholders revealed a number of major questions and concerns.

For instance, the VLT language that was presented to the Senate included a "clawback" provision that would have allowed track owners to recoup \$455 million in license fees if a separate casino ballot issue passes in

COUNTRY INN RESIDENTS ENJOY NEW RAISED GARDEN BEDS



A recent clear, mild day brought volunteers to Country Inn Enhanced Living Center to install two raised garden beds for the residents to enjoy. The day started with Paulding County Master Gardeners and other volunteers unloading and building the two foot high wood structures. Each of the two garden beds were four foot by eight foot with seat extensions on each end. The raised features allowed handicapped residents to remain in wheelchairs to attend the gardens.

Employees, residents and their families are enjoying the gardens which were put into the interior courtyard near the gazebo.

November. There were also concerns raised that the Administration's revenue estimates for VLTs were too generous, legal challenges could delay implementation of the Governor's plan and track owners were being handed a lucrative gambling monopoly, while the racing industry was getting shortchanged in the deal. In fact, the CEO of MTR Gaming, which owns Scioto Downs in Columbus, estimated that the track could turn a \$30 million profit with the addition of video slots. At the same time, two horsemens' groups testified that the four percent return proposed for horseman under the Governor's slots plan was too low compared to other states.

In response, President Harris proposed placing a constitutional amendment on the ballot in November to allow Ohio voters to decide on the VLT issue. The amendment's language addressed many of the concerns that arose during the Senate's VLT hearings, and also included a provision to require that VLT licenses be competitively bid. However, the Governor quickly rejected this commonsense proposal.

The back and forth between the Governor and the Senate continued for several days until, on July 10, the Governor finally determined that he could move ahead with his VLT plan through executive order. At the Governor's request, House Bill 1 included language that sets parameters for placing slot machines at Ohio's horse tracks.

I voted against HB 1 because the Governor's plan is poorly-constructed and the

VLT language included in the budget is too broad and still leaves a number of questions left unanswered. For instance, while I received phone calls from horse enthusiasts and representatives from Ohio's agriculture community urging support for VLTs at racetracks, the Administration's VLT plan is still inadequate and unclear about how much revenue would be directed for purses, trainers, riders, breeding programs and other areas of the horse-racing industry.

I also opposed HB 1 because it is bad for Ohio's local school districts. The final version of the bill implements several aspects of Governor Strickland's evidencebased school funding model. While he touts his plan as an "unprecedented investment in Ohio schools" that will "transform Ohio classrooms," there is little about the Governor's proposal that is "unprecedented" or "transformative." Under his plan, 427 school districts are projected to receive less state aid in fiscal year 2010 than they received in fiscal year 2009, and 333 districts are projected to receive less state support in fiscal year 2011 than they received the previous year.


The proposal also places costly new mandates on local school districts without additional state support and relies heavily on one-time federal money for education over the biennium. The Governor promises billions of additional dollars over the next decade to pay for his education reforms, but he has yet to identify a way to pay for it.

In addition, I voted "no" on HB 1, because the bill

implements several health insurance mandates that could significantly drive up costs for small businesses and Ohio consumers. These include an expansion of Ohio's open enrollment program that could raise insurance premiums for average Ohioans, a requirement that private insurance companies offer coverage for dependent children up to age 28 and a mandate that certain businesses provide "cafeteria" health insurance plans for their employees.

At a time when Ohio families and businesses are struggling, the Governor's plan is not the budget to turn around Ohio and grow jobs. This budget is defined by lofty promises from the Strickland Administration—the promise of additional funding for schools, the promise of millions of dollars in gambling revenue from VLTs-and is weakly held together by billions in one-time federal and state money. I could not support a proposal that makes future funding unpredictable for our local school districts, raises costs on businesses and families and sets our state up for failure in two years.

ANTWERP HISTORY

By: Stan Jordan

We have a few lines from a journal of John Lincoln. He was a doctor for the area. He built a log cabin, 16x20 with a ground floor and a chimney of sticks and clay. This lot is the second one on the north side of West Canal, from South Main.

When I was a boy that was the home of Charles Traylor. The first house on that side of the street was owned by John Radenbaugh.

Dr. Lincoln stated that the canal boat, Eagle, stopped here last night and the canal froze over during the night and that was December 14, 1844. That is the first date that I ever heard of the canal boats

Mr. and Mrs. Lincoln returned from Payne and she stayed with Isaac Woodcox for a few days. You see, Mr. Woodcox operated a tavern by the canal at the very end of South Main Street, that was April 16, 1846. Then their baby was born, Thomas Wentworth Lincoln, the first baby born in Antwerp.

In 1844, Antwerp consisted of one store, two taverns, two physicians, two log cabins for dwelling and one other cabin unfinished. All the ground from the canal to the Maumee River was big huge timbers and later they are what brought the factories to Antwerp.

In 1860, the first stave factory was started and operated until 1875. When all the good timbers were used up the factory was forced to move north. This factory was on the north side of the canal on West Canal Street about where Rev. Jim Edwards now lives. I remember for years that a small white building sat in that area, and it was the office of that stave factory. Over the years that building disap-

The Saylor Hoop Mill was located on the south side of the canal between Main and Cleveland Streets. That would be over on Buffalo Street about across from Doctor Grav's office.

Jake Saylor came to this area in 1835. He was a very influential man as he helped build the Wabash and Erie Canal and he assisted in getting the railroad into town. He married a daughter of General Horatio Curtis in

Gay's Bucket Factory was located just east of town on the Canal Road a little east of the Water Plant Road on the south side. When I was a boy some of the foundation was still there and I think Mr. Nick Deager farmed that spot. It was one of the largest bucket factories in the state. It employed about 85 men and turned out 1,500 buckets daily. Lots of items came in buckets: candy, tobacco, dried vegetables, and they were used for storing. When the cottonwood timber was gone the factories closed up in 1887.

Munsons Hoop Factory was situated on the south side of Canal over on Buffalo Street. It went out of business in 1880. No timber or sales.

There was an oar factory east of town on Canal Street on the north side just about across from Pudge Kennedy's barn. They made oars of all



by a national lobbyist group that has progressively spread its policies across the country

months, the Humane Society of the United States (HSUS) has been barraging the Ohio Legislature with demands for radical changes to livestock husbandry practices that would be difficult for many local farmers to adjust to financially. Specifically, this special interest group, which is entirely unaffiliated with local humane societies, has demanded Ohio's adoption of stern mandates for larger and consequently costlier crate sizes, which could easily drive

much of our agricultural industry out of business or out of the state entirely.

For a group of political activists to raid Ohio and threaten to circumvent the legislative process is ludicrous and ignores our state's consistently successful farming practices. Without doubt, Ohioans know their own agricultural climate best, whether they are Ohio farmers, veterinarians or agricultural agency representatives. I believe that allowing out-of-state lobbyists to create mandates on Ohio's industry is unacceptable, and a conversation needs to take place between consumers and farmers. To accomplish this goal,

members of the Ohio House and Ohio Senate have passed a resolution for the creation of a specialized livestock board to establish standards for livestock care. House Joint Resolution 2, jointly sponsored by Representatives Margaret Ann Ruhl (R-Mount Vernon) and Allan Sayre (D-Dover), would create a committee to enforce guidelines regarding food safety and production, biosecurity and livestock wellness.

Members of the board will have a wide range of skills and expertise, ranging from veterinarians to consumers. The initiative, which will be added to the November 2009 ballot, is a crucial step toward maintaining control over our own agricultural practices and ensuring that Ohio's consumers and farmers have a voice. If changes in Ohio's farming practices need to happen, they will come from Ohioans themselves, not from Washington.

Farming is the prevailing livelihood here in northwest Ohio, and I was proud to vote in favor of this motion. With the majority of the 75th district dominated by rural farmlands, it is my obligation and privilege to preserve our region's agriculture. We can-

not afford to lose any more jobs by driving vital industries out of state and it is absolutely necessary that Ohio remains a business-friendly environment. I remain committed to implementing state policies that benefit Ohio's agricultural industry and I will continue to do all I can to protect our family farms, while working with the needs of consumers.



REPRESENTATIVE WACHT-MANN ANNOUNCES END OF BUDGET DEADLOCK

State Representative Lynn Wachtmann (R- Napoleon) today announced the Ohio House of Representatives passed House Bill 1. The \$50.5 billion, two-year state operating budget passed the Ohio House by a vote of 54-44, with Wachtmann in opposition.

Today, the House voted to accept the changes made

by a six-member legislative conference committee, nearly two weeks past the July 1st deadline. The committee was tasked with closing a \$3.2 bil-

lion deficit after Governor

Strickland's administration

announced a steep decline in

state revenues in June.

"The Senate Republicans have done wonders in improving House Bill 1, but we were still presented with a budget that left much to be desired,"

said Wachtmann.

The measure still contains items for which House Republicans have repeatedly raised objections. The plan is Governor Strickland's framework which includes \$4.3 billion in one-time revenue sources, with approximately \$2.2 billion in temporary federal funding; institutes more than \$1 billion in fee increases which the governor has previously equated to a tax increase; and paves the way for the governor to expand gambling in Ohio with slot machines.

"The use of one-time funds in this budget will only lead to disaster in two years when it's time to determine the next budget," Wachtmann said. "I expect to see a number of tax increases down the road stemming from the entitlement attitude we've provoked in Ohioans who will now come to expect these sources of one-time revenues to correct the problems we've chosen to deal with later. If we continue to use one-time money to fix our problems instead of looking for real solutions, then we place Ohio in a precarious position with an unstable budget."

House Republicans have continually called for measures to be added to the budget that would stream-
