US 24 IS A CON-STRUCTION AREA **NOT A SNOWMOBILE** TRACK

It may be a wide-open, tempting area for snowmobilers, but the new US 24 in Paulding and Defiance counties is off limits until the highway is opened to traffic.

"New US 24 is a construction area and is not a public roadway. It is against the law for anyone not associated with the project to be on the property," said Tim Burkepile, Ohio Department of Transportation District 1 deputy director.

With the recent snowfalls, project personnel have noticed an increase in snowmobiles and all-terrain vehicles running throughout the construction site. "We currently have a fencing contractor working on the US 24 project. They are installing barbed wire fencing which is easily camouflaged in the snow. Not only is it illegal to be on the project, it is also dangerous," said Burkepile.

Construction materials are stored throughout the project and there are also many excavated areas filled with water. "The snow hides these dangers from snowmobiles or ATVs on the closed right-of-way," said Burkepile.

Ohio Revised Code 4511.71 states: "No person shall drive upon, along, or across a street or highway, or any part of a street or highway that has been closed in the process of its construction, reconstruction, or repair, and posted with appropriate signs by the authority having jurisdiction to close such highway.'

Although I retired from the position of Superintendent and CEO of the Vantage Career Center nearly a year and a half ago, a part of me will always be there. Serving Vantage was certainly the highlight of my professional career. I know firsthand that high school students and adults in our area have the opportunity to gain skills that make them competitive in the workplace and at the post-secondary level because Vantage exists. Recently, I sent a letter to State Senator Steve Buehrer seeking his help. I would like to share parts of that letter with you.

First, I thanked him for our new US 24 that will be opening later this year and told him that we are getting more excited about it as time goes on. I also shared with him that several people in the community have mentioned that it would be nice to have a "community day" before the highway is officially opened. A time when area residents would be allowed to walk, ride their bicycles or drive their golf carts along a stretch of the highway.

Second, I shared with

him how our former mayor, D. Louise Miller, was active with the "Fort to Port" project from the beginning. She was present when Antwerp hosted the ground breaking ceremony on June 10, 2007, but has since passed away. I proposed to him that the bypass around Antwerp be named the "D. Louise Miller Thoroughfare." I believe that it would be a fitting memorial to her hard work.

In response, I did receive a letter from Senator Buehrer saying he "always appreciates hearing from the citizens of Northwest Ohio." He also said that he is supportive of having a community day such as I described and said he would be in contact with Kirk Slusher of ODOT concerning the matter. Also, he said, "As far as

naming the by-pass the 'D. Louise Miller Thoroughfare,' I will keep the idea in mind as the new General Assembly begins in January..." Now, I'm asking your help.

If you agree with my proposal, and since Senator Buehrer likes to hear from us, would you send him a note concerning this matter. I have shared this information with the Antwerp Chamber of Commerce and they too, individually will be sending letters. Together we can make this happen.





CAUV FILING TIME NEARS

County Auditor Susan K. Simpson announced that Current Agricultural Use Value (CAUV) renewal forms have been mailed out, and reminded those currently enrolled AND those wanting to enroll for the first time to file their information before March 2, 2009.

By Ohio law, CAUV applications are to be filed with the County Auditor's office by the first Monday in March, which this year is March 2, 2009. Applications must be renewed each year and annual renewals are free, but there is a filing fee for a new application. If forms are not received by March 2, 2009 the Auditor will be required to value the property at its market value and recoup the tax savings for the past three years. The new land value will most likely increase your property taxes.

CAUV has been the law in Ohio since 1982. It is a statesponsored, county-implemented application program. It allows the County Auditor to value farmland at its crop production value rather than its highest and best use value. It also protects the farmer from paying unnecessarily high property taxes for farmland and encourages farmers to keep their land in agricultural production.

Intelligence Briefing for Military & Police Forces

The final segment of this article is directed to police and military officers at all levels. It is as though roll call was underway and the orders of the day issued. I ask that you read this carefully and let it become a part of your standard operating procedures manual of the heart. Your response to this will nelp decide the ultimate fate of our nation. As sworn officers and oath bound military men and women, you are under the lawful order doduring the Nuremburg Tribunals of 1945-48. That body decreed to all men and women under arms that merely obeying orders of any kind was not an affirmative defense for actions taken in combat or against civilian populations. The benchmark that was established was, if the "order" was criminal in nature or "required" the affected forces to commit an act they knew was or suspected to be criminal in nature, duty to disobey that order and in some cases seek the immediate arrest and prosecution of the ordering authority. That operational standard still exists and will be used should the occasion arise in the near future. Let me be VERY clear. If a police officer from any jurisdiction, private contractors hired to act as agents of the police, or a military member acting in an "official" capacity should carry unethical "orders" that violates the effected person's lawful rights, safety, security, or freedom, then the offending "agent" of government is liable in court both criminally and civilly. In the worse case situation, the offending agent may

be at the mercy of citizens who will not tolerate such abuse.

Resistance to such government actions by the citizenry in these situations for the preservation of life and peace is therefore justified in the extreme.

We are left then with this "future" to contemplate. Either intelligence will dictate that this nation's constitutional laws will be followed under all circumstances, or there will be severe consequences both immediate and long term. Be it known that NO police or military authority is exempt from safeguarding the American people from violations of their absolute rights and that all such authority must be lawful, constitutional, humane and fair.

That any officer of the law or of the military have as their first priority, the intelligent and judicious use of their power, and the full knowledge that the Republic of the United States and its people sponsible for their individual and collective actions in defense of the American people during times of crises from whatever cause.

Be it further understood, that no President, General, Judge, Governor, Attorney General, law enforcement official, legislator, public official at any level or animal control officer may violate civil rights, the Bill of Rights, the law, constitutional authority, or any other covenant with the American people for any reason including open warfare. Any such violation will be considered a violation of the official's oath of office and will be subject to civil and or criminal penalties.



Johnny Ringo was a cowboy who became a legend of the old west, mostly because of his affiliation with the Clanton Gang in and around Tombstone about the time of the fight at the O.K. Corral. He was considered a gun fighter, but no records show that to be true. But he did shoot a few unarmed men. Almost all people feared him for what he might do.

He was one of the gang of rustlers known as 'The Cowboys' in and around Tombstone. Some called him the 'King of the Cowboys' but by comparison his companion, Scott Cooley (former Texas Ranger) was more of a gunfighter than Ringo.

He was born John Peters Ringo in Green Fork, IN on May 3, 1850. His family moved to Liberty, MO in 1856. He was a contemporary of Frank and Jessie James and a cousin of Cole Younger. In 1856, the family moved to Gallatin, MO and rented property from John W. Sheets, who was the father of the first official victim of the James Gang when they robbed the Davis Country Savings Assn. in 1869.

On July 30, 1864, when the Ringo family was traveling through Wyoming headed for California, Martin Ringo, Johnny's father, while stepping out of a covered wagon with a loaded shotgun accidentally shot himself and the charge entered the right side of his face and exited the top of his head. The 14 year old Johnny and the rest of the family buried him on a hill beside the trail.

By the mid-1870's Ringo had left California and migrated to central Texas in the area around Mason County. Here he became a friend of an ex-Texas Ranger Scott Cooley. For years, the relations tween the American and German people of the area had been tense. Sort of an extension of the war while most Americans supported the Confederates the Germans supported the Union side.

Trouble started when two American rustlers, Elijah and Pete Backus were dragged from the Mason County Jail and lynched by a predominantly German mob.

Full-blown war began on May 13, 1875 when Tim Williamson was arrested by a hostile posse and murdered by a German farmer named Peter Bader.

Scott Cooley, his friends and Johnny Ringo, conducted a terror campaign against their rivals and this was called The Mason County War. Locally it was called the Hoodoo

War. Cooley retaliated by killing the local German deputy sheriff, John Worley, by shooting him, scalping him and throwing his body down a well on August 10, 1875.

Cooley already had a bad reputation but was respected as a Texas Ranger and would kill several others during 'The War'. After the killing of a Cooley supporter, Moses Baird, Ringo committed his first murder of note on September 25, 1875 when he and a friend named Bill Williams rode up in front of the house James Cheyney, the man who led Baird into the ambush. He came out unarmed and invited the boys in and began to wash his face on the front porch. Both Ringo and Williams shot him to death. The two rode to the house of Dave Doole, but he was armed and they fled back to town. Sometime later Scott Cool-

ey and Johnny Ringo mistook Charlie Bader for his brother Pete and killed him. After that both men were jailed in Bernet, Texas by Sheriff A. J. Strickland. Both Cooley and Ringo were broken out of jail by friends. Though after that they parted company to evade the law. Charlie Bader was un-By November 1876, the

Mason County War had petered out after costing over a dozen lives. Scott Cooley was presumed dead and Ringo and his pal George Glidden were locked up once again. One of Ringo's cell mates was the notorious John Wesley Hardin. Legend has it that Hardin was afraid of Ringo due to his ruthless ways and unpredictable temper.

Glidden was sentenced to 99 years and it seems Ringo was set free. Two years later it is noted that Ringo was a Constable in Loyal Valley, Texas. Soon after this he showed up in Arizona for the first time.

Ringo showed up in Cochise County in 1879. For the most part he kept to himself only mingling with the local element when it suited him.

In December of 1879, while Ringo was plenty drunk he shot an unarmed man named Louis Hancock in a saloon in Stafford, Arizona merely because Hancock refused a free drink of whiskey because he preferred beer. He survived the shooting.

Ringo had a bad temper and most people feared him. He usually pushed people as far as he could. He was a fast gun and most people avoided

Ringo did not participate in the battle at the O.K. Corral. Some movies put him

there but that's not true. In March of 1882 the Earps suspected Ringo had something to do with the murder of Morgan Earp, but no proof. The Earps went on a ram-

page or vendetta to avenge the murder in their family. The Earps killed without question anyone who had been tied into the ambush of Morgan Earp. Sheriff John Behan deputized Ringo to help capture

the Earps, but after they had killed all the men that participated in the killings of the Earps they fled to Colorado. All of this has been around Tombstone, Arizona. In recent years some of the facts and truths fell by the wayside.

The big movie makers did not

stick too close to the facts. In the movie 'Tombstone' it shows Doc Holiday killing Johnny Ringo. Well, that didn't happen. As near as I can find out, the truth is, he committed suicide. The following is the accepted way of Ringo's demise.

On July 14, 1882, Johnny Ringo was found dead in the crotch of a huge tree in West Turkey Creek Valley with a bullet hole in his right temple and an exit wound at the back of his head. His body had been there probably since the previous day. The area residents had heard a shot in that area the previous day. His boots were found tied to his saddle on his horse that was captured about two miles away. Most cowboys who slept outdoors would tie their boots to the saddle to keep the scorpions out of them. At the coroner's inquest it was officially ruled suicide.

All of this stuff happened nearly 130 years ago. There has been many writers who used their own ideas and in years later some people swear it is all true. It is a known fact that Johnny Ringo killed himself, but the following men claim to have done him in.

Some writers claim Earp and Holliday killed Ringothat's not so.

Lou Cooley claimed he shot Ringo about the same time as Earp and Holliday.

Some say Doc Holliday killed Ringo but that's impossible. Colorado Court records show that Holliday was in court on July 11, 14 and 18 so that proves Doc Holliday didn't do it, although Big Nose Kate had caused a lot of hate between the two men. She took up with Ringo when Holliday was pulling a jail sentence for carrying a

Another fellow, Buckskin Frank Leslie claimed he

"FROM THE VANTAGE POINT": VANTAGE KEEPS PEOPLE WORKING

Vantage keeps people working—the majority of people Vantage trains continue to live and work in the Vantage district. Vantage students, past and present, are people you meet every day as you run errands, get your car fixed, stop at a restaurant for a meal, or drop your child at daycare. Vantage students have learned how to make a living and we are proud of their successes.

What is the most difficult thing for most people to do? Right now it is to find work if you are unemployed. It is also tough to find the money to pay for additional training, although that is one of the best investments a person will make in their lifetime.

At Vantage Career Center, the most difficult thing to do right now is to ask voters for additional funding to renovate and expand the training facility. It's always hard to ask people for money or donations, especially in the plunging economy we are experiencing. But the need is great—and larger expenses will be coming for repair of the boiler units, roof, plumbing, and electrical systems. If the operating systems cannot be replaced with new, more efficient products, the costs will continue to rise. With almost 250 people on the payroll, Vantage serves our district's needs for high school

and adult workforce training. Over 450 students enter the building during the school day, and over 100 people are teaching or taking classes during the evenings throughout the year. Enrollment of the high school has remained solid for the past ten years. Adult training has increased by at least 15 percent in the past year.

Vantage has trained thousands of students in the past 33 years of its existence thanks to taxpayers who support workforce training. Vantage students support the economy of the towns they grew up in and neighboring communities because they have chosen to retrain rather than relocate. Renovating and expanding the building will allow people of all ages to continue to learn a skilled trade in a cost-effective manner. Maintenance costs will increase disproportionately as we "put out fires" instead of prevent them. That practice will be inevitable if the 1.2 mill bond levy doesn't pass on February 3.

Handicapped-accessibility in any public building is a huge asset and it is a necessity for the populations Vantage serves so frequently. The legal requirements of the Americans with Disabilities Act can be met by complete renovation. Several classrooms are upstairs in open lofts above the trade and industry labs. Students using crutches and wheelchairs cannot easily climb to their daily classroom. Restrooms at Vantage are also not handicapped accessible, which causes problems for

visitors and employees as well as students of all ages. The renovation of the facility will provide a totally handicapaccessible building.

Your support of the 1.2 mill bond levy on February 3 is crucial to upgrading the workforce in the community. The Van Wert area's capacity to train skilled employees for new industry is an important factor when decisions are made to settle a business in our area. Vantage cannot currently meet the demand for retraining in the health professions due to the small size of its current facility. Other courses are limited in enrollment due to smaller than average classrooms.

Without the public's support of the 1.2 mill levy, Vantage will forfeit over \$16 million from the state's Ohio School Facilities Commission to assist with the \$34 million renovation and expansion project. It is important to pass the bond levy now, while construction costs are the lowest seen in years. This also will increase the likelihood of completing the project under budget.

Our belief in the value of education we provide to adults and high school students leads us to ask the public for assistance—even in tough times. The deterioration of the Vantage facility will continue to limit the amount and quality of skilled workforce we can provide for the Van Wert community. A property owner with \$100,000 value will pay only \$37.80 extra per year, or 10 cents per day. Passing the 1.2 mill levy will make a difference in the lives of hundreds of people annually as they find gainful employment. The difference that extra \$37.80 per year makes in their lives will impact the well-being of our local economy. Please contact me at 419-238-5411 ext. 102 for more information.




