WCCH CHRISTMAS OPEN HOUSE

You are invited to a Christmas Open House at the Woodburn Christian Children's Home. Bring your family, bring your friends or just come by yourself. There will be tours and refreshments served. The Open House is scheduled for Saturday, December 5th from 2:00 to 5:00 p.m. and Sunday, December 6th from 2:00 to 5:00 p.m. All of the children and staff from the Woodburn Christian Children's Home hope to see you there. WCCH is located at 24902 Notestine Road, two miles east of State Road 101.

The Woodburn Christian Children's Home is a ministry of Christian Churches and Churches of Christ. Since 1972, this special home has provided a Christian family environment for children who are homeless or who have other special needs. Throughout these years about 200 young people (ages 6-21) have been

a part of our family. Some of these young people have been reunited with their families, some are in college and others have Christian families of their own.

The Woodburn Christian Children's Home is supported entirely by voluntary contribution. We receive no federal, state or county support. We are entirely dependent upon our private contributors whose strong support enables this ministry to operate on a cash basis.

WCCH operates very efficiently. Our cost of caring for a child is about half the average cost of similar child-care throughout the tri-state area. Children are evaluated for placement on a needs basis. Family participation is on a sliding scale. Over the years, numerous children have been accepted for placement even though their parents had little or no ability to pay. —Daniel Grant, WCCH





Today, we continue our study of John Calvin's doctrinal beliefs found in "The Institutes of the Christian Religion" and how unscriptural these doctrinal beliefs are. Loved ones, as I have said many times, study the Bible. Let the Bible speak and don't follow the doctrines or teachings of man in their creeds, manuals, church covenants, the statement of fundamental truth, and there are many more creeds. The Bible has all we need and especially the New Testament, as to how we can be saved, how to conduct our worship, how to govern the church, just to name a few.

Now to the third of five of John Calvin's teaching. Today we are looking at 'limited atonement':

Calvinism teaches that since God has elected only a portion of the human race to be saved, then Christ did not die For all, but only for the elect. As I study the New Testament and you can do this too, the Bible says different.

The first scripture verse we can look at is John 3:16. There is no sweeter verse in the Bible. This shows that God is love that He loved the world so much that He, God, allowed His son to die for all men; this includes everybody. To free all who

believe and obey Him, from their sins. I would ask that you study

these scripture verses: 1 Timothy 2:3-4; 2 Peter 3:9. These are some powerful verses against limited atonement. I am letting the Bible speak, not me, but I agree with what the New Testament is saying in these verses lest I find myself arguing against God and Christ!

Here is some more scripture verses from the New Testament: 2 Corinthians 5:14-15; these verses teach that Christ died for all men, hmm. Hebrews 5:9 tells us that Christ being made perfect became the author of eternal salvation unto all them that obey Him: being the author means Jesus was able to offer the Gospel to all nations and would save all who obey Him.

Now that the New Testament has shown you the truth about limited atonement, will you help those who are trying to restore people back to the truth of what the New Testament teaches, and the one true church?



These programs have not only given the farmers new practices and skills to help them make a living but it has offered our youth a lifetime of skills, memories and friendships through 4-H. However, it is this day that Extension reaches out to you, asking you to help Paulding County.

The Paulding County OSU Extension provides programming in 4-H Youth Development, Agriculture and Natural Resources, Family Consumer Sciences, and Community Development. None of these services will continue if the Extension office is closed. How could losing the Extension office affect you? Do you have kids? Over 270 local youth participate in the 4-H program and 100 of those children attend 4-H camp. Do you or someone you know farm? More than 200 farmers annually attend agricultural and livestock programs for the latest in research information and updates in production agriculture.

The Paulding County OSU Extension Office needs your financial support to keep our office open and continue to assist our community. Historically, the financial funding of the Extension program was based on an agreement between the County Commissioners and The Ohio State University Extension. The immediate goal of the committee is to raise sufficient funding to keep the Extension office open at this time. Your contribution would provide the local funding needed in order to receive the state and federal funding, thus allowing the office to operate in 2010.



Friends and readers, a few months ago I wrote a story on John Dillinger, and within a three weeks period, I have had quite a few readers talk to me about John in one way or another.

Dillinger was a no good bank robber, killer, thief, convict and most any other words that belong to the underworld. He operated in the depression times. He was not known much until the early '30's but he had a life of crime dating back into the '20's.

He buddied up with Homer Van Meter who was born in Fort Wayne and Harry Pierpont who was born in Liepsic, OH.

The other day I met Randy MacNamara at Dr. Gray's office and he was telling me about his mother's experience as a teenager. She was employed as a waitress in a small restaurant near Roanoke, IN on US 24. At that time US 24 and US 30 were both paved highways across northern Indiana and Ohio. These roads were used pretty heavily by all the robbers and crooks and the Mafia out of Chicago.

One day a fleet of six big black cars turned in and parked. The second car held a big man in fancy clothes, it was 'Capone'. Some of his men came inside and some were on guard outside.

She was impressed by Capone's fancy clothes and his friendly demeanor. He was a good tipper and not a problem at all. He made a lot of friends there. At sometime or other she feels that Dillinger had also stopped in. They got a lot of small time hoods because of the nearness of Chicago, Detroit, Toledo, Cleveland and the lake shore.


Over in south Paulding County, Bob Laukauf tells me that he has a newspaper clipping that tells of Dillinger's gang robbing a small store in Briceton. I have heard of that clipping before. Steve Knapp tells me that when Dillinger was in Fort Wayne, his Uncle Dick was a policeman and was one of them trying to catch Dilligner.

Here at WBN, Bryce Steiner is the head ink dauber, but his father tells me about a Dillinger Museum in Northern Indiana. He says it is pretty much authentic.

Old timers say that Dillinger robbed the police station in Warsaw and Auburn, IN for arms, ammo and bullet proof vests. I got an e-mail from Vern Mees some time back. His father, Sam Mees, opened the A&W Root Beer Stand years ago. They lived on the corner where the kiddies toys are now. Anyhow, Vern lives in Crown Point, IN over where Dillinger used a homemade wooden gun to escape with. Vern says in this area people are going to exploit the Dillinger Era for tourism by a big renovation of the Crown Point Jail.

Anyway you call it, John was a gangster, murderer, robber and any word that means a no-good-nick.

The lady-in-red, Anna Sage, sold John out to the



F.B.I., then the feds backed out on the deal with Anna. Shortly after, she was banished to Austria, where after a few bad years she committed suicide.

Ben Franklin told me one time, "There is no honor among thieves." See Ya!

He was not considered a very smart cookie, wasting much of his dough on half-baked schemes. Despite being a little flaky at times, he was still a crusty old man and considered a positive roll model for millions.

Doughboy is survived by his wife, Play Dough: three children: John Dough, Jane Dough and Dosey Dough; plus they had one in the oven. He is also survived by his elderly father, Pop Tart.

The funeral was held at 3:50 for about 20 minutes.

Lillian Matzen Detmon and LeRoy Detmon had two boys, Arthur and Glenn. Glenn was born in 1925 out on the Ernie Matzen place.

Sometime along in there, they moved to Elmore, Ohio and Glenn started to school there. Then they moved back to Antwerp and finished his schooling here in 1943.



The war started while he was still in high school. He tried to enlist in the Air Force but he had trouble distinguishing colors and they wouldn't take him.

The Army took him in September of 1943 and sent him to Camp Chaffee, Arkansas for 13 weeks of Basic Infantry Training for an Armored Infantry Battalion.

After a few more weeks of $advanced\,training\,they\,loaded$ all their gear onto the Wabash Railroad and headed north ending up at Fort George G. Meade at Maryland, one of our bigger P.O.E.'s.

After a week of bad weather they landed at Liverpool. They trained a little more at a camp in England. They were still the 18th Armored Infantry Battalion. They were assigned to Patton's Third Army upon landing in Europe. He served with Patton from south of Paris up to Bastogne, Belgium.

BUDGETS

Enterprise budgets represent estimates of income, costs, and potential net income associated with the production of crops and livestock. Income and costs often are difficult to estimate in preparing a budget because they are numerous and variable. Therefore, think of sample budgets as a first approximation and then make appropriate adjustments that reflect specific production situations for your operation.

Enterprise budgets are designed as tools for projecting costs and returns for crop and livestock enterprises, and more importantly, as guides for planning individual farms. As farmers begin preparing for a new crop year, budgeting acts as a guide in the decision making process of committing resources that provide the most profitable enterprise for the farm. Without some form of budgeting and some method of tracking the enterprises' progress, it is difficult to determine if the goals of the farm have been reached.

Budgeting is often described as "penciling it out" before committing resources to a plan. The Ohio State University Extension has had a long history of developing "Enterprise Budgets" that can be used as a starting point for producers in their budgeting process. Barry Ward, Production Business Management Leader, has updated the Enterprise Budgets for 2010 and posted these budgets to the Farm Management Website of the Department of Agricultural, Environmental and Development Economics. Updated Enterprise Budgets can be viewed and downloaded from the following website: http://aede.osu. edu/Programs/FarmManagement/Budgets/

These enterprise budgets are compiled on downloadable Excel Spreadsheets that contain macros for ease of use. Users can input their own production and price levels to calculate their own numbers. Barry Ward indicates these Enterprise Budgets have a new look with color coded cells that will enable users to plug in numbers to easily calculate bottoms lines for different scenarios. Detailed footnotes are included to help explain methodologies used to obtain the budget numbers. Starting this year, Extension will be updating these Enterprise Budgets periodically during the year if large changes occur in price or costs. Budgets will include a date in the upper right hand corner of the front page indicating when the last update occurred.

Crop management decisions should be made in accord with the goals, objectives and mission of the farm operation. You may not be able to make perfect decisions, but by developing and using enterprise budgets you can improve the quality of information available to you. This information can make it much easier to analyze the economics of alternative enterprises.



SENATE URGES REVIEW OF OHIO WORKERS' COMPEN-SATION SYSTEM

For Ohio's economy to recover and experience growth in future years, our state must not only work to attract new investment and jobs, but ensure that existing businesses, some of which have called Ohio home for decades, have the resources to compete with companies in other states and across the world. To accomplish this goal, state and local leaders must take steps to eliminate burdensome regulations, support education and workforce development initiatives and help keep the cost of doing business in Ohio low.

While there has been progress on all three fronts in recent years, my conversations with business owners in Northwest Ohio and across the state reveal that there is still much more work to be done. In particular, the business leaders I have talked to consistently say that the cost of workers' compensation premiums in our state is a major hit to their bottom line, threatening to put some companies out of business and impacting the ability of others to expand and hire additional employees.

Even more disheartening is that the Ohio Bureau of Workers' Compensation approved new rules earlier this fall that would actually raise workers' compensation premiums for thousands of businesses in the state by reducing the maximum discount that employers can receive through Ohio's group rating program. On October 20, I invited BWC Administrator Marsha Ryan to come before the Senate Insurance, Commerce & Labor Committee to discuss these changes. After her testimony, many groups came forward to express their opposition to the plan and explain how rate hikes would hurt their businesses. In addition, I sent a memo to the Bureau of Workers' Compensation Board of Directors last month urging them to postpone further premium increases. I explained that at a time when large and small employers across our state are struggling to keep their doors open and their employees working, this proposal would serve as a detriment to job growth and economic recovery. Despite

this plea and opposition from other lawmakers, the Board voted to move forward with the group-rating changes on October 30 meaning that nearly half of Ohio employers will see higher workers' compensation taxes in 2009 and 2010.

While the BWC administration believes that these changes will help as part of a larger reform strategy, the verdict is still out on the impact on Ohio's future economic development efforts. In the meantime, my colleagues and I in the Ohio Senate are working toward other reforms including studying the possibility of alternatives to our state's government-operated workers' compensation system in an effort to reduce premium costs and provide more options for workers and businesses.

Senate Resolution 118, which passed the Senate on November 17, creates the Competitive Workers' Compensation Task Force to review the feasibility of allowing Ohio employers the option to obtain private workers' compensation insurance. Members of the Task Force will include business owners-both from Ohio and other states-workers, legal experts, insurance industry representatives with workers' compensation experience, local officials, legislators and several other state leaders, including the Administrator of the BWC and the chairperson of the Workers' Compensation Board of Directors. You may recall that the Senate included a similar provision in our version of the BWC budget in June, but it was removed during conference committee deliberations on the bill.

Ohio is currently one of only two states in the country that still relies totally on a government-operated workers' compensation system. Many other states have moved to an entirely private system or a public-private hybrid. For example, West Virginia converted its workers' compensation program into a private plan and opened the door to competition from

other private insurers. I recently had an opportunity to speak with the Governor of West Virginia, a Democrat, and several legislators from both sides of the aisle, all of whom said they were very pleased with their state's new approach.

Ohio is not West Virginia, Nevada or one of the other states that have moved to a private workers' compensation system, and the task force may conclude that that is not the best course for our state, but I believe we owe it to Ohio workers, businesses and the future economic success of our state to at least study the idea. As this review gets underway, I will continue to do everything I can to promote a workers' compensation system in Ohio that cares for injured workers, keeps costs low for businesses and helps our state move forward.

ONLINE DOG LICENS-ING NOW AVAILABLE VIA COUNTY AUDITOR'S WEB SITE

Ohio law (955.01 ORC) requires that all dogs more than three months of age be licensed each year not later than January 31st. A Paulding County Dog License (dog tag) is available online via the Paulding County Auditor's web site www.pauldingcountyauditor.com through ****

the NEW! Dog Licenses Link. A convenience fee is charged to your credit card and postage if you chose the online service. Dog tags will also be available in the Auditor's office or at the dog shelter. Auditor Simpson said, "I am pleased to be able to bring this online service to the residents of Paulding County. It was necessary to make some changes and it came at a very good time since the online service company offered a FREE six-month trial period. Many county auditors are making use of an online service due to reduced office staff and hours. It provides a very convenient method for the public and allows for a higher quality of licensing records

and fiscal control.' You will no longer be able to purchase your dog license through an authorized dog licensing agent (e.g. local hardware store). The elimination of licensing agents was necessary due to reduced staff, budget constraints, and fiscal controls being tightened by the county auditor. Auditor Simpson added, "I just don't have the staff to administer licensing agents scattered all over the county; my office is responsible for the money and records and we can't achieve good controls under the current reduced general fund budget. We were handling ALL applications twice (manually and electronically) and now that can be reduced significantly with this dog licensing software. Unlike

Once again it is time to purchase and renew dog licenses. Licenses must be purchased December 1st 2009 to January 31st 2010. Licenses purchased after January 31st 2010 will be assessed a penalty fee of \$15.00

All dogs over three months of age must have a license and must be wearing the license at all times according to the Ohio Revised Code. Dogs purchased or adopted after January 31st must be licensed within 30 days of purchase/adoption date.

Dog license may be purchased online at www.pauldingcountyauditor.com a convenience fee of \$2.50 will be added to all online purchases to cover credit card processing and postage.

Dog licenses may also be purchased at the Paulding County Auditor's Office (please call to check open hours at 419-399-8205), or at the Paulding County Dog Warden's Office located at 13387 US HWY 127 (next to Jacob Eaton Acres) on Tuesdays from 10am-2pm, Thursdays from 2pm-5pm, and Saturdays from 10am-Noon

Dog licenses may also be purchased by mail with the form below. Please note that credit/ debit card purchases are only available by using the online sales system.

Note: According to Ohio Revised Code, a kennel owner is a person, partnership, firm, company, or corporation professionally engaged in the business of breeding dogs for hunting or for sale. If you are not registered to collect sales tax in Ohio and are in the business of selling dogs, you must be registered to collect and submit Ohio sales tax by purchasing a Vendor's License. A kennel license can only be purchased at the Auditor's Office.

many counties, our office has never had dog licensing software. Therefore, maintaining over 3,000 dog tags each year has been very time consuming and difficult; this software allows for better processing. I will not put good fiscal management at risk; the best solution was to offer online service. After our initial free trial period, the Dog and Kennel Fund should be able to support the online service. We will also be able to retain the necessary fiscal controls, improved records, and better public service."

You will still be able to mail in an application form by cutting one out of the local newspaper or printing an application form off the web site. License programs are administered by the county auditor; license fees are set by the commissioners. A penalty, which is equal to the cost of the tag, is charged for purchasing a license after January 31st. If the dog is obtained after January 31st the owner has thirty (30) days to license the dog without penalty.

An Ohio dog tag is valid for the entire calendar year for which it is issued and is valid anywhere in the State of Ohio. If it qualifies, a license may be transferred upon payment of a small fee and recording the transfer within the auditor's office. The auditor's office is located within the courthouse. The telephone number is 419-399-8205; please call ahead for office hours due to reduced hours.

After July 1st license fees will be one-half the original fee for the following reasons ONLY:

-A dog becoming three (3) months old on or after July

-A dog brought from outside the state on or after July 1st.

-If a tag is lost, a duplicate shall be furnished by the auditor after we verify registration and payment of a small fee for each duplicate tag issued.

A dog license is your pet's ticket home if he gets lost. Even homebody dogs can get out an open door or gate, so even if Spot never leaves home by design, he can still get out accidently. Many dogs never find their way back home because they lack identification, and the best way in town for identification is the state-mandated dog license. License money is deposited into the dog and kennel fund to pay the administration of the program and the incarceration of stray dogs.


