

The royal palace in Tehran is breath-takingly beautiful! When one steps into the palace, that person is surrounded with millions of pieces of glittering, sparkling glass. It appears as if the doomed ceilings, the side walls and columns are diamond-covered and not cut glass; however, they are small pieces of mirrors. The edges of the myriad of little mirrors reflect prism light, throwing out the colors of the rainbow. Spectacular!

### VETERAN'S MEMORIAL PARK SETS NEW TABLETS

What was once a gleam in Karen Sanders' eye has now come to reality. On July 21st at Antwerp's Veteran's Memorial Park (on 424). Men from Homier's Monuments, out of Defiance, were erecting the Veteran's Memorial Tablets.

Standing tall and radiant, the tablets proclaim our area's veterans' names from the Civil War until now, with space for future Veterans.

Nancy and Jim Lichty were there excitedly watching the finishing touches. Looking for names the Veterans' came up, helping them to find their names. I asked Nancy how did these men know the tablets were here and she and Jim looked at each other and said, "I don't know."

The whole scene is overwhelming. Antwerp is so very blessed to have such a beautiful park and now a wonderful Veteran's Memorial.

The whole project took 21/2 years to complete. The first meeting was held in January of 2008. Around \$100,000 was raised for this memorial. Kudos go to Karen Sanders, Chairman; Nancy Lichty, Treasurer; Keith and Joyce West, Fund-Raising Chairman; Lori Manon, Historian; Judy Steele, Star Levy, and Sandra Wann. The husbands also deserve a hand for their support in this endeavor.

The Dedication Tablet features Jay Sanders' picture of an Eagle and a flag. These pictures were also sold as part of raising funds for the tablets.

There will be flood lights illuminating the tablets, Military flags for all the branches of service, a MIA-POW flag, 2 granite benches, sod and tile work will complete the memorial.

Kudos also go to Homier Monumental for the excellent job done. The first part of the project was overhauling the soldier. Now the soldier stands proud at the entrance of the park.

The formal dedication will be held on August 29, 2010 at 2:00 p.m.

#### THE BRIDGES OVER THE **MAUMEE AT ANTWERP**

The other morning I had coffee with Ken Hahn, Dave Hand, Rick King, Tom Wannemacher, Tim Derck and Gary Derck. Some of the areas big grain farmers.

The topic of the morning was the closing of the bridge on SR 49. One of the boys asked what I knew about the history of the bridges.

Please read the excerpt from The Diary of J. Lincoln, Antwerp's first doctor and record's keeper that I knew about.

This is about building the road from Hicksville to Antwerp and it is dated June 18, 1845:

Commencedtheturnpike from Hicksville to Maumee River 6¼ miles. Mostly rails 12 feet long, placed close together and covered with earth.


Ditch on each side 6 feet wide at the surface and and one at the bottom, 2 feet deep. Space for the road between the ditches, 16 feet. Rails and logs completely covered with earth from

the ditches. Stumps cut down level with the ground. Road and ditches perfectly straight from Hicksville to river regardless of stumps.

Expense \$1.25 per rod. Ditches are dug by plowing by the other bridge in about 1910. This picture was taken looking from the north to the south.

This three span bridge was replaced in 1950 by the present river bridge.

1800's a W.N. Snook owned the river bottom north of the Maumee. I think he was Junior Snooks', great-greatgrandfather. From the records I have there has been a number of the Snook family who were very prominent in Antwerp's early history and




#### **HURRICANES, WEATHER DISTURBANCES & INTENSE** HEAT

This week I am taking a break from the article series and writing a different article. I will also do this next week.

This hurricane season is well under way and as we are nearing the core of the season (September and October) WSI and CSU have lowered their total number of storms just ever so slightly down to 19 storms. In fact, forecasts for the amount of hurricanes and major hurricanes have not changed one bit. Just this week a tropical storm or hurricane is expected to form and hit the oil spill and head directly into New Orleans, Louisiana. Already, as of Thursday, July 22, 2010, this tropical wave is a Tropical Depression in the Bahamas is expected to hit Miami and the Florida Keys as of Friday morning, July 23. Update: Tropical Depression Three turned into Tropical Storm Bonnie on Thursday evening and is located a couple hundred miles southeast of Miami, FL. According to the National Hurricane Center, it will probably hit Key Largo when it makes landfall in Florida and then move into the Gulf of Mexico and move through the oil spill area. They are not expecting Bonnie to become a hurricane. This hurricane season is expected to be just as extreme or possibly even more than the 2005 hurricane season. The reason for this over-active potential season is because the Atlantic, Caribbean, and Gulf waters are much warmer than normal and wind shear is weaker than usual which should allow for the formation of large and powerful hurricanes.



Many people have wondered what a powerful hurricane would do if it hit the oil spill area. Well, NOAA and ŴSI say that if a hurricane would directly hit the oil spill or go just to the west of it, oil would go on land and many areas would be coated with a thin layer of oil. But if it would go just to the east of the oil spill near Florida, it would drive in to the Caribbean Sea and disperse the oil and help it degrade. The reason for this is hurricanes rotate counterclockwise which would mean that if the hurricane hit it directly or went just to the west the winds and storm surge would be from the south and bring the oil onto land and if it went to the east of the oil spill, it would disperse the oil southward. Last week the eastern twothirds of the country were hit by severe flash flooding, severe and violent thunderstorms, and oppressive heat.

This weather was brought by a stationary front that divided the Midwest in half. The northern part of the Midwest got cooler temperatures in the 70's while south of the front, there was an oppressive heat wave. Right along the front, temperatures were in the mid to upper 80's with high humidity with heavy and severe thunderstorms. Now the front has moved out of the country and has brought much cooler conditions to the Midwest and Northeast. Last week, many areas were hit with torrential downpours which caused flash flooding and some areas even had large hail and tornadoes. One of the hardest hit cities was Milwaukee, Wisconsin. It was hit with flash flooding and a rainfall total of 5.61 inches which was the second highest on record. Milwaukee International Airport was closed when torrential rains caused flash flooding on the runway. The tower had already been evacuated because of a tornado warning.

NOAA is still predicting that most of the nations temperatures for the next several months are going to be way above average accept for the Southeast and the Mississippi Valley. Also by December, our area is supposed to have above average precipitation while in July and August the Mississippi Valley, the Ohio Valley, and the Southeast are supposed to have above average precipitation.

#### LATTA, OHIO REPUBLICANS **URGE GOV. STRICKLAND TO ASSURE OHIOANS THAT OHIO WILL NOT SEEK TO USE TAXPAYER DOLLARS TO COVER ELECTIVE ABORTIONS UNDER** OBAMACARE

In light of recent reports detailing plans by several states to use high-risk pool health plans funded by federal taxpayer dollars under President Obama's health care law to offer abortion services, Ohio House GOP members urged Governor Ted Strickland (D) to assure Ohioans that the final plan to be submitted by the State of Ohio will not include elective abortion as a covered benefit.

In the letter, Congressman Bob Latta (R-Bowling Green) joined House Republican Leader John Boehner (R-West Chester), Steve LaTourette (R-Bainbridge), Pat Tiberi (R-Genoa Town-

ship), Jean Schmidt (R-Loveland), Michael Turner (R-Centerville), Jim Jordan (R-Urbana), and Steve Austria (R-Beavercreek) expressing concern over reports that several states have submitted - and the Obama administration initially approved - plans to create taxpayer-funded high-risk pool health plans under ObamaCare that would cover elective abortions. The Obama administration has since backpedaled and said it will not approve such state plans. But given the mixed messages sent last week by the Administration and significant public opposition to taxpayer funding of abortion, the Ohio legislators are seeking assurances from Gov. Strickland that Ohio's own plan - which has not yet been finalized, according to state officials - will not include elective abortion as benefit.

"Ohioans were misled by the Obama Administration about the cost of the President's health care legislation, and they cannot be misled again when it comes to this unconscionable use of taxpayer dollars," the representatives write. "Your voice as Governor is needed to help ensure that not a dime of the \$152 million in federal funds Ohio is set to receive for its high-risk pool plan goes toward covering abortions. We ask that you assure Ohioans that Ohio will not seek to use funds from the President's health care law to fund abortions."

**FISH SPAWNING IN PONDS** 

easy meal of eggs. Incubation time is dependent on water temperature with hatching taking only a week or so if water temperature is in the 70 degree range.

The advantage nest builders have in ponds with soft bottom materials is that males continually fan away sediments that could cover the eggs and cause egg mortality due to oxygen deprivation. Many fish species that simply disperse their eggs randomly along the bottom and provide no parental care do very poorly in ponds and lakes with soft bottoms. The eggs simply sink into the soft bottom muck and become smothered. Fish species that disperse their eggs typically require rocky or rock/sand bottoms where soft sediments are absent and oxygen deprivation will not occur.

So what about channel catfish? They are also nest builders, survive well in ponds, but generally do not reproduce successfully in ponds. Why? Channel catfish are cavity nesters and require a dark cavity in which to enter and lay their eggs. They do not build nests out in the open like bass and bluegills. Most ponds and small lakes do not have such cavities. Occasionally, smaller channel catfish will spawn in a muskrat run or hole in a small water body and a few small catfish might be seen. In larger lakes where large rock rip rap is placed on a dam, larger cavities are created and catfish use them. If channel catfish did spawn effectively in ponds, it could cause a problem. Too many channel catfish can muddy the water, creating problems for the sight-feeding bass and bluegills.

Yellow perch can do well in small, warm lakes and ponds but often do not reproduce successfully. They lay egg ribbons on aquatic vegetation or brush. Egg ribbons that fall onto the soft bottom will become covered in sediments and die. Also, perch lay their ribbons early and are often exposed to weather extremes, causing many spawning failures.

Years of research and experience with fish stockings have demonstrated that largemouth bass and bluegill are the two species most suitable for stocking Ohio ponds. Redear sunfish and channel catfish are stocking options that in most instances perform well for the pond owner.

#### SENATE BILL WOULD HELP ENSURE CONSISTENCY, **RELIABILITY IN EFFORT TO** CATCH SPEEDERS

If you drive across any of the major highways that dissect our state during this busy summer travel season, you are bound to see multiple police officers patrolling the road for speeders and other unlawful drivers. While many motorists are guilty of having the occasional lead foot, we can all respect and appreciate the tremendous job these men and women do to keep our roads and communities safe.

In early June, however, a ruling by the Ohio Supreme Court raised legitimate questions and concerns about how law enforcement officers determine the speed of a passing motorist. In their 5-1 decision, justices stated that "a police officer's unaided visual estimation of a vehicle's speed is sufficient evidence to support a conviction for speeding," as long as the officer is trained and certified by the Ohio Peace Officer Training Academy or a similar organization. In other words, Ohio cops can cite someone for excessive speeding just by looking at the car and estimating how fast it is moving.

I have no doubt that the majority of law enforcement professionals in Ohio are honest and well-trained, but in a country where the justice system was founded on the creed that guilt must be proven in a court of law, I believe police officers should have verifiable evidence of a driver's speed before writing them a ticket. Allowing officers to issue speeding citations based solely on their visual estimation threatens to damage public confidence in Ohio's law enforcement community.

In the weeks since the Supreme Court's ruling, many of my colleagues and I in the Senate have received numerous letters, emails and phone calls from concerned Ohioans calling for legislative action to address the issue. In response, I recently co-sponsored Senate Bill 280, bipartisan legislation which would prohibit a police officer from ticketing a motorist for speeding without independent verification from a laser, radar or airborne speed reading device. The proposal would help promote consistency and reliability in measuring drivers' speed, while ensuring our dedicated law enforcement officers can continue their important campaign to catch speeders and keep Ohio's road safe.

Two species of fish recommended for stocking in Ohio ponds are the largemouth bass and bluegill. A major reason is based on their ability to reproduce or spawn. Both species are nest builders meaning a parent, the male for these two species, builds a nest in shallow water as waters warm in spring.

Bluegills are colonial spawners with many saucer shaped nests being located in a small area which makes them easy to see. Largemouth bass are more solitary nesters and typically nest in a little deeper water. Males of both species continually tend to the nest and defend the eggs against intruders desiring an

#### **BUFFALO WALLOW FIGHT**

The Red River War had a number of side battles and the Buffalo Wallow Fight was one of the more spectacular ones, this took place on September 10, 1874.

Colonel Miles' outfit was fighting one of the Red River Battles and his unit was running short of all supplies, so he sent two civilian scouts, Billy Dixon and Amos Chapman and four enlisted men, Sergeant Z.T. Woodhall and Privates Peter Rath, John Harrington and George Smith from his camp on McClellan Creek asking where was his supplies? He didn't know it, but Lyman's Wagon Train of thirty-six wagons were under a siege by Indians on the upper Washita River.

On the morning of September 12, they were in Hemphill County, a rolling county, they found them selves surrounded by about one hundred and twenty warriors; Comanches and Kiowa. Some of these Indians were from the wagon train siege.

Dixon and his companions decided to dismount and make a desperate stand, as there was no cover in this area. It wasn't long before George Smith took a bullet through his lungs. It was his job to hold the horses and when he went down the horses bolted with all the supplies, packs, canteens, coats, blan-

kets and rations.

Not long, both Harrington and Woodhall were both hit and Chapman got hit in the left knee and it was shattered. All hell broke out here with one hundred and twenty wild Indians against six soldiers.

For a few minutes the savages slowed up and Dixon, who now had a minor calf wound, spotted a buffalo wallow a few yards away. He told his buddies to take refuge in this sort of shallow depression, this was about ten feet in diameter.

By noon all except Smith and Chapman had reached the safety of the Wallow. They used their hands and butcher knives to make a parapet around this area and still kept the savages at bay away from the wounded men.

Dixon tried several times to get to Chapman, the wounded soldier, but the bullets and arrows drove him back. Finally, in the mid-afternoon he was able to reach Chapman and bring him into the wallow.

It was very hot, no water or food, but these boys were good marksman and kept the Indians at bay. The Indians couldn't get to Smith to get his weapons.

After a few hours a rain storm came up and gave some relief from the heat and it seemed to slow up the Indians attack. But the rain brought

and Rath carried him over to the wallow, their make shift fort, and he died late in the night.

to go look for help along a trail about a mile away. He soon saw a column of U.S. Calvary and was lucky to get their attention. It was about 225 men from Fort Union, New Mexico. The sergeant of the troops caused the Indians to leave the area and the wallow and Lyman's wagons.

Well, they didn't get much help from the troops. A little hard tack and dried beef. Major Price, who was leading the group said he would notify Colonel Miles and help arrived about mid-night.

George Smith's body was wrapped in a blanket and buried there in the wallow, and the wounded men were taken to Camp Supply for treatment. Chapman's leg was amputated above the knee a little later. Woodhall and Harrington recovered and continued their military service.

Colonel Miles recommended all these men receive the Medal of Honor for bravery under adverse conditions and one posthumously for Smith.

Dixon received his award from Colonel Miles while they were camped at Carson Creek near Adobe Walls.

The small battle or skirmish showed the guts and fortitude of some of our troops. See va!

#### GILLMOR URGES OHIO MAYORS TO BUY "BIO-OHIO." SUPPORT STATE'S AGRICULTURE INDUSTRY

State Senator Karen L. Gillmor (R-Tiffin) is encouraging mayors in cities and villages across Ohio to support our state's agriculture industry and local farmers whenever possible by purchasing supplies made from Ohio bio-based materials like corn, soybeans and switch grass.

"More and more, the raw materials to make everyday products, like office supplies, cleaning and construction materials, come from Ohio crops. This has provided an important new market for our farmers during difficult economic times," said Senator Gillmor, who is a member of the Senate Agriculture Committee. "At the state level, we have been working to maximize the substantial buying power of state agencies to support our state's number one industry-agriculture-at no additional cost to taxpayers. Our hope is that local governments can join us in reinvesting public dollars back into Ohio's economy and Ohio workers."

In February, Senator Gillmor passed Senate Bill 131. This legislation, now law, established a bio-products preferred purchasing program in Ohio for state agencies and state-supported colleges and universities. Similar to existing "Buy Ohio" provisions in state law, which help ensure the state is supporting Ohio vendors whenever possible, SB 131 requires these public institutions to give purchasing preference to bio-based products when a bio-based alternative is available and when the cost is not prohibi-

The federal government has a bio-preferred program, which among other things, certifies products as being bio-based and maintains a list of vendors that can provide them. Senator Gillmor's bill wisely built upon the resources of the federal program to save the state costs and manpower, and earned Ohio the distinction of becoming the first state in the nation to establish a buy bio-products program. In fact, SB 131 has been submitted for review by the Council of State Governments to use as a model for other states to follow.

Though her bill did not impact local governments, Senator Gillmor is hoping Ohio mayors will support the effort voluntarily and join the bio-Ohio movement. A few already have, which has earned Ohio a ranking of 4th in the nation for establishing BioPreferred programs.

Not only is this initiative important for farmers, but many Ohio entrepreneurs are taking the raw materials from farmers and turning them into everyday products; in



fact, Ohio ranks 5th in the nation for biomass production, from which bio-products are made. Major companies like Proctor & Gamble, Sherwin Williams and the Scotts Company are all producing bio-based products.

"Our mayors are on the front lines of economic development and understand the value and importance of agriculture in their communities," Senator Gillmor said. "It is my hope that we can continue to build support for Ohio-grown materials as well as give a boost to the innovators who are putting Ohio's bio-products industry on the map.

#### LATTA OPENING STATEMENT FROM SUBCOMMITTEE HEARING **ON BP OIL SPILL**

This morning, Congressman Bob Latta (R-Bowling Green) delivered the following opening statement during the House Energy and Commerce Oversight and Investigation Subcommittee hearing titled "The Role of the Interior Department in the Deepwater Horizon Disaster." Video of the opening statement can be found on Congressman Latta's YouTube Channel.

"Mr. Chairman; Mr. Burgess: Thank you for holding this subcommittee hearing on the Interior Department's role in the Deepwater Horizon Disaster and I thank our witnesses for appearing today.

"Last month, I had strong words for BP CEO Tony Hayward when he testified in front of the Oversight and Investigations Subcommittee and since then I have reiterated that BP needs to be held accountable for this disaster of epic proportions. However, I have also been awaiting the opportunity to hear from and question Department of Interior officials regarding their role in the Deepwater Horizon disaster, especially since President Obama has repeatedly said that he and his Administration are 'in charge' and take responsibility for the response effort, as the law so requires.

Earlier this month, I traveled with some of our colleagues to the Gulf to tour the Louisiana coast and meet with community leaders and residents who have been affected by the disastrous BP oil spill. While I was encouraged by the spirit of the hard-working local residents, it is clear that they are frustrated by the federal response, and the lack of coordination amongst the government agencies. The trip reinforced my belief that it is critical we find out what went wrong and how and why it happened - this includes a thorough investigation into the current Administration's actions leading up to the incident and during the response. Furthermore, I believe the Administration's moratorium on deepwater drilling in the Gulf is devastating to the region and I would like to hear about the Interior's role in making this decision. A recent report by a nationally-renowned economist from LSU states that the loss of 8,000 jobs, nearly a half billion dollars in wages, and

over \$2.1 billion in economic activity will be triggered in just the first six months of this moratorium. The Administration would have been better advised at stopping the flow of oil instead of focusing on imposing the drilling moratorium, this in spite of a federal judge overturning the first moratorium and calling it 'arbitrary and "capricious."

Mr. Chairman, I look forward to hearing the testimony today and I yield back.'


The Land and Living display will feature many new exhibits including a giant pumpkin patch that will feature Gus Swisshisler, as he carves a giant squash weigh-

Ohio 49 just north of Antwerp – Route closed July 19 for 21 days for bridge rehabilitation. Traffic will be detoured onto U.S. 24, U.S. 127 and Ohio 18 back to Ohio 49. Work is being done by Suburban Maintenance and Construction.

Ohio 637 bridge (5-span) over the Auglaize River, between Ohio 111 and Ohio 66 east of Junction – Bridge repairs will occasionally reduce traffic to one lane through the work zone during daytime hours only beginning April 19. Traffic maintained with flaggers. The project is expected to be completed by the end of the month. Work is being performed by Vernon Nagel Construction, Napoleon.

#### **PAULDING CHRONICLES I**

Almshouse/Poorhouse The Toledo Colony Mayflower Descendants met June 26 at Bowling Green at Sam B's Rest. Following the luncheon and business meeting, the members were asked to identify the compact Signer from whom they are descended and also a favorite place they had traveled to in the past. This writer was in Israel and Germany in 2000.

The Lt. Gov. Report was given by Ric Harner. He asked for any volunteers for upcoming offices for the next term. Member, Marj. Waterfield presented Kenneth McCartney with a 50 year membership certificate of the Toledo Colony. (see picture). It was noted that in the past he has held every office sometime during that time. Mrs. Mc-Cartney was also present.

Mr. Harner made available a new book, "Making Haste from Babylon", this publication is very interesting reading on the Puritans and the Pilgrims and the history of the comet at the time of their coming to America and much more.

The speaker was Dr. Ruth Herndon of BGSU Department of History (27 Williams Hall, Bowling Green, OH 43403). She has written two books: "Children Bound to Labor", and "Unwelcome Americans".

Dr. Herndon spoke on "Boston Almshouse". She has researched the records that are still available to write her book, trying to find out more about the people. There were 11,800 pilgrims names listed. It was welfare and was considered a community/local responsibility. The intellectual inheritance was to take care of the needy. They would send them back where they came from, they would try to find out where their hometowns were. Children were "Bound Out" to families who would

take care of them.

To get food and care (a cow) one had to prove he was responsible. The "Almshouse" poorhouse was shown up in Boston because it was an English custom. Boston was the cradle of welfare, then Philadelphia, then N.Y.

Every town had a "Poor Person" Overseer, and by 1690 Boston had one of those persons. They became wealthy enough and famous enough that "Wards" were developed. Then delegations were set up to look over certain areas such as idleness; cruelty to children; gambling; plus looking into disorder in homes that needed help. Beggars were recognized and treated as well.

Overseers of the poor did not get paid but were elected and one became Lt. Gov. of Pennsylvania. They were pillars of the community. Boston was proud that they knew how to take care of their poor.

Almshouse records tell us that there are more men than women listed. It was not full of single women and children. Eleven percent were designated as "colored" or not European" (not white).

Where did they come from? Boston-about 13%; New England-about 23%; Ireland was about 18% of all. It wasn't the potato famine very early (1795-1817). Some would stay a few weeks in the winter (for one time). It was a place of refuge, but also it was a work house. Mentally ill could stay at the Almshouses; physicians were hired by the city to care for the poor. It was sex-segregated; no liquor. Each Almshouse/Poorhouse was supported by that particular community.

Laterlaws, in particular the 1834 Poor Law, organized the parishes into Unions who became responsible for running the workhouses. At this time strict controls were enforced regarding who was eligible to enter the workhouses and the conditions under which they operated. Some were much harsher than others and the staffs were incompetent resulting in inmate suffering.

Knox Co. Ohio is famous for it's poorhouse, which was said to be haunted. It opened in 1857 for the mentally insane and poor and indigent. When it closed, it became a part of the Mt. Vernon Bible College. A tragic elevator accident took the lives of several students which only added to the rumors of mystery of the building.

Did Paulding County have a poorhouse? Please tell us about it.
