#### **ODOT TOUTS HISTORIC CONSTRUCTION SEASON AT 2010 OHIO STATE FAIR**

The Ohio Department of Transportation's orange barrels—a symbol of the state's summer construction season—are joining the butter cow and the prize animals of one of the largest junior fair shows in the nation at the 2010 Ohio State Fair.

Starting today in the fair's Marketplace building, ODOT is commemorating its historic construction season—with more than \$2 billion invested into construc-

tion projects this season. "As we mark the historic \$2 billion end of state fiscal year 2010, Team ODOT now

prepares for a second \$2 bil-

lion investment for state fis-

cal year 2011," said ODOT Director Jolene M. Molitoris. "We think this accomplishment is something Ohioans should be proud of. Through these investments, we are creating a true 21st Century multi-modal transportation system."

Joining ODOT Director Molitoris for the opening of ODOT's exhibit was U.S. Deputy Secretary of Transportation John Porcari, who talked about the unprecedented federal investments made through the American Recovery and Reinvestment Act, including \$53 billion invested in rural America.

Each year, the Ohio State Fair is a showcase for the state's agricultural accomplishments. Since 1912, ODOT has also been a staple at the fair, highlighting the state's transportation progression and efforts to make travel safer and more environmentally-friendly.

ODOT will be reaching out to Ohio's younger drivers who visit the fair-drivers between the ages of 16-25—by asking them to join a national pledge to stop text messaging while driving. According to the National Highway Traffic Safety Administration, a study found that as much as 71 percent of drivers admit to texting or talking on the phone while behind the wheel.

Visitors to ODOT's fair booth will also be invited to take the "Go Ohio Transportation IQ Quiz." Do you know what percentage of the U.S. population is within just a day's drive of Ohio's borders? The answer is part of a special exhibit on ODOT's statewide multimodal transportation futures plan.

#### VILLAGE OF PAULDING COUNCIL MINUTES FOR 7/6/10

Paulding Village Council met in Regular Session on July 6, 2010, at 6:30 p.m. in Council Chambers at the Municipal Building. Mayor White called the meeting to

Finance Director Tope called roll with the following members present: Barb Rife, Kim Sutton, Jim Guelde, Mike Trausch, and Roger Sierer. Administrator Wiebe and Solicitor Jones were also present. Councilman Randy Daeger was absent.

Mayor White requested a revision to the drafted minutes of the June 21st meeting to reflect Councilwoman Kim Sutton's absence. Trausch motioned to approve the revised minutes of the June 21st Council meeting, seconded by Rife. Vote: Rife, yea; Sutton, abstain; Guelde, yea; Sierer, yea; Trausch, yea.

Russell Herman, Village resident, was present to discuss a delinquent utility bill (in the amount of \$132.76) that had been incurred by his ex-wife while she temporarily occupied the residence at 121 W. Caroline St. with their children and a child from a previous marriage. He noted he had requested village utilities be turned off until she placed the account in her name, but that the Village refused to comply with his request. He relayed he had received a call from the Village Solicitor stating the Village's position on the matter, and was told he would be charged with telephone harassment if he called the office again. Mr. Herman noted he has assumed total responsibility for the utilities he has consumed since he moved back into the residence on March 1st, and requested Council write off the delinquent bill. Solicitor Jones relayed the divorce decree states Mr. Herman is

a mediation session by a court appointed mediator to resolve this matter. Solicitor Jones requested Mr. Herman keep him advised of the outcome of the mediation and promised not to do anything with the utility service until he was advised of the outcome of the mediation. Solicitor Iones sent Mr. Herman a letter on June 11th, prior to the water being shut off, requesting Mr. Herman advise him of the status of the mediation by June 18th, but Mr. Herman did not reply. Solicitor Jones then called Mr. Herman at his office on June 21st, and was advised the mediation had been cancelled and the issue wasn't resolved. Solicitor Jones noted the Village lived up to its end of the bargain, and believes the court order provides sufficient language advising him how to remedy the issue - mediation or to file an appropriate motion with the court. Council requested Mr. Herman get clarification from the court that he is not responsible for the delinquent utility bill, and noted that it is the policy of the Village that any delinquent bill is ultimately the responsibility of the property owner. Mr. Herman does not believe it is fair for him to pay fees to file a motion with the court for a bill of \$132.76. He also requested it be on record that his ex-wife is related to Barb Rife and is the mother of Roger Sierer's grandson; therefore, he requested they not be allowed to participate in this discussion. Solicitor Jones recommended that Mr. Herman's request be denied based on the language in the divorce decree that states he is responsible for all expenses related to the property, along with the Village's policy that all bills are ultimately the responsibility of the property owner. Mr. Herman requested documentation stating the Village's policy that property owners are ultimately responsible for outstanding bills issued by the Village office. Mayor White polled each Councilmember whether or not he/she support the Solicitor's recommendation to request Mr. Herman resolve the issue through mediation, or to waive the bill. Vote: Rife, take the advice of the Solicitor; Sutton, take the advice of the Solicitor; Guelde, take the advice of the Solicitor; Sierer, take the advice of the Solicitor; Trausch, abstain. Mr. Herman noted he does not have the money to file something through the court, and if his utilities are shut off he will file a suit against the Village.

did not prepare any legislation for tonight's meeting to designate Jeffery Park "Alcohol and Smoke Free" because he has been trying to determine if new legislation is needed, or if Council just needs to amend current legislation. He noted that prior legislation already designates all Village parks as "Alcohol Free", and inquired as to Council's desire to make them "Smoke Free". Council requested only Jeffery Park be deemed "Smoke Free". Solicitor Jones noted he will have legislation prepared for the next meeting designating Jeffery Park as a "Smoke Free" Solicitor Jones also noted

he had received a letter from the Ohio EPA stating their acceptance of the new Water Plant's revised construction schedule as proposed by the Village with the understanding that the new plant will be fully operational no later than twenty-four (24) months from receipt of Closing Instructions from Rural Development. Rife inquired when the project will be advertised for bid. Solicitor Jones noted information must first be submitted to Rural Development for approval, but estimated the project should be bid sometime in September 2010. He also relayed GE has received the Village's membrane contract, and that they will be preparing information for the engineer.

Trausch thanked the Village for allowing the Emmanual Baptist Church to use the Skate Park for their Skate Board exhibition.

Sierer noted sprinklers have been placed at Jeffery Park to water the outfields. He noted the next step in this process is for Sierer to contact Hoeffel Engineering when the project is complete, and for Tony Hoeffel to contact the State Inspector to release the property to the Village.

Rife inquired when trash was to be picked up this week due to the holiday. Tope informed Council trash would be picked up on its normal schedule.

#### RUDOLF DIESEL

The inventor of the Diesel Engine, Rudolf Diesel, was born in Paris in March of 1858. His parents were Theodore and Elise Diesel. They were German people living in France due to so much political unrest at that time. His father was a book binder and his mother was a daughter of a merchant from Nuremberg.

When Rudolf was 12 years old his mother sent him to live in Augsburg with an uncle because of the waring nation. His uncle was a math teacher.

Rudolf wanted to become an engineer and he finished at the top of his class in 1873. He enrolled in a new school called The Industrial School of Augsburg. In 1875 he received a scholarship to the Royal Bavarian Polytechnic of Munich and he accepted, but his parents wanted him to go to work and earn a living.

In Munich, one of his professors was Carl VonLinde and he gathered a lot of good experience from Carl. He also worked at a machine works in Winterthor, Switzerland and finished his college also. He again had honors in January 1880 and returned to Paris.

Here he assisted his old professor, Linde, when he helped in the design and construction of an ice and refrigeration plant. He was also Director of the plant.

In 1883, Diesel moved his wife and family (they had three children) to Berlin and he became the manager of Linde's Corporate Research and Development Depart-

Here he also started to play around with steam, he always said a steam engine lost about 90% of its available energy.

In 1887 Gotlieb Daimler and Karl Benz invented a motor car and then Diesel started to work on another engine called the Carnot Cycle.

He stopped working on the Carnot Cycle and realized that steam was not efficient and he wanted a better source of power.

The man was very intelligent about thermodynamics and drag and loss of power and he wanted to make an engine to replace steam. He also worked on engines other than combustion type engines.

So in the end, he made a diesel engine for stationary power plants and they worked fine. Then after his departure his followers made some smaller diesel engines for big trucks and airplanes that now used jet fuel and diesel.

On September 29, 1913, he was riding a mail boat out of Norway and told the purser to call him at 6:15 in the a.m. When they went to his room it was empty with no explanation of where he had gone.

His body was found about 10 days later far beyond recognition. But his personal belongings proved that the body was Rudolf Diesel. He was age

#### **BATTLE OF PALO DURO** CANYON

I imagine that you folks are like myself and never heard of this place or battle. But I'm going to write a little about it because it was the

last fight or battle of the Red The Comanches, Kiowas and Cheyennes had been

stock piling horses, food supplies and made the Palo Duro Canyon their home and hideout since early in 1874 and had completed the job of storing up supplies for the winter. This canyon was in the Texas Panhandle.

Colonel Mackenzie and his 4<sup>th</sup> Calvary came up from the south to trap the Indians in their wikiups. There was a number of skirmishes in the area at that time, mostly with the Comanches and Mackenzie reached the Palo Duro late in September of 1874. Early in the a.m. of Sep-

tember 28th, a scout found the Indian camp and notified the Colonel. Mackenzie brought all his troops up to the canyon's edge. But a Comanche, Chief Warbonet saw the soldiers and fired a warning shot alerting the tribe, but he was soon shot and killed.

This canyon had a steep rim all around it and since the Colonel's troop couldn't find an easy trail down to the bottom they rode their horses down that steep incline. They first hit the camp at Chief Lone Wolf's Kiowa tribe and routed it. Chiefs Iron Shirt and Poor Eagle tried to skirmish with the soldiers but the camps were so spread out that a good line could not be formed.

Some of the Indians took off and left everything behind, all their winter supplies, clothing, animal food and the horses. By nightfall, the warriors were gone and all of the camps were destroyed. The loss of the canyon was the death nell for the Indians. It was their hideout and all their winter supplies. The troops took 1400 horses. The horses that Mackenzie didn't need, they destroyed them, to keep the other Indians from using them.

But the Indians had no supplies and couldn't hold out over the winter so many of them returned to the Ft. Sill Reservation by November 1874. It was in 1875 that Lone Wolf's Kiowas came in, that was a terrible cold February.

I had seen in movies and stories about Chief Iron Shirt, but this is the first time I ever read anything about

But this fight was the last of the Red River Wars. It was a terrible sore in the side of the Calvary and the immigrants going west.



#### **POND STRATIFICATION**


Many Ohio ponds and lakes undergo a regular yearly process known as thermal stratification. A pond is thermally stratified when there is a noticeable temperature difference in the water profile. You may have noticed this in the summer while swimming. If your pond is stratified, you will notice the deeper water around your lower legs is noticeably colder than the surface water. Stratification is not a major concern, but it can contribute to pond management problems if specific circumstances arise.

Normal thermal stratification of a pond, if it is to occur, generally begins in May or early June and ends in September or early October. Soon after the ice melts in the early spring, the entire pond begins to circulate from top to bottom, maintaining a uniform water temperature. As long as winds are strong enough, the pond water temperature will remain uniform, even as the pond begins to warm during spring.

As the summer season brings hot, still weather, surface waters warm up more rapidly than deeper waters. As the difference in tem-

perature increases between

warm surface water and cool bottom water, a thermocline develops; creating a layer of noticeable water temperature change that acts as a physical barrier between warm water at the surface and cold water at the bottom. When a thermocline is

present there is no mixing of surface and deep layers of water. Because photosynthesis and oxygen production only occur near the surface, water in the deep layer becomes devoid of oxygen and develops an oxygen demand. The thermocline can be

broken by heavy wind and cold rain common during a summer thunderstorm, or by the installation and initial operation of a bottom aeration system. When the thermocline breaks down, the oxygen-rich surface water layer mixes with oxygendeficient bottom water layer. Whether a fish kill will occur is dependent on the ratio between the volumes of the two layers. If the oxygen deficient lower layer volume is equal to or larger than the oxygenated upper layer and the pond mixes, the result is severe oxygen depletion and potential fish kill. Bottom aeration, when in-

stalled in spring, is the method of choice to prevent pond stratification and reduces the chance of a summer turnover fish kill. If the system is sized correctly, stratification cannot occur because deep water is constantly pumped to the surface ahead of the bubbles and new oxygenated water from shallow area replaces the displaced deep water. Bottom aeration systems can either be electric or windmill powered as both do a good job mixing water in the pond.





#### HEAT, HEAT, AND MORE HEAT... AND SOME FLOOD-ING TOO

By: Josh Steiner About six months of this year have been record breakers. The months March through July have been the hottest months on record for many cities around the world including Moscow which broke its all time record when on July 26, 2010 the temperature soared to 99.76 degrees Fahrenheit. According to NOAA, June was the warmest month on record for the entire world since records started back in the 1800's. Some areas have had record rainfall especially during June and July when several massive storms systems stalled over the Central US which cooled them off, but brought extremely heavy rainfall and violent thunderstorms. One city that was hit especially hard at the end of July was Milwaukee, Wisconsin. Some areas in the city reported 7.5 inches of rain in only two hours. This rainfall caused flash flooding all over the city and the Milwaukee

International Airport was

closed because the runways

were underwater. Luckily,

the airport had already been

evacuated because of a Tor-

nado Warning earlier in the

day. Overnight, these storms

continued to produce heavy

rain and flash flooding. An-

other city that was hit hard

was Chicago. On Friday night

and early Saturday morning

of the 23<sup>rd</sup> and 24<sup>th</sup> of July, the

city was hit by heavy rain and

thunderstorms which formed

from the excessive heat in the

area. The greater Chicago area

had rainfall of up to seven

inches which caused flooding

because of the dry, cracked

ground from the heat. Fi-

nally, the cold front pushed

through the region bringing

more drenching showers and

storms and gave us a relief from the humidity and heat. This summer has also been full of heat waves. These heat waves from strong ridges in the upper levels of the troposphere. These strong ridges come from high pressure centers descending from the Arctic and bring extremely cool air into the United States. At the end of June this happened when a high pressure center after an extremely strong storm system brought storms which brought extremely cool air for June into the region. This high settled into the region for about a week and then started to strengthen into a strong ridge. This ridge brought extremely hot temperatures into the region for most of the eastern two-

thirds of the country. Wide-

spread Mid 90's to near 105

were common from the Great

Lakes to the East Coast. Ever

since then our area hasn't

even been in the seventies. Today, Wednesday, August 4, we are in another heat wave. This heat wave started when a high pressure center developed into a ridge in Arkansas and Mississippi and is now bringing extreme temperatures and heat indices to the Deep South, Mississippi Valley, and Ohio Valley. This heat is supposed to continue for another couple of days.

#### ODOT CONSTRUCTION AND MAINTENANCE PROJECTS WEEK OF AUGUST 2, 2010

**Defiance County:** 

Ohio 66, and Ohio 66 interchange with U.S. 24, Defiance. This project has received funding through the American Recovery and Reinvestment Act. –

The ramps on the south side of the interchange (the exit ramp from eastbound U.S. 24 to Ohio 66, and the entrance ramp from Ohio 66 to eastbound U.S. 24) were closed on July 6 for reconstruction. The ramp reconstruction work will be coordinated with the final stages of construction of the new structure over U.S. 24 and the adjacent roadway construction on Ohio 66.

Traffic on Ohio 66 detoured as follows during this phase:

—Ohio 66 northbound – Traffic detoured onto west-bound Ohio 15/18 to east-bound U.S. 24 to Domersville Road to westbound U.S. 24 back to northbound Ohio 66.

—Ohio 66 southbound

Traffic detoured onto west-bound U.S. 24 to eastbound
Ohio 15/18 back to south-

bound Ohio 66.

—Eastbound U.S. 24 traffic wishing to access southbound Ohio 66 will be detoured onto eastbound Ohio 15/18 to southbound Ohio 66.

—Eastbound U.S. 24 traffic wishing to access northbound Ohio 66 will be detoured to Domersville Road to westbound U.S. 24 to northbound Ohio 66.

On August 17, both the abovementioned ramps and the new Ohio 66 bridge over U.S. 24 will open to traffic. When the new structure and ramps open, the ramps on the north side (the exit ramp from westbound U.S. 24 to Ohio 66, and the entrance ramp from Ohio 66 to westbound U.S. 24) will then close for reconstruction. The ramps on the north side are scheduled to open September 23.

Work continues on the Ohio 66 (Clinton Street) bridge over U.S. 24 which was closed March 1 for five months for bridge replacement, widening and ramp reconstruction. Southbound traffic detoured onto U.S. 24 west to SR 15/18 to U.S. 24 east back to SR 66. Northbound traffic detoured onto U.S. 24 east to SR 281 (Domersville Road) to U.S. 24 west back to SR 66. Traffic on U.S. 24 is not currently affected.

Traffic on Ohio 66 from the U.S. 24 interchange to Sessions Avenue is currently one lane in each direction to allow for drainage work in preparation for widening and the installation of a raised curb median. The project will continue through October. Work is being performed by Mosser Construction, Fremont.

Ohio 15 one mile north of Ohio 18 – Shoulder and slope repair will reduce traffic to one lane through the work zone. Work is being performed by Defiance County ODOT.

Paulding County:

Ohio 111 west of Ohio 49

- Pavement repair will reduce traffic to one lane through the work zone. Work is being performed by Paulding County ODOT.

Ohio 637 south of Ohio 111 – Tile replacement project

will reduce traffic to one lane through the work zone. Work is being performed by Paulding County ODOT.

Ohio 637 over Maddox Creek between County Road 24 and County Road 12 – Route will close for 21 days beginning August 2 for bridge rehabilitation. Traffic detoured onto U.S. 224, U.S. 127 and Ohio 114 back to Ohio 637. Work is being performed by Vernon Nagel, Inc., Napoleon.

River Street (County Road

424/old U.S. 24) from Main Street to Island Street in the village of Antwerp – Pavement reconstruction, water line, sidewalk and curb work is under way. 

#### STIMULUS-FUNDED CON-STRUCTION ON OHIO'S **HIGHWAYS NETS 8000 JOBS IN JUNE**

During the same month that President Obama visited Ohio to mark the start of the nation's 10,000th road project paid for by the Recovery Act, more than 8000 construction workers had jobs on Ohio's stimulus-funded transportation projects in June, according to preliminary figures collected by the Ohio Department of Transportation.

Monthly reports from Ohio's contractors show that 8,335 workers were paid with stimulus funds last month mostly working on highway, bridge and pedestrian/bicycle construction projects across the state. That's a 19 percent increase from the month before, when contractors reported nearly 7,000 jobs in

Those same June reports also show that construction workers clocked in 332,448 hours on the job and earned nearly \$10.5 million in paychecks in a single month.

These new job figures add to the thousands of jobs already created and retained Ohio's transportation stimulus investments. Since the start of the Recovery Act, Ohio workers on stimulusfunded transportation projects have earned more than \$52 million, clocking in 1.9 million hours on the job.

From June through September, ODOT anticipates more than \$40 million in paychecks will be earned by these laborers and workers, as the summer construction season intensifies on these stimulusfunded projects across the

As of mid-July, ODOT and its local partners had awarded more than 381 contracts on stimulus-funded transportation construction projects worth more than \$871 mil-

"Through these Recovery Act investments in transportation, we are putting more Ohioans to work and helping to ignite the state's economic engine," said ODOT Director Jolene M. Molitoris. "A true 21st Century multi-modal transportation system will strengthen Ohio's competitive position in national and global markets and revitalize our cities and towns.'

President Obama was in Columbus in June for the start of work on a \$15 million stimulus-funded roadway and sidewalk project near Nationwide Children's Hospital, recognized by the White House as the 10,000th stimulus road project to get underway in the country.

While a majority of the Recovery Act projects are improving Ohio's roadways and bridges, new to the list of stimulus-funded projects to get underway are a \$6.8 million intermodal crane replacement project at the Port of Toledo and a \$3.3 million waterfront redevelopment project along Lake Erie in Lorain County.

Also in the past month, the Federal Aviation Administration added more than a quarter of a million dollars in additional funding to the state's stimulus construction projects at four airports, bringing Ohio's total aviation Recovery Act allocation to \$24.5 million.

He stated the tires have not been cleaned up at Heckley's and requested Officer Carpenter inform them that the Board of Health is being notified. Councilman Mason will contact the Board of Health.

Officer Carpenter reported the Grant application was submitted. If the City receives it, the federal government will pay everything for a full time officer for three years and the City will have to keep the offi-

cer on for an additional year.

Mayor stated we need to purchase a jack and tire wrench for the Trail Blazer. The fog lights and glove box lock needs to be replaced. A hose and spray nozzle will need to be purchased for the water tank. Mayor stated the project on Carl St. was changed, he feels it did not work and will contact them. Lesa reported the printer


