## LEAVES ARE A VALUABLE ORGANIC RESOURCE

Leaves – love 'em or hate 'em? This time of the year, leaves are an issue for those of us that have mature trees, especially if many of them are oaks. Raking can become wearisome, as the oak trees tend to spread out their leaf loss over a long period of time. It's not as if raking is a one-time autumn chore.

The benefits of fallen leaves are undisputed. But too much of a good thing can seem like a bad thing. Put those leaves to work for you! Here are some ways to make good use of all those leaves:

—Use them as garden mulch. If you allow whole leaves to remain around your perennials in the garden, they tend to mat down and smother plants as well as create a breeding ground for pests, especially slugs. But chopped with a mower or shredder, they make a great mulch. Spread a two- to three-inch layer of chopped leaves around plants to help insulate the root zone through the winter. As with any mulch, make sure you keep them from actually touching the base of the plant

### THE FAIRVIEW GRANGE HALL DESTROYED

On Tuesday afternoon of October 26<sup>th</sup> the Fairview Grange Hall was completely destroyed by a violent wind storm. I guess the pilots would call it a wind sheer or a micro burst. Or it could have been a tornado as a number of them were reported in the area and some were confirmed. I guess the building was built in 1891 and was used as a church for many years until 1907.

I guess the Grange was started nationally in the middle 1800's. It was to foster and perpetuate farming and to bring all the farms together and help each one, and to pass farming news and comradeship.

Eventually the Grange Insurance Company came out of it and is a nation-wide business now.

The Fairview Grange #1666, in its time was very active. Around the turn of the century and up until the 1940's. It held the Farmer's

Institute, sponsored 4-H Clubs for many years, had many dramas, and plays on the stage. It had lots of picnics and carry-in dinners. I was told at one time they met twice each week. This was reduced as time went on. I guess it was closed now to monthly meetings, but at inspection time it was used for authenticity.

The Fairview Grange still has their Charter, but for the last few months they met with the Payne Grange at the Essen House for a breakfast meeting.

Their 99 year lease was about to run out a few years ago, so they talked with the land owner and she told them that as long as there was a Grange Hall #1666, they were welcome to stay and the lease was extended.

For many many years, The Fairview Grange #1666 was a very active part of this area and is still active but the building now is a part of history.

to avoid stem rot.

—Use them as a soil amendment. Clay soil is the bane of our existence here in northwest Ohio. It's hard to work with and many things find it hard in which to grow well. But add shredded leaves to it and the organic material will help break it up and allow for better drainage. The beauty of using shredded leaves in soil is that they also improve sandy soils by help-

ing increase moisture retention. They add nutrients as well, but the real advantage is as a soil conditioner.

—Lawn mulch. If the leaf cover isn't too heavy, simply mowing over it will provide your lawn with a wonderful mulch. Leaf litter added to the grass clippings returns nutrients to the soil and the shredded leaves will help insulate the lawn during the cold winter months.

—Compost them. Shredded leaves compost faster, but even adding whole leaves to your compost pile will contribute that valuable "brown" factor required for rich compost.

If you still find that you have too many leaves, share them with your friends and neighbors who may not have enough. In any case, don't be tempted to burn them. The smoke contains carcinogenic toxins and in most areas, burning leaves is illegal.

## AN UPDATE ON THE NEW ROAD PROJECTS IN AND AROUND THE CITY OF WOODBURN

On March 15, 2010 the contract was awarded to do three projects at a cost of \$287,880.78. These projects will be paid with 100% Federal American Recovery and Reinvestment Act. Locations are: Woodburn Road from Hetric Road to State Road 101 (west). State Road 101 to Broobst Road (east), and Bull Rapids Road north to the City limits (north). Added to these, the County agreed to extend new asphalt from our City limits on Bull Rapids Road north to the new highway construction project. Along with that, the county chip 'n sealed Maumee Center Road between US 24 and Highway 101 and Sampson Road from Woodburn Road to US 24.

He says that while he and his wife were out driving he noticed they were low on gas. So he pulled off at the first exit and came to this dumpy little gas station with one pump. There was only one man working the place, so he asked the man to fill it up while he checked the oil. Wheeler added a quart of oil, closed the hood and then noticed his wife talking and smiling at the gas station attendant. When they saw him looking at them, the station attendant walked away and pretended as if nothing had happened. Wheeler paid the man and he and his wife pulled out of that seedy little

station. As they drove down the road, he asked his wife if she knew the attendant. Well, she admitted she did know him, in fact, she had known him very well. For it seems that they not only had gone to high school together, but they dated seriously for about a year. Well, Wheeler couldn't help bragging a little and said, "Boy, were you lucky I came along. Because if you'd married him you'd be the wife of a gas station attendant instead of the wife of a Chief Executive Officer."

His wife replied, "My dear, if I had married him, he'd be the Chief Executive Officer and you'd be the gas station attendant."

**PAULDING COUNTY CHRONICLES I**

*Reminiscences of Old Fort Wayne Part 1*

The following insert was given to the Mary Penrose Wayne Chapter Daughters of the American Revolution several years ago by Mrs. Lucien P. Ferry of Decatur, Indiana.

"My father, Louis T. Bourie, who was an Indian trader and an interpreter, came to Fort Wayne in 1762, before General Anthony Wayne built the fort here in 1794. Later he became a warm personal friend of

Anthony Wayne.

"There were only two houses standing near the old English Fort, and it was near these that my father built a home and brought his family to life. This old English Fort was built before 1762, between the St. Joseph's and Maumee Rivers, in what was then known as the "Old Apple Orchard" and now known as Lakeside.

"After living here for a while, he moved back to Detroit but becoming dissatisfied there, he finally moved here again, this time to stay. This was in 1814 and I was a baby three months old. "When I was older, I was told how we came her from Detroit by water in a pirogue—boat hewn from a large log—the boat being large enough to hold trunks, bedding, passengers and a good stock of provisions for a long trip.

"The only means of travel in those days was by water or horseback, an occasional wagon came sometimes from Ohio or Kentucky. When my father and his family landed, he found that his house had been burned to the ground, 'fired', so we were told by the Indians.

"While my father was building a new house we lived in the fort built by General Anthony Wayne and saw a great deal of military life there. The new house was built on East Columbia Street between Clinton and Barr Streets, near the fort.

"After my father's death my mother and I went to live with my oldest brother, John Bourie, who had married and built a home on East Columbia Street, opposite my father. This brother was the father of the late Louis T. Bourie and Miss Desdemona Bourie, who is still living with the family of Louis T. Bourie in Lakeside. "My sister, Hattie, married Colonel George Washington Ewing, so well known in the early days of Fort Wayne.

"About the year 1822 I was sent to school and this school was held in the fort. My teacher was a Baptist missionary by the name of McCoy. This same missionary baptized by immersion a daughter of Captain Wells, who, as you know, was a brother-in-law of Little Turtle. Captain Wells had three daughters: Rebecca, Ann and Jane. Ann married Dr. Turner; Rebecca married Captain Hackley and Jane married a Mr. Gregg. There was great excitement when Captain Hackley hanged himself at his home in Bloomingdale. This, of course, happened when I was a child.

"I next went to school in the Council House. In one room there were cupboards full of tobacco to be sold or given to the Indians. Whenever the boys were unruly, they were shut up in these cupboards until they were almost suffocated. I next went to school in the jail, which was situated where the Court House now stands. The old jail was built of logs and I remember being told of a man by the name of Alexander, who was imprisoned very often for debt. This happened so often that upon investigation it was found that he could lift out one of the logs, step out and replace it. (So

he learned how to beat the system)."

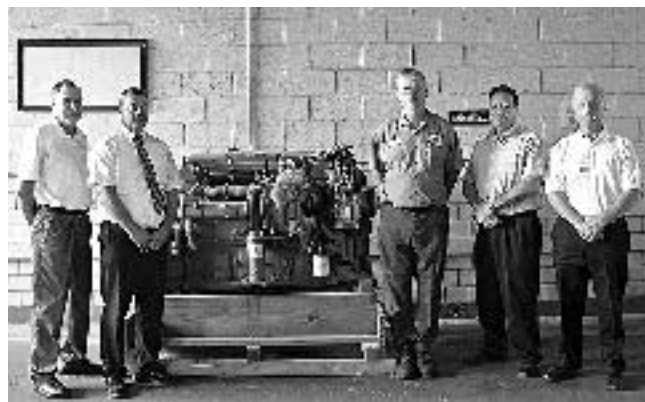

Dorothy talked to me a lot about New Guinea. They were there for two years and it is a very poor country and a complete turn around for what we have here.

They don't wear much clothing. The ladies go naked from the waist up. The men wear a sort of loin cloth. Most of the men chew 'Beetle Nut', it leaves their teeth and mouth area blood red. This nut also has a stimulant or something that gives the men a high.

The men can have more than one wife. It don't seem to cause a lot of trouble. The men are boss and the women do most of the work. Raising a hog or so is done in about every household. Sometimes a man will trade a hog for another wife.

The mission was in the mountains and it took three hours of miserable riding in a truck to get over to Mt. Hagan for supplies. Sometimes you could buy American-type food. If they have some just in off the boat you buy extra, because American food don't last long.

Then you have a three-hour ride back in the truck. The trip is horrendous bad roads, curves, heat, moisture and travel sickness. It was a chore to go to town. No points of relief, just in the undergrowth.

At the Out Station was the churches and schools. Most churches were allowed to teach at some time. This was a teenage school.

They were there for two years and everybody loved everybody. When it was time to leave, there were tears and sobs, and each side was feeling sad and lonely and John and Dorothy felt as bad as anyone. They were on their way home but they were leaving some fine people.

It was 1982 and they were sent to Andros Island in the Caribbean. They lived close to the shore of Caridan.

There at the church, John did the maintenance and Dorothy held service, taught songs, music, and Dorothy also taught art and was in charge of the Christmas Program. The time went fast there and it was soon time to be relieved.

In 1987 they were sent back to Belize and there were lots of changes for the better, a new causeway to the Crooked Tree Island and a lot

of progress also. They landed at Belize City and then traveled about 30 miles inland. She ran the medical clinic while the two nurses were gone. She loved to help the children's cuts, scrapes and lots of lice and worms was the most common and they were so grateful and loving.

I asked her about electricity, and she said they had a generator, but all the water came from the river. Downstream was the drain for the toilet, next was the clothes washing area, then came the water for bathing and then the drinking water.

They left that area and again they left a lot of friends. Their replacements came and they went back to Ohio.

In 1989 they started to work at the Jacob Eaton Home in Paulding. John and Dorothy were house parents. John got sick in 1998 and passed away. Dorothy went back to the Jacob Eaton Home and worked, but she missed John's good help. She worked there for eight more years and then retired out of there. She took care of a lot of children in those years and knows she helped them. She was well liked by the pupils and students while at the home.

She is now living in Paulding, but she is very active in a church called 'The Bird Lake Wesleyan Church' in Osseo, Michigan.

I asked about her hobbies. She likes to read and travel and help at her church a lot. She writes a column for the church newsletter every month.

At her church she does everything she can. She talks, leads the meetings and helps with the music.

Well, Dorothy, you and John helped a lot of people over the years. Maybe you didn't get done as much as you wanted, but you were certainly a dedicated couple.

Like always it was so nice talking with you and telling the people about your missionary work.

**YAMAMOTO**

In early April of 1943, the Navy force in the South Pacific intercepted a message for the Supreme Headquarters in Japan to all the Japanese forces in the Solomon Islands. It said that Admiral Yamamoto would be visiting the area around Bouganville. The Admiral was the man in charge of the whole Japanese operation, Army and Navy.

The Japanese were very exact and strict about times and instructions. The message said they would be leaving at 6:00 a.m. out of Rabaul on a certain day in April (about two weeks yet) and would be in two 'Betty' Bombers and an escort of 4-Zero Fighters.

The fact that the Americans had broken the Jap Code was one of the best kept secrets of the war. I don't think anyone below a 'bird Colonel' was allowed to know that.

On the American side, each Admiral would ask for superior officers, if they could shoot down Yamamoto. Well, this went all the way to Washington, D.C. and President Roosevelt gave the okay to intercept that flight. But he and all the brass stressed the fact that Admiral Yamamoto had been killed. Because if the Americans knew he was in that plane then they would know we have broken their code. So it was just called an important mission.

From Henderson Field on Guadalcanal to a small island of Bouganville was about all a P-38 using regular gas tanks could go one way. So sixteen dropable gas tanks were located and flew in for the important mission. All the pilots were deemed the best from all the outfits on Guadalcanal. The crews worked day and night to get those 16 P-38's ready to go.

Practice after practice and meeting upon meeting and the rules and instructions were set. They left about four in the morning flying right down on the water for almost all the distance. Radio silenced—we don't want them to know we are coming. We want them to think we are just a morning patrol.

It was a long tiresome ride over the water. Stay as low as you can, but don't let your prop hit the water.

After about daylight one of the planes developed motor problems and limped back to Henderson Field.

They rendezvous just a few miles out of Bouganville and flew up to a few hundred feet altitude to look for the enemy. Just like the Japs are, one of the pilots broke silence to alert all the pilots. That was at 9:34 p.m., right on time.

There was to be four fighters to shoot down the 'Betty' Bombers and the rest of the planes to fly top cover.

Lieutenant Rey T. Barber took on the first bomber and watched his tracers go into the fuselage and engines. Soon the right engine began to smoke and as the Lieutenant turned to take on the other bomber he saw the first plane crash into the jungle below. That was the plane that carried Yamamoto. The flight leader said, "Let's get out of here," and they did. They had shot down both 'Betty' Bombers and four Zero's and lost one P-38. The remaining planes flew

at top speed for Henderson Field and made it okay. The pilots could not tell anything because they still didn't know who they had shot down.

A Jap party found the plane the next day in a very thick jungle. Yamamoto had been shot through the lower left jaw and the left shoulder. He had been thrown clear and was still in his seat under a tree with his left hand holding the hilt of the sword.

His body was cremated at the town of Buin in New Guinea and the ashes was flown back to Japan. His ashes are buried in a public cemetery in Tama, Tokyo.

As a brilliant leader, he had his doubts about the success of this whole operation. See ya!

November 13, 2010, will mark the 50<sup>th</sup> anniversary of the vicious abduction and murder of Nancy Lee Eagleson of Paulding. Nancy's family and those of us who lived through this tragedy still remember, still mourn, and still hope that, one day, this crime will be solved. Nancy will always be remembered as a sweet young woman who felt the pain of others and who was not afraid to help and defend those in need. Her violent death profoundly affected the village of Paulding and forever altered the fate of her family members and friends. Even in death, Nancy can be

considered a champion and a symbol in the campaign to end violence against women and children in America.

To honor the memory and short life of Nancy Lee Eagleson and commemorate her tragic death, a memorial service will be held Saturday evening, November 13<sup>th</sup> at 7:00 p.m. at the First Christian Church in Paulding, 1233 Emerald Road. There will be music, prayers, and memories shared. The service will be casual, and anyone who wishes to speak may do so.

Following the service, rain or shine, there will be a march for all who wish to participate, to further commemorate this event. Approximately 8:15 p.m. on the 13<sup>th</sup>, participants will gather at the site of the former Paulding (Movie) Theatre in the 100 block of West Perry Street. From there, participants will march to Jackson Street and then proceed along Jackson Street to the site of the abduction on Flat Rock Drive. At the abduction site, there will be a prayer and a moment of silence before dispersing. Marchers are asked to bring a flashlight or candle to light the way and wear light-colored clothing.

Please consider honoring the life of Nancy Eagleson on November 13<sup>th</sup> to show that our community still cares and still waits for answers.

**LETTER TO THE EDITOR**

Recently Daniel Eric Martinez was diagnosed with Multiple Sclerosis. Multiple Sclerosis (MS) is a disease where the body's immune system attacks its own nervous system. It can be a very debilitating disease. Eric's disease was found extensively in the brain and is now appearing in the spinal cord.

Eric had several illnesses throughout the winter that resulted in long periods of time off work. In March he thought he had scratched his cornea, within a week he had lost all his vision in his right eye and he was told it was Optic Neuritis. A week later he was diagnosed with MS. He had to face

the possibility that he would never fully regain his vision and didn't know when he could return to work. He has since regained his eyesight.

Eric is a CCNO corrections officer and being very fit and alert is a requirement of his job. He was able to return to work at the end of May. He was able to work for two weeks before had a relapse, this time in his left leg. He spent a week at the Cleveland Clinic where his family never left his side. He was then transported to the Fort Wayne Rehabilitation Hospital for two weeks. He was released and was required to attend outpatient rehab three to four times a week. He is still attending rehab two to three times a week.

It was during this period of time that his wife (Tiffany Gaskill Martinez) lost her job. Tiffany has Type 1 Diabetes and sometimes has not been able to take the right insulin because of money. With both Eric and Tiffany out of work and trying to raise a three year old daughter, attending physical therapy every other day in Fort Wayne becomes even harder. He still has trips to Cleveland every other week. He lost his insurance in July and the medical expenses have continued to pile up. At the time he has been denied disability and social security benefits, so no income.

In August he decided to return to BGSU to finish his education degree. The doctors do not know when or if he will be able to return to his job at CCNO. But Eric felt that God has granted him this chance to return to college and finish his degree. With his education degree he knows that with the steady decline of his health, he would be able to continue to support his family. He wants to educate the community of this disease.

At 27 years old he continues on and is determined to do anything he can to live a successful life, despite not being able to work and the bills keep accruing, he will succeed. His entire family has stood behind him and his continued success. After being wheelchair bound for many months, he now walks with just the assistance of a cane. He is now beginning to student teach in Paulding and Toledo.

However, all of this has taken a huge financial toll on all of his family. Some weeks he has to decide between physical therapy or class because the money for gas is not there.

This is the reason a benefit is being put on for Eric and his family.

The benefit will be held on November 6, 2010 at the Paulding VFW. There will be a two man corn hole tournament, an auction, 50/50 raffle, children's games and live entertainment. A meal will be served all day starting at 2:00. The menu includes pulled pork, scalloped potatoes, baked beans, salad, chips and dessert. There will also be a bake sale, silent auction all day and a live auction starts at 6:30.

**LETTER TO THE EDITOR**

On Friday night I took my eight month old twins trick-or-treating. Since they are too young for candy they collected money to raise awareness and for research of Congenital Diaphragmatic Hernias. My daughter, Kennedy, was born with this condition and we thought this would be a good way to spread the word!

Congenital Diaphragmatic Hernia (CDH) occurs in approximately one in every 2,500 births (1,600 cases in the U.S. each year). The cause of CDH is not yet known. The diaphragm is formed in the first trimester of pregnancy and controls the lungs' ability to inhale and exhale. CDH occurs when the diaphragm fails to form or to close totally and an opening allows abdominal organs into the chest cavity. This inhibits lung growth.

Every patient diagnosed with CDH is different. Survival rates depend on the types and number of organs involved in the herniation and the amount of lung tissue available. There are many surgical procedures and complications that may or may not occur with each individual, including in utero surgery.

Roughly 50% of babies born with CDH do not survive. Of the 50% that do survive, most will endure long hospital stays, feeding issues, asthma and other problems. A few of the survivors suffer from severe long-term medical issues.

In our case we were very lucky and Kennedy's hernia formed later in the pregnancy and her lung was almost fully developed. She did have as many complications and other babies born with it. Kennedy spent a total of three months in the hospital and had three surgeries in a span of about five months.

CDH occurs as frequently as Spina Bifida and Cystic Fibrosis, yet there is very little research being done and virtually no media coverage. We really want our community to be aware of this condition and the number of people it affects. Hopefully in the near future we will be doing some more fund-raising and awareness events! Keep your eyes and ears open!

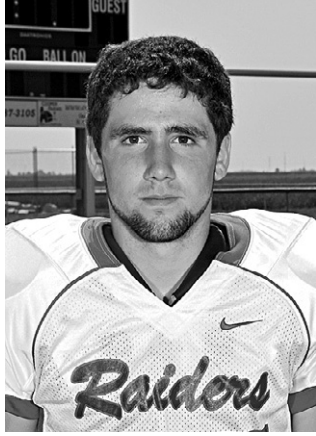

### STORY OF THE OLD AND THE NEW

I can sit here at my desk at the WBN and look east and see the new renovated East River Street. This is also called Old 24 or County Road 424 now.

I'm going to describe this corner of 424 and SR 49 like it was when I was seven or six years old.

Where the WBN office and parking lot is now, at that time, was a big two-story building that housed Tom Foster's Clothing Store, but due to the Depression it was sold and the building torn down and it became a gasoline station operated by

Chas VanHorn and later became a barber shop.

Across the street to the south in the three-story building was the Doering and Long Grocery and Department Store. Across SR 49 to the East where the Marathon Drive Thru is now, was a gasoline station. They sold Winged 70 Gasoline, owned by Art Rodgers and operated by Everett Carr and his son Harry. Across the street to the south was Battershell's 5 & Dime Store, that is where the Subway is now. What is now there beside the Subway—the Zartman's Safeway Driving School—at that time was a Sinclair Gas Station. That station was managed by a number of men: Bob McLaughlin, Roy Miller, Sam Grimes and some others.

On the north side of East River Street right out close to the street was a small hamburger shop called The Cupie Shop operated by Leroy Gaisford. What is now Kam-meyer's IGA parking lot was three houses. The west one was a family named Jump who moved away in the

early 1930's. Then there was the house where Mr. Foster moved his clothing store to in the late 1930's. This house was moved down on Kroos Drive. The last house on the left side was a large house built by Ed Gordon who operated a hardware on North Main Street. This house later became Dr. Bazzali's house.

The State of Ohio made that street and road U.S. 24. At that time it was a stone road all the way to the State Line.

This street was paved and concreted in 1931 and was a good road until the big trucks wore it down over those many years.

The construction company that did the renovation of East River Street did a very good job—new storm drains, new water lines, curbs and walks, landscaping with the village installing new street lights. That new part of the street should last for many decades if the big trucks stay off of it. It is now just a country and city road and street.

**INDIAN SUMMER VIOLENT STORMS & COLD, SNOWY LATE FALL**

Last week on Tuesday a powerful storm system moved through the Great Lakes region, hit the area shattering records—wind speeds, tornadoes, thunderstorm winds, and even pressure. At about 4:00 p.m. Tuesday, the atmospheric pressure bottomed out at an incredible 28.20 inches (954 mb) which made it the lowest air pressure ever officially recorded in the United States from a non-tropical low pressure system even by-passing the Great Blizzard of '78. There have also been unofficial reports of air pressure being below 27.95 inches on Lake Superior and in Southern Ontario.

The storm system was also so strong that it pulled arctic air from Canada causing a major blizzard for most of North Dakota, Minnesota and Manitoba, Canada. This blizzard had winds of up to 75 mph wind gusts and dumped almost a foot of snow over central and northern North Dakota, parts of Minnesota and Southern Manitoba. Throughout the rest of the Midwest, all of the Great Lakes region and the North Central states, the National Weather Service had issued a High Wind Warning for sustained winds of 40-50 mph with gusts of up to 70 mph. This caused major power outages over Iowa, Illinois, North Dakota, South Dakota, and Minnesota. In Ohio and Indiana, a major severe weather outbreak had wreaked havoc across the area with storms producing tornadoes and high winds in excess of 80 mph. The severe weather had come from a line of storms that had formed over Missouri and Illinois in the overnight hours when the Storm Prediction Center in Norman, Okla-

homa issued a very high risk for tornadoes and damaging winds on Tuesday. The line of storms then intensified as predicted and raced across the area late morning producing tornadoes over area with several tornadoes reported in Paulding and Allen counties in Ohio and Indiana. After the storms had gone, storm damage was incredible across the area especially in Grabill, Indiana where an EF 1 tornado had been confirmed by the NWS which had destroyed many barns and snapped power lines and many trees. In Paulding County, two tornadoes were confirmed in the southern and eastern parts of the county where one was in Scott as an EF 1 and one in Oakwood as also an EF 1. North of Antwerp, the Grange Hall was completely demolished by a possible tornado or straight line winds. I had seen this when my dad had shown me pictures of the destroyed building. After the storm had passed through, temperatures dropped significantly on Thursday when we didn't even make it out of the mid 40's.

For this week and beyond, forecasts are showing that temperatures will be in the 50's for this Wednesday, November 3, 2010 and then for Thursday, November 4, 2010 temperatures will drop to the mid-40's with rain and gusty winds and then further to the upper-30's for Friday with snow showers at night. Also, nighttime lows will drop to the mid- to upper-20's by the end of this week. By next week, though, temperatures will be climbing again to the upper 40's and low 50's, but this time I don't think that we will have a major warm up.

For the rest of November, our temps will stay below average for most of the month with a possible severe weather outbreak mid-month but turning cold again. Snowfall will be above normal with

several possible accumulating snows by the end of the month. Mostly, our snowfall will come from numerous Lake Effect snow showers making their way into the area and giving up to an inch of snowfall at a time. In December, temperatures will take a dip again with possible record low temperatures. Lake Effect snowfall will be up also giving us several inches, but mainly our snow in December will be from big snowstorms dumping on us up to 15-18 inches in one of them.

In January, a high pressure center will develop in the Southeast United States causing temperatures to rebound to near normal in our area. January will also have an extreme ice storm threat because temperatures in the north will be extremely cold while temperatures in the south will be extremely warm which would bring us right in the middle which is usually where ice storms form when storm systems cross our area. By the end of the month, our temperatures will be getting colder again with a big snowstorm to end the month. February will start off with a very cold air intrusion from the north setting the stages up for the biggest snowstorm of the year with snowfall amounts ranging from 15-22 inches. But by March, a spring teaser will be in line with temperatures rebounding to the mid-70's causing a major tornado threat come mid-month. By the end of March, temperatures will be in the 20's and teen's again with another possible snowstorm of up to

13 inches.  
Now remember these are only educated guesses are probably aren't even that accurate, but when forecasters say that temperatures are supposed to be below average and snowfall above average they are only averaging everything out. So there still could be warm temperatures and dry periods with no snowfall. Also during La Ninas, temperatures can be in the 50's and 60's one day and the next we could be below zero. This is also why we have an ice storm threat. So this winter be PREPARED for any change in weather conditions.
