Joe Fisher graduated from Paulding High School in 1998, where he earned three letters in football and baseball, while earning 1 letter in basketball.

In basketball, Joe was a member of the 1995 Northwest Conference Championship team and won the JV Coaches Award the following year. During his junior year, he was voted the Most Improved Player for the Varsity

During his baseball career, Joe earned multiple team and conference awards. His junior year he was an Honorable Mention Northwest Conference selection as well as being a Northwest Conference Scholar Athlete, and he participated in the District All Star baseball game. As a senior, he was named First Team Northwest Conference

and was once again a Northwest Conference Scholar Athlete. Joe also received numerous team awards during his junior and senior seasons.

It was on the football field where Joe really excelled as he was a three year starter and three year all league performer. He was a Second Team All League selection his sophomore and junior years, while landing on the First Team his senior season. freshman and sophomore years, teaming up with his twin brother Todd to play second doubles. His senior year he ran track in the spring and was a member of the 4 x 400 and 4 x 800 teams that made it to the regional finals.

On the football field, Tony started his junior and senior years at quarterback for teams that went a combined 18-2, including a 10-0 record his senior year. That team won the Northwest Conference Title and finished the season ranked 7th in the state. Tony was selected as a first team all conference performer his senior year at quarterback, unseating the previous year's first team winner. He also won numerous team awards during his football career.

Basketball would prove to be the dominant sport during Tony's time at Paulding High School as his name appears throughout the record books. His high school career started by his team winning the Northwest Conference championship his freshman year. Tony was a three year starter and earned many team awards while serving as Team Captain and All Northwest Conference honors his senior year. He currently has the following places in the Paulding High School Basketball Record Book: two of the top six single game rebound totals, fifth in career field goals made, fifth in career points, third in rebounds in a season and a career and also holds the school record for most steals in a sea-

son and a career. After high school, Tony went on to Ohio Northern University where he earned a degree in Civil Engineering. During this time, he participated on the basketball team and received many honors. His senior year as a team captain, he led the Polar Bears to the NCAA Division III Na-

tional Championship. Tony currently resides in Lancaster, Ohio with his wife Kellie, and three children, Zachary, Bryson and Brooke. He is the Director of Utilities in Fairfield, Ohio.

Scott Woodard graduated from Paulding High School in 1984, where he earned 11 varsity letters: three each in basketball and football and four

On the track, Scott was a member of the 1981 Northwest Conference championship team, as well as the 1983 district championship. He was awarded the Most Valuable Runner during the 1983 and 1984 seasons. Scott was a member of the 4 x 400 relay team that competed at the state track meet and set a school record in 1984.

In basketball, Scott was a member of the 1984 Sectional Championship team while earning a spot on the Northwest Conference Honorable Mention team. That team also won the Van Wert Holiday Tournament, beating Wayne Trace both times for the title. His name appears in the Paulding High School basketball record book in a couple of

places. Scott holds the school record for best free throw percentage in a season (83.6%), and ranks fifth in number of free throws made during a career (169).

During Scott's three years as a varsity football player, Paulding High School went 26-4 and won the Northwest Conference title his senior season in 1983. He obtained Northwest Conference First Team honors as a defensive back and Northwest Conference and District Honorable Mention as a running back during his junior season. Scott led the team in rushing and was named the Most Valuable Back and Player on that team. His senior year he was a co-captain and once again led the team in rushing. He was named to the Northwest Conference Offensive and Defensive First Teams, and he was also named the Second Team Kicking Specialist that season. Scott also made the All District Second Team and was an Honorable Mention All State selection his senior year. During his career he rushed for over 2100 yards, had almost 2600 total yards, and scored 201 points. Scott was also a multiple Crescent-News player of the week selection.

Scott currently resides in Pigeon Forge, Tennessee.

### WE MUST FAIL IN ORDER TO SUCCEED

failure is comical. I don't care if it is in business, personal lives, or politics; everything has to be spun as if it were a success. As soon as something bad happens, the talking heads start spinning it as an astounding achievement for whatever group they are associated with. Nothing is ever negative.

As individuals, we, like

the political and other figures of our day, have this tendency to declare everything we do a success. We want to hide mistakes and failures. But what does this do to our growth if we actually grow more in our failures than in our successes? What are we turning ourselves into if we try to isolate ourselves from failure or deceive ourselves from really facing our failures?

Martin Luther, during the Protestant reformation, was influential in taking education out of the realm of the church and into the hands of the state. Dr. Marilyn Harran notes that by doing this, "Luther allowed both teacher and student to rejoice in learning and to permit mistakes and even failure without undermining a person's value and importance." In order to be content and have a healthy self-esteem, we must separate our worldly success from our inner peace.

We live in a culture where we attack failure so harshly that people become afraid to act because they are afraid to fail.

Unfortunately, this can happen in a church. It often seems like church leaders are like clay pigeons at a shooting range. As long as they are not doing anything, maintaining the status quo, and not rocking the boat, they are safe. But as soon as they start to move, the gunfire ensues and attempts to blow them to pieces. A healthy church is just the opposite; it is a place where people can be creative about ministries, attempt different things, and have people there to support them and encourage them when they fail. Every leader of every ministry in any church will fail at times. I will deliver some bad sermons. We'll attempt some outreach programs that won't click. The worship will be a distraction some times and not conducive to us worshiping God. Some children's programs will be too chaotic and not gel. Every ministry will have failures, but a healthy church is a place where it is safe to fail. Instead of attacking and tearing down leaders in your church when they fail, be a place that builds up and encourage when people stumble.

A healthy family is like that healthy church. It's one where everyone is a pillar of support under each other to propel one another toward their dreams: A place where children can try new things and have people there to support them and encourage them when they fail. And a healthy church and a healthy family must be made up of healthy individuals who feel free to try different things and know they will be valued and supported when they fail. Because if we are honest with ourselves, failing is something we do an awful lot if we are actually trying to grow. It's excruciating to watch kids learn to ride a bike. It's

rare to have that kid who can just pick up a bike and start riding. They fall and hurt themselves, but the adults around them encourage them to get back on and try again. The adults don't yell at the children and scream, "You suck! Why are you always falling you stupid idiot!?" The kids are already telling themselves that in their head and sometimes even out loud. What they need is encouragement because the goal is to get that kid riding his or her bike. Eventually, through the pain and suffering, they can ride the bike and feel a sense of accomplishment. The safest way to never

fail is to never try something new or different. We all know picky eaters who will not try new food. I am not one of them. It doesn't mean I will like everything I try, but it does mean I will taste it. Being a picky eater does have its benefits. It means that they will only eat what they like and not have to taste food that they dislike. I have experienced some disgusting tastes in my life when I have tried different foods. Not having those bad tastes does sound like a good thing, but it also means that I would not be able to discover what would possibly be my new favorite food. We miss out when we

May we not let our failures define who we are. May we continue to learn through every situation and grow into who God wants us to be.

#### PAULDING CO. CHRONI-**CLES II**

(Latty Twp. 1892 Paulding Co. Atlas) Josiah Upthegrove—A successful farmer and stock raiser, was born in Highland County, Ohio in March 1848, the son of Andrew and Susanna (Rollins) Upthegrove, freedmen of Virginia and Carolina. The mother died when her son was only 18 months of age. He was left to the care of his Uncle Randal Upthegrove, where he remained until he was 18 years of age.

After working a short time, he came with his uncle to Emerald Township, Paulding County and remained until 1865 when he went to Greene County, Ohio and married Miss Carrie E. the daughter of Burt and Martha Kirk of North Carolina, the latter of whom was a slave. They then returned to Paulding County.

They had six children: Charles H.; Mattie J.; Fannie H.; Mary E.; Thomas A.; and Minne D. Mrs. Upthegrove died June 6, 1885 of quick consumption. Her husband, by hard work, continued to gain property and prominence in the county of residence and by 1892 possessed 120 acres of improved land.

In connection with his farming, he loved and raised horses. Mr. Upthegrove was a member of the United Brethren Church and was a staunch supporter of the Republican Party in politics.

(Jackson Twp. 1892 Pauld-

ing Co. Atlas) John Upthegrove - (deceased by 1892) was a native of South Carolina and was born in 1825, in the bonds of slavery. He was one of a number brought from the South Carolina, in 1835, by their owner, Henry Upthegrove, and set free in Clinton County, Ohio. In the latter place John Upthegrove grew to manhood and subsequently went to Fayette, County, and then he purchased 180 acres of land when he relocated in Emerald and Jackson Townships. He cleared this land and made improvements on it and it was then the residence of his widow and children after he died. He married Phoebe J. the daughter of Benjamin Jones, of Clinton County, Ohio and 11 children were the issue of this marriage. They were: Rev. Henry H., of Eaton, Ohio, colored Methodist Episcopal church; William Henry (deceased). Sarah, wife of William Christ; Mary M. wife of John Jones;

John Upthegrove died in November 1890. He was a member of the Methodist Episcopal Church and was highly respected. He was a republican in politics and filled offices of township trustee and supervisor.

Olly, Ida, Cora and John.

Note: This family is still prominent in Paulding County. I welcome all correspondence concerning this family and the history of the families related to them. Slavery was not legal in Ohio. I am unsure how many black Union soldiers fought in the Civil War or if any went from Paulding County. Thanks for your reply.

#### **USING DE-ICERS**

#### By: Jim Lopshire, Extension Educator

The presence of ice and snow should remind us of our options to keep important areas clean and safe from icy conditions. Chemical de-icers will help remove ice, but can also cause damage to the surrounding environment. Manual snow-removal followed by the application of an abrasive such as damp sand to create traction can keep sidewalks safe without the problems associated with de-icers. Using de-icers wisely, or replacing them with manual removal and abrasives, can minimize the potential for damage while keeping steps and sidewalks safe.

Most de-icing chemicals are technically "salts" that work by lowering the freezing point of water below 32° r. Saits can damage plants by direct contact with snowmelt containing de-icers or in salt spray from roadways. Repeated shoveling or blowing snow that contains de-icers onto nearby landscape plants will increase the likelihood of contact injury. Second, by repeated yearly applications the resulting build-up in adjacent soil may damage plant roots so they are unable to take up

The following five major ingredients offered in different brands of chemical de-icers each bring some advantages and disadvantages:

\*Calcium chloride - the traditional ice-melting product that continues melting ice in temperatures down to about -25 degrees F. It rarely harms plants unless used in

excess, but it can create a slippery, slimy surface on concrete and other hard surfaces.

\*Rock salt – the original ice melter and the least expensive available now. Because it's sodium chloride, it's effective down to about 12 degrees F. It can, however, damage not only concrete and plants but also soils and metals. \*\*Potassium chloride – an-

other chloride formulation

that can damage plant roots.

Plus, it can cause serious

plant injury when washed or splashed on foliage. \*\*Urea (carbonyl diamide) a fertilizer sometimes used to melt ice. It's only about one-tenth as corrosive as sodium chloride, but it still can contaminate ground and surface water with nitrates. Urea is only effective to about 21

\*\*Calcium magnesium acetate (CMA) – a newer product made from dolomitic limestone and acetic acid, the principal compound in vinegar. It does not form a brine as the salts do, but rather helps prevent snow particles from sticking to each other or the road surface. It has little effect on plant growth or concrete surfaces; however, its performance decreases below

Make sure areas receiving snow and de-icer have good drainage so a thorough watering in the spring can help flush the excess salts. Plant tolerance increases if the soil is rich in organic matter. Incorporating gypsum into the soil may also help offset some of the negative effects of deicing salts. Incorporate 10 to 20 pounds of gypsum per hundred square feet prior to planting in salt exposure ar-



#### **CYRUS MCCORMICK**

Readers, I'm really interested in combines and I thought I would look up their history. I hope you enjoy this

Cyrus Hall McCormick was an inventor and founder of the McCormick Harvesting Machine Company. Now later on it became part of the International Harvester Company in 1902. This whole family became very prominent in the Chicago area.

Cyrus was born in 1809 on the family farm known as Walnut Grove in Rockridge County in Virginia. This is in the Shenandoah Valley on the western side of the Blue Ridge

His parents were Robert McCormick and Mary Ann Hall McCormick. He was the eldest of eight children. His father was an inventor and made some of the earlier parts of the reaper. His father worked on a horse drawn reaper for 28 years. He couldn't market it and so he stopped working on it.

When Cyrus was 21 years old his father gave him the deed and rights to the reaper. Cy and a trusted slave, Jo Anderson, finished the reaper in 18 months. It was tested and demonstrated in 1831 and 1834. (Stan's note: If you noticed that in 1831 Paulding County area was still a dense forest and hardly any population. In fact it wasn't even a

In 1847, Cyrus and his brother, Leander moved to Chicago and built a huge centralized factory building making harvesting machines. This product sold very well.

Some of this was helped by the fact that the railroads were just now being built all over the nation and this was a way of delivering their ma-

Right about this time, advertising came about and he had salesmen who could also demonstrate the machines.

A man called William H. Seward said of McCormick's invention that 'the American frontier moved forward thirty miles a year'. As we're sitting here and looking back

over history of the Midwest and farming that is probably about right. Cyrus won a lot of awards

for his invention. He moved the harvesting along in a hurry besides the extra help that In 1851 the reaper won

the Gold Medal of the day at the London Crystal Palace Exposition as well as the one in Paris. The papers read that Cyrus McCormick's Reaper done more for the case of agriculture than any other liv-

He had a big lawsuit against John Henry Manny for his infringement on McCormick's patents. He had Lincoln and Stanton as attorneys and they won the case. Later Abe Lincoln had Mr. Stanton as his Secretary of State. In 1879 his brother, Lean-

der, changed the name from Cyrus McCormick & Brothers to McCormick Harvesting Machine Company. Over the years a number of brothers have all been included in the

Cyrus married Nancy Fowler in 1858, and they had seven children. Cyrus died in Chicago in 1884. The last part of his life he was an invalid.

Now that's about all I have on that company, but I know it also used other names later on. In looking back on the time of the reaper to the new big combines and shellers we have here; also the cotton combine works off this same

Old Cyrus was indeed a big part of American History.






#### Feeling Overwhelmed? Stop And Smell The Roses

Fresh flowers, however, aren't the only way to reap the benefits. According to Dr. Hirsch, other

ways to incorporate floral aromas into a daily routine include:

- Use floral-scented body washes and lotions;

- Keep sachets of lavender in dresser drawers;
- Float orange rinds in glasses of water;
