or the play "A Christmas Story", you will remember the scene where Ralphie's friend Schwartz unleashed the 'triple-dog dare' on Flick on the playground. Flick couldn't stand up to the pressure of such a lofty dare, despite the breach of etiquette, and licked the pole. He found himself stuck by his tongue to the pole on the cold playground. Then the bell rang. All the kids started running back to the school building. As Flick was pleading for them to come back, one of the friends asked, "What are you gonna do?" Ralphie just said, "I don't know. The bell rang." And he ran off to leave Flick stuck to the pole.

When Jesus called Peter, Andrew, James, and John, they immediately left what they were doing and followed him. Immediately. They didn't hesitate. They dropped their work tools and immediately followed Jesus. Later in his ministry, Jesus

encountered three other guys. They came up with excuses to not follow Him despite making comments suggesting that they wanted to follow Him. They just wished following Him was a little more convenient. Jesus replied with three overstatements. "Foxes have holes, and birds of the air have nests, but the Son of Man has nowhere to lay his head... Leave the dead to bury their own dead. But as for you, go and proclaim the kingdom of God... No one who puts his hand to the plow and looks back is fit for the kingdom of God" (Luke 9:57-62 ESV). He spoke against security, waiting for the perfect situation, and looking back.

Those three had their "buts", but what is your big "but"? It might be similar to the "buts" of those three men. Are you putting off doing what you know God wants until you are a little more secure in life-whether that is a job, home, or something else? You may be waiting for the finances to be just right in your life to start giving the way God wants you to. In this case, you think you are willing to follow God but His timing is just a little off. You assume, and wrongly so, that

the perfect situation to follow Him and take spirituality seriously is something that you can do at some perfect point in the future. Maybe you would like to follow Him, but you just aren't ready to give up the life that you are currently enjoying. Your reasons may be com-

—Psalm 103:1

pletely different than those expressed by the three Jesus encountered. It could be your popularity. Following Jesus would probably cause that to dwindle as you would become a little freakish in almost all areas of your life. It could be the way you entertain yourself. Following Jesus usually does change that. Whatever your excuse is, big "buts" get in the way of us surrendering ourselves to Jesus and living His life in the here and now. Honestly, when we look in the spiritual mirror, we each have big "buts" that we wrestle with. Some bigger than others, but each one is something that needs to be done away with if we are going to have the spiritual body God wants

The problem is that we cannot be the people that God wants us to be because we don't have the surrendered heart of the early church. Check out that church in Acts 2:42-47 and Acts 4:32-37 to get a glimpse of how Christians living together the way God intended can really impact their lives and the lives of those around them. When it comes down to it, we aren't really followers of Jesus; we're

#### WHAT CAN I GIVE THIS **CHRISTMAS?**

#### Winning the Battle for a Generation Column by: Rick Jones, Executive Director, Defiance Area **Youth for Christ**

In our giving and getting culture, especially this time of year may we slow down and ponder a bit, what can we give this Christmas?

In 1872 the poet Christina Rossetti wrote a poem that only appeared after her death. About thirty years later the poem was set to music and titled "A Christmas Carol." Today, we know it as "In the Bleak Midwin-

But there's a fascinating back-story to this beloved Christmas carol. Rossetti was a devoted follower of Christ who for many years volunteered at the St. Mary Magdalene "house of charity," a refuge for women coming out of a life of prostitution. In the Victorian Era of her day, economic forces often caused women to eke out a living by selling their bodies. Some of the "women" were only twelve years old. Rossetti's efforts in offering Christ and helping find better jobs for these marginalized women came through in some of her po-

In light of Christ's great power and love, Rossetti's poem asks:

"What can I give Him, Poor as I am?"



We made a terrible and costly mistake at the expense of our pets. Contact your local shelters for assistance and get references. We'd give anything to know Odie is again doing well.



We talked of taking one complete load of one and two burner oil stoves. Those units sell pretty quick. We will also take all the barrels of coal, oil or kerosene that we can purchase. Plus a few tents and cots and blankets, and a smaller amount of tools and mining supplies.

In the hotel room, I talked about sending Mom and Dad a 2-burner oil stove. We could drop it off at Sublette Cut Off

out there in Western Wyoming. That is where the Oregon Trail turns north and the wagons heading for the gold fields in California turn and go southwest. I could send money with the boys and have the station master at the Wells Fargo find a trustworthy fellow to take it on north to the folks at Hood River, Oregon. Mom would be tickled pink to get a handy stove like that. I will send a couple bags of kerosene to last them

Jim Martin said he would take care of that for me and to see that it got sent on to my parents, because I will be leaving the 3M Wagon Train at Kearney, Nebraska. Jim, Hiram and Sam will all go on

We tossed around the idea of us dropping off a 2-burner stove at Fort Kearney for El Paso Sam to take with him to his Indian agency position. He will need a cooking implement of some kind and that would be a lot better than a fireplace and hearth.

I guess I never told you, but the last time we stopped at North Platte, El Paso Sam met a fine lady (Callie Thorton) who was a niece of the hotel manager. Callie and Sam struck up a fine relationship in just a little bit. Sam will see her when the wagons go west and then on the return trip again.

General Kearney told us on the last trip that the Army Engineers would build a station for the Indian Agent. It will be 40'x40' with two rooms in the back for the proprietor and his family. Plus a shed for a team of animals and a wagon that the government would supply. So all of this would fall into place if Sam gets the job and if he brings that lady from North Platte with him. Well, this is all just conversation and up in the air, but I feel that it will happen and I want it to hap-

Hiram went down to the bank and got our money for delivering the gold dust supply. Jim and I went down to the post office and bought a money order. Jim sent his back to his wife and family

at Molene, Illinois. I bought a money order for about all the money I had. I know the folks up in Oregon can use it, I know they appreciate it. Jim will mail it at the Sublette Cut Off when they get there.

Well, this is February 20th and we are still in Independence, Missouri. We had a spring-time blizzard. It snowed for two days, I guess we got over eight inches of snow, but not a whole lot of wind. It just snowed and

Thank goodness we had all the wagons loaded and we didn't have to do that in the

We loaded my wagon with the blankets and clothing and then with the 20'x10' fly over the front and top of the wagon to keep out any rain or snow.

Well, we are waiting for the snow to melt a little or for the trail to get packed down a little. Sometimes that can make the trail a lot rougher because of the holes in the snow. That shakes your bones

Well, we wanted to be loaded and headed for California by March 1st. We are leaving early in the morning on the 27th of February, our first big stop will be Fort Kearney, Nebraska, a little over 200 miles.

#### **SANTA'S REINDEER**

Santa and his sleigh-pulling reindeer are fascinating and magical. It is amazing that a team of reindeer can travel worldwide in one day and bring the joy of giving to all. But what do we know about reindeer?

Reindeer are a deer of the Arctic regions of the world, the largest reaching up to four feet high at the shoulders and up to 250 pounds in weight. Reindeer and Caribou are two

names for the same species, with reindeer generally referring to the domesticated variety that are herded by humans and pull sleds. According to the Alaska

Department of Fish and Game, male and female reindeer both grow antlers each year during the summer. Male reindeer drop their antlers at the beginning of winter, usually in late November to mid December. Where as, female reindeer retain their antlers till after they give birth in the spring. Also, the reindeer is the only species of deer in which the female, as well as the male, have antlers.

Reindeer have four stomachs that are very similar to a cow. They eat a wide variety of vegetation consisting of edible mushrooms, tough grasses and of course lichen which is the favorite food of reindeer.

Reindeer have large broad hooves which act like snowshoes to support them over snowy and boggy ground giving reindeer the ability to spread its weight on soft snow to prevent them from sinking. These hooves emit a "clicking" sound as the animal walks, caused by a tendon in the foot rubbing against a bone.

Reindeer have unique hairs which trap the air, thus providing them with excellent insulation. These beautiful animals have the ability to lie on snow without melting it or getting wet. During the cold winter months the reindeer have a thick, woolly fur next to their skin and during the summer, this fur thins out so the reindeer stays cool. These hairs also help keep them buoyant in the water. Reindeer are very strong swimmers and can move across wide rushing rivers and amazingly, even the frozen ice of the Arctic

According to one legend, Santa's reindeer have the remarkable ability to fly and Donner, Cupid, Dasher, Dancer, Prancer, Comet, Blitzen, Vixen, and Rudolph are the only known flying reindeer in existence. As the legend goes, the reindeer are given the power of flight through magic corn given to Kris Kringle by a great wizard. Through this magic corn, the reindeer's strength is increased to three times normal, their stamina is increased to infinity, and their hoofs can use the air as if it were solid ground.

So please remember it is important to have some carrots for the reindeer and a cookie or two for Santa to help them through their journey of delivering gifts for all those who believe.





#### THERE ARE TWO SIDES TO THE AUTO BAILOUT

Ohio is experiencing a resurgence of its automobile manufacturing industry. This development has especially been good news for Toledo, where last month Chrysler revealed that it will hire 1,100 new employees and spend \$1.7 billion as it develops new models for its Ieep brand.

Chrysler reported that its nationwide sales increased 45 percent in November, and auto sales throughout the state have been rising over the last couple of months. No one denies that this is good news, and we all hope that it continues. But we also must not ignore the costs involved in keeping these automobile manufac-

turers afloat through the

federal bailout of Chrysler and General Motors in Debate was heated then

about whether the government should have lent the money, and the issue is becoming contentious once again. State Representative Matt Szollosi, a Democrat from Toledo, recently criticized Governor John Kasich for not supporting the auto bailout. I understand why Rep. Szollosi would not want to give credit to Republicans for anything. This is politics, after all. But his assessment that opponents of the bailout were "dead-wrong when they failed to support the investments that led to the auto recovery" is misleading because it provides only one side of the story. His support for the bail-

outs focuses only on the results it had on the auto companies. It ignores entirely the attached price tag for the American people. We must not forget that taxpayer money was used to fund the \$85 billion bailout. That is, money earned by American citizens and paid to the government via taxes was used to bail out a struggling company. If people had such devotion to Chrysler and GM, then they would have purchased enough of their vehicles that the bailout wouldn't have been necessary in the first place.

The United States already has a bailout mechanism in place, called bankruptcy. It gives failing companies an opportunity to escape their financial woes without becoming a liability to the taxpayers. It is not as if the facilities and equipment at the manufacturing plants would have burst into flames as soon as the company filed for Chapter 11. Those resources could have been purchased by another, private company, which could have continued production of the vehicles. A potential tax incentive could have been put in place for another private company to take over manufacturing. Instead, the federal government used tax dollars to bail out a private business, which shows a lack of loyalty and respect to American taxpayers.

Frankly, I am not interested in deciding who should take credit for the recent success of Ohio's auto industry. I am more interested in creating job opportunities for everyone, by removing unneeded government obstacles on private businesses and allowing the free market to succeed or fail on its own.




