UNCONSCIOUS BIAS IN PARENTING SITUATIONS AND EVERYDAY LIFE

The 21st Century after-school program at Wayne Trace Local Schools in conjunction with the YWCA welcomes guest speaker Courtnee Carrigan and her presentation Unconscious Bias in Parenting Situations and Everyday Living. It will take place in the Lecture Hall at Wayne Trace Jr./Sr. High School on Tuesday, April 16 from 5:00-6:00 p.m. This presentation is free to the public.

So what is unconscious bias? It is the concept that we are all bias at an unconscious level that influences our decision-making in ways that we are unaware. In other words, we, as individuals, make decisions based on stereotypes without intentional control. Social scientists have demonstrated time and time again that unconscious bias exists in our society. In fact, the bias begins as early as age three when we are taught to categorize the world around us. Categorization allows us to make



sense of new information, but it also leads to stereotyping. That stereotyping results in discrimination when people rely on those preconceived notions in making decisions.

Presenter Courtnee Carrigan has assembled award-winning curriculums that build awareness and promotes individual and systematic change through common sense actions. She has served as Diversity Facilitator for the National Underground Railroad Freedom Center

GREAT LAKES SPEED SQUAD COMPETITION

Area sports enthusiasts were treated last weekend as Bell's Skating Rink hosted the last regular season meet of the Great Lakes Speed Squad on Sunday morning, April 7, 2013. Between 180-200 speed skaters from all over Indiana, Michigan, Illinois, Ohio, and Kentucky, not counting spectators and sport enthusiasts, descended upon Bell's beginning at 5:00 a.m. for registration. Competitors at Sunday's event ranged in age from 4 to 59 years old.

President of the Bell's Speed Club, Brian Gettys, said that the quad skaters took to the floor first, beginning at 6:00 a.m., followed by the rookie inline skaters. Then, at around 10:00 a.m., things really began to heat up as the standard inline skaters took to the rink for what Gettys promised would be "a lot of fast action," and, added with a mischievous smile, "a few crashes."

"Some of the fastest ama-



teur standard inline skaters in the country were at Sunday's race," Gettys said. "This was our biggest group of competitors. These guys raced at speeds of 26-28 mile an hour, running 8 second laps in the 100 meter. It's like watching short track ice skating in the Olympics."

Interestingly enough, Apolo Anton Ohno, the most decorated U.S. Winter Olympian of all time, got his start racing competitively on quad skates when he was just six years old. He later went on to become a national inline speed skating champion before taking an interest in short track speed skating on the ice in 1994.

Winning the Battle for a Generation Rick Jones, Defiance Area YFC

For many who are reading this article you may identify with the lesson of the story that I am going to tell you about today, a lesson on failing and having a vision for life. Today's true story shows how vision can be born out of failure.

Edward Steichen, who eventually became one of the world's most renowned photographers, almost gave up on the day he shot his first pictures. At 16, Steichen bought a camera and took 50 photos. Only one turned out—a portrait of his sister at the piano.

Edward's father thought that was a poor showing, but his mother insisted the photograph of his sister was so beautiful that it more than compensated for 49 failures. Her encouragement convinced the youngster to stick with his new hobby. He stayed with it for the rest of his life, but it had been a close call. What tipped the scales? LEGISLATION AIMED AT CREATING JOBS, LOWERING GOVERNMENT COSTS

There are a lot of different issues being discussed at the Statehouse these days. But the primary area of focus continues to be improving the jobs market and helping reduce the costs of operating government.

At the beginning of the year, House Republicans introduced their first 10 bills of this legislative session in order to share our vision with the people of Ohio. I would like to share some of the details of two bills in particular that I believe will greatly help the unemployed find work and ensure that public money is used more efficiently.

House Bill 2 addresses the serious need in Ohio to help people looking for work with available jobs. The first stage of this process is using Ohio Means Jobs, a statewide job-search resource that is available on the Internet (OhioMeansJobs.com). It works much like other job sites, but is focused specifically on Ohio.

Obviously, there are times when people have been laid off or are in between jobs and need temporary assistance. House Bill 2 requires that Ohio residents seeking unemployment insurance first sign up with Ohio Means Jobs. This will initiate weekly

e-mails that list job offerings.

Within eight weeks of receiving benefits, the person is required to meet face-to-face with someone working in a county jobs center, who will assist in moving the process further and helping the applicant to find jobs that meet their abilities and interests.

This process serves two important purposes. First, it helps jobseekers find jobs. Secondly, it promotes accountability through this taxpayer-funded program and provides proper oversight.

Another bill, House Bill 6, is geared towards lowering the costs of local government audits. Through what are called "Agreed Upon Procedure" (or AUP) audits, the Auditor of State is able to focus more narrowly on specific transactions, thus improving efficiency while not sacrificing accountability.

The option of AUPs was proposed last year by the Auditor of State's office. Not all government entities would qualify, but according to the auditor's office there are more than 5,700 entities that would qualify.

It should be noted that the cost of these audits are passed down to the entity being audited, which as we all know are ultimately passed down to the taxpayers. I believe this is a viable option, particularly for smaller government entities, such as townships, villages and libraries.

HIGHWAY PATROL GRADUATES 63 CADETS IN CEREMONY

The Patrol's 154th Academy Class graduated on April 5, 2013 after 22 weeks of intense paramilitary training. The keynote address was provided by Senator Keith Faber, Ohio Senate President. Additional remarks were provided by Director Thomas P. Charles, Ohio Department of Public Safety; Colonel John Born, Patrol Superintendent and Captain Brigette Charles, Academy Commandant. The Oath of Office was issued by Judge Peter B. Abele, Fourth Appellate District, Ohio Court of Appeals.

Courses completed by the 154th class included Core Values, crash investigation, criminal and traffic law, detection of impaired drivers, firearms, physical fitness, self-defense and emergency vehicle operations.

Tpr. Daniel J. Schritter, South Point, Ohio was selected as class speaker and thanked the Academy and cadet family members for being supportive during their training.

Three of the graduates received special honors for top performance in various fields of study at the Patrol Academy. The honorees were:

- Overall performance - Tpr. Justin P. Lister, Rodman, NY
- Top performance in academics - Tpr. Clayton A. Grubb, Cleveland, OH
- Top performance in driving - Tpr. Aaron M. Ross, Somerset, KY
- Top performance in firearms - Tpr. Justin P. Lister, Rodman, NY
- Top performance in physical fitness - Tpr. Justin P. Lister, Rodman, NY

Additionally, the following cadets were recognized for their leadership: Tpr. Daniel J. Schritter, South Point, OH; Tpr. Cody K. Quattlebaum, Chesterhill, OH; and Tpr. Brittany N. Kenney, Sabina, OH.

Each of the commissioned troopers reported to their posts on Monday, April 8. The graduates' first 60 working days will be a field-training period under the guidance of a veteran officer. The new graduates are assigned to 35 of the Patrol's 58 posts.

REPORT: MORE REGULATIONS, FEWER COMMUNITY BANKS DUE TO DODD-FRANK REGULATIONS

According to a recent report conducted by the Federal Deposit Insurance Corporation (FDIC), since the enactment of the Dodd-Frank Act almost three years ago, community banks continue to struggle with navigating the burdensome and complex rules and regulations of the law.

"The Dodd-Frank Act and its 400 regulatory rules and mandates impose uncertainty and increased complexity of compliance, which in consequence are hindering our community bankers. This report outlines many of the concerns I have heard from the community bankers in my district that complying with these regulations are costly and curbing the growth of community banks."

A portion of the report summarizes interviews that were held with community bankers, where participants stated that no one regulation, but rather the cumulative costs to comply with multiple regulations are preventing new community banks from forming. Since 2011, no new community bank charters have been granted, due in part to the regulatory burden of Dodd-Frank.

saw some exciting skating reminiscent of Apolo Anton Ohno's early days. Perhaps two of the most exciting skaters that competed on Sunday were Bell's Speed Club's own Christian Keesler and past X-Games medalist BJ Steketee.

17 year old Christian Keesler started skating in 2004 and won his first National Championship on quads in 2006. In 2007, Keesler switched to inline skates and in 2009 he started skating on outdoor tracks. Keesler has trained at the Olympic Training Center in Colorado Springs, Colorado for the past three years and has vied for a spot on the junior world team. Keesler's father, Bell's Speed Club Head Coach Chris Keesler, says his son has a very good chance of earning a slot on the junior world team this year.

At the time this story was written, Keesler, a Wayne High School student, was competing in France, where he placed 13th overall out of 79 total inline skaters in his division. "Christian accomplished several goals while competing in France, and we are extremely proud of him," said Coach Keesler on Wednesday. Christian's long term goal is to win a national inline skating championship.

BJ Steketee, a chiropractor, husband, and father of five from Jennings, MI, also raced on Sunday at the Great Lakes Speed Squad event. In an interview with Steketee's wife, Jenny, she said that Steketee's relationship with speed skating was one of love at first sight. "In 1989, BJ's dad took him to watch a speed skating practice. After watching the practice, BJ told his dad 'I want to do that!' His dad bought him skates on the spot and he started practicing that day," said Steketee.

Even though Steketee may have fallen in love with speed skating at first sight, the sport didn't automatically love him back at first. "He had a rough time those first years," said Steketee, adding, "he got lapped in a couple races."

Steketee continued to work hard, however, and by 1994 he was a member of the junior world team. From 1996-1998, Steketee competed in the X Games, winning a bronze medal in 1997. In 1999, he obtained sponsorship from a Dutch financing company and travelled to the Netherlands for six months to compete professionally on outdoor road courses, which are very popular in Europe. During this time, he won an astonishing 15 marathons.

From 2000-2006, Steketee took a hiatus from competitive skating to become a chiropractor and start a family with his wife, Jenny. Upon his return to competitive skating in 2006, he won national championships in both the classic two man relay and the 2000 meter skate. From 2009-2010, Steketee again took time off to start his chiropractic business in Michigan. In November of 2010, Steketee tried out for and earned a spot racing on the National Speed Skating Circuit, and he has raced two full seasons on the circuit. Steketee also came in 9th place at the world cup trials in 2012, earning six individual medals at the Indoor Nationals competition.

"We have some fantastic talent on our team," said Head Coach Keesler, "with many of our skaters having goals of joining the junior world team and competing in international competitions."

5. A study of the Bible will tell us of all the blessings that God has for us. Please read Ephesians 1:3 and John 10:10.

6. A study of the Bible helps us to learn from the mistakes of others especially in the Old Testament, please read 1 Corinthians 10:11 and Ecclesiastes 12:13-14.

7. In the Bible we learn about God's love, John 3:16. Also we learn how we can express our love to God, 1 John 2:5. Always begin Bible study with prayer. Now for

the "5 W's and the 1 H of Bible Study." As you study any passage of scripture, any book of the Bible, train yourself to constantly ask: Who? What? When? Where? Why? and How? Accurate answers to the following questions will help assure correct interpretation.

1. Ask "who" is speaking? "Who" is this about? "Who" are the main characters? And then, to "whom" is he speaking?

2. Ask "what" is the subject or event covered in the chapter? "What" do you learn about the people, the event, or the teaching from the text? "What" instructions are given?

3. Ask "When" do or will the events occur? "When" did or will something happen to a particular person, people or nation?

4. Ask "where" did or will this happen? "Where" was it said?

5. Ask "why" is something being said or mentioned? "Why" would or will this happen? "Why" at this time? "Why" this person?

6. Ask "How" will this happen? "How" is it to be done? Ask "How" is it illustrated? Prayerfully and hopefully this may help some.

PATROL REMINDS DRIVERS TO KEEP THEIR EYES ON THE ROAD

The Van Wert Post of the Ohio State Highway Patrol is reminding drivers to keep their eyes opened and focus on the roadway while driving. According to the National Highway Safety Administration last year in the United States, 3,331 people were killed and 387,000 people were injured in crashes involving a distracted driver.

Sending or receiving a text message takes a driver's eyes off the road for an average of 4.6 seconds, the equivalent, at 55 mph, of driving the length of an entire football field.

"Every time someone takes their eyes or their focus off the road - even for just a few seconds - they put their lives and the lives of others in danger," said Lt. L.D. Brode, Commander of the Van Wert Post.

"Distracted driving is unsafe, irresponsible and in a split second, its consequences can be devastating."

Distracted driving is any non-driving activity a person engages in that has

potential to distract him or her from the primary task of driving and increase the risk of crashing. Distractions can be Visual - taking eyes off of the road; Manual - taking hands off the wheel; or Cognitive - taking the mind off driving. Texting while driving is an example that results in all three types of distraction.

Before our country's independence in 1776, settlers escaping religious persecution and tyrannical rule came to the New World. They were the first pioneers to make up the very fabric of the United States. Since our country's inception, brave men and women, spanning every generation in American history, have stepped up and defended our inalienable rights. To honor those who served in the most recent conflicts, a special organization has been created as a means to show appreciation to veterans for their service and sacrifices for our country.

Honor Flight Network is a non-profit organization created solely to honor America's veterans for the trials and tribulations faced in service. Veterans are flown to Washington, D.C. to reflect at their war memo-

rials. The Honor Flight is a one day trip that begins early in the morning and returns the evening of the same day. Top flight priority is given to WWII survivors who served between December 7, 1941 and December 31, 1946 along with other veterans who are terminally ill.


Honor Flight Northeast Indiana is a recognized independent hub of the National Honor Flight Network and was created to take our veterans from Fort Wayne directly to Washington, D.C. Motor coaches will be standing by to transport them to the WWII Memorial, as well as other memorial stops throughout the day, before flying them back to Fort Wayne the same evening. All flights are 100 percent funded by individual and corporate contributions. They receive no funding from any level of government. They are recognized as a 501(c)(3) organization.

Upon the completion of their eighth flight, Honor Flight has flown over 490 WWII veterans to see their memorial at no expense to them. Each veteran is given the opportunity to bring

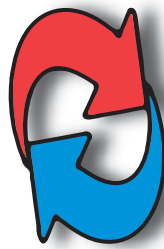
their own volunteer as a companion for assistance throughout the day. If a veteran cannot find a volunteer to go with them, the organization will provide one. All volunteers must pay their own way, which is \$400. Any WWII veteran who has yet to see the memorial is eligible to participate and Honor Flight is always looking for more WWII veteran applications. The Honor Flight on May 8 is filled, but there are a few spaces left for the trip on May 29. After these flights have concluded Honor Flight will be taking applications for all veterans who served after WWII to the present day.

The WWII Memorial in Washington, D.C. was dedicated in May of 2004 and is a long overdue "thank you" to the servicemen and women who sacrificed so much for our freedom. 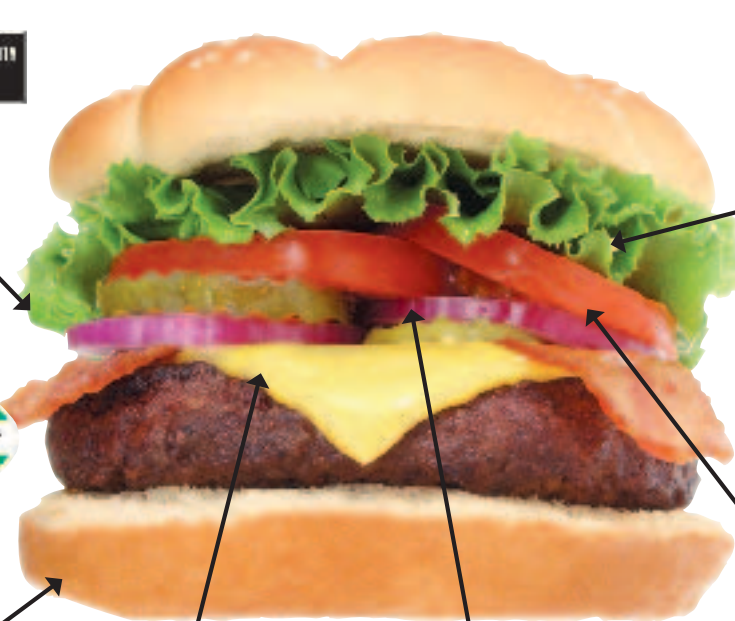

IS YOUR PORTFOLIO TRULY DIVERSIFIED?

Life is full of ups and downs — and the financial markets are no different. As an investor, you're no doubt happy to see the "ups" — but the "downs" can seem like a real downer. Isn't there any way to help smooth out the volatility in your investment portfolio?

First of all, to cope with volatility, it's helpful to know what causes it — and there can be many causes. Computers that make trades in milliseconds, based on mathematical models, are sometimes blamed for intraday volatility, but large price swings can also occur following the release of government economic reports, such as those dealing with unemployment and housing

starts. Global events, such as the European economic malaise, can also send the financial markets into a tizzy.

By being aware of the impact of these events, you can see that the workings of the markets — especially their volatility — may not be as mysterious as you thought. Still, while knowing the causes of volatility can help you prepare for market swings, it won't blunt their impact on your portfolio. To do that, you need to create a diversified mix of investments because your portfolio can be more susceptible to negative price movements if you only own one type of asset.

To illustrate: If you owned mostly bonds, and interest rates rose sharply, the value of your bonds would likely drop, and your portfolio could take a big hit. But if you owned stocks, bonds, government securities, certificates of deposit (CDs) and other investment vehicles, the rise in interest rates would probably affect your portfolio less significantly.

Unfortunately, many investors think that if they own a few stocks and a bond, they're diversified. But you can actually extend your diversification through many levels — and you should. For the equity portion of your portfolio, try to own stocks representing many market sectors and industries. Also, consider international stocks. And rather than just owning

U.S. Treasury bonds, consider corporate bonds and municipal bonds, and diversify your fixed-income holdings further by purchasing short-term, intermediate-term and long-term bonds. Work with your financial advisor to determine the mix of asset classes and investments that are appropriate for your financial goals and objectives.

How you ultimately diversify your portfolio depends on your risk tolerance, time horizon and long-term goals — there's no one "correct" asset mix for everyone. And over time, your diversification needs may change. To cite one example, as you enter your retirement years, you may need to increase your percentage of income-producing investments while possibly reducing the amount of growth investments you own. These growth-oriented investments tend to be more volatile, and you may want less volatility during your retirement. However, even during retirement, you will need to own a certain percentage of growth investments to provide you with the growth potential you'll need to stay ahead of inflation.

Keep in mind that diversification can't guarantee a profit or protect against loss. Nonetheless, building a diversified portfolio may help take some of the volatility out of investing — so look for diversification opportunities whenever possible.

MAKE A DIFFERENCE FOR THE FAMILIES YOU TOUCH

Things move so quickly in today's world. We're often pre-occupied, stressed or fearful of taking a stand. No matter how fast the world might be moving around us, it's critical that we slow down and pay attention to our children.

State and local agencies and concerned citizens all work toward the common purpose of preventing child abuse and deliver a powerful, collective message about the importance of protecting children, supporting families and strengthening communities.

These messages are most effective at the community level, where specific actions can be identified and effective networks mobilized. The Ohio Children's Trust Fund works to support communities in these efforts by providing information, materials, assistance and message guidance. All Ohioans share a responsibility to support children and promote safe and stable families. Research has shown that toxic stress from child abuse and neglect impedes healthy brain development and effective child development. As a result, child abuse and neglect prevention is the most critical issue we can address for the long-term well-being of our children and communities.

Research has demonstrated that our past collective efforts have been successful at raising child abuse and neglect awareness across Ohio. Now is the time to advance from making people aware of child abuse and neglect to taking concrete action to prevent it. It indeed takes a community to keep children free from abuse and neglect, and everyone has an active role to play in this effort.

WHEN TO APPLY AQUATIC DYES

Aquatic dyes or pond colorants are a useful technique to control nuisance algae and submerged aquatic plants. Like all plants, submerged aquatic plants and algae require nutrients and sunlight to flourish. These plants can grow only where sufficient light reaches the bottom of the pond or lake. This zone is called the photic zone. Many factors affect how deep the photic zone extends, including plankton density, water color, and even wind.


Aquatic dyes work similarly by coloring the water a dark blue. The absorption and scattering of sunlight in the blue water significantly reduces the depth of the photic zone. This limits submerged plant and algae growth to only the shallowest areas of the pond or lake. For some pond owners, this reduction in plant biomass may be sufficient to meet their desired pond condition. Other pond owners may need to spot treat with herbicides and algaecides or introduce grass carp to eliminate remaining plants.

Dyes do not inhibit growth

of all aquatic plants. Dyes are recommended for use on submerged plants, such as pondweeds, watermilfoil, and coontail. Dyes also inhibit growth of filamentous algae, mat-forming algae, and single-cell planktonic algae. Dyes do not inhibit the growth of emergent plants, such as cattails, and are not effective in controlling floating-leaved plants, such as duckweeds and water lilies, once their leaves are floating on the surface.

The keys to effectively use of pond dyes are to make the initial application in early spring prior to germination. Pond owners are encouraged to apply dyes by April 1 if possible and certainly by April 15. This early application limits sunlight penetration, which in return, delays the growth of aquatic plants that later can become a problem in all but the shallower areas of the pond.

An early aquatic dye application can halt an early growth of aquatic plants before they have a chance to reach nuisance levels. When sunlight is reduced, plant growth is delayed due to lack of photosynthesis. Owners need to be aware that treating a pond with a dye can trigger a fish kill.

United Way of Paulding County and the FamilyWize Community Service Partnership have teamed up to make prescriptions more affordable for those without insurance or even those who have insurance that doesn't cover their medicine. FamilyWize cards have provided needed relief with great success, saving 590 people in our community more than \$73,772 on the cost of their medicine. However, there are still many more people whose health is endangered because their prescriptions are too expensive and they are not getting the medicines they need.

Surveys in the last two years by the Commonwealth

skipped a dose or didn't fill a prescription because of cost "In 2013, we'd like to see every person in our community who is unemployed, uninsured, has to buy medicine not covered by their health plan or government program, or is unable to get the medicine they need for any reason, get a FamilyWize card from the United Way," said Sonya Herber, Executive Director of the United Way of Paulding County. "We also encourage them to see what other services we can refer them to - like food banks and pantries, utility and housing assistance, and more. We know these are still hard times for many people and we're here to help."

United Way of Paulding County is one of 1,000 local United Ways that have joined

the FamilyWize Community Service Partnership over the last seven years. FamilyWize was recently named a Preferred Partner by United Way Worldwide to provide opportunities for increased awareness and collaborations nationwide. "Our partnership with United Way Worldwide and almost 1,000 local United Ways nationwide gives us a national platform to help people in every community across the country," said Dan Barnes, FamilyWize CEO and Co-founder.

Barnes added that FamilyWize has the capacity to help many more people and will be working hard to do so but the impact nationwide already is impressive:

- 5.2 million people helped
- 5,000 additional people helped each day
- \$470 million saved on the cost of medications

"Locally or nationwide, what's most important is that most of the time we save people about \$20 per prescription when they use this card," added Herber. "That's money in their pocket when they need it most to pay bills and other necessities."

Average savings are almost 40% and can be as high as 75%. FamilyWize cards can be used at most pharmacies including all chain pharmacies and groceries nationwide.

"FROM THE VANTAGE POINT": NETWORK SYSTEMS STUDENTS HELP RE-WIRE COURTHOUSE TECHNOLOGY

Built in 1876, the architects of the Van Wert County Courthouse never could have imagined the technology that would be used 150 years later. So naturally, when Vantage Board member (and Van Wert County 911 Coordinator) Kim Brandt found out that the courthouse network

wiring was going to be updated, she contacted Network Systems instructor, Larry Regedanz to see if the class would like help out.

The two discussed the project at the Vantage Grand Open House in February. The courthouse technology network was out of date, and

they were having some trouble with their internet due to internal wiring problems. Regedanz and his senior class went through the building - from the basement to the clock tower - checking out switches, hubs and network wiring for the 45 courthouse computers. They found some wiring that needed to be replaced and set up a schedule that would have them work at the courthouse on Tuesday and Thursday afternoons, replacing Cat 5 wiring with Cat 6 wiring. This is a wiring upgrade which future-proofs the courthouse for faster internet speed and helps protect against electrical interference.

"There are some unique experiences on this project that students would never get in lab. For example, they were standing on a piece of plywood in the attic of the courthouse, it was relatively dark, and they were making Cat 6 cables. The students discovered that making those cables on site is much more difficult than making them while sitting in a classroom," said Regedanz.

"We're all very excited to have the opportunity to work with the Vantage students on this project. Mel Nomina is the lead person on the project and he's glad to provide the students with the experience of running the new cable," commented Brandt.

Senior Jaquobe Markward (Lincolnview) stated, "This project is a great learning experience for us to help us get ready for future jobs." Other seniors working on the courthouse project are Dylan Boroff (Lincolnview), Austin Meyer (Ottoville), and Wyatt Sawyer (Paulding).

ELECTION ADVISORY FROM OHIO SECRETARY OF STATE JON HUSTED

Secretary of State Jon Husted announced that the deadline to register to vote for the May 7th Primary Election will be Monday April 8, 2013.

Register to Vote/Update Your Address:

The deadline to register to vote in the May 7, 2013 Primary/Special Election is Monday, April 8, 2013 (30 days prior to the election). Voter registration forms are available at MyOhioVote.com or from local boards of elections and other designated agencies, such as libraries and BMVs.

Should voters have moved since the last election, they should also act now to update their voting address online at MyOhioVote.com. This should also be done by April 8 to ensure they can vote with ease on Election Day.

Check Your Registration: Not sure where to vote or if your voting address is up to date? Voters can now easily check their voter registration information, including voting address and polling location, online at MyOhioVote.com. The new online service, which previously had to be done using two separate online tools, is part of an ongoing effort by the Secretary to enhance the service available at MyOhioVote.com. The system is populated with information from county boards of elections. It is important to note that boards may make a last minute change to a person's polling place that would not be reflected online, but voters would be notified by mail. Questions about information contained in the

online system should be directed to the county boards of elections.

Election Ballot Issues:

On May 7th voters in 74 counties will decide several local races and 354 local issues, including 141 school issues and a number of local tax levies, bond issues and charter amendments. A complete list of local issues appearing on the ballot is available here and at MyOhioVote.com.

In-Person Absentee Voting:

In-person absentee voting began April 2, 2013, or 35 days before the election. For specific information including times and locations, contact your board of elections.

Absentee Voting by Mail:

Boards of elections began mailing out absentee ballots on April 2, 2013, to voters who requested them. Voters have until Saturday, May 4th at noon to request an absentee ballot by mail and they may do so by contacting their county board of elections for more information, or by downloading an absentee ballot request form at MyOhioVote.com.

To cast an absentee ballot by mail, voters must complete, sign and seal their voted ballots, taking care to provide the required information, including proper identification. Voted ballots must be postmarked the day before Election Day and received no later than 10 days after the election (May 17, 2013). Absentee ballots may also be delivered in person to boards of elections no later than the close of the polls on Election Day. They may not be returned at polling locations.

Election Day Voting:

Polls are open 6:30 a.m. to 7:30 p.m. on Election Day. Voters choosing to head to the polls must remember to bring the proper form of ID and know their polling place and precinct. Voters can check their polling place and precinct and get other important voting information by visiting MyOhioVote.com.

Get Elections Updates and Ohio's Virtual Voting Sticker:

Ohio voters are encouraged to link with "Ohio-SOSHusted" on Facebook and Twitter to get elections information and updates throughout the year. Here they can also get a virtual voting sticker badge to let their friends and followers know they've participated in the election, whether they chose to cast their ballots by mail or in person. Facebook users simply need to "like" Ohio Secretary of State Jon Husted's official Facebook page to "wear" a virtual sticker on their wall. Twitter users may share their voting badge by visiting the Secretary of State's website.

Vote in Honor of a Veteran:

With Vote in Honor of a Veteran, voters may demonstrate the pride they feel for a veteran by dedicating their vote to them. LAKE ERIE BIRDING TRAIL COMES ALIVE

Spring migration will bring millions of birds to Ohio in the coming months, and the Lake Erie Birding Trail offers a great opportunity to view many rare and exciting species, according to the Ohio Department of Natural Resources (ODNR).

The Lake Erie Birding Trail encompasses the Ohio shoreline and inland areas from Conneaut in the east to Toledo in the west. More than 80 primary birding sites are highlighted along the trail, which is divided into seven loops: Ashtabula, Cleveland, Huron and Lorain, Sandusky Bay, the Lake Erie Islands, the western Lake Erie marshes and the Oak Openings. The sites within each loop are similar in habitat and landscape. People can visit the entire trail in one trip or explore the trail loop by loop.

Many birds migrate north in the spring to reach their breeding grounds. Nearly 400 different species of birds have been spotted in these areas, and these sightings typically occur in spectacular numbers. A diverse group of migrant songbirds fill lakeside woodlands. Waterbirds pack marshes and the open lake waters, and secretive marsh birds breed in coastal wetlands.

Birders and others who want to help fund conservation in Ohio can now purchase the 2013 Ohio Wildlife Legacy Stamp. This year's stamp features a black-capped chickadee photographed by Sheffield Village resident Bruce DiVaccaro.
