make the rounds doing the previously mentioned 'Egg and Beg' to raise money for Allie's medical expenses. According to Mrs. Fritcha, the youth were going door to door asking for donations from local residents, and for each donation, the philanthropist in residence is allowed to crack an egg, squirt ketchup, or dump some other food item on the teenager of their choice.

'Well, that's certainly an interesting way of raising money,' I thought to myself, 'and for sure it's the thought that counts; but how much money can a dozen teenagers raise letting adults crack eggs on their heads?'

With Zach's phone number scratched down on a piece of paper, I headed over to the New Haven High School Parking lot to talk to the teens and find out.

When I arrived, the dozen frightful looking youth were standing in a circle talking and laughing. As I approached, they turned and, in unison, bowed at the waist with their hands folded and welcomed me in the traditional Japanese manner by saying "Kon nichi wa."

(It probably goes without saying that I love these kids. More about this in a minute!)

Then, everyone started talking at once, telling me about 15 year old Allie, about how sweet and outgoing she is, and how well liked her older sister, Mackenzie (a senior at New Haven High School) and younger brother Isaiah (a student at Central Lutheran) are.

By the looks of Allie's friends in the NHHS parking lot on Thursday night who were covered in everything from cracked eggs and catsup to salsa and syrup, she and her sister and brother must be extremely well liked.

In less than three hours, the ragtag group consisting of Zach Fritcha, Andrea Jordan, Nicole Westrick, Taylor Vachon, Britni Bolinger, Trent Bell, Vance Shearer, Adam Hoffer, Matt Dunfee, Haley Morin, Julia Morin, and Lexi Bolinger had raised well over \$600 for Allie, and were on their way to Parkview North to personally deliver the money to Allie's family.

"We aren't done yet," Zach said of the group's fundraising efforts on Thursday evening, adding "we have a few businesses that we are going to talk to tomorrow about getting a donation from, and some other people that want to donate, like my Mom."

This brings me back around to why I love this group of kids, and why I think they all have hearts of gold.

Thursday evening's fundraising endeavor was completely initiated and powered 100% by our local

New Haven youth. No adult came up with this idea, nor did any adult cart the teens around from door to door to drum up support for it; solely because of the efforts of these 12 teens, a story that should have been a sad one in every way is brimming with hope.

Contrary to what the mainstream mega-media sources would have us believe, there still are a lot of good young people out there who truly care about each other, and will go out of their way to help a friend in need.

Now, is it a coincidence that the fundraiser these teens rocked on Thursday evening was called an 'Egg and Beg', that eggs generally come packaged by the dozen, and this group consisted of a dozen teens?

Probably. I don't think it's a coincidence, however, that this kind of story happened here in New Haven.

If you've read any of my columns for New Haven Bulletin.com in past year, you probably already know that this is not where this story is going to end.

Dan Keller of Archbold Equipment stated, "Over the past 10 years farm equipment capabilities have increased dramatically." The tractors and combines can be programmed for each season and at harvest time they will vary by only one inch. The savings are incredible now that the computers measure bushel output vs. fuel consumption, vs. acreage and can automatically set the machines for the

most optimal fuel usage at the same time as increasing production. One new feature introduced into production this year is a combine can call its tractor and it will move along with the combine as it continues to harvest while unloading into the hopper wagon. The tractor can use the same production map program and will drive only through harvested areas, not damaging uncut crops. It's quite a sight to watch the

machines work together. Another new feature JD has developed is programs and apps that a manager can watch over 30 pieces of equipment simultaneously and switch between each one monitoring all activity and numbers coming from each machine in the field. All of the larger farm equipment shown at the Ag Day was made in Waterloo, Iowa. Providing food for the event was the Paulding County 4-H Club.

SENIOR CIRCLE LUNCH AND LEARN

On Wednesday, July 24th, 2013 the Lutheran Health Network's Senior Circle Club hosted a Lunch & Learn Seminar in the Police Training Room at City Hall in New Haven. Approximately 60 area senior citizens attended the event,

which included a free brown bag lunch sponsored by Heritage Park. The topic for the forum was "Facts About Heart Failure", and was presented and moderated by Dr. Rakesh R. Chawla, an invasive and interventional cardiologist from the St. Joseph Medical Group.

Dr. Chawla started out by telling those assembled that heart failure affects more than 6 million Americans, and more than 670,000 individuals are diagnosed with issues related to the heart. While heart failure is often symptomless, and looks differently in men than in women, said Dr. Chawla, it is very important to receive a proper diagnosis for the disease in addition to a well-managed treatment plan.

"Heart failure is often characterized by insufficient blood flow to the body's cells and tissues," said Dr. Chawla. "As we age, the heart muscles weaken and cannot pump blood as effectively as it once did. Symptoms can sometimes appear as fainting, shortness of breath, increased heart rate, swelling, and fatigue."

Dr. Chawla encouraged everyone in attendance to take simple steps to improve their cardiovascular health, such as eating more whole grains, vegetables and fruits, and lean protein sources and slowly introducing exercise into your daily routine. If exercise is not already something you do and extra weight is an issue for you, Dr. Chawla recommended walking in a swimming pool to help alleviate stress on the joints and to help make exercise more enjoyable.

Following Dr. Chawla's presentation, Lunch and Learn attendees were invited to ask their own heart-related questions and receive expert advice from the doctor.

A native of Dayton, Dr. Chawla has special interest in aggressive acute-care cardiovascular and vascular medicine. He is a graduate of The Pennsylvania State University, University Park, Pennsylvania, the Jefferson Medical College of Thomas Jefferson University in Philadelphia, and completed his internship and residency at Akron City Hospital and St. Thomas Medical Center in Akron, Ohio, in 1997. He completed two fellowships, one in cardiovascular medicine at Medical College of Wisconsin in 2001, and the second, a fellowship in interventional cardiology, at the University of California San Francisco in 2003. Dr. Chawla is currently

accepting new patients at his office in the Lutheran Medical Park building located at 1302 Minnich Road in New Haven in the former Scott's Food Store Plaza. To schedule an appointment with Dr. Chawla, contact his office at 260-469-6210.

TACKLING ILLEGAL IMMIGRATION

Yet again, Congress is debating a bill to reform our failing immigration policies that leaves taxpayers here in Indiana spending millions to cover the cost of undocumented citizens.

Since the federal government has neglected to enforce existing immigration laws, we can only hope that something will come out of the discussions taking place in Congress this year. Even though immigration is and always will be a federal issue, the federal government's lack of enforcement and regulation has compelled states to take it upon themselves to address the problem.

In 2011, the Indiana General Assembly passed Senate Enrolled Act 590, which made various changes to Indiana's laws concerning the enforcement of federal immigration regulations. There were two key provisions of the law targeting illegal immigration in Indiana:

- Any local government is prohibited from doing business with a company that hires illegal immigrants.
- Any illegal immigrant is excluded from collecting state or local benefits such as: welfare, health-care services, college scholarships and financial aid.

The measure also required the Indiana Office of Management and Budget (OMB) to calculate how much illegal immigration costs taxpayers and to make a written request to Congress for reimbursement.

Before this law was passed, there weren't any concrete figures on how much taxpayers paid each year for illegal immigrants. According to a study by the Pew Hispanic Center, there were an estimated 110,000 undocumented citizens in Indiana in 2010. When OMB completed a cost evaluation on illegal immigrants, the agency found they cost Indiana taxpayers over \$130 million per year.

When our law was getting ready to take effect, a federal judge blocked two provisions of SEA 590. This temporary ban will remain in effect until the case is resolved in court.

With the federal government's inability to regulate illegal immigration, proactive state policies like Indiana's help us address the related problems within our state borders. Our law sends a clear message to illegal immigrants that our state will not be a sanctuary for people who are in our country dishonestly and take advantage of our public services funded by tax dollars. What do you think?

Topics include: primary assessment, ventilations including use of CPR breathing barriers and bag-valve-masks, choking, CPR/AED, and use of epinephrine auto-injectors and asthma inhalers.

Attendees to this 5.5 hour class receive a two year certification and access to free online refreshers.

Adult and Pediatric First Aid/CPR/AED

With an emphasis on hands-on learning, the Red Cross First Aid/CPR/AED courses give attendees the skills to save a life. Participants learn how to respond to common first aid emergencies, how to respond to cardiac and breathing emergencies in

adults, the use of automated external defibrillators (AED), and more.

Blended learning courses allow flexibility to busy participants by completing their classroom training online and testing their skills in person. Attendees receive a two year certification and access to free online refreshers upon completion.

Babysitter's Training

Designed for students age 11 and older, this in-person course provides the knowledge and skills necessary to safely and responsibly care for infants and children up to the age of 10. Topics include how to: respond to emergencies with first aid, rescue breathing and more; make good decisions under pressure; communicate effectively with parents; recognize safety and hygiene issues; manage young children; feed, diaper and care for infants; and start a babysitting business.

Students receive materials that are useful both during the course and when they start babysitting, including a compact emergency reference guide, an interactive CD-ROM featuring an activity booklet with games, songs, recipes and other activities, an electronic client organizer, and much more.

the post as president of the College of New Jersey (now Princeton University). Arriving in 1768 with his family and 300 books for the college library, he threw himself into the task of building up the young school.

As the Revolution approached, Witherspoon’s Presbyterian belief that people should choose their own government put him firmly on the Patriot side. He realized the colonies would have to fight Britain. “If your cause is just, if your principles are pure, and if your conduct is prudent, you need not fear the multitude of opposing hosts,” he preached.

In the Continental Congress, some delegates worried the country was not yet ripe for independence. “The country is not only ripe for the measure, but in danger of rotting for the want of it!” Witherspoon retorted.

He became the only minister to sign the Declaration of Independence. He lost a son in the Revolution, which also left the college in dire straits. After the war he tackled the job of rebuilding the school. “Do not live useless and die contemptible,” he exhorted his students, who included nine future cabinet officers, 21 senators, 39 congressmen, three Supreme Court justices, 12 governors, a vice president, and a president—James Madison, who was also one of five Witherspoon students at the Constitutional Convention.”

Courage is born from adversity and the scriptures remind us as followers of Jesus Christ that we are to be strong and courageous, to not be afraid... Joshua 1:9 (NIV), “Have I not commanded you? Be strong and courageous. Do not be terrified; do not be discouraged, for the LORD your God will be with you wherever you go.”

UNDERSTANDING BIBLICAL PROPHECY

Prophecy in the Bible is one of the most misunderstood genres. It is popular to view prophecy as an exercise in predicting the future. People will try to decipher all of the hidden meanings in Daniel, Revelation, or some other book. But the purpose of Biblical prophecy was typically focused on transforming the original audience into who God wanted them to be.

Let's look at a few Bible stories to see how prophecy worked.

Jonah went to Nineveh and prophesied that God would destroy their city in forty days. The people of Nineveh responded by believing in God, fasting, and repenting. The story goes on to say, "When God saw what they did, how they turned from their evil way, God relented of the disaster that he had said he would do to them, and he did not do it," (Jonah 3:10 ESV). God relented from his prophetic declaration to destroy the city because the people changed.

Or another story.

When the Israelites built the Golden Calf, God told Moses that He was going to unleash His wrath on the Israelites and consume them. Moses responded by pleading with the Lord: "Turn from your burning anger and relent from this disaster against your people," (Exodus 32:12 ESV). The story continues, "And the Lord relented from the disaster that he had spoken of bringing on his people," (Exodus 32:14 ESV). The Lord once again relented from a disaster that He declared He would bring about. This time, the punishment was averted by the prayers of a righteous man and not the repentance of the people, but there is no way to get around the prophetic declaration of the Lord did not happen.

And another story.

Jeremiah went to the rul-

ers of the house of Judah at the beginning of the reign of Jehoiakim and gave a prophecy that actually showed them and shows us how prophecies from God actually work. There is an explicit condition stated in this prophesy unlike the unspoken condition we saw in the two previous stories. Jeremiah proclaimed to them, "Mend your ways and your deeds, and obey the voice of the Lord your God, and the Lord will relent of the disaster that he has pronounced against you," (Jeremiah 26:13 ESV). God overtly told them that He would not inflict the punishment that He pronounced on them if they would change, turn back to Him, and obey Him. They were not destined to the fate of the prophesied disaster of being conquered by Babylon. God followed His initial prophecy of punishment with a prophecy of hope.

This statement of hope is an unspoken idea that is contained within every prophecy of punishment. God always responds graciously to sincere repentance.

With this in mind, the way we view prophecy throughout Scripture should change. The purpose of prophecy is not for us to get hung up on the future predicting nature of prophecies. That exercise leads to massive speculation and fruitlessness. We need to focus on the life-changing nature of prophecies.

Jonah was sent to declare God's wrath on Nineveh so that they would repent and begin to follow God. Jeremiah did the same with the royal court of Judah; however, they did not repent and they were inflicted with the prophesied punishment. Both prophecies had a conditional nature to them. Prophecies need to be viewed as instructional messages from God.

We could say that God's prophecy of punishment on the Israelites at the time of the Golden Calf and the Ninevites during the time of Jonah were failed prophecies because the declared punishment didn't occur. But they were actually successful prophecies because they brought about repentance.

The failed prophecy is the one that actually happened. Jeremiah prophesied punishment upon Judah if they didn't obey God. The goal was obedience, not punishment, yet they remained rebellious and received the prophesied punishment. This was a failed prophecy. Not because the events predicted came about but because the word of Jeremiah did not bring about faithfulness.

God's plan doesn't change, but the path to His plan adjusts based upon the faithfulness or faithlessness of people. Who will He use? Who will He punish? Will He relent His disaster? Will He unleash His blessings?

Which brings me to a question to ponder. Will I turn to God, be faithful, obey Him, and let Him use me to bring about His will?

Will you?

OHIO CHAMBER BACKS PLAN TO INVEST MORE INTO REGIONAL INFRASTRUCTURE TRANSPORTATION FUNDING KEY TO CONTINUED GROWTH

The Cincinnati USA Regional Chamber on July 23rd announced support for Ohio Governor John Kasich's Jobs and Transportation Plan to direct more than \$470 million in transportation funding into four critical infrastructure projects in Southwest Ohio.

Governor Kasich's Jobs and Transportation Plan will make it possible for Southwest Ohio to benefit from new funding resources and innovative approaches for transportation infrastructure funding. Additionally, this funding will reduce project completion time by 20 years. The Cincinnati USA Regional Chamber continually advocates for greater investment in transportation infrastructure, as it is critical to the continued growth of the regional economy.

\$107 million will fund the Martin Luther King Interchange Modification Project. The Chamber believes this project is critical to our region as Cincinnati's Uptown is home to two major universities and nine hospitals and related facilities. Each day, 60,000 workers come to and from the Uptown neighborhood, which is also home to more than 40,000 residents.

Additionally, \$363.3 million is allocated for three projects on the Interstate 75 corridor, and is essential to the supply chain and manufacturing corridor that exists along that critical regional and national interstate highway. The recommendations must be approved by Ohio's Transportation Review Advisory Council.

"We applaud Governor Kasich for his leadership on this important issue. As we continue to grow jobs and improve the economy in Ohio, we need a 21st Century infrastructure system to ease the movement of goods and people," said Matt Davis, Vice President of Government Affairs at the Cincinnati USA Regional Chamber. "Top priority should be given to projects that have a strong economic development component, as these projects do and we encourage the TRAC to approve the Governor's recommendations."

If you remember this is about the big dairy out on CR 21. It is owned and operated by the Zijlstra Brothers who hail from Kubarb, Holland.

Their father, Leo, had a family dairy business over in Holland but he needed to expand but couldn't because there was no room available anywhere.

They had from 50-150 milk cows but realized they had to expand if the boys joined into the business, so they came to the U.S. and looked all over for a good spot. They even looked up into Wyoming.

They settled here in the Antwerp area in 1998. The area and soil here is a lot like it is back in Holland.

While the dairy was being built they lived in the Charlie Ferrari house down on CR 162, and Jan finished high school here in 2000.

The dairy was in operation at that time. They started with about 700 cows. Jan's family operated the business while he went off to the Ohio State University branch in

Wooster, OH. While he was at college he met a pretty girl who became his wife, Hillary Bordener, from Freemont, OH, class of 2001 at St. Joe High School. They were married in 2007 at St. Mary's in Antwerp. To this union four children have been born: Ilse, 10 in 4th grade at AHS; Alex, 8 in 3rd grade; Anneliese, 3, and Lily is 8 months old.

They started the dairy in August of 2000 with 700 cows and has increased to about 1400 cows. They milk the cows three times each day. They leave two hours each day for cleaning the equipment. There are two brothers and they operate it like a family business. They have about 15 employees. Jan tells me they feed the cows silage, alfalfa, corn, keola, corn gluten—they feed the cows two times a day.

The milk is put into a big tanker truck and most of it goes to Minster, OH. It is used in making yogurt. The milk is sold by the hundred weight, not by the pint, quart or gallon.

Jan said this country is about like the area back in Holland. They got acclimated quickly over here. He likes the country, the people are so friendly.

I asked if he had time for hobbies. He said he enjoys going down to the big "O" and having hot wings and drink a beer and talk with his friends and neighbors on Wednesday nights.

Hillary loves animals, especially horses; gardening; children; cooking and bak-

ing; meeting with the family and going down to the Riverside Christian Church.

They have settled into the American way of life pretty good. They back all the children's activities at the school and that will get busier as time goes by.

Well, Jan and Hillary, it was mighty interesting talking with you.

At the game, I had two glasses of sassafras tea. Ben had a few mugs of near beer. Some of the men would put in spirits and they could get near drunk on near beer.

Pastor Rick Grimes was born in Hicksville in 1961 and graduated in AHS in 1980.

He fished the Maumee River a lot with his Uncle Joe Fanin. They caught a lot of small channel cat fish and now and then a big one. But on this evening in early September Rick was fishing in Snook's Bottom. A short ways down stream from the SR 49 bridge.

He caught himself some good bait and figured a rain was coming so fishing might be pretty good.

He had some luck and the rains came and he just went on fishing. After the front goes through the barometer rises and the fish won't bite. This was at night, he just wore a hat with a light on it. Pretty soon he got a good bite and after a lot of pulling and scraping after 10 minutes he brought in a flathead catfish of about 23 pounds, but what a strong puller.

On his 9 foot rod he had a lot of action that pulled very hard and long and after he pulled that one in, it weighed about 25 pounds.

Rick says the answer to the big ones is having your drag set right, let the fish fight the pull, there is no reason to have your line to break. After 10-12 minutes he caught this big lunker and this one weighed about 33 pounds. Along about 8:30 a.m. he stopped at the WBN and showed me all these fish.

ODOT CONSTRUCTION & MAINTENANCE PROJECTS WEEK OF JULY 29, 2013

Did you know this highway fact... ?

The I-75 reconstruction project required more than 5,000 measurements to be taken by the District 1 survey department.

Interstate 75 Reconstruction Project:

For the most recent information concerning the Interstate 75 reconstruction project through Lima and Allen County, and the safety upgrade of Ohio 117/309 on Lima's east side please visit: www.odotlima75.org

Interstate 75 between Fourth Street and Ohio 81 in Lima will have occasional nighttime lane restrictions during reconstruction of the existing lanes of pavement, replacement of mainline bridges and reconstruction of the interchanges. Work began in March 2013 and will continue through fall of 2015. Traffic is maintained two lanes in each direction the majority of the time. Lane restrictions generally occur from 7:00 p.m. until 10:00 a.m. the following morning. All ramp entrance and exits are currently available.

All entrance and exit ramps at the Fourth Street interchange with Interstate 75 are now closed as of Monday, July 15. The southbound entrance and exit ramps closed Monday, July 15 for 60 days for reconstruction. The northbound entrance and exit ramps closed July 8 until mid August for reconstruction. Traffic is detoured to the Ohio 65 interchange then north on Ohio 65 (St. Johns Road) to Fourth Street. Electronic message boards have been placed on Interstate 75 advising motorists to use Ohio 65.

Ohio 117/309 is one lane in each direction in the east-bound lanes from just west of the interchange with Interstate 75 to Bowman Road during a safety upgrade project which will reconstruct areas of the pavement and install a raised curb median in the center of the roadway.

Beginning Monday, July 29, traffic will be switched from the south side of roadway to the north and will be two lanes in each direction without a center turn lane. Only two lanes of traffic will be maintained, one lane in each direction, from Wil-

lard Avenue (Speedway) to the west of the Interstate 75 interchange where concrete pavement has been placed and must cure prior to traffic being placed on it. Once the cure time is complete, traffic will remain one lane in each direction from Willard Avenue to the west of the interchange, but will be traveling on the north side of the roadway.

for sanitary and storm sewer installation. Traffic detoured onto Ohio 49, U.S. 24 and U.S. 127 back to Ohio 111. Work is being performed by Underground Utilities Inc., Monroeville.

Ohio 114 east of Grover Hill closed July 22 for 10 days for crossover replacements. Traffic is detoured to Ohio 637 to Ohio 613, to Ohio 66 back to Ohio 114. Work is being performed by the Paulding County ODOT maintenance garage.

Ohio 637 south of Ohio 111 will be restricted to one lane through the work zone at various times for drainage repair. Work is being performed by the Paulding County ODOT maintenance garage.



TIPS FOR SETTING - AND PURSUING - FINANCIAL GOALS

You can get lucky by finding a parking meter with time left on it. You can "luck out" by having nice weather on your vacation. You can even be lucky at love. But when it comes to financial matters, you're better off not counting on Lady Luck — and focusing instead on setting and pursuing goals.

Here are some suggestions for establishing and pursuing your financial objectives:

- Be specific. You probably have a lot of ideas about what you want to do, but if you're going to turn these wishes into reality, you need to get specific. So, for example, instead of telling yourself that you want to retire early, set a goal of retiring at, say, 62. You can then use this target number to help guide your overall investment strategy. To illustrate: You can determine that you need to invest a certain amount of money each year, and earn a certain rate of return, to be able to retire at 62. You can also estimate about how much money you can afford to withdraw from your investment accounts each year to sustain a retirement that begins at 62.

- Prioritize your goals. Of course, you want to achieve all your financial goals — and you can have a better chance of doing so if you rank these goals in terms of both importance and timing. For example, you may want to send your kids to college, purchase a vacation home and still be

able to retire at age 62. How should you allocate your resources to each of these goals? Should you invest more at any given time for a specific goal? What types of investments are best for each of these goals? Prioritizing your goals can help you answer these and other questions — and help direct your overall investment strategy.

- Be prepared to change your goals. Over time, your family and financial circumstances can change considerably — which means you shouldn't be surprised, or alarmed, if you have to change your goals accordingly. And you'll find it easier to maintain this flexibility if you've worked diligently to create an investment portfolio with sufficient resources to allow you to change direction, as needed.

- Review your progress regularly. If you're going to eventually achieve your goals, you absolutely need to measure your progress along the way. Are your investments performing the way you had anticipated? Are your goals becoming more expensive than you had initially envisioned? To achieve these goals, are you taking on too much — or too little — risk? To answer these types of questions, it's a good idea to review your overall progress at least once a year and then make whatever adjustments may be necessary.

As you can see, it will take considerable effort to set, review and (hopefully) achieve your goals. MEETING NOTES OF APPOINTMENTS:

Corey Walker, DJFS; Jim Langham, Paulding Progress - Mr. Langham interviewed Mr. Walker regarding the pending purchase of a building to house Paulding County's DJFS. Mr. Walker noted Paulding County DJFS is currently located in three buildings. The main office is at 303 W. Harrison Street; and the ACCENT job center is being leased and is located on Dooley Drive; and 315 W. Harrison is rented and used for supervised home visits and storage. Mr. Walker explained the new building will be large enough to meet all three needs. He explained that the building will not use any direct local dollars and will be county property once the loan is paid. Mr. Walker emphasized the importance of having one site for all services. He is also excited about the handicapped accessibility, stating the hallways and doors will accommodate wheelchairs. Mr. Walker explained the agency's focus is on assisting clients in finding employment. At their main office, clients can apply for food stamps, Medicaid, and cash assistance. Some entitlements require working. ACCENT job center assist clients with resumes, applications, and work directly with potential employers. By combining the two sites at one place, clients will enjoy a 'one-stop-shop'. The county owns the facility at 303 W. Harrison. The Commissioners intent is to utilize it for records' storage for county offices. Mr. Walker estimates

ANTWERP ROTARY VISIT NEW FACILITY

Dr. William Bricker announced at the Antwerp rotary Meeting on Thursday, July 25th that the presenter of the day would be from the new industry that started in Hicksville.

Christopher Kerns from Fort Worth Towers answered questions concerning the new business that opened up last year in July 2012. The old Dietrich building was purchased and needed quite a bit of work to be used for this manufacturing facility.

What is made here? Chris, who is the Production Manager, said FWT makes electric poles. Electric poles are not wood like they have been made over the past 150 years, but they are made of rolled steel. These are anywhere from two to four sections in length. Some are very large and can measure up to 250' long.

Currently FWT puts out

about 2200 tons of finished poles. Their goal over the next year is increase the tonnage to 5000 tons per month.

About 500 sections per month are brought into the factory after the metal has been shaped as an octagon. The two halves are welded together then taken by a large crane, down the line to be finished by the workers. After that the poles are shipped to be galvanized. Larger sections will be finished in a facility behind the new factory.

The finished poles are placed out back, then wait to be shipped out to power suppliers such as AEP, First Energy, Duke or Northwest Energy.

At this time there are 157 skilled workers at FWT and they make from \$14 to \$20 per hour. They are continuously looking for welders with skill.

the DJFS will be moved into its building early fall.

Denise Gebers, Paulding Progress - Ms. Gebers met with the Commissioners to discuss the reorganization of the Paulding County Dog Warden and kennel. The Commissioners confirmed that Brandon Shuherk was appointed interim Dog Warden on July 1, until the Sheriff

LATTA INTRODUCES SPORTSMEN HERITAGE & RECREATIONAL ENHANCEMENT ACT

Congressman Bob Latta (R-Bowling Green), in conjunction with the Congressional Sportsmen's Caucus, has introduced H.R. 2799, the Sportsmen's Heritage and Recreational Enhancement (SHARE) Act. This bipartisan legislation would create an official advisory board, known as the Wildlife and Hunting Heritage Conservation Council, to serve as counsel to the Departments of the Interior and Agriculture on policies that

benefit recreational hunting and wildlife resources.

"Ensuring that sportsmen and sportswomen have an advisory capacity role across future Administrations is vital for all who enjoy the great outdoors throughout the nation to engage and provide consensus recommendations to federal agencies who will benefit from the Council's vast experience and expertise," said Congressman Latta. "I am confident that this legislation will serve to the betterment of current and future generations of hunter-conservationists."

The Congressional Sportsmen's Caucus is a bipartisan, bicameral group with nearly 300 members of the House and Senate representing almost all 50 states. Congressman Latta serves as Co-Chair of the caucus.

FARM SERVICE AGENCY ANNOUNCES ACCEPTED CRP OFFERS IN OHIO

The USDA Ohio Farm Service Agency (FSA), announced that 9,992.6 acres were accepted during the 45th Conservation Reserve Program (CRP) general sign-up. Currently, Ohio has 317,363 CRP acres enrolled on 37,162 contracts.

Nationwide, USDA accepted enrollment of 1.7 million acres bringing the total program enrollment to 26.9 million acres.

For more than 27 years, CRP has protected natural resources in Ohio while providing economic and environmental benefits to rural communities throughout the state. The newly accepted CRP offers will continue the CRP legacy by improving water and air quality, increasing wildlife habitat and preventing soil erosion.

CRP is a voluntary program that allows eligible landowners to receive annual rental payments and cost-share assistance to establish long-term, resource-conserving covers on eligible farmland throughout the duration of their 10 to 15 year contracts. Accepted contracts will become effective October 1, 2013.

All CRP sign-up 45 offers were evaluated and ranked using the Environmental Benefits Index (EBI) that consists of the following five environmental factors plus cost: wildlife enhancement, water quality, soil erosion, enduring benefits and air quality.

PAULDING COUNTY COMMISSIONERS MEETING MINUTES 7/22/13

This 22nd day of July, 2013, the Board of County Commissioners met in regular session with the following members present:

Fred Pieper, Tony Zartman, Roy Klopfenstein, and Nola Ginter, Clerk

ALLOWANCE OF CLAIMS: Warrants documented as 199624 through 199707 for County Bills were approved and certified to the County Auditor for payment.

IN THE MATTER OF AMENDING THE 2013 ANNUAL APPROPRIATION (FUND 022):

The Board of County Commissioners does hereby direct the County Auditor to amend the 2013 Annual Appropriation by appropriating the following in the Domestic Violence Fund (Fund 022):

022-001-00001/Domestic Violence/Other Expenses AMOUNT: \$69,000

MEETING NOTES OF APPOINTMENTS:

Jim Langham, Paulding Progress - Mr. Langham learned that a third wind energy company will soon be ready to break ground on their project. Northwest Ohio Wind Energy's parent company, Trishe, plans to erect 50-55 turbines in Blue Creek and Latty Townships in the southern part of Paulding County. Brad Norton is the field specialist for Northwest Ohio Wind Energy. His office is located in Grover Hill in the building previously occupied by the bank. Northwest Ohio Wind Energy's project plan is before the Ohio power citing board for approval. The Commissioners have supported alternative energy projects, noting that they broaden the county's tax base, providing new revenue to the schools, townships, and other county entities. The Commissioners encourage all developers to consider Paulding County as a possible project site. The Commissioners also noted the two wind energy companies they have worked with (EDP Renewables and Iberdrola) have been very community minded. Both projects have been a positive experience for those involved. The Commissioners explained the PILOT (Payment in Lieu of Taxes) began this year for the EDP Renewables project. EDP Renewables' project power went on line in 2011; however, wind farms have to be on line for a full calendar year before the PILOT is due. EDP Renewables made their first PILOT in February, 2013, for the tax year 2012. Power generated from Iberdrola's project went on line in 2012 and won't be taxed until 2014 for the full calendar year 2013. Their first PILOT will be due February, 2014. Currently, Benton Township has the most turbines. So far, all turbines are in the Wayne Trace School District. Keith Turvey, Tri-County AD-AMHS - Mr. Turvey and the Commissioners had a telephone conference to discuss the new board structure. Mr. Turvey explained the State Budget Bill which just passed provides permissive language for Mental Health Boards to go from an 18 member Board to a 14 member Board. The rationale for the change is the issue in keeping an active 18-member Board, largely due to the specified nature of those who are state appointed. Those members appointed by the state must have appropriate licensure or credentials. These board members are difficult to fill because those qualified are usually employees of local mental health centers. Employees are not eligible to serve on the Board due to a conflict of interest. This is problematic especially in rural, sparsely populated areas. The Commissioners were in agreement of reducing the number of Board members in an effort to achieve a full Board appointment.

Tom Edwards, Smith-Boughan - Mr. Edwards presented the maintenance agreement for the HVAC system at the Courthouse and the Sheriff's Office. Sheriff Landers and Dave Cline were also present at the meeting. Mr. Edwards noted a 3% increase annually on each of the five-year agreements. Mr. Edwards discussed the settings on the thermostats and noted different filters are being used in the wall units at the Courthouse. The Sheriff's Office/Jail is currently on one chiller unit located on the roof of their building. The possibility of zoning the rooms and installing individual units in an attempt to economize was discussed. Sheriff Landers noted the building gets a lot of sun in the south wall of windows. The Commissioners remarked the Probate/Juvenile Court and Probation may need another unit as well. Sheriff Jason Landers - The Sheriff reported the Dog Kennel transition has been going smoothly. The Commissioners discussed the recent mandatory law regarding dog tag fee options (1 year, 3 year, or permanent). A meeting will be scheduled with the Dog Warden and the Auditor to discuss these options.

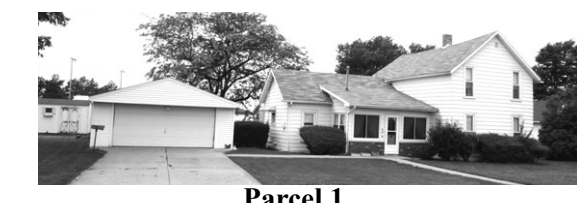

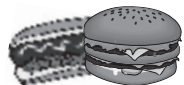
