





WEST OHIO FOOD BANK'S 25th Anniversary & Hun-Ger Action Month

On September 11, Gary Bright, CEO of West Ohio Food Bank (WOFB), will be participating in the Mayor's weekly press conference to share several big announcements:

First, September is National Hunger Action Month and WOFB along with Mayor Berger (who will be making a proclamation to this effect) are asking that everyone find some way to get engaged in the fight against Hunger. There is a calendar available on their website (wofb.org) suggesting simple ways to get engaged daily.

Second, WOFB is announcing that it is in its 25th year of operation and they are kicking off their anniversary campaign at the press conference announcing ways that everyone can partner with them in their pursuit of "ending hunger together". "The West Ohio Food Bank can provide eight meals to one of our local food pantries or soup kitchens with every donated dollar. Because we can make a dollar stretch so far, every donation counts and makes a significant impact. We would love to see as many people as possible commit to donating \$25/year, \$25/ month, or whatever amount is feasible for them in honor of our 25th Anniversary and to help us meet the increasing need. Everyone is invited to our distribution center for a tour so that they can see how dollars are put to work. We are seeking sustaining partners in addition to our traditional donors. Our focus this year is to engage with more people who share our vision of ending hunger together and will commit to partnering with us as a donor, volunteer, advocate, or in other ways" states Bright.

From a very humble start in 1988 as the "Lima Area Food Bank" the agency was housed in the basement of the First United Methodist Church, and distributed about 115,000 meals of food. In 1991 the food bank moved to larger facilities on Kenilworth Street and began serving communities outside of Allen County. By 1997 the food bank needed to expand further still and moved to a 50,000 sq. ft. facility on Wayne Street and enjoyed the benefit of larger freezer and refrigeration capacity. At that time the Wayne street location seemed ideal, but by 2003 the need to move again became obvious. Millions of pounds of food had to be turned away as the treezer and retrigeration capacity had been exceeded. Then CEO Bambi Markham sought and found the current facilities at 1380 E. Kibby St. with industrial freezer capacity of 11 semi truck loads and a refrigeration unit capable of holding five truck loads of perishable goods. While the space of the current facility is capable of handling double the 7,000,000 pounds of food that the West Ohio Food Bank distributes to the 175 programs in the 11 counties served, more funds are needed to allow for increased distribution. Industrial freezer and refrigeration space is currently more than adequate, but the age of the units have caused the food bank to enter into a \$120,000.00 capital campaign to replace the industrial chillers and compressors that are the heart of the food banking.

Finally, WOFB, in partnership with Activate Allen County will be unveiling the Activate Allen County's Mobile Produce Market at the Health Summit on September 17 at Lima Senior High at 5:30 p.m. Plans are to have the bus in operation for the public by the following week. The intent of this program is to bring affordable, fresh produce, into areas of Lima and Allen County where it is not currently accessible. All forms of payment will be accepted, eventually including the EBT card, and prices will be set at rates that residents in the area can afford as product sales will pay only a small portion of the program costs. Major corporate and other sponsors, who will be announced at the unveiling, are paying a majority of the program's costs.





In Joshua 24:15 Joshua challenged the Israelites to choose if they would follow St. James Lutheran Church



ODOT CONSTRUCTION & MAINTENANCE PROJECTS WEEK OF 9/9/13

Did you know this transportation fact...?

All traffic signals within ODOT District 1 are inspected annually and receive a complete field check of components. Annual inspection and maintenance is important to ensure reliable operation. The district traffic department maintains 39 traffic signals, 3,300 highway lighting fixtures and 60 school flashers

Interstate 75 Reconstruction Project:

For the most recent information concerning the Interstate 75 reconstruction project through Lima and Allen County, and the safety upgrade of Ohio 117/309 on Lima's east side please visit: www.odotlima75.org

 Interstate 75 between Fourth Street and Ohio 81 in Lima will have occasional nighttime lane restrictions during reconstruction of the existing lanes of pavement, replacement of mainline bridges and reconstruction of the interchanges. Work began in March 2013 and will continue through fall of 2015. Traffic is maintained two lanes in each direction the majority of the time. Lane restrictions generally occur from 7:00 p.m. until 10:00 a.m. the following morning. The following is project information for the coming week:

Ohio 117/309 interchange

—The entrance ramp to Interstate 75 northbound from Ohio117/309 is closed as of August 29 for at least one month to allow for construction of the new northbound ramp and new northbound pavement on Interstate 75.

—Traffic on Ohio 117/309 eastbound wishing to access I-75 northbound will be directed to Ohio 117, Greely Chapel Road to Fourth Street back to I-75. Ohio 117/309 westbound will be directed to Lost Creek Boulevard, Ohio 117, Greely Chapel Road and Fourth Street back to I-75.

Fourth Street interchange

—The southbound entrance and exit ramps at Fourth Street remain closed for reconstruction. Traffic is detoured to the Ohio 65 interchange then north on Ohio 65 (St. Johns Road) to Fourth Street. Electronic message boards have been placed on Interstate 75

advising motorists to use Ohio 65. Northbound ramps are open.

<u>I-75 Mainline</u>

—Traffic on I-75 northbound has been switched onto the new concrete pavement from just south of Fourth Street to a point prior to the Ohio 117/309 interchange where traffic is then transitioned back to the existing pavement. This will allow crews to complete the construction of the new concrete pavement at the south end of the project.

—Paving of the new lanes on Interstate 75 in the northbound direction outside the barrier wall from just south of Fourth Street to Ohio 117/309 is completed at this time. Paving in the southbound lanes from south of Fourth Street to the Ohio 117/309 interchange is under way. Traffic on Interstate 75 could be affected at times. Motorists are cautioned to watch for concrete trucks entering and exiting the highway over the next several weeks as the operation continues.

—Motorists should be aware that all entrance and exit ramp merge areas have been shortened throughout the project area. Drivers on Interstate 75 are encouraged to use the passing lane through the zone if they do not wish to exit. Signs advising this have been placed throughout the project area.

• Ohio 117/309 is two lanes in each direction without a center turn lane from just east of the interchange with Interstate 75 to Bowman Road during a safety upgrade project which will reconstruct areas of the pavement and install a raised curb median in the center of the roadway. All traffic is currently traveling on the north side of the roadway while work takes place on the south. Only two lanes of traffic are maintained, one lane in each direction, from Willard Avenue (Speedway) to the west of the Interstate 75 interchange. This part of the project will be completed this fall.

—Ohio 117 between Ohio 309 and the service road behind McDonald's will close Friday, September 6 beginning at 9:00 p.m. and will reopen Monday, September 9 at 6:00 a.m. to allow for reconstruction of the pavement and of the intersection. Traffic detoured onto Lost Creek Blvd. back to Ohio 117. Traffic on Ohio 309 will not be affected and access to the restaurants at the intersection will be maintained.

• Ohio 81 from just west of Stewart Road to just west of Neubrecht Road east of Lima is one lane in each direction in the existing eastbound lanes for pavement reconstruction. All ramp movements are currently maintained at the interchange with Interstate 75. **DEFIANCE COUNTY:** Ohio 15 from the city of Defiance to the Williams County line restricted to one lane through the work zone intermittently for pavement repair and resurfacing. Work is being performed by Gerken Paving, Inc., Napoleon. PAULDING COUNTY: Ohio 49 on the south end of the village of Antwerp will close for one day on September 16 for drainage work. Traffic detoured onto U.S. 24, U.S. 127 and County Road 424 back to Ohio 49. Work is being performed by Lentz Construction for the village of Antwerp. Pavement repair will take place at the following intersections with traffic maintained through the work zone. Work is being performed by Paulding County ODOT maintenance garage:

-U.S. 127 and Ohio 111 -U.S. 127 and Ohio 613 -U.S. 127 and Ohio 114 **Ohio 637** between Ohio 111

and Ohio 66 restricted to one lane through the work zone for replacement of drainage components. Work is being performed by Paulding County ODOT maintenance garage.

Ohio 111 in the village of Paulding west of U.S. 127 closed July 8 for seven weeks for sanitary and storm sewer installation. Traffic detoured onto Ohio 49, U.S. 24 and U.S. 127 back to Ohio 111. Work is being performed by Underground Utilities Inc., Monroeville.

PUTNAM COUNTY:

U.S. 224 a half mile west of the village of Kalida to the CSX railroad in the village of Ottawa will be restricted to one lane through the work zone for pavement repair and resurfacing. Work is being performed by Bluffton Paving, Bluffton.

Ohio 108 south of Miller City to just north of Miller City will be restricted to one lane through the work zone for pavement repair and resurfacing. Work is being performed by Bluffton Paving, Bluffton.

Ohio 694 from the Glandorf corporation limit to just north of Glandorf will be restricted to one lane through the work zone for pavement repair and resurfacing. Work is being performed by Blufton Paving, Bluffton.

Ohio 634 between the village of Cloverdale and Road T-I-22 restricted to one lane through the work zone for drainage work. Work is being performed by the Putnam County ODOT maintenance garage.

VAN WERT COUNTY:

Ohio 49 inside the corporation limits of the village of Convoy restricted to one lane through the work zone for pavement repair and resurfacing. The project is expected to be completed during the week. Work is being performed by Shelly Company, Findlay.

Ohio 117 near its intersection with Ohio 116 is now open.

U.S. 127 three miles south of Van Wert closed August 13 for 45 days for bridge repair. Traffic is detoured to Ohio 81 to Ohio 118 back to U.S. 127. Area young people ages 8-17 will have a chance to take to the skies on Saturday, September 14, 2013, as Experimental Aircraft Association (EAA) Chapter 2 hosts a Young Eagles Flight Rally at Smith Field Airport, Fort Wayne, IN.

The rally is part of the EAA Young Eagles Program, created to interest young people in aviation. Since the program was launched in 1992, volunteer EAA pilots have flown over 1.8 million young people who reside in more than 90 countries.

Free airplane rides are just part of the Flight Rally. Pilots hope to give a new generation a chance to learn more about the possibilities that exist in the world of aviation. Pilots at the event will also explain more about their airplanes allowing young people to discover how airplanes work and how pilots ensure safety is the prime concern before every flight.

Following the flight, each young person, will receive a certificate making them an official Young Eagle; a log book to record their flight and future flights; access to Sporty's Complete Flight Training Course for FREE; EAA student membership until age 19; Academy of Model Aeronautics student membership; and many other benefits. 



Generally speaking, if you're efficient at a particular task, you'll get good results without wasting effort. As you've already learned from your life experiences, it's usually far better to be efficient at something than to be inefficient — and that's certainly true with investing.

So, what can you do to become a more efficient investor? Here are a few ideas:

• Invest systematically. If you put a few dollars in an investment, such as a stock, that you heard was "hot," and then a few months later put some more money in another vehicle that strikes your fancy, and you continue this pattern indefinitely, you may not be maximizing your resources. By taking this type of haphazard approach, you could end up owning a bunch of investments without rhyme or reason — a motley assortment that may not help you reach your goals.

Instead of following this route, consider a systematic approach, sometimes known as dollar cost averaging. To do so, you'll first want to identify some investments that are appropriate for your objectives, risk tolerance and time horizon. Then, automatically move the same amount of money each month from your checking or savings account into the investments you've chosen. When the price of your investments falls, your contribution will buy more shares, and when the price rises, you'll buy fewer shares - in other words, you'll be fulfilling the "buy low" part of the classic investment formula. Over time, this technique should result in a lower average cost per investment. Keep in mind, though, that dollar cost averaging does not ensure a profit or protect against loss — and you'll need to have the financial resources available to continue investing, even in "down" markets.

 Reinvest dividends. Among your investments, you may own stocks that can pay dividends. You can take these dividends as cash, but if you don't need the money to meet everyday expenses, you may be better off by reinvesting the dividends This is an efficient way to increase your shares — and boosting your share ownership in quality investments can be a key way to help build wealth. (Be aware that companies can reduce or discontinue dividends at any time.)

• Look for tax-efficient techniques. Another type of efficiency associated with investing is tax efficiency, which refers to your ability to defer taxes as long as possible. Tax-deferred accounts, such as a traditional IRA or a 401(k), can help you put off the tax bill until retirement, when you may be in a lower tax bracket.

• Consolidate investment accounts. If you have one IRA with one financial services provider, another IRA with a second, and a separate investment account with a third, you may end up paying more in expenses, fees and commissions than is necessary – and since these costs can eat into your investments' "real" rate of return, this scattershot ownership method may be inefficient. You may be better off by consolidating all your investment accounts with one provider.

Seek to become an efficient investor. You may be pleased with the results.

The Ohio High School Athletic Association board of directors met Thursday for its regularly scheduled September meeting. The following are highlights from the meeting. The complete set of meeting minutes will be posted later at OHSAA.org.

• The board reviewed the list of 30 schools that met the 2012-13 OHSAA Respect the Game Challenge. Eighteen of those schools also earned the Harold A. Meyer Award. The OHSAA will issue a separate release Friday with the list of schools and description of the awards.

• The girls and boys soccer regional tournament draws were conducted and will be posted on the soccer pages at OHSAA.org. Sectional draw/ seed meetings will be held around the state October 6.

• The 2014 and 2015 girls and boys track and field divisional alignments and representation were approved by the board and are posted at: http://www.ohsaa.org/members/sptdivis13.htm

• Five schools were recently penalized for committing infractions of OHSAA bylaws or sports regulations. The list of schools, along with their infractions and penalties, is always included in the complete meeting minutes, however media members may request the list prior to the meeting minutes being posted by contacting Tim Stried, OHSAA Director of Information Services, at tstried@ ohsaa.org.

• The baseball coaches association made two proposals. First, to increase the number of playing dates that an individual player is allowed to participate during the baseball regular season from 27 to 32. (Note this would not change the number of team games permitted, which is 27.) Second, to expand tournament rosters from 18 players to 22. The board is expected to vote on the proposals at its December meeting.

from the 2013 regional and state baseball and softball and boys state tennis tournaments were presented to the board. The baseball tournament saw a total state tournament attendance of 15,152, which is the fourth-highest all-time, and resulted in a net profit of \$10,203. The softball regional and state tournaments resulted in a loss of \$9,850, which included a total state tournament attendance of 6,630. The boys tennis state tournament saw a crowd of 1,141 and resulted in a loss of \$5,674.

• The board approved a correction to the Division I girls basketball tournament representation. Initially, Marietta High School was incorrectly listed as a Division II school and Chillicothe was listed as a Division I school. It has been corrected (Marietta is Division I and Chillicothe is Division II) and Marietta has been assigned to the Northeast District Athletic Board's list of Division I schools for the sectional and district tournaments. After recalculating the formula to determine the number of regional qualifiers from each district, the addition of one more school to the Northeast resulted in the Northeast gaining one more Division I regional qualifier, while the Northwest lost a Division I regional qualifier. Therefore, the 16 regional qualifiers in Division I girls basketball will be comprised of the following district champions: seven from the Northeast, one from the Northwest, four from the Southwest and four from the Central/East/Southeast combined district.

• The board approved the winter sports manuals. The manuals will be posted on the respective sports pages at OHSAA.org.

• The board approved the 2013-14 OHSAA General Media Regulations and a oneyear extension with Impact Action Sports Photographer to serve as the OHSAA's official state tournament photographer.

AREA STUDENTS TO HOST FIELDS OF FAITH EVENT

Students from Antwerp, Hicksville, Wayne Trace, Paulding and other area schools will be joining thousands of other youth on athletic fields all across the nation on Wednesday, October 9, 2013, at 7:00 p.m at the Antwerp Community Ball Fields. They will share their Christian faith with fellow students during the eighth annual national Fields of Faith event. This rapidlygrowing, interdenominational outreach event will be held at more than 450 locations

throughout the nation on this same date.

While many Christian rallies are anchored to an entertainer or professional speaker that creates a spectator event, Fields of Faith is structured as a student-to-student ministry. Peers invite their own classmates and teammates to meet on their school's athletic field to hear fellow students share their testimonies, challenge them to read the Bible and to come to faith in Jesus Christ.

This will be the third Fields of Faith event for the Antwerp area. Last year, approximately 200 students and supporters attended at Antwerp.

The national growth of Fields of Faith has been remarkable. Since the beginning of Fields of Faith in 2004, more than 600,000 students have joined in the movement. In 2012 alone, more than 160,000 students gathered on 424 fields across 37 states to participate in the event.

It's not just those numbers that have FCA organizers excited about Fields of Faith. It's the real-life impact that these gatherings are having on young people. Last year's series of events saw 3,710 students make first-time faith commitments to follow Jesus Christ, 4,809 recommitted their life to Christ and 6,885 committed to reading the Bible daily.

"The impact of Fields of Faith has been incredible in just these past few years," said Les Steckel, FCA president and former veteran NFL coach. "It's all about young people in these communities coming together on their school's athletic field and challenging each other to go back to the fundamentals of reading God's Word and coming to faith in Jesus Christ."

The impetus for Fields of Faith began with Jeff Martin, an FCA staff person, who conceived the idea from an Old Testament reference in 2 Chronicles 34 after searching how to help today's generation of students face spiritual battles and temptations. In the scripture, King Josiah, an influential teenager very similar to Fields of Faith attendees today, gathered his people and challenged them to read the Bible. As a result, they changed their culture.

In 2004, the Josiah-influenced dream came true when 6,000 students gathered on school athletic fields throughout three states for the first Fields of Faith event. That was the beginning of what has become one of the most significant faith-related gathering of students in a single day.

"Fields of Faith chall this generation to be committed to reading the Bible and living a transformed life for Jesus Christ," said Martin. "It's students challenging students, peers challenging peers and that's the heart and soul of Fields of Faith." While Fields of Faith has its roots with FCA leadership, the event is designed to include multiple national Christian organizations, local churches and ministries.
