THE OLD JAIL: BIDS OPENED



On February 13, 2013 in Paulding County Commissioners opened the bids for the old jail. The old jail was built in the late 1800s and has been used until about seven years ago when a new jail was built and finished. There has been an outcry about trying to save the jail and the commissioners have been asked to put it up for bid instead of demolishing the historic structure.

At 10:45 a.m. the commissioners opened the letters. There were four sealed bids submitted, but only one included the request of a plan of action for the building. The Paulding County

Commissioners have rejected all bids for the sale of the old County Jail due to incomplete bid packets.

The pending sale will be put out for re-bidding, with bid opening scheduled for March 20, 2013, at 9:45 a.m.

LATTA INTRODUCES BILL **TO REPEAL ESTATE TAX**

Congressman Bob Latta (R-Bowling Green) introduced a bill to permanently repeal the estate tax and ensure that individuals are not taxed on the increased value of an estate by retaining the stepped-up basis at death. 'Our nation was founded on the belief that through hard work, an individual can create an inheritance for future generations. The estate tax, also known as the death tax, punishes the efforts and investments that hardworking taxpayers have made during their lifetime. Many families are forced to sell off land, equipment and assets in order to pay the tax," said Congressman Latta. "Permanently eliminating the estate tax is an important step in ensuring that our small businesses and farmers, which are an essential part of Ohio's economy, can grow and prosper into future generations."

Currently the top estate tax rate is set at 40 percent, with an exemption of \$5 million, indexing that exemption amount to inflation. The estate tax is a federal tax levied against the assets of a person's estate when they pass away.

The team designed paper covered with special chemicals. Once the paper goes through the printer, the chemicals are exposed to a light source that causes the text on the paper gradually to fade. It disappears completely in 16 to 24 hours, but can be quickly erased by running it through the printer again.





Dan took our P-51 back to the Aachen Air Base to refuel and pick up another 40mm magazine. It is only about 9:30 in the morning.

We are back in the air and west of the Schnee Eiffel in the area of Monchau, but off to the west of that area a little.

We spotted a number of German vehicles lined up to cross a bridge that the Americans had blown up. They were almost dead targets, because they couldn't maneuver.

The first tank in the crossover was a big King Tiger. You can't hurt that big thing on the front end, because it has eight inches of armor. We put a 40mm round into his track on the right side and we made a circle and came back and blew the other track off. By now the tank can't move, and they don't have a wrecker to move him. I think we did a good job there.

Dan put a 40mm round into the engine weld of two more tanks in line there and that buttoned up that highway and there will be no more traffic going west on that road.

We tore back to our base to refuel and pick up another magazine of 40mm shells.

The other two P-51's were back and we had to wait. It was now noon and we caught a truck going to the mess hall. There was a lot of talking and waving as each pilot was telling what he had destroyed that morning.

We are not receiving any flaks because the German's don't have any. They do have some machine guns on each vehicle, then they try to duck down when they see a plane bearing down on them.

That afternoon was about the same furious action. There sure was a lot of

good stories and good reports to turn into the General.

About all of the German Armament was tanks, halftracks, troop carriers, and some anti-tank weapons.

So we needed some 40mm or even bigger. Those two planes that carried the six 5" rockets called 10xM1 really did a good job today.

Lt. Hornish told about getting one big Tiger Tank. He said he fired one 5" rocket and it hit the Tiger right where the turret attaches to the lower body of the tank. It blew the turret over to the side of the tank, and then a big fire started inside the tank. What a lucky shot!

He said he got one more tank and two half-tracks and a couple of trucks. "Oh my goodness, what a 5" rocket will do to a truck!" He said.

Lt. Wiltsie said, "I wasted a rocket until I got used to what they would do and boy, did I have a day! I got 4 tanks, a water truck and a trailer."

Gen. Norm said, "Well fellows lets add up everything and see what we got today." We got one King Tiger Tank out of action and one destroyed, seven Tiger Tanks destroyed, two half-tracks, three trucks and one water wagon.

"Fellows, I'd say that's a pretty good Christmas day," said General Norm. See ya!

We are back to the agency now. A lot of the garden vegetables are ready, because this is the last week of July in 1859.


Rooster, the runner, takes over the cooking chores when he is here. He spent all morning out in the garden getting some fresh vegetables for our big cookout later this afternoon. We had fresh vegetable soup with buffalo meat and fried deer meat. We had biscuits and honey with mulberries and honey for dessert.

There were the four soldiers, Callie and I plus the twins and Yellow Tulip. We sat around the fire and talked. The ladies put the twins to bed and we talked for a couple of hours after that.

We rested all day as there isn't much to do right now. Slim has been bringing in the wood preparing for winter, but he even took today off, and sat in the shade with us.

We played ball with the twins and even went fishing down by the bridge in Rattle Snake Creek.

The wheat is ready to be cut now and Gen Kearney, Billy Metzger and about 10 soldiers arrived this afternoon to cut



They had brought a number of harvesting cradles and some flails and tarps to catch the wheat. The soldiers made a swath across the wheat field with the cradles and left the straw lay on the ground. Then they gathered up the straw and made a large pile under the shade tree. They had a beater, something like a carpet beater. They beat the straw and that removes the chaff from the berry. That all falls down on to the tarp and then we separate the wheat from the chaff. Then it is dried in the sun for a little while and then they start making wheat flour.

They take a flat stone and lay some wheat kernels on the stone and then take another stone and grind it in to a powder like substance. All this flour is put into clean dry buffalo entrails. They will stay dry until needed. It took all day to make the flour, put it away and store it.

They used grease from bear, deer, buffalo, and small animals. As well as maple syrup, honey, parts of roots and tree bark in their cooking.

Rooster is their cook because the Mess Sgt. didn't come along on this trip. He stayed at the fort. We have deer ribs off the spit, fried deer meat on the griddle, boiled potatoes, quartered and hot deer poured all over them.

After supper Rooster showed off his cooking skills. He sliced some new potatoes as thin as possible and dropped them into a bucket of hot grease for a little bit and then fished them out and passed them around on a neat platter after he salted them a little. Everyone liked them, but there was only two or three for each because it had a long time to make them. Rooster called them potato chips. They were a big hit.

The other day, Rooster gathered in a lot of corn and spent a couple of hours getting the corn clean by husking and getting the silk off.

He then took some bear grease and mixed in some honey and stirred it all up and put it on our sweet corn and then sprinkled a little salt on top. The Rooster and his cooking has become quite a hit here.

Gen. Kearney sits in the shade in Callie's rocking chair a lot. He talks about the slavery situation and the condition our country is getting into.

He appears to have aged a lot lately. This last trip should help him and I hope it does, but he does seem to have put all the world's troubles on his shoulders. The Gen. rode Roosters' horse back to the fort to find out all the news bulletins concerning the current action of the impending war and will soon be back. Regan Clem of Antwerp's Riverside Christian Church will be leaving for Liberia in Africa on February 16. He will fly out of Indianapolis to New York City and then onto Liberia from there. He will return March 2.

Liberia has long been friends with America, as two of their major cities are named after past American Presidents: Monrovia and Buchanan.

Regan is part of a unit called Hope2Liberia. The major goal is to provide good clean drinking water for the common Liberian family. You see, one out of four children will die before their fifth birthday because of contaminated water.

Hope2Liberia will be taking over 200 water filters to install for the town water supply. They take a container and put it on a street corner and pour the local water supply into the container. They install the water filter on the discharge spigot and then out comes safe clean drinking water. Regan's group will install the filters and teach the local people how to install and maintain these filters. The populace has plenty of water but it is so contaminated with more germs than you can imagine! There is no sanitary system; all of the refuse goes out onto the ground and eventually back into the water. These water wells are very close to the surface. The water level is just a few feet below the ground level. There is no chance for the dirt and



pany. Truck Maintenance, Inc. helps maintain many of the delivery and service trucks you see on the road every day. In fact their logo, "We can handle it", demonstrates that anything needed in the fleet maintenance department, can be handled by Truck Maintenance, Inc. At this time they have approximately 300 customers, some of which have entrusted their fleets with them for over 30 years.

Much of their business comes from locally owned, small businesses. These types of businesses may only have one or two delivery vehicles. When those vehicles break down it is extremely urgent to get them in and fixed. Because of this urgency, Truck Maintenance, Inc. is open 24 hours a day, 6 days a week. Andrew said, "We always have to think about what the customer needs to complete their day, so our schedule has to be very fluid."

A recent example of this schedule fluidity would be when a customer's truck needed repairs on a Sunday. The call went out requesting a mechanic at 5:00 p.m., and by 6:00 p.m. two mechanics were in the building working. The truck was repaired and ready for Monday morning deliveries. One of the employees said that working at Truck Maintenance, Inc. was somewhat like being a fire fighter; you never know when you will be needed, and every time you are it is an urgent matter.

Not only are the employees at Truck Maintenance, Inc. flexible, the Parts Department strategically stocks items that are customer specific. That gives them the ability to service a vehicle during 2nd and 3rd shifts, when most parts warehouses are closed. Andrew stated, "The most costly thing for our customers is down time and so we really can't have any of that. We're held to a very high standard of low, low down time."

An additional service the team at Truck Maintenance, Inc. offers is transportation for drivers back to their place of employment or to their home. This helps the drivers stay focused on servicing their customers.

Truck Maintenance, Inc. also places their employees needs high on their priority list. Rick said, "Really what we want from our employees is to come to work, enjoy themselves, and then go home. Family is always first. If one of the employees has a problem with a family situation, we really try to cater to that. We want to make sure that they are taking care of their family because that really is the most important thing." Because of the good communication and positive relationships with their employees, Truck Maintenance, Inc. has a very low turnover rate. At this time they employ around 40 employees including some part-time. Their team consists of hardworking, dedicated employees; many of which have been with Truck Maintenance, Inc. for over 15 years. In fact, 14 of their employees have been there over 15 years. They also hire a few college or high school students to do part time work throughout the vear. In the last 2 years Truck Maintenance, Inc. has added

fork lift repair to its service line-up, and has also expanded into commercial vehicle sales. Now when a customer's vehicle is no longer able to be repaired, they have options to put their customers back into service.

This year Truck Maintenance, Inc. is building a new location in New Haven. They have purchased 14 acres on the corner of Adams Center and Moeller Road. When asked what was the biggest benefit they have received from Chamber Membership, Andrew stated, "I think the biggest benefit is having our name listed with other prominent businesses there. There are some good home grown businesses that are part of the Chamber and I think our name needs to be there too. I think it is good to be associated with businesses that have integrity and are doing things right."

LATTA LEGISLATION REMOVES BURDENSOME PAPERWORK MANDATE ON AUTO DEALERSHIPS

Congressman Bob Latta (R-Bowling Green), along with Congressman Gary Peters (D-MI), introduced legislation that would repeal a duplicative mandate that requires auto dealers to certify if a new vehicle has an emissions system.

"This bipartisan effort to eliminate outdated and duplicative regulations will relieve auto dealers from unnecessary red tape they must deal with on a daily basis. This redundant paperwork requirement is from an outdated law that has been superseded by modern technology and standard vehicle warranties. Small business owners are already compliant with the law and the only impact of this unnecessary paperwork requirement is increased costs for auto dealers and consumers," said Congressman Latta.

"Repealing laws that burden small business with no discernible benefit to consumers is something both parties should agree on. I commend Reps. Latta and Peters for their effort to repeal this obsolete mandate," added David Westcott, chairman of the National Automobile Dealers Association (NADA). Under the current regulation, the Clean Air Act requires dealers to present the buyer with written confirmation that a visual inspection has been completed of a new-vehicle's emissions system, however documentation certifying compliance can already be found under the hood or on the Internet. Additionally, new-car dealers are contractually obligated to perform comprehensive predelivery inspections of the vehicle to ensure the emissions system is functioning properly.

LATTA AND PASCRELL INTRODUCE HATCH ACT REFORM

Representatives Bob Latta (OH-5) and Bill Pascrell, Jr. (NJ-9) introduced a bipartisan bill, the State and Local Law Enforcement Hatch Act Reform Act of 2013, which amends and clarifies current law as outlined in the Hatch Act. Specific provisions in the introduced legislation will allow sheriffs, who are on duty 24 hours a day and seven days a week, to participate in political activities and establish a statute of limitations of six months to file a claim with the Office of Special Counsel (OSC) against a state or local law enforcement officer for an

alleged violation. "Under current law, allowable political activities as it applies to the office of sheriff are ambiguous at best. While the first priority of the office of Sheriff is to serve the people, it is both a public and elected position. Updating the Hatch Act will bring much-needed clarity to the law and codify current OSC practices," said Latta. ing collaboration between the art teacher Mrs. Girlie and librarian Mrs. Bagley. The Hatch Act, first enacted in 1939, is the federal law that governs the political activity of public employees, and was created to ensure that federal resources were not directed for partisan political objectives.

Last year, the Hatch Act Modernization Act of 2012, was signed into law and allowed for state and local law enforcement officers to run for the office of Sheriff without having to quit their current place of employment. The latter provision was included in Latta's State and Local Law Enforcement Hatch Act Reform legislation from the 111th and 112th Congress.

Week Three of the New Haven Citizens Academy was held at the New Haven Adams Township Fire Department located on Hartzell Road. Fire Chief John Bennett and EMS Chief Ed Lytal presented a detailed and informative look at the City's emergency response services.

Fire Prevention Educator for the city of New Haven, Shawna Gunder, discussed the department's initiatives to educate the community about fire safety. The Fire Safety Trailer and Hazard House were discussed as means of educating the community's children about fire prevention and fire safety. Tours of the fire station and presentations by Ms. Gunder can be arranged by community groups and individuals by calling the station at 260-493-7500.

Fire Chief John Bennett briefly discussed the department's high Insurance Service Office (ISO) rating. New Haven Adams Township is rated as 3, which is a credit to the department's quick response time, well-trained staff, and wide range of equipment. Because of this rating, residents may receive reduced homeowner's insurance rates or discounts from their carrier (depending on the company). In 2012, the fire department

responded to 1,470 calls for assistance, with an average response time of less than 4.2 minutes.

The Fire Department training officer John Gunder discussed the wide variety of training programs available to New Haven Adams Township firefighters. All firefighters in the department, both paid staff and volunteers, are required to be cross-trained. New recruits must successfully complete the Firefighter I/II course and be certified as First Responders/Emergency Medical Responders. Other training opportunities available include Master Firefighter, Safety Officer, Inspector, Investigator, Fire Service Manager, Fire Officer I/II/III, Fire Instructor I/II/III, CPR/ AED, Hazardous Materials and Paramedic training. In 2012, the department's firefighters logged 5,266 training hours which roughly averages out to approximately 80 hours per firefighter. The minimum training hours required per firefighter is between 60-80. The department also works closely with the Anthis Public Safety Academy and New Haven High School's ICE Program to recruit potential future firefighters, giving them the opportunity to learn about careers in the fire service prior to graduation.



Chief Bennett also pointed out that reflective address signs are available for the community to purchase at the station on Hartzell Road. The signs are intended to be placed on a mailbox, post, or pole in residential yards. These signs dramatically increase visibility of your house number, particularly at night, and assist both the fire and EMS responding to your location in the event of an emergency.

EMS Chief Ed Lytal gave an interesting overview of the history of EMS service in New Haven Adams Township. New Haven's first provider of ambulatory services was Harper & Son Funeral Home beginning in 1887. The reason funeral homes traditionally provided this service was because they were the only ones who had vehicles conducive to transporting patients lying down to the hospital. (No medical care was provided.)

From 1947-1972, the Fort Wayne Police Department provided some basic transportation to the hospital for patients as well as Harper's. In 1971, a new TV show called 'Emergency!' began to influence the future of how emergency services would be provided in New Haven and the country at large. In 1977, Emergency One began to provide Advanced Life Support EMS services to Allen County. In 1978, the Adams Township Fire Department began providing Basic Life Support EMS services, and as a result Harper's announced they would cease their transport operations at the end of 1979. In 1979, what New Haven currently knows as Emergency 45 began Basic Life Support operations in the city.

In 2003, Mayor Terry McDonald requested that the City look into providing Paramedic/EMS services to the residents of New Haven Adams Township. This was the beginning of the modern Emergency Medical Services that residents in the area currently have access to. Emergency 45 is staffed by Paramedics, Basic/Basic Advanced EMTs, and Intermediate EMTS.

In 2012, the department responded to 1,614 runs to residents of New Haven Adams Township. The department is busier than all but 3 stations in the city of Fort Wayne. 46% of the runs the department responded to were for Advanced Life Support needs and happened between the hours of 7:00 a.m. and 7:00 p.m. The department is financially supported by both property tax revenue and insurance billing. The revenue collected from insurance billing directly offsets the salaries of full time staff. Without this revenue, there would be no EMS service in New Haven Adams Town-

In 2012, the department

created an EMS Subscription Service for residents that limits the out of pocket expenses related to medical transport/ treatment provided by the New Haven Adams Township EMS. For \$55.00 a year, residents that live in the New Haven Adams Township EMS coverage area can participate in this program. It is important to note that the Lifecare/ TRAA Ambulance service does not provide service in New Haven Adams Township; therefore, the membership subscription service that is frequently seen advertised on $T\bar{V}$ and in the newspaper for these companies will not do New Haven Adams Township residents any good while they are in the NHAT coverage area. More information about his affordable service that benefits our community's EMS service will be forthcoming later this spring.

In 2010, the department received a \$3,500 grant from Parkview Hospital and Professional Emergency Physicians that provided a 12 lead ECG machine that electronically reports the patient's information to the Parkview ER and Cath Lab. This lifesaving device allows patients being transported by Emergency 45 to the hospital with a heart attack to bypass the emergency room completely and head right to the lifesaving care they need in the hospital's cath lab. New Haven was the first department in the area to offer this high level of technology and patient care to its residents.

At the conclusion of the presentations by Chief Bennett and Chief Lytal, the Citizens Academy students were taken on a tour of the facility by firefighters Dan Bastin and Randy Linker.

Next week, the Citizens Academy will learn about the City's Code Enforcement with Tim Fox at City Hall.

High School Wrestling Sectionals were held all over the state this last weekend. Sectionals are the first of two steps wrestlers take on their path to wrestling in the Jerome Schottenstien Center for a state wrestling title. Wayne Trace competed at the Lima Central Catholic Sectional along with twelve other area D-III teams. Only the top four wrestlers in each weight class can advance to the second step of the journey, districts.

Wayne Trace entered this year's Sectional as one of the top teams in the area. They battled hard for two days and found themselves with five wrestlers in the championship match and three wrestling for placement. This would be the most ever the red, white, and blue would have competing for top place honors. As a

team, they would finish in third place behind runnerup Coldwater and Sectional champs Lima Bath.

Seeded third, Matt Baxter (120) would defeat Kimmett from Jefferson before falling to second seeded Tebbe. Baxter would battle back in the Consi bracket and defeat Columbus Grove's Haunstein to secure his trip to Kettering. He would drop his match for third place to Freeman from Bluffton and finish fourth.

Aaron Miller (132) would wrestle through the championship rounds as the number one seed and finish as a sectional champion. He would tilt matches with Lincolnview's Gibson and Spencerville's Bockey in his favor. In a highly contested championship match, Miller would be up by one point with 30 seconds left. With his legs in, he would put Kaiser from Coldwater on his back for precious back points and secure the win.

Third seed Tyler Showalter (138) would face off against Garrett from Lima Bath and tech fall him. Then, he faced second seeded Spencerville's Binkley and pin him setting up a match with number one seeded McCormick from LCC. Showalter would fall short in this match and finish as sectional runner up. Josh Reel (152) would be victorious against Illig from Jefferson to set up a match against Bath's Wise, the three seed in this weight. Reel would wrestle him tough and with a vicious head lock, in the waning seconds of the match gained the lead, but he was only awarded points for the takedown and no back points and fall just shy of the upset. He would finish in 6th place.

In the 160 pound class, Sawyer Temple would send Sawmiller from Spencerville and Delphos St. John's Wrasman to the Consi bracket. He would then square off against number one seed McAdoo from Allen East. This match was a nail biter and would not be decided in six minutes. Score remained 1-1 and went into overtime where Temple would lose the match with McAdoo capturing the takedown.

^aRiley Moore (220) would drop a match to Spencerville's Krouskop and be forced to wrestle for district alternate. He would dominate in this match, pinning McKinley of LCC and earning a fifth place finish and the alternate spot at districts.

"Overall, I am excited to have six wrestlers and possibly an alternate taking the next step and going to Kettering to wrestle at districts. We emphasized that records aren't important any longer. What a wrestler had done in the season doesn't matter, what does matter is the six minutes you have when you step on the mat. Can you be the better wrestler in those six minutes? Today, we had six wrestlers that were good enough in those six minutes to advance to Districts," commented Coach Clem-

ens. "It's difficult. Obviously, the farther you advance in your bracket, the tougher it is going to be. At Districts, you are going to see the very best of each area from around 60 high schools, most kids will only have a handful of losses and our kids need to be prepared both physically and mentally for that challenge," stated Coach Stabler.

'We told the boys, you just need to give yourselves an opportunity. Anything can happen at Districts, but you have to be there to have a chance," quipped Clemens. "I have seen kids come out of Sectionals in fourth place and make it out to the Schott," said Stabler. "Six of our wrestlers are now a mere 18 minutes away from being able to wrestle where every wrestler dreams of. They have spent countless hours preparing for these 18 minutes and now six Wayne Trace wrestlers have a chance," stated Clemens. The Raider wrestlers will head to Kettering Fairmont on Friday, February 22nd to begin competition at 3:00 p.m. The Raider wrestling family would like to wish them good luck at Districts. Also, Wayne Trace wrestling would like to wish all Paulding county wrestlers and GMC conference wrestlers good luck as the remainder of the county and conference travel to Bowling Green for their District tournament.



TREE SELECTION

If you are thinking of planting a tree or shrub in and around your home site, now is a good time to begin planning and ordering your trees. Choosing a variety with the characteristics that will provide the greatest satisfaction in a given situation requires careful consideration.

Most homeowners make the mistake of deciding what kind of tree they want and then try to fit it into their landscape. A more positive approach is to decide where a tree is needed and what that tree should do in the landscape. Understanding the types of benefits that you want to get from your project: wildlife habitat, snow/ wind control, recreation, or aesthetics can make a big difference in choosing which tree(s) you should plant. After the desired type of tree has been determined, then it is much easier to select a species to fulfill these requirements.

Once you know what type of tree you are going to buy, you must decide if you intend to buy a bare-root, machineballed, balled-in-burlapped, or containerized plant. How you treat the tree or shrub at ery plants. This type of tree is dug when dormant with no soil on the roots. The roots must be protected from drying out and from mechanical damage. Plant them as soon as possible while the trees are dormant.

Machine-balled trees are dug as bare-root and then the roots are packed in sphagnum peat moss or wood shavings and wrapped in plastic. Handle them carefully to avoid breaking roots. These, too, should be planted while they are still dormant.

Balled-in-burlapped trees are dug from a production field with an undisturbed ball of soil around the roots. The root ball is wrapped in burlap that is tied with twine or wire and pinned with nails. They may place the ball in a wire framework or basket.

Containerized plants are sold in pots. These plants may have grown in the container for a year or more; may have been dug bare-root and planted in the pot earlier that year; or may have been fieldgrown, dug with a soil ball, and potted. Both the balledin-burlapped and containerized plants usually cost more than bare root plants. However, since you move soil with the roots, the plants are more likely to survive.

The Paulding County Soil and Water Conservation District currently have tree seedling and nature products. The trees are bare-root seedlings. For additional information contact the SWCD office at 419-399-4771 or visiting their office located in the Extension Building located on the fairgrounds.

SECRETARY OF STATE HUSTED RELEASES NEW BUSINESS FILING FIGURES FOR JANUARY 2013

Secretary of State Jon Husted announced that 8,060 new entities filed to do business in Ohio in January 2013. These numbers are up compared to January 2012, in which 6,940 new entities filed with the Secretary of State.

Though the most visible role of the Secretary of State is that of chief elections officer, the office is also the first stop for individuals or companies who want to file and start a business in Ohio. While recognizing these numbers can't provide a complete picture of Ohio's jobs climate, they are an important indicator of economic activity that Secretary Husted hopes will add to the discussion of how to improve the state's overall climate for business.
