Terry was a member of the Christ Lutheran Church in Woodburn, Indiana; the American Legion Woodburn; VFW in New Haven; and the Wire Association International.


Terry served his country during the Viet Nam War, 1968 & 1969 in the United States Air Force.

### **VOTING IS EASY IN OHIO**

#### Guest Column by: Ohio Secretary of State Jon Husted

To all Ohio voters: There has been a lot of discussion about recent changes in the voting laws. Some of that discussion has informed and some of it has misled. As the chief elections official in our state I want you to have the facts about how easy it is to vote in Ohio. Please use it to guide your many choices in casting a ballot in General Election this November.

Option 1 – Vote by Mail Around Labor Day, my office will be sending all registered voters an application to vote by mail. Complete it, return it in the envelope provided and your ballot will be mailed to you starting 28 days before the election. Then, when it is most convenient for you and from the comfort of your own home, you can fill out your ballot.

Many will choose to mail it back in the security envelope provided, never having to leave home to vote. Still others will choose to drop it off at the board of elections – either way your ballot will be counted as part of the official tally on Election Day.

**Option 2 – Vote Early In** Person

Beginning on October 7, 2014, and over the course of four weeks, you can go to your local board of elections during regular business hours to cast your ballot in person. To accommodate voters who cannot go during the week, your board of elections will also be open for voting from 8 am to 4 pm on the two Saturdays before the Election. This bipartisan voting schedule was recommended by local Republican and Democratic elections officials and will be the same in each of the 88 Ohio counties, ensuring all voters have equal access to the polls no matter where they live.

**Option 3 – Election Day** And let's not forget Election Day itself, when polls close to your nome will be open from 6:30 a.m. until 7:30 p.m.

Ohio is the most important swing state in the nation and as Secretary of State, I will continue to work to build the best system of elections in the nation where it will continue to be easy to vote and hard to cheat.

### THE PAULDING COUNTY **BOARD OF ELECTIONS: APRIL 7th IS VOTER REGIS-**TRATION DEADLINE

All people who are not registered to vote and wish to vote in the upcoming Primary Election on Tuesday, May 6th, must register by Monday, April 7th, at the Board of Elections; (or, you may register to vote at an office of any Deputy Registrar of the Ohio Bureau of Motor Vehicles; public libraries; public high schools or vocational schools; County Treasurer's Office; Office of Secretary of State or any of the 88 county Boards of Elections). Normal office hours for the Paulding County Board of Elections office are Monday through Friday 8:00 a.m. to 12:00 Noon and 1:00 to 4:00 p.m. The office will be open until 9:00 p.m. on Monday, April 7th, voter registration deadline.

Have you moved or changed your name since the last time you voted? If so, you should notify the Board of Elections by Monday, April 7th. Persons not certain of their registration validity may contact the Board of Elections office at 419-399-8230, or write, email, or stop in the office at 105 East Perry Street in Paulding. You may review your voter information on our website at http://electionsonthe. net/oh/Paulding or searching "Paulding County Ohio Board of Elections." You may also change your name or address online by www. MyOhioVote.com.

Should you wish to register at the Paulding County Bureau of Motor Vehicles which is located at 831 North Williams Street, Paulding, the office hours are Monday 8:00 a.m. to 6:30 p.m.; Tuesday through Friday 8:00 a.m. to 5:00 p.m.; and Saturday 8:00 a.m. to 12:00 Noon.



With absentee voting starting 28 days before the election, Ohio remains above the national average for access to voting. Many of our surrounding states, including Michigan, Kentucky, Pennsylvania and New York don't even provide an early voting option. In addition, with the exception of states that vote exclusively by mail, Ohio has been the only state to send absentee ballot applications to all voters ahead of the election. These steps meant that Ohioans did not experience long lines at the polls that other states did in 2012 when approximately one in three Ohio voters chose to

• You will be at least 18 years old on or before November 6th.

• You will be a resident of Ohio for at least 30 days immediately before the election in which you want to vote.

• You are not incarcerated (in prison) for a felony conviction under the laws of this state, another state or the United States.

• You have not been declared incompetent for voting purposes by a probate court.

• You have not been permanently disfranchised for violations of the election laws.

You are eligible to vote in elections conducted in your voting precinct more than 30 consecutive days after

V 38 – not ceremonially washed; not commanded by law but added in the tradition of men. You put tradition before God's Holy Word; it will cause you to lose your soul.



One of the great takeaways of Jesus coming in flesh and then subjecting himself to all the fears of humanity is Jesus identifies with us in our suffering and shame. For example, Christian doctor and author John White writes...

John White tells the story of his days as a medical student. For one of his classes, he missed a practicum about venereal disease and had to make it up at the clinic. When he arrived at the clinic he ended up in a line with a bunch of patients who had actually contracted a venereal disease. White barged up to the front and told the head nurse, "I need to see the doctor." "That's what everybody says," snorted the nurse, "now get in line." "But I'm a medical student." "Big deal," said the nurse, "You got it the same way as everybody else; now you can stand in line like everybody else. John White writes: In the end I managed to explain to her why I was there, but I can still feel the sense of shame that made me balk at standing in line with the other men who had a venereal disease. Yet Jesus shunned shame as he [went to the cross]. And the moral gulf that separated him from us was far greater than that separating me from the men at the clinic... But he crossed the gulf, joining our ranks, embraced us and still remained pure. He identified with those he came to save. He became like us.

Regarding Jesus practice to identify with humanity, the writer to Hebrews writes... Hebrews 4:15 (NIV), "For we do not have a high priest who is unable to sympathize with our weaknesses, but we have one who has been tempted in every way, just as we are—yet was without sin."

In-Person Absentee Voting: In-person absentee voting begins April 1, 2014, or 35 days before the election. To ensure all Ohio voters have the same amount of time to vote in person early, Secretary Husted issued Directive 2014-06, establishing uniform hours statewide so all voters have fair and equal access to the ballot during 2014 elections.

Register to Vote/Update <u>Your Address:</u>

The deadline to register to vote for the May 6 Primary Election is April 7, 2014 (30 days prior to the election). THE NORTH SIDE OF DAGGETT STREET IN THE 1930'S

We start at the very east end of Daggett Street on the north side. As I remember a number of renters lived there. The first I remember is Amos Bickhard, and they had two boys. The next house was a Mr. Miller, and the next house was the home of Guy Sackryder. The next house on the corner was people named Gatton and Cristo. The next was the home of Dewy Byers. Then came the Jennings Grueter family's home. Then was the home of Bert Major, Sr., and after that, the home of Griswald and Coles. The last house on that side of the street was John Franklin, Sr. That takes us to the Wentworth Road. See ya!

They are beginning to tile extensively and many tile factories are scattered over the county; the tiles varying from twoand-a-half to ten inches.

# **INVESTS IN JOB CREATION**

Senator Cliff Hite (R-Findlav) announced the introduction of Ohio's 2014 Capital Budget, which provides local investment dollars to support individual communities' construction priorities. The bill funds needed improvements to public facilities across the state including schools, colleges and universities, and parks. The legislature generally approves a capital budget every two years in order to fund pressing construction and maintenance projects around the state. The plan also serves as an important mechanism in creating Ohio jobs and moving the state's economy forward. "These funds will help spruce up our local attractions, improve infrastructure, and add capacity at our colleges," said Hite. "I'm elated that our area received so much positive attention in this year's capital budget." Once fully enacted, Ohio's proposed new public construction budget will create approximately 31,000 new jobs over the next several years from the \$2.386 billion it injects into needed repairs,

### LATTA PROVISION INCLUD-ED IN STELA REAUTHORI-ZATION BILL

The House Energy and Commerce Committee's Communications and Technology Subcommittee held a hearing to discuss the reauthorization of the Satellite Television Extension and Localism Act (STELA), legislation providing satellite subscribers access to broadcast television on March 12, 2014. Last week, the Committee released a discussion draft of legislation to reauthorize STELA, which included language from H.R. 3196, a bill sponsored by Congressman Bob Latta (R-Bowling Green), Vice-Chairman of the Subcommittee.

"I am pleased that the Committee has brought forth legislation to reauthorize STELA and incorporated language from my bill, H.R. 3196, that eliminates the 'integration ban' regulation on leased set-top boxes," said Latta. "The integration ban has forced consumers to pay higher prices for leased boxes and imposed additional energy consumption costs, resulting in more than \$1 billion in costs for consumers and businesses and impeding investment and innovation. At a time when technological advancements are occurring at an unprecedented pace, Congress must empower market participants to flexibly and efficiently meet the ever-evolving demands of the consumer. Elimination of the integration ban is a step toward fulfilling that congressional responsibility. I want to thank Subcommittee Chairman Walden and Committee Chairman Upton for including this provision in the STELA reauthorization draft, and I look forward to working with members of the Committee to ensure this legislation becomes law."

H.R. 3196 has received bi-partisan support with Congressman Gene Green (D-TX), Congressman John Shimkus (R-IL), Congressman John Dingell (D-MI), Congressman John Barrow (D-GA), Congressman Ed Whitfield (R-KY), Congressman Jim Matheson (D-UT) and Congresswoman Marsha Blackburn (R-TN) as

The STELA reauthorization draft extends the provisions in the Communications Act that allow satellite providers to offer these distant signals for five years. It also eliminates the sweeps week prohibition on signal changes. Finally, it includes Congressman Latta's provision from H.R. 3196, eliminating the section of the Federal Communications Commission's (FCC) rules that require CableCARDs in leased set-top boxes. This provision will give cable companies more set-top box flexibility, allowing the FCC





### NEW LAKE ERIE BIRD-ING TRAIL GUIDEBOOK COLLECTS BEST BIRDING LOCATIONS IN OHIO

The Ohio Department of Natural Resources (ODNR) Division of Wildlife and Ohio Sea Grant at Ohio State University have released the Lake Erie Birding Trail Guidebook, a 232-page compilation of 88 popular and less well-known birding locations all along Ohio's Lake Erie coast, from Ashtabula to Toledo. In addition to locations of parks and other birding spots, the book lists commonly sighted species and noteworthy rarities, park amenities, and online resources for visitors.

'Lake Erie and its environs are the premier birding destination in Ohio, and in the entire Great Lakes region," says Jim McCormac of ODNR. "Nearly 400 species have been found along the Ohio shoreline, and migration periods see enormous numbers of songbirds and waterbirds. Many Lake Erie birders are from out-of-state or elsewhere in Ohio, and the Lake Erie Birding Trail helps visitors navigate the best hotspots."

Birding along the Lake Erie coast contributes \$30 million to the local economy every year, and Ohio's 1.6 million self-identified birders alone spend over three quarters of a billion dollars annually on their pursuits. The Lake Erie Birding Trail Guidebook not only makes it easier for them to spot both common and rare birds when visiting parks and preserves in northern Ohio, but it also gives birders the opportunity to point out their economic contribution to local businesses with a set of "birder calling cards" that link owners to more information.



BULENCE... AS A PASSEN-GER AND AN INVESTOR

If you're like many travelers, you get a little nervous when your airplane goes through some turbulence. And if you're like a lot of investors, you may get somewhat jumpy when the financial markets are volatile. Yet flight turbulence probably isn't as scary as it seems, and the same may be true for market volatility — if you know how to respond.

Let's look at some positive responses to market movements:

• Don't overreact to turbulence. Turbulence happens on most flights, but passengers are well aware that they can't "bail out" at 30,000 feet, so they generally don't panic. As an investor, you also need to avoid panicky behavior — by not taking a "time out" from investing. Over a period of decades, if you were to miss just a handful of the market's best-performing days, your returns could be dramatically reduced. And the best days often follow some of the worst. So if you're not invested in the market, you could miss out on the beginning of a new rally, which is typically when the biggest gains occur.

 Balance your "cargo." The ground crew properly positions an airplane's cargo to maintain the plane's center of gravity and reduce the effects of turbulence. When you invest, you also need to achieve balance by owning a variety of vehicles, including stocks, bonds, government securities

and certificates of deposit. You'll want your investment mix to reflect your risk tolerance, goals and time horizon. While this type of diversification can't guarantee profits or protect against loss, it can reduce the effects of "turbulence" - that is, market volatility - on your portfolio. Over time, your "cargo" (your investments) may shift, becoming too heavy in stocks or bonds relative to your objectives. Consequently, you'll need to periodically rebalance your portfolio to ensure

tation method" with your goals. If you are flying from New York to Los Angeles, you may experience delays or some changes in the flight plan — but your goal is still to reach Los Angeles as quickly and efficiently as possible. Consequently, you wouldn't scrap the idea of flying and head to the West Coast on foot. When you invest, you will also encounter events, such as market downturns, that you feel may be slowing you down in your progress toward your long-term objectives, such as a comfortable retirement. But if your objectives haven't changed, neither should your "transportation method" of reaching them. In other words, don't abandon your long-term strategy in favor of quick fixes, such as chasing after "hot" stocks that may not be suitable for your needs.

• Maintain perspective on your "flight path." When you've flown, you've probably observed (perhaps with some envy) some of your fellow passengers sleeping through periods of turbulence. In the investment world, these types of people are the ideal long-term investors - they know that turbulence, in the form of market fluctuations, is normal, because they've experienced it many times before. ### **PAULDING COUNTY HIS-TORY: NATURAL GAS & OIL** IN 1887

**By: Caroline Zimmerman** The theories as to the origin of petroleum and natural gas can be divided into two main groups: (1) those which are made chemically, and those which are the result of that matter acting on mineral matter, and (2) matter that acts on mineral matter as the result of a partial decomposition of vegetables of animal substances that have been stored in the earth or stone. Either of the above theories is convincing evidence that there could be abundant supplies of both gas and oil found beneath the surface of Paulding County. This was thought MORE than a century ago. The first well drilled in the county was at Paulding, by the Paulding Oil & Gas Co. in the summer of 1887. Both gas and oil was obtained, but not in enough quantities to make it a paying position for the company. Regarding the well, the

Paulding "Gazette" of July 28, 1887, said: "The suspense is over. It has been demonstrated to a certainty that gas and oil underlie the city of Paulding. At three o'clock Tuesday afternoon the long listened for cry of 'Trenton rock is Struck', was heard. It was reached at the depth of 1,473 feet and four inches. The drillers penetrated it four feet and rested for the night. On Wednesday morning work was resumed and at two o'clock in the afternoon at the depth of 16 feet in the Trenton rock and 1,489 feet and four inches from the surface, gas was discovered.'

The news of the new wells traveled quickly and within minutes hundreds of our citizens rushed to the scene of the wells. The value of the corner lots went up 100% in a few hours. In the evening a jet was attached to the mouth of the well and the gas carried about 20 feet up the derrick, where it was set on fire. The flames leaped upward to the distance of about 10 feet and shed a wild, weird light around upon the scenery in the vicinity of the well.

Hundreds of people visited the grand lighting up of the well. "Down the Gas Well" was the prevailing cry of the evening. All ages of people were caught up with the excitement and enthusiasm. All types of personalities were there from schoolmarms to poets.

Sometime later - "Oil is found to filling up in the well, already to the depth of 90 feet, and it is not known which will be the predominating element – gas or oil. The drillers are closely watching the well and further developments are hourly expected. It is not yet known whether it will be necessary to 'shoot' it or not. A meeting of the stockholders will be held this afternoon."

In accordance with the decision of the stockholders, explosives were put in the well a few days after, hoping to accelerate the flow of gas, but instead of so doing, it immediately began filling with salt (silt) water. Attempts were made to remove this, but of no avail; the well was rendered useless and, therefore, abandoned.

Since the above attempt, other wells have been drilled at Melrose, Payne and Antwerp, in all of which some oil and gas (mostly oil) has been obtained. In all of these, Trenton rock has been struck at a depth of 1,400 and 1,500 feet. What is known as the Lamb well, six miles west of Paulding, has yielded the best results of any yet in the county. It was drilled in the spring of 1891 and has a reported capacity of 220 barrels of oil per day. The Home Oil and Gas Company, of Antwerp, and a company at Payne, are yet at work sinking wells, and from present developments there is but little doubt, if any, but that Paulding County will soon occupy a prominent position in the oil and gas field of Ohio.'

### **BALLOT BOARD CERTIFIES VOTER RIGHTS AMEND-MENT AS SINGLE ISSUE**

The Ohio Ballot Board, chaired by Secretary of State Jon Husted, certified that a proposed constitutional amendment concerning voter rights consists of one issue.

Petitioners will now need to collect 385,247 signatures, which is equal to 10 percent of the total vote cast for governor in 2010. As part of the total number of signatures needed to place the measure on the ballot, petitioners must also have collected signatures from at least 44 of Ohio's 88 counties, and within each of those counties, collect enough signatures equal to five percent of the total vote cast for governor in the most recent gubernatorial election, 2010.

Other members of the Ballot Board include: State Senator Bill Coley; State Senator Nina Turner; Mark Griffin; and William N. Morgan. Ballot Board meetings are open to the public.



### VANTAGE BOARD HEARS UPDATES

The Vantage Board of Education held its regular meeting on Thursday, March 6, 2014. The minutes of the February 6, 2014 regular meeting were approved, as well as financial statements for January, 2014. The Board approved a resolution to amend the appropriations and revenues for the FY14 and a resolution to accept the amounts and rates as determined by the budget commission and authorize the necessary tax levies and certify them to the county auditor as follows: General Fund, 3.10 Mills; Permanent Improvement, .70 Mills; and Bond Retirement, 1.05 Mills. The report of the Treasurer included the approval of the cash reconcili-ation worksheet and the investment report.

Superintendent Staci Kaufman provided the Board with an update of her recent visit with Congressman Bob Latta in Washington, D.C., where she discussed points for consideration in the Perkins Act reauthorization and Work-force Investment Act reauthorization language. Local Vantage initiatives and success stories were shared, reinforcing career technical education's value in Ohio. She also commended several Vantage staff members for their outstanding work with a Vantage student recently. The efforts of Counselor Jim Fisher, Intervention Specialist Ashley Cline, Instructors Shelly Knippen, Mike Miller, and Mat-thew Miller, and supervisors Ted Verhoff and Mike Knott were noted. Adult Education Director Pete Prichard reported that the new accreditation process should be completed by August, 2014 and a partnership with Northwest State Community College, Rhodes State, and the University of To-ledo on a grant involving the Industrial Automation Program. He updated the Board on programs maintaining 100% retention and Trade and Industrial students already earning college credit that can be applied to an Associate of Technical Studies Degree. Plans are in place to increase truck driv-ing classes starting in March and the wind-turbine and pipe welding programs have a planned spring class start. High School Director Ben Winans reported on the successful Open House, results of the Regional BPA, SkillsUSA and FCCLA competitions and state qualifiers, the new online appli-cation being used by Student Services and preliminary enrollment numbers, 2nd quarter Blue Chip-pers, and program activities.





General Fund Receipts in January, 2014, were up from December, 2013, by \$127,250.08; and was up from January, 2013, by \$78,429.98. Ms. Fickel also reported dog tag sales are down by 16% from last year. She commented the Homestead Exemption applications are due June 2, 2014, adding there are new guidelines to follow. Ms. Fickel discussed the real estate fund and how the valuation has impacted it. Gene Olwin – Mr. Olwin met briefly with the Commissioners with questions regarding the distribution of the PILOT for the wind farms. The Commissioners were able to answer his questions to his satisfaction and provided him with a breakdown of the PILOT for the wind farms. The Commissioners also thanked Mr. Olwin for his interest. Kris Gerken and Kim Oliver, Hun-tington Insurance – Mr. Gerken and Ms. Oliver discussed the upcoming renewal (June 1, 2014) of the County Health Insurwill make an offer by March 31. Hunting-ton will be going out for bids from other carriers on the County's behalf.
