A LOCAL STORY OF CYSTIC FIBROSIS

Cheyenne Maynard, age 5, of Antwerp Ohio is still too young to understand what Cystic Fibrosis is, and what it does to her body. All she knows is having CF means 35+ hours of breathing treatments a month, along with a vest that shakes her and knocks her mucus loose. It also means, hundreds of enzymes (pills to help digest her food properly, hundreds of vitamins, and far too many hours spent at doctor appoint-

ALLEN COUNTY PROPERTY TAX BILLS ARE DUE MON-DAY, MAY 12, 2014

"Tax due day is fast approaching" says Chief Deputy Treasurer William Royce. The due date is May 12, 2014. Payments must be in the Treasurer's office or postmarked by May 12, 2014 to avoid penalty.

Several payment methods are available including the brand new self-pay kiosk which is located just outside the Treasurer's office.

"Fun and paying taxes are not two concepts we usually put together," says Royce "But I've actually had a taxpayer tell me it is fun using the kiosk!"

Another payment option that is growing in popularity is the Single Electronic Payment option that can be accessed on the Treasurer's website which is www.allencountytreasurer.us.

"The Single Electronic Pay option is free, secure and fast." says Royce.

No setup or log in is reauired. Simply enter your bill duplicate number found at the top of your tax bill, fill in the remaining fields and

ments). At the doctor's, she get throat swabs (a long Qtip that scrapes the back of her throat until she gags/ coughs), PFT tests (test to measure the capacity of her lungs) chest x-rays and blood drawings.

Cystic fibrosis is a lifethreatening (inherited) lung disease. The body of a CF-er creates thick, sticky mucus causing problems in both the lungs and digestive system. CF is not a very common disease, an estimated 30,000 children and adults in the United States have CF. Currently, the median predicted age of survival for people with CF is in the early 40s. Everyone who has CF is born with it-some find out right away, and others don't find out for years, sometimes even 20+ years. Thanks to the newborn screening test, now everyone who has CF is diagnosed at birth (Chevenne was two weeks old when her parents found out) and they can start getting the proper care needed to live a healthy life, with as little damage to the lungs as possible. They started putting the CF gene into the newborn testing in 2008.

The most common symptoms of CF are:

Very salty-tasting skinPersistent coughing, at

times with phlegm • Frequent lung infections



Wheezing or shortness of breathPoor growth or poor

weight gain in spite of a good appetite BUT having CF has

taught this amazing girl how to be strong-and that her family is very passionate in having her succeed in everything that she does. One day, Cheyenne said she wanted to raise some money for her disease, so her Grandpa went to GFS, and bought her a candy fundraiser box. Cheyenne was so proud to knock on people's door, and ask if they would like to buy candy so she can find a cure for CF! Within a week, Cheyenne had sold four boxes of candy all by herself! She raised \$210 for her walk! Her family is so proud of her!

Every year there is a walk in Fort Wayne for people battling Cystic Fibrosis. Rain or shine, hundreds of people gather to support everyone with CF. There is an old saying, "Sometimes you need to take a minute and walk a mile in some-one else's shoes." At these walks, you get the honor to walk amongst the people who battle CF, and you do get a chance to walk in their shoes for a minute. You look around and see all the faces of the children, and even adults and you realize what fear is. You see the faces of people who have lost loved ones to CF and you see hundreds of faces filled with HOPE! In these walks nothing else matters, but the people with CF. You see them proudly taking steps... steps closer to a cure. And that is what these walks are all about. All it takes is a few steps and you can make a difference in these people's lives. Cystic Fibrosis Foundation is not a government funded charity, meaning any hopes of finding a cure is solely based on individuals making donations out of the kindness of their hearts.

The Allen County Public Library has created the ACPL Family App, available for free download to iOS devices: https://itunes.apple. com/us/app/acpl-family/ id840890789?mt=8

The ACPL Family App will be a tool that will bring the library outside of its physical walls and meet families where they are. Rather than simply being a form of entertainment, the ACPL Family App is meant to be an intentional use of technology for effective adult/child interaction, promoting learning and development.

Highlights of the app are:

• Parents and caregivers may sign up for push notifications with early literacy tips for parents of babies, toddlers, and preschoolers, and fun facts to share with schoolage children.

• A reading timer and log are included to help teachers, caregivers and families keep track of time spent reading. This feature has the ability to log multiple users.

• Librarian-created booklists provide users with titles to share with children on topics ranging from difficult family issues to fun stories for preschoolers. These lists are linked to location information and as well as hold capabilities to make the titles as accessible as possible.

The Paulding County Local Emergency Planning Committee will hold its Hazardous Material Exercise on Saturday, June 21, 2014. Mercer Landmark (Latty Facility) has agreed to host the exercise. Exercises are conducted to review our emergency response capabilities and to train for potential hazardous material releases. Your participation in this full scale exercise is critical to the success of the event.

The Paulding County LEPC Full Scale exercise will begin at 9:30 a.m. The exercise will begin at the Mercer Landmark (Latty facility) located on the east side of Latty on US 127. The timeline will begin when a call is made from the facility management that a strong tornado has hit the facility and that a number of Anhydrous Ammonia nurse tanks have been ruptured, there appears to be a valve leaking on the 30,000 gallon storage tank, and numerous Anhydrous Ammonia railcars have rolled also. There were also a couple farmers hauling chemicals at the site when the tornado hit and there are a number of employees injured on site.

9-1-1 Dispatch will be responsible for paging Scott Department which has jurisdiction of the area. Mutual aid will be requested from Payne and Grover Hill Fire Departments. EMA will already be active as the agency was tracking the storms as they moved through the county. Weather requests from the fire department will go to EMA with conditions at the time of the incident consisting of heavy rain just ending. Winds have switched around to the East as the cold front moved through with winds gusting to 25mph carrying the vapor plume to the West over the village of Laity with a population of approximately 75 affected.

ICS must assess the situation, determine how personnel can safely approach the scene and remove the victims for transport to the hospital. Also, ISC must also determine whether occupants of the homes in the area should shelter in place or evacuate.

EOC shall give support on weather decisions, evacuation decisions, and input on the product involved.

Victims shall be transported to Paulding County Hospital with the Emergency Room testing their hatmat protocol and treatment of inhalation/bum victims.

The exercise should conclude around noon.

Registration will begin at 9:00 a.m. at the Paulding County Sheriff's Office. Lunch will be provided at the Latty Facility followed by the after action evaluation.

LATTA VOTES TO PROTECT AMERICAN WORKFORCE

Congressman Bob Latta (R-OH) released the following statement in support of H.R. 2575, the Save American Workers (SAW) Act, which the House passed. The legislation would reinstate the definition of full-time employment to 40 hours, ultimately protecting jobs and ensuring that the American workforce is not pushed to part-time as employers determine how to pay for the significant cost increases of providing healthcare coverage under Obamacare.

"Today, the House took an important step to ensuring hardworking Americans do not lose hours or their jobs as a result of the President's signature law," said Latta. "The 30-hour rule included in Obamacare forces employers to fundamentally alter their employee's work schedule by cutting hours and shifting a larger proportion of their workforce to part-time. It could also draw workers away from certain industries, like the food service industry, where workers rely on the flexibility to build a work schedule that meets their needs - whether taking on extra shifts or working around a class schedule. By aligning the definition of full-time employment to the traditional industry standard, the House has taken action to reform the President's health care law and mitigate obstacles to American workers and businesses, and I urge the Senate to do the same."

Under Obamacare, a 30hour workweek is considered full-time, triggering the employer mandate. This rule puts 2.6 million lower income workers, those with a median income of less than \$30,000, at risk of losing their jobs or hours. One-half of small businesses have stated that they plan to either cut hours to reduce full-time employees or replace full-time employees with part-time employees to avoid these significant cost increases. Industries that employ lower skill workers or a large number of entry-level positions will also be hardest hit under Obamacare's 30-hour rule, as 89 percent of impacted workers do not have a college degree.



was very survivable if caught early-which could only be known through surgery.

I sat next to him in the waiting room before the operation. It was odd seeing him in a hospital not striding with confidence into a patient's room or giving orders at a nurses' station like a battleship commander—something I had witnessed many times as a boy accompanying him on Saturday morning rounds. Instead he sat in silence with his shoulders rolled and hands shaking.

"You know doctors make the worst patients," he said. "Why?" I asked.

"Because we know too

much. We know the thousands of things that can go wrong that most people never imagine."

Thankfully his cancer was caught early and he survived, but something important happened when the physician became the patient, when the expert became the examined. He gained something that can't be taught in medical school or acquired from years of practicing medicine. Cancer gave him empathy. I saw his compassion for his patients grow following his own health crisis. Doctors may make the worst patients, but patients make the best doctors.

Regarding the work of patience in our lives the scriptures say... Galatians 5:22-23 (NIV), "But the fruit of the Spirit is love, joy, peace, patience, kindness, goodness, faithfulness, gentleness and self-control. Against such things there is no law."



NEW FLOOD APP BRINGS AMERICAN RED CROSS SAFETY INFORMATION TO MOBILE DEVICES

The American Red Cross announced its new Flood App to help save lives and reduce losses from floods and flash floods.

This free app gives iPhone, iPad and Android smart phone users instant access to local and real-time information, so they know what to do before, during and after a flood. The content is available in English and Spanish based on the user's language settings on their mobile device. The app includes locationbased, audible NOAA flood and flash flood watches and warnings – even if the app is closed.

"Floods are the most common natural disaster in the United States and affects hundreds of people here in the greater Toledo area every year," said Amanda Aldrich, regional communications specialist for the American Red Cross of Northwest Ohio. "People can use the Red Cross Flood app to create emergency plans so all household members know what to do if flooding threatens their home. In a flash flooding situation, the audible alerts in the app can truly save lives - even when users are away from a radio or TV."

Other features of the app include:

• One-touch "I'm safe" messaging that allows users to send a message letting family and friends know that they are out of harm's way;

• Preloaded content that gives users instant access to critical action steps, even without mobile connectivity;

• Toolkit with flashlight, strobe light and audible alarm to let others know where you are;

· Locations of open Red Cross shelters;

• Real-time recovery resources for returning home and cleaning up; and

• Badges users can earn through interactive quizzes and share on social networks.

The new Red Cross Flood App is being released during National Flood Safety Awareness Week, which runs from March 16-22.

"National Flood Safety Awareness Week is the perfect time to download the app and to start preparing," added Aldrich. "Even though there is still snow on the ground, warmer weather and sunshine is right around the corner. The arrival of spring means rain and the inevitable flooding we see here every year."

The Flood App, along with the others, can be found in the Apple App Store and the Google Play Store for Android by searching for American Red Cross or by going to redcross.org/mobileapps.

Apps can help prepare people for disasters, but they are not a substitute for training. Red Cross First Aid and CPR/AED training empowers people to know how to respond to emergencies in case advanced medical help is delayed. People can visit redcross.org/takeaclass for course information and to register.





start a business in Ohio and as a result, more people are taking advantage of it," Secretary Husted said. "We have effectively cut the red tape and rolled out the red carpet, which results in more companies choosing Ohio as the place to do business and create jobs."

Ín October 2013, as part of an ongoing effort to improve and modernize the way the Secretary of State's office handles business, Secretary Husted launched Ohio Business Central. Enabling business owners to file online is a benefit to customers and taxpayers alike, reducing paper and streamlining the process. That means customer service is up and processing times are down from as many as four days to one and half days on average.

Forms currently available for online filing include those for forming a limited liability company in Ohio, renewals for trade or fictitious names, biennial reports for professional associations or limited liability partnerships, statements of continued existence for nonprofit corporations, reinstatement and appointment of agents, as well as certificates of limited partnership. Collectively, these forms represent approximately half of all filings received by the Secretary of State's office in 2012. Based on the success of Ohio Business Central so far, Secretary Husted plans to roll out additional opportunities to start a business online by the end of the year.

"Business filings can now be done 24 hours a day, seven days a week in Ohio - it couldn't be more convenient," Secretary Husted said. "We are hearing from customers who instead of filing in states like Delaware, say they are now choosing Ohio where it's not only faster than before, but less costly."

Secretary Husted noted that with lower taxes and an overall better business climate, more companies are choosing the Buckeye State. Ohio saw a record number of new business filings in 2012 with 88,068, and again in 2013 when 89,735 companies were filed in Ohio. In the first few months of 2014, new business filings are trending toward another record year.

USDA PREPARES TO AC-CEPT MAL & LDP RE-QUESTS; SETS 2014 MAL LOAN RATES

The U.S. Department of Agriculture's (USDA) Farm Service Agency (FSA) will begin accepting requests for marketing assistance loans (MALs) and loan deficiency payments (LDPs) for eligible 2014 commodities. Notice of the authorization is published in today's Federal Register.

MALs and LDPs for the 2014 crop year become available to eligible producers beginning with harvest/ shearing season and extending through a specific commodity's final loan availability date.

Sugar commodity loans for 2014 crop will be available to sugar processors beginning October 1, 2014.

MALs and LDPs provide financing and marketing assistance for wheat, feed grains, soybeans, and other oilseeds, pulse crops, wool, mohair and honey. MALs provide producers interim financing after harvest to help them meet cash flow needs without having to sell their commodities when market prices are typically at harvest-time lows. Allowing farmers to store their products at harvest facilitates a more orderly marketing of commodities throughout the year. A producer who is eligible to obtain a loan, but agrees to forgo the loan, may obtain an LDP if such a payment is available.

Marketing loan provisions and LDPs are not available for sugar.

The 2014 Farm Bill also establishes payment limitations per individual or entity not to exceed \$125,000 annually on certain commodities for the following program benefits: price loss coverage payments, agriculture risk coverage payments, marketing loan gains (MLGs) and LDPs. These payment limitations do not apply to MAL loan disbursements. Please consult your local FSA office for details.

Adjusted Gross Income (AGI) provisions were modified by the 2014 Farm Bill, which states that a producer whose total applicable threeyear average AGI exceeds \$900,000 is not eligible to receive an MLG or LDP.



FOR THE LOVE OF DOGS: A RUNNER'S PLEA

The Nurturing Well by: Jill Starbuck

I love dogs. In fact, I'm the proud owner of two beautiful eight-year-old dogs, a Siberian Husky and a Golden Retriever. They make up part of my family. Along with my dogs, I also love to run. However, more often than not, dogs and running do not mix.

There is nothing like a dog charging and growling at a runner to ruin a great pace or a leisurely jog. Unfortunately, this happens frequently. Whether in the country or in town, dogs will chase runners. The friendliest of dogs even leave their own yards to chase runners. Whether out of optimism or confidence, many dog owners swear their dogs will not hurt us. Yet, these are the same dogs that corner us, growl at us, and have even bitten us. Dog owners must understand that a dog may act differently around runners, especially when the dog owners are not present. Runners catch dogs off guard; therefore, the dogs automatically become defensive. They simply respond the way dogs are meant to respond. However, their natural instinct can cause serious issues.

If you're a dog owner, please review the following tips on how to protect local runners and children (because they run too!):

1. Never assume your dog won't bite. Just because your dog has never bitten anyone doesn't mean it won't. It's best to assume your dog will bite. Almost all of the dogs that have threatened us on

our runs have no history of violence. The dog owners are genuinely surprised.

2. Follow leash rules. If your town has leash rules. please adhere to them. Many times owners will let their dogs out for a few minutes to do their business. But those few minutes are when we've come across these dogs. Try letting them out the back door instead.

3. Keep an eye on your dog. Almost every time we've been cornered or bitten by dogs, the dog owners are nowhere to be found. Or they are completely oblivious. Typically they are in their house, but have no clue as to what is happening outside. This happens 9 out of 10 times.

4. Vaccinate routinely. In the event your dog bites a runner, chances of serious problems arising from the bite are lessened when a dog is updated with its shots. Approximately 4.5 million people are bitten by dogs each year, making dog bites the fifth biggest reason for emergency care visits. Of those dog bites, more than 50% result in infection.

5. Check leashes and chains for defects. We witnessed a dog come completely off its chain while on one of our runs because the cord it was chained to had become worn.

Avid runners will run at any time, even in the early morning and late evening hours. They also run in rain, high winds, and snow. So, please be aware that a runner could be coming around the corner at any time. As the weather gets nicer, more runners and children will be outdoors. Please help protect them by following these tips.

There are some important steps to become more aware of motorcyclists:

• A motorcycle is a motor vehicle with all of the privileges of any vehicle on the roadway.

• Allow plenty of space in front of the vehicle you are driving and do not follow a motorcycle too closely.

LATTA JOINS HOUSE IN PASSING LEGISLATION TO **SUPPORT OUR NATION'S** VETERANS

Congressman Bob Latta (R-OH) released the following statement after joining his colleagues in the U.S. House of Representatives in support for passage of H.R. 4486, the 2015 Fiscal Year Military Construction and Veterans Affairs Appropriations Bill.

"Our veterans have made incredible sacrifices in service to our country, and it is our duty to ensure they are taken care of upon their return home," said Latta. "Today, the House passed legislation to ensure we can uphold our commitments to our veterans, ensuring they have quality medical care, access to job and training programs, and other benefits they have earned. It also addresses critical impediments to providing these services, including the unacceptable claims backlog, by modernizing current systems to best serve our nation's heroes." The legislation provides \$64.7 billion in discretionary funding for veterans' programs, \$1.5 billion more than appropriated last year. It also provides \$173 million to create a paperless claims processing system in an effort to end the disability claims processing backlog. Next, it requires the Department of Veteran's Affairs, the Department of Defense and the private sector to share medical data in a timely and accurate manner, so our veterans get the best medical care possible. The bill also provides for support systems and infrastructure to promote and preserve a high quality of life for our veterans and their families.

The post office in Sharpsburg, GA has an unfortunate twist on the U.S. Postal Service's unofficial motto—it's neither snow nor rain nor gloom of rear-end collision that stays these couriers from the swift completion of their appointed rounds. The postal rural carriers at the Sharpsburg post office have become easy targets for distracted drivers, following accidents this summer that have sent three people to the hospital and prompted one of their own to resign.

Anne Kerlin is a 19-year veteran and one of the six Sharpsburg carriers who has been involved in accidents over the past few years. She empathized with the most recent victims, including Jennifer Doolittle, who resigned last month. "I can understand why she quit," Kerlin said. "I was terrified after it happened to me. You're just waiting to



get hit again. We're just sitting ducks." Doolittle was rear-ended in her Honda Odyssey by a 17-year-old driving a Ford F-150 near East Coweta High School. The accident occurred near the end of the school day on Highway 154 as Doolittle was delivering mail to the last mailbox on her route. The impact spun her minivan around before it came to a stop in a ditch. The 35-year-old mother suffered head and neck trauma, minor cuts and bruising, and is undergoing physical therapy as part of her recovery. "I'm just thankful I didn't have my hand in the mailbox, because if I had, I wouldn't have an arm," she said. Doolittle quit the job last month. She said lingering anxiety over the June accident, ongoing physical limitations and dealing with the red tape involved with workers' compensation claims prompted her to resign. She had been a substitute carrier for about six years at the Sharpsburg and Senoia post offices. "That accident was enough to scare me," Doolittle said. "I hate that road. I hate to drive." Gina Powers was rear-ended last month by a welding company's commercial truck on state Highway 16. Her Honda CR-V traveled 34 feet and flipped over on its top before it came to a stop, according to the police report. Powers, 42, also suffered injuries, including a broken nose. She currently works limited hours and duties, answering the phone at the post office. The man who hit Powers was taken by helicopter ambulance to Atlanta Medical for his iniuries. His truck sideswiped a tree and then hit another tree head-on before it came to a

trees, according to a police report. Cynthia Olmstead, a supervisor at the post office, said the most disturbing similarities about the recent accidents is that both of the drivers at fault appeared to not have noticed the postal carriers were stopped before impact -- although their carriers' cars were clearly marked, emergency lights were flashing and they were on straight-aways, stretches of highway with unlimited visibility. "We want to make the public aware that we're out there. Both of those accidents were at no fault to our carriers," she said, adding that carriers diligently exercise safety precautions, including trying to get off the road whenever they can. She said some of the problems with the state routes in this eastern section of the county is that they are two lanes with no or limited shoulders or emergency lanes where the carriers can safely get their vehicles off the road. Even then, Dianne Lewis, a 20-year veteran and the post office's safety captain, is advising carriers that it's better to get pulled out of a ditch by a tow truck, than to get carted away by an ambulance. Carol Walls, a rural carrier, fears local motorists are becoming so hurried and distracted that they're not only endangering mail carriers, but also other service people out on the roads trying to do their jobs. "It's not just carriers, but it's meter readers, garbage men, school bus drivers and so on," she said. Olmstead said their concerns are only aggravated by one of growth's byproducts-more distracted drivers on the roads. "We find people are on their cell phones or text messaging, and when someone is hitting you in the rear end at 65 miles per hour, it's a concern," she said. Betsy Tomlinson, a substitute carrier who's driven all 15 of Sharpsburg's routes, described the trend and the increasing "near misses" more bluntly. "They're rude. The drivers are just rude," she said. She described impatient drivers who follow too closely, and then slam on their brakes at the last minute or "sling out" into oncoming traffic to pass the carriers instead of waiting until there are safer sections to pass. While postal carriers pull off the road when they're able, the problem with Hwys. 154 and 16 is that there aren't a lot of places where the carriers can pull over. "They'll get right up on our rear end," Tomlinson said. "I've had people behind me, follow me

cars, which range from large trucks to compacts, many of their vehicles have been converted for mail delivery. Steering wheels have been added to the passenger side of the vehicle, passenger seats have been removed and trays have been added to hold the mail. The conversion makes for quicker and easier access to the curbside mailboxes. The rural carriers' cars are clearly marked with official postal carrier signage, and they operate with emergency lights flashing while they are on the route. Some of the carriers, who don't opt for the full conversion, also "drive in the middle" to quicken and thereby reduce the length of their stops at the mail boxes. Driving in the middle involves straddling a makeshift seat over the car's center console while the left leg operates the gas and brake pedals and the left arm steers. The right leg is positioned on the floorboard of the passenger side for balance. Driving in the middle allows the carrier to use his right arm to reach the mailbox quicker without having to lean over the passenger seat. More importantly for Lewis, the driving-in-themiddle mode allows carriers to keep their eyes on the rearview mirror while they're stopped at a mail box. If they sense an approaching vehicle is not going to stop, they can pulThe rural postal carriers of the U.S. Post Office in Sharpsburg created this list of safety tips for homeowners and motorists to help them in their quest for safer mail delivery: * Mark your mailbox on both sides. * Clear any trees and tall bushes away from the box so it can be seen by carriers, garbage pickup, emergency vehicles and school bus drivers. * Maintain the box on a sturdy post so that the door opens and closes easily. A door or lid that has come off the box and is subsequently stored inside the box makes it difficult for mail delivery, especially on heavy mail days such as on Mondays and the day after a holiday. * When decorating

for the holidays, special occasions or yard sales, ensure that the lid can be opened. If the lid won't stay closed, repair it with something other than a rubber band. * Leave mail at the front of the box instead of the rear, especially on busy highways and roads. * If you receive a lot of mail, magazines, catalogs and small catalogs, install a box large enough to hold it all. * Pick up your mail daily. Put your mail on hold or have a family member or neighbor pick up your mail if you can't pick it up daily. * Keep your mailbox free of road obstacles such as parked cars, garbage cans, children's toys or bikes. Ask your lawn service and garbage pickup service to allow room for carriers to approach the box or driveway. * Teach your children to stay away from the mailbox when they see the mail carrier coming. The children should approach the box only after the carrier leaves the mail in the box and moves on to the next receptacle. * Teach your teenagers to watch out for rural mail carriers, especially on Saturdays, during summer break and school vacations and holidays. * Watch for carriers and slow down, especially on two-lane roads and highways. Allow some distance between you and the vehicle in front of you. * Stay off cell phones while you're driving. Pull over in a safe place to take or make your call. Sharpsburg's rural carriers deliver mail between 10 a.m. and 3 p.m. Monday through Saturday. Carol Walls added: "Our county is growing rapidly, and we have a lot more traffic than we used to. We also have a lot more mailboxes. We're are out there delivering between 10 a.m. until 3 p.m. Monday through Saturday. "We only ask that you be alert and watch out for us. We are your friends and neighbors and relatives out there doing our jobs."

Steve Maurer, State Executive Director for Ohio's Farm Service Agency (FSA) would like to remind producers to report the acreage to your local FSA office within 15 days of the final planting date of the crop, when bad weather prevents planting or damages crops. This applies to all crops, whether covered by crop insurance, not covered by insurance, or covered by FSA's Non-insured Assistance Program (NAP). Final planting dates vary among counties and crop types.

Producers who have their crops insured through a private crop insurance company should contact the insurance agent immediately and advise them of the damaged crops. Additionally, for those crops covered under FSA's NAP, producers should immediately contact their local FSA office to report the acres and file a CCC-576, Notice of Loss Application.

"Producers with NAP coverage should report their losses within 15 calendar days of crop damage from natural disaster, so the loss can be appraised and production counted before the crop is put into another use, abandoned or destroyed," said Maurer.

Crops not covered with

a private insurance or NAP policy should still be reported to the local FSA office. This will provide FSA with a historical record of your crop should disaster assistance become available.

LATTA LEADS LETTER TO **DOT REQUESTING AN-OTHER HOURS OF SERVICE EXTENSION FOR PROPANE** DELIVERY

On Friday, Congressman Bob Latta (R-Bowling Green) led a letter with Speaker Boehner and the Republican members of the Ohio Congressional Delegation to U.S. Department of Transportation (DOT) Secretary Anthony Foxx, again requesting the agency extend the hours of service emergency exemption, which expired Saturday. This is the second letter Latta has led regarding the issue. A week after the first letter was sent, DOT granted the initial extension, which provided regulatory relief for commercial motor vehicles delivering propane to affected areas and consumers in Ohio and throughout the Midwest.

'We've experienced extremely cold temperatures this winter - the effects of which continue to jeopardize the lives and livelihoods of Ohioans," said Latta. "My colleagues and I have already taken action to address this issue through legislation that passed both the House and Senate, but we must do everything we can to get our constituents the supplies they need to heat their homes and farming operations while the bill awaits action by the President. An extension of the emergency exemption will continue to allow propane to be delivered to those most in need as quickly as possible, and I urge the President to take swift action." The letter notes that the U.S. House and Senate have passed H.R. 4076, the Home Heating Emergency Assistance Through Transportation (HHEATT) Act, which would remedy a lapse in the exemption until May. However, since the President could take a number of days or weeks to sign the legislation,

the letter requests an interim hours-of-service exemption to provide certainty for suppliers and distributors transporting emergency loads of propane. Finally, the letter notes that the hours-of-service exemption has also proved beneficial and that the Republican members of Ohio's Congressional Delegation stand ready to assist in any way needed to remedy the situation.

In addition to the two letters he led to DOT, Latta also led a bipartisan letter with Energy and Commerce Committee Chairman Fred Upton (R-MI) and 33 other Members of Congress, to President Obama on February 17. The letter requested that the President declare a state of emergency for parts of the Midwest that are currently experiencing ongoing propane supply shortages, ultimately lifting weight limitations for vehicles carrying emergency propane supplies to these areas and allowing more propane to be delivered faster to those in need.



SPECIAL FISHING REGULA-TIONS FOR LAKE LA SU AN HAVE BEEN SET

Fisheries biologists have set the special fishing regulations for this year at Lake La Su An Wildlife Area, according to the Ohio Department of Natural Resources (ODNR), Division of Wildlife.

Anglers are reminded that they are no longer required to make reservations, or obtain special fishing permits in order to fish the lakes on the La Su An Wildlife Area. In addition, anglers are not required to check in or out at the fish check station. All lakes on the area will be open to fishing, however; the number of days that anglers can fish the lakes will be restricted.

From May 2 through September 29 the lakes will be open to fishing four days a week: Friday, Saturday, Sunday and Monday. The La Su An Wildlife area will be closed to fishing at all other times. All lakes will be open from sunrise to sunset during designated fishing days. Sunfish bag limits for 2014, will be 25 fish daily, with no more than five fish being eight inches or larger. Largemouth bass will have an 18 inch minimum length limit, with a five fish daily bag limit and channel catfish will have a two fish daily bag limit. All bag limits are in effect area wide. This means that only one bag limit will be allowed each day regardless of how many lakes an angler fishes. All statewide fishing regulations apply to the area lakes except when superseded by the special regulations mentioned above. Anglers are also reminded that no fish may be

used as bait on the area. These changes have been designed to continue the tradition of quality bluegill fishing on the La Su An area lakes by continuing to regulate the amount of fishing pressure without the need for anglers to obtain a reservation. Parking will only be allowed in designated areas. 
