#### WIFFLEBALL TOURNAMENT **AT WAYNE TRACE**



#### LATTA LEADS BIPARTISAN CHARGE TO CUT UNNECES-SARY RED TAPE

The U.S. House of Representatives passed H.R. 724, a bipartisan bill sponsored by Congressman Bob Latta (R-OH), to repeal a duplicative mandate on auto dealers. Co-sponsored by Congressman Gary Peters (D-MI), this legislation is the result of bipartisan cooperation.

"H.R. 724 is simple, direct, and sends a clear message that hardworking American taxpayers, and specifically auto dealers, should not be burdened with redundant regulatory requirements. This legislation will make the car-buying process a little simpler and let auto dealers spend less time complying with obsolete regulatory requirements and more time developing their businesses, investing in local communities and creating jobs. As this legislation represents, finding ways to reduce unnecessary red tape is not only a policy goal both sides of the aisle can agree on, but it is a policy goal that can actually get done," said Congressman Latta.

#### OFF THE WALL GRAFFITI TAKES ON THE SNOW!

In the midst of the snow plows, sunshine, icy roads, a level 3 snow emergency and school closings, an abstract gathering of individuals took place on Tuesday, January 7<sup>th</sup>. Some Antwerp young people had the opportunity to meet, draw and paint with Off The Wall Graffiti. The original plan was to paint a wall in The Arch (the building of the Antwerp Community Youth Center), but alas, due to the non-cooperating weather, The Arch didn't have heat or water. But leave it to the "outside the box" thinking of Maura Mc-Carthy, the founder of Off The Wall Graffiti, and her mother, Sharon McLaughlin, manager of the Essen House Restaurant in Antwerp—creativity would be born on this snow week! After a few back and forth phone calls with ACYC director, Angel Steiner, the venue was set: Essen House Restaurant. That's right! Those of you who remember the old school, know that there is a basement under that gym, and that's where the kids had the opportunity to collaborate with



some very talented artists. These artists really are all just philanthropists at heart. They stopped in Antwerp mid-way to Michigan, and used this opportunity to share with a few of the kids the importance of using their creativity as a positive outlet.

Off The Wall Graffiti is a non-profit organization (founded in 2010) that tours the country doing art where ever that may take them and in the process, mentoring budding artists who may have had a tendency to get "bored" with the rigidity of society's rules—sometimes getting them into trouble when they deface public or private property with their artistry. Maura states it best (taken from her website), "We are directing their self expression to sanctioned areas, we may even end up on walls-with permission."

OTWG's Mission The Statement:

"The mission of OTWG is to elevate the self esteem and talent of under-served 10-25 year old artists. In order to accomplish this mission, we will provide mentoring and contests for students to stretch their skills, focus their competitive nature, and win art supplies in support of self-expression, connecting them to a global community of artists in the pursuit of an education in the arts."

They are currently working on finishing a documentary, This or That Documentary Tour, which will showcase several US cities that they visit, organize painting event, connect with some budding artists, and get life lesson interviews. They are hoping this inspires the ones out there who feel that nobody is listening or cares.

Danny is part of The Maven Imprint which is a "for artists by artists" collaborative. It is an artists' agency and production company. As they build with their partners (such as Off The Wall Graffiti), they work as a movement to combine interconnectedness and cross-brand promotion with a professional business mentality. MAURA MCCARTHY is sort of the mastermind behind everything in Off The Wall Graffiti. She gets contacts and gigs set up which has given them venues all over to do live art and other expressive events. What she loves about art is how it enables her to connect with kids of like-mindedness. Many kids have "found" her, so to speak, and she gets them talking, and they'll do art together-and a mentorship has been born! She's seen many kids rise above obstacles that life has put before them, and pursue their artistic talents for the good of themselves, society, and the world. Maura is the mother of two grown children-a daughter who is pursuing her BFA in art education from Southern Oregon University, and a son attending college at the University of Colorado, Boulder.

All of these fine human beings are currently traveling together as a collective with Off The Wall Graffiti on their This or That Documentary Tour. A designer from Ireland, Stuart Crawford, also toured with them, but has since returned home. The corporate sponsor of this group's endeavors has been Blick Art Supplies. All of the kids in attendance on January 7th took part in a preliminary, inspirational time, by doodling on some Essen House Restaurant placemats, but a couple of them were a little too intimidated to put their work on glass. Yep! They used four inch thick glass that Sharon McLaughlin said has been gathering dust in the basement. And what better way to reuse, than to let these guys demonstrated their creativity. The medium was acrylic paint and paint markers. The purpose of this activity? Well, there were a couple: 1) to get kids to be creative without the use of an elec-

tronic device;

2) to help spruce up The Arch.

The kids all worked for almost two hours on their creations. But some of the more in depth masterminds couldn't get all of their expression out in that time frame. No worries, though! Sharon said they will be able to have their artwork to finish as soon as the weather breaks and they will be transported over to their new home at The Arch. There are many more pieces of glass like the ones the participants worked on, so the extra paint and as many pieces of glass needed/wanted will be donated to the Antwerp Community Youth Center kids.

"I want to thank Off The Wall Graffiti for taking the time with these kids and showing them how what's up in their heads can come out & look beautiful. I loved it! And to Sharon for getting this distraction from the weather set up," commented ACYC director, Angel Steiner.


A placebo "is a simulated or otherwise medically ineffectual treatment for a disease or other medical condition intended to deceive the recipient." It's given because some people get better just from the thought of being treated. It's fake. It's not

And we fill our spiritual lives with so many placebos.

James wrote, "If anyone thinks he is religious and does not bridle his tongue but deceives his heart, this person's religion is worthless," (James 1:26 ESV). Talking religion can make people think that they are religious. The right answers. Impeccable theology or witty spiritual guidance. James recognized the danger in words. It can lead to a worthless religion. Just talking, even though it may make us feel like we have done something, is not religion. The focus of James' letter was to emphasize that having the right beliefs or saying the right things is no substitute for actually living out true religion.

When we think that we're right with God, yet it is not leading us to love the least of these, we're just taking a spiritual placebo. It may make us feel good, but it is not true religion.

James continued, "Religion that is pure and undefiled before God, the Father, is this: to visit orphans and widows in their affliction, and to keep oneself unstained from the world," (James 1:27 ESV). To visit orphans and widows in their affliction and to keep unstained from the world. True religion is living the life that we read or hear about. True religion is truly helping rather than just saying



Our times spent together as a church and learning together are important. That is not to be discarded in our search for true religion. For those outside of a flawed yet reclaimed community, it is something to be part of. True spirituality is not found outside of relationships with God and other sojourners. Without authentic relationships where we learn together, we will not know the direction God wants us to go. But we always must remember that talk is not the goal. Knowledge is not the goal. Attendance is not the

EACS Superintendent Dr. Kenneth Folks tells a story that during his tenure as principal, the teachers in the building he administrated had his full blessing to call 911 from the classroom in the event of an emergency.

"I had confidence in the teachers' ability to make a sound decision in the best interest of safety," said Folks. "If this meant calling 911 to summon an ambulance or the police when minutes counted, then it was the right decision to make."

and one that we take very seriously."

In the event of inclement weather, said Folks, the team begins driving all of the very same roads the buses will be expected to drive as early as 4:00 a.m. to gather information about what is going on in the neighborhoods and towns that make up the EACS school district. The team also monitors weather reports and communicates with other school districts in the county to find out what they are seeing in their neighborhoods, said Folks.

For instance, to try and determine whether or not school would be in session



on Friday, January 10, 2014, Folks said he and the team began driving all of the roads on Thursday afternoon and felt very confident that the district could open for instruction on a 2 hour delay schedule.

One of the biggest obstacles facing the transportation department, said Folks, was the buses being able to turn the corners under the slippery and snowy conditions. Further complicating matters was the light snow that began falling late on Thursday, that combined with the dropping temperatures and the slick snow already on the ground, made for unsafe travel for the school buses once again.

"It's one thing for me and my little Chevrolet to take corners and maneuver the roads in this weather," said Superintendent Folks, who actually gave this interview while driving en route from Leo Jr. Sr. High School to Woodlan High School. "The buses on these same roads are another matter entirely."

With the loss of four student instruction days this past week, thoughts of many parents around the area have turned to how these days will be made up. Superintendent Folks says the district will apply to the Indiana Department of Education for a waiver for two of these days because school was cancelled due to county-wide Department of Homeland Security travel warning. Another day will be made up with an already-built-into-the-calendar school make-up day on February 20th. Dr. Folks plans to approach the school board at the next meeting about making February 11th (previously scheduled to be a district wide teacher in-service day) a student instruction day.

"I wish I had a crystal ball so I could see exactly what the weather was going to do and when it was going to do it," said Superintendent Folks of his school delaying and cancelling abilities. "We always try to give families as much notice as we can when it comes to delays and closings. Unfortunately, the safest decision isn't always the most convenient decision, however, we will always do what is safest for our students, faculty and staff."



Across Madison Street to the west was the home of John Foster, then the home of Roy Ewing, and the last house was the home of Sam Sunday. Their daughter also lived with them for years and her name was Mrs. Egglof. That block also contained the Texaco sub station and the corral and loading pens for the railroad. At one time that was a busy area.

#### **PREPARING KIDS FOR** THEIR CAREERS

#### Casey's Comments by: IN State Rep. Casey Cox, **House District 85**

With the 2014 legislative session officially underway, the Statehouse is buzzing with activity. This is my very first session, and I am excited to get started. I am proud to be part of a visionary team that is dedicated to keeping Indiana on the right track. This year is a "short session", meaning the General Assembly only meets for 10 weeks compared to a "long session" where the General Assembly meets for four months and addresses the budget. During this time, we have several items to address. While there are many matters to attend to, House Republicans have identified key legislative priorities. Among those top priorities are making sure that children are prepared for the future, starting as early as preschool.

Last year, the General Assembly took action on early education, opening the door for low-income Hoosier families to have access to high quality preschool options. It is a priority that we continue these efforts in 2014, so the youngest Hoosiers have the best possible start to their education. I am working to expand the current preschool education scholarship program for those who are up to 185 percent of the Federal Poverty Level. What this means is that a family of four with a household income of \$43,568 would qualify to have their son or daughter apply for the scholarship if the bill passes. According to a study from the United Way of Central Indiana, children in poverty are read to an average of 25 hours before they begin first grade. By comparison, middle class children are read to an average of 1000 hours before they begin first grade. To shrink these levels of discrepancy, it is important that the state provide opportunities for low-income families to send their children to a high-quality preschool. Indiana is one of 10 states that does not currently offer state-funded preschool programs. The time for action is now, and we can no longer sit idly by.

Right now, 60 percent of Hoosier children (ages 3-4) are not enrolled in preschool. As a father of two young children, I recognize the importance of early childhood education. I view education as a critical investment, and I believe that a high-quality preschool education can pay tremendous dividends in children's lives down the road. This session, it is a top priority to make these opportunities more accessible to families of limited means.

Every child, regardless of their parents' financial situation, deserves the chance to receive a great education. It is our intention that with the creation of a preschool voucher program, even children with the smallest means can start off on the right track, and from there, continue on a path to academic success that will ultimately lead to a life of economic prosperity.

Q: How do young Bald Eagles learn to hunt and how long does it take them to learn? How much of their skills are innate, and how much do they have to learn from their parents?

A: An excellent question. Young eagles form wild nests develop their hunting skills on their own, but spend considerable time after they fledge watching their parents and undoubtedly learning by watching what the adults do. The actual skills involved are learned by trial and error, I'm sure. Much of the hunting skill (or at least the drive to hunt) is innate, as our hacked eagles were fledged into an environment without adults around to "teach" or "show" these young birds. Yet, these birds, again through trial and error,

creating interesting products, offering outstanding service, contributing to their local communities and employing Ohioans in the process. Each month, a handful of diverse businesses linked together by a common theme are featured on the Secretary of State's website at OhioBusinessProfile.com, where Ohioans are encouraged to go to submit companies they feel are deserving of recognition in future months.

Secretary Husted's office also releases a monthly report of new business filings in Ohio. Recent data has shown that the number of newly-registered businesses in Ohio is up for the year as compared to the same time frame last year.

learned to hunt for themselves and survive. We felt it was important to continue to provide food at our hacking towers after the eaglets fledged, to give them a source of food for as long as they needed it. Eventually, each eagle at its' own pace, these young birds stopped using our offering and began foraging on their own. Similarly in the wild, the adult parents will continue to provide food for some time after fledging, while the newly flighted birds hone not only their hunting skills, but their flying skills. On average, I would say it takes about 4-12 weeks for young eagles to start hunting successfully. True, fully reined, specialized hunting skills, probably take years to develop.


ARE ROUTINE PHYSICALS A WASTE OF TIME?

#### The Nurturing Well by: Jill Starbuck

In recent years, much debate continues regarding the usefulness of routine physicals. Some people argue that the Affordable Care Act will add a significant number of eligible patients, which will take away time from more critical health issues. Others argue that it is unnecessary for relatively healthy people to undergo an annual exam. A number of studies continue to imply that routine exams have no medical benefit. Some people argue that these exams are a ploy for the medical field to make easy money. Some studies indicate that these exams don't reduce overall deaths, hospitalizations, costs, etc.

However, before you readily agree with these arguments, take into account the flipside. Those who recommend the annual exam claim that patients can discover and treat conditions that could affect them later in life. Catching some of these issues ahead of time can prolong life. To counter the argument that only unhealthy people should schedule a routine physical, take into account the following true scenario.

Scenario: A healthy woman in her early 40s sought a routine physical. With the exception of occasional migraines, she routinely exercises, has healthy vital signs, is at a healthy weight, and eats a relatively nutritious diet. However, she decided with her competitive activities and a poor family health history that she should ensure her health stays on track. While the doctor and the patient felt that everything would turn out normal, an EKG showed an irregular heartbeat. Following that, the woman's bloodwork indicated a low platelet count. From there,



physical saved a perfectly 'healthy" woman. Moral: Everyone has the right to determine whether they should get a routine physical or not. But when a healthy person such as the one above runs into a shocking discovery, a routine physical seems to make sense and would be discriminatory to suggest that only those unhealthy should seek physical exams. Consider the benefits of a physical exam. A routine physical could be your only yearly medical expense by proactively ensuring your health. A routine physical may catch something in the early stages that can prolong your life and even reduce expenses if caught early enough. In some cases, such as the woman in the scenario, it can save a life. What's your take? Is a person's life worth all the expenses and recommendations for routine physicals? What do you think the woman in the scenario would say?





#### **BIOLOGISTS PROPOSE REMOVING BOBCATS** FROM OHIO'S THREATENED SPECIES LIST

The Ohio Wildlife Council received proposed changes to several species designations, including bobcats, as well as potential dates for the upcoming fall hunting seasons on Wednesday, January 8, according to the Ohio Department of Natural Resources (ODNR)

The ODNR Division of Wildlife biologists submitted a proposal to remove the bobcat from Ohio's threatened species list. The bobcat was one of 71 species on Ohio's first endangered list in 1974. However, the bobcat popula-

tion began to rebound in the 1970s, and in recent years the number of verified sightings has continued to increase, prompting the status change from endangered to threatened in 2012. Bobcats are still considered a protected species in Ohio with no hunting

or trapping season. Three other species were proposed to be changed on Ohio's state-designated species. A fourth was added as a species of concern, and this designation does not require council action.

#### **Snowshoe Hares**

Now endangered, snowshoe hares were proposed to be changed to a species of concern. Translocated hares have not been detected in Ohio since 2010 as the population has declined.

#### **Bewick's Wren**

Presently listed as endangered, the Bewick's wren is proposed to move to extirpated. A Bewick's wren nest was last confirmed in Ohio in 1995

#### Smooth Greensnake

Currently a species of concern, the smooth greensnake is proposed to move to the endangered list. This rare snake has lost much of its habitat and range in Ohio.

Eastern Hog-Nosed Snake

The Eastern hog-nosed snake will now be listed as a species of concern in Ohio.

Hunting season date proposals are prepared by the ODNR Division of Wildlife biologists and maintain many traditional opening day dates.

• Monday, September 1, is the proposed start date for Ohio's fall squirrel and dove hunting seasons.

• Hunting seasons for cottontail rabbit, ring-necked pheasant and bobwhite quail are proposed to start November 7, the first Friday in November.

 Fox, raccoon, skunk, opossum and weasel hunting and trapping are proposed to start Monday, November 10.

• Proposed 2014 fall wild turkey hunting season dates are Monday, October 13, to Sunday, November 30.

 Proposed 2015 spring wild turkey dates are Monday, April 20, to Sunday, May 17.

• The proposed 2015 youth wild turkey weekend dates are April 18-19. New this year, it is pro-

posed that youth hunters can

harvest up to two wild tur-

keys during the 2015 two-day

youth season (one per day).


