When he was unable to get an answer, he called the Paulding County Sheriff's Office. The Sheriff's Office encoded the Oakwood EMS and they were able to quickly get to Triston's mom.

Ohio activated its Ebola preparedness plan when it learned that an Ebola patient visited the state: Ohio was notified Wednesday morning by the CDC that a Dallas nurse who has tested positive for Ebola visited Summit County on October 10-13. Ohio has been planning for months for a possible Ebola incident and it put those plans in motion upon learning this information.

Ohio is taking an aggressive response to this situation: Learning from the experience in Dallas, Summit County is using its quarantine powers to isolate people that had confirmed close contact with the nurse-one person so far. Also, the Ohio Department of Health has sent epidemiologists to Summit County to support their work to identify people who had contact with the Dallas nurse. Also, Ohio and local health care officials are working with the CDC in order to receive the latest information on developments as well as to quickly learn about new recommendations for managing an Ebola patient.

This plan is a requirement of the Indiana Department of Natural Resources, Division of Outdoor Recreation to allow the Township to remain eligible to apply for competitive state and federal park and recreation grants.

The plan provides guidance for park issues, improvements and administration from 2015 through 2019.

Ohio and local health care officials have been preparing for Ebola since this summer: The Ohio Department of Health has been working since summer to make sure those on the frontlines— local doctors, EMS, hospitals and local health departments—have the information and resources they need. Officials from the Ohio Department of Health and local health care organizations recently came together to discuss the status of their preparedness efforts and to conduct a table top exercise to test the response to a hypothetical positive case. The CDC recently certified Ohio's high-security state health lab to be able to test for Ebola so that Ohio health care officials can get test results as quickly as possible. Ohio has

and they all have experience dealing with infectious diseases and the resources and training to prepare for and respond to any serious outbreak.

### Facts About Ebola:

• Ebola is a rare and deadly disease caused by infection with one of the Ebola virus strains. Ebola can cause disease in humans and nonhuman primates (monkeys, gorillas, and chimpanzees).

• Ebola is spread by touching the blood and body fluids of a person who is sick with Ebola, or things with their blood and body fluids on it like clothes and bedding. Ebola is not spread through the air, food or water.

• Patients are contagious only when they are symptomatic and show signs of a fever.

• Anyone believing that they have been in contact with a person with Ebola should call their health care provider

## 30 YEARS OF LEAD-ERSHIP – YOU ARE INVITED

Ron Eschbach has been at the Antwerp Exchange Bank for 30 years this October. There is a celebration in honor of his commitment to the bank and the community all day on Friday, October 24.

It was in 1973 when a fresh graduate of Bowling Green State University began working in Defiance at a local bank. On October 29, 1984 he moved on to become head loan officer of the Antwerp Exchange Bank. Ron Eschbach wanted to move back to Paulding County for his life and career.

Ron is originally from Paulding where his mother, Ruth, and family continue to live. Even before he graduated from Paulding High School, his desire to be in the financial business sector was established.

Ron has witnessed many changes over the years in the banking industry. When he began in Defiance, every record, every deposit, every withdraw and transaction was kept in ledger books. There were rooms just to hold these books. Since then, he has seen the introduction of debit cards, ATMs, computers, web accounts and passwords, automatic transfers, ACH, Direct Deposit and many others. Credit cards came in widespread usage in this time.

The first checks with MICR encoding were printed in 1959 and it took a while for banks to adopt this system, but by the time Ron came on board, it was nearly implemented everywhere. MICR stands for Magnetic Ink Character Recognition, and is the funny shaped but readable numbers on the bottom of checks that allow the bank routing and account numbers to be read by enabled devices at high speed.

Ron married his wife, Marsha, whom he met in Fort Wayne at Kaysan's Restaurant in Fort Wayne. One of his hobbies include spending time with family including his son Nate and his step-daughters Kim and Kari. Ron has seven grandchildren. When he is not working, Ron enjoys playing on the green at the golf course.

Rotary has been a consuming part of Ron's life along with being on many committees and boards in the county including Paulding County Hospital and United Way. Community has been at the forefront of his life.

At this time, he does not have plans of retirement because he loves his work. Apparently his workers do too. John Kobee stated, "Ron is an excellent leader. He encourages collaboration on all the bank projects." Several of the bank employees have been at AEB as long or longer than Ron. Others have even come back to work after their children left home and the bank was more than willing to have them come back.

The future of Antwerp Exchange Bank will revolve heavily around the use of mobile devices and internet. The bank will be introducing an app for smart phones, for people who need immediate access to their accounts and allow instant transfers.

Last year, it was decided to completely renovate the Main branch. Using local business for the completion of the work made it a very good decision to create a new larger environment of space.

Another big project with Mr. Eschbach at the helm has been the AEB Payne Branch. It opened in December of 2008 and is approaching its sixth year in the area. The bank has been well-received by the community. This year a new building was constructed on the site of derelict buildings downtown. The Payne Chamber of Commerce approached Geoff Hyman, Payne Operations Manager, and Ron about the revitalization of the downtown space. The plans proceeded and worked well for the bank and the town.

Other current projects involve the Indiana side of the line with the new Antwerp Exchange Bank Loan Office in Harlan. Ron said it has been going well there and they have had talks of opening a full branch in the future because people are asking for a local bank.

Yes, Ron has been quite the fixture of the area. His leadership and skills are apparent even through the banking industry conundrums of the late 2000's and the bank coming out stronger than ever.

## NEW DOWNTOWN REDIMED OPENS IN THE ANTHONY WAYNE BUILDING; NEW HAVEN LOCATION READY FOR PATIENTS NEXT WEEK

In July, Lutheran Health Network announced that it would be adding two new RediMed urgent care clinics. The first opened its doors to patients in downtown Fort Wayne on October 20, 2014.

The downtown RediMed, found on the first floor of the Anthony Wayne Building, 203 E. Berry St., includes three exam rooms and a procedure room. Radiology, lab services and lower acuity procedures will be available on-site. The downtown RediMed has led to the creation of 10 new healthcare jobs.

A second new RediMed is set to open Monday, October 27, in New Haven. This location at Lutheran Health Plaza, 1302 Minnich Road, will offer urgent care and occupational medicine services. RediMed New Have has created seven full-time positions and one part-time position.

Both locations have the same hours: 8:00 a.m. to 8:00 p.m., weekdays, and 8:00 a.m. to 2:00 p.m. Saturday and Sunday. Flu shots are available at all six RediMed urgent care clinics in northeastern Indiana.

Architecture and design services for multiple RediMed projects this year are being handled by MKM architecture + design. The general contractor is The Hagerman Group. All RediMed clinics are staffed by physicians and mid-level providers and offer X-ray, laboratory and prescription services on-site with convenient locations and hours. Appointments are not necessary. Additional services to be offered at the clinics include fracture management, hydration management, foreign body removal and diabetes management.

Besides urgent care, RediMed provides occupational medicine through its Business Health Services arm of the organization. Business Health Services also assists employers and employees with worker compensation as well as wellness and preventative medicine.

## BALLOT BOARD DECIDES BOTTLE BILL AMENDMENT IS SINGLE ISSUE

The Ohio Ballot Board, chaired by Secretary of State Jon Husted, certified that the proposed Bottle Bill for Ohio constitutional amendment consists of one issue.

Petitioners will now need to collect 385,247 signatures, which is equal to 10 percent of the total vote cast for governor in the most recent gubernatorial election. As part of the total number of signatures needed to place the measure on the ballot, petitioners must also collect signatures from at least 44 of Ohio's 88 counties, and within each of those counties, collect enough signatures equal to five percent of the total vote cast for governor in the most

## LATTA CALLS FOR TRAVEL **RESTRICTIONS TO COMBAT EBOLA**

Congressman Bob Latta (R-OH), member of the House Energy and Commerce Committee, which has jurisdiction over public health issues and the Center for Disease Control and Prevention, called for immediate travel restrictions to West African nations. In addition, Congressman Latta stressed the need that those being monitored for potential exposure to Ebola should be prohibited from both domestic and international travel.

"In responding to the Ebola outbreak, we must examine every possible solution, including travel restrictions," said Latta. "While there are no direct flights from Liberia, Guinea or Sierra Leone to the United States, travel from West African nations should be suspended immediately in an effort to protect the health and safety of Ohioans and all Americans. In addition, anyone being monitored for potential Ebola exposure should be prohibited from utilizing public transportation in an effort to contain the outbreak."

Latta visited Mercy St. Vincent's Medical Center and Paulding County Hospital to see firsthand their Ebola preparedness and response efforts. He remains confident in Ohio's state and local health care networks' preparedness and ability to aggressively respond to a potential Ebola incident.





I am writing in support of the library renewal levy on

November 4. I am proud to have such a quality and historic institution in Paulding. To have attracted the experienced and qualified staff we have to our small county is a plus. The fact that our library system wins awards for programming and staffing, and is asked to educate other librarians at conferences is a true feather in the cap for our county and our community.

I applaud the library board for listening to the community it serves. Last fall, the library requested a 'continuing' levy for a certain amount, in hopes of not having to come back to the voters repeatedly. The voters said, No, and the library board heard them.

The measure that is coming before voters this November is a 'renewal with a reduction' of a levy passed in November 2009. It is designed to renew the levy that is in effect now and reduce the amount. It will need to be re-approved again in 5 years. It will not increase your tax bill.

These dollars represent almost half of the total budget of the Paulding County Carnegie Library, and the need for renewal is now. If this renewal fails, the library cannot 'try again' in the spring, because the levy will have expired at the end of 2014, taking 50% of the library's funds off the table. Any future levy request would be a 'new levy' and would be calculated at new, higher property valuation rates than those that were in effect in 2009.

Having a strong, accessible library is a quality of life issue, like having a strong school system, welcoming parks, and a local hospital. Even if you haven't used the library this week or even this year, our town and our county are better places to live because the library is here and vibrant.

I urge you to honor the library's modest request for a 'renewal with a reduction' on November 4.

## **SECRETARY OF STATE HUSTED RELEASES NEW BUSINESS FILING FIGURES** FOR SEPTEMBER 2014

Secretary of State Jon Husted announced that 7,947 new entities filed to do business in Ohio in September 2014. These numbers are up compared to September 2013, in which 6,239 new entities filed with the Secretary of State. The Secretary of State's office has assisted with 71,668 new business filings to date in 2014 (January-September). This is an increase from the same time period last year, in which there were 68,562 new business filings.

During the previous two years, 2012 and 2013, the state saw a record-setting number of new businesses file with 88,068 and 89,735 new companies filing to do business in Ohio respectively. Growth in online business filings has been steady and available online services continue to be expanded. Since the program's launch in October 2013, nearly 26,000 filings have been submitted and one in three new companies is now started online in Ohio.

Though the most visible role of the Secretary of State is that of chief elections officer, the office is also the first stop for individuals or companies who want to file and start a business in Ohio. While recognizing these numbers can't provide a complete picture of Ohio's jobs climate, they are an important indicator of economic activity that Secretary Husted hopes will add to the discussion of how to improve the state's overall climate for business.

NOTE: New business filings are classified as forms filed with the Ohio Secretary of State that declare the formation of a business entity, including for-profit, non-profit and professional corporations, limited liability companies, partnerships, limited partnerships and limited liability partnerships. Filing as a business in



An additional 1,313 deer were harvested by archery hunters on October 11-12. The total number of antlerless deer checked by hunters during the two days was 7,926, a 21 percent increase from 2013 (6,553).

Ohio hunters have many more opportunities to pursue deer throughout the fall and winter. The youth gun season is November 22-23, gun season is December 1-7, muzzleloader season is January 2-5, 2015, and archery season is open through February 1, 2015.

Hunting is the best and most effective management tool for maintaining Ohio's healthy deer population. During the 2013-2014 season, Ohio hunters checked 191,459 deer. Ohio ranks fifth nationally in resident hunters and 11th in the number of jobs associated with hunting-related industries. Hunting has a more than \$853 million economic impact in Ohio through the sale of equipment, fuel, food, lodging and more, according to the National Shooting Sports Foundation's Hunting in America: An Economic Force for Conservation publication.

The ODNR Division of Wildlife remains committed to properly managing Ohio's deer populations through a combination of regulatory and programmatic changes. The goal of Ohio's Deer Management Program is to provide a deer population that maximizes recreational opportunities, while minimizing conflicts with landowners and motorists. This ensures that Ohio's deer herd is maintained at a level that is both acceptable to most, and biologically sound.

Until recently, the populations in nearly all of Ohio's counties were well above their target numbers. In the last few years, through increased harvests, dramatic strides have been made in many counties to bring those populations closer toward their goal. Once a county's deer population is near goal, harvest regulations are adjusted to maintain the population.




