ODOT IS READY FOR WIN-TER KEY TO CLEAR ROADS IS BEING PREPARED

Last winter broke many records in the state, especially for the Ohio Department of Transportation (ODOT): most road salt used (more than 1 million tons), most money spent (\$119 million), and most snow plow miles driven (more than 14 million). This winter, ODOT is ready. Earlier this month, ODOT crews around the state began conducting random 150-point inspections to finetune snow removal equipment in anticipation of the coming winter. The inspections are part of the department's annual

Chief Deputy Treasurer William Royce wants to remind everyone that the fall property tax due date is fast approaching.

"Taxes are due Monday, November 10 and must be in our office or postmarked by that date to be considered on time." Royce said. He also wants to remind taxpayers that local banks are no longer collecting payments.

"We know that paying at the bank was convenient for some taxpayers but due to process changes it is no longer timely or efficient." said

Many payment options are available; in person, by mail, electronically through the Treasurer's website, by credit card, payments can be dropped off in the Child Support drop box on the south end of the courthouse, on your smartphone or mobile device, or you can use the self-pay kiosk at the Treasurer's office. There are also a variety of payment plans available.

I don't know why he chose that pseudonym, but there are surely times when we need to observe silence and do good, letting our actions speak for us.


OHIO BIOLOGISTS ENCOUR-AGED BY 2014 LAKE ERIE HATCH RESULTS SURVEY

Results from the 2014 Ohio Division of Wildlife bottom trawl survey on Lake Erie showed an average walleye hatch and a good perch hatch.

Results from Ohio's waters of the western basin indicate that this year's walleye hatch is similar to the average hatches of 2001, 2007, and 2010. Ohio's bottom trawls caught around 20 walleye per hectare in 2014, slightly below the long-term average of 26 walleye per hectare, and the best since 2007. Average hatches from three of the past eight years has resulted in a broad range of walleye ages and sizes that make up the Lake Erie walleye population. Based upon result from the August trawl surveys, it appears that the 2014 hatch was near average and should contribute to the fishery in future years.

The 2014 yellow perch hatch appears to have been successful in both Ohio and Ontario waters of the western basin. This is the fourthbest yellow perch hatch in the western basin since the interagency survey began in 1987. Two back-to-back good yellow perch hatches should help the perch population in the western basin rebuild and lead to quality perch fishing in the near future. It takes two years for walleve and perch to grow large enough to be harvested by Ohio's fishermen.





OHIO EPA ACCEPTING APPLICATIONS FOR RECY-CLING & LITTER PREVEN-TION GRANTS

Ohio EPA is accepting applications for various recycling and litter prevention grants.

Ohio EPA administers programs relating to statewide source reduction, recycling, recycling market development, litter prevention and scrap tire recycling projects. Litter prevention, recycling and scrap tire grant applications can be accessed at www. recycleohio.gov.

Grant programs include:

Community Recycling Grant: This funding allows Ohio communities to support and expand community recycling and litter prevention efforts. Grants provide new infrastructure for collection and materials processing, involving materials such as construction and demolition debris, electronics, glass, paper-based materials and plastics. Those eligible to apply include municipal corporations, counties, townships, villages, state colleges or universities, solid waste management districts or authorities, park districts and health districts. The grants require 50 percent matching funds.

Litter Management Grant (formerly the Litter Cleanup and Tire Amnesty Grant): This program seeks grant applications that will improve local environments through litter prevention, beautification and waste reduction activities. Ohio communities and nonprofit organizations can receive funding to support litter cleanup activities and litter prevention and awareness. Grant proposals must include a litter cleanup activity to take place on public land, roadsides or public waterways, and involve the use of volunteers. In addition to other eligible entities listed above, Keep Ohio Beautiful affiliates, boards of education and nonprofit organizations also may be eligible. Ten percent matching funds are required.

Market Development Grant: Grant funds are offered to Ohio businesses that propose to create infrastructure for successful markets of recyclable materials and related products. The program seeks proposals involving materials collected or processed in Ohio. In addition to the eligible entities listed under the community recycling grant above, business or nonprofit applicants must apply under a contract with an eligible government agency serving as a

pass-through agency that can document and receive funds. This grant typically focuses on equipment purchase. The cooperating enterprise must commit to provide a 100 percent grant fund match, with a maximum grant period of 24 months.

Scrap Tire Grant: Financial assistance is available to Ohio entities interested in converting manufacturing operations to accept scrap tire material, expanding tire processing operations or developing a use for scrap tire material and related products. The program seeks proposals involving material collected or processed in Ohio. Applicants must be sponsored by an eligible government agency that will serve as the grant applicant and be the passthrough agency for documenting and receiving funds. This grant also requires 100 percent matching funds from the sponsoring business or nonprofit organization. The grant has a maximum duration of 24 months.

Grant applications for all four programs are due February 2, 2015. Grant awards will be announced in April 2015, with funding available in July 2015. BETSY ROSS AND THE AMERICAN FLAG

About half way between Betsy's upholstery shop and the waterfront is the Post Road. This road starts in Boston and runs all the way south to Philadelphia, some 228 miles. It is a well-maintained road because the East Coast Stage Line runs both ways every other day. It is usually quite busy with passengers and it also carries the U.S. mail.

That young man, Paul Revere, is one of the drivers. He is very good with horses. It takes all of three days to cover the distance. It can be a rough ride at times.

You can also take the Cunard Line, which is about a 4 day boat trip, but it is a lot smoother ride. You end up at the waterfront in Philly.

HUNTING SEASONS FOR RING-NECKED PHEASANT, COTTONTAIL RABBIT & BOBWHITE QUAIL HAS OPENED IN OHIO

Cottontail rabbit hunting continues through Saturday, February 28, 2015. Ringnecked pheasant hunting is open through Sunday, January 4, 2015. The pheasant and rabbit seasons are closed during the 2014 statewide deer-gun hunting season, December 1-7.

Bobwhite quail season continues through Sunday, November 30. Quail hunting is open in 16 counties in southern Ohio: Adams, Athens, Brown, Butler, Clermont, Clinton, Highland, Jackson, Meigs, Montgomery, Pike, Preble, Ross, Scioto, Vinton, and Warren.

• Rabbits, pheasants, and quail may be hunted from sunrise to sunset. The daily bag limit for all three species is four rabbits, two pheasants (roosters/males only), and four quail.

• Cottontail rabbit hunting restrictions were removed in the snowshoe hare protected area in Geauga and Ashtabula counties. Snowshoe hares are protected as a state-endangered species, and it is illegal to kill them in Ohio. Rabbits and hares look very similar, but hares are generally larger than rabbits with longer legs and ears. Snowshoe hares have a thick white coat in the winter that helps them blend in with the snow. In the spring, they shed their winter coat and grow a thin brown summer coat.

• The ODNR Division of Wildlife releases pheasants in select hunting areas throughout the state. This year releases took place October 24 and Octoer 31 (prior to small-game youth hunting weekends), Thursday, November 6 (prior to opening day), Friday, November 14, and Wednesday, November 26.

• Additional hunting information is contained in the 2014-2015 Ohio Hunting and Trapping Regulations. The regulations are available where hunting licenses are sold, at wildohio.gov or by calling 1-800-WILDLIFE (1-800-945-3543).



DEAR MISS C...

About 2 months ago, I lost my husband. The amazing part was the blessing of having my family and friends surround me with support just when I needed it most. They helped me make arrangements, take care of details, listen to me blubber, and were there to share the joy of remembering all of the good times. I was overwhelmed with the love and support. Which I guess is why I was so shocked when greed destroyed a long time friendship with someone I trusted and loved. Miss C, I miss my husband and am torn apart trying to understand why my friend chose money over my friendship. It's not even just the money part that hurts, but it feels like a friendship betrayal. Is this normal? I don't know what to do next!

—Grieving in Ohio

Dear Grieving in Ohio,

The key words you used are grief and stress. You are not alone. Many people can relate to this kind of fighting after a loss. Many people can share stories about how their favorite Aunt Matilda became Crazy Aunt Matilda, sneaking into the house before the funeral to grab knick knacks she wanted to keep for herself. Or when your closest brother or sister who was once your biggest support, now seems to just fight about everything. The world may feel like it is falling to pieces, meanwhile you are trying to cope with the reality of life after the passing of your loved one. And you know what the number one conflict after a loss? You guessed it, the battle over material items and money. We all deal with the stress and grief in different ways. These differences might be the very source of conflict. So! What can we do to cope and fix it? Well, there is no magical cure. But I can share a few common conflicts and offer a few potentially helpful suggestions. 1) There are many reasons that death brings out the worst in people. But one reason is that during high

stress and grief, our brain actually functions differently! There are parts of the brain that think rationally and other parts of the brain that react with emotion and impulse. In high stress, our rational brain defaults to our emotional brain. So when lots of people are reacting with emotion, you can see how conflict might arise.

2) Grief typically (or at least for a period of time) equal total loss of control. We want more than anything to have control over something. Though control, is often an illusion at best. Either way this loss of control is very scary. So during this time people will seek out ways to feel in control. Sometimes that is by beginning to make arrangements without consulting others. It might mean immediately trying to pass out belongings or financial information. We are prone to make mistakes in this time. So a family member or friend could be helpful by assisting with regaining control doing whatever tasks might be needed (even if it is helping by making sure toilets are cleaned when mourners visit).

3) Communication (or lack there of) can be a key issue that leads to conflict. If a plan isn't made for who, when, and how certain things will be handled, it is not uncommon for one person to go rogue. Communicating isn't always easy, but it is crucial to reducing conflict. If at all possible, make a plan right away for how and when things will be handled. Agree on a time frame to all sit down together to go over the will, discuss next steps, and ensure everyone is on the same page. Make a plan for regular updates and communication between family

instead of "you statements". So, for example, instead of saying, "I can't believe vou threw away mom's clothes without talking to me first. You are so self-centered and thoughtless". Instead you could say, "I was really hurt when you threw away mom's clothes without talking to me first. It made me feel like you didn't care about my grief or my attachment to those things. There were some items in there I really wanted to keep that are now gone". By focusing on the behavior, how it made you feel, and the impact you can hopefully open a dialogue without making the other person defensive. Also, be open to their feedback. You probably haven't been perfect either, so try to openly listen to what they need from you.

5) And finally, we tend to generalize the negatives. Extending behaviors of a griever to represent who they are as a person. For example, you and cousin John have been close for 35 years and you think he is a great guy. After the death of your grandmother, he does some shady manipulating to try to get her car. You are outraged and appalled, so you think to yourself, "wow, I always thought John was a good person. Now I see him for what he really is. I can't believe I never realized how greedy he is." All of the sudden everything else John does around the death is clouded by your new-found realization that John is a shady, greedy troll. Timeout. Let's take a few steps back here. Grief makes us all do crazy, sometimes crappy, things that we often regret. It is important to cut people (and ourselves) some slack. People do all sorts of awful stuff when they grieve, so view these things as poor choices due to an impossible time in life. It doesn't override the 10, 15, 35, or 50 years of wonderful things you know about the person. Try to remember that this may be the exception in their behavior, not the rule. Just like you need to be gentle and forgiving with yourself, you need to be gentle and forgiving with others.

Have you ever considered how powerful a hug, a handshake, a pat on the back, a wave, a smile, or other simple gesture can be? We especially realize the importance of such gestures when they are missing. Yet, as always, she taught me a lesson, which is that sometimes words and gifts aren't enough or even necessary—that sometimes what we need the most is truly very simple.

OHSAA'S SPORTSMANSHIP, **ETHICS AND INTEGRITY COMMITTEE HONORS 30** SCHOOLS

The Ohio High School Athletic Association's Sportsmanship, Ethics and Integrity (SEI) Committee has announced that 30 member schools have been selected to receive school sportsmanship awards from the 2013-14 academic year. The 30 schools met the 'Respect the Game Challenge,' while 10 of those schools also earned the Harold A. Meyer Award. In addition, Columbus Bishop Watterson High School and Lakewood High School have been selected to receive the highest award, which is the prestigious Commissioner's Award.

The list of recipients was accepted by the OHSAA Board of Directors at its regularly scheduled meeting October 16. This is the fourth year the OHSAA's revised three-tiered process for the Sportsmanship, Ethics and Integrity school awards has been implemented.

In order to meet the 'Respect the Game Challenge,' schools must complete a comprehensive checklist that confirms the various sportsmanship, ethics and integrity programs within their school. Besides developing a well-planned, educational program on sportsmanship, the form reminds schools to develop a comprehensive student-athlete campaign; a coaches campaign; a student body, student support group, parents and fan campaign; and a public address announcers campaign. diseases such as CWD. We have worked closely with the Pennsylvania Department of Agriculture to identify and trace back positive cases," said State Veterinarian Dr. Tony Forshey.

The state has quarantined 43 captive deer operations in Ohio since April 15, 2014, for receiving approximately 125 deer from operations in Pennsylvania that later tested positive for CWD. Twenty-two of those quarantines were lifted after negative CWD test results were confirmed in 53 of the suspect animals from Pennsylvania. ODA will continue to enforce quarantine restrictions on 21 operations, including five hunting preserves, until the department is satisfied that the threat of disease transference has passed.

The disease is fatal in deer, elk and moose, but there is no evidence CWD can be transmitted to humans, according to the Centers for Disease Control and Prevention (CDC) and The World Health Organization. Though no human disease has been associated with CWD, the CDC recommends, as a precaution, that people or other animals do not eat any part of an animal diagnosed with or showing signs of CWD.

"We have no reason to believe that there has been transference to the state's wild deer population," said Scott Zody, chief of the ODNR Division of Wildlife. "With hunting season in progress, there are no CWD concerns that should prevent anyone from enjoying wild deer hunting in Ohio or from consuming meat from healthy animals."

The ODNR Division of Wildlife is recommending that hunters continue to take standard precautions such as shooting only animals that appear healthy, wearing rubber gloves when field-dressing their deer and washing thoroughly when finished. If hunters should observe a deer that appears unhealthy, they are encouraged to contact their local wildlife office or officer.

Since 2002, the state has conducted surveillance throughout Ohio for the disease. State and federal officials will continue this regular sampling and testing throughout the hunting season to continue to monitor the health of the state's wild deer population. Tissue samples from 753 deer killed on Ohio's roads were collected from September 2013 through March 2014 and were tested for CWD. An additional 88 hunter-harvested mature white-tailed deer and nine deer displaying sympin death. It is transmitted by direct animal-to-animal contact through saliva, feces and urine. Signs of the disease include weight loss, excessive salivation, increased drinking and urination, and abnormal behavior like stumbling, trembling and depression. Infected deer and elk may also allow unusually close approach by humans or natural predators. The disease is fatal in deer, and there is no known treatment or vaccine.

from a \$6.5 billion proposal to a \$19 billion war contractor's wet dream. The White House halted the scheme this year, and the lab is reworking plans for fixing its 60-year long nuclear meth habit.

New H-bomb production is advertised as "revitalization", "modernization", "refurbishment" and "improvements". The buzz words are used by corporate weapons contractors and their congressional lapdogs who speak of the "40-year-old submarine warhead" (known as the W-76), or who feign concern over "fires, explosions and workplace injuries" that are 'deplorable" because the equipment "breaks down on a daily basis", the Times reported.

The War System always neglects to mention that 15,000 plutonium warheads are currently maintained at Pantex, Texas and are good for 50 years, according to The Guardian, September 29. The trillion dollar nuclear bomb building plan is to produce up to 80 new warheads every year by 2030.

The military currently deploys almost 5,000 nuclear warheads - on submarines, land-based missiles, and heavy bombers. This, even though Pentagon Chief Chuck Hagel signed a report (before he was appointed to his current job) that found that only 900 nuclear warheads were "necessary." Hagel's report recommended abolishing 3,500 warheads now in ready reserve, saying warhead numbers are much larger than required.

Independent observers, watch dogs and think tanks have argued for decades that the arsenal can be drastically reduced and made less dangerous: a) by not replacing retired warheads; b) by taking deployed warheads off "alert"; and c) by separating warheads from missiles and bombs. This separation would lengthen warningto-launch times, thus easing international tensions and ending the terrifying likelihood of accidental or unauthorized launches.

Greg Mello of the Los Alamos Study Group, which bird dogs the Cold War lab, says the reason new H-bomb production is being considered at all is simply private greed. For-profit corporations now run all the government's nuclear weapons labs, ever since they were privatized in 2006. Mello says, "The nuclear weapons labs are sized for the Cold War, and they need a Cold War to keep that size."

Further, in a report leaked last year, the Navy itself questioned the need for producnon-proliferation budgets to pay for it."


The \$1 trillion doesn't include a few hundred billion more for new nuclear war-fighting systems like:

• The \$80 billion cost of building 12 new ballistic missile submarines to replace the Navy's Trident fleet. Sen. Richard Blumenthall, D-CT, told the New London Day September 23, "The essence here is this boat will be the strongest, stealthiest, most sustainable of any in the history of the word." "Sustainable"? Well yes; like bankruptcy or suicide.

• The Air Force's \$44 billion plans for a new nuclear bomber called the Long-Range Strike Bomber Program (LRS-B). The Air Force reportedly wants 80-100 of them at roughly \$550 apiece. The chilling rationale for these billions was provided by Lt. Gen. Stephen Wilson, Chief of Global Strike Command, who said September 16 at in Washington, DC, "It will be essential as we move forward to have a bomber force that can penetrate any place on the globe and hold any target on the planet at risk.'

• The planned replacement of 450 Minuteman 3 ICBMs known as the "Ground-Based Strategic Deterrent"—set to be deployed in existing silos after 2030—that a RAND study said would cost between \$84 and \$219 billion.



ADDICTION RUNNING TO TRILLION\$

In 2008, the Obama Administration made eye-popping headlines by announcing a 10-year, \$80 billion nuclear weapons development program. In 2009, Mr. Obama promised to pursue a "world without nuclear weapons," but that was then. By 2010, new warhead plans had grown to an estimated \$355 billion, decade-long cash cow that amounts to a cool \$1 trillion over 30 years. The colossal expense has already been generally adopted by the House and Senate in military authorization bills - according to the September 22 New York Times.

duction sites just opened – a \$700 million non-nuclear parts plant run by Honeywell in Kansas City, Missouri. The other factories include a uranium fabrication complex at the Y-12 site in Oak Ridge, Tennessee; and a plutonium processing works at Los Alamos National Laboratory (LANL) in New Mexico. The latter two programs have run up such enormous cost increases that even the White House has blinked.

Plans for LANL's plutonium production—originally expected to cost \$660 million—expanded into a \$5.8 billon golden goose. The project was suspended in 2012, and engineers went to work at cost cutting. At Oak Ridge, the uranium processing "canyon" rocketed ing any new warheads. (The Navy controls at least 1,152 warheads spread across its 14 Trident submarines.) And James Doyle, a 17-year veteran scientist at the Los Alamos National Laboratory (who was fired this past July 8 for independently publishing a scholarly article defending nuclear disarmament), told The Guardian, "I've never seen the justification articulated for the 50-to-80- pits per year by 2030."

Jay Coghlan, of Nuclear Watch New Mexico, was shocked by the President's double talk, telling the Guardian, "Obama's proposed 2015 budget is the highest ever for nuclear weapons research and production. And at the same time, they're cutting

Becky Suvar, Paulding County Waste Management Education - Ms. Suvar presented information regarding her 2015 projected budget. The Paulding County WMEA is funded primarily with grant dollars. Ms. Su-var reported Paulding County WMEA is doing quite well financially. She then presented several suggestions for 2015 that would enhance the county's waste management and recycling program. Ms. Suvar would like to recycle tires again in 2015 and is also looking into reinstating glass recycling. The Com-missioners commended Ms. Suvar for her good 'management' skills over the


