The largest concern was the increase in semi traffic with the addition of several of the area's livestock operations, the maintenance equipment for wind farms, and highway 49 being the main artery connecting US 24 to US 30. Speakers in favor of the Village's position included: Sheriff Jason Landers, EMA Director Ed Bohn, Antwerp Exchange Bank's Geoff Hyman, Divine Mercy School Principal Cathy Schoenauer, Wayne Trace Elementary School representative Nancy Speice, State Representative Tony Burkley, County Commissioner Mark Holtsberry, Williamson Insurance's Lindsay Timm & Kiley Flaugh, St. Paul UMC Pastor David Rohrer, Paulding County Coroner Joseph Kuhn D.O., The Rock Youth Center's Jennifer Martin, Payne Chamber's Chad Benschneider, Payne Police Chief Rodney Miller, and several others showing their support of the Village's position.

The EMA Director spoke about the 25% increase since last fall of crude oil and other hazardous tankers flowing down the rail road that crosses SR 49 and the increased risk of letting traffic flow unchecked through downtown heading directly at the dangerous rail crossing. Geoff Hyman voiced his concerns for AEB Bank's drive thru customers exiting onto SR 49 if the light only changes when traffic is sensed on Merrin St. Chad Benschneider asked ODOT for examples of cases where there have been lawsuits over placement of stop lights in which there wasn't enough traffic to justify a traffic light? This was one of ODOT's major reasons for denying the permit. The only case they could come up with was in Lima and the case was dropped before it went to court. It was also mentioned that the Payne Chamber along with the Antwerp Exchange Bank in co-

operation with the Village of

Payne recently invested vast

ing light on 49 with a red flasher on Townline. The answer was simply NO, ODOT finds that flashing lights are ignored shortly after being constructed. Then we asked if ODOT would consider a flashing school zone light on 49 near Divine Mercy School? The answer was NO citing that the school had to have property that had street frontage onto the highway to require such a light. The Village Solicitor Jim Sponseller spoke at length citing the Ohio Revised Code & the Traffic Manual stating that ODOT is using a very narrow interpretation of the code and that it is subjective to interpretation. The code states several times that ODOT "MAY" require the removal of traffic control devices which is the government's legal term that it can, but it isn't mandated or required. The Mayor stated that nearly one third of the traffic control manual is corrections and updates to the manual. The overall feeling is that something is driving this issue from special interest groups like the trucking industry to make these small rural towns have less control over their safety control devices. The likelihood is that unless we see several severe crashes at these intersections ODOT will likely keep this point of view. Let this be a warning to all the small towns that you are just one thunderstorm away from losing a part of

your town's identity. —Chad Benschneider,

2015 SPORT FISH CON-**SUMPTION ADVISORY RE-FLECTS SOME SIGNIFICANT IMPROVEMENTS**

Some Ohio waterways are showing signs of improvement based on sampling conducted for the 2015 sport fish consumption advisory. All "Do Not Eat" advisories for the Mahoning River have been removed and replaced with less stringent advisories described below. There are also improved advisories listed for Lake Erie, the Tiffin River and Findley Lake.

A total of 503 fish tissue samples collected from 16 lakes and 19 streams in 2013 form the basis for the new advisory. Fish consumption evaluations help Ohio anglers make informed decisions about consuming their catch. Fish low in contaminants can be an important part of a healthy diet.

A statewide advisory of one fish meal per week remains in place due to mercury. Fish contaminated with high levels of mercury have been shown to cause neurological damage and impaired development in young chil-

• Largemouth bass - one meal per week (previously one meal per month due to mercury).



Senator Cliff Hite (R-Findlay) announced the introduction of new legislation today regarding immunizations against meningitis.

Senate Bill 121 will require the Ohio Department of Health to prescribe a schedule for immunizations against bacterial meningitis. The Center for Disease Control currently recommends the vaccination to all students at ages 11 or 12, with a booster at age 16.

The bill comes as a follow-up to last year's Senate Bill 275, which created a statewide Meningitis Awareness Day, set for March 9. Senator Hite's niece, Tess Whitson, passed away within hours of contracting the disease.

"I am continuing my commitment to Tess and other victims by introducing this

bill. If we can prevent even one death with the passage of this bill, we will have made a difference," said Hite.

Senator Hite introduced the bill while speaking to the Immunization Advocacy Network of Ohio today, a group of vaccination advocates from around the state. They have previously supported the addition of meningitis to the list of required vaccinations for students.



Anglers can sign up now for a drawing to fish the Castalia Fish Hatchery in Erie County, according to the Ohio Department of Natural Resources (ODNR). A halfmile section of Cold Creek is open for select dates during 2015 to a limited number of designated anglers.

Controlled trout fishing is offered by the ODNR Division of Wildlife at the Castalia State Fish Hatchery from May 4 - November 30. No weekend or holiday fishing is available. The trout stocked in Cold Creek measure between 10-12 inches. Most of the fish are rainbow trout, although brown trout are also available. Random drawings for permit selection will be held in April. The results of the drawing will be posted at wil-

Anglers interested in this event must apply online in order to be eligible for a random drawing. Only one application is allowed per person. Anglers age 16 and older must hold a valid fishing license in order to apply and participate. Apply at wildohio.gov.

dohio.gov.

Two fishing seasons will be offered:

- Adults and teens 16 and older can fish from May 4 -June 12 and August 17 - November 30.
- A second season will be held for those 15 and younger from June 15 - August 14.

Youth sessions are 7:00-11:00 a.m. and 11:30 a.m.-3:30 p.m., and successful applicants will be assigned a session. Adult sessions are 7:00 a.m. - 12:00 p.m. Individuals selected to participate can bring two adults ages 16 and older and three youths ages 15 and younger (no more than six people total).

Special fishing rules will be in effect for this event to ensure a quality fishing experience. This includes a no catchand-release rule; anglers keep all fish they catch. The daily bag limit is five trout per angler. Anglers are required to check in at the hatchery upon arrival and check out at the end of their session.

The SFR is a partnership between federal and state government, industry, and anglers and boaters. When anglers purchase rods, reels, fishing tackle, fish finders and motor boat fuel, they pay an excise tax. The federal government collects these taxes, and the U. S. Fish and Wildlife Service administers and disburses these funds to state fish and wildlife agencies. These funds are used to acquire habitat, produce and stock fish, conduct research and surveys, provide aquatic education to youth, and secure and develop boat accesses.

THE SMELL OF SKUNK IS IN THE AIR!

like springtime, the snow has melted and the sun is shining and the familiar smells of spring are returning. Those familiar smells may include blooming flowers, fresh cut grass and even the unpleasant scent of skunks. You may not see the skunks, but you will be sure to smell their fragrant scent as the weather continues to warm up.

During the winter, skunks spend the majority of their time in their dens until the warm weather breaks.

Early spring is the peak breeding season for skunks. The skunks will mate in early March and they will have their young in May and June. Skunks have a gestation period of 60-75 days with an average litter size of three to ten of young baby skunks called

The skunk's main defense is a complex chemical substance that includes sulfuric acid that can be released when the animal is threatened. Because of this ability, skunks will stand and face a threat rather than run away. They may be able to face their threats but they don't stand a chance against cars.

Cars are the leading cause of death to skunks especially in areas of high traffic. Skunks may have a horrible smell that can linger for days once they spray, but they do serve a valuable purpose in our communities.

Skunks eat insects and small creatures such as mice that are considered pests to



THIRD TIME'S A CHARM, CLEMENS 6th AT STATE WRESTLING

The 2015 OHSAA state wrestling tournament was held this past weekend at the Jerome Schottenstein Center on the campus of The Ohio State University. Two Raider wrestlers, senior Tyler Showalter and junior George Clemens IV once again found themselves wrestling on the biggest stage in Ohio. This was Showalter's second trip and Clemens' third to the state wrestling tournament.

The Clemens' name is nothing new to the state wrestling tournament, and is actually synonymous with Paulding County wrestling. George Clemens Jr. started a wrestling club in Paulding County back in the 80's and began setting the foundation of what is today's wrestling landscape in the county, as many Paulding kids would begin their wrestling career in the Paulding County Wrestling Club.

George Clemens III, eldest son of Clemens Jr., began in this very club. He only went on to be the first ever state qualifier from Paulding High School and Paulding County. Luke Clemens was the next son to step onto the mat and only improved on what George Clemens III was able to accomplish. Luke was only a three-time state qualifier for the Panthers. Several other Paulding wrestlers made it to the state tournament, and most of them had some experience with a Clemens, either in the club, or at the Jr. High

George Clemens III then began the Wayne Trace Wrestling Club and in its inaugu-

ral year, had eight wrestlers. George Clemens IV began wrestling in this year, and Tyler Showalter started his wrestling career the second year of the club's existence. Clemens III then began his coaching career at Wayne Trace and eventually became the school's varsity wrestling coach when Dennis Stabler stepped down and became the Jr. High coach.

Wayne Trace and Dennis Stabler had its first ever state qualifier, Corbin Griffiths. Lucas Jacomet then became the second, and Stabler and Clemens III were the coaches in the chairs for both of these wrestlers; however, as the wrestlers that began in the WT Wrestling Club were beginning their high school careers, the number of wrestlers qualifying for the state tournament was about to explode.

Kameran Clemens was the next Clemens and Wayne Trace wrestler to grace the floor of the Shcottenstein Center. He made two trips to Columbus, but like his father and uncle before him, was unable to capture that extra win needed to be able to stand atop the podium. He was the first product of the Wayne Trace Wrestling Club to achieve this honor, but not

Dustin Taylor and Sawyer Temple were the next two. Dustin qualified once in his career and Sawyer was a twotime state qualifier. Temple placed his name in the record books as being the first ever Raider wrestler to place at state by garnering a 7th place finish and the work of beginning wrestlers at an early age was starting to show for Clemens III.

George Clemens IV made his first trip to the Schott in

his freshman year and was joined by Taylor and Temple as being the only year the red, white, and blue sent more than two wrestlers to state. Clemens IV was only the sixth wrestler from Wayne Trace to make the trip, but was unable to wrestle to a podium finish this year.

The following year, Tyler Showalter, yet another product of the WT Wrestling Club, joined Clemens IV, and the two wrestled on the floor of the Schott, but neither were able to garner a podium fin-

In arguably the toughest district in the state of Ohio, Clemens IV earned his third trip and Showalter his second to wrestle their last matches of the season, and Showalter's last matches of his career, in front of thousands at the state wrestling tournament. This also marked the fifth year in a row that Wayne Trace sent multiple wrestlers to the state wrestling tournament.

Showalter may be the oddity in wrestling today as wrestling comes second to football and in a sport that demands so much to be in the elite, most wrestlers will only focus on wresting and wrestle year round. The two sport stand outs dropped a close match to Josh Weber of Loudonville to open the tournament by a score of 9-7. He then followed that up by pinning Davidson of Eastwood in 44 seconds. Another win ensured a spot on the podium. He met Brandon Bates from Genoa in this match, and was up 6-2 when an aggressive move placed him out of position and eventually cost him the match.


"I am grateful that the last time I stepped on a wrestling mat was here. This is the biggest stage for an Ohio wrestler, wrestling against the top 16 kids in the state. Many seniors don't get the chance to even come here and compete, and I am just glad I had the opportunity to do it again," commented Showalter.

For Clemens IV, wrestling is his passion. He wrestles nearly 12 months a year and is driven by a desire to break what the family deemed the Clemens curse at the state wrestling tournament. When he stepped on the mat for his first match this year, it was the ninth time a Clemens attempted to place on the podium and his first match was be a tight one. He notched a 2-1 decision over Luke Coniker of Steubenville Catholic

Next up, he faced returning state placer Louis DeMarco of Gates Mills Hawken. With a win in this match, he could secure a spot that his uncle, and brother before him were unable to attain, a spot on the podium. It was a tight match, and as the clock ticked down, you could hear all Clemens' that had wrestled before yelling encouragement to the youngest of the family.

With seeing triple zeros on the time of the clock, and the score reading 9-5 in favor of Clemens, a huge weight was lifted off of the wrestling family from Paulding County, Ohio. Clemens IV was guaranteed a podium finish, but more importantly, he had done what no Clemens before him had been able to.

Clemens IV went on to wrestle very well the remainder of the tournament and dropped close decisions in matches with the very best that Ohio has to offer at 120



IDENTIFIES AN ADDITIONAL 145 NON-CITIZENS REGIS-TERED TO VOTE, REFERS 27 FOR ILLEGALLY CAST-ING BALLOTS

As part of a continuing effort to ensure only those eligible are registering to vote and casting ballots in Ohio, Secretary of State Jon Husted today announced his office has identified an additional 145 registered voters who are not citizens of the United States as required by law. Of these, 27 have been referred for further investigation and possible prosecution based on reported vote history in previous elections.

"No amount of voter fraud is acceptable and as the state's chief elections officer it is my responsibility to maintain our voter rolls and ensure only those who are eligible are participating in our elections," Secretary Husted said. "Every vote matters, especially given that 70 local elections have been decided by single vote or tied over the last 16 months."

The Secretary of State's office was able to identify these 145 individuals using information provided by the Ohio Bureau of Motor Vehicles (BMV) by virtue of the fact that in order to obtain a driver's license, someone who is residing in Ohio legally and not a citizen must provide documentation to the BMV. Records show that the individuals in question provided non-citizen documentation on at least two occasions. This is important because based on information the individuals themselves provided to the BMV, there is a greater degree of certainty that they were not citizens at the time they registered to vote.

In addition to the 27 individuals referred to the Attorney General, the Secretary of State's office also identified 118 non-citizens who are currently registered to vote in Ohio, but there is no evidence to show they ever cast a ballot. They have been sent letters requesting that they cancel their registrations if they are indeed not United States citizens.

This announcement is a continuation of Secretary Husted's work over the past four years to clean up Ohio's voter rolls through improved sharing of government-held data. In fact, he was the first Ohio Secretary of State to share data electronically with the BMV, which has made identifying non-citizens on the voter rolls possible.

The 145 individuals identified brings the number of non-citizens registered to vote in Ohio to 436. In December 2013, Secretary Husted found 17 non-citi-

voted illegally in the 2012 Presidential Election and an additional 274 non-citizens who registered to vote but there was no record of casting a ballot. The 17 cases were referred to the Ohio Attorney General's office for further investigation, which so far has resulted in four convictions. Letters were sent to the remaining 274 non-citizens, which has resulted in 96 voter registration cancellations, six individuals have become naturalized citizens, 63 were undeliverable and 109 remain under investigation by the Attorney General's office. Despite these efforts, the

Secretary of State's office does not have access to the resources necessary to identify all non-citizens on the rolls. This is due to the fact that many non-citizens have access to Social Security numbers, which under federal law can also be used to register to vote. President Barack Obama's recent Immigration Accountability Executive Actions will only exacerbate this problem by granting millions more access to this valid form of identification that can be used to register to vote.

In an attempt to address this issue before the executive actions are fully implemented, Secretary Husted recently wrote President Obama and testified before Congress to raise awareness about this matter and to ask the federal government to give states real-time access to accurate, searchable, electronic databases of non-citizens who have valid Social Security numbers so that they may distinguish between citizens and lawfully-present non-cit-

"I am committed to my responsibility to make it easy to vote and hard to cheat, and with the cooperation of the federal government we can do this without any additional burden on the voters," Secretary Husted said. "Without access to the information we need, this will continue to be an unresolved problem."

When it comes to improving the security and access of elections in Ohio, Secretary Husted continues to seek legislative authority to offer full online voter registration. This system would save the taxpayers money and create additional ease in participating in Ohio elections, but would also add an extra layer of security by allowing the state to instantaneously check voter eligibility before new voters are even placed on

"Maintaining accurate voter rolls is an important part of our ongoing mission to protect the integrity of our elections," Secretary Husted said. "I will continue to push for legislative authority to create an online voter registration system and access to all of the tools necessary to ensure that Ohio remains a national leader in election integrity."




