

LOCAL HIGH SCHOOL STUDENT, MAGGIE WILSON, **PARTICIPATES IN YOUTH TOUR 2015**



The Youth Tour 2015 for Ohio and West Virginia is a group of 36 juniors and seniors from Ohio; and 2 juniors and seniors from West Virginia who are members of their local Cooperative Electric Companys. Paulding-Putnam Electric Cooperative is Maggie Wilson's family's co-op. The kids were scattered all across the state ranging from small Paulding, Ohio like Maggie Wilson (Antwerp High School student) or larger towns like Oxford to the big cities of Columbus and Cincinnati. They were all brought together by a common source, the local electrical co-ops who sponsored all of their trips.

The local co-ops were the people who went through the process of choosing who was able to attend the trip and day conference. Anyone else who was interested in attending, filled out an application, then were sent a booklet and a test that had to be completed and sent back. Finally, the student goes through a personal interview process. Miss Wilson commented on this section of the selection process, "This was a good experience for me not only to practice for a job, but because of the opportunity it gave me."

After being chosen in March for the trip opportunity, participants started to receive information in the mail about the trip. This included things like dress code and itinerary. "The lead up to my trip was a very exciting and stressful time. I was nervous about going with so many strangers, but incredibly excited to meet these new and fascinating people," stated Wilson.

Maggie continued to recall the beginning of her trip with the following:

"When the day finally arrived for me to leave my mother, my sister and I drove to Columbus to Buckeye power for a lunch and a small send off. This was where I had my first interactions with my new best friends. Adam, the tour director, had us go around and announce our names, co-ops and school. After that we loaded the bus. This was the most nerve-wracking part of the trip because I had no idea who I would end up sharing a seat with. I saw a girl and asked if she wanted to sit with me and she accepted. Then I saw a familiar face and then another. Through the power of social media I had found a few of the other Youth Tour attendants and one of the girls sat behind me and the other I recognized immediately. She attends Fairview High School and we had been in long jump in Track & Field together for a number of years. With the four of us then... Caleb to my right and Sam in front of me, we soon could not stop talking. Weaver lead the discussion, explaining Weaver lead the discussion, explaining the Transportation Improvement District (TID). TIDs are set up in accordance to the Ohio Revised Code (ORC) Chapter 5540. Their purpose is to promote intergovernmental and pubic-private cooperation of transportation resources and investments to finance, construct maintain repair and operaconstruct, maintain, repair, and operation of a transportation project. In order to qualify for funding, counties must register with ODOT Division of Jobs and Commerce. Registration is in the spring of each year with applications for spring of each year with applications for projects made late spring of each year. Creation of a TID is done by a resolution by the Commissioners. The Commissioners then appoint the District Board of Trustees, consisting of five members plus one non-voting member from the House of Representatives and one from the Senate. Once registered as TID, counties may apply for assistance. one from the Senate. Once registered as a TID, counties may apply for assistance in funding transportation projects, following the application requirements. Mr. Weaver explained there are currently19 counties registered as TIDs with ODOT. ODOT's Office of Jobs and Commerce will award \$3.5 million of competitive grant funding to TID projects for SFY 2016. The total amount of funding provided for each fiscal year is

limited to 25% of the total project cost. formed the Commissioners that MVPO formed the Commissioners that MVPO will assist counties in the application process for no fee. He suggested creating the TID and appointing board members this fall so that plenty of time is permitted to complete the applications by spring for SFY 2017. Ms. Smith interjected with more counties creating a TID, ODOT will consider increasing the total amount of funding available. the total amount of funding available. Both Mr. Weaver and Ms. Smith encouraged the Commissioners to work closely with Paulding County Economic Development and the Paulding County Engineer to coordinate projects

Ed Bohn, Paulding County EMA – Mr. Bohn met with the Commissioners to update them on the storm that passed through Sunday afternoon. He reported there was damage to some homes and several trees were broken/uprooted. Mr. Bohn explained the storm developed in Paulding County as a result of oped in Paulding County as a result of the clashing of updraft and downdraft weather systems. He noted rainfall in the County ranged from .5" to 4". Ms. Bohn also reported the mitigation grant paperwork has been submitted to FEMA, Region #5, Chicago. He said the grant request is for \$25,000 to be used in case of natural disaster. Mr. Bohn in-formed the Commissioners that to his formed the Commissioners that, to his knowledge, all 18 weather sirens in the County are in working order. He also commented the new sirens are to be installed this week.

Thinking about the time it takes to travel from one place to another, robotic aids such as the Vita HD tremendously saves time and money, and most importantly, safety. A physician can see many more patients from the convenience of their office then could ever

happen in person.

One concern brought up was safety—technology has it's issues with hackers and leaks, especially brought to light with the Ashley Madison breakdown. Could this happen with these robotic aids? The hospital IT staff assured not only are firewalls in place, but so is SSL encrypted security to make sure the information is private between the doctor and the patient, including the video feed.

The shortage of doctors has brought this equipment to the forefront, endorsed by Medicare. Paulding, along with many other smaller hospitals struggle with this, not only in Ohio, but across the nation.

Randy mentioned that there are many uses for these new tools. The robots could be used in locations such as assisted living and nursing facilities to have share a doctor and be available all at the same time with the same doctor and potentially have the best access possible for all.

When will this begin to be used? "Right now," according to Randy. "We have had this in trial for the last few months and we are now bringing it out to active service." Randy, with nurse Theresa Breedlove and Dr. Kabour, demonstrated how this worked with Randy being the patient. Labour made suggestions to help Randy with his health. This will become more common as technology continues to improve.

Randy said how this is one of the biggest changes in medical history. He also answered what would happen if the data connections were disrupted. IT workers stated there are three live internet connections in the hospital at anyone one time. If one went down another would kick in to pickup the data transmission.

After his health check Randy demonstrated how he could control a similar model health aid robot in California. The software, whether on a PC, iPad, iPhone or other device could control the robot no matter there were as long as a there is a network/internet connection. Steering the robot through an emergency demonstration room it was obvious this could be used to further health options. Moving close to patients and double-platinum in the digital domain. 

'You have heard that our ancestors were told, 'You must not murder. If you commit murder, you are subject to judgment.' But I say, if you are even angry with someone, you are subject to judgment! If you call someone an idiot, you are in danger of being brought before the court. And if you curse someone, you are in danger of the fires of hell. ... "You have heard the commandment that says, 'You must not commit adultery.' But I say, anyone who even looks at a woman with lust has already committed adultery with her in his heart." Matthew 5:21-22, 5:27-28

Jesus in the Sermon on the Mount expanded on the commandments "You shall not murder" and "You shall not commit adultery." Jesus said that anger is breaking the commandment about murder and lusting is breaking the commandment about adultery. In effect, Jesus is saying just because you haven't actually killed someone or committed adultery with someone, you think you've kept the commandments. But if you're raging at someone, insulting someone or calling someone a fool, you're still missing the point about this commandment of murder. And if you are lusting after someone you are in effect missing the point about the commandment about adultery.

what you think, you are and that where the mind goes the body follows. All sins originate in the mind. These commandments and Jesus' commentary on them puts us on notice that anger leads to abuse and murder and that lust leads to fornication and The commandments not

USDA EXPANDS FARM SAFETY NET, OFFERS GREATER FLEXIBILITY FOR BEGINNING, ORGANIC & FRUIT & VEGETABLE **GROWERS**

Agriculture Deputy Secretary Krysta Harden today announced that Whole-Farm Revenue Protection insurance will be available in every county in the nation in 2016. The U.S. Department of Agriculture (USDA) is also making changes to the policy to help farmers and ranchers with diversified crops including beginning, organic, and fruit and vegetable growers, better access Whole-Farm Revenue Protection.

'Whole-Farm Revenue Protection insurance allows producers who have previously had limited access to a risk management safety net, to insure all of the commodities on their farm at once instead of one commodity at a time," said Deputy Secretary Krysta Harden. "That gives them the option of embracing

USDA also provided additional flexibility to producers by making the following changes, including:

- Beginning Farmers and Ranchers - RMA makes it easier for more beginning farmers and ranchers to participate in the program by reducing the required records from five to three historical years, plus farming records from the past year. Additionally, any beginning farmer and rancher may qualify by using the former farm operator's federal farm tax records if the beginning farmer or rancher assumes at least 90 percent of the farm operation
- Livestock Producers -RMA removed the previous cap that limited participants to those who received 35 percent or less of their income from livestock production. Producers will now be able to insure up to \$1 million worth of animals and animal prod-
- Expanding Operations - RMA increased the cap on historical revenue for expanding operations to 35 percent from its previous 10 percent to better allow growing farms the opportunity to cover their growth in the insurance guarantee.

A new school year has started and once again public schools across the U.S. are clamoring to control girls' bodies. The offender this time: my alma mater in Midwest Michigan. As of August 18, 2015, the district decided to prohibit the wearing of yoga pants, leggings and stretch pants when students return to the middle and high schools on September 8. The previous dress codes allowed these items as long as they were covered by another garment that was at least finger-tip length when students held their arms straight at their sides-basically, you could wear form-fitting pants as long as you wore something over top of them. Not surprisingly, students did not all follow that rule, which takes me back (way back) to my high school days when we thought it was imperative to wear shorts over our leggings. As is so often the case, the justification for such policy changes is framed as though it helps teachers and staff maintain an appropriate educational climate. The Superintendent commented, "We are not trying to impart style on our students ... We just want to eliminate disruptions and distractions." In reality, it seems these decisions are typically because someone or a vocal group alleges that "hormonal" boys cannot control themselves if they have to attend classes with girls who dare to show that they actually do have legs under their pants.

This district is by no means the first to adopt or consider adopting such a policy. Earlier this year, a North Dakota district determined that yoga pants were a "distraction," noting that they might prompt boys to "focus on something other than schoolwork." Evidently the school even asked students to watch the film "Pretty Woman" and compare their attire to the prostitute character played by Julia Roberts. Hundreds of middle school girls in Evanston, Illinois wore leggings to school in protest of a similar policy change. Students also held signs with slogans asking "Are my pants lowering your test scores?" More than 500 students signed a petition against

the dress code. In fall 2014, a group of students in New Jersey started the hashtag #Iammorethanadistraction to highlight the problems with school district policies that focus on girls

well as "any device, costume or covering that gives the appearance of or simulates the genitals, pubic hair, anus region, or pubic hair region." At a hearing about the bill, Moore announced "Yoga pants should be illegal in public anyway." In Missouri, state legislators decided that the problem was in that institution as well. They announced they are considering instituting a dress code for interns, ostensibly to "protect them" from sexual harass-This type of victim-blam-

ing couched in paternalism is deeply problematic. We can oppress you, it says, but it's for your own good. It's not a matter of whether schools should be allowed to institute dress codes. Of course, they can and should. But these policies are not about students, they are about girls. And they reinforce a dangerous logic that if a girl looks a certain way then she is the problem. Let's be clear - like all hu-

man beings, the bodies of women and girls vary dramatically. So, yes, some girls will fill out their pants differently than others, or their shorts will be shorter because, hey, imagine that, they are taller. This human diversity should not be policed, especially not in a culture in which many girls already suffer from dramatic self-esteem decreases in these years due to concerns about their bodies. Schools (and other institutions) should indeed be concerned about sexual harassment, but requiring that the would-be victims change their behavior instead of the would-be offenders merely allows the perpetrators to absolve themselves from re-

BARN BOOTS ARE A GOOD THING! AVIAN INFLUENZA WHAT PAULDING COUNTY **CITIZENS SHOULD KNOW?**

"It's a critical part of our countywide emergency preparedness plan," stated Sarah Noggle, Extension Educator for Agriculture and Natural Resources in Paulding County. "If Avian Influenza (AI) also known as the Bird Flu were to hit Paulding County it would be very devastating to our county as a whole."

Safety for our community members is our number one concern. Currently the two

"Barn Boots" and separate barn clothes to our backyard poultry growers. A person needs to designate a pair of shoes or boots and a set of clothes that are only going from the house to the chicken coop or barn. These boots and clothes need to be disinfected daily for the best protection against AI. The disinfection or washing process is important because Avian Influenza can be passed from the smallest particles on your clothes, under your fingernails and especially your shoes. The main carriers of AI are the water fowl migratory species. Avian Influenza virus par-

ticles can stay alive for days. I couldn't tell you all the steps I took a few days ago. For example, AI could be passed from other poultry producers shoes that didn't have "Barn Boots" and walked into the local gas station or grocery store to another backyard growers shoes. If that grower did not change shoes and quickly ran to the barn to feed and water their chickens, they could potentially infect their entire flock.

Cooper Farms are a major part of Paulding County agriculture and one could ask any of the employees at any of their facilities of the heightened biosecurity. These employees have designated boots, clothes and are even required to shower between barns multiple times during their work days. Their employees also cannot be around other poultry or poul-

In our emergency preparedness plan, we are asking our community members that have poultry to call or email the Extension Office at (419)399-8225. We also have available on online registration form that is quick and easy at go.osu.edu/pauldingpoultry. Information obtained will be kept confiden-

Avian Influenza has had an impact on one of our inschool 4-H programs for this year called Chick Quest. Statewide this program has been canceled for the calendar year 2015 and into 2016. Most people already know that Jr. Fair Poultry projects were not allowed to be exhibited at any county fair in Ohio. With Avian Influenza taking a terrible toll on egg laying

operations to the west, Ohio has moved to the top of the list of egg production by state. Some parts of the country are seeing egg shortages and increased prices as local suppliers are feeling the crunch of reduced layer numbers nationwide. The cost of a dozen eggs has increased \$.51 since April 30, 2015 according to the US Department of Labor Statistics. This has a spiral effect on foods like mayonnaise and ice cream.

Our overall goal at the Extension Office is education and preparation in the event Avian Influenza hits here in Paulding County. We want to create Better Lives and Stronger Communities for the citizens of Paulding County. This voluntary registration is just one of those ways to keep the citizens safe.

In the past few issues of this paper, I have brought to you some columns about a memorial in Rennes, France for a German Prisoner of War Train. There were some boys from Paulding County on that train, as well as my brother Jack. He is officially known as, "Garner Earl Jordan." There is a lady from Indiana named Jo Shipley who was going through an old trunk that belonged to her uncle after he had passed away. She used his name and serial number, and contacted the Vets Admin. in St. Louis, and she was given a lot of government papers that were old and had been de-classified by the government.

She was given the papers about the German Prisoner of War train in Rennes, France, because her uncle was on that train, also. The box cars were loaded to 120 people in each car. 8 American aircrafts strafed the trains twice and killed a number of soldiers and wounded 70 more. M/S Shipley travelled to Rennes, France a few times and talked to some people about this prisoner train and the fact that these townspeople had made a me-

morial for this train to honor these boys. The Germans did not supply the 1300 people on the train with food or water. There was a bridge out down the line and the train could not be moved, and it was stifling hot outside and almost unbearable inside the box car. After a few hours, the peo-

ple of Rennes got permission to bring some relief to the prisoners. They brought water, bread and fruit, and this went on most of the night. The local people of Rennes have made a memorial for the prisoners for that train. It is one of those box cars of that time and it is painted and kept in good repair by the citizens of that area.

M/S Shipley has made a number of trips to France and has talked to those people and visited the hospital where her uncle was a patient, and some of the nurses who were there. Even talked to some old-timers who were present there 70 years ago. M/S Shipley sent pictures and stories to the Jordan family about that area and times. We are so grateful to her for thinking about Jack and his family. He passed away back in 2002.



USDA UNVEILS NEW STRATEGY TO CONSERVE SAGE GROUSE HABITAT ON PRIVATE LANDS

Agriculture Secretary Tom Vilsack announced a four-year strategy that will invest approximately \$211 million through 2018 in conservation efforts to benefit the greater sage grouse. The strategy, known as Sage Grouse Initiative 2.0, will build on successful public and private conservation efforts made since 2010 to improve sage grouse habitat. The new plan will provide additional assistance for ranchers to make conservation improvements to their land, which mutually benefits the iconic bird and agricultural operations in 11 Western states.

"The Sage Grouse Initiative has proven itself as a model for how wildlife and agriculture can coexist and thrive in harmony, and that is why we are announcing steps

today that will expand this important initiative throughout the life of the 2014 Farm Bill," said Vilsack. "I applaud America's ranchers for their initiative in improving habitats and outcomes for sage grouse and other wildlife, and for their recognition that these efforts are also good for cattle, good for ranching operations, and good for America's rural economy."

Since its launch in 2010, public and private partners engaged in the Sage Grouse Initiative (SGI) have conserved 4.4 million acres, an area twice the size of Yellowstone National Park, using voluntary and incentive-based approaches for conservation. Between 2010 and 2014, USDA's Natural Resources Conservation Service (NRCS) invested \$296.5 million into SGI, which partners matched with an additional \$198 million. By the end of 2018 with implementation of the SGI 2.0 strategy, NRCS



and partners will invest approximately \$760 million and conserve 8 million acres, an area more than seven times the size of the Great Salt Lake.

NRCS leaders from California, Colorado, Idaho, Montana, Nevada, North Dakota, Oregon, South Dakota, Utah, Washington and Wyoming worked with conservation partners to develop the four-year strategy.

The wildfires devastating Western communities also impact habitat for wildlife like sage grouse. Under the SGI 2.0 strategy, NRCS will focus on reducing the threat of wildfire and spread of invasive grasses after fires to restore wildlife habitat and quality livestock forage. The strategy will also focus on removing encroaching conifers, protecting rangeland from exurban development and cultivation, protecting mesic habitats like wet meadows, and reducing fence collisions. While in Oregon, Vilsack

will meet with conservation partners, ranchers, and government officials who have worked through SGI to conserve sage grouse habitat. Oregon has seen success in sage grouse habitat conservation, especially through the targeted removal of conifer trees that invade sagebrush habitat. Through SGI, NRCS has helped Oregon ranchers address more than two-thirds of the conifer problem on private lands in the state's priority areas, and with SGI 2.0, anticipates 95 percent removal on priority private lands by 2018.

"The Sage Grouse Initiative is making a difference because private landowners voluntarily work with us to produce results on the ground," Vilsack said. "The decisions Western ranchers and other private landowners make every day about what to do on their land will continue to have a critical impact on sage grouse."

SGI conservation practices are targeted to ensure maximum benefits in the areas where they are implemented, and this focus will continue in SGI 2.0. During the past five years, SGI has increased conservation easements 18fold and strategically located them in priority landscapes that contain the majority of the birds. These easements not only protect important lands but help stitch together the broader landscape, connecting public and private lands into a footprint of healthy habitats.

These voluntary conservation practices work. Earlier this year, the U.S. Fish and Wildlife Service (FWS) determined the Bi-State sagegrouse, a subpopulation of the greater sage-grouse along the California-Nevada border, did not require listing because of the conservation efforts of NRCS and partners proactively working to conserve the species. This success is seen nationwide, evidenced in the recent decisions not to list the Arctic grayling in Montana, the proposed delisting of the black bear in Louisiana, and the recent delisting of the Oregon chub.

The deteriorating health of the sagebrush habitat and the greater sage-grouse has sparked an unprecedented, collaborative federal-state partnership. This comprehensive approach includes strong conservation plans for state and private lands, strong federal conservation plans, and

If you're not aware, COPA stands for Co-op Owners for Political Action and their political action committee is ACRE®. which stands for the Action Committee for Rural Electrification. ACRE® protects the interests of cooperatives and their member-owners. The political action committee fights to keep electric rates affordable.

Ohio Congressman Bob Latta was the featured speaker and discussed the issues facing the electrical industry. "This is a fight for survival, to make sure we have power in this country ... It's up to us. It's a constant fight, and we will keep at it. This administration doesn't want any coal, zero. For states that are coal dependent like Ohio and In-

diana, it becomes our prob-

The Clean Power Plan has regulations that will cut carbon emissions at existing power plants 32 percent from 2005 levels. The goal is higher than what was originally proposed. Latta warned those in attendance that the regulations do not just effect power producers and homeowners but businesses as well. If plants have to shut down because they cannot reach those levels, it is possible that blackouts will happen. "You just can't shut off power to a steel plant," he said.

George Carter, CEO/ GM at Paulding Putnam Electric Cooperative, said when he looked at the White House release about the new EPA regulations he was struck by the fact that the ag department and rural America were not among the list of those responsible

for overseeing how it was implemented. "That is one thing we need to fight for," he said. "We really need to push for equal treatment on ĥow rural American is dealt with."

Darin Thorp, president of North Western Electric Cooperative, statement is similar in nature, "If you take a look at energy production by state, the east coast and west coast won't be affected by this," he said. "The coal plants we have today we've had to spend \$1.1-\$1.2 billion to get to this level. They say natural gas is the way (to help alleviate power concerns), but the EPA put more regulations on that last week. They want renewable (only). The restrictions are harder than before. We need everyone to step up and send emails to our government."

Steve Thomson, State Wildlife Officer Supervisor in northwest Ohio, was recently named Ohio Wildlife Officer of the Year by the Shikar-Safari Club International, according to the Ohio Department of Natural Resources (ODNR). Officer Thomson is an ex-

perienced veteran employee with over 20 years of service in wildlife and natural resources law enforcement. A graduate of the 19th Wildlife Officer Training Academy in 1993, he has worked as a wildlife officer assigned to Allen and Erie Counties and was promoted to an investigator positon in 2002. Recently, Officer Thomson has

been promoted to Unit Supervisor, where he will oversee several counties in northwest Although Officer Thomson

primarily works in northwest Ohio and along Lake Erie, his influence extends throughout the state. Thomson is an instructor on the ODNR Division of Wildlife's law enforcement training team. Officer Thomson's primary expertise is in firearms training and crime scene investigation and he spends countless hours training officers throughout Ohio.

As an investigator, Thomson has been assigned to many of the more difficult and complex cases, especially those that involve serious offenses, state property damage, and commercialization of wildlife. Officer Thomson serves as a jurisdictional representative to the North American Wildlife Enforcement Officers Association (NA WEOA). NA WEOA is a professional organization of wildlife officers from across the United States and Canada.

The Shikar-Safari Club International was founded in 1952 by an international group of hunters interested in exchanging ideas about the sport. Each year the club sponsors an award for the wildlife officer of the year in all 50 states, 10 Canadian provinces, and the territories of both nations. In 1966, the Shikar-Safari International Foundation was formed to support various wildlife conservation projects with funds raised by club members.





of mosquitoes due to our extra wet spring and summer. Staci Miller, Education Specialist taught the residents the different life cycles a mosquito goes through before it becomes an adult mosquito. Mosquitoes have six legs. They also have a head, thorax and abdomen. On the head are two large compound eyes, two simple eyes, two antennae and a proboscis. Two large, scaled wings sprout from the thorax. Male mosquitoes locate females by the sound of their wings. Females can beat their wings up to 500 times per second, and the males pick out the higher frequency of those

beats when seeking a mate. Female mosquitoes can lay up to 300 eggs at a time. The eggs are deposited in clusters called rafts on the surface of stagnant water, or they are laid in areas that flood regularly. Eggs can hatch in as little as an inch of standing water.

Mosquitoes spend their first 10 days in water. Water is necessary for the eggs to hatch into larvae, called wigglers. Wigglers feed on organic matter in stagnant water and breathe oxygen from the surface. Then they develop into pupae, which do not feed and are encased in cocoons. Over the few days, the pupae change into adult mosquitoes. The entire life cycle process can take between 10-30 days depending on the temperature of the environment. Mosquitoes are cold-blooded and prefer temperatures over 80 degrees. The average mosquito lifespan is less than two months. Males have the shortest lives, usually 10 days or less, and

females can live about six to eight weeks, under ideal conditions.

Due to the abundant rainfall this year, there have been reports of the West Nile Virus in Northwest Ohio. West Nile virus came to the U.S. in 1999. Scientists first identified it in a feverish woman in Uganda - the West Nile district - in 1937. There were large outbreaks of the virus reported in Israel, South Africa, and Romania up through the late '90s. The virus first appeared in the United States in 1999 with an epidemic in New York.

Mosquitoes have strong senses which help them to find and locate their next meal. Mosquitoes can smell human breath. They have receptors on their antennae that detect the carbon dioxide released when humans exhale. Those plumes of CO2 rise into the air, acting as trails that the mosquitoes follow to find the source. Sweat also helps mosquitoes choose their victims. Our skin produces more than 340 chemical odors, and some of them smell like dinner to mosquitoes. The chemical octenol, released in our sweat, as well as cholesterol, folic acid, certain bacteria, skin lotions, and perfume can attract them. Body heat also enables them to help mark their next target. Mosquitoes use heat sensors around their mouthparts to detect the warmth of your body and the blood inside it then land on you and locate the best capillaries for tap-

Only female mosquitoes bite people using her proboscis which is a long, pointed mouthpart that is serrated to pierce the skin and locate a capillary. While one tube of the proboscis draws blood, a second pumps in saliva containing a mild painkiller and an anti-coagulant. The saliva causes the bump and the annoying itching. DEET is considered the 'gold standard' of mosquito repellents. Endorsed by the Centers for Disease Control (CDC), DEET doesn't mask the smell of the host, the mosquitoes simply don't like it because it smells bad to them.

the residents learned all about mosquitoes, they each got to make their own mosquitoes using suckers, pipe cleaners and tissue paper. Staci told the residents that instead of the mosquitoes sucking your blood, if you got tired of your mosquitoes you could suck their blood since their bodies are suckers!

his life to the service of his country. From his heroism on the shores of Normandy, to his advocacy for fellow veterans in Wyandot County, Mr. Shull exemplified his generation and their commitment to protect the freedoms that define America. As we mourn the loss of such a great member of our community, we commemorate the long and distinguished life he led."

About Mr. Shull Mr. Shull was drafted

into the military on February 9, 1942, and was stationed at Fort Bragg in North Carolina. His service was the only time he had lived outside of what is today's Fifth Congressional District of Ohio. He served in the Ninth Infantry Division, 34th Field Artillery Battalion - one of the first to go onshore in North Africa.

During the D-Day invasion, Mr. Shull landed on Utah Beach, from where he fought through France, Belgium and Germany. His division participated in eight major battles throughout

For his service in France, Mr. Shull was awarded the French Legion of Honor. The award is the highest accolade given by the French government.

Mr. Shull was honorably discharged on June 21, 1945, and remained active in the veterans community ever since. He held many positions in American Legion Post 225, including Commander and Finance Officer. He also served for 40 years on the Post's Honor Guard, and the Wyandot County Veteran Service Commission, of which he was selected and appointed in August 1985.


