



To further enhance patient experience and the efficiency of its emergency departments and urgent care clinics, Lutheran Health Network is now offering a digital option to let patients tell staff at LHN facilities that they are on the

The new "Tell Us You're Coming" feature allows individuals to notify an LHN emergency department or RediMed urgent care clinic in advance of their pending arrival. Facility staff use submitted information to better prepare for patients' care upon their arrival. Staff can also greet patients by name and acknowledge their symptoms, which can put patients at ease and improve their experience.

"Tell Us You're Coming" can be easily accessed on the home page of Lutheran-Health.net in the QuickER section or via an app called iTriage. Using iTriage, patients may click on the Facilities icon on the first screen and then click on the Emergency Department icon. Orange "Tell Us You're Coming" tabs are visible under the hospital EDs where the option is available.

"Tell Us You're Coming" does not schedule an appointment for patients or let them move ahead of other patients. All patients are cared for based on the acuity of their condition, whether the option was utilized or not.

Providers can use a referral feature to notify a Lutheran Health Network emergency department of an incoming patient. Physicians or medical staff can use an "Additional Information" field to provide relevant patient details.

iTriage is an easy-to-use smartphone and online application that allows users to locate vital medical information and local medical services on their smartphones and computers via step-bystep navigation, whether at home or on the road.

Lutheran Health Network added the "Tell Us You're Coming" feature in mid-December. Since then, an average of five patients visiting the adult and pediatric ERs at Lutheran Hospital have used the feature daily. LHN has been a local advocate of iTriage for more than a year. #### THE MOST FAMOUS **GROUNDHOG OF ALL!**

February 2<sup>nd</sup> marked Groundhog Day, featuring the famous rodent meteorologist Punxsutawney Phil predicting our weather forecast for the next six weeks. The first Groundhogs Day happened on February 2, 1887 in Gobbler's Knob in Punxsutawney, PA. Groundhog Day got its roots from the ancient Christian tradition of Candlemas Day, where clergy would bless and distribute candles needed for winter. The candles represented how long and cold the winter would be. The German's began their own tradition by selecting a hedgehog to predict the weather. As German's came to America, the settlers continued the tradition but selected a groundhog as their rodent meteorologist because they were plentiful in Pennsylvania according to history.com.

Punxsutawney Phil is a groundhog but also can be called a woodchuck with a scientific name of Marmota monax. A typical groundhog weighs 12 to 15 pounds with a life span of six to eight years. Punxsutawney Phil weighs about 20 pounds and is 22 inches long. He is a rather large and a well fed groundhog.

Groundhogs are covered with coarse grayish hairs (fur), tipped with brown or sometimes dull red. They have short ears, a short tail, short legs, and are surprisingly quick. Their jaws are exceptionally strong. A groundhog's diet consists of lots of greens, fruits, and vegetables and very little water. Most of their liquids come from dewy leaves. A groundhog can whistle when it is alarmed. Groundhogs also whistle in the spring when they begin

A dip in these rivers on auspicious dates during the Kumbh is said to rid pilgrims of their

graduates stay in Indiana, further contributing to the state's economy.

IPFW is trying to increase the percentage of graduates in the field of science and technology due to its close partnership with Purdue University. Daniels supports this new change of designation by explaining that this new title will provide for a closer match between the nature of IPFW's degree production and the state's performance funding formula.

Opponents see this as a proposition that will keep students in the region from having the option of obtaining either Indiana University (IU) or Purdue University degrees while remaining in a location that is convenient for them. However, this concern has not emerged in similar cases. For instance, Indiana University-Purdue University Indianapolis is considered a Metropolitan University and still allows students to obtain either an Indiana University or Purdue University

**SECRETARY OF STATE HUSTED TO PRESIDENT OBAMA: EXECUTIVE AC-**TIONS ON IMMIGRATION **INCREASE POTENTIAL FOR NON-CITIZEN REGISTRA-TIONS & VOTING** 

In a recent letter to President Barack Obama, Ohio Secretary of State Jon Husted raised concerns that the President's Immigration Accountability Executive Actions may have implications on the integrity of elections. These executive actions increase the potential that non-citizens may illegally register and vote by granting millions more access to the valid forms of identification used to register "As chief elections official

in a key swing state, I take very seriously my responsibility to make it both easy to vote and hard to cheat by ensuring that only eligible voters may participate in federal, state and local elections," Secretary Husted said. "Despite our diligence in cleaning up Ohio's voter registration rolls over the past four years, the President's executive actions have expanded a loophole and made it more difficult for us to determine if potential registrants meet the primary standard for voting - U.S. cit-

Under federal law, any person with a valid Social Security number or driver's license can register to vote, provided they attest to their eligibility. The recent executive actions would expand the risk for illegal voter registrations in Ohio and other states by non-citizen voters who have valid forms of identification and who willingly or negligently affirm their eligibility to vote.

Should the executive actions remain in force, Secretary Husted is asking that President Obama's Administration provide state elections officials real-time access to accurate, searchable, electronic databases of non-citizens who have valid Social Security numbers so that they may distinguish between citizens and lawfully-present non-citizens.

In his letter to President Obama, Secretary Husted noted that the ongoing debate over voter fraud and voter access has bred significant hyperbole from across the political spectrum, eroding voter confidence. After issuing the first statewide report of voter fraud and voter suppression, and conducting a thorough review of Ohio's voting rolls, Secretary Husted has consistently maintained that while voter fraud does exist, it is rare and he has taken many steps to modernize Ohio's elections system to prevent fraud in the future.

For example, following the 2012 Presidential Election and through a data-sharing partnership with the Ohio Bureau of Motor Vehicles, Secretary Husted determined that in Ohio, 291 non-citizens were registered to vote and 17 had actually cast ballots. The 17 were referred for further investigation and potential prosecution and the rest were sent letters to cancel their Ohio voter registrations.

'We have been careful to uncover the facts, to be transparent with the data, and then to take reasonable steps to improve our elections system and boost voter confidence," Secretary Husted said. "The President's executive actions have the potential to roll back progress we have made in Ohio. It is my hope that he will work with us to minimize their impact on the integrity of our elections."

This is June 27, 1944. The invasion has been on now for three weeks. We have a good foot-hold in France, but we are hung up here in the Caen area. The Germans are protecting this town to the last man. It is a very important rail and highway junction. The English Field Marshall, Montgomery, has attempted to take this town a number of times, but has been pushed back each time. Both sides have lost a lot of men and equipment here. The troops going north towards Belgium along the coastal area are doing a little better, but the Germans are determined to keep this area as long as they can. We spent most of the morning around Caen and the St. Lo area. We got a couple tiger-tanks and a few smaller ones. We also shot a convoy of supply trucks pretty hard. We used our cannons and machine guns on the hedgerow area. The going there is very

On our sortie this afternoon around the Caen area, they were waiting for us. Our planes all took a lot of ground fire. No ack-ack burst but small arms fire was so thick, you could have walked on it. But we managed to knock some of the positions out of commission.

Here in the barracks tonight, we discussed the dawn patrol. The Col. came over and filled out all the papers that needed to be done. Lt. Nelson from Grafton, Minn. got a package through the mail today. It was a good sized piece of cheese and a lot of crackers. We were having a ball with the goodies and all the crewmen came in. They had patched up all the holes in the airplanes and had them ready for the dawn patrol tomorrow. Well, we talked and played a card game called, "Hearts" and all helped put the cheese and crackers away. We played cards quite late even though we had a very early breakfast tomorrow.

#### **BLOODY BILL ANDERSON, WILLIAM QUANTRILL AT LAWRENCE KANSAS**

Quantrill's Raiders, a lawless army of 300-400 riders, rode into Lawrence Kansas at dawn, August 21, 1863. They were a band of hoodlums, some dressed in the army clothes of the Confederacy, but they were killers, not soldiers.

They rounded up all the women and held them as hostages and made the men bring in all of their guns and arms of any type and put them in a wagon or they would kill the women. All the businesses were robbed and the loot was loaded into wagons that belonged to the people. There were about 1,600 people living in Lawrence in that time. The men were helpless. They were rounded up along with all the young boys and were shot dead in the streets. Around 200 men and boys were killed that day. This was done right in front of the wives and daughters, and then they burned the town.

Lawrence was considered a town of Northern sympathizers and Quantrill was supposed to be Confederate soldiers, but they were merely a band of robbers, murderers and cut-throats, living off of the loot from the towns they robbed. Bloody Bill Anderson was a Lt. under Quantrill, but a much meaner and bloody killer who hated any and all people who were from the North and the U.S. govern-

This went on for over three years. There was another bloody ambush called the Centrailia Missouri Massacre. It was considered the Confederate gorilla's most brutal and deadly action.

They were able to capture a passenger train in Centrailia, and then kill 24 Union soldiers in cold blood who were riding on the train. Then, they sat up an ambush and killed over 100 Northern soldiers. Anderson was a psychotic killer and to take a life meant nothing to him. He was killed about a month later in another robbery in Albany, MO. He was about 23 or 24 years old.

Some people thought of him as another Robin Hood, as he killed any and all Northern sympathizers he could find. But, he was just a sadistic killer who was on a revenge binge. It has been written that he killed 49 men by himself. Southern sympathizers in Missouri saw his action as justified for revenge. But, to me, he was just a plain murderer and mayhem.

#### **OHIO HUNTERS CHECK MORE THAN 175,000 DEER** IN 2014-2015

Ohio's white-tailed deer archery season closed Sunday, February 1, marking the end of Ohio's 2014-2015 deer hunting season. Across the state, hunters checked a total of 175,745 deer during all 2014-2015 hunting seasons.

In the last few years, through increased deer harvests, dramatic strides have been made in many counties to approach acceptable populations. The effectiveness of these management efforts are reflected in the decreased number of deer checked this season. During the 2013-2014 hunting season, Ohio hunters checked 191,455 deer. Bag limits were reduced in 46 counties prior to the 2014-2015 deer hunting season, and antlerless permits were eliminated in 29

will be revised this summer through a random survey of hunters and farmers. Participants in the survey will have the opportunity to provide input about the future of deer management in Ohio.

The Ohio counties that reported the most checked deer for all implements during the 2014-2015 season: Coshocton (5,727), Licking (5,281), Tuscarawas (4,883), Muskingum (4,748), Ashtabula (4,418), Knox (4,191), Guernsey (4,181), Holmes (3,625), Harrison (3,448) and Carroll (3,406). Coshocton County also reported the most deer harvested in 2013-2014 (6,270).

Ohio ranks fifth nationally in resident hunters and 11th in the number of jobs associated with hunting-related industries. Hunting has a more than \$853 million economic impact in Ohio through the sale of equipment, fuel, food, lodging and more, according to the National Shooting Sports Foundation's Hunting in America: An Economic Force for Conservation publication.

The ODNR Division of Wildlife remains committed to properly managing Ohio's deer populations through a combination of regulatory and programmatic changes. The goal of Ohio's Deer Management Program is to provide a deer population that maximizes recreational opportunities, while minimizing conflicts with landowners and motorists. This ensures that Ohio's deer herd is maintained at a level that is both acceptable to most, and biologically

Find more information about deer hunting in the Ohio 2014-2015 Hunting and Trapping Regulations or at wildohio.gov. A detailed deer harvest report was posted online each Wednesday during the season.

Hunters continue to utilize various methods to report deer kills. Since the deer season began on Sept. 27, 2014, 46 percent of hunters phoned in their report, 29 percent reported online, 15 percent used the mobile-friendly website and 9 percent traveled to a license agent's location.

Ohio's first modern day deer-gun season opened in 1943 in three counties, and hunters checked 168 deer. Deer hunting was allowed in all 88 counties in 1956, and hunters harvested 3,911 deer during the one-week season.



#### **JARETT BUTE MAKES ANTWERP WRESTLING HISTORY**

Antwerp High School Wrestling team recently competed at the GMC Championships on February 7, 2015. Antwerp had a very productive day as 3 of the 4 Archer wrestlers were able to place in the top 4 of their respective weight classes. Sophomore Logan Shaner went 3-1 with 2 pins on the day to earn himself a 3<sup>rd</sup> place finish at 132 pounds. Junior Justice Clark went 1-1 on the day to finish 2nd at 152 pounds. This is Justice's 2<sup>nd</sup> runner-up finish at the GMC tournament for his career thus far. Senior Jarett Bute made Antwerp Wrestling history on Saturday by becoming the first high school wrestler at Antwerp to earn a GMC Championship! Bute finished the day 2-0 with 1 pin and 1 major decision. Jarett's hard work not only this year, but throughout his entire career have earned him the right to be called a champion. He truly lives by the motto "You only deserve what you earn." The Antwerp Wrestling community are proud of all high school wrestlers for their hard work and leadership week in and week out.

#### FINALLY! RAIDER WRES-TLERS GMC CHAMPS!

If you were to enter the new Wayne Trace wrestling room you would see district qualifiers and state qualifiers posted on the wall. In addition to those names, you would read sayings such as "finally" and "hard work beats talent, when talent doesn't work." If one were to ask Coach George Clemens what his accomplishments have been with his squads, he would likely go through a check list of the last few years and team's accomplishments of tournament wins, sectional champs, district qualifiers, and state qualifiers and the Raider's one state placer. Unfortunately, a GMC title would not be on that list.

The 2015 team, boasting probably the winningest class of wrestlers for Wayne Trace, the senior class that captured back to back Jr. High GMC titles, have their sights set on that ever eluding goal. To chase down that dream of both wrestler and coach, you need to have multiple champions and as many placers as possible in each weight. For one reason or another, previous teams had fallen just short, finishing runners up the last few years, but that has changed.

"It's not always how your most talented or experienced wrestler does at the league tournament, but how the wrestler that could pull off an upset, the one that could just be one place higher at the end of the day does," stated Coach Clemens. "We stressed all week long how important bonus points would be and how we had to win key match ups. We knew it was likely going

to be a two team race between us and Tinora, and we had to make sure to win all head to head match ups with anyone wearing a green singlet."

Wayne Trace opened up the opening round rat tails and only dropped a couple of matches. They were aggressive from the start and lead after those first few matches. The second round, however, was the pivotal round with wins placing wrestlers in the championship match. The Raiders faired very well in this round, finding the team having seven wrestlers advance to the championship match and was just as importantly three battles back and found themselves wrestling for third. Before heading into the finals, Wayne Trace held a slim 3

point lead over Tinora. Max Rassman started the finals off for the red, white, and blue at 113 pounds. Max squared off against Martin Steinberger of Tinora. This was a huge head to head match. Martin found himself up early in the match, but Max battled, gained position, and the crowd erupted when Max put the Tinora wrestler on his back and pinned him in the second period to earn his first GMC championship as a freshman.

George Clemens took the mat next and faced Trystan Jordan from Edgerton. George came out aggressive and put points up with takedowns and back points from his leg style of wrestling. He continued to push the pace and took this match with a major decision, 15-2. George became a three time GMC champion as a junior.

Still remaining in the same chairs at the championship match for their third

consecutive match, coach Clemens and Goeltzenleuchter watched Ruger Goeltzenleuchter battle with Justin Howard of Ayersville. Ruger worked his typical style of dumps and knee taps for takedowns and his turks for back points and finished off his opponent with a tech fall, 18-3, to earn his first GMC crown as a sophomore.

With Coach Clemens and Nielson taking a round off, they were on the third place mat. Caleb Schultz garnered another victory for Wayne Trace after defeating Ayersville's Gage Bergeon with a decision of 12-5 and placing third in the conference. Heading back to the

championship match for the 145 pound finals, Zaine Cotterman faced Bobby Kelly of Fairview. Zaine had already upset CJ Higbea from Tinora and now faced off against the number one seed, #14 state ranked, and returning GMC champ Kelly. Cotterman was runner-up to Kelly last year. "We had a game plan against Kelly. We wanted to keep it close, be patient, and try to score off of his go-to shot," stated Clemens. In the most exciting match of the day, Cotterman followed his coach's script, and battled to the final 20 seconds of the match and found himself tied at 9-9. Wrestling from the bottom, Cotterman went up and almost out before Kelly maintaining control; however, with a mere 5 seconds on the clock, Cotterman exploded again and worked on escaping. Kelly lost control and in desperation locked hands around Cottermans ankles, was called for clasping, and Cotterman earned the upset and was a GMC champion his senior year.

After some injuries incurred off of the mat, 152 pounder Tyler Showalter barely made it through his first match of the day. While sitting in the hall with his chest iced, Coach Clemens told Tyler he could scratch and save himself for the sectional tournament. Tyler's response summed up all the wrestlers mentality for the day, "I have been to the Schott. We have done everything except for this. Winning GMC's is more important to me and I want to win one for him (Clemens)." Tyler continued to wrestle and captured his second GMC crown defeating Justice Clark of Antwerp by

tech fall, 17-2. Following that win, and the momentum continuing for Wayne Trace, Jacob Dingus stepped on the mat against Chris Hahn from Tinora. Another pivotal match head to head against the team trailing the Raiders. Dingus found himself down early, but battled back and made a late push with a takedown, and then turned Hahn to his back and got the pin for the win.

Brandon Laney followed up that win with a win of his own over Burton Bassett of Fairview. Laney battled back through the consi's and controled his third place match from start to finish. Again, adding valuable placement points for the Raider team at 170 pounds.

Josh Reel stepped onto the mats at Fairview for his last GMC tournament and pinned both of his first two opponents, Nolan Garner of Tinora and Hunter Stark of Ayersville. Yet again, a win over a wrestler in a green

singlet. He dropped his finals match in a hard fought contest to Chase Carpenter of Fairview, but went a runner-up for the day.

The Raiders last finalist of the day was freshman Braxton Asher. Braxton dropped a match to eventual GMC champion Gavin Saul of Fairview. He then picked up a win in the consi's to propel him to his finals match; however, he fell short in that third place match and was a fourth place finisher his freshman year. The Raider wrestlers end-

ed up dominating the finals matches, winning 8 of 10 and finishing with an all time record six individual champions. With the two head to head matches over Tinora wrestlers and the dominant performance in the finals, Wayne Trace distanced themselves from Tinora and won their first ever GMC title. In the process, Zaine Cotterman named the GMC most outstanding wrestler with his efforts on the day by upsetting the #2 seed, and followed that up with his thrilling win over state ranked and returning GMC champion Bobby Kelly.

"This is what we wanted. We wanted to get a title for Coach Clemens. After all the hours he has put into this program, and where he has taken wrestling at Wayne Trace, we just wanted to finish this for him. We all went out and wrestled with our hearts and gut, like he had asked us to do, and now we can walk into our gym and see a GMC champion wrestling banner hanging on the wall," commented Tyler Showalter after the celebrations were over.

"Finally" as the wall in the wrestling room at Wayne Trace reads, the last goal that had been previously unattainable can now be checked off of the list and the wrestlers can now prepare for a state run.

#### CLEAR WALKWAYS AND AREAS AROUND MAILBOX-ES OF SNOW & ICE FOR SAFETY OF MAIL CARRIERS

With the recent snowfall, Postal Service carriers will attempt to make deliveries wherever possible. The Northern Ohio District is asking customers to help with the safe delivery of mail by keeping walkways and sidewalks clear from snow and ice. In past winter storm events, Postal carriers have suffered serious injuries related to slips, trips and falls due to icy and snow covered walkways and porch steps.

Letter carriers are instructed to use good judgment, if a potential hazard exists, and to hold mail to addresses where ice and snow are not cleared. "No one wants to inconvenience the customer," Northern Ohio District Manager Melvin J. Anderson said. "However, we must ensure the safety of our employees."

The Postal Service is asking customers to help keep their letter carrier safe this winter through the following actions:

• Clear enough snow from curbside boxes to allow mail trucks to approach the box, deliver the mail and to drive away from the box without danger of the need

• Walkways should be cleared of snow and ice and allow enough traction to avoid slips, trips or falls.

• Steps should also be kept clear of ice and snow and in good repair so as not to cause injury to the letter carriers or others who visit the customer's home.

• Overhangs should be clear and free of snow and ice to avoid injury.

The proposed bill has been identified as a legislative priority for the Ohio House of Representatives by Speaker Cliff Rosenberger (R-Clarksville) and the majority leadership team. "This proposal is a success

dividend. We are doing more with less in the Secretary of State's Office, providing the best possible customer service, which has led to record business filings and increased revenues. Now we want to pass the savings on to our customers," Secretary Husted said. "Passage of this legislation will make it even more affordable to do business, attracting more companies to Ohio. I applaud Speaker Rosenberger and his leadership team for making this a priority."

Under the proposed legislation, Ohio will see the first reduction in fees associated with business filings in modern history and make Ohio more competitive with other states. Over a five-year period, taking into account initial and annual fees, the proposed cut would make Ohio the most affordable place to start a limited liability company as compared to the surrounding states of Kentucky, Indiana, Michigan, Pennsylvania and West Virginia.

Secretary Husted also noted that the benefits of cutting filings fees extend beyond making it easier to do business in Ohio.

'This is not only good for Ohio's businesses, but also for Ohio families," Secretary Husted said. "Making it easier to do business encourages economic growth, which can lead to new and better employment opportunities for

hardworking Ohioans." In October 2013, Secretary Husted launched Ohio Business Central, allowing businesses to file some of the most commonly-used forms online. This saves businesses time and money and has significantly streamlined administration at the Secretary of State's Office. To date, more than 35,000 filings have been submitted and half of all new companies are now started online in Ohio.

Ohio is in a position to reduce filing fees as a result of Secretary Husted's fiscal stewardship over the past four years. During that time Secretary Husted saved taxpayers more than \$14 million in spending compared to the previous administration representing a 16% cut. As part of that, payroll costs were down by \$4.4 million and Fiscal Year 2014 marked the lowest spending on payroll in



#### LATTA, KAPTUR LEAD LETTER EXPRESSING CON-**CERN WITH HHS' LIMITED CHOICE OF FARMSTEAD PROGRAMS**

Congressman Bob Latta (R-OH) and Congresswoman Marcy Kaptur (D-OH) led a letter, which included other members of the Ohio delegation, to U.S. Department of Health and Human Services Secretary Sylvia Mathews Burwell expressing concern about guidance released by CMS that describes the types of settings in which states may use federal Medicaid funds to pay for home and community based services (HCBS). Under this guidance, a "farmstead or disability-specific farm community" is listed as an example of a residential setting that has the effect of isolating individuals receiving HCBS from the broader community.

'Our state is home to several farmstead programs, like Bittersweet Farms, which is located in Ohio's Fifth Congressional District," said Latta. "These programs provide vocational and education programs, as well as residential support, for people with autism that enable these individuals to maximize their po-

#### ODOT REFLECTS ON AC-COMPLISHMENTS OF 2014

The Ohio Department of Transportation (ODOT) District 1 has observed special times in its history. The completion of the relo-

cation and expansion of U.S. 30 in Hancock, Wyandot and Crawford counties in 2008, and of U.S. 24 in Defiance, Paulding and Henry counties in 2009 are certainly notable. But the district has never

rebuilt an interstate.

In 2012, ODOT District 1 began the first of three projects to reconstruct the existing lanes of Interstate 75 and reconstruct all interchanges and bridges in the city of Lima and Allen County from just north of Ohio 81 near Stewart Road to the Auglaize County

"The reconstruction of Interstate 75 is not a typical highway construction project," said Kirk Slusher, Ohio Department of Transportation District 1 deputy director. "The accomplishment of planning, designing and constructing a project of this scope should not go unheralded," he said.

With two years left to go before the third and final phase of the \$150 million project is complete, transportation officials are reflecting on what has been achieved so far on the reconstruction of Interstate 75 in Allen County and other significant projects completed in 2014.

Slusher noted some the most significant milestones of the Interstate 75 reconstruction project to this point:

 The northern section from Ohio 81 to Fourth Street was completely opened to traf-





#### **TROOPERS ASKING MO-TORISTS TO #MOVEOVER**

Last month, an Ohio State Highway Patrol trooper was struck by a vehicle as he was standing outside of his cruiser, responding to a crash on the side of I-475. Thankfully, he sustained non-life threatening injuries, but he was knocked over a guardrail, fell into a steep ditch and had to be pulled up to safety by a

Hundreds of people are killed or injured each year after pulling over to the side of a road and subsequently getting struck by another vehicle. The Ohio State Highway Patrol is asking motorists to help keep their fellow drivers as well as law enforcement officers safe by following Ohio's Move Over law.

The law requires all drivers to move over one lane when passing any vehicle with flashing or rotating lights parked on the roadside. If moving over is not possible due to traffic or weather conditions, or because a second lane does not exist, motorists should slow down and proceed with caution. "By moving over, motor-

ists are helping to protect the lives of everyone who works on or uses our roadways," said Lt. Tim Grigsby. "It's not just the law; it's the right thing to do."
