### CAMERON STOLLER WINS COUNT SPELLING BEE!

On February 9th, students from all over Paulding County met to compete in the County Spelling Bee. The Bee took place at Antwerp Local School, Monday night at 7:00 p.m. This was the second stage in the spelling bee process and to get here, every contestant had to have already won their school spelling bee in order to advance to the county round. Many kids studied their word lists for months, in anticipation for the competition.

On Monday, they found out if their hard work paid off. For one 5th grade student from Wayne Trace Payne,

it certainly did. Cameron Stoller went against eight other spellers, grades 5 through 8, correctly spelling every word throughout the course of the Bee. Other students also did well in the competition, aside from just one trip-up that cost them advancing toward 1st place. One such student was runner-up Faith Meraz, who correctly spelled words like "typhoon" and "begonia." Only eight rounds into the Bee, Stoller was given "behoove," which led to the championship word "homonym," both of which she spelled confidently.

After rounds of applause for Stoller and all the com-

peting students, the award ceremony began. The winner and runner-up both received gift cards to Barnes and Noble, courtesy of the Antwerp Exchange Bank, and check money, from the Antwerp VFW. All participants were awarded medals and certificates for their academic achievements.

The next step for Stoller is the Regional Spelling Bee, where she will compete against the victors of several other county spelling bees. It will be held at IPFW on March 7, 2015. The winner of that competition will advance to the Scripps National Spelling Bee in Washington D.C.

### **HOLOCAUST EXPERT VISITS** ANTWERP FRESHMEN

Kristi Keller, a Holocaust Resource Consultant, recently visited Mr. Miesle's freshmen world history classes to share information about victims of the Holocaust, especially Jehovah's Witnesses. Most students are aware of the sufferings of Jewish victims but do not realize other minority groups were persecuted during the Holocaust as well, including Witnesses, the disabled, and homosexuals. Keller showed the students the badges worn by these different groups and explained how Witnesses were offered the chance to sign a declaration renouncing their faith in order to be set free from concentration camps.

Keller also introduced students to the stories of Max Liebster and Simone Arnold Liebster, a husband and wife who were both Holocaust victims during their youth. Max, a German Jew, was arrested when he was 24 and sent to Sachsenhausen, a concentration camp near Berlin. There, he found his dying father, whom he later had to carry on his back to the crematorium



furnace. Max was a prisoner for nearly six years in five concentration camps. He lost seven family members in the Holocaust.

After the war, in 1956, Max married Simone Arnold, a Witness whose family also suffered during the Holocaust. When she was a child, Simone's father was arrested and sent to a concentration camp, while she and her mother were left to fend for themselves without money or a working permit. Around that time, Simone was also expelled from school for refusing to "Heil Hitler."

When she was 12, Simone was sent to a penitentiary house where Nazis tried to "reeducate" her; there, she could not talk, could only bathe twice a year, had to perform constant chores, and received beatings as punishment. After the war, Simone was reunited with her parents, but not before they had all suffered great physical and emotional loss.

After learning of the Liebsters' story, students in Mr. Miesle's class had the privilege of Skyping with Simone, who is 85 and lives in France.

### ODA DIRECTOR BURMAN ASKS MEALS PROGRAM CONSUMERS TO "GO STEADY!"

Ohio Department of Aging director Bonnie K. Burman, Sc.D., visited the meals program at the Council for Older Adults of Delaware County today and rode along with Gary and Sandy Must, volunteers with the Meals on Wheels program, to deliver special Valentine's Day cards to consumers. The cards included tips to help consumers prevent falls in their homes. One in three older Ohioans will fall this year. The STEADY U Ohio initiative encourages all Ohioans to learn how to help an older loved one avoid a life-altering fall.

"Often, older adults do not want to talk about falling because they see it as a threat to their independence," Director Burman said. "When you help loved ones understand that falls are not a normal part of aging and that most falls can be prevented, you are giving them one of the best gifts they can receive: peace of mind."

"A single fall can be life-changing for an older adult, but it doesn't have to happen," added Bob Horrocks, executive director of the Council for Older Adults. "We are proud to support the STEADY U Ohio initiative in helping our older friends and neighbors remain safe in their homes and their community."

Director Burman encourages all Ohioans to talk to their older loved ones about falls. "Be persistent, but also respectful. If they don't want to talk about it, that's okay, but bring the subject up again soon. By showing you care, you can help remove some of their anxiety about the topic and help them reduce their risk."

Tips to help a loved one prevent falls include:

• Don't let your loved one become afraid of falling. Look into programs like A Matter of Balance that can teach older adults to lose their fear and build strength and balance.

• Ask about chronic pain. Pain can cause your loved one to avoid activity, which increases the risk of falls.

• Encourage them to ask their doctor for a falls risk assessment. Learning what

causes falls is crucial to preventing them.

• Offer to be physically active with your loved one. Simple activities like walking or swimming regularly can maintain strength and balance. Find something you both enjoy doing.

• Promote good nutrition and dehydration to reduce the risk of weakness, dizziness and fatigue.

• Talk about changes to your loved one's home to reduce falls risks, such as installing grab bars in the bathroom, removing throw rugs and improving lighting.

Simone answered students' questions about her experiences, and she emphasized the importance of adhering to one's own voice of conscience and countering peer pressures that undermine one's values.

### ENERGY & COMMERCE COMMITTEE ADVANCES LATTA'S DRINKING WATER PROTECTION ACT

The House Energy and Commerce Committee passed H.R. 212, the Drinking Water Protection Act, sponsored by Congressman Bob Latta (R-OH). The legislation now awaits a vote by the U.S. House of Representatives.

"Today, the Energy and Commerce Committee took an important step to protecting our public health and safety by advancing the Drinking Water Protection Act," said Latta. "My legislation takes the thoughtful, robust approach needed to adequately assess and manage the risks of algal toxins in our drinking water, and I thank the Committee for its support. I look forward to working with my Congressional colleagues and leadership to ensure this legislation is taken up for a vote on the House

floor in a timely manner." Latta introduced the Drinking Water Protection Act to help protect drinking water from harmful cyanotoxins, which caused a water emergency in Northwest Ohio last August. The bipartisan bill requires the Environmental Protection Agency to develop and submit a strategic plan to Congress for assessing and managing the risks associated with algal toxins in drinking water.

### LATTA, ESHOO, ISSA, MATSUI, DELBENE REIN-TRODUCE BIPARTISAN, BICAMERAL WI-FI INNOVA-TION ACT

Congressman Bob Latta (R-OH), Vice Chairman of the Energy and Commerce Committee's Communications and Technology Subcommittee, along with Ranking Member of the Communications and Technology Subcommittee Anna G. Eshoo (D-CA), Congressman Darrell Issa (R-CA), Congresswoman Doris Matsui (D-CA) and Congresswoman Suzan DelBene (D-WA), reintroduced the Wi-Fi Innovation Act, bipartisan, bicameral legislation that addresses growing spectrum demand by examining ways to improve spectrum efficiency and maximize its use.

"As more and more technologies utilize Wi-Fi to connect to the Internet, the need for increased wireless spectrum grows," Latta said. 'The Wi-Fi Innovation Act examines ways to maximize spectrum use by efficiently expanding the deployment of wireless networks and services, so everyone can benefit from next-generation technologies. Utilizing unlicensed spectrum remains a critical component of promoting economic development and increased connectivity across the country, and the Wi-Fi Innovation Act would help bridge the digital divide." Spectrum is a driver of economic opportunity in our country, serving as the invisible backbone of our digital age and turning our smart devices into connected tools for education, commerce and safety," Eshoo said. "But we've only scratched the surface in optimizing this finite resource. To fully realize its potential, the bipartisan, bicameral Wi-Fi Innovation Act

responsibility to ensure that the U.S. continues to be the center for technology and innovation, and spectrum will be necessary to achieve this."

"If we want the Internet to continue to thrive the FCC needs to keep up with the growing demand for wireless spectrum capacity," DelBene said. "Our bill takes a step in the right direction while also helping to bridge the digital divide that some low-income and rural communities face because of unreliable access to wireless networks."

The Wi-Fi Innovation Act directs the Federal Communications Commission (FCC) to conduct tests within the 5 GHz spectrum band to determine if spectrum can be shared without interfering with current users. The bill also acknowledges ongoing efforts related to the development of critical safety applications in vehicles and other intelligent transportation initiatives and creates a study to examine the barriers to Wi-Fi deployment in low-income areas.

Similar legislation was also introduced in the U.S. Senate by Senator Marco Rubio (R-FL) and Senator Cory Booker (D-NJ).

Congressman Bob Latta (R-OH) reintroduced the Veterans Air Travel Streamlining Act and the Children of Military Service Members Commemorative Lapel Pin Act in an effort to honor our nation's heroes and their families. Latta previously introduced both pieces of legislation in the 113th Congress.

The Veterans Air Travel Streamlining Act would waive the TSA pre-check program application fee for U.S. military veterans with a service-connected disability rating of 50 percent or greater. It is important to note that eligibility requirements would still need to be met before being approved for the precheck program.

"Currently, injured veterans must contact TSA with the details of their confirmed flight itinerary and all other relevant information to be eligible to use TSA pre-check lanes or other expedited screening procedures," said Latta. "While these efforts by the TSA are commendable, this process can be time consuming and redundant. The Veterans Air Travel Streamlining Act would provide an opportunity for us to show our gratitude to our nation's heroes by expediting certain screening procedures that can be time consuming given their injuries."

The Children of Military Service Members Commemorative Lapel Pin Act, would honor military children for their contributions to our military, through their parents, with an official lapel pin.

"We must do everything we can to honor and respect not only our men and women in uniform, but also their families who have sacrificed so much for them and for our country," said Latta. "Our military children have endured frequent moves, long and short-term absences of a parent, and threats of parental loss in war. The Children of Military Service Members Commemorative Lapel Pin Act is just one way that we can recognize them for their contributions to our country."

H.R. 543, the Blue Water Navy Vietnam Veterans Act, bipartisan legislation co-sponsored by Latta, was also introduced in the House. The bill grants presumptive Agent Orange exposure status to service members who served in the territorial seas of Vietnam during the Vietnam War. This would enable eligible veterans to receive expedited consideration for Veterans Affairs (VA) benefits if they suffer from any of the diseases the U.S. government has linked to Agent Orange.

### A HIDDEN TREASURE IN **PAULDING COUNTY: THE BLACK SWAMP NATURE** CENTER

A true piece of natural wonder exists at the Black Swamp Nature Center. The Nature Center wasn't always a wildlife area, the land use to be part of the sugar beet factory. There were four ponds constructed by the beet factory to aid in the production process of the beets. Three ponds still exist today as part of the Black Swamp Nature Center. There was also a dam built for water retention that still exists today. The sugar beet factory closed down in 1948, it wasn't until 1958 that the wildlife area was established. From 1958-1990, the Ohio Department of Natural Resources (ODNR) spent monies on turning the wetlands, wooded areas, and ponds into fish stocked, wildlife refuge park with a driveway and parking lot that exists as what we know today at the Black Swamp Nature Center. In 1990, the Paulding Ponds Wildlife Area was offered and approved for sale to the Paulding County Commissioners from ODNR. Today the Black Swamp Nature Center is maintained by the Paulding Soil and Water District (SWCD) with the ownership of the property being the Paulding County Commissioners.

The Black Swamp Nature Center is one of the few designated wildlife areas in Paulding County. The nature center consists of 51 acres of land. There are 24 acres of woodland, 14 acres of wetlands and six acres of old meadow as well as the Nature Center building. The Nature Center building offers a picturesque view of nature for many different events such as meetings, trainings, and field trips for local schools and rental for personal events. There are four nature trails available to the public for daily walkers or those who truly want to enjoy the wonders of nature. Year around the nature center is home many different species of wildlife and birds. There have been over 175 species of birds documented at the Black Swamp Nature Center. The Black Swamp Nature Center is a prized piece of history and natural wonder in Paulding County. The Paulding SWCD would invite you to come visit the nature center and explore the



### **HELPING OUR STUDENTS** WITH HOUSE BILL 7

#### **Guest Column from State Representative Tony** Burkley

Ohio House Bill 7 is a bill sponsored by Representative Jim Buchy that prohibits scores from this first year of new state assessments, including those supplied by the Partnership for Assessment of Readiness for College and Careers (PARCC) from being used against students in any way, offering them safe harbor. The bill was passed in the Ohio House on Wednesday, February 11th with broad bipartisan support.

I believe that this bill helps students to succeed by providing additional time to prepare students for higher expectation.

The provisions of this legislation are straightforward. The bill disallows the use of students' scores from state assessments to make decisions regarding grade promotion or retention and granting of credit. It ensures that students may re-take end of course examinations for high school courses throughout their high school career. The bill also clarifies that the new state assessments are not used to meet requirements under the third grade reading guarantee, and prohibits the release of individual students' test scores from tests administered during the 2014-15 school year. House Bill 487, passed and signed into law during the last General Assembly, provided protection to teachers and administrators by allowing local districts to decline to use the student test results from the 2014-15 school year to make decisions such as termination and granting tenure. I was proud to support this bill. However, I feel that it is our duty to provide that same level of support to the students who are taking these tests.

ceed. While HB 7 is not a fixall solution to our education system, I believe that it is a step in the right direction.

Acting sooner rather than later on this issue is in the best interest of the students. With the testing already taking place in some school districts, it is imperative that these protections are put in place expeditiously. With the bill's passage in the House, we now must wait on our colleagues in the Senate to continue the process. With their support, we can have this bill become a law soon enough to help our student's this school year.

As always, I would appreciate hearing your feedback on this and any other issues in the state legislature. I encourage you to contact my office with any concerns or ideas in regards to state government.

### **SECRETARY OF STATE HUSTED REMINDS OHIO-ANS: ONE VOTE MATTERS**

Ohio Secretary of State Jon Husted offered more reasons why every vote matters and can often have a significant impact on the outcome of an election.

Based on a review of recounts conducted following the 2014 General Election on November 4<sup>th</sup>, seven local issues were decided by one vote or tied. In each of these instances, one person could have made the difference in deciding whether local taxes would go up, bond issues passed or an area restaurant or store could sell liquor.

"Whether it is a statewide or local issue, every ballot question has an impact on our lives and it is important that every voice is heard," Secretary Husted said. "When voters stay home they allow others to make these decisions for them."

Secretary Husted also noted why these findings reinforce the emphasis his administration places on making it easy to vote and hard to cheat.

"Accurate voter rolls and integrity in the elections process are always important, but when a single vote can carry such weight it raises the stakes," Secretary Husted said. "We, as elections officials, continue to do our part



to ensure casting a ballot is easy and the system is secure, but ultimately it is up to the voter to take advantage of the many opportunities to partic-

ipate in every election. A total of 70 local issues and races have been decided by one vote or tied (based on a review of recounts conducted by the Secretary of State's Of-

This is the middle of June 1944, the invasion is about two weeks old. We have a good foot-hold in France, but we're not moving very fast. In fact, we are still pounding away at Caen. The Germans are determined to keep this city at any cost. That is in the English sector and Montgomery has not captured the city yet.

On our dawn patrol this morning, we ended up above over Caen. We spotted four Tiger-Tanks sitting at the edge of a small town to ambush a column of American medium #3 tanks, operated by the English. There were two tanks on each side of the street waiting for the M3's to get in range. We got on through the radio to the other pilots and divided up the targets. I was to take the first one on the east side. I came in low and aimed my rocket at the middle of the tracks. The rocket done a good job on his boogie wheels. His boogie wheels just flew in all directions. I swung around and got some elevation and attacked his tank from the rear. I put a few of my 22 mm cannons into his engine and it started to burn. I swung around on another pass and could see my wingman had done about the same to his tank at the rear of mine. The black smoke from those burning tanks was getting pretty thick.

By now we were getting a lot of small caliber anti-aircraft rounds. I made one more circle at a slower speed and I could see the other pilots had taken out the other two tanks, that part of the city would be free for the English tank column coming down the road. We flew over the area looking for any targets or roadblocks or even a small bridge to blow up with our rockets. There was a small air field at the edge of town that wasn't being used anymore, so we blew the hangers to pieces. They were using the buildings for some other storage and we started some fires. On our afternoon sortie, we didn't find any big targets, we just shot up the fence rows, hoping to help the infantry boys.

After supper, we met in the barracks and set around and talked about our morning flights. After our crewmen got our planes ready for tomorrow's dawn patrol, they came in and listened to the pilots talk about blowing up the Tiger-Tanks. They got as excited as the pilots were. We hear that by knocking out those tanks, we helped save a lot of boys' lives. Our medium tank is no match for the Tiger-Tank. We all feel pretty good about our morning patrol.

### BEYOND DETERRENCE, COMPASSION

Ronald Reagan's assertion back in 1984 that "a nuclear war cannot be won and should never be fought" seems to have become accepted across the political spectrum in the U.S. and abroad. The level of destruction that would result would at best make it impossible for medical systems to respond adequately and at worst lead to climate change on a global scale. Reagan continued: "The only value in our two nations possessing nuclear weapons is to make sure they will never be used. But then would it not be better to do away with

them entirely?" Thirty years later, the paradox of deterrence-nine nuclear powers with weapons kept absolutely ready for use so that they will never have to be used-is far from resolved. Meanwhile 9/11 bent our imaginations toward suicidal nuclear terrorism. The possession of even our large and varied arsenal of nuclear weapons would not deter a determined extremist. Fear became so powerful that it motivated not only the grotesque proliferation of information-gathering agencies but also assassination and torture. Anything became justified, including trillion dollar stalemated wars, to preempt the wrong adversary from getting their hands on a nuke.

there flashpoints Are where systems designed for reliable and eternal deterrence blur into a new landscape of deterrence breakdown? The example du jour is Pakistan, where a weak government maintains a stable—we hope—deterrent balance of nuclear forces against India. At the same time Pakistan percolates with extremists with possible sympathetic connections to the Pakistani military and intelligence services. This focus upon Pakistan is conjectural. It may be unfair. A nuclear weapon could just as easily fall out of state control in regions like the Caucasus or-who knows?-even at some U.S. base where security was lax. The point is that fear of such scenarios distorts our thinking as we struggle to respond creatively to the reality that nuclear deterrence doesn't deter.

FEBRUARY MARKS HEART Month

### The Nurturing Well by: Jill Starbuck

February is often filled with hearts of all sorts, including heart-covered cards, heart-shaped candy, and heart-filled wishes. But February is not just synonymous with Valentine's Day anymore; it is also tied in with the real, physical heart that keeps our bodies functioning. February marks American Heart Month, raising awareness of potential issues that often become serious heart problems such as heart disease.

According to the Centers for Disease Control and Prevention (CDC), each year more than half a million Americans die from heart disease, making it the number one killer in the United States. With 1 in every 4 deaths related to heart disease, this health issue costs the United States nearly \$110 billion annually. Typical risk factors include high blood pressure, obesity, diabetes, high cholesterol, smoking, poor diet, and stationary lifestyle. As you can see, most often these risk factors can be controlled.

Perhaps the sneakiest and often most critical risk factors are high blood pressure and high cholesterol. The CDC estimates that 1 in every 3 adults, equating to 67 million people, have high blood pressure. High cholesterol sufferers number about 71 million people. Of the millions of people who have high blood pressure and/or cholesterol, less than half have control over these issues. Some likely do not realize they even have a problem. Without signs or symptoms, high blood pressure and/or cholesterol can become a deadly surprise.

To help prevent heart disease, the American Heart Association introduced four new guidelines in November of 2014.

1. Risk Assessment: Schedule an appointment with your healthcare provider to understand your risk level for heart disease. Armed with high-tech calculators, a host of risk factors to identify, and the knowledge to diagnose potential issues, your healthcare provider is the best place to start. Remember that high blood pressure is a common and deadly threat without a warning sign. The best way to combat high blood pressure is to get frequent checkups.

2. Obesity: Remain at a healthy weight level to avoid many issues that obesity can cause. Learn how to eat properly by seeking a nutritionist who can tell you what your caloric needs are and how to avoid falling into common eating traps.

**3.** Cholesterol: As mentioned earlier, high cholesterol can be a silent killer. In fact, those with high cholesterol have twice the likelihood of getting heart disease than those who have normal cholesterol levels. Seek a physician to learn your cholesterol level.

**4. Lifestyle:** What we eat and how we live affects our health in a big way. Seek to eat a clean diet with lots of fruits and vegetables. Work exercise into your daily routine.

### LOCAL GIRL SCOUTS EARN GOLD AWARD

Two local girls have earned the Girl Scout Gold Award and will be celebrated at an event next month.

Sydney Czerniakowski is Toledo resident, 2014 graduate of St. Ursula Academy, and freshman at the University of Toledo. In her project, Czerniakowski turned pillowcases into dresses for African children. She chose a simple design that allowed her to teach others to make them using her sewing skills, and a lightweight fabric compatible with high temperatures. Czerniakowski made a video of her project and created a brochure with dress design instructions. She also collected donated fabric and embellishments, gathered volunteers, and made 200 dresses. She donated extra fabric and instructions to her high school's fashion class and club who have committed to taking on this project for years to come.

Stephanie Ravas is a Perrysburg resident and sophomore at Notre Dame Academy. In her project, she focused on providing intervention strategies for preschool children entering school with fine motor developmental deficits or delays. Ravas created specialized enrichment teaching tools to be used at both school and home that help children learn to complete daily routines and practice skills. She created six individual selfhelp task charts and pieces to strengthen developmental milestone skills such as: task sequencing and planning, self-help skills, and coordination skills. Ravas also created and built two sets of cubbies for the classroom that further develop and help children practice developmental skills of task sequencing and proper recall while creating self-sufficiency in the classroom.

The Girl Scout Gold Award is the highest award that Girl Scouts in grades 9-12 may earn. To achieve the award, girls commit at least 80 hours to a specific project over the time span of one to two years. Criterion for the girls' project includes community involvement outside of the Girl Scout structure, providing an innovative approach, incorporating project sustainability, and taking action to educate and inspire others. Approximately six percent of Girl Scouts nationwide earn this award.

The girls will receive their award alongside 23 other girls at the annual Gold Award recognition event at the Schuster Center in Dayton on Sunday, March 8 at 3:00 p.m. The event kicks off National Girl Scout Week.

### ARE THE U.S. & RUSSIAN GOVERNMENTS ONCE AGAIN ON THE NUCLEAR WARPATH?


A quarter century after the end of the Cold War and decades after the signing of landmark nuclear arms control and disarmament agreements, are the U.S. and Russian governments once

along toward implementing an administration plan for U.S. nuclear "modernization." This entails spending \$355 billion over a 10-year period for a massive renovation of U.S. nuclear weapons plants and laboratories. Moreover, the cost is scheduled to soar after this renovation, when an array of new nuclear weapons will be produced. "That's where all the big money is," noted Ashton Carter, recently nominated as U.S. Secretary of Defense. "By comparison, everything that we're doing now is cheap." The Obama administration has asked the Pentagon to plan for 12 new nuclear missile-firing submarines, up to 100 new nuclear bombers, and 400 land-based nuclear missiles. According to outside experts and a bipartisan, independent panel commissioned by Congress and the Defense Department, that will bring the total price tag for the U.S. nuclear weapons buildup to approximately \$1 trillion.

For its part, the Russian government seems determined to match or surpass that record. With President Vladimir Putin eager to use nuclear weapons as a symbol of Russian influence, Moscow is building, at great expense, new generations of giant ballistic missile submarines, as well as nuclear attack submarines that are reportedly equal or superior to their U.S. counterparts in performance and stealth. Armed with nuclear-capable cruise missiles, they periodically make forays across the Atlantic, heading for the U.S. coast. Deeply concerned about the potential of these missiles to level a surprise attack, the U.S. military has already launched the first of two experimental "blimps" over Washington, DC, designed to help detect them. The Obama administration also charges that Russian testing of a new medium-range cruise missile is a violation of the 1987 INF treaty. Although the Russian government denies the existence of the offending missile, its rhetoric has been less than diplomatic. As the Ukraine crisis developed, Putin told a public audience that "Russia is one of the leading nuclear powers," and foreign nations "should understand it's best not to mess with us." Pravda was even more inflammatory. In an article published in November titled 'Russia prepares a nuclear surprise for NATO," it bragged about Russia's alleged superiority over the United States in nuclear weaponry.

Not surprisingly, the one nuclear disarmament agreement signed between the U.S. and Russian governments since 2003 the New START treaty of 2011 is being imple-mented remarkably slowly. New START, designed to reduce the number of deployed strategic nuclear weapons (the most powerful ones) in each country by 30 percent by 2018, has not led to substantial reductions in either nation's deployed nuclear arsenal. Indeed, between March and October 2014, the two nations each increased their deployed nuclear forces. Also, they maintain large arsenals of nuclear weapons targeting one another, with about 1,800 of them on high alert ready to be launched within minutes against the populations of both nations. The souring of relations between the U.S. and Russian governments has been going on for years, but it has reached a very dangerous level during

the current confrontation over Ukraine. In their dealings with this conflict-torn nation, there's plenty of fault on both sides. U.S. officials should have recognized that any Russian government would have been angered by NATO's steady recruitment of East European countries especially Ukraine, which had been united with Russia in the same nation until recently, was sharing a common border with Russia, and was housing one of Russia's most important naval bases (in Crimea). For their part, Russian officials had no legal basis for seizing and annexing Crimea or aiding heavily-armed separatists in the eastern portion of Ukraine.

But however reckless the two nuclear behemoths have been, this does not mean that they have to continue this behavior. Plenty of compromise formulas exist for example, leaving Ukraine out of NATO, altering that country's structure to allow for a high degree of self-government in the war-torn east, and organizing a UN-sponsored referendum in Crimea. And possibilities for compromise also exist in

them and, also, by providing an example of dependence on nuclear might, encourage the proliferation of nuclear weapons to additional nations. After all, how can they succeed in getting other countries to forswear developing nuclear weapons when 47 years after the U.S. and Soviet governments signed the nuclear Non-Proliferation Treaty, in which they pledged their own nuclear disarmament their successors are engaged in yet another nuclear arms race? Finally, of course, this new arms race, unless checked, seems likely to lead, sooner or later, to a nuclear catastrophe of immense proportions.

Can the U.S. and Russian governments calm down, settle their quarrels peacefully, and return to a policy of nuclear disarmament? Let's hope so.

more engaged in a potentially disastrous nuclear arms race with one another? It certainly looks like it.

With approximately 15,000 nuclear weapons between them, the United States and Russia already possess about 93 percent of the world's nuclear arsenal, making them the world's nuclear hegemons. But, apparently, like great powers throughout history, they do not consider their vast military might sufficient, especially in the context of their growing international rivalry.

Although, in early 2009, President Barack Obama announced his "commitment to seek the peace and security of a world without nuclear weapons," the U.S. government today has moved well other areas of U.S.-Russian relations.

Failing to agree to a diplomatic settlement of these and other issues will do more than continue violent turmoil in Ukraine. Indeed, the disastrous, downhill slide of both the United States and Russia into a vastly expensive nuclear arms race will bankrupt Lawrence Wittner (http:// lawrenceswittner.com), syndicated by PeaceVoice, is Professor of History emeritus at SUNY/Albany. 



This year, both recipients are from the Fayette County Board of Elections and demonstrate how individuals of opposite political parties can collaborate in a collegial and professional manner to administer elections.

"The Fayette County Board of Elections director and deputy director demonstrate a level of bipartisanship that all public officials should strive to achieve," Secretary Husted said. "Their ability to work together, putting the public interest ahead of political interests, has helped deliver well-run elections in their

Franklin County "Election Day Problem Tracking System": Communication among election officials on Election Day is essential. In Franklin County, the board of elections operated three separate locations where employees handled calls on a wide range of topics and issues. While the county was previously able to address inquiries received, it lacked a central location to collect all of the problems reported that might need further attention. To remedy this issue, the Franklin County Board of Elections developed software that enables election staff throughout the county to enter problems into a database. This system gives elections officials a centralized place to see what problems are happening in real time at polling locations throughout the county and to quickly address any issues that are impeding the election process.

Madison County "De-tailed Timeline Tool": To ensure greater efficiency and organization, Madison County has implemented a detailed timeline tool that all staff has access to and can use to plan their work on a daily, weekly and monthly basis. The system allows tasks to be assigned to a specific person, reminds them of deadlines, as well as priority election and daily tasks. The tool also provides for a way to report on progress and check off completed jobs. Officials in Madison County have stated that the tool has been useful in keeping everyone on the same page on what needs to be accomplished both on a daily basis and for future planning.

Montgomery County Voter Verifiable Paper Audit Trail Remover": The county currently uses voting equipment that produces a Verifiable Paper Audit Trail, or VPAT, that must be removed from each machine following an election. The process of removing the VPAT from the approximately 2,500 machines used in each election required the tedious process of unrolling each spool of paper, identifying it and storing it according to a retention schedule. In an effort to save the board both time and money, the staff simply modified a power drill to more quickly remove multiple VPATs at one time. A process that used to take eight staff members four days to complete, now takes four staff members two days.



#### VISITORS:






