SECRETARY HUSTED CERTIFIES SIGNATURES FOR DRUG PRICE RELIEF ACT CITIZEN INITIATED STATUTE

Ohio Secretary of State Jon Husted certified that petitioners for the Drug Price Relief Act citizen initiated statute have collected an additional 120,030 valid signatures and have met the constitutional requirements to appear on the 2017 General Election ballot.

Petitioners needed 91,677 valid signatures, a number equal to three percent of the total vote cast for governor in the most recent gubernatorial election, 2014. They also needed to collect signatures equaling 1.5 percent of the total vote cast in the most recent gubernatorial election within at least 44 of Ohio's 88 counties.

Having qualified for the ballot, the next step will be for the Ohio Ballot Board to convene to prescribe ballot language for the proposed law and certify it to the Ohio Secretary of State's Office no later than 75 days before the election - November 7, 2017.

DOING THE RIGHT THING

"There was a rich man who was dressed in purple and fine linen and lived in luxury every day. At his gate was laid a beggar named Lazarus,

covered with sores and longing to eat what fell from the rich man's table. Even the dogs came and licked his sores. "The time came when the beggar died and the angels carried him to Abraham's side. The rich man also died and was buried. In hell, where he was in torment, he looked up and saw Abraham far away, with Lazarus by his side. So he called to him, 'Father Abraham, have pity on me and send Lazarus to dip the tip of his finger in water and cool my tongue, because I am in agony in this fire.' Luke 16:19-24 (NIV).

This story is quite different from other parables that we find throughout the gospels. It's the only parable in which

one of the characters is given a name, and it doesn't take place just on earth but has to do with life after death. Jesus drew this story from real life just as He did His other parables. He uses the name of one of the individuals involved in this parable; the Lord would not have given the name of someone who did not exist.

Here are two men at the opposite ends of the social and financial ladder. One man represents the top echelon in riches and in society, the other man represents the lowest extreme of poverty. No two men could be farther apart in every way. Lazarus, dressed in rags, did not appear to have much in the way of any spiritual discernment or spiritual riches. The rich man had a respected name in the town in which these two men lived. However, all that the people in the town could see were the outward appearances of the rich man and the beggar. This is a picture of abject poverty and extreme riches. Two men could not have been farther apart socially and economically.

When the beggar died, there was no funeral. They just took his body out and threw it into the Valley of

Gehenna where refuse was thrown and burned; this is the place where they threw the bodies of the poor in that day. The minute the beggar stepped through the doorway of death, angels became his pall-bearers and he was carried by them into paradise. The rich man also died and was buried. He had a big funeral, and the rabbi's eulogy pushed him all the way to the top spot in heaven. The only trouble is that when the rich man died, his spirit went to the place of torment, the place where the lost go.

Jesus said that to love your neighbor as yourself is second in importance only to loving God with your whole being. The warning in this parable is still directed to those today who let their love of money get in the way of love of God and neighbor. A person cannot love money and love God; the two are not compatible as they will love one and not the other. Our Lord made it clear; a person must make the decision in this life where they will go after death. No one gets a second chance after death. The rich man loved money which is why he was a lost soul that went to hades.

SPECIAL TRAPPING DRAWING TO BE HELD AT KILLDEER PLAINS WILDLIFE AREA

A one-time drawing will be held Wednesday, October 19, 2016, at 6:30 p.m. for trapping in the wildlife refuge on the Killdeer Plains Wildlife Area, according to the Ohio Department of Natural Resources (ODNR).

The drawing will be held at the Killdeer Plains Check Station, located at 19100 C.H. 115; Harpster, OH 43323 (1-1/2 miles south of State Route 294 in Wyandot County).

All participants must register before 6:25 p.m., and must show a valid 2016-2017 Ohio Fur Taker Permit. Anyone interested should plan on being at the Killdeer Plains Check station by 6:00 p.m.

Registration forms will be completed by the trapper and placed in a drum. As these forms are drawn that trapper must select a unit to trap. There are nine available units in the refuge. A letter permit will be mailed to the participant, and further instructions will be given by the area supervisor.

The permit will be valid for portions of the trapping season, with some restrictions on times. No one may enter the refuge for inspection before receiving a permit.

Permits are not transferable. All trappers that are chosen must meet with the area supervisor for specific instructions before the start of the trapping activity.

It is unlawful for any per-

son to buy, sell, trade or barter any ODNR Division of Wildlife issued controlled hunting, fishing or trapping permit.

LATTA APPLAUDS PASSAGE OF LEGISLATION TO HONOR KOREAN WAR VETERANS

Congressman Bob Latta (R-Bowling Green) applauded the recent passage of legislation, H.R. 1475, the Korean War Veterans Memorial Wall of Remembrance Act, to create a wall of remembrance at the Korean War Veterans Memorial on the National Mall. The legislation passed the U.S. House of Representatives last week and was signed by Speaker of the House Paul Ryan yesterday. It now heads to the President's desk to be signed into law. Latta is a cosponsor of the legislation.

"More than 36,000 Americans lost their lives in the conflict which is often called the 'Forgotten War,'" said Latta. "Those who paid the ultimate sacrifice for our country should never be forgotten. Expanding the memorial in Washington to include recognition of these individuals will finally ensure their names — and

SUE DANGLER SELECTED AS EXECUTIVE DIRECTOR OF PCH FOUNDATION

Sue A. Dangler of Paulding was recently selected to be the first Executive Director of the Paulding County Hospital Foundation. The Foundation, an independent public charity, was organized in 1999 as an Ohio non-profit corporation with a mission "to improve the health and well-being of residents of the community." Soon thereafter, it was recognized by the Internal Revenue Service as a 501(c)(3) organization and became able to accept tax-deductible donations and gifts from individuals and organizations.

For its first 17 years, the Foundation has steadily grown with assets now totaling more than \$230,000, and annually awards thousands of dollars in college scholarships to Paulding County high school seniors who plan a career in health care.

About one year ago, the Foundation board of trustees discussed the need for a part-time executive director to provide on-going direction and to help the Foundation develop a strategic plan to grow membership and Foundation assets, and to formalize and expand the grant process with a focus on fulfilling the Foundation's mission.

That decision ultimately led to the selection of Sue Dangler as the Foundation's first executive director. Before retiring, she had spent some 38 years in education as a Paulding High School teacher, coach and principal, and more recently as the



Hicksville High School and Middle School principal. She was also the office manager of the Sweetwater Chophouse and Eagle Rock Golf Club in Defiance for several years. She is a member of the Defiance Area Foundation and has been a member of the Hicksville Rotary Club. She and her husband Kevin reside in Paulding.

Her first major undertaking with the Paulding County Hospital Foundation has been strategic planning.

"The background and attributes that Sue brings to the Foundation are exactly what we were hoping for," said Lou Levy, president of the Paulding County Hospital Foundation board of trustees.

"She has deep roots in Paulding County, growing up in Oakwood, Ohio. Sue has valuable experiences and contacts that were developed through a professional career outside the county as well. We're excited by the energy and passion that she has already brought to the Foundation," Levy said.

On 9-28, Lillie and I went to the meeting of Sheriff Jason Landers and his jail deputy explaining the new tax levy being placed on the ballot in November.

They told the numbers that's been spent for transportation to Van Wert and Putnam Co.'s jails. Very expensive way to deal with prisoners, also, could be very tragic from a traffic accident in transporting prisoners.

We were told that the jail is ready to re-open with minimal clean up and shining the floor. The original levy will end on 2021 that built and equipped the jail, so the jail will be paid off then. The new levy will replace payments from the general funds, hire 10 full and part-time jail employees, a full-time and 2 part-time cooks to feed prisoners. Estimated mileage costs would be about \$45.00 for every \$100,000 of property value. They explained the formula better than I did here, but regardless, to me, \$45.00 a year to put 13-14 full and part-time jobs in our county is a hell of a great investment here! These employees will pay taxes, support schools, activities, and spend money in local stores, and dealers! They will put money in the offering plates, pay to help rebuild our roads and bridges, fire protection, so, so much more!

Right now, Putnam County enjoys the \$325,000 of added funds to use in their county. If you really care about the health and growth of Paulding County, I ask you to do like me and my wife are going to do, and support our county, and vote yes!

I know that nobody wants to pay more taxes, I don't either, but what I am willing to do is make an investment in Paulding County by hiring people who will raise their kids here, go to church here,

and invest here by buying a house, car, and so many other goods from local merchants.

United auto workers 1st president Walter Reuther had several statements that I have believed in, and find this philosophy to be true... the best social program is a good-paying job, as spokes in the wheel, they support all I spoke of above, and make the community better! Remember to go to the next information meetings in Paulding and Oakwood, and hear Sheriff Landers out! It's a great investment in our county!

LATTA BACKS BILL PROVIDING RELIEF FOR SMALL BUSINESSES, SCHOOLS, AND NONPROFITS

September 28th, Congressman Bob Latta joined his colleagues in the U.S. House of Representatives to pass H.R. 6094, the Regulatory Relief for Small Businesses, Schools, and Nonprofits Act, legislation that would require a six-month delay in the implementation of the new Department of Labor (DOL) overtime rule. The rule was finalized earlier this year without Congressional approval despite concerns raised by small businesses, schools, and charitable organizations.

"I've heard from a number of schools and nonprofits in the Fifth District that simply don't know how they will be able to effectively pursue their missions when this rule goes into effect," said Latta. "Of course, small businesses will also be at a significant disadvantage and employees are going to face less scheduling flexibility and opportunities for upward mobility at work. Passing this legislation will give these organizations needed relief from a rule that was poorly thought out and finalized without any Congressional input."

The new DOL regulation was finalized in May of this year, and will go into effect less than six months later on December 1, 2016.

The rule dramatically alters the Fair Labor Standards Act, which establishes protections for America's workers. While the law's intentions are important, the regulatory

Everyone stood around and shook and howled for a bit then things settled down.

If you will remember, Callie is the hotel owner's niece but she is also Sam's girlfriend and more than that even. Things was sort of slow in the hotel lobby, so Callie could spend a lot of time with Sam.

All went into the restaurant and got a table in the corner and the happiness flowed like spring rain.

They all had the evening meal and talked quite a bit. Slim went on upstairs to bed, but they all agreed to meet for breakfast at 8:00 a.m. right here at the same corner table.

Callie Thornton was born in Cape May, NJ in 1825. She graduated from high school

there and had a year at the Community College.

Cape May is on the sea shore and damp most of the time. She didn't like anything about this area, so she went west to North Platte to work for her uncle in his hotel. That is where she met El Paso Sam Rivers.

If you will remember, Sam was born in Como, Mississippi in 1824. He went on west in his late teens and worked for the El Paso Devil's Gate Stage Coach Line. He got quite serious with a girl there, but she wasn't so serious and Sam left El Paso and worked his way on west to the desert southwest and was a civilian scout for Colonial Stockton in California Territory. He left that outfit and worked his way back to Santa Fe, New Mexico Territory. He caught a ride with a wagon outfit going back to Independence, MO. He met Slim Martin there and signed on with a wagon train going west to Fort Bridger, Wyoming Territory. That was in 1848, and he and Slim are still together having just disbanded the 3M Wagon Train.

So, Sam proposed to Callie and she accepted readily. Those two just seemed to be made for each other. The wedding was set for the day after tomorrow in the hotel lobby at 11:00 a.m. on December 31, 1851. Slim Martin was the best man and Callie's Aunt Nellie stood up with Callie. Aunt Nellie also gave her mother's wedding ring to Callie because there was no jewelry store in North Platte.

After the wedding there was a fine dinner for all the folks and friends, and it lasted well into the evening.

Jim, Callie and Sam all discussed when they would head east to Fort Kearney. Callie could be ready in three days, and then the boys could load all her belongings in Sam's wagon. Jim was ready to go anytime.

Sam wanted to be in Fort

Kearney before the first of February so he could start his new job by February 1st. Sam is to be the Indian Agent for the Lakota Nation. It was located in Broken Bow, Nebraska Territory. The building was already built and ready for occupancy.

Callie had all her clothes packed in a few trunks and bags, and she had some furniture and a dandy bed complete with mattress and bed clothes. That is just fine because Sam doesn't have hardly any possessions because he has been on the road in a wagon train for about three years.

Well, they left North Platte and headed east to Fort Kearney. Jim's wagon went first and broke a trail for Sam's wagon. Callie sat with Sam's buffalo robe and was plenty warm, but she wasn't used to all the bouncing the wagon got from the holes in the snow on the trail, but it really wasn't all that bad.

She was a good rider, she knew she would have to get used to the trail riding as it is around two hundred miles to Fort Kearney.

THE WIND MILLS

The Blue Creek Wind Farm has given Paulding County \$1,175,000.00 since its existence. I would say that is pretty good revenue.

It is estimated that nationwide, windmills off set 1.6 billions pounds of carbon dioxide a year. The windmills help our nation in other ways besides financially.

If the levy passes we will no longer be sending \$81,000 to Putnam County each quarter, that money will remain here in Paulding County.

FALL MANURE APPLICATIONS AND STOCKPILE LAWS

With an earlier expected harvest, livestock producers and commercial manure applicators will be out applying liquid and solid manure. For farmers in the Western Lake Erie Basin(WLEB) since July 3, 2015 when Senate Bill 1 or Revised Code 939.08 and 939.09 came into effect, the revised code restricts:

- 1) Hauling on frozen or snow covered ground
- 2) Hauling on saturated ground (top two inches of soil are saturated with precipitation)
- 3) Weather forecast calls for 50% chance of rain greater than half inch of rain projected in a 24-hour period

There are exceptions to the land applications.

Farmers can haul on frozen or snow covered ground or saturated ground or the weather precipitation condition under any of the following circumstances:

- 1) Manure is injected into the ground
- 2) Manure is incorporated within 24-hours
- 3) Manure is applied on an over wintering growing crop or cover crops

For stockpiling manure, farmers or applicators need to stockpile 500 feet away from a residence, 300 feet away from any water source (waterways or surface drains), and 1500 feet from any public surface drinking water intake. Also planned stockpiles cannot be stored in the field for more than 8 months.

For applying manure to fields, liquid manure applicators need to examine the fields for tile blowouts, soil cracks, wormholes, and any other situations that might allow manure to reach surface waters. For incorporated liquid manure or liquid manure incorporated within 24-hours there is not any setback requirements from ditches and streams during this time of year. For liquid and pen packed, if surface applied, with no plans of immediate incorruption, a vegetative setback of 35 feet is recommended or a 100-foot setback if

there is little to no vegetation growing. These are recommendations for non-permitted farms and are the rules for permitted farms, as stated in Ohio Revised Code 939.

TEEN DRIVERS REMAIN ONE OF OHIO'S MOST AT RISK GROUPS

Motor vehicle crashes are the leading cause of death in teens, ahead of all other types of injury, disease or violence. As National Teen Driving Safety Week is October 16-22, it's the perfect time for teens and their parents to discuss the dangers new drivers face so they can make safe and responsible decisions. Surveys show that teens whose parents set firm rules for driving typically engage in less risky driving behaviors and are involved in few crashes.
Young drivers who are 15 to 19 years old were involved in 15 percent of all traffic crashes in Ohio from 2013-2015. Of those crashes, a teen driver was at-fault 73 percent of the time. These crashes resulted in 271 fatalities and 40,505 injuries.
While crash causes may vary, speed-related factors contributed to a majority of the crashes caused by teens. Another 20 percent of crashes were brought about by failure to yield, running a red light or running a stop sign.
"Teen drivers need to realize that poor decisions while driving now can stay with them for the rest of their lives," said Lt. Timothy Grigsby, Van Wert Post Commander. "That is why responsibility, awareness and safety are so important for our youngest drivers."

INDOT PREPARES FOR SNOW, ICE WITH PRE-WINTER INSPECTIONS

Indiana Department of Transportation crews will begin preparing for the winter months with pre-winter inspections next month. During the month of October, INDOT inspectors will travel to each of the Fort Wayne District's 14 units to perform the annual inspection of snow and ice equipment.

During the inspections, INDOT's yellow trucks undergo a full bumper-to-bumper examination and inspectors look for mechanical defects in need of repair. Special attention is paid to the trucks' steering, engine and brakes. Any problems are noted and addressed by INDOT mechanics prior to the first snow or ice event.

The preventative maintenance is an important way INDOT prepares for the win-

ter months. Plow drivers also take part in mandatory snow and ice training each year, and most are already familiarizing themselves with their snow routes. INDOT Fort Wayne District is responsible for 140 snow routes in 17 counties in Northeast Indiana, maintaining 4,799 lane miles of roadway, 525 lane miles of interstate and 742 state bridges.

This is the 41st time out of 55 seasons that Woodlan has posted a winning record. The Warriors have had three .500 seasons and 11 losses in those years as well.

The Warriors are 352-192-6 in school history (.645 winning percentage).

LATTA VOTES TO PROVIDE RELIEF TO INDIVIDUALS HARMED BY COLLAPSING OBAMACARE CO-OPS

Tuesday evening, Congressman Bob Latta (R-Bowling Green) joined his colleagues in the U.S. House of Representatives to pass legislation providing relief to individuals that have lost coverage due to failed Obamacare Consumer Operated and Oriented Plans (CO-OPs). The bill, H.R. 954, the CO-OP Consumer Protection Act, exempts consumers from having to pay a penalty if the co-op that they were enrolled in collapses. Under Obamacare, the penalty in 2016 for an individual not having insurance is \$695 or 2.5% of adjusted gross income, whichever is greater.

"In yet another example of the failure of this law, 17 separate co-ops have collapsed since Obamacare was implemented," said Latta. "In a faulty design that only government could dream up, individuals that lost their health care through a co-op failure are being punished

twice — first by losing their coverage, and then by being forced to pay a penalty for not being enrolled in a plan. I voted to pass H.R. 954 to protect more than 22,000 Ohioans that were left without coverage after an Ohio co-op collapsed earlier this year from having to pay this penalty."

In May, the Ohio Department of Insurance announced that InHealth Mutual, an Ohio co-op set up under Obamacare, would shut down due to significant financial losses. The co-op had net losses totaling \$79 million in 2015 and suffered \$29 million in losses in 2016 until it was finally shuttered. In total, only 6 of the original 23 co-ops set up under Obamacare are still operating.

ANTWERP LOCAL SCHOOL CREATES NATIVE PLANT PRAIRIE



Antwerp Local School is currently creating a native plant prairie on the two-acre field located north of the school. The area will include plants native to Northwest Ohio, which will benefit the environment by attracting and supporting birds, butterflies, and pollinators. The prairie will also provide learning opportunities for Antwerp students.

When completed, the prairie will include trees and shrubbery, a pavilion, picnic tables, grass paths, and a mailbox with identification books to help visitors spot butterflies, insects, and plants. Anyone will be welcome to visit the prairie.

Mrs. Linda Mabis, a fourth and fifth grade science teacher at Antwerp Local School, initiated the prairie project after attending a class at the Dayton Midwest Native Plants Conference earlier this year. There, she learned the importance of planting native plants rather than turf grass. When she returned to Antwerp, she asked Elementary Principal Mr. Tim Manz for a small area of land to begin a prairie. Shortly afterward, she heard from Superintendent Dr. Martin Miller that she could use the entire two-acre field adjacent to the school.

The pavilion will be complete at the beginning of October 2016. Volunteers will begin planting trees and

bushes this fall and will plant native seeds toward the beginning of December, as a little layer of snow or frost on the ground creates ideal planting conditions. The grass paths will be completed in the spring of 2017, as well as any remaining planting.

This project has been possible due to the donations and teamwork of many people at the school, in the community, and from surrounding areas: Toledo Metro Parks (native plants seed), the Antwerp Board of Education (concrete), an anonymous donor (picnic tables), Tim Derck (spray), Master Gardeners of Paulding (trees), and fourth grade members of Girl Scout Troop 20516 (birdhouses).

Mr. Cord Ehrhart's Engineering Your Future class at Antwerp High School measured and flagged the area when the project first began, and many people have volunteered their time, supplies, and skills to complete the pavilion: Gary and Linda Mabis, Shane Litzenberg, Brad Peters, Chad Franklin, James Gray, Bud Mabis, and Lenney and Donna Wirz. Other community members have contributed financially as well.

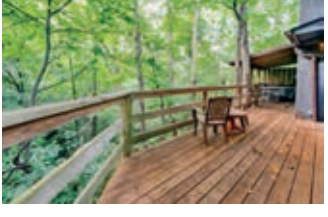

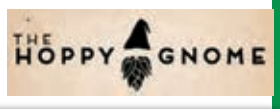

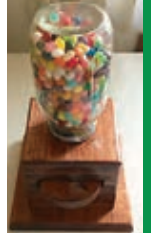
