AREA 1ST GRADE STU-**DENTS RECEIVE TREE** SEEDLINGS

In honor of Arbor Day & Earth Day, first graders at Paulding, Oakwood, Payne, and Antwerp Elementary



Schools learned about the importance of trees to our environment during recent programs. As part of this program, each student was given a Colorado Blue Spruce seedling donated by the Paulding Soil & Water Conservation District and packaged with assistance from the Wayne Trace FFA Chapter this year.

Students learned that trees are extremely valuable to our environment and need plenty of food, water, and nutrients in order to grow. Energy for trees to make food is obtained from the sun which starts the process of photosynthesis. Photosynthesis takes energy from the sun, combines it with carbon dioxide from the air to make food which allows the plant to carry out several processes needed to survive.

As a result of photosynthesis, oxygen is released for us to breathe. Students learned that just like they do, plants need water in order to carry out many other functions. Water helps carry much needed nutrients such as nitrogen or phosphorus taken up by plant roots to various parts of the plant where they are needed. Nutrients such as nitrogen or phosphorus provide additional energy to plants and help them carry out various functions such as producing leaves, seeds, and fruit among many other functions.

Students also learned some basic tree parts and some facts about each part. The leaves contain chlorophyll which is what gives trees their green color. The process of photosynthesis takes place in in the leaves. The trunk of a tree (stem) gives the tree support and shape. Trunks contain a network of cells which carry food and water throughout the tree. Roots are very important to giving the tree support. When the trees start out, the roots will grow straight down to become established. The roots have millions of tiny root hairs that absorb water and nutrients from the soil. At the tip of each root there is a root cap which protects the root as it pushes through the soil.

Bark covers the trunk of the tree. Branches and twigs of a tree and protects it from insects, disease, storm damage, and temperature swings. The crown of a tree consists of the leaves as well as branches at the top of the tree and filters dust and other particles from the air. It is also the function of the crown to cool the air, provide shade, and also slow raindrops during a storm. Students were asked if they knew how to tell the age of a tree. We look at the growth rings of a tree to determine age as each ring represents one year of growth for a tree. Several factors such as drought, excessive rain, fire, insects, injury, and air pollu tion can affect the growth of a tree and can be seen in the ring of a tree in the patterns of the growth ring.

Students were then given a paper plate which they used to draw their own growth rings according to their age. Next, we covered the value that trees provide to nature. Trees provide many services including: air cleaning, recreation & enjoyment, home for wildlife, and much more. In the process of photosynthesis, trees are taking in carbon dioxide and releasing oxygen providing clean air for us to breathe. When trees are taking in carbon dioxide and releasing oxygen, they are helping to remove harmful gases which help contribute to climate change. Trees also provide inviting and cool places for us to enjoy while also providing a home for wildlife.

Students learned that Arbor Day is an annual observance that celebrates the role of trees in our lives and that promotes the planting of trees. Trees can be helped in serval ways including: using paper wisely, pack lunch in a reusable bag, planting a tree, and of course recycling paper! Of course there are many more ways to help protect trees!

After learning all about trees, students took part in an activity called "Every Tree for Themselves! In this activity, students learned the difficulty that comes with trees obtaining all the resources they need in order to survive. Colored squares were placed on the floor to represent water, sunlight, and nutrients which trees need to survive. Each student now became trees and positioned themselves around the room.

Students or "trees" reach with their roots and branches (arms and legs) to gather their requirements. Everyone was reminded that trees can't walk around. One foot (their tap root) must remain plant-

times. They were not allowed to slide their cross-section along the floor or step off it; they were disqualified for doing so. Thirty seconds were given for all requirements to be gathered. After the time was up, students recorded the amount of requirements they were able to gather.

Other rounds that were played depicted scenarios which there was drought conditions, lack of nutrients, and overcrowding trees. The results from each of these rounds was compared with the first round in which all requirements are available to show the difficulties that trees face in the environment when they are trying to get all the requirements they need to survive! Along with their free tree seedlings, students were given instructions on how to care for and plant their young seedlings.

"Then the disciples went back to their homes, but Mary stood outside the tomb crying. As she wept, she bent over to look into the tomb and saw two angels in white, seated where Jesus' body had been, one at the head and the

other at the foot. They asked her, 'Woman, why are you crying?' "They have taken my Lord away,' she said, 'and I don't know where they have put him.

At this, she turned around and saw Jesus standing there, but she did not realize that it was Jesus. 'Woman,' he said, 'why are you crying? Who is it you are looking for?' Thinking he was the gardener, she said, 'Sir, if you have carried him away, tell me where you have put him, and I will get him.' Jesus said to her, 'Mary.' She turned toward him and cried out in Aramaic, 'Rabboni!'(which means Teacher). Jesus said, ... Go instead to my brothers and tell them, 'I am returning to my Father and your Father, to my God and your God.' Mary Magdalene went to the disciples with the news: 'I have seen the Lord!' These are called banks beavers and they usually build a slopping banks out of mud and sticks, but they don't build a little dwelling in the dammed up water. They live like a muskrat, maybe a mile away.

We contacted the DNR about beavers in the Maumee River and he said that is not true or words to that effect. But he did say they heard a report of beaver damage in the Cecil area and he talked of the type of gnawing on the trees that I have had reported to me.

Then later he said these are a smaller type of beaver maybe. But he too said we don't have a big rodent type of beaver that builds dams and little houses in the pond.

Now that is just what Jim said, and Jim called them the banks beaver. Jim has worked in that type of terrain for years and I am inclined to believe his version of this deal. Because I have seem pictures of the beavers' work on the saplings in the Maumee, I'm sure we have a beaver of some species along the banks of the Maumee. See Ya!

Well, I haven't written for a while. Gen. Kearney, and Lieutenant Morgan and the other soldiers went back to the fort a few days ago. All four of our soldiers have stayed here as they are to be here all summer. We all worked in the garden these last few morning and we can rest a few days now. We are well into the summer now, as this is the last part of June of 1853. We had a big scare the other day. A big herd of buffalo came across the prairie and headed for our camp. We were very lucky, as when the leaders of the group came to the bridge, they turned west and we didn't have any damage at all. If they had crossed the river, they would have trampled our camp down into the ground.

At the very end of the charge, hunter shot a young buffalo calf. That calf's mother was mad, and wouldn't leave the camp. It's a wonder she didn't charge towards us, but after a while she moved away towards the herd.

We have quite a bit of news today. Callie told me she was going to have a baby next February the 14th. All of us are excited and sat around the fire at night, and talked about our families, and the number of brothers and sisters we had.

I came from Mississippi and was a stage coach driver out of El Paso. When I left home at fourteen years of age, there was already eight youngsters in the family. Callie said, when she left Cape May, New Jersey, to work at her uncle's hotel in North Platte, Nebraska, she had two brothers and a sister.

Rooster came from Missouri and when he left to join the army, he thought there were eleven in his family. He can't recall all the names.

Farmer left home at fifteen because his father worked him like horse, and treated him like one. He came from down around Ina, Illinois. He said, "We never had anything, because Dad drank it up." Weed & Feed Products

Control of these pesky weeds is done by applying a post-emergent weed control. Unlike digging or pulling weeds, weed controls get rid of weeds from the roots to help ensure the weeds cannot grow back from root stubs that may be left in the soil. This is not accomplished overnight. Instead, the weeds slowly disappear over a period of a few weeks as the weed control kills the roots. Weed controls come in both liquid and granular form. Whether liquid or granular, the weed control needs to have an opportunity to adhere to the leaves of the plant in order to be effective because the ingredients enter the weed primarily through the surface of the leaves.

apply the granular Weed & Feed to a freshly cut lawn. If within 24 hours of mowing, it will help the granules of nutrients and weed control absorb in the fresh cuts on grass and weeds alike. After application, avoid foot traffic on the lawn and hope the weatherman was right in predicting no rainstorms for 24-48 hours. The heavy rain and foot traffic with the 24-48 hour window could dislodge the granules and make the weed control less effective.


The timing of post-emergent weed control application is important if the lawn is to get the maximum benefit from the product. As a general rule, the application should be made when the weeds are actively growing. Application for the most northern part of the U.S. is recommended in mid- to late-spring. For our area this means an application should be made sometime in late April or early May when air temperatures are between 60-90 degrees F. other time for applying weed controls is in the early fall. From mid-September to early October, weeds are actively growing. Weeds are susceptible to the weed controls in the fall because they are naturally translocating nutrients to their roots in preparation for winter dormancy.

The only times weed controls should not be used is on newly planted grass. Once that new grass has had time to grow and be mowed at least four times (approximately 20+ days), then you can apply a weed control to the newly seeded area. If you've already applied a weed control but need to overseed, it is best to wait one month after you last application. Whether liquid or granular, using a weed control will help ensure your lawn stays weed free in the warmer weather to come!



On Thursday, April 20 PARC Lane in Paulding hosted a feature with the Ohio Treasurer's office showing how much people can now save who previously were not allowed to when collecting disability. The event brought in families from around the county with disabilities and the advantages that are able to be received with updated laws.

STABLE was brought in to show what can happen with investments now versus several years ago. The nationwide enrollment is now available in Ohio for all qualified people with disabilities that occurred prior to age 26. These are tax free savings plans for disability related expenses and they can save and invest without losing their needs based benefits that otherwise would have been lost.

The three criteria that must be followed: They must be eligible to receive SSI or SSDI due to disability; have a condition listed on SSA's "list of Compassionate Allowances Conditions"; or self certification. Each person can have 1 account.

Self Certification includes physical or mental impairment that causes, "marked and severe functional limitations" (listed SSA's Blue book). They would also have to certify that the condition has lasted or is expected to last for at least 1 year and provide your Physician's information along with the date of diagnosis.

This year Online Enrollment makes it much easier and takes only about 20 minutes and a \$50 opening deposit. This can also be authorized by a Legal Representative (ALR). An ALR can be a parent, guardian or a power of attorney.

The annual and lifetime savings limit has been significantly increased and this is good news for everyone! People can even gift into the account. The annual limit for deposit and/or gifting is \$14,000. The lifetime limit is \$426,000.

There are different investments available from savings with FDIC protection to very aggressive where the investment could be lost if there is a downturn in the market, but otherwise a high interest rate. The funds invested in Stable are able to be transferred to a personal checking or savings account or to the STABLE card (debit) that has a lot of control put on it. For example. It Does not pull directly from the account. It has protection limiting of merchants and not cash access and no overdraft. There is also no cash access so it can only be used for items needed.

When purchases are made on the card there is a now online spending records and each transaction can be noted for tax purposes at the end of the vear.

There are several SSI considerations and one is that balances over \$100,000 count as a resource and will suspend



SSI but it won't be terminated. The Medicate benefits will not be affected regardless of the amounts.

The presenter stated that if the account holder passes away, the account could be transferred to another sibling with a disability or it would go to the account holder's estate and be distributed as other assets would be.

PAULDING PUTNAM ELECTRIC ENCOURAGES SAFE TREE PLANTING

Spring is here and it's the best time of year to start planting young trees. Paulding Putnam Electric Co-op knows that planting trees is a great idea. However, as beautiful as trees can be in certain places, everyone always need to be aware of the best place to plant them based on their



height. Understanding spread distance and mature height of the tree being planted will prevent any dangers that could happen in the future. Trees that mature over 25 feet can cause shock, fire hazards, power outages and so many more dangers when planted too close to power lines. Just because the tree is short and far away from the power lines now, doesn't mean it will be 5 years from now.

When deciding what trees to plant in a specific location, consider planting a minimum of 20 feet away from power lines. Trees that have a mature height of 15 feet are recommended to place near power lines, such as shrubs and bushes. Small trees that have a height/spread within 25 feet include Star magnolia, Crabapple, and Lilac. Medium trees that are 25-40 feet in height/spread include Dogwood, Eastern Redbud, and American Arborvitae. Large Trees that have a height/ spread over 40 feet include Maple. Birch, and Oak. Another location to be aware of when planting trees is near underground utility services. The tree roots grow just as much as the tree itself does. As the roots continue to grow, they can interfere with underground pipes, cables and wires. If these roots cause damage to the underground wires, it could harm other plants or trees, possibly lead to removal.




