

We are working on a living will and wondering if it is right to withhold hydration and nutrition to help expedite death?

God says in Deuteronomy 32:39, "I kill, and I make alive." Psalm 68:20 says, "... unto GOD the Lord belong the issues from death." James 4:15 says, For that ye ought to say, If the Lord will, we shall live." Hezekiah's near death experience in II Kings 20 shows us God is to be in charge of life and death.

Modern artificial life support mechanisms sometimes make it hard to tell if it is God or we who are taking life, but withholding hydration and nutrition is definitely pushing God's will away for our own. The healthiest person will die a horrible death without food and water.

In James 2:15-16 God makes it plain we are not to withhold daily food from someone who needs it. "If a brother or sister be naked, and destitute of daily food, And one of you say unto them, Depart in peace, be ye warmed and filled; notwithstanding ye give them not those things which are needful to the body; what doth it profit." Matthew 25:41-46 indicates it is wicked to withhold food from the hungry and water from the thirsty, and to do so is as though you were doing it to Christ Him-

Quality of life is not always the issue. Through the years while calling on people who were in a dying and sometimes comatose condition, I have lead many other patients or family members to Christ. God was still using those who were dying in their bad "quality of life."

LATTA'S SELF-DRIVING CAR LEGISLATION PASSED BY ENERGY AND COMMERCE COMMITTEE

This morning, legislation authored by Congressman Bob Latta (R-Bowling Green) to aid self-driving car development, testing, and implementation by establishing a federal regulatory framework was approved by the U.S. House of Representatives Energy and Commerce Committee in a 54-0 vote. Latta, Chairman of the Subcommittee on Digital Commerce and Consumer Protection, has been a leader in the bipartisan effort to address safety issues and regulatory obstacles regarding autonomous vehicles.

"Self-driving cars have the potential to reduce traffic accidents and deaths, increase mobility, and improve quality-of-life," said Latta. "The legislation passed by committee was the result of a bipartisan effort, which involved over 250 meetings with interested stakeholders in 2017 alone. Congress can't get caught flat-footed on this new technology, and this bill ensures that a definitive framework is in place as industry develops, tests, and deploys autonomous vehicles."



PERDUE REGARDING JA-PAN'S PLANNED INCREASE OF TARIFF ON U.S. FROZEN BEEF

The government of Japan has announced that rising imports of frozen beef in the first quarter of the Japanese fiscal year (April-June) have triggered a safeguard, resulting in an automatic increase to Japan's tariff rate under the WTO on imports of frozen beef from the United States. The increase, from 38.5 percent to 50 percent, will begin August 1, 2017 and last through March 31, 2018. The tariff would affect only exporters from countries, including the United States, which do not have free trade agreements with Japan currently in force.

U.S. Secretary of Agriculture Sonny Perdue issued the following statement:

"I am concerned that an increase in Japan's tariff on frozen beef imports will impede U.S. beef sales and is likely to increase the United States' overall trade deficit with Japan. This would harm our important bilateral trade relationship with Japan on agricultural products. It would also negatively affect Japanese consumers by raising prices and limiting their access to high-quality U.S. frozen beef. I have asked representatives of the Japanese government directly and clearly to make every effort to address these strong concerns, and the harm that could result to both American producers and Japanese consumers."

U.S. exports of beef and beef products to Japan totaled \$1.5 billion last year, making it the United States' top mar-

'The soils were as black as midnight", the saying goes. As we certainly all know, the area we now live and work in was once part of the Great Black Swamp where the woodland and wildlife were plentiful and plenty of swampland was to be found. It is said that this swamp covered nearly 1,500 miles or 960,000 acres across northwest Ohio in what is now the counties of Paulding, Defiance, Van Wert, Henry, Putnam, Wood, Sandusky, Hancock and Seneca. How did this wetland form? What lived in the wetland? What happened to it? Are there any parts of it left? Read on to find the answer to these questions and so much more!

Before we get too far, do you know what a swamp is? By definition, a swamp is a wet, spongy land saturated and sometimes partially or intermittently covered with water. It contains what is called hydric soils which are soils that formed under flooded conditions long enough during the season to develop anaerobic (no oxy-

gen) conditions in the upper layers. According to Historians at Sauder Village, the Great Black Swamp formed thanks to the Wisconsin Glacier which blanketed the area some 20,000 years ago. The enormous power and force associated with the glacier took what was once rugged terrain and flattened it out while also leaving a thick layer of clay in its aftermath. This clay left behind would prove to be a great base for the wetland that would follow behind as clay is the best soil particle to hold in water.

Glacial End Moraine

Clay was not the only thing left behind as there were some ridges of sand also deposited which distinguished one section of the swamp from the other. Sauder Village writes that most of the swamp was uniform in appearance and had a multitude of slow moving streams that helped drain it. Prairies were also a feature of the swamp and could be found in Wood and Sandusky Counties.

Soils of the Great Black Swamp were quite unique to say the least. As stated above, clay was a common soil particle found in the swamp that was great at containing the water. The Great Black Swamp Exhibit at Sauder Village does a great job explaining the layers of the soil making up the swamp. The surface layer was a dark black loam formed from plant material which had decayed. The middle layer had a yellowish color and was a clay type soil with some small pebbles mixed in. Below the middle layer, the lower soil layer was a clay that was blue in color while the bedrock layer was composed of limestone.

It was the well put together soil which drew in the settlers and made the area appealing to farmers who saw the rich, dark soil as an opportunity to be successful. At first, it was a great idea to drain the swamp which left behind that rich soil, but as time goes on, we have learned the richness is not found in as great of quan-

Dense forests were a staple of the Great Black Swamp. It is said that once the tree leaves and other various plant parts fell to the ground and decomposed, the water would turn black thus giving the name Great Black Swamp, according to Sauder Village. Common in the swamp was a variety of walnut, maple, cottonwood, ash, elm, and giant oak trees which grew to great heights and created quite a dense forest according to Historic Perrysburg.

Historic Perrysburg notes accounts that water in the swamp was so deep that if could touch the belly of a horse and would stay at such a level until the hot weather of the summer months took hold. When the ice thawed in the spring or the rains came,

there was plenty of muck to be left behind. With the constant standing water, you can certainly imagine that disease was certain to follow as well. Diseases such as cholera, typhoid, and malaria carried by pesky mosquitoes. Historic Perrysburg writes that many of these fevers and diseases which took a range of three to five years to get rid of and brought on chills and shakes as some of the many symp-With the rich soils found

in the area, pioneers and farmers saw a great opportunity in the swamp. It was in the 1840s that the swamp was first drained to clear it for farmland but also to rid of the fevers which plagued many. Some water drained from the swamp and trees cleared away were use on the canal systems that traversed through the area during this time. During the drainage of the swamp, we begin to see farmers first putting field drainage to use when they would dig ditches to move the swampy water to the nearest stream.

By the time 1850 came around, the Ohio General Assembly passed legislation signaling their support for drainage systems to clear the swamp which caused people to take advantage of this opportunity and settle the area. The job of draining the swamp was certainly not easy. By the time 1900 rolled around, very few areas of the Great Black Swamp remained.

Where can you find a good idea of what the Black Swamp may have been like? First, the Black Swamp Nature Center in Paulding is a great start to see wetlands right here in Paulding County. Another place to check out would be Goll Woods State Nature Preserve located near Archbold in Fulton County. According to their website, Goll Woods shows what a Black Swamp forest looked like as it features a multitude of giant bur oaks, white oaks, cottonwoods, and much more which are two hundred plus years old! Visit www.naturepreserves.ohiodnr.gov/gollwoods for more information on this great nature preserve.

If you wish to know more about the Great Black Swamp, WBGU-PBS out of Bowling Green has a great documentary titled "The Story of the Great Black Swamp" that is available for purchase on DVD or you can view it on their website. It is definitely a must see! Hopefully you have come to now enjoy learning about such a great feature of nature right in our own backyards!

UPCOMING ODOT WORK THIS WEEK JULY 31, 2017

The following is highway construction scheduled to occur within Defiance, Paulding, Putnam and Van Wert Counties.

Defiance:

State Route 2/state Route 49 within the village of Hicksville will close August 1 for approximately two weeks for excavation of a manhole. Traffic detoured onto state Route 18, U.S. 127 and U.S. 24 back to state Route 2 and state Route 49. Work is being performed by Vernon Nagel Construction, Napoleon, for the village of Hicksville.

State Route 18 between township Road 115 and Glenberg Road will close beginning August 28 for culvert replacements at three locations: two located west of Sherwood, one east of Sherwood. Work is being performed by Napoleon. Closures will occur consecutively as follows:

Culvert #1, located between Cicero Road and Rosedale Road, will close August 28 for 25 days. Traffic detoured onto state Route 2, state Route 249 and U.S. 127 back to state Route 18.

Culvert #2, located between Openlander Road and Behnfeldt Road, will close for 25 days following completion of culvert #1. Traffic detoured onto state Route 2, state Route 249 and U.S. 127 back to state Route 18.

Culvert #3, located between Flickinger Road and Glenberg Road, will close for 30 days following completion of culvert #2. Traffic detoured onto U.S. 24 and U.S. 127 back to state Route 18.

The entrance ramp from Baltimore Street to westbound U.S. 24 closed July 10 for approximately 60 days. The ramp was to close initially for one day only, but due to concerns with traffic merging onto U.S. 24, the ramp will now remain closed for the duration of the project.

As noted in the letter to the Commission, Secretary Husted is hopeful that the information provided will be used to help educate others about how elections are conducted in each state.

'I trust that in responding to the Commission, the information we are providing will assist you in sharing the facts about the system of elections that are carried out by each of the 50 states."

The letter to the Commission also outlines Secretary Husted's efforts to address voter fraud in Ohio. As the first Ohio Secretary of State to compile statewide voter fraud reports, Secretary Husted informed the Commission of his findings related to voter fraud and suppression, as well as non-citizens on the rolls.

"Identifying and addressing any instance of voter fraud, no matter how limited, is important because every vote matters. Over the last four years, Ohio has had 112 elections decided by one vote or tied," Secretary Husted wrote. "While none of these elections were impacted by the cases of voter fraud we have uncovered, it serves as an example why we as election officials must remain diligent in our efforts to preserve

the integrity of our elections."





This procedure is to be used until such time as the temperature is below 84 degrees as no combination of heat and humidity at that level will result in a need to curtail activity.

- 1. Thirty minutes prior to the start of activity, temperature and humidity readings should be taken at the site.
- 2. The temperature and humidity should be factored into the Heat Index Calculation and Chart and a determination made as to the Heat Index. If schools are utilizing a digital sling psychrometer that calculates the Heat Index, that number may be used to apply to the table.
- 3. If a reading is determined whereby activity is to be decreased (above 95 degrees Heat Index), then rereadings would be required every thirty minutes to determine if further activity should be eliminated or preventative steps taken, or if an increased level of activity can
- 4. Using the following table, activity should be altered and/or eliminated based on this Heat Index as determined:

Under 95 degrees Heat

• Optional water breaks every 30 minutes for 10 minutes in duration to allow hydration as a group.
