



#### HIKE THE DIKES AT MAGEE MARSH WILDLIFE AREA

Walkers, birders, and wildlife enthusiasts are encouraged to participate in the Hike the Dikes program at Magee Marsh Wildlife Area and Ottawa National Wildlife Refuge. Hikes take place the second Saturday of each month April through September according to the Ohio Department of Natural Resources (ODNR).

The Hike the Dikes program is free and open to all ages and interest levels, and provides opportunities to explore the natural wonders of Magee Marsh Wildlife Area and Ottawa National Wildlife Refuge. All walks are led by a trained and knowledgeable guide. Participants will learn about local wildlife such as birds, reptiles and amphibians, butterflies and marsh mam-

Main mals, as well as, wetland 419- plants and more.

Hike the Dikes is a partnership program between ODNR Division of Wildlife – Magee Marsh Wildlife Area, U.S. Fish and Wildlife Service – Ottawa National Wildlife Refuge, and Black Swamp Bird Observatory. Each walk is hosted by one of the partner agencies. Hike dates for 2018 include April 14, May 12, June 9, July 14, August 11, and September 8.

Hikes begin at 9:00 a.m. and usually last one to two hours, depending on the weather. Starting locations are dependent on the hosting agency. The hike in April will meet at the Sportsmen's Migratory Bird Center at Magee Marsh Wildlife Area, located at 13229 West State Route 2, Oak Harbor 43449. All other hikes will meet at the Ottawa National Wildlife Refuge Visitor's Center, located at 14000 West State Route 2, Oak Harbor 43449.

Anyone who attends three or more Hike the Dike walks in 2018 will receive a free hiking stick. For more information call Magee Marsh Wildlife Area at 419-898-0960 ext. 21 or Ottawa National Wildlife Refuge at 419-898-0014. To learn about other available programs, visit wildohio.gov.



I've often wondered how Noah could have had enough room on the Ark to house and feed all the animals for one year.

I know it seems hard to believe, but the Bible gives some pretty astounding figures as to the size of that Ark. Genesis 6:15 says it was 300 cubits long, 50 cubits wide, and 30 cubits high. If we take a cubit to be about 18 inches, the dimensions would be 450 feet by 75 feet by 45 feet high.

It would appear that Noah took many years (some say 100) to build the Ark and likely had help (perhaps from his sons). God told him to put food, the animals (two of every kind or species plus seven pairs of every clean beast) and his family into the Ark.

That ship was capable of carrying a load equal to 522 railroad cars. It would only take about 188 railroad cars to handle 45,000 sheep-sized animals. Today we have about 17,600 species of animals of varying sizes. This would leave the equivalent of three trains of 104 cars apiece for food.

There are many theologians today who are trying to tell us that the Bible is full of myths and errors, but they are wrong. Many things in the Bible are hard to believe if you don't search them

I WONDER WHAT IT WAS LIKE?

As I sit here in my famous corner with a window that looks out over Antwerp's busy thoroughfare and right outside is River Street; that used to be the main trail for General Anthony Wayne's men from Toledo to Fort Wayne. I wonder what it was like.

In the late 1820's a couple of pioneers came along and settled down, namely Mr. Curtis, as he built a fur trading store over in Crane Twp.

What comes to mind now is that line from the poem Hiawatha; right behind them rose the forrest, the dark and gloomy forrest.

As I understand, it was solid wood, hundreds of years old timbers, knee deep, black muck from millions of acres of decaying leaves, water that couldn't drain and insects that you can't imagine. I guess the best way to travel was by boat on the river. Most of the settlers came from the Toledo-Defiance area and worked their way into Carryall Twp.

I guess the government bought the land from the Indians and around 1805 to 1820 the Maumee Valley was made ready for settlers. A survey was made and counties and townships were laid out.

Carryall Township was laid out in 1829 and was part of Williams County.

General Curtis put up that trading post and that area was named Craneville after a man named Crane that settled in that area.

But on up the river, across the Indiana line was a Knagg Indian reserve, there was a lot of action north of Antwerp as a number of French soldier relics had been dug up there. All of this action was before 1800.

Antwerp, in 1835, was just getting settled. It was surveyed and laid out in 1841. Along about that time, General Curtis built the first store down at the south end of what is now Main St, as the canal would be dug there in a year or two. The canal was finished in 1843. The road to the Maumee from Hicksville laid out in 1844 & 45, they named it Antwerp in 1844. Antwerp became incorporated in 1864 and it has progressed each year until now. We are about

4700. I guess they call it progress, but the hotels are gone, the railroad is practically gone, the canal and reservoir are gone, the Anthony Wayne Trail has been moved and now called US 24, the livery stable is gone, but so is the black muck, the woods, the insects and standing water.

We are now an up and coming city with a great high school, all kinds of city utilities, great streets, curbs and drainage, a beautiful park and veterans memorial.

And here at the West Bend News, right above me is a duct that gives me lots of heat in the winter and cool air in the summer and a number of people who help me all the time.

I wonder what it was like. See ya!

#### UNDERSTANDING PAULD-ING COUNTY SOILS

So, you have lived in Paulding County for many years or maybe you have just moved into the area. Regardless of how long you have called Paulding County home, do you know about the soils that make up our county and the properties that come along with those soils such as drainage capability or the potential for slippage? In this article, it is my hope to give a brief overview on the land that makes up Paulding County so that you can be informed when utilizing the land for agricultural, building, or recreational purposes.

Let's first get a general understanding of Paulding County. You certainly don't need me to tell you how abnormal our climate can be, how much clay is in our soils, nor how flat Paulding County is. The soil survey gets it spot on when it says that Paulding County is "level to gently sloping" with not too much in the way of elevation change taking place in the county. Our county has several small streams and two rivers which crisscross the area and it has wetness which is a major limitation which has an impact on how the soils are used. According to the USDA Soil Survey, precipitation received in the winter allows for a good accumulation of soil moisture by the time spring rolls around and as you can imagine our soils are primarily used for row crop production and livestock.

Paulding County is noted for its broad area of flat slopes formed by the various glacial lakes that once inhabited the area As far as the soils found in Paulding County, we have Paulding, Roselms, Fulton, Latty, and Toledo soils which formed due to the clayey sediment left behind by the glacial lakes found primarily in the central and eastern sides of the county. For those in the western half of the county, Hoytville, Nappanee, and St. Clair soils make up the soil profile where action by the lake flattened out the slope and modified the till, which is material and sediment picked up by the action of glaciers, according to the Soil Survey.

soils. The USDA has a tool called the Soil Survey that is available in print at our office or via the web at websoilsurvey.nrcs.usda.gov. Most are likely apt to use to web version now which allows you to enter your location into the map with soil information populated tailored to your location with soil types laid out on a nice map. Should you ever need assistance with this tool, be sure to stop in at the Paulding SWCD office and we will happily assist! The names given above described soil series, which are a group of soil types that developed from similar parent materials (rocks, minerals, organic matter) under comparable climatic and vegetation conditions

One natural resource of many that are important to Paulding County would have to be our soils when thinking about the crops and livestock raised on this natural resource. The clay which makes up our soils was quite valuable to the early farmers in the area. According to the Soil Survey, clay was used in tile manufacturing when it came to drainage purposes but also as brick in building construction. Plastic tile and alternative building materials have since made the clay pits and kiln ovens a faded memory.

A question that seems to come up when development is being planned or when it comes to agricultural production is the limitations that come with the soil type. If there is one limitation that is to be highlighted given our clay soils, it would have to be for the potential for slippage. Not sure what that is? Soil slippage is essentially shallow landslide that involves loose material laying above unweathered bedrock. Put another way, it is a downslope movement of weathered material (such as soil), due to stressors that have accumulated beyond the ability of the material to resist collapsing, according to the US Forest Service.

Retired USDA Soil Scientist Frank Gibbs notes this is due to the high expansion clays found in Paulding County, especially near the Paulding-Putnam county line which he says form "Slickenslides" on the "bowl shaped" faces in the cracks of the soil. Before we continue, it helps to define some additional terms. A soil aggregate consists of many fine soil particles held together in a cluster while a ped describes an individual soil aggregate. Frank Gibbs notes that the peds in our area are about the sizes of "washtubs" to a "car hood" which crack widely open during dry periods, as many farmers around Paulding County know. As a rain comes, water enters these cracks and "greases" the peds, thus creating the "slickenslide" conditions according to Gibbs. He further notes these high expansion clays as one factor behind higher than normal road maintenance costs.

#### OHIO AGRICULTURAL LAW BLOG--AG ISSUES IN THE FEDERAL SPENDING BILL

Peggy Kirk Hall, Asst. Professor, Agricultural & Resource Law

Amidst a great deal of controversy, President Trump signed the "Consolidated Appropriations Act, 2018" on March 23. The omnibus \$1.3 trillion spending package includes a number of provisions that affect agriculture, not all spending related. One glaring omission from the bill that agriculture wanted, however, was language allowing the EPA to withdraw the Waters of the United States (WOTUS) rule. Otherwise, the new law contains fixes and clarifications for several key legal issues agriculture has faced in the past year and funding for important agricultural programs.

Section 199A tax deduction revised

Sellers of grain who were hoping to capitalize on the IRC § 199A 20% gross sales deduction when selling grain to their cooperative will be disappointed that the spending bill has removed the deduction and that the removal is retroactive to January 1, 2018. Congress enacted new provisions that will address sales to cooperatives. According to my colleague and tax expert Kristine Tidgren at Iowa State, "the cooperative patron is subject to a new bifurcated calculation and a hybrid 199A deduction. Essentially, the fix gives the cooperative patron a deduction that blends the new 199A deduction with the old 199 DPAD deduction (all within the new 199A). Depending upon their individual situations, cooperative patrons may be advantaged, disadvantaged, or essentially treated the same by selling to a cooperative rather than selling to a non-cooperative." CERCLA emissions reporting for livestock goes away The spending bill incorporates provisions of the Fair Agricultural Reporting Methods Act" proposed earlier by a bi-partisan group of Senators concerned about a

court ruling that subjected farms to air emissions reporting under the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA) (explained in our previous post). The EPA had delayed the reporting requirement to May 1, 2018. The reporting mandate is removed under the new law, however, which states that air emissions from animal waste at a farm are not subject to CERCLA reporting requirements, nor are emissions from the application, handling or storage of registered pesticides. A "farm" is an area used to produce crops or livestock that have a total value of \$1,000 or more.

#### Electronic logging device rule further delayed

We've reported several times on the Electronic Logging Device (ELD) rule that would require commercial agricultural haulers to utilize electronic technology that automatically records hoursof-service data. The Federal Motor Carrier Safety Administration (FMCSA) issued several waivers that delayed the requirement. The new spending bill effectively voids the ELD rule until September 30, 2018, by prohibiting the FMCSA from using its funds during that time to implement, administer, or enforce provisions regarding the use of electronic logging devices by operators of commercial motor vehicles transporting livestock or insects.

County-level ACRE pilot program to be established

The spending bill directs USDA to create a 2018 pilot program for county-level agriculture risk coverage (ARC) payments for the 2017 crop year. Farm Service Agency offices in each State will have the opportunity to provide agricultural producers a supplemental payment to ensure that there are not significant yield calculation disparities between comparable counties in the State.

## Rural broadband grant program funded

The law allocates \$600,000,000 for the USDA to conduct a new broadband loan and grant pilot program under the Rural Electrification Act. At least 90 percent of the households to be served by the project receiving a loan or grant under the pilot program must be in a rural area currently without sufficient access to broadband.

## Conservation funding maintained

The spending bill maintains full funding levels for farm bill conservation programs and exempts farms participating in conservation programs from obtaining System for Award Management (SAM) and Data Universal Numbering System (DUNS) numbers. The Great Lakes Restoration Initiative received \$300 million to carry out activities that would support the Initiative and the Great Lakes Water Quality Agreement, including grants for research, monitoring, outreach, and implementation.

#### Research funding increased

In stark contrast to significant cuts proposed by the White House, the spending bill contains the largest increase in research funding in over a decade. Research programs at the USDA would grow by \$33 million, to \$1.2 billion. The funding includes a \$25 million increase to a \$400 million budget for the Agriculture and Food Research Initiative (AFRI) established by the 2008 Farm Bill, surprisingly still \$300 million shy of the 2008 Farm Bill's proposed funding level.

#### E&C MEMBERS INTRO-DUCE BIPARTISAN BILL TO REFORM & IMPROVE PROCESS FOR REGULAT-ING OVER-THE-COUNTER MEDICINES

Congressman Bob Latta (R-OH) has introduced bipartisan legislation with members of the Energy and Commerce Committee to reform the outdated over-the-counter (OTC) monograph system. The legislation, the Over-the-Counter Monograph Safety, Innovation, and Reform Act, modernizes the monograph framework and allows new, safe products to come to market more quickly while addressing safety issues and expanding consumer choice. This would allow the Food and Drug Administration (FDA) to make scientific determinations for OTC ingredients through an administrative order process, which is much more efficient than the current rulemaking system. Introducing the legislation with Rep. Latta are Rep. Michael Burgess, M.D. (R-TX), Rep. Gene Green (D-TX), Rep. Diana DeGette (D-CO), Rep. Brett Guthrie (R-KY), and Rep. Debbie Dingell (D-MI).

"Nearly every American uses over-the-counter products in some way," said Latta. "Whether it's treating allergies, helping with a cough, or seeking relief for a headache, consumers want medicine that is safe, reliable, and af-

fordable. It's time to create a pathway for industry to enhance over-the-counter medicines and develop new, innovative products that will be a welcome addition to the current products so many American's depend on today. By modernizing the decades-old monograph system and improving the way OTC drugs are approved, this bill will provide more certainty for manufacturers, ensure consumer confidence, and foster innovation. The legislation introduced today was the result of bipartisan collaboration and discussion, and it's a big win for the countless consumers that purchase overthe-counter products."

"As a physician and more recently as a congressman, I have witnessed much change in the health care industry over the last 40 years; however, the over-the-counter monograph system has not had a significant update since 1972," said Burgess. "With more than 300,000 over-thecounter products on the market, that is far too long to wait. The bill introduced today will ensure that American development remains at the helm of over-the-counter drug innovation. I am grateful to Congressman Latta for his leadership on this issue, and I look forward to bringing our over-the-counter monograph system into the 21st century."

"I'm pleased to work together with my colleagues on a very important bipartisan bill that will streamline and modernize FDA's Over-the-Counter (OTC) monograph system and create user fees to provide much needed resources to improve the oversight and approval of OTC products," said Green. "The monograph system will become more flexible, better reflect the top science we have, and be more responsive to public health concerns when they emerge. I believe it will also encourage innovation in OTC products by assuring sponsors of future applications that they will not be faced with unhelpful administrative burden or delay."

"I'm proud to have shepherded this legislation along from research to writing to this latest step," said DeGette. "It will modernize how the FDA reviews over-the-counter medicines, a process that has not been updated since the 1970s. The current system simply has not kept pace with science, innovation and growth in the OTC market. Most importantly, this bill takes commonsense steps that will help the FDA prevent and address safety issues rapidly and efficiently."

'Over-the-counter drugs provide an affordable way for Americans to seek medical treatment," said Guthrie. "Unfortunately, the current FDA approval process for products over-the-counter is too slow, delaying important innovations that can help patients more quickly. The Over-the-Counter Monograph Safety, Innovation, and Reform Act will reform and modernize the antiquated monograph approval system and allow more innovative drug treatments to enter the market safely. I was proud to work with Representatives Latta, Burgess, Green, De-Gette, and Dingell on this bill, and I am working with all of our colleagues on the Energy and Commerce Committee to move this bill as soon as possible."

"Americans rely on overthe-counter medicines to treat everything from colds to headaches," said Dingell. "As scientific research advances, we must ensure that the approval process for these products keeps pace with innovation. Unfortunately, the over-the-counter drug system hasn't been updated in decades, delaying innovative treatments and making it harder for FDA to do its job of keeping people safe. I'm pleased to introduce this bipartisan legislation with my colleagues to modernize this broken system so we can ensure that new, safe and reliable products get to those who need them."

The OTC monograph system was established in 1972 by the Food and Drug Administration (FDA) to review the safety and efficacy of the OTC medicine ingredients then on the market, including doses, formulations, and labeling. Any OTC that conforms to a monograph may be manufactured and sold without an individual product approval. In the 45 years since the system was created, the process has not been completed and movement on unfinished items has been slow. The system has become a hindrance that does not allow for advances in science and new information concerning the safety of an ingredient.

The draft legislation updates the monograph process by specifically adding a new section to the Food, Drug, and Cosmetic Act to:

• Move away from the cumbersome current monograph finalization process to an administrative order procedure. Additional processes will be in place to ensure recourse should issues arise.

• Create new pathways to innovation for monograph products benefiting consumers, where none currently ex-

• Ensure the new drug approval pathway and other nonprescription drugs otherwise lawfully marketed are not affected.

• Include by reference existing OTC Review Final Monographs and deem final Tentative Final Monographs by statute.

#### **SOYBEAN TARIFFS EX-PECTED TO HIT OHIO FARMERS HARD**

Soybeans have now been added to the list of American products slated for tariffs in China, a move expected to hurt Ohio farmers in a state whose main crop and agricultural export is soybeans.

China is Ohio's most important soybean export market, so a tariff on American soybeans likely would drive down crop demand and the price Ohio farmers receive for the crop, said Ian Sheldon, an agricultural economist, who serves as the Andersons Chair in Agricultural Marketing, Trade and Policy with The Ohio State University's College of Food, Agricultural, and Environmental Sciences (CFAES).

"I knew it was coming," Sheldon said. "This is obviously going to hurt farmers."

In 2016, soybeans were Ohio's largest agricultural export, totaling \$1.4 million. Nearly half of what was exported (40 percent) went to China, according to the U.S. Department of Agriculture.

The demand for U.S. soybeans in China has been strong in recent years, fueled by the growing demand for meat in the Chinese diet and soybean meal to feed those livestock. Ohio is ranked sixth in the nation for soybean production.

It's unclear if or when China will follow through on the threat of 25 percent tariffs on American soybeans in China. But if the country does follow through, and American soybean prices in China go up, other countries could step up to supply more soybeans to China, and they could be sold cheaper without the tariffs. In the long term, that could cause the United States to perma-

nently lose a significant share of the soybean market, Sheldon said.

"U.S. farmers may not be able to grab that market share back," he said.

Across the United States, about one in every three rows of soybeans grown is exported to China, said Ben Brown, who runs CFAES's farm management program, which provides farm policy and market information to Ohio farmers and others.

A 25 percent tariff on American soybeans in China would change that ratio to one out of every five soybeans rows grown going to China, Brown said.

'The soybeans that don't get sold to China are going to need a buyer somewhere," he said.

Typically, soybeans aren't planted until early May in Ohio, so farmers still may have time to change their mind about how much of the crop to plant. The tariff threat may change some of their planting decisions, but likely won't cause them to shift dramatically away from planting soybeans, said Barry Ward, an agricultural economist with CFAES.

'This is creating some uncertainty," Ward said. "(But) producers know that lots of things can change between now and harvest."

Soybeans are one of 106 U.S. products that China announced today (April 4) it will impose tariffs on. In addition to agriculture, the other two main areas targeted are aircraft and automobiles.

China's tariff threat is the latest move in an ongoing back and forth with China that began March 8 when President Donald Trump imposed 25 percent tariffs on imported steel and a 10 percent tariff on imported aluminum from most countries, including China.

If the Chinese impose the tariff on soybeans, as well as on other agricultural products that they have announced, including pork and wine, that could change farmers' opinion of Trump, which has been largely supportive, Sheldon said.

"This may be the straw that breaks the camel's back," he said. "I think farmers haven't walked away from the administration yet, but they might, in time."

The demand for truck drivers is increasing rapidly. In the next few years, nearly 900,000 new drivers will be needed. Programs like the Vantage CDL class will be critical in trying to fill the need.

The 200-hour CDL Training program at Vantage is designed specifically to help prepare students to pass the Commercial Driver License (CDL) test and cover the topics they will need to succeed in the trucking industry as a professional truck driver. Students receive 50 hours of classroom instruction and 150 hours of hands-on training. As an added bonus, students who do not have their high school diploma will have the opportunity to obtain their high school diploma equivalency at the same time as the CDL class.

The Vantage CDL program "re-boot" is now under the direction of Jim Rosen, who has over 22 years of experience as a CDL training instructor. He is a former over-the-road truck driver for Schneider National Carriers and a veteran of the US Army. Jim has also served as the CDL Training Manager at Apollo Career Center.

Chuck Peters, one of the instructors for the program, noted that students who successfully complete the program and earn their CDL could make between \$50,000 to \$60,000 a year to start,

with more money possible after a few years of driving experience.

The cost of the CDL program is \$4,800, but Vantage has been awarded a grant from the OhioMeansJobs Development Workforce Revolving Loan Fund that would pay much of the cost of the class for qualifying students.

The next daytime class is scheduled to begin June 4, 2018. Investigators also inspected freezers to ensure legal fish species and size requirements of fresh water fish were met, and checked businesses for the illegal sale of invasive species, such as big head and silver carp, which are required to be headless or eviscerated. Investigators conducted a total of 23 inspections and issued three warnings for not having a wholesale permit from the ODNR Division of Wildlife.

Over the course of two months, several witnesses came forward, resulting in numerous charges against the men including hunting without a license, hunting without deer permits, taking more than one antlered deer, deterring a state wildlife officer, possession of untagged deer parts, and hunting without permission. All six men were convicted in court and ordered to pay fines and court costs totaling more than \$2,500. Deer antlers and firearms seized during the investigation were forfeited to the ODNR Division of Wildlife. Furthermore, three of the men lost their hunting privi-

leges for two years. During deer gun season, State Wildlife Officer Jason Warren, assigned to Ashtabula County, received a hunting without permission complaint from a landowner. He responded to the area and met with the complainant. Officer Warren was able to follow the suspect's footprints in the snow through woodlots, fields, a wetland, and across a set of railroad tracks to a residence. He contacted the suspect who thought the property was owned by a real estate company and believed that no one would care if he hunted the area. The man was issued a summons for hunting without permission and paid a \$245 fine in Ashtabula Municipal Court.

They found dozer tracks coming from the local roads and continuing onto the wildlife area where the dozer had been used to make roads to access the timber that was stolen. Officer Baker was able to get information about a suspect who had recently rented a dozer and sold timber. In September 2017, Officer Baker, State Wildlife Officer Wes Feldner, assigned to Monroe County, and Wildlife Officer Supervisor Bryan Postlethwait visited the area to locate the residual stumps, collect information about the timber that had been taken, and assess the amount of damage caused by the dozer. #### **USDA REOPENS ENROLL-**MENT FOR IMPROVED DAIRY SAFETY NET TOOL

#### **Bipartisan Budget Act** Makes Substantial Program Changes

U.S. Secretary of Agriculture Sonny Perdue is encouraging dairy producers to consider enrolling in the new and improved Margin Protection Program for Dairy (MPP-Dairy), which will provide better protections for dairy producers from shifting milk and feed prices. With changes authorized under the Bipartisan Budget Act of 2018, the U.S. Department of Agriculture's (USDA) Farm Service Agency (FSA) has set the enrollment period to run from April 9, 2018 to June 1, 2018.

"We recognize the financial hardships many of our nation's dairy producers are experiencing right now. Folks are losing their contracts and they are getting anxious about getting their bills paid check come in lower and lower each month. The Bipartisan Budget Act provided some much-needed incentives for dairy producers to make cost-effective decisions to strengthen their farms, mitigate risk, and conserve their natural resources," said Secretary Perdue. "This includes our support of America's dairy farms. We encourage dairy producers to review the provisions of the updated program, which Congress shaped with their feedback. Those changes are now in effect, and I'd ask any producers who are interested to contact their local USDA service centers."

#### About the Program:

The program protects dairy producers by paying them when the difference between the national all-milk price and the national average feed cost (the margin) falls below a certain dollar amount elected by the producer.

#### Changes include:

Calculations of the margin period is monthly rather than bi-monthly.

Covered production is increased to 5 million pounds on the Tier 1 premium schedule, and premium rates for Tier 1 are substantially lowered.

An exemption from paying an administrative fee for limited resource, beginning, veteran, and disadvantaged producers. Dairy operators enrolled in the previous 2018 enrollment period that qualify for this exemption under the new provisions may request a refund.

Dairy operations must

#### for 2018, even if you enrolled during the previous 2018 signup period. Coverage elections made for 2018 will be retroactive to January 1, 2018. All dairy operations desiring coverage must sign up during the enrollment period and submit an appropriate form (CCC-782) and dairy operations may still "opt out" by not submitting a form. All outstanding balances for 2017 and prior years must be paid in full before 2018 coverage is approved.

Dairy producers can participate in FSA's MPP-Dairy or the Risk Management Agency's Livestock Gross Margin Insurance Plan for Dairy Cattle (LGM-Dairy), but not both. During the 2018 enrollment period, only producers with an active LGM-Dairy policy who have targeted marketings insured in 2018 months will be allowed to enroll in MPP-Dairy by June 1, 2018; however, their coverage will start only after active target marketings conclude under LGM-Dairy.

USDA has a web tool to help producers determine the level of coverage under the MPP-Dairy that will provide them with the strongest safety net under a variety of conditions. The online resource, available at www.fsa.usda.gov/ mpptool, allows dairy farmers to quickly and easily combine unique operation data and other key variables to calculate their coverage needs based on price projections. Producers can also review historical data or estimate future coverage based on data projections. The secure site can be accessed via computer, smartphone, tablet or any other platform.

The Commissioners ask the following questions: What is the estimated reve-nue? Revenue is basically, when you look at the general fund, it's going to be other sources (LGF). You must have some millage on properties for general fund. This last year, Mayor, do you know what your expenses out of general was? \$56,073.20. Mr. Mescher stated that they don't know how much of that is sewer. The general fund includes, \$19,000 paid out for tanks, pumps, motors and guide bars, all for the sewer system. This was done, we got partial reimbursement from the insurance company from the electrical storm. Projected expenses in 2016, receipts were \$56073.20; general balance - \$52,185.06 end of 2017. Commissioner Zartman indicated to Mayor Moon that the Com-missioners are concerned, we understand your desire to make the community a better place to reside, live and buy a home and be able to make sewer payments. With limited resources, we need to make sure that you can absorb the debt. Com-missioner Klopfenstein mimed their concerns, if there is ever a default, who is liable. I'm very cautious of who assumes the debt if something were to happen. I would echo Tony's concerns. We want people moving into our villages that can contrib-ute. 

#### **USDA ISSUES FINAL DECISION ON CALIFORNIA FEDERAL MILK MARKETING** ORDFR

The U.S. Department of Agriculture (USDA) published in the Federal Register a final decision to establish a Federal Milk Marketing Order (FMMO) for California. The proposed FMMO would incorporate the entire state of California. The final decision is based on the evidentiary record of a public hearing held in Clovis, Calif., from September to November 2015. A recommended decision regarding the proposed program was published Feb. 14, 2017.

USDA will conduct a referendum among dairy producers to determine whether they support the proposed FMMO. The referendum will be held from April 2, 2018 through May 5, 2018. USDA will mail ballot materials to all known eligible dairy producers supplying milk to the proposed marketing area. The FMMO would become effective if approved by two-thirds of the voting producers, or by producers of two-thirds of the milk represented in the vot-

ing process. FMMOs are legal in-

struments that regulate the sale of milk between dairy farmers and the first buyer. Where appropriate, the proposed California FMMO adopts the uniform order provisions contained in the 10 current FMMOs in the national system. These uniform provisions include, but are not limited to, dairy product classification, end-product price formulas, and the producer-handler definition. The proposed order would recognize the unique market structure of the California dairy industry through tailored, performance-based standards to determine eligibility for pool participation. The proposed order provides for the recognition of producer quota as administered by the California Department of Food and Agriculture (CDFA).

California represents over 18 percent of all U.S. milk production and is currently regulated by a state milk marketing order administered by CDFA.

Along with issuing this final decision, USDA conducted a Regulatory Economic Impact Analysis to determine the potential impact of regulating California milk handlers under a FMMO on the milk supply, product demand and prices, and milk allocation in California and throughout the United States. The entire hearing record, including the Regulatory Economic Impact Analysis, is available at www.ams.usda. gov/caorder. Today's Federal Register notice is available at: www.regulations.gov.

USDA will hold a public meeting beginning at 9:00 a.m. on Tuesday, April 10, 2018, in Clovis, Calif., to answer questions related to how the proposed California FMMO would operate and how eligible dairy producers can participate in the referendum. Interested parties will have the opportunity to attend in person or watch the meeting live via webcast.
