

JERRY SNODGRASS NAMED NEXT OHSAA EXECUTIVE DIRECTOR



Longtime high school coach, athletic director and **OHSAA Assistant Director** will become OHSAA's 10th leader

COLUMBUS, Ohio - The Ohio High School Athletic Association Board of Directors has named Jerry Snodgrass as the OHSAA's next

Executive Director. dgrass will assume leadership duties in September when Dr. Dan Ross steps down after 14 years at the helm. Snodgrass will be the OHSAA's 10th leader in its 111th year of service to Ohio schools.

A native of Upper Sandusky, Ohio, Snodgrass served as a teacher, coach and administrator at schools including Defiance, Morral Ridgedale, Bryan and Findlay, where he served for 25 years, including 16 as athletic director. He has been on the OHSAA staff since 2008, first as an Assistant Director and then Director of Sport Management.

"We have an enormous responsibility in tion-based athletics and I am ready to take that on," Snodgrass said. "I have had a great mentor here and great mentors along the way to prepare me. No individual in this profession is successful

CHOW LINE: FDA WARNS ADULTS TO KEEP KIDS AWAY FROM LIQUID NIC-

My son found an e-cigarette strawberry flavored nicotine pack and almost drank it thinking that it was some kind of candy. Luckily I stopped him in time, but are these products safe for kids?

No.

As e-cigarettes have become more popular, the number of children who have been exposed to liquid nicotine has also increased.

So says the U. S. Food and Drug Administration, which this week warned parents, caregivers and other adults to be vigilant to keep kids from getting their hands on these packs of liquid nicotine and drinking them.

The new warning comes as data from the National Poison Data System shows that from January 2012 to April 2017, the agency received 8,269 calls related to liquid nicotine exposure in children younger than 6, mostly in regard to children drinking these products, FDA said.

So what are e-cigarettes and how are kids confusing the nicotine packs for something to drink?

E-cigarettes, also called

vapes, are a form of electronic nicotine delivery systems that are battery-operated smoking devices that can resemble regular cigarettes. The e-cigarette is equipped with a heating device that converts cartridges filled with liquid nicotine, flavorings and other chemicals into a vapor, which a person then inhales, similar to smoking a regular cigarette. Some of the flavors of liquid nicotine packs include cherry, strawberry, chocolate, vanilla

These products have grown in popularity with teens and young adults. In fact, nearly one in four high school students use electronic nicotine delivery products such as e-cigarettes, according to the Centers for Disease Control and Prevention's 2015 Youth Risk Behavior Survey. A recent study from the American Academy of Pediatrics puts the number at 3 million U.S. adolescents who use e-ciga-

"For example, some e-liquids may have labeling or advertising that misleads kids into thinking the products are things they'd eat or drinklike a juice box, piece of candy

or cookie," FDA said. The danger from such accidental exposure is significant for kids. Kids who ingest or drink liquid nicotine can experience a seizure, coma, respiratory arrest and death from cardiac arrest, FDA said.

As a result, the federal agency advises consumers who choose to use e-cigarettes

Always store e-liquids in

their original containers, so others know exactly what they are. This will help children know to avoid these products.

Always make sure product caps are locked when you're not using them, and relock caps when you're finished.

Avoid contact with your skin and eyes when you use these products. E-liquid exposure can cause burning and irritation, among other problems. In case of accidental contact with skin or eyes, wash the area thoroughly with soap and water.

Clean up any spills or splashes immediately using soap and water.

Never drink e-liquid, or allow anyone to drink it, because the liquid nicotine can be poisonous.

Call Poison Control immediately if a child accidentally drinks e-liquid, at 1-800-222-1222. Also call this number if you think your child has been exposed to these productseven if you're not completely

What does "surety" mean in Proverbs 6:1?

"Surety" means becoming guarantee for someone's debt. Today we call it cosigning. God indicates it is not wise (Proverbs 11:15) – "He that is surety for a stranger shall smart for it: and he that hateth suretyship is sure." (Proverbs 22:26) - "Be not thou one of them that strike hands, or of them that are sureties for debts."

All we have belongs to God (Psalm 24:1) - "The earth is the LORD'S, and the fullness thereof; the world and they that dwell therein." We are His stewards. We should use His funds to give or purchase things for His use. We should not put at risk our ability to freely and fully serve Him.

I have also seen many relationships ruined because a cosigner had to pay another's debt. Often someone who needs a cosigner is jumping into something too soon, and the cosigner is aiding them in going against God's will.

PATROL FOCUSES ON MO-**TORCYCLE SAFETY**

May is Motorcycle Safety **Awareness Month**

May is National Motorcycle Safety Awareness Month. The Ohio State Highway Patrol would like to remind motorcyclists to ride trained and sober. Also, motorists should be aware there will be an increase in motorcycles on the roadways with the warmer weather.

In 2017, motorcycle-involved crashes resulted in 155 fatal crashes, which is a 20 percent decrease from 2016. Another 3,409 crashes resulted in injuries. Only 29 percent of the motorcyclists killed in crashes were wearing helmets. Ohio law requires helmets for riders under 18 and drivers with less than one year of motorcycle experience. Passengers on motorcycles must wear helmets when the driver is required to do so.

Motorcyclists can help protect themselves and others from injury or death by taking a training class and wearing safety equipment. In 2017, the Patrol issued a total of 1,949 citations to motorcyclists, 20 percent were for operating a motorcycle without a proper license. Riding sober is also important. Last year, 35 percent of the fatal crashes involving motorcycles were alcohol and/or drug related. Motorcycle safety is not

solely the responsibility of motorcyclists. Everyone needs to be aware of their surroundings and other vehicles sharing the roadway. Motorists should keep in mind: • Give motorcyclists a full

LIMA MAN SENTENCED FOR HIS ROLE IN 2017 **FATAL CRASH**

Lima - On March 19, 2018, Patrick Hull, 24, of Lima, was sentenced in the Allen County Common Pleas Court on one count of aggravated vehicular homicide. Mr. Hull was sentenced to seven years in prison for his role in the August 5, 2017 crash which claimed the life of Holly C. Mooney, 23, also of Lima.

On August 5, 2017, at approximately 11:40 p.m., a 2002 Dodge Neon driven by Mr. Hull was traveling eastbound on Bluelick Road near North Dixie Highway. Mr. Hull attempted to pass another eastbound vehicle by driving off of the right side of the roadway. This action caused Mr. Hull to lose control of the vehicle. The vehicle came back onto the roadway and crossed the center line before striking a ditch and a utility pole. The vehicle overturned several times and came to final rest in a soybean field.

Mr. Hull was treated for minor injuries at the scene. The passenger in the vehicle, Holly C. Mooney, sustained serious injuries and as a result, passed away on August

Alcohol and lack of safety belt usage was determined to be a factor in the crash. Mr. Hull's blood alcohol level was .170, over twice the per se legal limit of .08. Both occupants were not wearing safety belts at the time of the crash.

Driving under the influence of alcohol, drugs, or a combination of both can result in life altering consequences. The Ohio State Highway Patrol reminds motorists to never drive impaired and to always wear a properly adjusted safety belt.



OUR BEAUTIFUL PARK

On January 5th, 1886 Mayor Frank Long, on a motion by Councilman P.P. Doering, appointed P.P. Doering, Henry Harris and Jacob Saylor as a committee to negotiate with Judge O.S. Latty

for the purchase of the grove east of town for Antwerp to have a city park.

Well they did meet with the judge about that grove and that grove became our beautiful Riverside Park. I will forever thank those men for the foresightedness to secure that area for our park.

Now that was in 1886 and I never found any more notes on the park until Mayor C.A. Bissell in 1936, secured the island and the north entrance to the park.

Around 1935 to 1936 Judge Latty's daughter donated all that land south of US 24 over to the railroad to the park's estate except the plot where the Park Station sets as that belongs to Warren Seslar.

She was a lady of over 90 years old and was living in Defiance County. It is a beautiful place to go and sit and watch the highway, the blue sky, the squirrels and the children having a good time. Try it sometime.


Mowing

Now that the grass has been growing, we'd like to share with you a few guide lines on mowing. Many homeowners take mowing for granted not realizing how much effect this has on the health and appearance of the lawn. Each of these tips plays an important part in the lawn's appearance.

For the best cut, sharpen your mower blades at least once a year and keep them sharp. Sharp mower blades give a clean even cut to your lawn and prevent tearing and shredding which can give your grass an off-color appearance.

Adjust the cutting height on the mower for the season. Set your mower at medium-height in the spring and fall. In early spring, this will remove the top brown-part of

However, if you absolutely have to mow when it is wet, make sure to wash out the cutting area of the mower immediately when you are finished. To achieve a quality appearance, try to alternate mowing patterns and directions. For instance, if you mowed horizontally last time, mow diagonally this time. This tends to keep the grass blades more erect and ensure a more even cut.

SO WHAT IS SMALLBORE SILHOUETTE?



Saturday May 5th, 15 competitors gathered at the Antwerp Conservation Club, to have a go at small bore silhouette...what is this you ask?

Animal cut outs (silhouettes) are placed on the rifle range and shot at with 22lr rifles. We use NRA sized targets, about 1/5th life sized, chickens at 25 yards, pigs at 50 yards, turkeys at 75 yards, and rams at 100 yards. There are 10 of each target, and you have a time limit of 5 minutes, for 10 shots (1 shot per target) all shots fired offhand (standing unsupported). The excitement comes from each target knocks down when it is hit.

Sounds easy, right? The high score that day was 15 out of 40. This game will humble you and fast. But that did not stop the excitement of trying to knock down all the targets. Of the 15 competitors we

had them ranged in age from 10 years old to past 70 years old. This game is great for families, as every one has an equal chance to do well and no expensive equipment or purpose built rifles are needed. All you need is any (safe to shoot) 22lr, a box of cheap ammo, and you have a chance of winning this match.

General Motors has pledged to generate or source all electrical power for its facilities globally with 100 percent renewable energy by 2050. The automaker is buying a total of 200 megawatts of wind energy from the Northwest Ohio Wind Farm, along with a wind farm in Illinois. When the wind energy from both farms comes on line later this year, General Motors will be 20 percent of the way to its goal. Construction for the Northwest Ohio Wind Farm is ongoing and is expected to be completed during the third quarter of

"We are happy to partner with General Motors to provide the clean energy it needs to help meet its sustainability goals," said Alex Daberko, Managing Director of Starwood Energy Group. "We appreciate GM's continued support, as well as that of Paulding County and the broader community, in helping to advance this project."

The construction effort is expected to create roughly 300 direct jobs and bring nearly \$1 million in additional local tax revenue to Paulding County annually, which will be used to fund local schools and community services.

"The Northwest Ohio Wind Farm will be a valuable and welcome asset to our community by providing much needed tax revenue for our schools and roads,"

said Paulding County Com-

missioner Roy Klopfenstein. "We thank Starwood Energy and everyone involved in this project for choosing our community to build the wind farm. The entire county will benefit for years to come."

According to a recent report by the American Wind Energy Association, over 2,000 Ohioans now work in

the wind industry, double the over 1,000 workers employed in the state in 2015. However, wind industry growth has slowed in the state with a change to the property setback law requirements for new wind projects in 2014. The Northwest Ohio Wind Farm was grandfathered in under the old rules.





LEPC HOLDS PROPANE IQ CLASS



The Paulding Local Emergency Planning Committee (LEPC) recently hosted a two-day class for first responders entitled Propane IQ. Firefighters from Antwerp, Crane Twp., Grover Hill and Paulding took part in the hands-on training with propane. Battalion Chief Steve Riska and Ret. Lt. Todd Smith of the Jacksonville Fire and Rescue taught the twoday class for Federal Resources of Stevensville, MD.

The class was made available to first responders in Paulding County by a Hazardous Materials Emergency Preparedness (HMEP) grant from the Ohio Emergency Management Agency. The amount of \$ 27,200 was awarded to Paulding County to put on two Hazmat IQ classes and two Propane IQ

Propane is an everyday product used for heating, cooking and to fuel vehicles such as forklifts, buses, delivery truck and others. "Whether it is a one-pound propane cylinder or a 30,000 gallon storage tank, the chemical property of propane remains the same," said Steve Riska. "One part liquid propane equals 270 parts propane gas. Propane liquid boils at -44 degrees Fahrenheit and is highly flammable. It is just a matter of how much propane you have to deal with."

Instructor Smith stated, "One of the biggest concerns about propane leaks or fires is that they are not treated

as hazardous materials incidents as they should be. We as first responders cannot be complacent when it comes to these type of calls." That is one of the concerns Alex Stoller of A Plus Propane has. Stoller couldn't be more thrilled that the firefighters in Paulding County are getting this kind of training. For that reason, A Plus Propane donated two 100-pound cylinders and the propane needed for the class. Stoller said he has seen what can happen when propane isn't given the respect it deserves.

Firefighters in the two-day class were given a combination of classroom instruction, worst case scenarios and hands-on training with propane. The first day they learned about the chemical properties of propane, the anatomy of DOT cylinders and tanks, propane hardware and a valve identification challenge. They then received hands-on demonstrations of propane releases in the gas and liquid forms as well as what to do when arriving on the scene of a leaking container. Day two was review and being given scenarios and situations of leaking fittings, valves and tanks. Brainstorming case studies of incidents that had a good outcome and some that were deadly were also discussed. The hands-on instruction involved "fire and ice," with the firefighters interacting with leaking propane in the form of gas and liquid. From working to solve a leaky valve to

addressing a missing fitting, the firefighters got to flare off propane in a safe manner and see how temperatures reached 900+ degrees and ice still was able to form on the underside of the flare tube fitting.

Lt. Paul Fruit of the Antwerp Fire Dept. was impressed with what the class had to offer. " As a person learning new things day in and day out, I felt privileged to have been able to attend this weekend's class dealing with propane and related emergencies," he said. "The knowledge the two instructors shared gave me a greater understanding of propane in its various forms. It may be a common product when it remains in its container, but when it starts to leak or catches on fire it is nice to know that I, as a firefighter, can make a difference for the better after taking this class." Lt. Fruit, who has recently become a fire instructor, hopes to share what he has learned and observed in the class and pass it on to other first responders in the area so they can serve their communities and the citizens of Paulding County.

Fire Chief Dave Volk of the Grover Hill Fire Department commented as the class was wrapping up, "I want to thank Ed Bohn, Paulding County EMA Director, for finding the funding and arranging for this Propane IQ class. The instructors from Federal Resources put on a well-informed, thought-provoking two day class. Their down to earth teaching style taught me and the other firefighters in the class a wealth of knowledge to take back to our departments. In my 25+ years on the fire department, this was one of the best training classes I have attended. I want to thank the Paulding County LEPC for giving us the opportunity to get this

type of training.' The Crane Twp. Fire Department under the leadership of Chief Bob Herber had seven firefighters in the class. Chief Herber said he wanted to emphasize the need for being prepared when called out

EXPLORING OHIO WILDLIFE: GROUNDHOGS

Throughout our Ohio Wildlife series, we have looked at some of the animals that call Ohio home. These animals come in a variety of sizes, colors, and behaviors that make them all unique in some way. This installment looks at another animal found well throughout Ohio in all 88 counties, the woodchuck, otherwise known as the groundhog. How much do you know about this animal such as its habitat, behavior, or how many there are? Read on to find out more!

Many are likely most familiar with the groundhog when it comes to Groundhog's Day that takes place every February 2nd and the famous Punxsutawney Phil. People come to see this groundhog to see if he will see his shadow, indicating six more weeks of winter, or if he does not see his shadow which tells us that an early spring is on the way. During the rest of the year, the groundhog enjoys the peace and quiet of being by itself.

Groundhogs are the type of animal that prefers to be by themselves for many of its days. According to National Geographic, they search for plants and grass for most of

their days, in addition to, digging burrows in the soil which can reach upwards of 66 feet long. These burrows will usually be found near generally open areas such as meadows or farmland, proving to be much of a nuisance to many landowners and farmers. They like the open areas because it allows them to easily keep an eye on their predators. According to ODNR, the entrance to their burrows are signified by a large mound of dirt around an opening with more than one entrance and several paths or rooms found underneath the surface.

Even though the burrows may be a nuisance to us, they are quite important for the groundhogs. Burrows serve as the shelter for the groundhog providing them with protection from their predators such as coyotes or hawks, while also serving as a place to raise their families, according to National Geographic. Their burrows are designed in a way that has a room to serve a purpose such as sleeping, nesting, and their restroom. Should a groundhog move out, it is not too uncommon for animals such as chipmunks or rabbits to take up residence.

Woodchucks have not always been regularly populated in Ohio as many may think. According to the Ohio Department of Natural Resources (ODNR), at the time Ohio was settled, woodchucks (groundhogs) were a rare sight to see but as the land was opened for agricultural production, populations went on the increase. The groundhog has a broad and flat head with small eyes and ears. Their fur has a graybrown color with a red hue and their legs are usually dark brown or black and are readily equipped for digging A routine diet for the groundhog will include primarily plant items such as grass, clover, soybeans, lettuce, apples; although they will eat some insects and snails.

Through winter the months, groundhogs are nowhere to be seen and thus do not serve as much of a nuisance during this time. During this time, they will crawl down into their burrows and hibernate the winter away.

Upon completion of hibernation when the first warm spring days arrive, the male woodchuck (groundhog) sets out to find a female mate. According to ODNR, once they find one mate, the male will search for more to mate with during their mating season

which will usually last from March till May and will stay in the burrow until the female shoos him away prior to her giving birth to the young. Groundhogs are born

hairless in litters of about 2 to 7 and weighing about 1.5oz, growing very fast in the weeks that follow. ODNR writes that by the time the young reach 9 to 11 weeks, the den becomes tight on space and the mother will shoo her young out of the burrow into a nearby one still taking care of them. The mother will continue to care for them throughout their development until they leave the burrow and create their own.

How can you prevent groundhogs from being a nuisance? According to the Farmer's Almanac, installing a wire mesh fence around your garden can be a good way to prevent them from feeding on your gardens and crops. It is important to make sure this fence goes at least two feet into the ground given their digging abilities. Kitty litter has also proven to be a deterrent for groundhogs as they will mistake the smell given off as urine from one of their predators. PAYNE FIELD FIRE ON MAY 1ST



The Payne Fire Department was called out to a field fire along the north side of the Norfolk Southern Railroad Tracks between Twp. Rd. 5 and Co. Rd. 11, at 2:58 p.m. Within minutes of the first fire crews arriving on scene mutual aid was requested from Antwerp Fire Department and shortly thereafter; Monroeville, Woodburn, Northeast and New Haven Indiana Fire Departments were called for grass fire units and tankers to supply water.

Not only were the firefighters battling the dry corn stubble burning in the field, but the warm dry southwest winds blowing 20 to 25 MPH and gusts at times upwards of 35MPH, that were recorded by the National Weather Service out of Northern Indiana.

At the same time this fire was going on, a second fire

was reported along the railroad tracks between, Co. Rd. 87 and Co. Rd. 7. The Paulding Fire Department was called out to handle that fire.

In all, over 20 firefighters, seven grass fire units and five tankers and two pumpers responded to not only battle the corn stubble burning in the field, but at one point to protect the home and detached garage of Mary Gonya on Co. Rd. 11 and the power poles north of their property. All told, nearly 100 acres burned.

The NWS had issued Red Flag Warnings throughout the region. Outdoor burning is NOT recommended during these conditions.
