LATTA-BACKED CHILD-**HOOD CANCER STAR ACT APPROVED BY U.S. HOUSE** OF REPRESENTATIVES

Legislation that Congressman Bob Latta (R-Bowling Green) has co-sponsored, the Childhood Cancer Survivorship, Treatment, Access, and Research (STAR) Act, was approved by the House of Representatives last evening. As it has already passed the Senate, it now heads to the President's desk to be signed into law. The Childhood Cancer STAR Act is the most comprehensive childhood cancer legislation ever approved by Congress.

Congressman Latta has previously worked to provide resources for pediatric cancer research and eradication efforts, including authoring provisions that secured funding under the Caroline Pryce Walker Conquer Childhood Cancer Act. The issue has been a focus in Northwest Ohio due to the Clyde Cancer Cluster, which came to light in 2002. A significant number children and young adults in eastern Sandusky County were diagnosed with cancer without any known cause.

"We've seen the devas-

cancer can have on families and communities in places like Clyde, Ohio, where nearly 40 cases were diagnosed over 15 years with no specific cause," said Latta. "I've worked to secure resources for pediatric cancer research previously, but it's also important we take a look at the larger picture for the survivors of childhood cancer as well. Many pediatric survivors begin to experience other health issues at an earlier age, and there still is much we don't know about how surviving childhood cancer will affect their health later on in life. The Childhood Cancer STAR Act will provide survivors with needed resources while improving the way we track the effects of this devastating disease."

tating effect that childhood

By 2020, the number of survivors of childhood and adolescent cancer in the United States is expected to exceed 500,000. The Childhood Cancer Survivorship, Treatment, Access, and Research Act advances pediatric cancer research and child-focused cancer treatments. It also improves the surveillance of childhood cancer to identify and track incidences of child, adolescent, and young adult cancer. This information can be helpful in developing research on the recurrence of cancer cases for child cancer survivors and determining the best strategies to prevent

the return of the disease. The legislation also establishes a new pilot program to test innovative models of care for childhood survivors. More than two-thirds of survivors suffer from late effects of cancer or cancer treatment. The Childhood Cancer STAR Act would also improve research on the late effects of childhood cancers.

Continued from Page 1 about their properties, making them more presentable than they are at present. Several empty houses are there and he would like to get them built up or removed. If they can get them built up, then he would like to get them connected to City utilities. John Moon is the mayor

of Grover Hill and the spoke on what the village needed. They are trying to stop the flooding on the east side of town. They are attempting to deal with the rundown homes and properties in the village. They are looking at how to do this and also to be bring new businesses in this town, and all of the towns. They are also making improvements to the park by working with the Lions Club. Construction of a community building for crowds is a serious plan which would be very helpful since building space is a problem for larger meetings. They would also like to get grants for job growth and planning. Moon mentioned that they are working with Maumee Valley Planning Organization to replace the septic system which has been marked as a failed system by the EPA. He would also like to encourage the youth to get involved and create business and get involved with community development. The drug problem is also something they are trying to tackle, but it seems to be inundating at this time.

Zoe McMaster spoke for the Village of Latty. They are looking to increase business and industry, while addressing infrastructure issues.

Zoe also spoke for Payne is trying to increase residents and population. They have a very aged utility infrastructure. A waterline extension and replacement along with sidewalks is also on the agen-

Jim States serves on the Vision Board and he is working for Melrose to get roads, blighted properties and police protection addressed. There are water and sewer needs they are working on and they would like to build a new park shelter house.

Jim spoke for Oakwood as well and said they would also like to get a new traffic light at SR 66 and 613. A better public transportation system is a growing need because of the aging popula-

tion. New paths for walking and biking through the parks are planned. They also need better internet access and improving zoning regulations to help clean up the rundown houses. Youth activities are also a top goal for Oakwood.

Tim Boss represented the Village of Paulding. Some of the goals include public transportation, complete streets, and add biking and walking trails. They would like to expand utilities to US 24 and US127 interchange. More outdoor activities for both youth and adults are also on Oakwood's "To-Do" list. They also would like a solution to the drug problems. Other items mentioned for Oakwood include more restaurants, various street improvements and utility

Joe Barker read for Scott and he said they would like to clean up the trash and blight issues in the village. He said they would also address the flood and drainage problems along with stopping the drug problems they have.

Joe also spoke for the Paulding County Township coverage area. He addressed what is needed and that includes high quality, high speed internet. He said that there needs to be a centralized access for weather with the EMA and have a plan for emergency NEXUS alert system. The funding was received and this was very encouraging for Joe Barker.

Dave Burtch emphasized how these goals were selected. It was from the people that came to the meetings, not town councils or anything else, but the people.

Tony Zartman, Paulding County Commissioner, spoke how the Vision Board began about 2 years ago, but officially became an entity about 1 year ago. Speaking for the Commissioners, Tony said they are behind this vision 100%. He thanked the fellow board members and fellow commissioners and the community who came together to make this happen.

Maumee Valley Planning Organization, Ellen Smith, spoke about the plans and how to fund these projects. MVPO is a regional planning organization dedicated to serving five counties in Northwest Ohio, of which, Paulding is one. General

planning is taken care of by MVPO and helps to connect the projects with funding. The community development plan was in the executive plan book and was available to all of the people who went to the meeting. She said there is a one month comment period open to the public.

Ellen talked about funding and how can these ideas be paid for. ODOT might help with transportation, Paulding County Land Bank could help with blighted properties and many others. She said there is certainly funding options available and MVPO is there to connect these sourc-

Erika Willitzer shared how the Vision Board plans to achieve its goals and to make sure that this continually expands and completes projects. She said the website is always active - pauldingcountyvisionboard.com She wants the community to know where the county was and where it is going. "If we work together," Erika says, "We can go after bigger grants that will work for all of us."

Ed Bohn spoke for the EMA and mentioned that the FEMA plan should be approved soon and will help flooding in many of the towns because they will be able get grants. Funding through FEMA may also be able to get grants for a community cen-

Susan Pieper spoke up for the Paulding County Library and she said Paulding County has the finest library in the country. They will also be putting in 3D printers in all of the branches.

Lisa Nicely asked how often each of the goals would be updated. Erika stated they would be checking them each month and certainly reevaluating each year.

One gentleman spoke up "what can we do?" The reply was to contact your town officials and say you want to help. They can add you to volunteer opportuni-

Mike Schneider from the Antwerp Chamber of Commerce asked if someone from the Vision Board would come to speak at one of their meetings and see if they overlap of

One person asked about getting higher education into part of the Paulding County Vision Board.

Jerry Zielke, Economic Development, said that we are down to 3.5% unemployment which is about the lowest possible number you can have. He mentioned how there is a problem with jobs and not enough people for the jobs here but at the same time there needs to be higher skilled positions. Sometimes I get very discouraged when warning people for whom I care, concerning the consequences of not accepting Christ. Many are not concerned and want me to mind my own business.

Friend, I know that is discouraging, and I've felt the same. However, that is our business as Christians. (Mark 16:15)

We should be like watch.

We should be like watchmen and warn everyone, from the Lord, of coming danger and judgment. (Ezekiel 3:18-19) – "When I say unto the wicked, Thou shalt surely die; and thou givest him not warning, nor speakest to warn the wicked from his wicked way, to save his life; the same wicked man shall die in his iniquity; but his blood will I require at thine hand. Yet if thou warn the wicked, and he turn not from his wickedness, nor from his wicked way, he shall die in his iniquity; but thou hast delivered thy soul." If we fail to do so, we are partially responsible. What the warned do with that warning

God has no pleasure in the death of the wicked (Ezekiel 33:11), but He will not force them to receive Him. Teders, assigned to Madison County, was investigating a deer checked in as a landowner-harvested animal. During the investigation, Officer Teders could not locate any property in Plain City, where the hunter lived, that was owned by the hunter. Officer Teders interviewed the hunter and determined that the man was hunting on property he did not own and was not a tenant of the property. It was also determined that the deer was harvested in Union County and was not checked in for over a month after the animal had been harvested. The hunter was charged for providing false data to game check and for failure to check the deer by noon the day after harvest. He was ordered to pay \$298 in fines and court costs, given a 1-year hunting license revocation, and placed on two years of probation. The antlered deer skull was also ordered forfeited to the State of Ohio

In early December 2017,

State Wildlife Officer Josh

State Wildlife Officer Matt

Shields, assigned to Union County, received a report concerning multiple dead deer lying in a field that appeared to have been shot with a rifle. Officer Shields and State Wildlife Officer Adam Smith, assigned to Logan County, handled the initial investigation where they discovered four antlerless deer that had been left at the scene. Officers interviewed suspects and witnesses and served multiple search warrants to collect evidence. Two men were charged in Marysville Municipal Court and pleaded guilty to: hunting deer without the written permission; shooting from a roadway; hunting deer by the aid of a motor vehicle; jacklighting; and hunting deer before and after legal hunting hours. Both men collectively lost their hunting privileges for four years, served 10 days in jail, and were ordered to pay \$2,714 in fines, court costs, and restitution. A .45-70 caliber rifle was also forfeited to the State of Ohio. This investigation was made possible thanks to several anonymous callers to the 1-800-Poacher Turn In A Poacher (TIP) ho-

Northwest Ohio - Wildlife District Two

During the 2017 deer gun season, State Wildlife Officer Matthew Leibengood, assigned to Sandusky County, was summoned to a hunting without permission complaint. Officer Leibengood arrived and found the landowners had blocked in the hunter's vehicle, who had a dead deer and was trying to drive away. The landowners alleged that the hunter killed the deer on their property. After questioning, Officer Leibengood determined the hunter had actually killed the animal on a nearby public hunting area, but had not tagged his deer. Officer Leibengood issued a summons to the hunter, who later paid a waiver in lieu of a

court appearance. During the first day of the bonus two-day deer gun season, State Wildlife Officer Greg Wasilewski, assigned to Richland County, responded to a report from a landowner that a hunter had shot and killed a deer on his property without permission. Unfortunately, before Officer Wasilewski could reach the

hunter, the man had fallen

from his tree stand and was taken by ambulance to the hospital. After recovering from his accident, the hunter was charged with hunting without permission and pleaded guilty to the changes in court. This man's misfortune is a good reminder to always have permission to hunt and to use extreme caution when hunting from a tree Northeast Ohio – Wildlife

District Three One cold spring day, State Wildlife Officer Jason War-

ren, assigned to Ashtabula County, received a call from a concerned angler who was fishing a Grand River tributary when he observed a large amount of red colored water suddenly flow into the creek from a pipe. The angler stated that he also noticed several dead fish in the water. Officer Warren responded to the area, met with the caller, and contacted the Ohio Environmental Protection Agency (EPA) to assist with the pollution investigation. Officer Warren began checking storm drains near the site and noticed a puddle of red liquid outside of a nearby fire station. Officer Warren contacted several individuals at the fire station who advised that they had added a nontoxic pink dye to the water in a fire truck to reveal the gender of an expected baby of one of the firefighters and it had washed into a storm drain. Officer Warren inspected the dye container and verified it was nontoxic and wished the expecting couple well.

State Wildlife Officer Jesse Janosik, assigned to Columbiana County, was patrolling Highlandtown Lake Wildlife Area when he observed a vehicle make multiple passes around the boat ramp parking area, destroying the grass. He initiated a traffic stop, identified the driver and issued him summonses for driving a vehicle in a non-designated area and damaging state property. He appeared in Columbiana County Municipal Court, was convicted, and ordered to pay \$277 in fines and court

During the 2018 spring wild turkey season, State Wildlife Officer Jeff Berry, assigned to Muskingum County, and State Wildlife Officer Wesley Feldner, assigned to Monroe County, worked with a wildlife investigator on multiple cases of unlawful baiting for wild turkey. The cases involved feed being placed in front of hunting blinds prior to the opening day of turkey season. Three hunters were contacted after hunting over the locations. reflecting on the tragic events that took place over the past year within our schools. It is high time that we come together as a state and as a nation with creative solutions to better protect our schools, which seem to have become top targets. None of us want to live in a world where parents fear letting their children go to class each day. Our school boards already have the ability to permit armed staffers in schools, which schools in northwest Ohio are already taking advantage of. In order to focus more on

this issue locally, the Ohio House is making school safety a top priority. We must give our districts more options for security and safety plans, allowing them to decide what works best for their schools and community. We recently passed legislation that includes a provision giving educational service centers (ESCs) the ability to levy a property tax that will specifically fund school security and mental health services. This permissive bill upholds local control and allows the community to come together to decide if it needs more funding for school safety.

Additionally, we approved House Bill 318, appropriating \$10 million in fiscal year 2019 for grants to public and chartered nonpublic schools for school safety programs and training for school resource officers (SROs). Many districts already employ SROs, but current law doesn't define their role, the duties that accompany it, or training requirements for the position.

The legislation would certain obligations and better prepare SROs for emergency situations that may occur on school grounds and their responsibility to address such events. Specifically, the legislation would require an SRO to complete 40 hours of training that has been approved by the Ohio Peace Officer Training Academy within their

first year on the job.

House Bill 318 not only creates necessary standards, but it encourages schools to utilize school resource officers. Their role will be clearly outlined, and districts will have more confidence in the ability for a hired SRO to manage emergency scenarios on school grounds. The bill also requires the Ohio Facilities Construction Commission to conduct a study of SRO services and security upgrades in existing school district-operated buildings and to submit a copy of the study to the Governor and General Assembly by February 1, 2019, to ensure their roles are being fulfilled. The results of this study may potentially spur additional legislation as to how to better fortify our

school buildings. Another bill currently in the committee process is House Bill 526, which would allow current or retired law enforcement officers to act as volunteer patrols in our schools to help deter a mass casualty event. There would be no cost to school districts that participate in the program. Each individual must go through a screening process and be firearm certified. Once approved, the names of the volunteers would be distributed to local school districts for the purpose of scheduling. Under the bill, the officers who volunteer in the program would be eligible for a tax credit in return for their professional services and time given.

At the end of the day, we all want our children to be able to learn in a safe environment free of distractions. The Ohio House has put forward reasonable solutions to better protect our school buildings and grounds, and I believe cities and towns across the state can get behind these measures. We must work together to offer more resources to our students in the event of sudden, unexpected emer-

LATTA VOTES TO PASS PAY INCREASE FOR TROOPS AND IMPROVE MILITARY READINESS

WASHINGTON, Congressman Bob Latta (R-Bowling Green) joined his colleagues in passing the bipartisan National Defense Authorization Act (NDAA) to provide members of the military with the largest pay raise in nine years, improve military readiness, and rehabilitate and replace worn out military equipment. The legislation passed by a vote of 351 to 66. 'After years of drawdowns

under the Obama Administration, we're working to rebuild our military and provide our troops with the tools they need to confront aggression and address global threats," said Latta. "That first means taking care of the men and women that serve our nation, and the NDAA provides the members of our military with their largest pay raise in nine years. We also take efforts to upgrade and modernize outdated equipment. Last year, four times as many military members were killed in training deaths than in combat. It's unacceptable that our military cannot function at full capacity because they have old airplanes, vehicles that are falling apart, or have seen a reduction in training. It's time to take the next step in the rebuilding of our armed forces."

Under the NDAA, pay for service members is increased by 2.6%, and the legislation also increases the size of the Army, Navy, Air Force, Marine Corps, Naval and Air Reserve, and the Air Guard.

Increased funding is provided to rehabilitate and replace Army equipment and repair and rebuild crumbling military buildings and infrastructure. At the same time, funding is used to boost the total number of aircraft and naval ships to maintain American superiority in the air and on sea.

In addition, the NDAA makes important reforms to the Pentagon bureaucracy and streamlines buying practices within the Department of Defense.

UNITED STATES TAKES ACTION AGAINST CANADI-AN TRADE MEASURES THAT DISCRIMINATE AGAINST U.S. WINE

U.S. Secretary of Agriculture Sonny Perdue and Trade Representative Robert E. Lighthizer announced that the Trump Administration has requested that the World Trade Organization (WTO) establish a dispute settlement panel to examine unfair regulations governing the sale of wine in grocery stores in the Canadian province of British Columbia (BC). The Office of the United States Trade Representative (USTR) is challenging BC regulations that discriminate against U.S. and other imported wine by allowing only BC wine to be sold on regular grocery store

"We want customers in British Columbia to have the opportunity to buy our great American wine. The practice of discriminating against U.S. wine is unfair and cannot be tolerated any longer. Our wine producers rely on export markets and they deserve fair treatment, especially by our northern neighbors in British

Columbia," Secretary Perdue

"Canada is an important market for U.S. winemakers," said Ambassador Lighthizer. "Discriminatory regulations implemented by British Columbia are unfairly keeping U.S. wine off of grocery store shelves, and that is unacceptable. Canada and all Canadian provinces, including BC, must play by the rules. The Trump Administration will continue to hold our trading partners accountable by vigorously enforcing U.S. rights under our trade agreements and by promoting fair and reciprocal trade through all available tools, including the

The BC regulations exclude all imported wine from grocery store shelves, a new and growing retail channel for wine sales in BC. Such discriminatory measures limit sales opportunities for U.S. wine producers and provide a substantial competitive advantage for BC wine. These regulations appear to breach Canada's WTO commitments and have adversely affected U.S. wine producers.

Additional Background Information

The United States is chal-

lenging BC regulations that were amended in April 2015 to permit the sale of wine in grocery stores. The amended regulations provide two options for grocery stores to sell wine. Under the "wine on shelf" option, a grocery store may sell wine anywhere within the grocery store, but only BC wine may be sold on grocery store shelves. Imported wine may only

be sold in grocery stores under a "store within a store" option. Under the "store within a store" option, wine sales must be conducted in a "wine store" that is physically separated from the grocery store, has controlled access, and has separate cash registers from the grocery store's cash registers. As a "store within a store", a grocery store may sell both BC wine and imported wine.

In 2017, U.S. wine exports to BC totaled \$56 million, and U.S. wine had a 10 percent share of the BC market. A number of grocery stores are already selling BC wine on their shelves under the 'wine on shelf" option. However, we are not aware of any grocery stores selling wine pursuant to the more costly 'store within a store" option. BC's regulations limit choices and raise costs for Canadian

The United States held consultations with Canada in 2017, but those consultations did not resolve the dispute. Requesting the establishment of a panel is the next step in the WTO dispute settlement

When President Trump addressed the American Farm Bureau Federation in January of this year, he reminded the audience that his commitment to our farmers has been clear since the day his Administration began: "From that day on, we have been working every day to deliver for America's farmers just as they work every single day to deliver for us."



HOW WELL DO YOU KNOW AGRICULTUR-AL BEST MANAGEMENT PRACTICES?

As a Soil & Water Conservation District, we want to provide those we serve with the tools and information they need to be good stewards of our precious natural resources. Many of you may be aware that the Ohio Environmental Agency (EPA) designated the Western Lake Erie Basin as an impaired waterway. According to the Ohio Sea Grant, this helps to clear the way for additional action to combat pollution that causes harmful algal blooms (HABs) to occur on Lake Erie. There are many best management practices (BMPs) that can be implemented which help to combat problems associated with runoff and soil loss. What are these practices? Where can you find information on them? Read on to find

Let's start out on where to find out information that I will discuss in the following article. The Ohio Soybean

Council awarded a grant to the Ohio Federation of Soil & Water Conservation Districts (OFSWCD) and SWCDs in the Western Lake Erie Basin including Paulding SWCD, to promote the adoption of Agricultural Best Management Practices. Ohio State University developed a website www.agbmps.osu.edu to provide landowners will an additional tool to have the knowledge they need to identify "high risk situations" existing in their fields and have the knowledge they need to know where to go for assistance to implement effective conservation practices. On this website, landowners can find information on BMPs along with agencies to contact for help.

On the Ag BMPs website, one page to take note of is the "Critical Concerns" page. On this page, visitors will find pictures and descriptions of critical resource concerns to use in identification along with links to best management practices that can be utilized to address the

concerns. So, what are these concerns exactly? Natural resource concerns arise when considering issues with soil erosion, nitrogen, and phosphorus; all of which have an impact on the water quality.

Let's talk soil erosion. Soil erosion can take place by means of wind or water and can undo thousands of years of hard work that built up that soil. When erosion occurs, this sediment finds itself in the nearest water source whether it be a ditch, stream or river and often requires removal. As this sediment builds up, boats and shipping vessels in the larger rivers are unable to pass through because their navigation channels have become shallow requiring dredging to take place to remove the sediment. In addition, OSU Extension writes that the increased sediment in the water also affects aquatic animals by clogging their gills, smothering nests and eggs, while also altering the water temperature.

What are some solutions? Reducing the amount of tillage performed is one easy practice that can be employed to leave more crop residue on the ground thus leaving cover on the ground that helps to slow down the force of rain drops hitting the surface. Conservation tillage leaves at least 30% of crop residue on the ground and lightly works the ground prior to or during planting. No-till which leaves the soil undisturbed between planting seasons with weed control being achieved by crop rotations. Strip tilling leaves the soil undisturbed with the exception of strips of 1/3 of the row width, often used for weed control during the planting season or preparing rows for planting. Pictures are provided on the Ag BMP's website highlighting each of the tillage practices.

Concerns arise with phosphorus and nitrogen runoff, especially when considering issues with harmful algal blooms (HABs) that we hear a lot about in Lake Erie and Grand Lake St. Marys. One thing that algae feeds from is the excess nutrients that are found in the waterways feeding our lakes. These HABs deprive the water of oxygen, which hurts aquatic life and brings about concerns with drinking water. Among practices that can help with this issue are: cover crops, grassed waterways, controlled drainage structures, or having a nutrient management plan

Grassed waterways is a practice that can be used to help with concerns relating to both soil erosion and nutrient runoff These are constructed channels that are planting with grass or similar vegetation that is designed to slow the force of water running off the field while also providing a chance for filtration of the runoff from the roots of the vegetation. According to OSU Extension, grassed waterways in Ohio act as "shallow field ditches" which help to collect field runoff from areas in a field that slope towards a wa-

While only a few BMPs were mentioned in this article, there are many more that can be utilized to ensure that we are doing the best we can to preserve and protect our valuable soil and water resources! BANKS-PANETTA AMEND-

MENT TO REPLACE DAN-

GEROUS CESIUM BLOOD

House of Representatives passed an amendment to the fiscal year 2019 National Defense Authorization Act (NDAA) authored by Congressman Jim Banks (IN-03) and Congressman Jimmy Panetta (CA-20) that provides for the replacement of high-risk cesium blood irradiators. Banks and Panetta both

serve on the House Armed Services Committee.

"This important amendment sets the goal of eliminating the use of radioactive cesium blood irradiators in the United States by 2027, provides funding for the United States government to remove and dispose of cesium, and helps fund the replacement cost of safer devices," said Banks. "This effort will significantly reduce the risk of WMD terrorism by removing and replacing radiological sources that pose unnecessary dangers to our communities."

OHIO ATTORNEY & COM-MUNITY RIGHTS ADVOCATE RECEIVES THE 2018 JOHN-SRUD UNSUNG HEROES AWARD

One of Ohio's most dedicated environmental attorneys, Terry Lodge, received the 2018 Johnsrud Unsung Heroes Award in Washington, D.C. Dr. Judith Johnsrud was a geographer who worked diligently for more than 50 years to protect communities from nuclear power in all its phases.

Lodge began practicing law in 1978. He has fought corporate welfare, defended peaceful protestors, and worked to advance other issues protecting people and nature. However, he is most well-known for his environmental efforts. For decades, Lodge has battled nuclear power plants, mountaintop removal, pipeline construction, and fracking wells. Today, he also works tirelessly in partnership with the Community Environmental Legal Defense Fund (CELDF) to advance, protect, and defend Ohio communities' democratic and environmental rights.

nize that [nuclear power] is a political problem and that problem lies in the law of the United States."

Lodge concurs, recognizing that the problem we face in protecting our communities from a multitude of environmental harms lies in this same law - and he sees local community democracy as the most viable remedy. In his address accepting the award, Lodge stated,

"Rediscovering and using . [our] forgotten tools [of local control and democracy] makes voting on issues a form of civil disobedience. How about a local ban on hauling spent fuel through your town? Give your town the gift of criminal punishments for transports of weapons or waste through it. Legislate your county's denial of consent to a radwaste dump. Legislate nature's right to exist; prohibit air, soil and water from exposure to nuclear perils and make citizens the legal guardians with the power to sue on behalf of nature. These changes are utterly necessary for the survival of the planet."


