Paulding's Jacob Eblin scored the first touchdown in the 1st quarter, quickly followed by Trevor Spiece on the Raider side. Neither team could get the extra point. This game had more extra point kick failures than they had pass through the goal posts.

Paulding and Wayne Trace both scored again in the 2nd period with Jacob

Deisler and then Evan Mohr scoring. Korbin Slade added two extra points for the Raiders with 10 seconds left in the 2nd quarter. The half ended with Wayne Trace squeaking out a 14-12 lead.

Halftime ended and the Raiders were the only scorers in the third quarter, effectively sealing the game. Wayne Trace's Trevor Spiece ran 5 yards to score the next touchdown.

The fourth quarter began with the Raiders leading 21-12. Wayne Trace came in with another touchdown at 8:31 seconds on the clock. Grant Baumle ran the 15 yards to add 6 points to the board. It looked grim for the Panthers

MONEY SMART FOR OLDER ADULTS RESOURCE GUIDE

Financial exploitation has been called "the crime of the 21st century" with one study suggesting that older Americans lost at least \$2.9 billion to financial exploitation in 2010 by a broad spectrum of perpetrators, including persons they know and trust, as well as strangers. Cognitive impairment diminishes the ability of some older adults to make financial decisions

and to detect frauds and scams. This is according to the publication Money Smart for Older Adults: Resource Guide which is now available free-of-charge at all library locations.

This 100-page guide is easy to read, printed in large print and organized by chapters covering everything from Investment Fraud to Medical Identity Theft, Telephone and Internet Scams to Scams that Target Homeowners and Veterans. "We are distributing this guide because we want all our patrons to be savvy about their financial management, but especially our older adults," shares librarian, Susan Pieper. "This guide is very easy to understand with wide

margins, areas for notes, and bullet points. It even includes a "post-test" readers can take at the end of this resource guide to ensure they have understood the points of financial competency."

Contributors to the information in this resource guide include: The Federal Deposit Insurance Corporation (FDIC), Consumer Financial Protection Bureau, U.S. Department of Health and Human Services, Administration for Community Living - Senior Medicare Control, Federal Trade Commission, Securities and Exchange Commission, Social Security Administration, Financial Industry Regulatory Authority, Inc., and the Internal Revenue Service.

ANTWERP POLICE REPORTS FOR AUGUST 22



The activity at Antwerp Police Department has continued at about the same pace as it was before.

For the month of July there were 117 calls and 40 citations. At the end of July officers of the Department met with the Sheriff, EMA Director, Antwerp EMS and Fire and the school administration and the School Resource Officer for making plans and preparations for a school emergency. The plans were reviewed and updated and made sure that everyone knows where the safe zones are and what outside agencies would be contacted in case of emergencies. The meeting was very good and what each agencies' job is. With school beginning, it ensures that teachers and staff know they are in good hands if such a situation would come up.

In mid August a local business owner brought in a bad check written by a resident in the village for an amount of \$146. The suspect was contacted by officers and served with notice, giving him 15 days to pay for the check in lieu of charges. The money was returned to the business owner.

On August 10, Officers arrested a village resident on order of the Defiance Adult Parole. The initial charge was aggravated possession of drugs. The defendant was transported to the county line and transferred to the Defiance County Sheriff's Office.

Also, on August 10 and individual arrested on warrant of indictment from the Paulding County Grand Jury. The indictment was for two counts of aggravated vehicular homicide, and two counts of aggravated vehicular assault. The individual was transported to the Paulding County Jail and handed to corrections officers.

On August 11 a resident of the village contacted the police department because of physical threats from the caller's ex-husband. She stated a firearm had been purchased and he let her know that information. The suspect denied making the threat. The case was investigated and charges are pending at the Paulding County Prosecutor's office.

ANTWERP FOOTBALL PREVIEW

ANTWERP - Enter the upcoming 2018 football season the Antwerp Archers are hoping to avoid the injury bug as Head Coach Drew Altimus welcomes several experienced players to this edition

of the Archer program.

In what appeared to be a promising season just a year ago, the blue-and-white suffered a couple of key injuries that set them back on their heels as the season quickly got underway. With that behind them, the head coach and his coaching staff are optimistic this season will bring a level of success and a few more wins.

Quarterback Keaton Altimus, now a senior, will be an extension of the coaching staff on the field, as the head coach's son will lead the Archer offense. The young Altimus suffered a season ending leg injury during the third game of the season and was forced to the sidelines. In just three games, the potent thrower still managed 96 completions and 12 touchdowns while throwing for 967 yards. Altimus is back and appears healthy and ready to meet the challenge in leading the Archers to a successful campaign.

While Altimus was sidelined in the early going, teammate Nick McCreery, a defensive end, also found himself on the sidelines after week two. McCreery is back and according to the head coach will play the defensive end and tight end position for the Archers.

"You win with seniors Keaton (Altimus) back and senior receiver Cole Seslar, our offense should be good. Having Keaton back is like having a coach on the field and Seslar will be a force and a scoring threat on offense," said Coach Altimus.

Last year, Seslar hauled in 52 receptions for 597 yards and seven touchdowns. With a healthy quarterback and a scrappy athlete like Seslar, look for his numbers to increase dramatically. Seslar, an honorable mention GMC recipient last year also totaled 45 tackles at the safety position.

The Archers return a host of solid experienced players that should enable them to manage more than one win, much like the last couple of

years.

"We have 41 kids playing football and our roster is dotted with a number of juniors and seniors. That is something we haven't had in recent years. With our numbers up, we will have a junior varsity team this year," commented Altimus.

Kicking specialist, Jacob Savina, a junior and two-year letterman returns and will be a fixture as the team's extra-point kicker. Last season Savina totaled 15 extra points and a field goal. Savina will also find time at the receiver spot and defensively as a cornerback.

"Savina has really grown from a year ago. He's very confident on the field and I expect good things from him as the season progresses," said Altimus.

Blake Schuette will return as the team's inside receiver as well as halfback. Schuette will also be on the defensive side of the ball at the defensive end spot. When Altimus was sidelined last campaign, Schuette was forced into the quarterback position.

Also returning with key experience and will most likely be a starter when the Archers open their season Aug. 24 on the road at Montpelier will be: Offense - Luke Brewer (inside slot receiver), Tim Taylor (running back), Dylan Hines (center), Brett Fulk (tackle), Kolton Titus (tackle), John Buehrer (guard), Tim Major (guard), and Andy McDougall (guard).

"We have experience on the offensive side with Taylor, Fulk, McDougall and several others. Taylor will be at the running back position and has really improved. He is a team player with a good attitude and he comes ready to play every day. McDougall is a fighter and Fulk will make his presence known on every play," Altimus said.

Defensively, the Archers will have Schuette and McCreery at defensive end with the linebackers being Fulk, Taylor, Dylan Hines and Jack Dohoney. Cornerbacks will

be Landon Reyes and Divyne East with Seslar and Brewer holding down the safety positions.

Fulk, a senior and three-year letterman looks to have a solid season after earning GMC honorable mention honors last campaign. The rugged defender led the team with 89 tackles last year.

Ashton Barnhouse returns for his senior year and

is also an experienced player as a three-year letterman. Barnhouse will be playing both offense and defense and is penciled in as a tackle and linebacker.

"Overall our defense has improved and will only get better. If we continue to play as a unit and stay focused then we will be okay," commented Altimus.

Anglers wanting to fish from a boat are encouraged to visit Harrison Lake State Park, located at 26246 Harrison Lake Road, Fayette 43521, or Van Wert Reservoir #2, located on Peter Collins Road just off US 127 in Van Wert. S.R. 1 STRUCTURE IN ALLEN COUNTY TO BE DEMOLISHED

CELEBRATING OHIO WILDLIFE: RIVER OTTER

It is time to once again highlight one of the many animals that call Ohio home. For this week's animal, we will go to the water as we feature the river otter. Where does it live? What does it eat? What does it look like? Read on to find out the answers to these questions and more about the river otter and its history.

Traditionally, the river otter has been found around North America with the exception of the cold Arctic regions and the desert southwest. They once were found throughout Ohio but became nonexistent in the state by the turn of the 20th century. According to the Ohio Department of Natural Resources (ODNR), the Division of Wildlife began an effort in 1986 where they intended to bring back the river otter to Ohio by bringing them up from Arkansas and Louisiana. Today, the river otter can be seen in about two-thirds of the state with eastern Ohio seeing a higher population.

It is no secret that the river otter is a species that is well adjusted to a life in the water no matter the season. The fur of this animal is grown to be thick that helps provide them with a source of insulation as they are swimming in colder waters. Overall, they have a dark brown appearance with a light brown on the face and stomach. River otters have webbed feet that allow them to swim through the water with ease, which are assisted by a large, flat, muscular tail that provides speed for them and that can make up about 50% of a river otter's weight



according to ODNR. On average, this species ranges in weight between 10-35 pounds and grow to a length of about three to four feet. According to the National Wildlife Federation (NWF), the river otter's whiskers come in handy as they rely on the whisker's sensitive nature to find and locate their prey in murky water or in darkness.

The NWF writes that the river otter can make a home in a variety of water-based habitats such as ponds, lakes, rivers, marshes, and estuaries given that there is plenty of food is found. Their home consists of a den located in water with hidden underwater entrances similar to that of the beaver. ODNR writes that this animal is able to live in either a freshwater habitat or a saltwater habitat but that they typically prefer the tributary of a large body of water that is free from pollution and that which is relatively untouched by humans. Within these habitats, they will dine on items such as crayfish, snakes, frogs, fish, and the occasional waterfowl. NWF states that the river otter has a high metabolism presenting the need to have frequent meals. Some of the river otter's predators include animals such as bobcats, alligators, or coyotes.

ODNR notes the river ot-

ter exhibits either a nocturnal behavior meaning they are active during the nighttime hours or a crepuscular behavior in which they will be active either a dawn or dusk. They enjoy a family oriented lifestyle often being spotted in large family units. River otters will begin their breeding season early in the spring with otter "pups" born blind and without teeth. According to ODNR, they will experience rapid growth gaining the ability to survive on their own by the age of six months yet the family will remain together for another one to two months or even as long as just prior to a new litter being born. The typical size of a river otter litter ranges between one to three pups who can live up to about nine years in the wild.

Now that you know a little more about the river otter, have you spotted one near you? The river otter is just another of the many species that can be found through Ohio. Stay tuned to further additions to our Ohio Wildlife Species where who knows what amazing animal we may feature next! Is there a particular species you want to know more about? PAULDING - The Paulding football Panthers enters
