

FLOODING IN PAULDING COUNTY



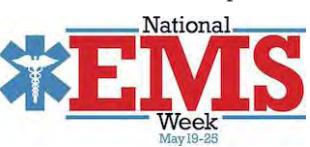

ALGAL BLOOMS IN LAKE ERIE'S CENTRAL BASIN COULD PRODUCE NEUROTOXINS

Harmful algal blooms pose a unique toxic threat in Lake Erie's central basin, new research has found.

Not only do blooms routinely occur in this area,

they can also produce types of cyanobacterial toxins that aren't typically detected through routine water-safety monitoring, according to a study published in the Journal of Great Lakes Research.

"The cyanobacteria we found in the central basin are completely different from what we've seen in the Toledo area in the western basin," said lead researcher Justin Chaffin, a senior researcher and research coordinator at The Ohio State University's Stone Laboratory.

"That's troubling because water treatment plants aren't typically set up to look for this bacteria or the toxins they create. It requires more expensive, more sophisticated equipment."

Harmful blue-green algal blooms and the toxic microcystins that accompany them have been a persistent threat in the lake's western basin. But until this study, bloom-related toxins hadn't been formally documented and analyzed in the central basin.

Several years ago, environmental scientists began hearing reports of harmful algal blooms in the central basin, in the waters just west of Cleveland. This was surprising at the time because the experts thought these environmental threats were concentrated primarily near Toledo, Chaffin said.

The water in the central basin hadn't been thought of as friendly to cyanobacteria because it isn't as warm or nutrient-rich as in the western basin, where nitrogen and phosphorous is plentiful because of agricultural runoff brought in by the Maumee River.

The research team sampled the water in four areas from 2013 to 2017 and analyzed satellite images taken before then for evidence of blooms. They found a cyanobacterium called Dolichospermum in the central basin during early-season blooms in July. This cyanobacterium is capable of producing a tox-

in that can attack the central nervous system in humans, and the researchers found genetic evidence that the bloom has the potential for the neurotoxin.

"What this means is that if you're a water plant operator in Cleveland, you have to be ready by late June or early July for cyanobacteria because they do have the potential to produce a really potent toxin. It could also be a problem for beachgoers if there's a north wind and these blooms gather along the Ohio shoreline," Chaffin said.

Researchers have shared these findings with the Ohio Environmental Protection Agency and with water plant operators, he said.

Later in the season, the researchers found the cyanobacterium Microcystis - the chief troublemaker in the western basin, which feeds off of excess phosphorous - in the central basin. The toxins, called microcystins, that it produces are most harmful to the liver and also a threat to the kidneys and reproductive system. Water plant operators routinely look for microcystins.

Figuring out precisely what is causing these unexpected algal blooms in the central basin will require more work, Chaffin said.

"We still can't pinpoint what's really causing these blooms because it's a complex interaction of several factors," he said.

But the new study did find evidence that it's a combination of low levels of iron (which decreases nitrogen availability), muddy water and a strain of Dolichospermum adapted to cooler waters.

The researchers found an association between central basin blooms and lower water clarity - meaning that when the water is muddier, the likelihood of harmful blue-green algae goes up. There's also evidence that iron plays a role. If there's not enough iron, beneficial algae's growth is suppressed,

their basements, as much as a foot in some of them, due to the heavy rains in a short period of time.

but the harmful algae found in this study likely flourish because they are efficient at capturing iron when the nutrient is in short supply, Chaffin said.

Continual work to reduce sediments, which lead to lower water clarity, is important, he said. And though phosphorous and nitrogen - which have driven blooms in the western basin - aren't present in high concentrations in the central basin, minimizing them is important to Lake Erie's overall health, he said.

LOCAL HIGH SCHOOL TEAMS COMPETE AT AREA 1 ENVIROTHON

On April 24th, teams from Paulding High School and Vantage Career Center competed at the 2019 Area 1 Envirothon Competition held at the Miller Conservation Farm located near Republic, Ohio in Seneca County. Paulding FFA under the direction of Advisor Staci Miller and Vantage FFA under the direction of Advisor Mike Miller represented Paulding County at this competition. Paulding FFA had two teams with the following members competing: Jen Stahl, Emma Horstman, Katelyn Strahley, Courtney Ludergerman, and Riley Noffsinger, making up Team 1. Team 2 members for Paulding FFA included Jonathan Reinhard, Shannon Hale, Jordyn Merriam, Sydney Reineck, and Colton Howell. Team Members for Vantage FFA Team 1 included: Kaylie Tressler, Megan Garrity, Braxton Conley, Preston Browning, Joel Schneider, and Kendall Roof. Team members for Vantage FFA Team 2 included: Jared Sukup, Joshua Sukup, Conner Wannemacher, Seth Brinkman, Alec Ander-

son, Jayden Huries, and Stuart Moorehouse.

The Paulding Soil & Water Conservation District was proud to sponsor the registration fees for both Paulding High School & Vantage Career Center. This contest covered Area 1 for Ohio which includes Allen, Auglaize, Crawford, Defiance, Fulton, Hancock, Hardin, Henry, Lucas, Marion, Morrow, Ottawa, Paulding, Putnam, Sandusky, Seneca, Van Wert, Williams, Wood, and Wyandot Counties.

What is this contest you ask? The Envirothon is a multi-disciplinary, environmental problem-solving competition put on by Soil & Water Conservation Districts with help from our agency partners at the Ohio Department of Agriculture, USDA-NRCS, and the Ohio Department of Natural Resources. This competition consists of a team of five high school students (grades 9-12) train and compete in the areas of soils, aquatics, wildlife, and forestry at regional, state and national levels. Students are also challenged at each station to answer questions on a Current Environmental

Issue which this year focused on "Agricultural Soil & Water Conservation Stewardship". Each school is allowed to bring two teams. Students rotate within their teams to each of the four stations to answer questions from a test that tests their general knowledge of the subject while also answering questions that are specific to the site. Tests are then scored from each station and tallied for an overall score for each team to determine placings. Teams are ranked first through fourth with a fifth-place alternate selected in the event the fourth place is unable to attend the state competition which will be held at Cedarville University June 9-11, 2019. Those who make it past the state competition advance to the North American Envirothon which will be held July 28-August 2, 2019 in Raleigh, North Carolina. In the North American Envirothon, teams from across the United States and several Canadian provinces compete and test their environmental knowledge.

How did this rewarding competition get its start? The Envirothon program originated in Pennsylvania in 1979 as a hands-on, outdoor competition to test high school students' knowledge of natural resources and environmental issues. The Pennsylvania Association of Conservation Districts sponsored this inaugural competition. In 1988, the original name, Enviro-Olympics was changed to Envirothon. That year, Pennsylvania hosted the first National Envirothon, which consisted of teams from Pennsylvania, Massachusetts, and Ohio. The first Ohio Envirothon was held the following year in 1989. Six teams participated, with students from East Knox High School capturing first place and representing Ohio in the 1989 National Envirothon.

In 1990, the Envirothon grew dramatically in Ohio, with more than sixty teams participating in four Area Envirothons. Ohio hosted the National Envirothon that year near Zanesville with Maine, Maryland, and New York joining the competition. By 1993, the Envirothon was well established in Ohio and on its way to becoming a truly national program. More than three hundred students participated in five Area Envirothons in Ohio. The 1993 National Envirothon was held at Niagara Falls, New York and attracted teams from nineteen states and one Canadian province. The program has grown every year since the 1988 competition in Pennsylvania when just three states competed to the thirty-two states and three Canadian provinces participating in the 1996 national competition held in Nebraska. Nova Scotia hosted the 2000 National Envirothon.

Through this competition, not only do students have the opportunity to gain a greater awareness of environmental issues and natural resource management, they also get the opportunity to meet and network with professionals from USDA-NRCS, ODA, ODNR, and Soil & Water Conservation Districts making up Area 1. Through this networking, students also have an opportunity to learn more

about environmental career opportunities and responsibilities. To learn more about the Envirothon competition, visit www.area1envirothon.org and see how your school can participate!

OHIO STATE LIMA & RHODES STATE ANNOUNCE ENERGY RESULTS, SPECIAL RECOGNITION

The Ohio State University at Lima along with its co-located partner Rhodes States College has completed the 2018-2019 year and earned special recognition in the "Strongest Energy Team" for the campus' participation in AEP Ohio's Continuous Energy Improvement Program to improve energy efficiency.

"As public institutions serving the people of Ohio, it is our duty to search out and implement best practices that result in the efficient use of our limited natural and fiscal resources and model those best practices," said Dr. Tim Rehner, dean and director at Ohio State Lima.

CEI helps participants apply principles and practices of continuous improvement to implement strategic energy management that may help reduce their electricity usage by 3-5 percent annually with little to no capital investment. Plus, AEP Ohio provides a total incentive of \$0.02 per kWh saved. Business customers served by AEP Ohio are eligible to participate.

Over the course of the reporting period, the Lima campus saved 488,000 kWh of energy compared to the predicted energy usage based on energy usage over the past three years. That is a 6 percent change. Participation in the CEI program has resulted in a \$58,905.28 energy cost avoidance through rebates and savings in energy costs over the measurement period, which was April 2018-March 2019.

"In addition to the successful completion of the program, the campus has earned special recognition for 'Strongest Energy Team' for the sustained work to engage the student body and employees in energy savings," said Dr. Cynthia Spiers, interim president at Rhodes State College.

Early in the reporting period, the campus formed an Energy Team to further university strategic and sustainability goals. The team includes members from the facilities department and the Sustainability Committee.

Some of the activities that resulted in the decline in usage include continuous improvement of the HVAC systems across campus, ongoing additions of occupancy sensors, change to direct digital control and scheduling of HVAC systems, and continuing upgrades and replacement of light fixtures with LEDs. The Sustainability Committee has also led an awareness campaign to reduce or eliminate space heaters on campus. While the campus has one primary AEP Ohio meter, all the main campus buildings are equipped with energy-monitoring submeters.

Savings from the successful completion of the energy efficiency program will be used for building infrastructure improvements. The campus partners plan to continue efforts to lower energy usage through joint initiatives and awareness campaigns.

A Friend of Sinners

PREVENT TICK BITES & THE DISEASES THEY CARRY AS WARM WEATHER RETURNS TO THE BUCKEYE STATE

As the weather gets warmer and Ohioans begin spending more time outdoors, the Ohio Department of Health (ODH) is urging people to take precautions to prevent

tick bites and the diseases they may carry.

"Diseases spread by ticks are an increasing concern in Ohio," said ODH Director Amy Acton, MD, MPH. "The best way to prevent tickborne diseases is to prevent tick bites by taking simple precautions at home and when working or playing in wooded or brushy areas from early spring to late fall."

Dr. Acton also recommends people who get sick after being bitten by a tick contact their healthcare provider, particularly if they have symptoms like a fever, headache, nausea, vomiting, joint pain, muscle aches, fatigue or a rash.

Most diseases in Ohio that are caused by the bite of infected ticks happen between spring and late fall since ticks are most active during warm months; however,

the blacklegged ticks that can transmit Lyme disease are active on all but the coldest days of days and can be encountered any time of the year when the temperature is above freezing. The most common diseases spread by ticks in Ohio include Lyme disease and Rocky Mountain spotted fever. There were 293 Lyme disease cases and 38 Rocky Mountain spotted fever cases reported in Ohio last year.

Here are some tips to avoid tick bites and Be Tick Smart!:

- Walk in the middle of trails. Avoid tall grass, brush and leaf litter.

- Use EPA-registered repellents labelled for use against ticks on skin. Always follow the label instructions.

EPA-registered repellents are safe and effective, even for

pregnant and breastfeeding women.

- Treat clothing and gear such as pants, boots, socks and tents with a product containing permethrin, or buy permethrin-treated clothing and gear. Do not apply permethrin directly to skin.

- Wear long pants, long sleeves and long socks. Tuck pant legs into socks.

- Wear light colors to make it easier to see ticks.

Check yourself, your children and pets thoroughly for ticks after spending time in areas that may contain ticks. If you find a tick attached to the body, here are some tips for safely removing them:

- Use fine-tipped tweezers to grasp the tick as close to the skin's surface as possible.

- Pull it away from your skin with steady, even pressure.

- Do not twist or jerk the tick which can cause the mouth-parts to break off and remain in the skin. If this happens, remove the mouth-parts with tweezers. If you are unable to remove the mouth-parts easily with clean tweezers, leave it alone and let the skin heal.

- Do not use petroleum jelly, a hot match, nail polish or any other "folk" remedies to remove a tick as these methods do not work.

- Dispose of a live tick by putting it in alcohol, placing it in a sealed bag/container, wrapping it tightly in tape or flushing it down the toilet. Never crush a tick with your fingers.

- Wash your hands and the bite area with soap and water.

LATE START ON PLANTING MAY NOT HURT YIELDS MUCH

Despite rain that has stalled the planting of corn and soybeans across the state, yields might not be reduced, according to two grain specialists at The Ohio State University.

That's because weather later in the growing season can have a bigger impact on yields than the date the seeds go in the ground, said Peter Thomison and Laura Lindsey, both agronomists at Ohio State's College of Food, Agricultural, and Environmental Sciences (CFAES).

During July and August, too much or too little rain or really hot temperatures can be detrimental because that's when corn plants form kernels and soybean plants form beans, Thomison and Lindsey said.

Only 4% of this year's corn crop has been planted compared to 50% this time last year; 2% of the soybean crop has been planted compared to 28% this time last year, according to a U.S. Department of Agriculture report released May 13.

During the week that ended May 12, only 1.5 days were suitable for fieldwork due to rain or ground saturation. Planting in soggy ground can lead to soil compaction, and seeds tend to develop shallow root systems.

"I think a lot of people would like to be done planting right now," Lindsey said. "But there's been several years where it has dragged on."

In 2017, though corn and soybeans were planted early, some had to be replanted in June because of excessive rain that reduced plant stands, Thomison said. Yet, the state had record high yields for both crops that year.

So, the situation is not yet critical. And farmers don't yet need to switch to planting a shorter-season variety of corn seed, Thomison said. Corn varieties of varying maturity can adjust their growth and development in response to a shortened growing season, he said.

"I don't want to be a fear monger," he said. "If we get our corn planted in late May or early June, and we have good growing conditions, we could still end up with a very good crop."

In 2011, only 19% of Ohio's corn crop had been planted by May 30, but the yields were the same as the five-year average, Thomison said.

Soybeans tend to have higher yields when they are planted between the end of April and early May, Lindsey said.

"I want to tell growers not to worry, but it's hard not to worry," she said. "It's hard to wait."

Soybean farmers can take some measures to try to ensure good yields even with a late start on planting.

If farmers don't end up being able to plant until sometime in June, they might want to increase the number of seeds per acre from 140,000 to 150,000 or 160,000, Lindsey said.

When planting soybeans in June, making rows that are 7.5 to 15 inches wide can be helpful, Lindsey said.

Rows of that width typically produce higher yields than wide rows of 30 inches or so, and the effect becomes even greater when soybeans are planted later, she said.

Narrow rows typically bring greater yields because as the soybean plant grows and its branches and leaves spread out, the canopy covers up the dirt between the rows. That allows little to no soil to be exposed to direct sunlight, which keeps the temperature in the soil down and maintains moisture in the soil.

Selecting the latest-maturing variety of soybean seeds that will reach maturity before the first killing frost can also help compensate for a delayed planting date, Lindsey said.

And it's important to remember, soybeans are very resilient plants, she said.

"Despite bad weather, they can still maintain relatively good yield."

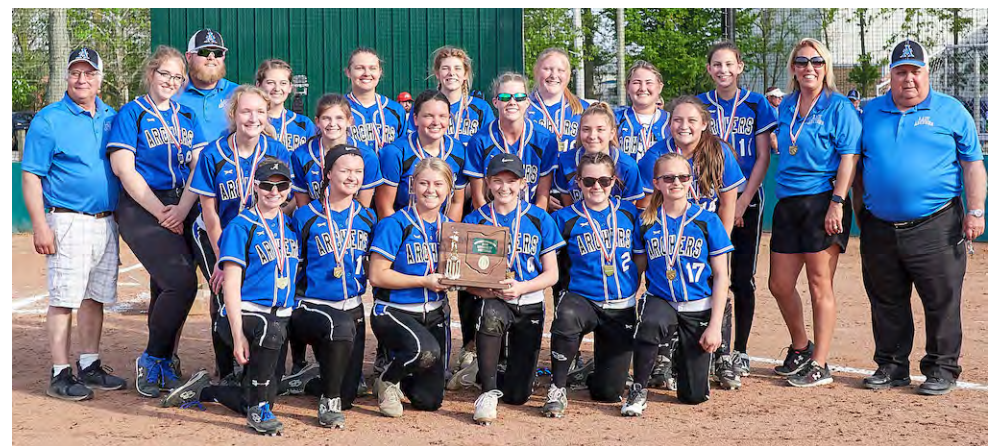
