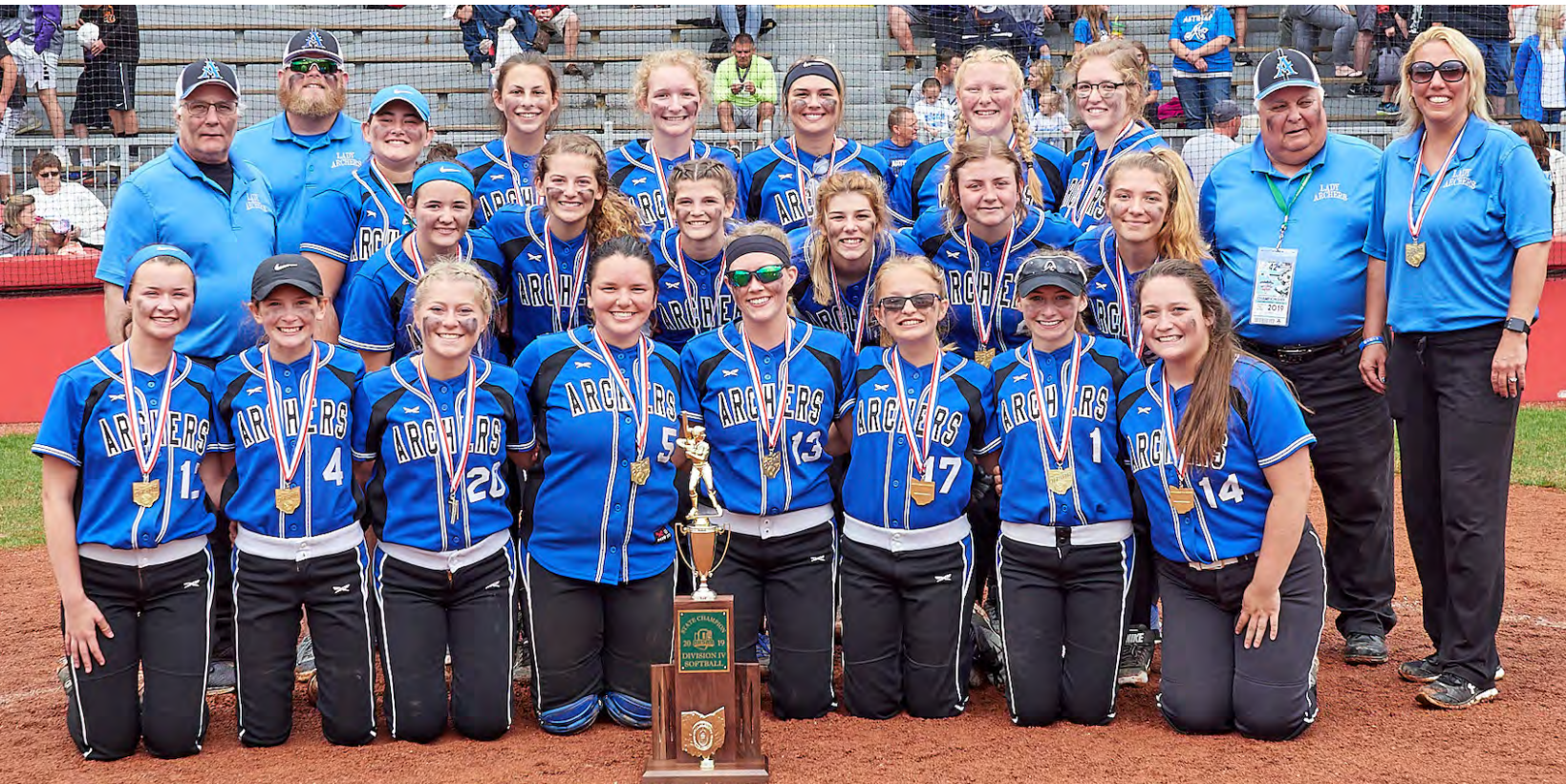


LADY ARCHERS WIN STATE SOFTBALL TITLE 2019 DIVISION 4 CHAMPIONSHIP IN AKRON, OH

SOARIN' HAWK RAPTOR BREAKS GROUND

Soarin' Hawk Raptor Rehabilitation Center, the non-profit organization that rescues and rehabilitates raptors, broke ground for its new home on Thursday, May 16. Soarin' Hawk's new home will be on Lima Road in Huntertown.

The nearly nine-acre site will enable the group to bring together two separate operations, a medical unit for injured raptors and, miles away, pens for both recovering and permanently housed birds. The ICU and the pens have been on loaned properties, and Soarin' Hawk has been looking for suitable sites for several years.

As the result of a successful capital campaign, Soarin' Hawk will construct:

- Modern recovery enclosures and habitats that are designed to provide a natural setting for the raptors, while minimizing maintenance.
- An aviary that will allow volunteers to exercise multiple birds in all weather conditions.

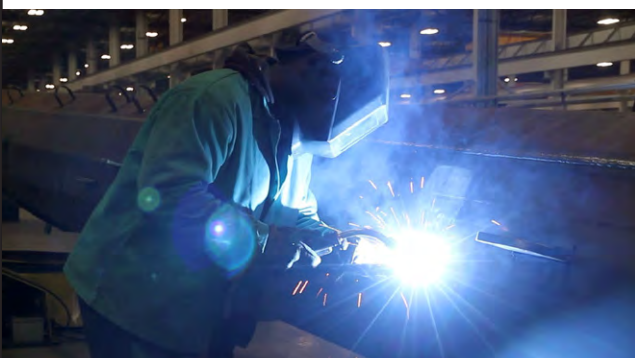

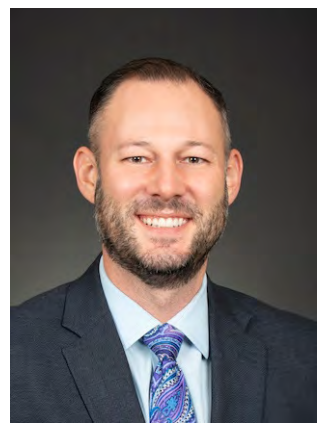

SEE A SWARM? DON'T EXTERMINATE, CALL A BEEKEEPER!

If you spot a large clump of honey bees on a branch, in a tree, or other covered area, you have found a swarm. Honey bees swarm naturally when the conditions are right for them to split their colony. This is how they keep their species populated. They generally swarm during the spring, but honey bees have been reported to swarm throughout the summer and fall as well. This year, with springtime being a bit delayed, swarm season could also be affected, and we could see swarms all the way into the summer months.

Swarming is the process by which a new honey bee colony is formed when the queen bee leaves the colony with a large group of worker bees. In the swarm, about 60% of the worker bees leave the original hive location with the old queen. They leave the remaining bees in the hive to raise a new queen as they continue now as two separate colonies. A swarm can contain thousands to tens of thousands of bees.

Unfortunately, swarms can cause problems for residents in urban areas and neighborhoods. But if you happen to see a swarm, please do not call an exterminator or attempt to use insect-killer on them. Simply call a beekeeper to help give them a new home!

How to Identify A Honey Bee?

Not all flying, yellow bugs with stingers are honey bees or even bees. We recommend that you identify the "bee" or gathered bees that you have spotted. Honey bees and bumble bees are great pollinators, and are generally not aggressive towards humans. Adversely, hornets & wasps (yellow jackets) don't contribute as much to pollination, can be very aggressive, and are generally regarded as a nuisances and pests.

You can typically tell which insects are great pollinators by the large amount of hairs on their bodies, as they will look 'fuzzy.' We unfortunately don't have the resources to help rescue bumble bees and other native bees (which you won't see gather in large numbers anyways), but we CAN help honey bees!

When To Exterminate? We recommend calling a beekeeper before an exter-

minator in 99.9% of the calls we get; so that pollinators like honey bees and bumble bees can be relocated, instead of being killed outright. If the situation becomes life-threatening, the only option may be extermination. However, if it is a simple matter of them being a nuisance, remember we need bees and their pollination for our food and survival. Allow them to take the honor of being a minor inconvenience until a beekeeper arrives.

Southwest Honey Co. can help remove honey bee swarms that are less than 20 ft. off the ground and are not inside a structure (like a house or post), in Fort Wayne, Indiana and the surrounding area. We help with swarm removal free of charge, but we do accept donations to assist our efforts.

WIC: WOMEN INFANT & CHILDREN: WHAT YOU NEED TO KNOW



WIC is a nationwide public health nutrition program that is focused on a very vulnerable population: pregnant women, infants and children under five years old. Each state takes jurisdiction of their own program of WIC. In Ohio, there are 210 WIC offices in 147 cities across the state. Right here in Paulding

County, a WIC office is available for its citizens.

At the Paulding office, located at 800 E Perry St., WIC director Sherry Miller, RN, CLC; WIC clerk, Sophie Mobley and breastfeeding peer helper, Andrea Schlueter, are ready to help and serve pregnant women, infants and children obtain healthy foods, support for breastfeeding and opening doors to a community of experts and resources to give them their best chance at a healthy life.

Paulding County has 10.7% of its population living below the national poverty level and more than half of that is women with children. WIC is an income-based program. For example, a family of 4, the annual household income needs to be under

\$23,107. Pregnant women counts as a family of 2. Call the office for more information about the income guidelines. Medicaid and SNAP recipients are automatically qualified for WIC — all they need to do is make an appointment to get the process of approval started. So, what can WIC give you? Each month WIC recipients receive food benefits unique to their family's needs. The WIC food package includes a variety of health options including: beans, cheese, canned fish, 100% fruit juice, whole grain bread, tortillas, and brown rice, cereal, peanut butter, infant formula, fruits and vegetable (fresh, frozen, or canned), eggs, milk, and infant cereal and baby food.

proved for WIC? As easy as calling the office and setting up an appointment! If you think or know you are pregnant, have babies or children under the age of five in your home (legal guardians or not - ask about Kinship Care), give the office a call at 419-399-2621.

Appointments at the WIC office are required for participants every three months. At these appointments, women and children will get benefits loaded onto their cards that they use at grocery stores. WIC is accepted at most grocery stores, just look for the WIC sticker in the front window of the establishment or ask the cashiers. Also at appointment times, participants will be given health education resources and tips about healthy eating and breastfeeding, as well as information about pediatricians and dentists, immunization services, social services, and other moral support.

Miller and Mobley commented, "We want to help more people and make more families aware of the programs and funds like WIC. So many families are in need and we have the means to help them if they just know we are here for them."

The Paulding County WIC office is located in the Paulding County Health Department building at 800 E Perry St, Paulding (beside Dollar General), phone number is 419-399-2621. Hours: Monday through Friday, 8:00 a.m. till 5:00 p.m.

throughout Indiana, Northwest Ohio and Southern Michigan. After rehabilitation, birds are released back into the wild in the area where they were found. The organization also does more than 100 educational presentations annually that reach 10,000 children and adults in schools, libraries and other public venues. For these programs, volunteers use 16 birds that are permanent residents with Soarin' Hawk because they have suffered injuries that prevent them from being able to hunt. These raptors include hawks, owls, kestrels and an eagle.

DO YOU HAVE A BUSINESS SUCCESSION STRATEGY?

If you own a business, you've always got plenty to think about: sales, marketing, employees, competition, industry trends, consumer preferences - the list goes on and on. You can give your business away outright, but you may want to consider using a trust or family limited partnership, both of which may allow you to control the business for as long as you want, while still receiving a regular income stream.

Selling the business outright - You can always sell your business outright whenever you like - right now, when you retire or some time in between. Of course, any sale brings tax considerations.

Using a buy-sell arrangement to transfer the business - Instead of simply selling the business in a traditional transaction, you could em-

ploy a buy-sell agreement. With this arrangement, you can generally determine when, to whom, and at what price you can sell it. If you would like to keep the business in your family, you may be able to fund the buy-sell agreement with life insurance, so family members could use the death benefit to buy your ownership stake.

Buying a private annuity - When you buy a private annuity, you can transfer the business to family members, or someone else, who will then make payments to you for the rest of your life, or, possibly, for your lifetime and that of a second person's. In addition to potentially providing you with a lifetime income stream, this type of sale can remove assets from your estate without triggering gift or estate taxes.

These and other techniques can be complex, so before deciding on what is best for your situation, you'll want to consult with your tax, legal and financial advisors. By taking your time and getting the professional help you need, you can make a successful succession choice.

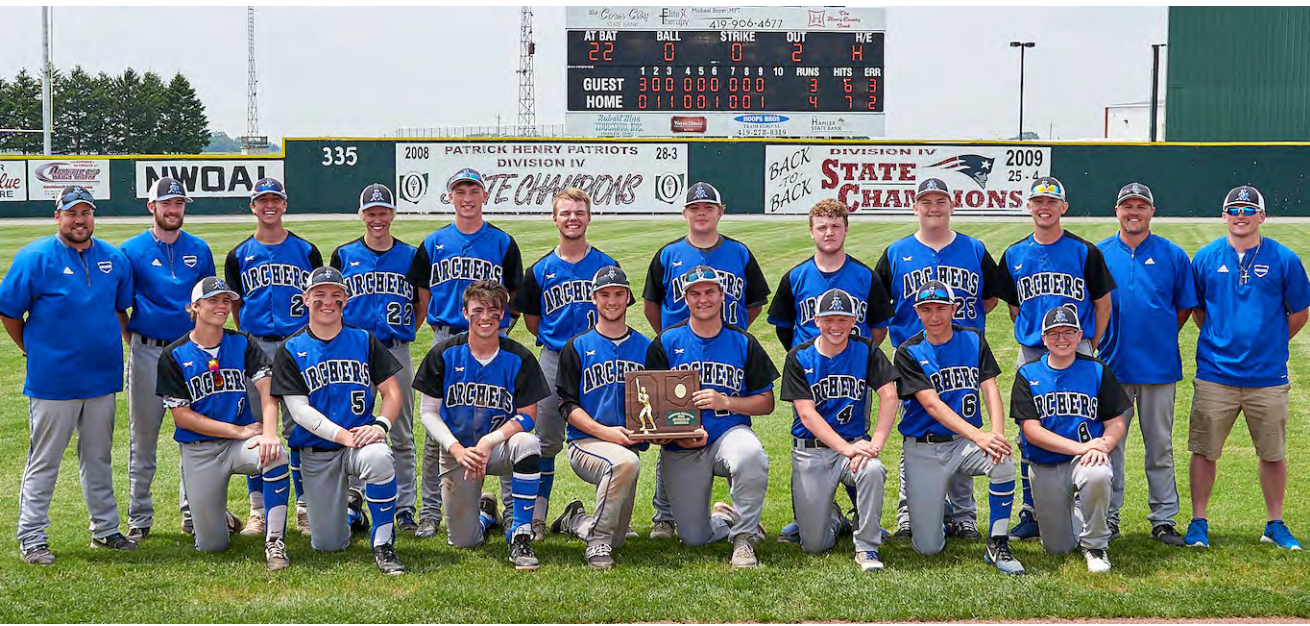

Come on out to enjoy some great make-n-take activities as well as meeting the Paulding SWCD Staff & Board of Supervisors who are happy to highlight the work our office is doing throughout Paulding County. We will also have finalists from our annual Conservation Poster Contest and Photo contests for the public to cast their vote for. Wait, there's more! We have some fabulous door prizes to give-away, so be sure to stop by our booth and put your name in for a chance to win!

The Paulding SWCD will have activities on Monday, June 10th, Wednesday, June 12th, Friday, June 14th from 12:00pm until 3:00pm on each of these days. Monday's theme is "Don't Hurt the Dirt", where visitors will have the learn about soil horizons and soil health by making their own edible soil! This activity takes chocolate chops, butterscotch chips, chocolate pudding, Oreo cookies, green

food coloring, and gummy worms to learn about what makes up each soil horizon and the life living in the soil. Be sure to stop by for this great tasting activity! Another activity you can take part in for the day is by making your own Cover Crop Critter! Like a Chia Pet®, the Cover Crop Critter will allow visitors to learn about the amazing benefits of cover crops and watch their seed grow!

Monday will also feature our Streamulator model available to learn about how streams work. The Streamulator model allows visitors to the power of moving water as streams meander and cut their way through the landscape. The effects of erosion and weathering are also visible with this model allowing visitors to see how erosion is a powerful force that changes the landscape on a continual basis. Visitors with the stream table have the opportunity build a community with buildings, bridges, and trees in such a way that it would be safe from any flood or rain event if the stream overflowed its banks. The Streamulator allows visitors to get their hands dirty in the sand and water to investigate erosion, floodplains, and the workings of streams.

Wednesday's theme is "Water Quality-It's Everyone's Business" where the main activity of the day will allow visitors to learn how their daily activities have an impact on the quality of our water resources. Visitors will make their own "Lake in a Bag" where they will start out with a bag with clear gel to represent a nice clean lake but notice how quickly the quality of the water in their lake changes once pollutants such as fertilizer, pet waste, car fluids, and more affect the quality of their water and lead to the formation of algal blooms that close beaches and impact drinking water supplies.

Also on Wednesday, our booth will feature two of our

Enviroscape models one of which will allow visitors to see the effects that non-point source pollution has on the environment and the other model will focus on wetlands and the services they provide to the environment such as helping with flood control or providing habitat for wildlife.

Nonpoint source point pollution is where the source of pollution is unknown and could be coming from a wide variety of sources. The Non-point Pollution Enviroscape allows visitors to see the negative impacts this pollution has on our environment and water resources. Wetlands are areas of land that are covered with water for most of the year and provide multiple benefits to the environment such as flood control, sediment trapping, and filtering out pollution. Come check out our Wetlands Enviroscape model to learn more!

Friday's theme is "It's Wild Out There" where visitors will enjoy learning about and viewing our Ohio wildlife skins and pelts, make a "Ladybug Puppet" craft, or an owl craft. The focus for this day will be all about the outdoors and the many great creatures found there. Activities for this day will include the opportunity to view our Ohio wildlife fur and pelt collection. Did you know that black bears are active mainly at night to avoid people or other bears or that they can run up to 30 miles per hour? Come learn these facts and more with us!

A scavenger hunt through the Black Swamp Nature Center will also be featured on Friday. Those who wish to take part in the scavenger hunt will need to meet at our booth on the midway. We will begin at 12:15pm and take approx. 30 minutes to complete the trek through the trails with a second session taking place at 1:30pm. 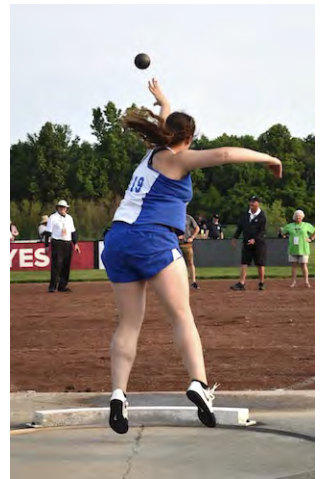
DESK VIEW: STATE TRACK AND FIELD MEET EDITION

PARTNERSHIP ENHANCES MVNU TRACK & FIELD PROGRAMS

The relationship between Mount Vernon City Schools and Mount Vernon Nazarene University continues to move at a marathon pace as the educational institutions are eyeing the finish line on efforts to strengthen indoor track & field opportunities for student-athletes.

Plans to share the Community Field House on the Mount Vernon High School campus were made public during a joint meeting between the two schools and the City of Mount Vernon on April 10. This will provide MVNU student-athletes a collegiate-level facility in which to train and compete.

"The plan to share facilities is yet another expression of the organic relationship between MVNU and Mount Vernon City Schools, the City of Mount Vernon, and the community," said Dr. Henry W. As MVNU's track and field program expands, Athletic Director Chip Wilson is coping with the growing pains that accompany the successes.

"Our track program has grown in size to the point that we do not have proper training space and equipment to give our student-athletes a dynamic athletic experience," said Wilson. "The

partnership with the Mount Vernon community and Mount Vernon City Schools will allow us to continue growing our numbers and give our student-athletes a high-quality space for training and competition."

The opportunity to collaborate with MVNU to include the collegiate-level track in the Community Field House project came in the eleventh hour, according to Mount Vernon City Schools Superintendent William Seder, but the decision has resulted in a six-lane, 200-meter track that will support growth and success for both programs.

"This facility will not only prepare our student-athletes for competition, it will be built to house competitions for both Mount Vernon High School and Middle School, as well as an indoor competition space for Mount Vernon Nazarene University's track & field teams," said Justin Sandford, athletic/activities director for Mount Vernon High School.

While new, state-of-the-art facilities are an added benefit to any athletic program, Wilson is a firm believer it is the core principles in his track & field programs that sparks engagement in the recruitment process.

"The new indoor facility will be an added recruitment tool for our prospective student-athletes. However, the goal in recruiting will continue to be centered around relationship building and providing opportunities for our student-athletes," Wilson said. "We have developed an environment and culture in our early development in men's and women's track & field that is grounded in Christ-centered relationships. This new partnership and facility will now be an added tool to use as an avenue to enhance this culture."

nerves," said David Shetlar, a professor emeritus with CFAES.

Their distinctive humming can be deafening for the birds and people around them, to the point that some birds and people will temporarily leave an area just to find solace, Shetlar said.

By showing up in the millions all at once, 17-year cicadas overwhelm their predators. The predators can eat some of the cicadas, but not all of them, leaving enough behind to guarantee the success of the next generation.

"It can be annoying for the cat or dog owner who watches his pet come in from the yard and upchuck some cicadas because he ate too many of them," Shetlar said.

After a few more weeks of mating, this brood of 17-year cicadas will die. However, the state hosts other broods, the state hosts other broods, and the next one will greet Ohioans in 2021, mostly in the western counties. Then in 2025, the southern tip of Ohio will witness another brood rising up out of the ground to fly awkwardly about, Shetlar said.

"It's a big entomological event," he said.

As an entomologist who has studied the emergence of various broods of cicadas over the years, Shetlar can also boast an experience most others cannot: He's eaten them.

He what?
"These things are perfectly edible," he told a colleague a few years ago, just before plucking a live cicada from a tree and popping it into his mouth.

The cicada had the consistency of milk chocolate with cream that oozes out of the center. Only it wasn't sugary cream oozing out.

"All the internal organs are pretty soft," he said.

As for the taste, the cicada had a mild, nutty flavor, like roasted almonds, said Shetlar, who pointed out that cicadas are not part of his regular diet. The meat he usually eats is both dead and cooked.

Even so, that wasn't his first time eating a cicada. In the 1970s, Shetlar ate one while teaching a course at Penn State University titled Foraging Off the Bottom of the Food Chain.

"You learn pretty quickly there are certain insects you don't eat," he said.

But everyone's standards on that are different.
