## PATROL TO FOCUS ON IMPAIRED DRIVERS

The Ohio State Highway Patrol is urging motorists to drive sober. During the Drive Sober or Get Pulled Over campaign, troopers will focus enforcement efforts on removing impaired drivers from Ohio's roadways.

Motorists can do their part in keeping the roadways safe by following all traffic laws, never driving impaired and always designating a sober driver. In 2018, there were 13,364 OVI-related crashes, which resulted in 402 deaths and 7,811 injuries.

"Our focus is removing impaired drivers from our roadways and educating motorists of the dangers it presents," said Lieutenant Tim Grigsby, Lima Post Commander. "We take impaired driving seriously and remain dedicated to promoting safety on Ohio's roadways."

Of those OVI-related crashes, 54 percent of at fault drivers were between 21 and 39 years old, while 67 percent were male. In 2018, troopers

## GETTING TO KNOW JESUS

Presented by the Oakwood Church of Christ

**His Death on the Cross**  
 All four of the gospel narratives give us information regarding the Lord's suffering and death. Each adds to our overall understanding. The assigned readings will give many of the same points. There are no disagreements between them, but various additional elements are given by each. In this lesson we have chosen passages from each to give an overview of what happened.

As you read these passages, remember that this was the Son of God, who allowed himself to be so tortured and to die in this way in order to be our Savior.

To the Place of Execution Read Mark 15: 15-27.

1. Before ordering that Jesus be crucified, Pilate had him: (a) fed; (b) bound; (c) scourged (beaten with whips).  
 2. The soldiers mocked Jesus by putting on him a garment symbolizing royalty, which was the color: a) black; b) purple; c) yellow.

3. They also put on his head a crown of: a) gold; b) thorns; c) cloth.

4. T/F. When these soldiers worshiped (paid homage to) him, they were sincere.

5. T/F. They spit on him.

6. Who was the person who carried the cross for him? a) Simon of Cyrene; b) Simon Peter; c) Judas.

7. The place where he would be crucified was Golgotha (Calvary), which means: a) a skull; b) a hill; c) a grave.

8. T/F. Jesus drank the wine that was mingled with myrrh.

9. It was what hour when

In John's account we find that Jesus carried his own cross. Apparently he carried it at first with Simon carrying it the rest of the way. The word "Golgotha" meant "a skull" in the Aramaic language. The word "Calvary" is from a Latin word meaning the same thing. The wine mingled with myrrh was intended to help him endure the pain, but he refused it.

In this parable Christ used the illustration to show Christians, knowing that life is short, should invest their money in eternity by laying up treasures in heaven. Matthew 6:19-21 - "Lay not up for yourselves treasures upon earth, where moth and rust doth corrupt, and where thieves break through and steal. But lay up for yourselves treasures in heaven where neither moth nor rust doth corrupt, and where thieves break through and steal: For where your treasure is, there will your heart be also." We do that by righteous acts, but also by giving God his ten percent, or tithes and offerings (Malachi 3:8-11), giving to missions to reach the world (Philippians 4:10-19), and giving to the poor (II Corinthians 9:8-9). after each of these passages! God takes extra care on earth as well as in heaven for givers.

## BE ALERT FOR OPPORTUNITIES WHEN PREPARING FOR COLLEGE COSTS

Now that summer is winding down, it will soon be "back-to-school" time. When children are young, your logistics for the new academic year may involve little more than a trip to buy school supplies. But if you'd like to send your kids (or grandkids) to college someday, you need to plan far ahead to meet the financial demands. **Scholarships** - Colleges and universities offer their own scholarships, but you're not limited to them. In fact, you might be surprised at the number and variety of college scholarships available to your child or grandchild - but to find them, you may need to do some digging. Find out what's offered from foundations, religious, ethnic or community organizations, local businesses and civic groups. Also, ask the high school guidance office for information. Your own employer might even offer small scholarships. You can find more information on scholarships on the U.S. Department of Education's website.

**College-specific investments** - You might also want to consider an investment designed to help you save for college. You have several options available, each with different contribution limits, rules and tax treatments, so you'll want to consult with a financial professional to choose an investment that's appropriate for your situation.

Community colleges - Not every bachelor's degree needs to begin and end at an expensive four-year college or university. Many students now fulfill some of their "general" education requirements at affordable community colleges before transferring to a four-year school - often saving tens of thousands of dollars in the process.

Paying for college is challenging. After all, for the 2018-19 academic year, the average annual cost (tuition, fees, and room and board) was \$21,370 for in-state students at public four-year colleges or universities; for four-year private schools, the corresponding expense was \$48,510, according to the College Board. And college costs will likely continue to rise over the next several years. But, as we've seen, by being proactive and having a plan in place, you can go a long way toward coping with these expenses and helping your loved ones enjoy the benefits of higher education.

## ANTWERP SUPERINTENDENT DR. MARTIN MILLER TO SPEAK AT NATIONAL FUTURE OF EDUCATION TECHNOLOGY CONFERENCE



Dr. Martin Miller, Antwerp Local School superintendent, has been selected to be a speaker at the National Future of Education Technology Conference in Miami, Florida on January 17, 2020. The title of his presentation is "The Z Train has left The Station".

Generation Z is the first generation of students to see virtually every human connected to the internet. They are the most connected, global, mobile, social, educated and sophisticated generation ever. Unfortunately, they find themselves trapped in an educational system forged during the industrial revolution. The title of this presentation refers to the fact that our Z generation students are leaving the traditional education system in search of a more dynamic means of receiving an education. This presentation advocates for new teaching and learning models of opportunity that increase educational productivity, reduce educational cost, and better utilize teach time while at the same time, maintain the most important feature, a public school system.

Generation Z is establishing a new track regarding how learning takes place. They are a driving force in the innovation of new learning tools, teaching styles, and unlimited access to resources. Generation Z is completely comfortable with learning alongside other students, even outside of their own school. "Food insecurity has become an increasingly significant issue across college campuses and can negatively impact a student's success", said Nicole Buccalo, Director of Student Engagement & Activities. "The SHOP hopes to alleviate the barriers and challenges associated with basic need insecurity and assist in helping students stay in school to, ultimately, earn their degrees", she said.

The SHOP was created in response to a 2019 study

completed by the Office of Student Engagement & Activities that found 39-percent of students have run out of food at some point, and 29-percent have worried about obtaining hygiene products. These findings show that Rhodes students are facing food insecurity at a rate that is 9-percent higher than the average of college campuses.

On Tuesday, August 27, at 11:00 am, Jacob King, President of the Rhodes State College Faculty Association, will kick off the event with a Ribbon Cutting. Other activities include the Penny Wars and T-Shirt Upcycling for SHOP patrons.

Rhodes State's Office of Student Engagement & Activities is accepting donations for shelf-stable food items as well as toiletries, cleaning supplies and personal hygiene products to continue to stock The SHOP. ## GRILLED CALIFORNIA SWEET POTATOES

(NAPSI)—The next time you're firing up the outdoor grill (or indoor grill pan, for that matter), throw on a sweetpotato or two. 1 tsp salt, plus more for sprinkling

Heat a grill or grill pan to medium-high. Meanwhile, in a large bowl, combine sweetpotatoes, oil and salt. Arrange sweetpotatoes on the grill or grill pan and cook until lightly charred and tender, 6 to 8 minutes, turning halfway through. Sprinkle with more salt and serve.

## DESK VIEW

Schooling exists universally for the purpose of educating people from their youth forth. As an exchange student, one of the main parts of going abroad is getting to experience life in a different educational setting. In a new place, at a different school, with many new people, and with little confidence in my German, I had my first day of school 2019 on the twelfth of August. The German school system, or at least the German school I am attending here, is very different from the schooling I have experienced at Antwerp to the point that the two are nearly incomparable. Of course, there are the conventional qualities of every school such as the definite prevalence of students, teachers, courses, assignments, and classrooms which remain constant for the Wilhelm-Hofmann-Gymnasium here in Sankt Goarshausen and the school I know in Antwerp. Though there are consistencies, many aspects of these schools vary greatly.

In the one week of school I have been a part of here, I have found many differences from my previous experiences at Antwerp. Students here are given more freedom with their days. Breaks are more frequent and less monitored. This school is situated on the Rhein River, and students are free to walk right outside of the school to visit it. There are three different buildings, so it is often that students are walking from class to class outside, where they are allowed to be whenever. If people want to leave to get something to eat or drink during a time when they are free, they can just do so. Unlike Antwerp, students can bring their backpacks to class as well as their own water bot-

les and food. There is also a common room for the higher grades, eleven, twelve, and thirteen, where students can study, chill, and talk without being closely watched. Students do not have a dress code, they are allowed to have their cell phones, and there is no bell system. To the student body here, these freedoms are normal. I am used to being under supervision all day at school and having many rules to follow that do not apply here, so these freedoms feel more empowering to me.

Another big difference between the school I am attending here and my home school is in the use of technology. At Antwerp, there is a device for every student to use, and in high school, students are using their laptops nearly every period during the day and at night for homework. Here at my school, which is public like Antwerp and not much larger, this type of one to one device system does not exist. There are a few classes using PC rooms, or computer labs, but the computers are not as quick and efficient as what students have in my hometown. Students can have their phones at school here, but there is not good enough service in Sankt Goarshausen for them to be very helpful. Though they are not using technology to teach and assign work at WHG, the courses are still demanding and everyone makes do with what they have. I did not realize what a luxury it is to have the ability to look something up or conveniently use the internet whenever I want throughout the school day.

Every school stands as an individual part of the general term of education. The basis of schooling boils down to learning, but the details occur in such variety. The details of any school, family, or individual can never be carried out in exact similarity which is what makes every life unique. As the school year begins back home for all of the kids I know and is in full swing here for me and all the people I have met and will meet, I keep in mind the one of a kind impact education holds in every person's life.

"Some distributors are making false—and dangerous—claims that Miracle Mineral Supplement mixed with citric acid is an antimicrobial, antiviral, and antibacterial liquid that is a remedy for autism, cancer, HIV/AIDS, hepatitis, flu, and other conditions," the FDA said. "But the FDA is not aware of any research showing that these products are safe or effective for treating any illness."

Although the agency first issued a warning against consuming these products in 2010, the warning was reissued this week after the FDA said it has received reports of consumers who have suffered from severe vomiting, severe diarrhea, life-threatening low blood pressure caused by dehydration, and acute liver failure after drinking these products.

"Drinking any of these chlorine dioxide products can cause nausea, vomiting, diarrhea, and symptoms of severe dehydration," the FDA warned. "Some product labels claim that vomiting and diarrhea are common after ingesting the product. They even maintain that such reactions are evidence that

the product is working. That claim is false."

Of particular concern for the FDA is that the more concentrated the product is, the more severe the consumer's reaction can be.

For example, "product directions instruct people to mix the sodium chlorite solution with a citric acid, such as lemon or lime juice, or another acid before drinking. In many instances, the sodium chlorite is sold with a citric acid 'activator.' When the acid is added, the mixture becomes chlorine dioxide, a powerful bleaching agent," the FDA said.

"Sodium chlorite products are dangerous, and you and your family should not use them," the FDA warned.

Board members are publicly elected officials who serve a term of three years volunteering their time and have many duties. They have the responsibility of the development and implementation of all short and long-term goals for the SWCD including the protection and conservation of the natural resources of Paulding County and Ohio. Board members meet at least once a month to carry out official duties of the office such as approval of financial reports, ditch petitions, and know the powers, responsibilities, and authority given to the SWCD by the state of Ohio. Lastly, board members hire capable district employees to carry out the daily work of the district, provide oversight for employees, review their performance annually, and provide adequate training for employees to remain current with the skills needed to carry out their positions.

How do you vote for a Paulding SWCD Supervisor? Residents or landowners, firms, and corporations that own or occupy land in Paulding County and are 18 years of age or older may vote for Supervisor. A non-resident landowner, firm, or corporation must provide an affidavit of eligibility, which includes designation of a voting representative, prior to casting a ballot.

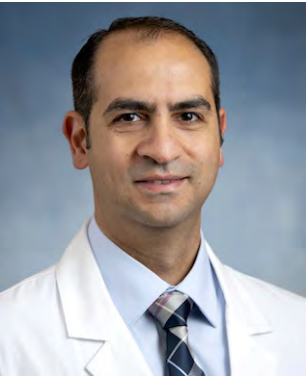

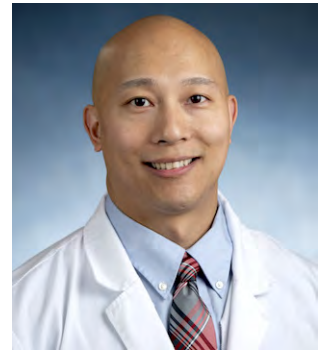
