Secretary LaRose is launching a new system to modernize the way we notarize in Ohio.

For years, Ohio has maintained a notary commissioning system that has allowed all 88 counties to institute their own licensing and skill requirements for their Notaries Public. Under the new, streamlined system, individuals interested in obtaining

Additionally, Ohio will begin allowing for online notarization which provides Ohioans the opportunity to have a document notarized while out of state or overseas. For example, if a servicewoman is seeking the opportunity to obtain a notarization of a mortgage document, she won't have to wait until she returns from deployment.

Electronic notarization will also be implemented, providing the ability to notarize digital documents for the first time.

"Ohio is just the sixth state to allow for online notarization," said LaRose. "That innovation, along with our additional modernizations, is another feather in Ohio's cap as we work to make our state Truck Auction.



It's a fairly predictable pattern: When the stock market rises, more people invest, but after a large-scale drop, many of these same people head for the exits. But by staying out of the financial markets, and only putting their money in "safe" vehicles that offer few or no growth prospects, are they really helping themselves? Here's the bottom line: If you're going to make progress toward your long-term goals, you have to become a long-term investor. But how?

To begin with, you need to understand that long-term investing involves accepting inevitable short-term price swings. You may not like seeing those sharp price drops, but it will help your outlook greatly if you can keep them in perspective. Studies have shown that the longer you hold your investments, the less impact market volatility can have on them.

So, to reach that point where the market's ups and downs have less of a cumulative impact on your holdings, consider the following actions:

Only invest money you won't need for a long time. "We know from the research of Kevin King with USDA-ARS, that too much dry fertilizer is leaving fields with surface applications," explains Patrick Troyer, Technician/Education Specialist with Paulding SWCD. "This project aims to reduce nutrient loading to the Maumee River basin and the Western Basin of Lake Erie, specifically dissolved reactive phosphorus, which has been linked to recent increases in algae blooms."

Tailoring fertilizer application to specific crop needs within a field is a critical management activity for addressing the environmental risk of nutrient loading. The Paulding project will enable farmers to implement precision nutrient management with subsurface placement fertilizer applicators. Among the project goals are to:

• Use variable rate technology and subsurface placement of nutrients with 20-25 producers;

• Increase use of preci-

sion-based nutrient placement within the project area;

· Reduce the amount of phosphorus leaving cropland.

The Paulding SWCD used grant dollars to purchase a John Deere 8330 tractor and 2510H toolbar for nutrient placement. It is setup with 16 rows on 30-inch spacing and holds 6 tons of fertilizer. Once in the field, it is averaging 30 acres/hr. The producer submits soil tests, a fertilizer prescription and provides the fertilizer.

Due to wet conditions earlier in the year, field application was delayed until early September. To date, 150 acres have been completed with another 330 acres signed up for this fall. "We anticipate more acres being enrolled through October," notes Troyer. "Also, our office would like to thank the USDA-NRCS staff for helping to promote this opportunity and the Defiance SWCD for inviting us to have our toolbar at their field day."

The Paulding Soil & Water Conservation District and the Ohio Pollinator Habitat Initiative will once again be collaborating on this worthwhile initiative. Milkweed is known as a pollinator species, which means it provides nectar or pollen for a variety of different species. Pollinator species such as the milkweed are suffering from a major population decline across Ohio as well as the United States due to habitat loss, chemical usage, and disease.

To increase the monarch butterfly numbers, the Ohio Department of Natural Resources (ODNR) and other partners created the Ohio Pollinator Habitat Initiative following a petition in 2014 to designate the monarch as an endangered or threatened

species. According to foragersharvest.com, the milkweed plant is one of the best known wild plants native to North America. Many farmers see it as a pest in their fields while nature enthusiasts see it as a vital species to the monarch butterfly. Milkweed is commonly found on roadsides, fencerows, and along streams. It has large oval shaped leaves with veins that branch out from the center.

The main distinguishing factor of milkweed is the white sticky sap that oozes out of the stem when it is cut. There will also be pink, purple, and white flowers on the plant when it is in bloom. Milkweed pods will range in length between three to five inches, have an egg shaped appearance, and a hook-like Every year in the fall, mon-

arch butterflies across the eastern U.S. and Canada begin a 3,000-mile-long journey down to wintering grounds in Mexico. According to the Ohio Department of Natural Resources, these same butterflies head back north in the spring, and delight us with their presence once again. However, this amazing journey would not be possible without milkweed, a group of plants critical to the survival of the monarch butterfly. As butterflies, monarchs can feed on the nectar of many different flowering plants, but as caterpillars, monarchs are entirely dependent on the availability of milkweed.

Protecting these plants, especially during the egg-laying period from July through September, helps both monarch butterflies and caterpillars continue their life cycle and ultimately results in more monarch butterflies that can complete their journey to Mexico and back according to the Ohio Department of Natural Resources. As part of this initiative,

milkweed seed pods will be collected with hopes in provide more milkweed plants for the monarch to utilize for its habitat. This collection runs from September 1st until October 31st and everyone is highly encouraged to collect pods from mature plants and bring them to the collection point for Paulding County which will be the Paulding Soil & Water Conservation District. The collection barrel is located on the front porch of the Black Swamp Nature Center located at 753 Fairground Drive Paulding, OH 45879. The collection bin is a green container with a yellow lid on the southwest corner of the porch at the Nature Center building.

Seedpods that are collected as part of this project will be used to establish new plantings and create additional habitat for the Monarch butterfly throughout Ohio in the coming years. "Common and swamp milkweed is essential for the survival of Monarch Butterflies in Ohio," said Marci Lininger, biologist with the US Fish & Wildlife Service. "Ohio is a priority area for Monarchs. This generation of Monarchs are also responsible for starting the life cycle all over again in the spring, and laying the following year's first generation of Monarchs in late summer,"

The Ohio Pollinator Habitat Initiative reminds us of several things to keep in mind when collecting seed pods:

1. It is best to pick the pods when the seeds contained within them are brown. Do not collect them when they are white or cream colored as they are not matured. The pod is ready to be picked when the seam of the pod opens with gentle pressure.

2. As pods are collected be sure to wear appropriate clothing as well as disposable

3. Place collected pods in paper bags or grocery sacks. Do not use plastic bags as they attract moisture.

4. Keep seeds in a dry, cool area until you can bring them to the Black Swamp Nature

5. Collecting pods will not affect milkweed populations in areas where they are already established.





Potassium is an essential mineral and electrolyte that people need as part of a healthy, balanced diet. Potassium is vital because

it regulate your body's fluid balance and controls the electrical activity of your heart and other muscles. It also serves several other functions in the human body. It lowers blood pressure, decreases the risk of stroke, supports bone-mineral density, protects against loss of muscle mass, and reduces the formation of kidney stones.

Consuming a high-potassium diet has been linked to a lower risk of death from cardiovascular disease, said Pat Brinkman, educator, Ohio State University Extension.

"Potassium helps maintain normal blood pressure by reducing the effect of sodium, but about 90% of the population in the United States consumes more sodium than recommended with only about 3% meeting the recommendations for potassium," Brinkman wrote in Potassium, a recent Ohioline fact sheet.

Ohioline is OSU Extension's free online information resource and can be found at ohioline.osu.edu. OSU Extension is the outreach arm of The Ohio State University College of Food, Agricultural, and Environmental Sciences.

According to guidelines from the Institute of Medicine of the National Academies of Science, people ages 14 and over should consume at least 4,700 milligrams of potassium daily, she wrote. Children ages 9 to 13 should consume 4,500 milligrams of potassium daily, with children ages 4 to 8 requiring 3,800 milligrams daily. Rec-

ommendations for toddlers ages 1 to 3 years old are 3,000 milligrams daily.

The best way to get the potassium your body needs is by eating a variety of potassium-rich foods daily, Brinkman wrote. There are, however, precautions you need to consider, she said.

"If too much potassium is consumed, it is normally excreted from the body without any problems," Brinkman wrote. "Some medical conditions such as kidney disorders or heart arrhythmias may require limiting potassium consumption."

Here are some foods that are high in potassium:

Baked potatoes (with the skin); Beet greens; Beans (including white, soy, and kidney); Sweet potatoes; Salmon; Orange juice; Swiss chard; Mackerel, halibut, and tuna; Non-fat or low-fat milk (chocolate or white); Spinach; Avocados; Tomatoes; Carrots

Brinkman also suggests these methods for increasing your potassium intake: Consume five or more

servings of fruits and vegetables daily, including some high-potassium fruits and

Choose fruits and vegetables for snacks.

Drink non-fat or low-fat milk, or consume non-fat or low-fat yogurt, as each of these items contain 300-400 milligrams of potassium. Include beans and le-

ing canned beans, buy nosalt-added canned beans, or drain the liquid from the can and rinse the beans to reduce the sodium. You can also choose to cook dry beans or



Last week, the Ohio Supreme Court decided to strip the initiative from the November ballot. The ruling was based purely on technical grounds and unpredictable administrative requirements.

The local county board of elections determined the initiative was unconstitutional and refused to place the people's proposed charter on the ballot. After a series of appeals to Common Pleas Court and the Secretary of State, the Ohio Supreme Court faulted the group on a procedural issue. The court did not address the petitioners' argument that the county board of elections never had the power to rule, like a court, on the constitutionality of the initiative, and that it unjustly took away the voices of Williams County

"The Supreme Court basically ruled that the people appealed to too many places and thus took too long to appeal to them, even though we were still well within the window for an election appeal to the Supreme Court. We followed the rules, including what this court stated in prior decisions. Is the court playing politics and protecting the corporate interests who want to exploit and drain our aquifer for profit?" said Cynthia Wise, a member of the Alliance.


