

### CHANGES COMING TO FORDER BRIDGE RIVER ACCESS SITE

The Ohio Department of Natural Resources, in collaboration with the Black Swamp Conservancy, will be breaking ground on a new H2Ohio stream and wetland project in Paulding County on September 28. The Forder Bridge Floodplain Reconnection Project will create a series of "treatment train" wetlands and repair a stream on the property.

Shortly after the Conservancy purchased the site in 2016, most of the property was taken out of agricultural use and reforested with native tree plantings. H2Ohio funding will be used for four acres of wetland restoration and restoring two streams on this 54-acre property.

"The goal of this project is to slow the runoff of water from the property and allow natural processes to

### ALG HEALTH TO OPEN MANUFACTURING FACILITY IN BRYAN, OH COMPANY LOOKS TO CREATE HUNDREDS OF JOBS IN NW OHIO

ALG Health announced today that they will be opening their newest manufacturing facility in Bryan, Ohio. The company will be opening its respirator mask making facility in 100,000 sq. ft of the building on Mulberry St, owned and managed by the Spangler Candy Company. ALG Health, at its peak, is forecasted to bring nearly 400 jobs to the area, starting in November of 2020.

our Spangler Main campus" says Bill Martin, President of Spangler Candy Company. "Since the space in our Spangler West campus became available, our goal has been to bring in a business that would benefit the overall community." Spangler Candy Company has owned and managed the 400,000-square-foot facility, which is the former Ingersoll- Rand/ARO manufacturing complex, for the last two years. ALG Health is current-

ly manufacturing its medical-grade respirators and masks in Defiance, OH, but the significant increase in demand has required the company find a larger location. According to Owner and CEO Adam Harmon, "The response to our products has been overwhelming, and we needed to find a space that was as close to move-in ready as possible." He continued to explain by stating, "It was crucial for us to keep the business in Northwest Ohio, and we were very fortunate to find a location in this area ready to go."

The company had previously discussed moving operations to a Napoleon, Ohio facility but Harmon noted, "The city of Napoleon was great to work with, but at the end of the day, the facility needed more upgrades than time would allow.<sup>2</sup>

like that," said Martinez of Sylvania.

"At first when she was getting bad, he would explain to everybody when we went places that she had Alzheimer's. It started to take a toll on him....In the end, he was physically and mentally exhausted. None of us could help. Or we could only help so much. He chose to do that. God love him for that. I can't believe he took on that challenge," Martinez said.

Martinez's mother died in June 2019. A mother of eight children, she didn't recognize her husband toward the end and even though she was home, she would say she wanted to go home.

researchers Dementia and public health experts are zeroing in on dementia risk factors, including lifestyle and genetics, in the Hispanic, Latino and Latinx community. According to the National Institute on Aging, the Centers for Disease Control and Prevention (CDC) reports that by 2060 the number of Latinos age 65 and older is expected to nearly quadruple, and that Latinos will face the largest increase in Alzheimer's disease and related dementias cases of any racial/ethnic group in the United States. Because age is the greatest risk factor for Alzheimer's, that means there will be more Latinos with the disease in the years aheadabout 3.5 million in the United States by 2060, according to the NIA.

Currently Hispanics are about 1.5 times more likely to develop dementia than non-Hispanic whites, according to the Alzheimer's Association's Facts and Figures report. New research released this summer is helping dementia experts understand how genetic predictors of Alzheimer's risk may differ among Hispanics of different backgrounds/heritage, and between Hispanic and White individuals.

"We need to advocate and focus in on research, understand the risk factors and dramatically improve the timeliness of diagnoses," said Julia Pechlivanos, Executive Director of the Alzheimer's Association Northwest Ohio Chapter. "Dementia is a looming but under-recognized public health crisis in Hispanic/ Latin American communities in the United States."

Alzheimer's is a progressive brain disease that affects memory, thinking and behavior. In Ohio, there are 220,000 individuals aged 65 and older living with the disease. There currently is no cure for the disease. "Alzheimer's is a disease that does not discriminate. It can't be prevented, and it can't be slowed," Pechlivanos said. "But we know that when the Association provides families with education about the disease and offers support for caregivers, it makes a great difference." Alberto Williams-Medina was born in Bayamón, Puerto Rico but spent most of his time in Vega Alta, on the northern coast of the island. He said he grew up with his grandparents and his great grandparents and was taught to care and respect his elders. His great-grandmother had

Alzheimer's which they called "senil demencia."

Today he is in the Master's in Medical Physiology program at Case Western Reserve University and will start volunteering as an Alzheimer's Association community educator to give programs in Spanish. Sacred Heart Chapel in Lorain, Ohio, whose congregation is comprised of mostly Puerto Rican and Mexican families, with a smattering of people from Central America and Latin America, will be his first assignment. "It's absolutely necessary to cater to the needs of the Hispanic, Latino, Latinx communities," he said. "I think the Alzheimer's Association trying to immerse themselves in the culture is beautiful," Williams said. "That makes us think we are valued. It's not just a onesize-fits-all."

S. Cathy McConnell, Pastoral Associate at Sacred Heart Chapel, wants to make that connection because she knows how important it is for families to connect with resources about Alzheimer's and dementia. Her mother had Lewy body dementia, the second most common type of dementia after Alzheimer's. "When people say they have someone who is sick, dying or has Alzheimer's I immediately refer them," she said.

"I was a caregiver for my mother. There were nine of us, we were a team and we were able to keep mom home. I've noticed the community here, many of them do the same thing, the problem is they are not given the same tools," Sister Cathy said.

Sister Cathy said she is not sure about the scientific differences as to why Alzheimer's may impact the Latino community more, "but the way that the community deals with it may be different. I think there is a little bit more patience when mom forgets something. In the mainstream community it's more about let's find a facility for mom."

Martinez, his sister Gina Martinez-Villagomez and sister Cynthia Neptune all helped in their mother's care. Neptune, who lived next door to her parents, said the hardest part for her was seeing her mother progressively get worse. "I would go over to the house and I would come back and I would just be crying because I knew she was slowly slipping away."

stories and 4000 square foot of floor space. The pilot and the camera crews descended from the airliner to setup as President Trump made his way down the stairs.

Security was setup up surrounding the airport. ### STATE ALZHEIMER'S PLAN **TO ADDRESS GROWING ALZHEIMER'S CASES**

In 18 months, Ohio is expected to have its first official plan to galvanize public, private and non-profit resources to address the burgeoning growth of Alzheimer's in Ohio.

Like an Octopus with tentacles, each case of Alzheimer's reaches deep into a family. According to the Alzheimer's Association 2020 Facts and Figures report, there are 220,000 Ohioans aged 65 and older living with Alzheimer's and 604,000 family and friends who care for them.

But those numbers do not tell the full story.

They do not include people younger than 65 who have been diagnosed with early-onset Alzheimer's; the number does not include anyone diagnosed with other dementias; it does not include people diagnosed with mild cognitive impairment which can be a precursor to Alzheimer's - ;and it is not inclusive of thousands of Ohioans whose family members are ignoring the symptoms or who are attributing the symptoms to normal aging and missing the medical cause.

Eric VanVlymen, Regional Leader for the Alzheimer's Association in Ohio, said, "Currently over half of the people are not diagnosed, and 50 percent are not told of their diagnosis. When you think about that you have a better understanding of how Alzheimer's impacts families, communities and our economy."

In August, Governor Mike DeWine appointed 11 Ohioans to the newly minted State Task Force on Alzheimer's and Dementia, charged to create Ohio's first state Alzheimer's plan. Led by Ohio Department of Aging Director Ursel J. McElroy and a representative from The Ohio Department of Health, the Task Force by law has 18 months to complete a state Alzheimer's plan. The group is expected to address issues such as the importance of early detection and diagnosis, resources for caregiver support, quality of care and safety.

Whatever the State Task Force comes up with, it will have a lasting impact on how Ohio fights this progressive brain disease. "First, I want to say thank you to the Governor and the elected officials for making this happen and to the Ohio Department of Aging Director Ursel J. McElroy for their leader-Let me know and I'll ship," VanVlymen said. "As give you a Penny for Your we expect Alzheimer's to double in the next 30 years, it's essential for the state to plan how to care for those individuals. This is a unique opportunity to be proactive to greatly increase the accuracy and timeliness of diagnosis through early detection," he said. VanVlymen added that accuracy and timeliness of diagnosis is more than just catching the disease earlier in its progression. The disease is costly. Today, the average per-person Medicaid spending for seniors with Alzheimer's and other dementias is 23 times greater than average per-person Medicaid spending across all seniors without

dementia, according to the Alzheimer's Association. In 2020, caring for people with Alzheimer's nationwide will cost Medicaid an estimated \$51 billion — and will rise nearly 300 percent (before inflation) by 2050.

Early Detection is Key

Dr. Alan Lerner, who is co-director of the Clinical Core at the Cleveland Alzheimer's Disease Research Center and Director of the Brain Health and Memory Center at the Neurological Institute of University Hospitals Cleveland Medical Center, said early detection is critical to beating Alzheimer's. "The focus in the field is on early detection," Lerner said. "You need to have knowledge if we think about a world where we can treat Alzheimer's better," he said.

At this summer's Alzheimer's Association International Conference® (AAIC), scientists reported results of multiple studies on advances in creating a blood test to detect changes in the brain before dementia symptoms occur. Maria C. Carrillo, Ph.D., Alzheimer's Association chief science officer, said, "There is an urgent need for simple, inexpensive, non-invasive and easily available diagnostic tools for Alzheimer's. ... The possibility of early detection and being able to intervene with a treatment before significant damage to the brain from Alzheimer's disease would be game changing for individuals, families and our healthcare system."

Another game-changer: A Possible Treatment on the Horizon

As the State Task Force shapes its recommendations, those in the Alzheimer's community are waiting with anticipation to hear the results of the U.S. Food and Drug Administration's review of the investigational drug aducanumab. If approved, aducanumab would become the first treatment ever for Alzheimer's disease. All current Alzheimer's treatments address symptoms only. A decision is expected in 2021.

### **BROWN, PORTMAN, GRASSLEY INTRODUCE BILL TO INCREASE HEALTH CARE ACCESS FOR CHILDREN**

WASHINGTON, DC -U.S. Senators Sherrod Brown (D-OH) and Rob Portman (R-OH), along with Senate Finance Committee Chairman Chuck Grassley (R-IA), introduced the bipartisan Accelerating Kids' Access to Care Act to help families access life-saving care for children with complex medical conditions. The Pioneer Railcorp (Pioneer) will receive \$4.1 million to invest in the infrastructure of the Napoleon, Defiance, & Western Railway Co. (NDW). Senator Rob Portman and Senator Sherrod Brown of Ohio announced the award of \$4,112,452 to the Ohio Rail Development Commission (ORDC) to fund the Napoleon, Defiance, & Western Critical Safety Upgrade project. This funding is awarded as part of the U.S. Department of Transportation's (DOT) fiscal year 2020 Consolidated Rail Infrastructure and Safety Improvements (CRISI) grant round.

The CRISI award will fund 50% of project costs, with \$3,862,452 (47%) matched by the NDW and \$250,000 (3%) by ORDC. The project will replace 10 miles of steel rail and replace 29,000 ties on 29 miles of rail line. The line runs from Woodburn, IN to

Napoleon, Ohio. "The majority of these granted funds will be spent in the 16 miles of track that runs the full east to west length of Paulding County," stated Paulding County Economic Development Director Tim Copsey. "Our Paulding County office was approached about this grant early this summer and was in full support in working with Pioneer Railcorp. This additional \$4.1 million dollar investment into this rail line is both welcome and needed. This is another victory for our county, those businesses that currently use this line, and those that intend to use it in the future. We can and will build on this. Everything we gain right now in building our county infrastructure at any level is setting us up for future growth," continued

Copsey. BRX Transportation Holdings acquired NDW and its parent company, Pioneer, in 2019. Since that time, Pioneer, NDW and ORDC have worked to improve tie condition and the safety and efficiency of the line. But the line remains in need of substantial

investment to provide the service necessary to grow traffic and attract new industry.

The Napoleon, Defiance, & Western is strategically located for U.S. manufacturers in a key logistics corridor in Ohio and Indiana with tremendous growth potential, but has been hamstrung for years by poor tie and rail conditions," Pioneer Railcorp CEO Alex Yeros said in a response to the news. "The CRISI grant, combined with funding from ORDC and NDW, will dramatically improve safety and efficiency on NDW. We are proud to partner on this project with U.S. DOT Secretary Elaine L. Chao, U.S. Senators Portman and Brown, Rep Bob Latta (R-OH), Rep. Jim Banks (R-IN), Federal Railroad Administrator Ronald Batory, and the honorable Commissioners and staff of ORDC and thank them for the leadership to grow rail service in northwestern Ohio. Their dedication to safe, efficient, and modern railroad infrastructure are directly supporting jobs and the economy in Ohio, Indiana, and across the U.S."

The process is difficult and full of challenging hurdles, which can delay children and their families from receiving the care they desperately need.

The Accelerating Kids' Access to Care Act would provide states with the ability to use a streamlined screening and enrollment process for

out-of-state pediatric care providers that need to enroll in another state's Medicaid program, helping to speed up access to care for kids and families and reduce paperwork requirements for providers.



• A statement that you are a qualified elector;

• If you want the ballot mailed to you, you will need to include the address to which you want your ballot mailed.

You are encouraged to mail or bring your absent voter's ballot application to this office as soon as possible due to the anticipation of a heavy voter turnout. However, pursuant to Ohio law, an application for an absent voter's ballot must be received by the Board of Elections office by 12:00 Noon on Saturday, October 31st. Applications for persons who are hospitalized by a medical emergency will be accepted until 3:00 p.m. on Election Day.

If you requested an absent voter's ballot by mail and change your mind about voting absentee and decide to vote at your voting location on Election Day, you will be required to vote a provisional ballot. You may not return your absent voter's ballot to your voting location. If your absentee voted ballot is received by this office pursuant to Double voting is against the law. You or an immediate family member may deliver vour absent voter's ballot to the Board of Elections office until the close of the polls on Election Day (7:30 p.m.) or you may return your absent voter's ballot by mail. If you return your ballot by mail, it must be postmarked no later than the day before Election Day (November 2nd) and received by the office not later than 10 days after Election Day in order to be counted. Please affix sufficient postage for the prompt delivery of your ballot. An USPS mailing label which contains the date is strongly encouraged. On Election Day, November 3rd, you must vote at the voting location where your residence address (by precinct) places you.





• There are no campsites at the Forder Bridge River Access Site. Camping is strictly prohibited on the property.

• No littering or dumping. Visitors are expected to take their trash with them when they leave.

### **OHSAA ANNOUNCES NEW FOOTBALL REGIONS AND PLAYOFF INFORMATION**

COLUMBUS, Ohio - The Ohio High School Athletic Association has announced new regional alignments for the upcoming football playoffs after 664 schools opted in for the postseason. In a normal season, 224 schools qualify for the playoffs, with eight schools from each of 28 regions earning a bid through the OHSAA's Harbin computer ratings system, which will not be used this season.

Originally, there were 709 schools that indicated they planned to contend for a playoff bid this season playing 11-man football, but the COVID-19 pandemic has caused some schools to start their seasons later or end early. Based on the recommendation from Governor DeWine and the Ohio Department of Health, the OHSAA shortened the football season.

PLAYOFF SCHEDULE AND FORMAT

On September 29 and 30, the head coaches in each region will vote to seed the teams in their region. The OHSAA will then place teams on brackets on October 1. With various numbers of schools in each region, many of the higher seeds will have a first-round bye in most regions.

Once the brackets are set, the top team on the bracket of the specific game will have the first opportunity to host the game throughout the regional playoffs. If the top team on the bracket cannot host, the other team will host the game. The OHSAA will determine sites for the state semifinals and state championships.

If a team is unable to play a playoff game on the assigned day according to the bracket, its opponent will advance on the bracket.

### ANTWERP POLICE DEPARTMENT REPORTS

This article originally was written for Visions Volume 6, published by the Paulding County Progress in 2005. Some entries have been updated.

PAULDING – There's a history behind every name of every township, waterway, town, school and land-



mark. Here are more Paulding County place names: Jackson – (Township) Probably for Provident Ap

Probably for President Andrew Jackson.

Jacquette – Unknown.

Knoxdale – (Also Knox) Possibly for the first Secretary of War, Henry Knox. Other possibilities are that it was named for Knox County, Ohio, or for a family named Knox.

Latty – (Township, Village) The township was organized in 1855 and named in honor of Alexander Sankey (A.S.) Latty, who was county auditor at the time. Latty later platted the town on his land.

Leslie's Crossing – Founded by George Leslie II, the town later was called Briceton.

Link Post Office – Unknown. This crossroad community in Carryall Township may have gotten its name for a local family, or it may have been considered a "link" between Antwerp and Hicksville.

Llewellyn – (Also Lewellyn) Tom and Sam Llewellyn built on the north side of the Paulding-Van Wert County Line; the area on the south side of the road was Scott. Townspeople had to choose between the names of Scott and Llewellyn.

Mandale – Named for Dale Mann. A plat for the town was filed in June



A township and a village were named for Alexander Sankey Latty, a pioneer, county official and judge. 1889 by D. Mann and Alice Mann.

Marble – Unknown. Possibly a family name.

Marie DeLarme – One version says it was named in honor of a daughter of an early French boatman. However, another source indicates the name is a corruption of the phrase "marais de l'orme" meaning "elm swamp."

Maumee – According to one writer, the French explorers meeting the Miami Indians understood from them the name of their tribe as Me-ah-me or Meau-me, which they recorded in French as Miami. The rapid pronunciation of this three-syllable word, Miami, led the settlers here after the War of 1812 to pronounce it in two syllables as Maumee. The name also was sometimes written as Omi or Omee, which may have been short for the French "au Miami" and "aux Miamis," meaning to or at the Miami or Miamis.

McDonald Pike – Another name for Road 107. A road often was named for the person who petitioned for it. McGill – Named for John McGill, an organizer of Benton Township, described as "that old wolf hunter and veteran of the War of 1812."

Melrose – Believed named after the Melrose Abbey in Scotland.

Molasses Gap – For a sorghum mill there, used to press juice for sorghum cane; the juice is boiled down to make molasses.

Morrison Post Office – Named for Chief Justice of the U.S. Morrison R. Waite. The site was also known as Holcombeville.

Murat – A canal town named for Joachin Murat, a French statesman and military leader.

Newberg – (Also Newburgh) Probably descriptive; literally, "new town." Also see Royal Oak.

New Harrison – Probably named in connection with William Henry Harrison (see "Harrison").

New Rochester – One source indicates the town was named by Johnny Appleseed, who traveled through Paulding County. Possibly for Rochester, N.Y. or East Rochester, Ohio. There were Rochesters in Noble, Stark and Lorain counties in Ohio, and a New Rochester in Wood County.

Nindeville – (Also Nineville) A settlement around the Ninde family's mill, located in Harrison Township.

Oakwood – The town was originally called Wide-A-Wake, but later received the more prosaic name of Oakwood, largely because of the heavy stand of oak trees in the area, according one source. Another source suggests a ridge filled with white oaks was located there.

Ohio – From an Iroquois word meaning great river.

Oquanoxa's Reserve – Named for a chief who resided in a village there with about 600 Indians of the Ottawa tribe until the reservation was sold and its inhabitants were forced to relocate to Kansas.

Paulding – For John Paulding, who along with David Williams and Isaac Van Wart captured Revolutionary War spy Major Andre, who was working with Benedict Arnold.

Payne - Probably for Henry G. Payne, a U.S. Senator from Ohio and lawyer with financial interests in the railroads. A post office called Payne was established there in 1858. The suggestion has been made that the post office was named Payne by a grateful community for Senator Payne's efforts on its behalf with the Post Office Department. Other speculation is that it was named for a general in the army or for an early postmaster. The railroad station and later the town adopted the name

of the post office. The community changed its name from Malottville to Payne in 1882.

Plumb's Crossroads – For Caleb Plumb, who established the crossroads settlement and built a store.

Point Pleasant/Pleasant Grove – A post office settlement established on the Paulding and Van Wert Pike; probably descriptive.

Reid – (Also Reids) Named for Capt. Robert M. Reid, who was largely instrumental in securing the establishment of a post office for this canal town.

Renollet – For the Renollet family, who had large holdings at the site on the Wabash Railroad.

Roselms – (Also Roselm) From the family name "Rose" and the elm trees in the vicinity.

Royal Oak – A man named Darling opened a small grocery in the front room of his cabin at the site. Darling fashioned a sign from a store packing box and wrote on it with charcoal the words "Royal Oak Grocery." He then nailed this sign to a stately old white oak tree. It was from this grocery and sign that Newberg got its other name, Royal Oak. Also see Newberg.

Scott – For John Scott, who platted the village in 1882. Also see Llewellyn.

Section 8/Section Eight – A timber town established in Section 8 of Paulding Township in the 1890s.

Six Mile Creek – So called because it empties into the Auglaize River six miles above its mouth.

Smiley – For J.E. Smiley, the postmaster who ran a general store and operated a mill and a shingle and a basket bottom factory.

Sophia – Unknown. A post office town in Blue Creek Township from July 1893-April 1895.

Spencer – Unknown. This canal town was located in Washington Township. Possibly a family name. One source mentions that "the 'state boat' best remembered by the older citizens of Washington Township was under the command of Capt. Spencer."

St. Andrews – Laid out by two men of Scottish descent and named for the patron saint of Scotland.

Sunnyside – Probably descriptive.

Tate's Landing – For Irish canal contractor Lyle (or Lyal) Tate, who purchased land there on the Wabash & Erie Canal.

Timberville – Combination of "timber" - a local product or resource - and "ville" meaning town. It was located at Lock 31 on the Miami & Erie Canal and

> Lock. Tipton – Unknown. There also are Tiptons located in Indiana and Iowa and

> England. Toronto – Unknown. Possibly for Toronto, Canada or Toronto in Jefferson

County, Ohio. Washington – (Township) Probably for George Washington. Washington is America's most common place name.

Wayne Trace - Named in connection with General "Mad" Anthony Wayne, hero of the Battle of Fallen Timbers in 1794. Wayne's army traveled through Paulding County along the Auglaize River, Flat Rock Creek and Maumee River. There's a road named Wayne Trace in Fort Wayne, and reportedly U.S. 127, which runs in front of the Wayne Trace High School, was once known as Wayne Highway.

Wildcat Creek – Probably descriptive. A pioneer reminiscence noted that in the area in 1857, wildcats, bear, wolves, deer and panthers were numerous.

Worstville – For John Worst, who owned a sawmill in this railroad town in the late 1800s.

Wrexham – From Wrexham Lewis, who platted a town and called his Wrexham. Alexander Sankey Latty platted another portion of the town and called his Latty. The town was later incorporated as Latty.


