Can you give me an explanation concerning the animals in Leviticus 11:8 that were not to be eaten?

From the time of creation to the flood, everyone was a vegetarian (Genesis 1:29-30). Then God permitted everything that moved to be eaten (Genesis 9:3). Around 1490 B.C. the Lord gave Moses instructions specifically for the Jewish people, primarily to set them apart from the Gentiles. These laws were a "shadow" (picture) of Christ according to Colossians 2:14-17 "Blotting out the handwriting of ordinances that was against us, which was contrary to us, and took it out of the way, nailing it to the cross; And having spoiled principalities and powers, he made a shew of these openly, triumphing over them in it. Let no man therefore judge you in meat, or in drink, or in respect of an holyday or of the new moon or of the Sabbath days: Which are a shadow of things to come; but the body is of Christ." The unclean animals were associated with things like bringing forth death, having filthy habits, feasting on dead, rotting and diseased animals, etc. They were a good picture of both sin and sinners. These animals included all kinds of vultures, parasites, slimy scaleless fish, serpents, pigs, swarming creatures and many others. The clean animals had better habits and were less destructive - such as cows, sheep and goats. Once that picture had fulfilled its purpose when Christ died on the cross, the necessity for keeping it was done away as we saw in Colossians 2:13-17. Read also Acts 10:9-15 and verse 28. 
PUBLIC NOTICE: VILLAGE OF PAULDING CEMETERY SPRING CLEANUP



You might have initially based your financial strategy on a specific type of retirement lifestyle, but now that you're nearing retirement, perhaps you've changed your mind. Your anticipated new lifestyle might require either more or less income than you had originally projected and if that's the case, you may need to adjust the risk level in your portfolio or make other adjustments.

As you can see, managing risk is a balancing act - and you may need to make some tough choices. But as long as you're aware of how much risk you can take, and how much risk you may need to take to reach your goals, you can develop a strategy that aligns with your objectives.

ANTWERP CHAMBER SPOTLIGHT ON BUSINESS

Our Antwerp Chamber of Commerce spotlight for February is Antwerp Manor Assisted Living Facility located in the old elementary building at 204 Archer Drive in downtown Antwerp.

Brian McLaughlin is the administrator of Antwerp Manor and he has a special connection to this particular area of the town. His great grandfather was the architect of the old Antwerp school and Brian's father helped with the project when he was home from college back in 1963. This was the last project they worked on together as Brian's great grandfather died shortly after the completion of the school. In 2004, Brian's father was selling tooling to Dana and a few other machine shops in Antwerp when he discovered that the city was planning on demolishing the old school as the new K-12 building had been constructed just east of town. Armed with a desire to preserve what

he and his grandfather had built he made a deal with the city council to build a field house at the new school in exchange for the old school buildings. Brian's father was now the proud owner of an old school with no idea what to do with it. After discussion with local and state officials, the idea of having an assisted living facility in Antwerp would be just what the community needed. The remodeling of the old school began in 2005 and all of the supplies that were left behind were shipped to Haiti to help with the rebuilding of schools after Hurricanes Ivan and Jeanne devastated the island.

On January 1st 2006 the Essen House Restaurant opened to the public, a full year before the first phase of the Manor House opened in January 2007. The second and third phases of the facility opened in 2009. The recession of 2008-2010 started a chain reaction which resulted in a change of ownership in 2013. The new owner leased the business to a company

MILITARY HISTORY OF PAULDING COUNTY

Joshua Byron Hartzog, Paulding County's only Medal of Honor Recipient, was born February 3, 1866 in Grover Hill, Ohio. The son Of Joshua



Schuykill County, Pennsylvania, January 30, 1830. Mr. Hartzog was of German descent and moved to Paulding

was

in

County in 1850, with the trade of a blacksmith. Upon moving into Washington Township, he met and married Eliza J. Mackeral, January 16, 1851. Eliza was born in 1833, and passed away December 31, 1864, leaving behind 4 children. She is buried in Middle Creek Cemetery, Grover Hill, Ohio.

Joshua remarried to Sarah Jane (Blythe) Pease. She was born January 27, 1838, in Waynsburg, Stark County, Ohio. Her first husband was Mark Pease, who passed away. Joshua and Sarah were married May 15, 1865. Sarah's father, Henry Blythe, was a Civil War Veteran. With Joshua and Sarah's marriage, the blessing of 4 children were born.

Thus the story of Joshua Byron Hartzog begins. As a small child, Joshua picked up the values of family and hard work as he worked the farm ground in Washington Township with his father and other siblings. By 1889, Joshua wanted to seek the adventure while serving in the United States military.

Joshua traveled to Michigan. On April 25, 1889 at Detroit, Michigan, at the age of 21, Joshua enlisted in United States Army. He lists his occupation as a laborer. Joshua has Dark Eyes, Dark Complexion, Dark Hair and is 5-4" tall. He is assigned to Company E. 1st United States Artillery with the rank of private. On December 29, 1890, Joshua was a participant in the Pine Ridge Campaign that occurred at Wounded Knee, South Dakota. The purpose of this action, was to arrest the Sioux Chief, Big Foot and disarm his warriors. A powerful medicine man had convinced the warriors that their "Ghost Shirts", would protect them from the Bluecoats bullets.

When Joshua's commanding officer was wounded, Private Joshua Hartzog, braved the heavy gun fire to rescue the officer. An eye witness stated, "All the Indians opened fire on us. One of my men went for ammunition and did not come back. My captain called on me to come back, but I kept moving nearer to the Indians, and kept shouting. Lieutenant Hawthorne came toward me and was calling, when suddenly I heard him say, "Oh, my God"! Looking around I saw him lying on his side, and then I knew he had been hit. Hartzog ran to him and carried him back behind the hill".

On March 21, 1891, for his actions on December 29, 1890, at Wounded Knee, part of the Pine Ridge Campaign, Joshua Bryon Hartzog was awarded

the Congressional Medal of Honor. The written statement for his medal reads, "Went to the rescue of the commanding officer, who had fallen severely wounded, He picked him up and carried him out of range of hostile gun fire." He also served with Company G., 5th United States Artillery, with the rank of sergeant. Joshua stayed in the military until July 21, 1892. In 1893 Joshua found himself at the Chicago World's Fair as part of the Exposition Police Force. Joshua returned home to Grover Hill and July 25, 1894, he marries Elvina Elizabeth Gensel who was born December 10, 1865, in Paulding, Ohio. She was the daughter of James H. and Mary (Ackerman) Gensel. James was a Civil War Veteran, who served with 20th Mississippi Infantry, Confeder-

ate Army. With this marriage, 8 children will be born. With 2 sets of twins. On July 25, 1897, Joshua's father, Joshua Sr., passed away, he was buried in Middle Creek Cemetery, Grover Hill, Ohio. By 1910, Joshua and family was living in Pinconning, Bay County, Michigan as a farmer.

On February 10, 1910, Joshua filed for his military pension and the family moved to Arkansas. On September 24, 1916, in Higginson, White County, Elvina passed away and is buried in Gum Springs Cemetery, Searcy, White County, Arkansas.

On August 7, 1917, Joshua married Carrie E. Davis, in Wellington, Kansas. (Appar-ently, that marriage did not work out!) In 1918, Joshua married, Mariah Gertrude Thurmon, born in 1870, and lived in Higginson, Arkansas, and had 1 child, a daughter, Thelma Lucille. Joshua was a farmer. Well, that marriage will not last either. In 1923, Joshua married Madie Bell McClellan, who was born in 1884 in Mississippi. They lived in Garden, Arkansas until Joshua Bryon Hartzog died. He passed away, May 27, 1939, in Beebe, Arkansas. He was buried beside his first wife, Elvina, in Gum Springs Cemetery, Beebe, Searcy, White County, Arkansas.

Families received invitations with links to view the service online. The public will have the opportunity to view it this summer.

Saum says the memorial service includes reflections from CHP Hospice nurses, social workers, and staff; music by the CHP Hospice musician and a patient family member; and messages of hope and encouragement from CHP Hospice chaplains.

CHP also offers monthly bereavement support groups to promote healing following a loss. The groups are free



THE FIRST FAMILIES IN PAULDING CO. (BURIED WHEN/WHERE?)

Who were the first persons to succeed and die in what is now Paulding Co.? The first white settlement was made in Auglaize Twp. by Shadrach Hudson in 1819. The route along the Auglaize River had been opened up by Gen. Wayne to Defiance. More settlements came on the Maumee from Ft. Wayne and along the Indian trails throughout the county. Eventually all of Paulding Co. became settled. Some of the townships became organized before the county became organized in 1839. Who were these FFA ("First Families of Antwerp) in 1800? or the FFP (First Families of Paulding") in 1800? or the FFC ("First Families of Charloe) in 1800? (and others). There are always some "Layers of society that were evident" by how the people "do their business"; "pay their bills"; "handle their personal affairs". The people who belong to certain churches, live in certain parts of town or areas and try to make the best

appearance "do appear" to be the most prominent, honest and the citizens who will bring the community up in it's top standards. Preachers, teachers, business people, and leaders in the community help with the community fellowship to form a good teamwork for good community government. It's always hopeful that communities have good examples to follow. THEY are buried in the cemeteries.

Even these early settlers realized the importance of schools and churches being made available. Taxes were a necessary thing in order to get ahead, but it had to be done. Roads had to be built, teachers had to be had, Newspapers needed to be encouraged and supported if the community was going to succeed. Good political leadership would make or break them ..

We are now in 2021. What happened to all of these historical people who have gone before us and are buried in the soil of Paulding Co.? Some were prominent, some were not. There are many centuries of graves that are apparent in our graveyards and many more that are not. The American Indians were here for centuries before the white settlers. They lived along the Maumee and Auglaize waterways. By traveling around Paulding Co. we can see that a lot of pioneers and citizens have come to Paulding Co, settled here and died here. We have a lot of beautiful cemeteries. Many are fading/who are these people?

Even the Maumee River in Defiance has marked Indian graves along the highway dating back to 1790. Ponti-

ac's birth memorial is there, also. We have Indian graves in Paulding Co. (no doubt); graves of : white settlers, black slaves; & our cemeteries are filled in each twp. with graves of persons who wished to be buried here or who died here as citizens. Some of the stones are no longer visible. Who are they?

If wills were not probated when a person died, which other proof is there of the person's death other than an obituary or newspaper writeup? Health Dept. records are not always up-to-date or back as far as the death we are searching. Some of our cemeteries are VERY old in Paulding Co. (or not at all).

The local library has an "obituary file" of newspaper

items. Also, it has some books of research by the local Genealogical Society on the cemeteries. However, these do not cover the deaths that are not visible in the cemetery. (or newspapers). Some people are kind enough to share old Bibles, but they only go back so far. Some funeral homes have limited info to share.



Northwest Ohio - Wildlife District Two

In February 2020, Lake Erie froze and provided a small window for anglers to ice fish. During one of these days, State Wildli fe Officer Matt D. Smith assigned to Henry County, was contacting anglers as they came back to shore to verify catches and to check for fishing licenses. Officer Smith contacted two men from Wisconsin who had several walleye shorter than the 15-inch minimum length. The men were issued the appropriate citations. In December, State Wildlife Investigator Matthew Fisher, assigned to the Lake Erie Unit, was on patrol when he received word of a disabled vessel on Lake Erie. High winds caused the waves to reach 5 feet high and did not allow another boat on site to reach the disabled boat. The U.S. Coast Guard was called to help tow the boat to safety. Investigator Fisher monitored the location of the disabled boat through binoculars as the Coast Guard responded. When the Coast Guard arrived at the

hunter orange clothing, and did not have written permission to be on the property. Summonses were issued and the defendant was found guilty, subsequently paying \$495 in fines and court costs.

Southeast Ohio - Wildlife **District** Four

While on patrol in Gallia County in February, State Wildlife Officer Roy Rucker spoke with U.S. National Guard personnel who were assisting with the brush cleanup from a recent ice storm. In situations that involve public safety, wildlife areas sometimes serve as temporary holding spaces to help other agencies complete their mission. In this instance, Crown City Wildlife Area was used as a staging site for brush that was removed from local roadways. The two individuals with the National Guard were using a backhoe to compact the pile as dump trucks came into the area to unload the brush. Access to the wildlife area was not disrupted, and the brush was removed when it was safe to do so.

During the 2020 two-day white-tailed gun hunting season, State Wildlife Officers Wes Feldner and Logan Ambrister were patrolling in Belmont County when they received information about a road hunting incident. The officers responded to the area and met with the person who reported the violation. He had contacted an individual loading a deer into the back of a small truck. The officers examined the area and found evidence that the deer was shot from the roadway. The property where the violations took place was leased for hunting, and the suspects did not have written permission to hunt there. The officers were able to identify two suspects. Both individuals admitted to committing several violations, including hunting with the aid of a motor vehicle, shooting from a roadway, hunting without written permission, and failure to complete the game check process. The suspects were issued several summonses, and the firearm and the deer were both seized as evidence. Both individuals were found guilty in the Belmont County Western Court and paid \$870 in fines and court costs. The suspect who shot the deer was given a oneyear hunting license suspension. The deer was ordered forfeited to the Ohio Division of Wildlife and was later processed by a local facility and the venison was donated to a food pantry.

the Miami-Erie Canal. At one popular fishing location, Officer Schemmel was contacted by a mother while her family fished beneath a bridge. One of her children had scraped and cut his head underneath the bridge and required immediate attention. Officer Schemmel quickly responded with a first-aid kit and provided water and bandages to properly dress the wound. The boy quickly calmed down and was later transported to a nearby medical facility. Prior to the young angler departing, Officer Schemmel gave him a new Spider-Man youth fishing pole for his strength and patience. The fishing pole was graciously donated by a local conservation club to be handed out in situations such as this. After checking in with the family later that day, the boy received a few stitches, but was eager to get back out and use his new rod and reel.

Near the end of the south zone waterfowl hunting season, State Wildlife Officers Matthew Hunt and Mathew Bourne were contacting groups floating on the Mad River. After contacting a few hunters along the river, the officers heard multiple shots near their location. The officers investigated and found three individuals hunting from a blind over a private pond. The hunters were new to waterfowl hunting. One of the hunters had not obtained the required state and federal hunting stamps. Two of the firearms were not properly plugged. The individuals received two verbal warnings for the unplugged firearms. One citation was issued to the individual who did not purchase the required stamps.

dock, the water levels were too low to launch their boat, so they had to move to another location. During this time, Investigator Fisher continued to monitor the boat, which was drifting farther out into the lake because of the high winds. Investigator Fisher relayed the boat's location to the Coast Guard to assist them in locating the vessel. Once the boat was safely at the dock, it was discovered that the boaters had been waterfowl hunting when some of their duck blind material became entangled in the motor. When one of the hunters went to cut it free, he accidentally stepped on the fuel line connector and broke it, rendering the motor inoperable and setting the boat adrift.

Northeast Ohio - Wildlife District Three

Conservation projects are as much a part of a state wildlife officer's responsibilities as law enforcement-related tasks. Each year when winter temperatures dip low enough and several inches of ice forms, wildlife officers venture on foot into wetlands to tend wood duck nest boxes, preparing them for the spring season. State Wildlife Officer Tom Frank, assigned to Mahoning County, checks and cleans approximately 70 boxes each year when weather allows. In the past several decades, conservation efforts involving wood duck nest boxes have contributed greatly to the recovery of this species. To learn more about placing nest boxes for wood ducks as well as other cavity nesting species, visit wildohio. gov. During the 2020 white-tailed deer gun hunting season, State Wildlife Officer Tom Frank, assigned to Mahoning County, was patrolling an area where hunters are known to trespass. in electric plant facilities. The largest capital credits refund in co-op history: Nearly \$2.2 million was returned to members last December via capital credits – this is proof of each member's ownership in the co-op.

PPEC replaced 528 poles, rebuilt 21 miles of line, and repaired the Fort Brown and Continental substations. Cecil Sub-

station was rebuilt completely (a \$2 mil-lion project). Total system outage time was re-duced to 59 minutes per member in 2020 – well below the goal of 100 minutes.

"Overcoming obstacles and surviv-ing them is the co-op way, and it's in large part due to the dedication and resilience of our employees," Carter said. "I want to personally thank each employee that useds for BUFC I heavity ours different works for PPEC. I know it was a difficult and fearful year, and I greatly appreciate the efforts each one of you put forth."

Carter recapped the years of experi-ence the co-op has lost due to retirements, including Member Service Manager Re-nee Boss, Lineman Dennis Clark, and Operations Manager Ted Slusser. "I also want to thank Mr. Doug Fort-man a chaleves the howerd It's collarge

man as he leaves the board. It's a challenge to replace all this experience and wisdom at the co-op," Carter said.

Looking at rates, Carter explained that wholesale power prices from PPEC's Cardinal Generating Station "have re-mained mostly flat" but are beginning to increase due to transmission cost increases.

"Moving the power from our gen-erating plants to our local substations is done over the transmission system," Carter explained. "The transmission system is like a big toll road – we must pay to use it. These costs have increased and are projected to continue increasing in coming years. They will impact future rates." Board Secretary-Treasurer Dr. Ron

Black reported that the cooperative "per-formed well financially" in 2020, with PPEC's auditing firm of Bashore, Reineck, Stoller, and Waterman issuing an unqual-ified, or clean audit opinion. This means the financial records accurately reflect the
