## FIRST ANNUAL RALLY 4 RECOVERY EVENT IN VAN WERT, OH

According to mortality reports from the Ohio Department of Health, drug overdoses killed more Ohioans in 2020 than in at least the previous 14 years. The COVID-19 Pandemic led to a spike in substance abuse, and now more than ever, local communities should be aware of recovery resources and services.

Families of Addicts Van Wert will present its first-ever Rally 4 Recovery, taking place at Fountain Park on July 18, 2021, from 1:00 p.m. to 5:00 p.m. The event will feature emcee Scotty Mays, speaker Steve Makofka, and four opportunities for anyone to learn how to administer Narcan. In addition, families from Northwest Ohio and Northeast Indiana can be introduced to wrap-around support services available to those recovering from addiction.

Event organizers are currently seeking 30 vendors to set up tables at the event and a volunteer photographer to capture the event. Those interested in either opportunity are encouraged to call FOA at (419) 203-0200 and ask for Shane Manson.

Families of Addicts is headquartered in Dayton, OH and has multiple hubs in the Miami Valley, including Van Wert. FOA rebuilds families and transforms lives through the 3 E's; educate, empower and embrace. Through weekly meetings in Van Wert County, navigation, one-on-one phone support and outreach opportunities, FOA is a

sought-after and respected resource. The non-profit is unique because it provides support for the entire family and advocates for individuals to find their face and voice, which is key to eliminating the stigma associated with addiction. ## PHYSICIAN ENCOURAGES A HEALTHY LOSS OF PANDEMIC POUNDS

As the days get longer and more of our community is opening up, a local physician is encouraging patients to reverse the extra pounds they may have added over the past year of the pandemic. David Mohan, MD, Family Medicine, with Lutheran Health Physicians, says it's a great time to get back on track with healthy habits and shed that extra weight.

"Pandemic pounds are going to be the same as loss of pounds at any other time," says Mohan. "Consistent adherence to a low-carbohydrate and low-calorie diet on a daily basis is needed. Learning how to count carbs and count calories is really essential."

A recent study by the University of California, San Francisco, confirmed what many of our scales and wardrobes have already shown us - lower activity levels and increased snacking and overeating have added up, and not for the better. The study found significant increases in weight of roughly a

pound and a half gained per month following the shelter-in-place orders of last spring.

Even before the pandemic, CDC data from 2017-2018 showed that 35 percent or more of the adults in Indiana struggled with obesity. "Overweight" is defined as a body mass index (BMI) of 25 or higher; "obese" is defined as a BMI of 30 or higher.

Extra pounds can increase the risk for many serious diseases and health conditions that are some of the leading causes of preventable, premature death. Being overweight can lead to high blood pressure, Type 2 diabetes, high blood cholesterol, coronary heart disease, stroke, gallbladder disease, osteoarthritis, sleep apnea, many types of cancer and other concerns.

"If you have gained the 'Quarantine 15,' a gentle caloric restriction of around 1,800 calories a day coupled with 20 to 30 minutes of cardio exercise at least 5 days per week is essential, if approved by your physician," explains Mohan. "Regular cardio exercise traditionally increases the heart rate to a targeted 65% of the maximum heart rate, helping burn calories and improving cardiovascular fitness. Always check with your physician to determine if caloric restriction and/or cardio exercise is right for you."

According to the National Institutes of Health, strategies for weight loss and weight maintenance include dietary changes, physical activity, behavior therapy, pharmacotherapy and surgery. Your primary care physician can help you determine what course of action can support your health objectives.

## NSCC RECOGNIZES NURSING AND ALLIED HEALTH GRADUATES AT PINNING CEREMONY

Northwest State Community College recognized its Nursing and Allied Health division graduates at a recent pinning ceremony in the following areas: Practical Nursing (PN), Registered Nursing (RN), Phlebotomy, and Medical Assisting.

Graduates of the nursing programs are eligible to take the National Council Licensure Exam (NCLEX) and enter directly into the workforce, or they may transfer their credits for additional study. During the ceremony, the College recognized fourteen students for induction into the Alpha Delta Chapter of the Alpha Delta Nu Nursing Honor Society. In order to qualify, students must maintain a minimum 3.0 grade point average, with at least a B in all nursing classes.

Both Phlebotomy and Medical Assisting options lead to entry-level positions in the healthcare field, and students earning the Phlebotomy Technician certificate may choose to continue their education for an associate degree in Medical Assisting.

## FDA-APPROVED TREATMENT QUICKLY IMPROVES PATIENT'S QUALITY OF LIFE

Sandra Johnston remembers her first episode like it was yesterday. She felt she couldn't breathe, experiencing a shortness of breath as though she had just run a marathon. Worried, her husband took her to the emergency room, where doctors had to restart her heart to get it back into rhythm. The diagnosis was atrial fibrillation, a heart rhythm disorder that causes the heart to beat quickly and chaotically.

Atrial fibrillation - also known as "AFib" or "AF" - is the most common heart rhythm disorder, affecting more than 2.3 million people in the nation. AFib occurs when the heart's electrical rhythm is disrupted, which prevents blood from being pumped efficiently to the body.

Left untreated, AFib can lead to stroke, weakness, breathlessness, fainting and a decreased quality of life.

For 15 years, Johnston's condition was mostly controlled through medication. When she once again experienced shortness of breath and an irregular heart rhythm, she was referred to Jason Rodriguez, MD, a cardiac electrophysiologist at Lutheran Hospital.

"They did a number of tests and talked to me a lot about my options," says Johnston. "That's when Dr. Rodriguez said I was a really good candidate for cardiac ablation."

Shortly after Johnston's consultation with Dr. Rodriguez,

she experienced an AFib incident lasting 44 hours, forcing doctors to stop and restart her heart to get it back into rhythm. "We decided to go ahead with it (the procedure) at that point because I couldn't live like that," explains Johnston.

The procedure - called pulmonary vein isolation (PVI) - is a new cardiac ablation treatment option for AFib patients. PVI creates scar tissue around the pulmonary veins to block the electrical signals that cause arrhythmia. While older treatments rely on X-ray or mapping support for guidance, this procedure uses a miniature video camera and "headlight" to deliver a live-action view of the inside of the heart. The amount of laser energy used during the procedure can be customized based on a patient's needs and the device's unique balloon design adapts to the heart's specific anatomy. Lutheran Hospital is the first and only site in Indiana currently offering PVI.

"This new technology has been designed to perform with unparalleled accuracy and precision," explains Rodriguez. "We are committed to innovation and offering our patients early access to many of the latest cardiac treatments."

"As the first and only site in Indiana to perform this next-level procedure, we continue to advance heart care for residents throughout the region," adds Brady Dubois, CEO, Lutheran Hospital. "The work of Dr. Rodriguez and the entire

**MILITARY HISTORY IN PAULDING COUNTY**

Dr. Doctor Craig Goings, I know, the name sounds like a typo, but seriously, this was his real name. He was born in Rumley, Shelby County, Ohio. The son of Joel Westin, who was born in Virginia, March 16, 1799, and Elizabeth (Cole) Goings, born in Virginia, February 5, 1808. Joel and Elizabeth were married November 7, 1831, in Guernsey, Ohio.

Doctor had parents who had census takers confused. Joel W. Goings, was of Indian race, a member of the Wapoo Tribe. Elizabeth, was of Irish descent. So in the 1840 census, Doctor was listed as "colored". In 1850, while living in Shelby County, Ohio, census records list Doctor as Mulatto. Doctor was the seventh son of the family, and commenced



"doctoring", at the early age of twelve, while living in Shelby County, Ohio. In Van Buran, Ohio, July 16, 1860, Doctor married Rebecca Fox, the daughter of Archibold, a full blooded Indian, and Mary Ann (Collins) Fox. Together they had nine children.

Doctor Goings had received some college education and was known as a "Faith Healer". He claimed that the "spirits" had imparted to him the healing powers that he possessed and used.

In June of 1863, in Shelby County, Ohio, Doctor Goings, registered for the Civil War Draft. Doctor was not selected to serve, the 1890 Veteran Census had his name down, but all the lines on the form were left blank. The 1860's ended with the death of his mother, Elizabeth, February 8, 1869, in New Rumley, Harrison County, Ohio. She is buried in Collins Cemetery, Kettleville, Shelby County, Ohio.

By 1870, Doctor, Rebecca and five children were living on a farm in Van Buren, Shelby County, Ohio. Doctor started to become well known, after practicing in the states of New York, Pennsylvania and parts of Ohio.

Doctor's father, Joel Westlin Goings, passed away, September 22, 1872 in New Rumley, Harrison County, Ohio and is buried along side his wife, Elizabeth. By 1880, the Goings family was still living in Van Buren, Ohio, but with seven children. Doctor was still farming and traveling to different parts of numerous states as a "faith healer".

On November 5, 1881, the Goings family, settled on a farm in section 7, Washington Township, north of the Mt. Zion E.U.B. Church. Dr. Goings was a member of the Methodist Episcopal Church and belonged to the Masonic Lodge at Shipperville, Pennsylvania. He was elected Washington Township Trustee in 1884, as a Republican, and served one term.

By 1900, Doctor and Rebecca, were still living in Washington Township. That same year, he published a pamphlet called "The Faith Cure to the Invalids", a nineteen page pamphlet which sold for .25 cents a copy. Dr. D.C. Goings passed away, June 1, 1911. He was buried in Middle Creek Mt. Zion Baptist Church Cemetery, north of Roselms, Ohio

After the death of Doctor, Rebecca lived with her daughter Julia and her husband, Howard Grant in Washington Township. Rebecca passed away, August 15, 1922 and is buried beside her husband Doctor. Doctor was well known as a well to do man in his community.

good idea to recognize the importance of good communications because it plays a role in almost every aspect of living - including your finances. You'll want to clearly communicate your financial goals to your loved ones - and you'll want to hear theirs, too.

Let's look at some of the communications you might have with family members:

- Your spouse - You and your spouse may have different thoughts about a range of financial topics - how much to save, how much to spend, the level of debt with which you're comfortable and so on. Try to reach some type of consensus on these issues. However, in regard to investing, you don't necessarily have to act in unison all the time. You each may have different investment styles - one of you may be more aggressive, willing to take on more risk in exchange for potentially higher returns, while the other would rather invest with an eye toward mitigating risk, even it means accepting a lower return. Of course, there's nothing stopping each of you from pursuing your individual investment strategies in your own accounts - IRA, 401(k) and so on. Still, if you are going to work toward common goals - especially toward a shared vision of your retirement lifestyle - you each may want to compromise in your investment choices. And this accommodation is even more necessary in your joint accounts.

- Your parents - If you may someday be involved with your parents' financial plans - which is highly likely - you should know in advance what to expect. This may not be the easiest conversation to have, but it's an important one. So, for example, ask your parents if they have a durable power of attorney, which allows them to designate someone to manage their financial affairs if they become physically or mentally incapacitated. You might also inquire if they have protected themselves against the potentially enormous costs of long-term care, such as an extended nursing home stay. If not, you might suggest that they contact a financial advisor, who can offer solutions. Once you begin communicating about these issues, you may well want to go further into your parents' estate plans to determine what other arrangements, if any, they have made. If it seems that their plans are not fully developed, you may want to encourage them to contact an attorney specializing in estate planning.

- Your grown children - Just as you talk to your parents about their estate plans, you'll want to discuss the same topic with your own grown children. Let them know who you have named as a durable power of attorney, what's in your last will and testament and whether you've established a living trust. If you're already working with a financial advisor and an estate planning professional, make sure your children know how to contact these individuals. Of course, you don't have to confine your communications to estate plans - if you want to help your children financially, such as loaning them money for a down payment on a home, let them know.

By talking with your loved ones about key financial matters, everyone benefits. So, keep those lines of communi-

cation open.

## OHIO STATE LIMA AND FORD ANNOUNCE PARTNERSHIP TO ESTABLISH ENGINEERING EDUCATION AND MANUFACTURING CENTER

The Ohio State University at Lima and the Ford Lima Engine Plant announced a partnership to establish the Ohio State Lima Engineering Education and Manufacturing Center (EEMC) at Ford Lima Engine Plant Training Center today. The new center will revitalize the existing training center at Ford to provide learning and laboratory experiences for students in Ohio State's Bachelor of Science in Engineering Technology (BSET) program.

"This partnership will prepare students to immediately contribute to the 21st century manufacturing engineering jobs in our region upon graduation," said Tim Rehner, dean and director at Ohio State Lima. "The EEMC will integrate academia and industry by bringing both systems together in one space. Students will benefit from having easy access to a resource-rich space that is informed by the best from manufacturing systems and academic discoveries."

The 40,000 square foot EEMC will house learning and laboratory courses beginning in Autumn 2021. This renovated space will provide students with state-of-the-art hands-on experiences involving metrology, materials, machining, assembly, robotics, industrial controls and CAD/CAM. Originally built in 1994 to address local training needs, the facility is poised to

provide critical space for an in-demand program.

"We're eager to transform this space and ultimately the advanced manufacturing landscape in this region," said Shawn Stewart, plant manager at the Ford Lima Engine Plant. "The EEMC will establish west central and northwest Ohio as the hub for manufacturing engineers in the region and the model for manufacturing engineering education."

Ohio State launched the BSET in Autumn 2020 on three of Ohio State's regional campuses, including Ohio State Lima. This unique degree was developed to address the gap between education and industry and focuses on industrial manufacturing leadership development. The program integrates teaching and learning with industry examples, laboratory equipment and manufacturing experts as faculty and mentors.

"Having young, educated and talented engineers who design and operate our region's world-class manufacturing plants is essential to long-term competitiveness and economic development," said David Berger, mayor of the City of Lima and chair of the Lima Auto Task Force. "I applaud the collaboration between the Lima Ford Engine Plant and The Ohio State University at Lima which is creating the opportunity for showcasing a unique four-year engineering program to fill critical human resource needs for our local industries."

upstairs has been turned into the costume room and the upstairs community room now has cupboards for props and other stage equipment. The second-floor lobby has seen some improvements and the balcony is now the most recent project.

Enlarging the tech booth was the first major project along with a new soundboard and now the addition of a new

lighting console and new LED lighting on stage. The balcony floor has been reinforced and leveled to allow for the installation of permanent theater seating. At this time, the Huber is looking for volunteers this summer to install the flooring and then the seats. If you would be available to donate a few hours, contact the office with your name and number. Work sessions will be scheduled around availability of volunteer schedules and announced on Facebook. These improvements have been possible through the generosity of donors, balcony seat sales, and the continued support of volunteers.

Currently, we have about half of the seats in the balcony sold with this fundraiser continuing until all seats are purchased. These funds will support the completion of the balcony and the next stages of improvements at the Huber. If you are interested in purchasing a balcony seat, contact the office for more information.

team is truly remarkable. Patients have reported feeling better just hours after the procedure."

Following her procedure, Johnston says she is doing well. "If somebody has atrial fibrillation that's as bad or worse than mine, I would highly recommend it," she states. "It's a wonderful way to treat people."

**GMO VERSUS NON-GMO CROPS**

Ohio is one of the leading states planting Non-GMO crops. GMO stands for genetically modified organisms. About 92% of the US corn and 94% of soybeans in 2018 were genetically modified for weeds, insects, or drought tolerance. Japan and many European countries are demanding crops that are Non-GMO, so farmers can pick up premiums by growing these crops. Premiums vary by company, crop variety, and purity but premiums may be around \$0.25 per bushel and \$1-\$2 per bushel on soybeans.

In a GMO crop, scientist identify a gene in an organism, then copy and insert that gene into a crop like corn, soybeans, potatoes, etc. GMO crops are typically resistant to herbicides like glyphosate (Roundup with CP4 gene) or Glufosinate (Lib-

Scott Denamen recently responded to a call about a wild turkey being taken during the closed season in Geauga County. The season had opened in Ohio's south zone, but not the northeast zone. The caller stated that while driving past a residence, he had seen a man carrying a firearm and a dead turkey. Officer Denamen arrived at the home and contacted the suspect. The suspect stated that he had seen the turkey in the backyard and was able to get a shot. Officer Denamen explained that the season had opened the previous day in the south zone, but not the northeast zone. The suspect admitted he did not confirm the season was open. He retrieved the already processed bird and it was taken as evidence. One citation was issued for taking a wild turkey in the closed season.

In the early spring of 2021, State Wildlife Officer Jesse Janosik, assigned to Columbiana County, received multiple complaints and observed large amounts of litter at Highlandtown Lake Wildlife Area. During a Friday night into Saturday, Officer Janosik witnessed multiple water bottles, beer cans and other items thrown and littered onto the Highlandtown Lake Wildlife Area and onto the shore of the lake. Officer Janosik issued six litter summonses to six different individuals to appear in Columbiana County Municipal Court. More than \$2,600 in fines and court costs were assessed to the six individuals for littering on the wildlife area.

**Southeast Ohio - Wildlife District Four**

In January, State Wildlife Officer Mark Basinger, assigned to Athens County, received a call about a bobcat that was struck and killed by a motor vehicle. Several calls were taken that day about the same bobcat. Officer Basinger was on the scene within 90 minutes of the reported incident, but after a thorough search of the area did not find it. There is no legal bobcat season in Ohio, so they may not be picked up or kept in possession. Sightings of bobcats as well as black bears, bald eagle nests, and other specific species can be reported at wildohio.gov. Please contact 1-800-POACHER (1-800-762-2437) to report wildlife violations.

During January and February 2021, State Wildlife Officer Anthony Lemle, assigned to Guernsey County, conducted 12 investigations for

deer that were killed illegally in the county. This resulted in 20 citations being issued and the collection of \$4,394 in fines and court costs. In addition, multiple deer parts were forfeited, and five years of hunting privileges were lost. Call 1-800-POACHER (1-800-762-2437) to report wildlife violations.

**Southwest Ohio - Wildlife District Five**

In April 2021, officers with the Ohio Department of Natural Resources attended an event held by Police Unity Tour Team Ohio. The event featured a roll call for fallen officers in 2019 and 2020, parachuters, bag pipes, helicopters, plenty of food, and vendors. The Police Unity Tours' main goal is to raise money for the preservation, maintenance, and to maintain the legacy of our Fallen Blue Heroes who have made the ultimate sacrifice to protect our communities. Wildlife Officers Ryan Schock, Jason Keller, and K-9 Scout brought an ATV for the kids to sit on. Natural Resource Officers Matt Kruse and Jason Gantt brought their large patrol vessel from the Ohio River that the attendees could tour. The event was well attended, with more than 1,000 people coming through the gates. Thank you to all the officers that serve no matter what patch is on their shoulder.

During the 2020 white-tailed deer gun hunting season, Warren County Wildlife Officer Jason Keller was on patrol when he noticed a hunter coming out of the woods. This person was new to deer hunting and had not killed a deer before. After Officer Keller asked to see the hunter's permit, he realized that it was inside his friend's truck, who was still in the woods and had the keys. Officer Keller told the individual he could look it up on the computer in his vehicle. While Officer Keller looked up the permit, he noticed this person had checked in a buck during the 2019 deer season. Further investigation revealed the buck was harvested by the second hunter and checked under the first hunter's name. The second hunter eventually came out of the woods and admitted to killing three bucks during the 2019 season. The second hunter was issued three summonses and pleaded guilty to all counts in the Warren County Municipal Court. Additionally, the defendant paid \$875 in fines and court cost.

**LATTA CALLS ON USPS TO PERMANENTLY RETURN MAIL PROCESSING ACTIVITIES TO TOLEDO**

Congressman Bob Latta (R-OH5) penned a letter to the United States Postal Service (USPS) Postmaster General and Chief Executive Officer Louis DeJoy requesting to permanently transfer the mail processing activities for Northwest Ohio's mail from the Michigan Metroplex back to the Toledo Processing and Distribution Center (P&DC). The local postal carriers and the people who work to deliver the mail do a great job, but unfortunately, for years, the USPS Michigan Metroplex Facility has failed to reliably deliver mail, including bills and absentee ballots, to residents of Ohio's Fifth Congressional District.

To improve operations so that residents in Northwest Ohio receive their mail on time, Congressman Latta requests an expansion of operations at the Toledo, OH, P&DC to allow for the permanent return of mail processing responsibilities for Northwest Ohio, instead of the USPS continuing to utilize the Michigan Metroplex Facility in Pontiac, Michigan for these duties.

"Over a decade ago, the USPS began to implement policies that resulted in the closure and consolidation of mail processing facilities in Ohio," Latta's letter explains. "One result of this new strategy was the consolidation and transfer of mail processing operations from the Toledo P&DC to the Michigan Metroplex facility. Since this decision was implemented, residents, businesses, churches, courts, and Boards of Elections in Northwest Ohio have experienced countless delays in mail delivery, lost or discarded mail pieces, and other failures.... Many of these problems, if not all, can

be traced back to failures occurring at the Michigan Metroplex."

"To fix the situation, I explored the USPS time and time again to improve services in Michigan by any means necessary," the letter continues. "I was assured for years that the USPS took my concerns seriously and that the problems would be addressed through the hiring of more mail processors, the implementation of better standards and processes, and other so-called remedial actions. Unfortunately, none of these actions have proven to fix the problems with timely mail delivery in Ohio and I have lost all faith in the Metroplex's ability to effectively process my constituents' mail."

"In fact, after receiving feedback from my constituents, it seems that the only action that did improve the mail processing and delivery of Northwest Ohio's mail was when the decision was made to temporarily transfer processing duties to facilities in Ohio ahead of the 2020 Presidential Election," the letter concludes. "Given this feedback, along with the closer proximity of the Toledo P&DC to my constituents and the undeniable local benefits it would have for my constituents and businesses, I call on the USPS to develop and implement a new plan, within sixty days, to permanently transfer the mail processing activities for Northwest Ohio's mail from the Michigan Metroplex back to the Toledo P&DC."

erty Link, PAT gene). GMO corn insecticides resistance is obtained by using up to seven genes from the Bacterium thuringiensis that produces proteins that are toxic to certain insect pests like corn root-worm, corn stalk borer, corn earworms, fall army worm and several other insect pests. Common selling points of GMO corn is that it has less weed and insect pests. Cons are that it contributes to weed resistance if those herbicides are over used and people eating those crops may have allergy concerns and possible future antibiotic resistance (not proven yet).

I am definitely neutral on the science about GMO versus Non-GMO technology. As a Type I diabetic, I take Humulin insulin created from human cells inserted into bacte-

ria which I use on a daily basis to survive. Diabetics can use beef and cattle insulin but I prefer human insulin (even if it comes from a bacteria)! GMO crops are also being modified in Africa to have higher nutritional value like 6X higher Vitamin C, 2X higher foliate, and 169X beta-carotene. On the other hand, GMO crop seed is expensive to plant and with weed resistance, allergies, and possible antibiotic resistance; there just may not be a right or wrong answer.

Many large conventional farmers find it easier to plant GMO crops. It helps with many weeds and insect problems and makes management generally easier. However, many farmers are raising Non-GMO crops, especially if they have glyphosate resistance weeds and if they are striving to get higher premiums. Soil health and organic farmers

also like non-GMO crops because they want to work with nature to control pests naturally. Here are general guidelines for raising Non-GMO crops.

A key component is to avoid contaminated seed or pollen from GMO crops planted nearby. Most Non-GMO farmers plant earlier maturing corn and soybeans to try to avoid pollen contamination. Also, some farmers may plant both GMO and Non-GMO crops. In this case, always plant your Non-GMO crops first and select early maturing varieties. That way you minimize planter, sprayer, and harvester clean out, you should have less pollen contamination, and since the Non-GMO crops should mature faster, they are the first crops harvested. If spraying, remember the same rule applies, spray all Non-GMO fields first then GMO fields second, because all equipment (planters, grain tenders, sprayers, trucks, grain carts, harvesters) have to be cleaned out to avoid contamination. Farmers now have many mobile phone applications that can really help track seed, planting dates and rates, chemical sprays used, and harvesting. Depending on the company and where the crop will be exported, usually the highest premiums go to the highest purity seed along with certain crop varieties.

Planting Non-GMO crops requires managing several other considerations. Watch the prevailing wind direction to avoid pollen contamination from nearby fields. Smaller fields are easier to contaminate than larger fields, so border rows may need to be larger. Farmers are often advised to plant and harvest the outside

Non-GMO crop rows first and then sell that harvested seed as GMO seed. Most contamination occurs on the outside rows and this process helps clean out equipment. Soybeans are easier to contaminate than corn, because soybeans have less grain volume compared to corn. Some companies are using a genetic corn pollen blocker (Gat gene) which only allows pollen to be accepted from the host plant. Other issues include eliminating volunteer plants, minimizing planter errors, and issues caused by flooding (GMO seed sprouting) or drought (which may slow down pollination from the host Non-GMO crop). Dr. Peter Thomison, OSU retired corn extension specialist has a great fact sheet "Managing Corn Pollen Drift to avoid contamination of Non-GMO corn. Spring is a busy time for all farmers trying to get crops planted. Be Safe!

Judge also mentioned that he just signed an MOU with Mentors for Williams County Mentoring Program and also that Paulding County is now a pilot county for MRSS. MRSS, Mobile Response & Stabilization Services, this specialized approach allows our team to go into the home and quickly assess, understand and determine needs and develop care plans for youth along with their families. Judge Wehrkamp stated that MRSS program has been a huge game changer for our kids. Judge also stated that he has been working with the OhioRISE Advisory Council to draft rules, including eligibility, care coordination, MRSS, IHBT and respite to be an eligible Medicaid expense. Ms. Lou Ann Wanemacher stated that her office will be sending out the 2nd half tax bills soon and she thanked Judge Wehrkamp for everything he and his workers/volunteers are doing to help our county's children with services for support and mental health. Mr. Holtsberry added that he was contacted by Linda Nieman with the Toledo State Hospital Cemetery Reclamation Project. Mr. Holtsberry stated that this group's mission is to preserve the cemeteries and develop them into a place of remembrance and reflection for people who have experienced mental illness, disability, or addiction and

their family members. Mr. Holtsberry stated that this group found 30 Paulding County residents' graves along with the grave of Private Leonard Scott Peppers, Company A, 148th Infantry, Ohio Army National Guard. Private Peppers was from Antwerp, OH, he served shortly for our county and spent the rest of his life at Toledo State Hospital and his mental issues were never resolved. Mr. Holtsberry stated that this group will be honoring him with a proper grave marker instead of a stone with a number this Saturday, May 15th at Toledo State Hospital New Cemetery. Ms. Claudia Fickel stated that her office has started training on the new software system and she is hoping to go live with the system late this summer.

The next scheduled Elected Officials Luncheon is Wednesday, July 14, 2021 at noon.
