AVAILABLE

The Ohio Development Services Agency and Northwestern Ohio Community Action Commission want to remind Ohioans that assistance is available to help with their home energy bills. The Home Energy Assistance Program (HEAP) helps Ohioans at or below 175 percent of the federal poverty guidelines pay their heating bills. And Ohioans who are threatened with disconnection, or have been disconnected from their utility service, may also be eligible for the HEAP Winter Crisis Program, which started on November 1, 2020.

Ohioans can visit energyhelp.ohio.gov to apply online, download a copy of the application, or find contact information for a local Energy Assistance Provider. Individuals will need to have copies of the following documents to include with their application:

- Most recent utility bills
- · A list of all household members (including birth dates and Social Security numbers)
- Proof of income for the past 30 days for all household members (12 months for certain income types)
- Proof of U.S. citizenship or legal residency for all household members
- Proof of disability (if applicable)

HEAP benefits are applied to an individual's energy bill after January 1st. If you need immediate assistance with your energy bills, please contact your local Energy Assistance Provider. A list of providers can be found at energyhelp.

Applications for the HEAP Winter Crisis program must be received by March 31, 2021. The last day to apply for the regular HEAP benefit is May 31, 2021. For more information on the programs, visit energyhelp. ohio.gov or to schedule an ap-



of 98, earning him the distinction of being Paulding County's oldest veteran, let's look at his life's story. Henry was born October 27, 1900, in Antwerp, Ohio. The son of Oscar Eugene and Barbara Manilla (Boyd) Reed, those who knew her best called her, may. Oscar was born, April 12, 1868, in Ohio. Barbara was born November 8, 1873, in Jackson Township, Seneca County, Ohio. This couple was married on August 2, 1891 in Sandusky, Ohio. After the birth of Henry, the couple and child, moved to Paulding, living on Harrison Street. Oscar was a farmer and Barbara a housewife. Not sure what happened with their marriage, Barbara and Oscar divorced. September 23, 1908, Oscar remarries a woman, Julia A. Matzen in Allen County, Indiana. Julia was born, April 12, 1887, Harrison Township, Paulding County. Oscar changed vocations, becoming a Teamster, Julia became a laundress.

Henry had signed up in Hicksville, Ohio, to serve in the Ohio National Guard, July 14, 1917, not knowing his training and abilities would be needed in the upcoming months. August 1917, he registered for the draft. He was a farmer, 5-10" tall, brown hair, brown eyes, fair complexion, excellent character. He was serving with Company E. Ohio National Guard Infantry when called to service. He was



Henry Jackson Donnell sent to serve with Company F. 145Th Infantry, as a private up to the date, November 20, 1917, then was sent to headquarters of the 145th Infantry until he was discharged. He served in Muese-Argonne, Ypres-Lys defensive sector. American

Expeditionary Forces, June 15, 1918 to March 27, 1919. Honorable discharge May 1,

Returning home, he became a baker, working in a bakery, but he still stayed in the Ohio National Guard. Where he rose from a private, to sergeant, to 1st sergeant, October 23, 1924 to July 25, 1926. Then promoted to 2nd lieutenant July 26,

Then he found a girl, Devota Maria Johnson. Born December 5, 1902 the daughter of Andy and Pearl (Sebert) Johnson. Henry and Devota, were married December 4, 1926 in Paulding, Ohio. They moved to Railroad Street in Antwerp, Ohio. Henry was a plasterer and Devota was a homemaker. June 6, 1927, a son was born to Henry and Devota, Henry Kenneth Donnell.

A man named Samuel A. Sargent owned the second steam boat to traverse the Maumee River from Maumee Rapids on West, this was around 1836. This ship was built in

Brunnersburg and was christened The Anthony Wayne. It could carry 18 tons of freight and a number of passengers. It was not a powerful boat. It had one paddle wheel on the stern, but it could travel even when the water was pretty low as it was a flat bottom boat. It made quite a few runs from Defiance into Fort Wayne in the years of 1836-37.

I guess about this time a barge fixed up for passengers ran from Defiance to Fort Wayne and I think it was a three day round trip.

Well, this steamboat, The Anthony Wayne, had a couple good years and in 1837-1838 it tied up at Rochester for the

In the spring of 1838 the high river and ice broke the boat loose and it drifted on down stream.

It went over the rapids at Maumee City. It was caught and had not too much damage and was renamed The Davy Crockett and made many runs between Maumee City and Toledo. From what I read, I think that area was pretty well populated and sort of bustling and busy for weeks. I know that the soil there is very good for farming and truck gardening.

This man, Sargent, who owned the steam boat also owned a stage line that operated daily between Maumee City and Toledo. I don't know

if he owned the stages from Defiance to Fort Wayne or





of aborted fetal remains. In February 2020, the remains discovered on Klopfer's property and in his car were buried in a dignified ceremony in South Bend, Ind.

The Dignity for Aborted Children Act would:

Require abortion providers to dispose of aborted fetal remains just as they would any other human remains. Failure to do so would be punishable by a fine and up to five years in prison.

Require a consent form so the mother can choose between retaining possession of her unborn child or allowing the provider to cremate or inter the remains. Failure of the provider to execute these forms would be punishable by a civil penalty.

Require abortion providers to report to the U.S. Department of Health and Human Services (HHS) the transfer of remains for cremation or interment. Contractors providing these services would be required to report how they provided for proper disposition.

Direct HHS to annually review these reports to verify all abortion providers are ensuring the dignified disposition of aborted children.

ty LEPC Local (Emergency Planning Committee) meeting took place over zoom. The meeting was chaired by Paulding County Emergency Management Director Ed Bohn. The meeting revealed that people were getting their COVID shots in the county. 65% of Nursing home residents have now received their shots. 60-65% of the staff at the facilities, along with the hospital staff, have received theirs or have antibodies from previously having it. Dave Foltz said some EMTs are receiving the vaccine and some aren't. Ed said less than 20% in the county received it. Some in the meeting were concerned about the low number of EMS staff receiving the vaccine but it was explained by Paulding County Hospital CEO Ron Goedde, that those who were concerned with certain issues such as pregnancy may very well want to avoid the shot as the testing has not taken place on how it might effect the mother and child.

Mark Holtsberry brought up about trains blocking tracks in south and central Paulding County being excessively long and many times stopping for extended periods of time. Sheriff Landers replied that the issue was a concern for many people in the county, and said his Deputies have been contacted about the train issues. They call to Atlanta where rail headquarters are, but they don't seem to get much response. If the County Commissioners would make rules about such things, then citations could be issued and then probably to court for fines. Jason has said it's frustrating because people get upset and he feels

like he can't do much. Protection Personal Equipment PPE is still coming, according to Bill Edwards, Paulding County Health Department. The PPÉ is then taken to Ed Bohn, who manages the stockpile at the OSU Extension building. The only thing lacking in the county is the vaccine. Another shipment of N95 masks are coming in next week.

It was stated that Paulding County Hospital has been very busy with vaccine clinics and they don't have enough shots to administer as many as people would prefer. Currently they are doing shots on Wednesdays and Fridays.



K-12 STAFF VACCINA-**TIONS**

Every public school district in the state - except for one - has agreed to resume in-person schooling by March 1 which was a requirement for staff to have early access to the vaccine.

K-12 schools whose staff can be vaccinated the week of February 1, 2021, have been notified. All other schools will be contacted tomorrow with information on when their K-12 staff will be permitted to receive a vaccine.

More details on Ohio's K-12 vaccination process will also be released on Friday. The plan ensures that the maximum number of people can be vaccinated in the shortest amount of time. The plan also makes the process as simple as possible for staff to be vaccinated and is organized to allow most K-12 staff in a county to be vaccinated within seven days of their assigned vaccination start date.

PANDEMIC IMPACTS **ON K-12 STUDENTS**

Ohio has prioritized getting K-12 students back in schools by March 1 because many adolescents' social-emotional and mental well-being has been impacted by the pandemic.

"We know some of our

students have not been in the classroom in months - it's taking its toll," said Governor DeWine. "For some, remote learning works, for others, it doesn't. We are in danger of too many kids struggling for too long if they don't get back to school in person."

"School is community for our youth," said Ohio Department of Mental Health and Addiction Services Director Lori Criss. "It benefits kids so much more than academic content. It's the social and emotional connections that kids feel with friends, classmates, extra-curriculars, teachers, and more." According to the Ohio De-

partment of Mental Health and Addiction Services, the change of routine and the constant uncertainty of the pandemic produces anxiety, and the disconnection from learning, emotional, and social supports can lead to depression. In addition, missed significant life events like graduations, proms, art performances, science competitions, sports, and more can result in grief.

- reason to live; • using drugs, alcohol or

The Van Wert County Foundation administers the 2021 grant support provided by The Associated Charities Fund, The Flickinger Memorial Trust, and The James A. & Minnie C. Kesler Memorial Fund.

The Humane Society is building a new 3,000 squarefoot shelter at 480 Fox Road, Van Wert. The shelter will

have modern HVAC and ventilation systems, sealed concrete floors, dog kennels with indoor/outdoor access, open roam areas for cats and separate medical isolation areas for dogs and cats. These are lacking at its current location at 309 Bonnewitz Ave., Van

dog pound, where dogs were housed for three days then euthanized if not reclaimed by the owner. It is not functional to house animals for lengthier stays. The space is limited; dogs and cats kennel in the same large area with no access to fresh air and the outdoors. The new shelter will provide a safe haven for stray, homeless, neglected, and abused companion animals in our community.
