### **PAULDING COUNTY MAYOR ASSOCIATION HOLDS FIRST** QUARTER MEETING

The Paulding County Mayors Association reconvened at the county economic development office with the first quarter meeting of 2022. Ten of the eleven county villages were represented to vote in the only order of business for the year. The group again elected Mayor Greg White to represent them on the Paulding County Economic Development Board for the year.

On hand to present to the group was county Commissioner Roy Klopfenstein. The commissioner introduced discussion to the group about the state opioid settlement. There is a county process that will need to be set up in the near future for fund disbursement. Klopfenstein then shared of his run for the 82nd District seat in the Ohio House of Representatives. Also sharing information with the group about their ongoing election campaigns Judge Michael were Wehrkamp and Paulding County Area Foundation Director Lisa McClure, who is running for a commissioner seat.

Commissioner Mike Weible introduced himself to the group and shared of rebroadband cent success around the county, with township partnerships using ARPA funds. Weible also invited the villages to indicate



### **TIPS FOR REDUCING** FERTILIZER COSTS

Farmers are re-evaluating their fertilizer application due to high fertilizer prices. Farmers who regularly applied fertilizer may not need as much or any additional fertilizer if their soil tests are optimal; especially for lime, phosphorus (P), and potassium (K). Most agricultural clay-based soils have around a ton of P and perhaps 40 tons of soil K. Applying high priced fertilizer when it may not be needed is not a good investment.

Soil testing is a good investment for both rented and owned cropland. Soil tests are accurate for 3 years, but knowing what fields need fertilizer is the most important. Fields that are nutrient low should be prioritized over high or optimal fields, especially if fertilizer dollars are limited. Without recent soil tests, farmers are just guessing their crop's nutrient needs. Soil samples are usually taken in the fall or early spring. Soil tests are often taken at the same time of year and then compared over several years to see soil fertility trends. Weather, crop rotation, and the soil environment may change your soil fertility and nutrient availability.

Start by looking at field's

Yes, pork products played an important role in our area and it must have seemed like a logical name to the first organizers of my neighborhood. I have never heard any present-day neighbors or local officials voice any concerns over the name "Pig Lard."

I understand that lard may have an image problem among some today in Ameri-

soil pH which should be between 6.0 -6.8 for most field crops. If the soil pH is in the right range, then most other soil nutrients should be available at optimal levels. A low or high soil pH generally ties up critical soil nutrients. Next look at soil P and K levels. Most current soil tests are now using Melich-3 instead of Bray P1. Mehlich-3 P returns approximately 35% higher soil test phosphorous (STP) values than Bray P1 and approximately 14% higher soil test potassium (STK) values.

New crop removal rates for corn are now estimated to be .74# of N, .35# P2O5, and .2# K2O for each bushel harvested. These removal rates are based on P2O5 and K2O and NOT actual fertilizer rates. For example, for potassium chloride (0-0-60), it takes 100# of 0-0-60 to equal 60# K2O. For soybeans, .79# P2O5, and 1.14# K2O are removed for each soybean bushel harvested. For wheat, estimates are .96# of N, .49# P2O5, and .24# K2O for each wheat bushel harvested. These numbers are based on recently updated Tri-State Fertilizer guidelines.

The optimal range for P is around 20-40# P2O5 based on Mehlich-3 which is very close to the old standard of 30-60# P2O5 Bray P1. For

loamy and clay soils, the optimal range for K2O is 120-170 while for sandy soils the range is 100-130.

When fertilizer prices are high, fields that are in the optimal range have enough nutrients for at least one or several years to grow crops without any nutrient deficiency signs. When fertilizer prices come down, farmers can start applying fertilizer again to keep yields and fertility levels up. In general, soils with good soil health can maintain and even raise crop fertility levels. Beneficial soil fungi (mycorrhizae) supply the plant with 6X more P than roots can alone. Good soil structure and maintaining high soil organic matter (SOM) levels create good soil fertility.

When fertilizer soil tests are less than optimum, start by correcting your pH with lime first then address P and K fertilizer needs. Soil pH along with SOM determines when most nutrients are optimally plant available. Soil P levels remain steady longer

than soil K, especially if forages are harvested. In high fertilizer cost years, avoid trying to "build up" or over applying fertilizer, because it does not pay. Just use up fertilizer in your "soil bank".

For phosphorus (P) fertilizer, avoid broadcasting by applying P starter fertilizer in a band to increase P fertilizer efficiency. Potassium (K) fertilizer can be broadcast because it moves into the soil easier than P. For nitrogen, consider lowering your application rates. Based on the cost of N fertilizer (\$.90 per # of N) and the price of corn (\$5.85/ bushel), lowering your N fertilizer rate 15-20# per acre may only cost you 1 bushel of corn, so it's more economical to cut back N rates slightly. Always follow the 4 R's when applying fertilizer. Apply the right rate, use the right source, apply it at the right time, and in the right place.

### **MILITARY HISTORY IN PAULDING COUNTY**



# **By: Mark Holtsberry** Alfred Henry Paul Blan-Mary was born in Ohio, the

medium weight and height, Private First Class, served in Europe with Company G. 166th Infantry, also known as Company G. 6th Ohio National Guard. Alfred had moved to Chicago, Illinois, working at the Chicago Plating Company at 509 Wabash Street.

On June 3, 1918, Alfred registered for the draft. He was listed as blue eyes, light brown hair, medium build and medium height. Alfred came back to Paulding and on September 5, 1918, signed up with the National Army out of Paulding. He basically, at this point, volunteered to serve. Alfred was sent for training at Camp Sherman, which is in Ross County, Ohio. He was serving with 32nd Company, 8th Battalion, 158th Depot Brigade.

The early part of October, Alfred caught broncho pneumonia. On October 7, 1918, a day shy of his 22nd birthday, Alfred passed away. His father was notified of his death. Alfred was brought home to be buried in St. Marys Cemetery, Junction, Ohio in row 4, Grave 4. Alfred's brother Leo, survived the war, and was honorably discharged, May 17, 1919.

Alfred's father, Philiase, passed away in 1929, from heart failure, due to catching pneumonia. His wife Mary, passed away in 1931, from health issues she had been dealing with for years. They too, were buried in St. Marys Cemetery.

### WOODBURN CITY COUNCIL **MEETING MINUTES 3/7/22**

Minutes for the Woodburn City Coun-

cil Meeting on March 7th, 2022: The meeting began at 7:00pm with the Pledge of Allegiance. In attendance was Mayor Kelsey, Clerk-Treasurer Cummins, Superintendent Walls, Officer Cowan as well as Councilmen Voirol, Watts, Gerig, and Martin. Chief Parker and Councilman Thompson were not present. Kaleb Dienelt with Reliance was also present. Chief's Report: Officer Cowan was

present to answer any questions on behalf of the police department.

Superintendent's Report: The superin-tendent reported that almost immediately after the last Common Council meeting, 60 water meters that were ordered previously had arrived for future use and the city should not be short on meters any time

Mayor's Report: API will begin work on the Stellar Streetscape project this week. The Indiana governor has rescinded the public health emergency for the state as of March 3rd. The mayor discussed the updated state-wide policy for remote meet-ings that was passed last year. The mayor reached out to the Allen County Depart-ment of Planning Services regarding the potential of a housing TIF district for each of the two new home developments that are in process. Landis and Sons Tree Service took down approximately 18 trees that were to be removed for various projects forthcoming this year. New trees will be planted in the near future. Clerk-Treasurer's Report: The meeting


minutes were presented from the February 21st meeting. After discussion, Councilman Watts moved to accept the minutes from the February 21st meeting as presented, second by Councilman Gerig, all present in favor. The warrants were presented. After discussion, Councilman Voirol moved to pay the warrants as presented, second by Councilman Watts, all present in favor. The clerk-treasurer was asked by a resident if she could be on a payment plan in order to resolve her outstand ing balance. She proposed paying \$100 each Monday, starting Monday March 14th, and continuing until paid in full. This would result in payment in full within about 6 weeks. After discussion, Council-man Gerig moved as proposed without adding late fees to the account, second by Councilman Watts, all present in favor. The Allen County Multi-Hazard Mitigation Plan is in need of being updated by the end of the year and the Allen County Office of Homeland Security has asked the city of Woodburn to produce a representative to assist in updating this plan. After discussion, it was determined that Mayor Kelsey will tentatively take this responsibility on and may later pass this along to an officer if that becomes appropriate to do so.

Councilmen's Report: Councilman Martin asked about how the construction on Main Street would impact the post office as well as other local businesses in the area. The Mayor explained that API should be aware of the needs of the local businesses but he will reach out to impacted busi-nesses to make sure that concerns are addressed appropriately. Audience: A resident went over details

for a proposed community food pantry and wanted to know what the city council thought about the idea. After discussion, it was determined that the city would not be opposed to this idea and offered suggestions for community contacts that may help get this project started. Councilman Voirol moved to adjourn

daughter of Peter and Theresa Sieren. Peter, was a Civil War Veteran, who served with Company E. 192nd Ohio Volunteer Infantry.

Philiase and Mary, were married June 5, 1876 in Defiance, Ohio. They settled in Auglaize Township and by 1900, the Blanchard's were raising three daughters and three sons, Alfred being the youngest, and they all worked on the family farm. By 1910, the family was still living on the farm, with the children all in school. As war was looming in Europe, Alfred's brother, Leo Charles, had signed up July 28, 1917 to serve in the National Army out of Defiance. Leo, 5-6" tall, gray eyes, brown hair, fair complexion,

### **COLLABORATION MOVES PAULDING COUNTY BROADBAND FORWARD**

A collaboration between Carryall Township trustees, and the Paulding County Commissioners, has started a process of bringing additional fiber broadband to the county. The commissioners awarded a bid that will provide Carryall Township with an additional 28.2 miles of fiber optic cable in the ground, passing 213 homes. This \$634,568 project is located west of Highway 49 and north of the Maumee River.

The only bid submitted was by local internet service provider Sherwood Mutual Telephone Association (SMTA). The bid is the first of many for providing additional cable in the county. Having an additional option of good reliable internet anywhere in the county is a positive for future residential and business growth and offers an attractive incentive opportunity.

Having been provided American Rescue Plan Act (ARPA) funds, the Carryall Township trustees were looking to do something that would use these funds to benefit as many residents in the township as possible. Discussions in how the trustees could make the dollars go even further began and a col-



Current Vantage Adult Education LPN students are assessing "Susie," a high fidelity medical simulation mannequin, who is the patient. Students try to figure out what nursing care "Susie" needs to improve her medical needs. Students fill the role of the nurse, doctor, aide, and pharmacist. The Vantage LPN-RN Transition program will begin in the fall of 2022.

Vantage Career Center Adult Education is currently enrolling students in the new LPN-RN Transition Program, created through a grant provided by the Van Wert County Foundation. This part-time program is scheduled to begin in the fall of 2022. All graduates of the program will receive a diploma of completion and are eligible to take the National Council Licensure Examination (NCLEX) for Registered Nurses to become a Registered Nurse (RN).

"We are excited to offer a program which will allow students to continue working full time, be involved in family activities, and obtain their RN by offering a consistent schedule throughout the program," says Adult Education Director, Angie Fahy. "Students should see a quick return on investment once they complete and obtain a job working as an RN." Nursing diploma programs are the most estab-

lished and traditional nursing education types. A common misconception is that the nursing diploma program is somehow subordinate to an associate degree, but students are adequately prepared to take the NCLEX licensure exam and ready to hit the ground running in a variety of patient care settings as a working and skillful RN.

A quick comparison of the diploma programs compared to degree programs may offer even further clarification about Career Tech Education: Those wishing to become registered nurses may choose to pursue a Diploma Program or a Degree Program. Both programs must be approved by the Ohio Board of Nursing to operate. Requirements for instructors for both programs are the same, and established under the Ohio Revised Code. Both programs must be offered through accredited schools to be eligible for financial aid and to be approved by the Board of Nursing. Both programs require passage of the NCLEX – RN examination for licensure as an RN. Diploma Programs often offer the completion of the licensure in a shorter timeframe because of the academics being embedded in the curriculum. Diploma programs are traditionally offered with a schedule that allows for a balance of work, school and family life. The schedule remains consistent throughout the program with the same group of students, which eliminates class

cancellations and schedule Traditionally, changes. diploma programs are less expensive because many of the extra costs such as; technology costs, books, uniforms, etc. are included in

the tuition. The Vantage LPN-RN Transition Program provides a clear pathway for area LPN's to obtain their RN. The program was specifically designed to create work-life-school balance. There are no prerequisite courses required. "The Van-tage LPN-RN Transition Program provides a carefully designed pathway for LPN's to receive credit for previous training and work experience, and expedites the pathway to becoming an RN," says Program Coordinator Jean Sullivan.

All LPN's that meet Vantage admission requirements are eligible for a seat in the program. Classes will be held one evening per week and one clinical day a week. Experienced instructors will work closely with students to assist them to meet their goals. Students will complete 840 face to

face clock hours with expert instructors and preceptors over an 18 month period. Clinical experiences will take place at local hospitals, community health care agencies, schools, and rehab/ long-term care facilities. Course and clinical work includes advanced medicalsurgical nursing, maternity and pediatric nursing, psychiatric nursing, and professional nursing concepts. The program has been approved by the Ohio Board of Nursing, the Ohio Department of Higher Education, and is accredited by The Council on Occupational Education. Students accepted into the program who also reside in Van Wert County are eligible for the Van Wert County Foundation Adult Career Tech Scholarship. Graduates of Vantage LPN-RN Transition program will be able to continue on their educational path and obtain their Bachelor's degree (BSN). if so desired, at an accredited college or university of their choice.

More than 29% of eligible District 4 members voted in

Board election results were announced, with each board member elected to serve a three-year term:

• Incumbent William Dowler of Paulding was reelected to District 2 (represents Van Wert County in Ohio). No candidates submitted petitions to run against



Dowler, so he was re-elected by affirmation.

• New trustee William 'Bill' Beckman was elected to District 4 (represents Emerald, Jackson, Blue Creek, and Paulding Townships in Paulding County, Ohio; Delaware township in Defiance County, Ohio). District 4 had an open seat with three candidates running for election after Jay Dangler's decision not to run for re-election. Candidates Scott Strahley and Fred Pieper (both from Paulding) also ran.

• Incumbent Steven McMichael was re-elected to District 5 (represents Maumee, Adams, Jefferson, and Jackson Townships in Allen County, Indiana). No candidates submitted petitions to run against McMichael, so he was reelected by affirmation.

Board Chairman Dr. John Saxton, Secretary-Treasurer Dr. Ron Black, and President and CEO George Carter reflected on 2021's challenges and successes, highlighting the "huge struggle" PPEC endured last year.

"Not only have we had to battle through the pandemic as you all have, but we also dealt with material shortages and price increases like we have never seen. In some cases, price was irrelevant because the material was unavailable," said PPEC President and CEO George Carter. "This may last well into next year and will continue to put pressure on our service cost."

Carter also reported that the cost of purchased power from Buckeye Power (PPEC's electricity supplier) increased dramatically this year, two factors for which include the price of fuel and the transmission cost. To put the fuel cost into perspective, Carter reported that for the year 2007, the total cost of fuel averaged \$471,000 per month. Meanwhile, in January (one month) of this year alone, the cost was \$1.1 million. The same is true for transmission costs, but higher. "Since 2015, transmission costs have increased \$3 million and are now 20% of our total Buckeye bill," Carter said. "Looking back to 2007, total transmission costs were just above \$1 million; in 2021, the total was just under \$6 million. That's a nearly six times increase! This trend is expected to continue and will undoubtedly put upward rate pressure on the cooperative." Other 2021 highlights reported on during the meeting included:

est-ever score in the comprehensive RESAP safety inspection, conducted by Ohio's Electric Cooperatives.

• Total margins were down from the prior year – a result of higher wholesale power costs from Buckeye Power but above budget at \$4.78 million

• The largest capital credits refund in co-op history: \$2.3 million was returned to members last December via capital credits - this is proof of each member's ownership in the co-op.

• Member growth increased in 2021, with sold kilowatt-hours increasing 5% over the prior year

• Three apprentice linemen graduated from the 4year, hands-on Central Ohio Lineworker Training (COLT) program in Mt. Gilead, Ohio, and will soon be journeyman linemen: Terry Minic, Garrett Gerdeman, and Jordan Mohler.

• Retiree Mary Arend was commended for her 26 years of service to the co-op as a member service representative.

• Members were asked to save the date for PPEC's Member Appreciation Family Fun Event on Saturday, July 23, 2022.

Board Secretary-Treasurer Dr. Ron Black reported that "the financial health of our cooperative is strong," with operating expenses under budget by \$326,000 (5%) and utility plant investments - including poles, wires, transformers, and other equipment - increasing by \$5.7 million in 2021. PPEC's auditing firm of Bashore, Reineck, Stoller, and Waterman issued an unqualified, or clean audit opinion.

Board Chairman Dr. John Saxton gave an overview of the board's concerns and priorities, including setting the company's tone, ensuring safety is top of mind, reviewing budgets and monitoring performance. Succession planning was reviewed to address board turnover.

"Currently, we have five board members with less than five years of experience on the board," said Dr. Saxton. "Additionally, this year, Trustee Jay Dangler chose not to seek reelection, so we welcomed a new board member in District 4. It takes several years to get a good understanding of the industry and what's required, which is why we require educational training through our National Association NRECA. We must maintain this active education, which is vital for a strong board."

Dr. Saxton also addressed



lective agreement was made with the county commissioners to match committed township dollars with county ARPA funds.

The realization is there aren't enough funds to cable the entire township at this time. SMTA aims to capitalize on their existing infrastructure, currently located on the northwest Defiance-Paulding County line. Starting south into this portion of Carryall Township will allow the opportunity to eventually grow the township even further east and south. SMTA identified the most populous part of the township to cover at this time. This allows SMTA the opportunity to have a quicker return on investment and allow even more future growth in a very short time.

A collaborative effort to bring reliable internet to NW Ohio started several years ago. A Comprehensive Economic Development Strategy (CEDS) committee had been meeting, including several area economic development directors and some commissioners representing the area. Despite the Federal Communication Commission (FCC) maps showing adequate coverage for this area, the lack of reliable broadband was identified by the group as a critical need in the area. Paulding County Economic Development Director Tim Copsey, and the late Commissioner Clint Vance, joined the committee just after the CEDS group won a grant and enlisted the BGSU Center for Regional Development (CRD). CRD was asked to provide a more in-depth study of regional broadband and requested each individual county to help by providing maps of existing fiber optic cable in the ground in their respective county. Vance and Copsey started immediately contacting the broadband suppliers in the county. Eight providers were identified, with still others sharing wireless options. Scheduled meetings began with each provider, and a map was developed showing all current fiber optic cable in the ground, located around the county. The map clearly identified the void areas. meetings began again and the project moved forward.With local mapped void areas identified, and evaluated with providers located in those areas, discussions were finalized between the township and commissioners to combine financial resources and develop a project attractive enough to receive bids. A bid template was developed, indicting the collaboration, and was shared with the other townships in the county with the hope of deriving additional projects.


### Reviewed by John Vining

The local dinner theater troupe Off Stage Productions is performing "Mama Won't Fly" for your viewing and dining pleasure this spring. I had a chance to view the dress rehearsal for this production last night.

The trio of Jessie Jones, Nicholas Hope, and Jamie Wooten are rapidly becoming the premier writers of dinner theater scripts for

small community productions. Off Stage Productions has presented several of their works in the past, each more zany than the previous one. It seems like Jones, Hope, and Wooten explore different aspects of dinner theater production with each of their plays. With "Mama Won't Fly," they utilize a "minimalist" approach to the stage setup - few stage props and little side-to-side or front-to-back movement of the players. At first blush, this might seem to be a bland concept for a stage production. However, in the context of a cross-country road trip taking place in a variety of vehicles, it works! story The revolves

around a trio of ladies preparing for the marriage of one of them on a beach in California – the bride-to-be

Kecia Pontius plays Savannah Honeycutt, a talkative Southerner and the flamboyant sister of the groom, who is in charge of getting her cantankerous mother Norleen Sprunt (Dolores Foreman) from the Deep South to California in four days. The main problem is, Mama won't fly! After a bit a verbal sparring, Mama agrees to allow the use of her ancient Buick for the impending cross-country drive. Enter Hayley Quinn (Courtney Wendel), the blushing bride-to-be, who sees the long drive as a perfect way to get to know her future in-laws better during the four-day trip. Thus begins a series of misadventures, as the illmatched trio unsteadily make their way across Texas, New Mexico, Nevada, and finally to the Southern California beach. On their way, they encounter a variety of eccentric locals who turn the trip into a madcap adventure reminiscent of the 1940s-

Crosby "Road" movies. "Mama Won't Fly" calls on a couple of Off Stage veterans (Pontius and Foreman) to step into lead roles, while newcomer Wendel provides the third foil to the other leads. All are up to the task, as the interplay between the three diverse characters provides almost constant amusement and occasional outright guffaws. Pontius and Foreman play their characters as suitably but lovingly gruff and contentious, as grown children and aging parents many times are. Meanwhile, Wendel plays her young bride-tobe as achingly anxious to do and say the right things, desperately wanting to get off on the right foot with her soon-to-be in-laws. A special note: Anyone who has played "car games" on long road trips will find this group's portrayal of them on this interminable drive very funny!

Another aspect of stage production explored by writers Jones-Hope-Wooten in "Mama Won't Fly" is that the supporting actors all play multiple characters in this cross-country romp. This presented quite a challenge for the wardrobe manager of this production, but Julie Lang pulled it off very well. Veteran Terri Stevens plays four separate characters during the course of the road trip, and as always played each solidly. Her interplay as "Tanya" with Foreman's "Mama" in an early scene is noteworthy, and their stand-

and is aided by several community-minded volunteers. Some of the bonds formed have been life-changing for the youth. "Providing a fun and interactive way to discuss life issues and skills that teens can take with them throughout life through the means of mentoring relationships is impactful in the teens' lives," said Gathany.

Wehrkamp was a guest at the final cooking class of the 10-week program. "As the children prepared and served the food, you could see on their faces just how impactful the program had been on them. Their faces told the story," Wehrkamp recalled. "And all the while, they're learning a valuable life skill."

Future classes are scheduled for 2022. Next month, the LIFT Program will return to fishing while incorporating outdoor cooking skills.

Youth participating in the LIFT Program are not required to participate in any faith activities, and a youth may request an alternative to the YFC programming if he or she wishes. "We respect the varying religious beliefs of the children who participate," said Gathany.

### **I-69 SUPERSTRUCTURE REPLACEMENT TO BEGIN IN ALLEN COUNTY**

The Indiana Department of Transportation announces the beginning of a superstructure replacement project on I-69. Work is going to take place on the bridges over Robinson Creek which is just north of Lower Huntington Road. This project will take place over several construction seasons, with the first phase of work scheduled to begin on or after March 26 with work expected to end for this year in November. There will be various traffic changes and speed restrictions in the area throughout the project.

Shoulder strengthening will take place first before other phases of the project. The right lane and shoulder of southbound I-69 will be closed from the morning of March 26 until the morning of April 1. Crews will then move to the northbound lanes which will have the right lane and right shoulder closed from the morning of April 2 until the morning of April 8. During these lane closures, significant backups are expected during peak travel hours and drivers might want to seek an alternate route. A width restriction of 15 feet will also be in place during this portion of the project.

Once the shoulder strengthening portion of the project is complete, traffic will be moved to the outside lanes and work on the median half of the superstructure will take place in both directions of Î-69. The project is scheduled for completion in June 2024. All work is weather-dependent and schedules are subject to change.
