I have run across a couple of lists of the apostles names in the Bible and there seems to be some discrepancy. Why?

I used to get tripped up on the same thing. Actually there are four lists: Matthew 10:2-4; Mark 3:16-18; Luke 6:14-16; and Acts 1:13. The following apostles ap-

pear the same in all four lists: Andrew, Philip, Thomas, Bartholomew, Matthew, and James (the son of Alphaeus). The following are different: Simon (who is called Peter) is just called Peter in Acts 1:13; James the son of Zebedee is just called James in Luke 6:14 and Acts 1:13; John the son of Zebedee is surnamed Boanerges in Mark 3:17 and just called John in Luke 6:14 and Acts 1:13; Simon the Canaanite is also called Simon Zelotes in Luke 6:15 and Acts 1:13; Lebbaeus is called Thaddaeus in Mark 3:18 and Judas the brother of James in Luke 6:16 and Acts 1:13. Judas Iscariot is mentioned in the first three lists but is missing from Acts 1:13 because he had since taken his own life.

It may be helpful for you to write down the additional names given to each person in a given list. It has helped me in future reference.

Other dogs we had were chihuahuas; one named Leroy and another one named Ralph. All of our dogs were our pets and part of our family.


One time we bought a wiener dog and named him Brownie. Brownie had the opportunity one time to make some other little

fun writing this column and researching names. Hmmm. If I ever get a puppy, I think I will name him West Bend, Bryce, Chrystal or Angel!



MILITARY HISTORY IN PAULDING COUNTY



Bess Grace Garvin was one of Paulding's World War 1 Army Nurse Corp nurses and was born May 30, 1887. The daughter of John Franklin and Sarah J. (Snyder) Boyer. John was born in 1849, Sarah was born in 1852 both were born in Ohio. The couple was married February 8, 1872. They moved to Benton Township in 1880. The Boyer family consisted of, at that time, three daughters. A son, Thomas was born in 1882, then Bess was born in

On December 4, 1888, a daughter, Lucinda, passed away and was buried in Lehman Cemetery. By 1890, the family was still living in Benton Township. A son, Orie Franklin, was born in February 1889. By 1900, the family moved to Payne, where John took a job working at the grain elevator. A sister, Lola Emily, became a school teacher at Payne.

By 1910, Bess was living in New York in Manhatten Ward 12 at 100 Street 7, 5th Avenue. She was working as a student nurse at Mt. Sinai Hospital in the nursing program, where she graduated. By 1916, Bess was serving with the American Red Cross on the border of Mexico, where she served in the Mexican-American border

In 1917, her brother, Thomas registered for the World War 1 draft. Bess served in the military as World War 1 broke out. She was on the roster as of April 12, 1917, but was not inducted to active duty until January 19, 1918. She was assigned to go overseas, February 6, 1918 to Camp Hospital #25 to March 24, 1918. Then moved to Hospital #30, April 11, 1918. She also served at base hospital #3 until March 5, 1919. After returning home, then finishing her service at Ellis Island,

a Demobilization Station in New York. she was honorably discharged, April 13, 1919. Military records list her as, "Reserve Nurse relieved from active duty, not discharged." Bess met a fellow named Roger Baldwin Garvin, tall, light blue eyes and brown hair. He was in France with the 57th Artillery unit, serving as a 1st Lieutenant. He was discharged, January 25, 1919. Not sure how they met, but on August 30, 1919, they got married in Manhatten, New

By 1920, Bess and Roger were living in Bergen, New Jersey on Grand Avenue East, Englewood Ward #2. They were living with Roger's mother Helen Garvin and his two unwed sisters, Martha and Ruth. A daughter, Eugenie Boyer Garvin, was born December 19, 1920. Followed by a daughter, Leslie Ross Garvin, April 15, 1922. May 19, 1926, Bess father, John passed away. He was buried in Lehman Cemetery. By 1930, the Garvin family moved to Merrin Street, Payne. Roger a mechanic and Bess a nurse and the girls in school. On July 21, 1937, Bess' mom, Sarah passed away and was buried beside John.

By 1940 the Garvin family was still on Merrin Street. Eugenie had just finished her first year of college and Leslie her third year of high school. In 1942, Roger had to register for the draft, as America was drawn into another World War. In 1943, Eugenie served in the Air Force serving with the

Women Auxiliary Air Force. On January 27, 1949, Roger passed away due to health issues. He was buried in Lehman Cemetery. Bess took care and signed for his Military tombstone. November 29, 1950, Bess and her daughter, Leslie left New York for six months on the "Mormacyork", and sailed to Brazil to visit Eugenie and her new husband.

In 1963, Bess filed for Social Security benefits. On Monday April 12, 1971 at 1:37 a.m., Bess passed away at the Ottawa Valley Hospital. She was buried Wenesday April 14, 1971. Services were provided by Slade Funeral Home with Rev. Grant A. Sheely officiating. She is buried in Lehman Cemetery beside her husband Roger. She was a life long member of the Rueben J. Smith Post #297, Payne, Ohio.





LAWN CARE FOR THE HOMEOWNER

How to Choose the Proper Grass Seed

Now that we have warmer weather, many of you will want to buy grass seed to fill in some bare spots or over seed thin areas of your lawn. Spring is an excellent time for applying grass seed! But what type of seed should you get for your lawn? The short answer is high quality seed. A lawn can never be better than the seed that is sown.

Buying grass seed is like buying a car without seeing it or driving it. There is nothing tangible to compare it to. Until the seed grows into a lawn, the true quality of what you bought won't be visible for months. The only thing to evaluate is the seed label. Seed labels are written to meet agricultural regulations, and are unfortunately not "consumer friendly." Let us give you four guidelines to break down a seed label's four major requirements: Varieties, Germination, Inert Matter, and Weed Seed.

1. A pound of seed is not the same amount of seeds between varieties. A seed label tells you what varieties are in the package. However, it only tells you in percent by weight of the total package. It does not tell you that seed size and weight are dramatically different. For example, one pound of bluegrass is 1,400,000 seeds. That same pound in fine fescue is 530,000 seeds, and it only takes 225,000 ryegrass or tall fescue seeds to make a pound. What this means is the label does not tell you the amount of each variety you will see in your lawn. Ideally, you could determine the amount of a particular seed present by calculating the percentage by seed count. Unfortunately, seed count is not required on the label, and difficult to determine.

2. Germination is under the ideal conditions...not 'normal" Mid-West weather. A label gives you the percent of pure seed that is capable of growth in a prescribed time ınder laboratory conditions.

These laboratory conditions are ideal. Seeds are placed on wet filter paper and grown in an incubator with perfect light and moisture control for as long as 28 days. Furthermore, germination percentages cannot be compared between different manufacturers. The germination values may be the same, but they may have been achieved under differing laboratory conditions (i.e. Lab A germinated seed in an incubator for 10 days, and Lab B germinated seed in an incubator for 20 days).

3. Double the inert matter percentage for a more realistic filler amount. Some grass seed packages have filler in them. This is called inert matter. Inert matter or bulking agents like corn cobs or chaff are often added to make larger packages. Sand may be added to ensure that the packages will meet weight requirements. Volume of inert matter can generally be found by multiplying the percentage by weight by two. (i.e. 5% inert matter = approx. 10% of the

4. Weed seeds weigh less, so their unwanted plant count can be higher. Weed seeds are also a factor in selection of a grass seed mix. The label says percent by weight of all seeds in the package which were not included in the good pure seed crop. Similar to guideline 1--amount and weight are not equal things--is even truer of weed seeds. One harmless needle grass seed weighs the same as 32 harmful chickweed seeds. But both would be listed as 0.27%. If only 0.10% were chickweed, that would result in 560,000 plants in a 10,000 square foot lawn.

So, now armed with an understanding of grass seed labels, back to the question of what seed to get? Choose a premium seed mixture that guarantees a great lawn. Quality seed mixtures that work well in the Midwest will use a high percentage of bluegrass seed. Bluegrass has very small seeds, so a smaller package of premium seed can cover more area of your lawn. The bonus of bluegrass is its rhizome ability, which means the plant's roots spread to create new plants.

Bluegrass may be combined with other grasses to derive multiple benefits. Ryegrasses geminate fast to hold the soil. Tall fescues are
