#### LATTA VOTES TO BOOST TROOP PAY; PROVIDE MILI-TARY WITH RESOURCES IT NEEDS TO CONFRONT RIS-ING GLOBAL THREATS

Congressman Bob Latta (R-OH5) released the following statement after voting in favor of the National Defense Authorization Act (NDAA). The annual defense legislation sets priorities and policies for our armed services. The bill passed by a vote of 329 to 101.

The men and women of our armed forces deserve to have the resources they need in order to best protect and defend our country from increasingly dangerous global threats," said Latta. "By passing the NDAA, we are sending a message to our allies and adversaries around the world that the United States will always prioritize our national security and will remain prepared to challenge those that would wish to do us harm. I supported this year's NDAA because it provides our service members with a pay increase, contributes resources to help military families dealing with increasing costs and inflation, guarantees the right of military parents to have a say in their kids' education, continues the process of modernizing our forces, and provides the tools to confront the rising threats from adversaries like China, Russia, and Iran."

Background

The Fiscal Year 2023 NDAA includes a broad array of provisions that will impact pay for servicemembers, resources and policies for military families, and priorities related to national defense. For example, this year's NDAA included the following provisions:

• 4.6% pay increase for servicemembers

• 2.4% pay bonus for enlisted personnel to counteract the impacts of inflation on low-income military families. As the United States continues to combat rising inflation and the increased costs associated

with inflation.
• \$500 million for additional housing allowances to

counteract the skyrocketing cost of rent on military families.

A story of travel, adventure and service. Rassie Wilford Beverly, also known as Erastus, was born in Columbus, Ohio, January 31, 1890. The son of Samuel and Samantha Ann (Smith) Beverly. This

couple was married in 1869.

Samuel served in the Civil War as a private in the Confederate Army from Virginia. By 1900, the family of four children were living in Latty, Ohio. Rassie was in school along with his two brothers, Arthur and Cornelius and sister Clera M. Sometime after 1910, Rassie was living in Broughton, Ohio. Then he moved to Montana.

On June 5, 1917, Rassie registered for the draft in Sheridan County, Montana. He was listed as 5'6", medium height and build, brown eyes and black hair, listing farming as his vocation. Rassie moved back to Broughton where he was sent to serve with 158th

Depot Brigade. He served with this unit until July 15, 1918. He was then assigned to Company C. 334th Infantry. On September 2, 1918 Rassie was put on the ship

Aquitania, and set sail from

New York to France. He

served with this unit until November 2, 1918. He was then assigned to Company C. 1st Provisional Regiment Camp at D'Auvours Le Mans, France, then was transferred to Headquarters Department Army Service Corp American Expeditionary Force to July 8, 1919. On July 8, 1919, Rassie boarded the ship, Manchuria at St. Nazaire, France and set sail for Hoboken, New Jersey. Ship docks July 18, 1919. He was be Honorably Discharged July 26, 1919. In 1942, Rassie registered for the World War Two draft. He was living at 434 North Second Street, Saginaw, Michigan. He was working at the Chevrolet Service Parts Plant. His wife, Elsie passed away 8:35 A.M. October 15, 1943 in Saginaw, Michigan. November 8, 1941, daughter Elnora M., married Rollie M. Cramer. November 8, 1943, Elnora joined the Woman's Army Corp in Detroit, Michigan. Her husband, Rollie, also served in World War Two. 



Van Wert City Schools announces its 2022-2023 Free and Reduced Price Meals policy for students unable to pay the full price of meals served under the National School Lunch and School Breakfast Program. Each school office and the central office has a copy of the policy, which may be reviewed by any interested

Please note that the USDA's Free Meal Program expired June 30, 2022, which provided free meals for all students. Eligible students may still receive free or reduced-price meals but must apply for these benefits. Application forms are

Households may apply for benefits any time during the school year. 



In light of the recent risis and new authority provided through the bipartisan Access to Baby Formula Act, the U.S. Department of Agriculture (USDA) is announcing a series of additional steps it will take to strengthen resiliency in WIC, which covers the cost of infant formula for families with limited means. - shopping for infant formula for WIC participants. WIC participants may not currently use their benefits to purchase infant formula or other food items online. This can make it more challenging for families to find formula if their local stores are not carrying it. USDA will use up to \$50 million in American Rescue Plan Act funds to test and launch online shopping in WIC, with planning grants announced last month. USDA will also propose rulemaking to address regulatory barriers to online shopping and to expand the types of stores eligible to participate in the program. Online shopping will give WIC families more options. The Administration proposed to further expand online options in the President's 2023 Budget.

Heavy rains have been falling in many areas in the month of July. This has many farmers wondering how much Nitrogen (N) is still available. Soluble N in the form of nitrate can be leached, some can runoff the surface, and other N can be lost by denitrification into the atmosphere. If corn is turning yellow, it can be nitrogen or sulfur (S) deficient or both. Many farmers are asking, is it too late to apply corn fertilizer? Late season corn N appli-

cations have proven to be successful, but often requires specialized high clearance fertilizer equipment. Often, fungicides and micro-nutrient blends are also put on late, so adding some N fertilizer is an option. University of Missouri and Ohio State University research shows that urea and dribbling on 28% UAN can be applied late season. With the recent rains, most fields should have adequate moisture for the N to used effectively. Some leaf burn may occur with broadcast urea, but yield damage is relatively slight. How late can N be applied?

Most research shows that N applied up to tasseling is quite effective, after tasseling; results are more variable. Corn takes up N much slower after tasseling as the corn goes from a vegetative stage to reproductive. Nitrogen is translocated from the stored N in the vegetation to make grain. Tissue tests are recommended to determine the rate of N needed. If for some reason, no N was applied, or a significant portion was lost; up to full rates of N can still be applied with good results.

Farmers are now using Y drops as a new way to apply late season N. The Y drop system applies liquid N to the base of the corn plant. Corn gets about 60% of its soil N within about 7 inches of the corn stalk. With Y drops, N can be applied right at the base of the plant so that about 80% of the corn roots are in the vicinity of applied N.

The Y drops increase N nutrient use efficiency. Farmers can apply the N in split applications to increase efficiency and also apply other nutrients or fungicides as needed. Most modern corn hybrids can now produce 1 bushel of corn using about 0.8 pounds of N per acre. With the high price of N fertilizer, increasing N nutrient use efficiency is needed to be profitable.

Corn nutrient uptake

curves show that about 75-80 % of N is taken up by the corn plant by tasseling or pollina-For phosphorus (P), about 50-60%, for potassium or potash (K) 75%, and for sulfur (S) about 50-55% is taken up by tasseling or the start of the reproduction phase. For N and K, most nutrient uptake occurs before pollination and significant portions can be mobilized from existing plant vegetation during grain fill. For P and S, a significant portion is taken up after pollination and most is still coming from roots. Sulfur is needed in a 10:1 ratio of N to S for optimal protein synthesis. If many of these nutrients are lacking, corn still has time to take up the fertil-Again, moist soil is needed for adequate root ab-

For calcium (Ca), about 80% is taken up before pollination. Boron (B) is needed to move calcium into the plant. Interestingly, only about 60% of B is taken up by tasseling. Calcium is second only to N in the total amount of nutrients needed for high production. Calcium activates many key enzymes, so keeping both Ca and B levels adequate is critical for excellent yields. Boron is often lacking and pint to a quart of liquid B per acre can improve calcium up-

For other micronutrients, about 50% of iron (Fe) and zinc (Zn), 40-45% of manganese (Mn), and 30% of copper (Cu) is taken up by tasseling. This means, that these nutrients can still be applied late with good results. Many fungicides contain at least one of these elements as a central part of their structure. Iron is needed to active an enzyme that makes chlorophyll, manganese is needed by crops to split the water molecule to make proteins. Zinc activates over 300 enzymes (some redundant) but Zn deficiency could account for up 10-30% corn yield losses. Ĉopper is needed to make lignin, and is slowly mineralized (2 to 5 years) from soil organic matter. A lack of copper means corn stalks may be weaker and more likely to lodge. Overuse of glyphosate has caused many of these micronutrients to be plant unavailable. Promoting good soil health with cover crops (especially oats) and healthy soil microbes makes all these nutrients more crop available.

Through these efforts, USDA's Food and Nutrition Service (FNS) has worked to ensure WIC participants and stakeholders have the information they need to keep infants safe and to access formula. #### AS GLOBE WARMS, IN-**FECTED PINES STARVE AND** DISEASE-CAUSING FUNGI THRIVE

The high heat and low water conditions produced by global warming weaken pine trees' resistance to disease by hindering their ability to mount an effective defense at The plan may be viewed online at https://www.in.gov/ the same time that pathogenic fungi in their tissues become

more aggressive, new research suggests.

The study is the first to simultaneously examine metabolic gene expression in both host trees and the pathogens attacking them under normal and climate-change conditions. The findings help explain the mechanisms behind what has become a wellknown fact: The warming world makes trees more susceptible to disease.

The study was conducted on Austrian pines, which are native to southern Europe and used ornamentally in the United States. Researchers tested climate change conditions' effects on the trees after infection by two related fungi that have killed large swaths of these pines over time.

"We decided to study the effects of the combined stresses of higher temperatures and lower water availability because that's what trees will experience in the future," said senior author Enrico Bonello, professor in The Ohio State University College of Food, Agricultural, and Environmental Sciences (CFAES).

"Within three days of infection under climate-change conditions, the tree was pulled in two different directions: It was deprived of carbon by both reduced photosynthesis and enhanced acquisition of the carbon by the fungi," said Bonello, who is a professor of molecular and chemical ecology of trees in the CFAES Department of Plant Pathology. "When we're talking about carbon, we're talking about sugars, food and reserves for all other metabolic processes in the trees, including growth and defense."

The research was published recently in the journal Frontiers in Forests and Global Change.

Carbon sequestration by the world's forests is a major mitigator of climate change's effects, and could be accelerated if improvements are made to their protection, management and restoration, experts say. In a 2021 study of U.S. forest plots, scientists estimated recent disease and insect disturbances had lowered carbon sequestration rates by 28% and respectively, from 2001-2019 compared to undisturbed forests.

"This is another reason to combat global warming induced by human activities another piece of evidence that what we are doing to the planet has so many implications," Bonello said. He and colleagues exposed

3-year-old Austrian pines to two sets of conditions: daily temperatures ranging from 59 to 82.4 degrees Fahrenheit for the control or, to mimic climate change conditions, daily temperatures of 68 to 91.4 degrees Fahrenheit, which reduced the amount of water in the atmosphere compared to available water in the cooler temperatures. After trees got accustomed to their conditions, they were inoculated with one of two strains of the pathogenic fungus. Diplodia sapinea, an ag-

gressive fungus, and its lessaggressive relative Diplodia scrobiculata are found in both the Northern and Southern hemispheres. They remain dormant much of the time, waiting for the best opportunity to kill host cells and feed on the dead plant material usually when their host is weakened. In addition to killing Austrian pines, the fungi have also begun damaging Scots pines in Scandinavia.

"The hypothesis is that the warming and lower water availability in those areas is making trees more susceptible to a pathogen that would normally sit in the background," Bonello said.

Three days after infection, the team collected plant and pathogen tissue that was used for an RNA sequencing analysis to identify gene activation, or expression, pattern changes in the trees and both strains of

The analysis showed a fundamental change in the trees exposed to the climate-change conditions: Their capacity to carry out photosynthesis decreased, meaning they had fewer resources to invest in their own food supply, growth and defense against disease. At the same time, both strains of the fungus ramped up their carbon utilization machinery, and the usual difference between their aggressiveness disappeared - they became significantly more pathogenic, and to the same extent, than

under normal conditions. "Essentially, climate change conditions led the host to starvation, which is compounded by the fact that the fungi became more aggressive, grew faster and killed more host tissue faster," Bonello said. "These were early responses, but it gives us an idea of what's

happening in the system." While these results are one example of one tree species and one type of pathogen, the research offers insights into how much damage global warming may do to one of the planet's main carbon sinks.

"Pathogen and pest invasions are already having an effect on carbon sequestration," Bonello said. "If you make it even worse with climate change, carbon sequestration will be affected negatively because trees will die in ever larger numbers. Trees that might otherwise survive adverse environmental conditions for a while, and recover if conditions become better or intermittent, may be killed by pathogens in the meantime."

After discussion, Councilman Watts moved to pay the warrants as presented, second by Councilman Thompson, all present in favor. A change order related to the Mainstreet Project was presented for considera-tion. After discussion, Councilman Thompson moved to approve Change Order # 1 to API, which results in the additional payment of \$30,387.55, second by Councilman Gerig, all present in favor. A third and final invoice to be paid to API Construction for the Mainstreet Streetscape Phase II project was presented in the amount of \$258,734.50 to API with another \$13,617.20 to be paid to the city escrow account as retainage as well as an additional \$9.00 for fees associated with the escrow account. After discussion, Councilman Thompson moved to proceed as proposed, second by Councilman Gerig, all present in favor. If the work is accomplished to the Council's liking, the Clerk-Treasurer then asked if they would approve the release of retained funds for the project to API in the amount of \$32,156.33. This may take a few more days as the last retainage amount will need to be deposited first, with the full amount paid as a check to API, and then the escrow account will be closed. After discussion, Councilman Thompson moved to release the retained funds for the Mainstreet Streetscape Phase II Project in the amount of \$32,156.33, second by Councilman Watts, all present in fa-

Councilmen's Report: Councilman Thompson reminded Council about the benefit on July 17th for the Jackson family.

Audience: Chris and his associates provided information about potential services of grant writing that they can facilitate on behalf of the city. A resident came to discuss an issue with his utility bill. It was de-termined that the resident was having issues with his water softener, and that this
