Serving overseas as a small-town boy from America is intense, stressful and humorous! Enjoy a lighthearted story with me from our last 20 years overseas!"

Remember ever getting tingling, painful sunburn on your neck or back? I remember those years in Indiana where it seemed like spring weather would never come and then it arrived. Inevitably it meant an "early season sunburn" in the era before anyone used sunblock. Eventually the skin adapted and turned into a tan of some kind.

Living overseas in a place that has summer and spring weather all-year-round, we get tourists from many sundeprived places in Europe. We can have UV indexes of 11 and up all year. When going to our airport, we look at briskly arriving tourists who are stark snow-white. We then walk to the other end of the airport where the departing passengers are gingerly walking with pink and red

sunburned legs and arms.

One summer our sons got to experience quite a sunburn. We had a two-day boat journey and the seas were very rough. I slumped off to my bed to try to sleep my way through the rough seas. My sons felt they could better handle the waves by being outside on the main deck, and I agreed in a half-conscious state of nausea. Periodically they would return back to our

cabin to see how I was doing and then head back outside over the two days.

On arrival to the port after two days, I noticed the backs of my sons' necks and heads very seriously sunburnt. The cool sea breezes deceived us into forgetting about the intense sunrays. Had there been a hospital nearby, we would have made a visit, but it wasn't an option. We were now ready to start a month of travel with much time outside and their oozing and damaged skin would need to be covered for weeks to be able to heal. We found a surplus store that sold hats with long built-in bandanas that stretched around the sides and back.



There are many home remedies and placebos to handle rough seas. I often lay flat, chew on raw ginger, suck on lemon wedges, and pray like mad for calm seas.

Caps of that style were not common back then for those not trekking across the Sahara. The hats did not meet the boys' fashion standards, but there was no other option. They wore those desert caps every time they were outside for the rest of the trip.

To this day, when we pull out photos from that summer (with them wearing their desert hats), the boys still roll their eyes and remind me of allowing them to spend two full days out on the boat's main deck.

Hosea Gerald Hummell

was an Antwerp boy who joined the Navy to serve in World War 1. Hosea was born January 25, 1897 in Antwerp, the son of LeRoy, born November 27, 1872 in Ohio, and Catherine Doyle (Fox) Hummell, born December 1874 in Ohio. LeRoy and Catherine were married in Paulding, June 30, 1894. By 1900, the Hummell



family, LeRoy, Catherine and 3 children were living with parents Catherine's Antwerp. By 1910, LeRoy, Catherine and now 5 children were living on West Washington Street, Antwerp, but now Catherine's parents are living with them. On August 28, 1915,

Catherine Fox passed away. She was buried in Maumee Cemetery, Antwerp. Michael Fox passed away October 18, 1917 and was buried beside his Catherine. In 1917, Hosea, was living at 055 Jefferson Avenue, Detroit, Michigan. On May 18, 1918, Hosea joined the United States Navy Reserve, and called for active duty. He was stationed Detroit, Michigan.

May 22, 1918 to June 14, 1918, Hosea was at the Naval Training Station at Great Lakes, Illinois. Then sent to Norfolk, Virginia to serve at the Naval Operating Base until June 24, 1918. Serving 177 days on the U.S.S. Arkansas until November 11, 1918. He had attained the rank of Seaman 2nd Class. He was released from duty, January 23, 1919, due to lack of funding for the Naval Department.

Hosea was Honorably Discharged, September 30, 1921. On September 12, 1918, Hosea's father LeRoy had to register for the draft. He was listed as short and slender build, blue eyes and light hair. He was not chosen to serve. By 1920, Hosea, most of the time going by his middle name, Gerald, was single and living on Jefferson Avenue in Detroit, Michigan. He was working as an inspector at a Rubber Works Factory.

In 1926, Hosea's father Leroy passed away and was buried in Maumee Cemetery. By 1935, Hosea was a patient at the United States Veterans Administration Facility in Center Township, Grant-County, Indiana. By 1940, Hosea was still lying at the Veterans facility. It is unclear what his health issues were. On November 18, 1944,

Hosea Gerald Hummell passed away. He spent 9 years, 7 months and 23 days in that care facility. He was buried in Maumee Cemetery. His mother, Catherine, signed for his Military tombstone application. She passed away in





Mother nature played havoc last weekend at several Midwest racetracks I cover. Two weeks in a row Oakshade was rained out but Lorain, Attica and Montpelier got their races in. Because of the county fair, Fremont changed their race date to Monday and will ran 305 Sprints and Vintage Race Cars. Races not covered here can be viewed on my Facebook page, Ohio Sports Blitz.

The big headline this week. Kody Swanson (last week's Toledo Rollie Beale Classic winner) set a new world speed record for a USAC Silver Crown car during Friday afternoon's qualifying at World Wide Technology Raceway in Madison, Ill. The California native's time of 30.675 around the 1.25-mile paved oval was 146.699 mph, topping the former speed record for a Silver Crown car set by him in 2012 at Iowa Speedway at 146.212 mph. He broke Chris Windom's nine-year-old series track record at WWT of 31.082 seconds and 144.778 mph, set in 2013. As a result, Swanson became the first driver to capture 40 career USAC Silver Crown poles. All eyes were on Swanson at the start of the 100-lap feature. He had never won the race and he's currently on a win streak. The race had 5 different leaders all pressing each other from the green flag to the checker. Cautions helped Kody and with 25-laps to go he regained the lead and was

able to hold off several challenges to get the win. Finishing behind Swanson was, Davey Hamilton Jr., Mario Clouser, Justin Grant, and Nathan Byrd. On Saturday evening the Bettenhausen 100 for Silver Crown Cars, at the Illinois State Fairgrounds was rained out and the make up day for this prestigious race will be October 15th.

At Lorain Raceway Park, the Midwest Supermodified Series had their season Championship. JJ Henesone one of the young guns, and 3rd generation driver grabbed his first Supermodified feature win in honor of his grandmother Nancy Henes, who the race is named after. Behind your race leader was 2nd A.J. Lesiecki and 3rd Kyle Edwards. Edwards from Bartlet, TN, finished 3rd but won his second MSS points championship in a row.

At Attica Raceway Park, Canadian Skylar Gee survived a restart with just two laps to go and drove to his first career 410 sprint car win. Gee led all 30 laps of 410 Sprints A-main, but it wasn't easy as Tyler Gunn pressured him several times late in the race but when Gunn jumped the cushion and flipped in turn four with two laps to go, Gee had clear sailing, hitting his marks perfectly on the restart and driving to the victory worth \$3,500. After tangling with Chris Andrews battling for fifth early, Attica point leader Cole Macedo came back to finish second ahead of DJ

Foos who edged Tim Shaffer and Trey Jacobs. Macedo's rally will add to his point lead for the 410 Attica Fremont Championship Series. In a caution-filled 25 lap UMP Late Model feature, Britton, Michigan's Devin Shiels powered away to his fourth win of the season and 14th of his career at Attica, placing him 5th on the division's all-time win list. The current Attica late model champion has not finished out of the top five all season at the speedway and has seven overall victories in 2022 at various tracks. Teenager Collin Shipley would get by Mike Bores on the last lap to steal second with BJ Gregory and Larry Bellman rounding out the top four. In 305 Sprint Action Jamie Miller, drove to his fourth win of the season at Attica. The win was Miller's 35th career 305 victory at the track. 

OHIO LEADING THE WAY WITH NEW AIRCRAFT TRACKING SYSTEM



COLUMBUS - As the number of drones grow, so do concerns about how to keep airspace safe for both crewed and uncrewed aircraft. Ohio is pioneering technology to do just that.

At low altitudes, detecting manned air traffic with traditional radar is much more difficult due to the presence of ground obstructions such as trees, houses, cars, and other low-flying objects such as birds and insect swarms. Since 2018, the Ohio Department of Transportation Office of Statewide Planning and Research has been working with the Federal Aviation Administration (FAA), DriveOhio/FlyOhio, Ohio Unmanned Aircraft Systems (UAS) Center, Ohio State University, and industry to develop and deploy a "detect and avoid" system to track drones, as a public service, and keep them from colliding with aircraft that

operate at lower altitudes like medical helicopters or crop dusters. This is a first in an urban setting.

"The future is now, and this is just the latest chapter in Ohio's storied history of pioneering flight technology," said Ohio Governor Mike DeWine. "We have the ability, the knowledge, and the resources to be the top destination for this industry to thrive."

"Efforts to develop the right kind of infrastructure drone technology through this cutting-edge system will promote safe practices and innovation in the sky, solidifying Ohio's place as a leader in the advanced air mobility space," said Lt. Governor Jon Husted.

The Uncrewed Traffic Management system includes three ground-based radar locations in central Ohio. A drone operator re-

quests clearance to fly, much like an aircraft pilot would, and is given permission to use the airspace from the FAA. Both drone pilots and manned aircraft pilots would be able to see each other and safely share the airspace.

"It gives drones an understanding of where they are in the airspace, who's around them, and what they can do to essentially safely navigate from A to B all while giving manned traffic the priority," said Dr. Matt McCrink, lead scientist for Ohio State's research team.

As of May 2022, there are more than 854,000 drones registered with the Federal Administration (FAA). Currently, the FAA requires all unmanned aircraft be operated within sight of the operator.

"The promise of drone deliveries has been around for some time, but that key infrastructure to support that has not existed and so ODOT is at the forefront of essentially establishing what that infrastructure looks like, how we can scale it, grow it, and incorporate it with the existing manned traffic control systems as well," McCrink said.

The development of this system will provide affordable and reliable needed protections against airborne hazards for operators to safely fly beyond visual lineof-sight without ground observers, allowing drone technology to grow in Ohio.

"The last mile package delivery is what the future holds. The FedExs, UPSs, Amazons - that 2-hour delivery that they guarantee, this technology will support that," said Richard Fox, airspace manager for the Ohio UAS Aside from product deliv-

eries, drones can also provide valuable information to emergency crews at a crash scene. The system was recently used as part of a multijurisdictional incident management training operation using drones, believed to be the first in the world. The exercise simulated a crash involving a semi-truck in Logan County. The drones provided airspace support by transmitting live video to emergency dispatchers, first responders, and the ODOT Traffic Management Center in Columbus giving them an "eye in the sky." However, when a medical helicopter was called to the scene to shuttle a victim to the hospital, the system was able to alert the drone operators so they could clear the airspace.

"ODOT's mission is to provide safe and easy movement of people and goods from place to place and that isn't limited to ground level," said ODOT Director Jack Marchbanks. "From researchers to drone pilots and aviation experts, our employees work hard each day to ensure that Ohio is the premier place to develop and grow this quickly emerging indus-

Advanced air mobility, which uses electric vertical takeoff and landing aircraft to easily move people and cargo, is another next major step in drone technology. An economic impact study found that over the next 25 years, advanced air mobility could benefit the Ohio economy to the tune of \$13 billion, 15,000 additional jobs, and \$2.5 billion in tax rev-

Calhoun adds that Ohio has certainly positioned itself in the right place to remain a leader in this emerging technology.

nounced the creation of a new public dashboard to provide Ohioans with information about the status of monkeypox in the state.

The Monkeypox Cases Overview dashboard and interactive map, available on the Ohio Department of Health website (odh.ohio .gov), shows the total number of cases across the state, the number of cases per county, the age range of people affected by monkeypox, the percentage of cases by sex, and outcomes, including any hospitalizations and

The dashboard, which will be updated weekly on Thursdays, is modeled after other dashboards ODH has developed to share information with Ohioans about infectious disease outbreaks, including the 2018 statewide outbreak of Hepatitis A.

As of today, there have been 147 confirmed cases of monkeypox in Ohio across 19 counties, with the most cases reported in two of the state's largest metro areas, Franklin County, including the City of Columbus, (33 and Cuyahoga County, including the City of Cleveland, (69 cases). Most cases (96%) have been among men. The Ohio Department of Health reported the state's first case of monkeypox on June 13. As we have seen cases increase nationally and here in Ohio in the past few weeks, this new resource can help Ohioans be aware of the health status of their communities.

"The Ohio Department of Health has been working closely with our local health department partners and healthcare providers to provide monkeypox testing, case investigation, contact tracing, and prevention and treatment options. As cases do continue to rise, we want to keep Ohioans informed about this outbreak, and what steps they should take to protect themselves," Dr. Vanderhoff said. "The risk of contracting monkeypox for most Ohioans remains low, as this virus does not easily spread like COVID-19. However, it is important to continue to do all we can to mitigate the spread of this virus and to reduce the burden of illness."

Monkeypox is spread through close, personal, often skin-to-skin contact with someone who has monkeypox. Monkeypox can cause a rash that may look like pimples or blisters. The rash will change and turn to scabs before healing. Some people may get flu-like like symptoms headache, muscle aches, sore throat, cough, swollen lymph nodes, chills, or exhaustion. Sometimes, people

USDA EXTENDS INFANT FORMULA WAIVERS, SUPPORTS WIC STATE **AGENCIES**

The U.S. Department of Agriculture has extended a series of waivers to provide WIC families with additional formula options through the end of the year. The waivers, which were previously set to expire at the end of September, will earlier of either Dec. 31, 2022,

of the state's COVID-19 major disaster declaration, ensuring WIC families have continued access to the formula they need. "USDA recognizes the

flexibilities provided by these waivers remain necessary as we continue to pull every lever to address infant for-

mula supply issues and provide certainty for families," said Agriculture Secretary Tom Vilsack. The waivers extended today allow WIC state agencies, with the necessary agreements from their infant formula contract manufacturers, to offer participants additional infant formula options, such as alternate sizes, forms and brands. The planned Dec. 31 expiration date will provide

state agencies with continued

flexibility while the nation-

wide supply of infant formula

recovers. USDA began offering waivers immediately after the Feb. 17, 2022, voluntary recall of certain Abbott powder infant formulas, which exacerbated existing supply chain issues caused by the COVID-19 pandemic. Since then, FNS has granted nearly 500 waivers to WIC state agencies, providing flexibilities to better serve WIC participants receiving benefits for infant for-

USDA's Food and Nutrition Service continues to work tirelessly to ensure WIC participants and stakeholders have the information they need to keep infants fed and safe. Working closely with the White House, recent USDA actions include:

- Recommending that state agencies in contracts with Reckitt Mead Johnson or Gerber - two of the three infant formula manufacturers for WIC, the third being Abbott seek contract flexibility to allow alternate formulas if the contracted size, form or brand of formula is unavailable, with USDA paying the cost differ-
- Leveraging new authority from the Access to Baby Formula Act to allow states to make imported formulas available to WIC participants, as well as participating in the cross-government mula to rapidly transport safe specialty and regular formula
