Jury selection took place October 18, 2022, for the case of State of Ohio VS Heidi L. Grant, who is charged with the murder of her husband, Christopher Franklin.

Ms. Grant was present in court with her attorneys, William Kluge and Robert Grzybowski. Prosecutor Joseph Burkard was present for the state along with Assistant Prosecutor Matthew Miller and Antwerp Police Chief George Clemens.

Twelve individuals were seated to begin selection, six of which were dismissed. Then fill-in placement selection began and two were dismissed immediately.

Next, selection for an alternate juror began and the state dismissed the first one.

WATER RATES INCREASE PROPOSED AT ANTWERP VILLAGE COUNCIL MEETING

The Village of Antwerp met in Regular session on October 17 to discuss items of concern for the residents. Regular business included the agreement that needs to be resolved by the village in order to have Sheriff Deputies help fulfill the role of EMS run personnel.

The central part of the meeting revolved around the Water Plant, infrastructure and meter improvements that will be an ongoing upgrade item in the future. The utility committee met prior and rec-



PARSON TO PERSON

By: Dr. James Bachman Dear Parson,

Do you believe in the pretribulation rapture of the church?

There are two aspects of Christ's return. First, He will come in the clouds with those who are with Him in heaven. Their earthly bodies will rise and be transformed into an eternal body like the resurrected body of Christ. At that moment, believers here will also receive a new eternal body and be "caught up" (raptured) together with them in the clouds and go with Christ back to heaven. I Corinthians 15:51-53 - "Behold, I shew you a mystery; We shall not all sleep, but we shall all be changed, In a moment, in the twinkling of an eye, at the last trump: for the trumpet shall sound, and the dead shall be raised incorruptible, and we shall be changed. For this corruptible must put on incorruption, and this mortal must put on immortality." I Thessalonians 4:16-17 – "For the Lord himself shall descend from heaven with a shout, with the voice of the archangel, and with the trump of God: and the dead in Christ shall rise first: Then we which are alive and remain shall be caught up together with them in the clouds, to meet the Lord in the air: and so shall we ever be with the Lord." (See also John 14:13; Acts 1:11)

The second part of Christ's return will take place after the seven-year tribulation when Christ will return with the believers and set up His kingdom on earth for 1,000 years, also called the Millennium (Revelation 20:1-4). It is obvious this part of the second coming is after the seven years of tribulation.

God promises not to take the church through the tribulation. I Thessalonians 1:10 -"And to wait for his Son from heaven, whom he raised from the dead, even Jesus, which delivered us from the wrath to come." (See also I Thessalonians 5:9; Romans 5:9; II Peter 2:9; Revelation 3:10).

Though we do not know the exact time of the rapture (Matthew 24:36-42; Mark 3:32; Acts 1:7), it appears to be near (James 5:9; I Peter 4:7).

We should be ready (Matthew 24:44) by being saved, walking with God, and being right with others. If the rapture was not before the tribulation, the whole clear doctrine of the imminent return of Christ would be destroyed.

(Continued from Page 1) fense Attorney William Kluge beginning the trial.

By 12:30 p.m. the state had called nine witnesses and presented evidence which included a 911 call made early morning, January 13, 2022 by Christopher Franklin alleging his wife, Heidi L. Grant, had woken him up by hitting him in the face/head with a table leg, baseball bat or something of the sort. A local sales clerk testified she had seen Franklin in the store moments after the alleged attack with a bloody and swollen face.

After a break for lunch, the state called Thomas M. PHD, Blomquist M.D., Coroner, Deputy Lucas County who testified the deceased had blunt force trauma to the head and face area and had been shot ten times.

After calling one more witness to testify on ballistic testing performed on the weapon the State rested.

The trial resumed Thursday, October 20, 2022.

Defense called, who would be their first and only witness, Ms. Heidi Grant. After an emotional testimony, the defense rested and the state called Police Chief George Clemens back to the stand as a rebuttal witness. When that testimony was complete, the state rested.

The court then took a recess for both sides to prepare for closing arguments. When closing arguments were complete (around 1:00 p.m.) the jury was given their instructions and then dismissed to begin deliberations.

Case recap: During the course of the trial, the state showed that at 7:27 a.m. on January 13, 2022 a 911 call had been received by Christopher Franklin stating that his wife, Heidi L. Grant, had struck him at least twice in the head with a table leg or something of the sort. Ms. Grant had left the residence, contacted a friend in Hicksville and met him to borrow his gun, traveled back to Antwerp, returned to her home and shot her husband just moments before an officer arrived. She then met

with officer on the porch and assured him that everything was fine, no violence had occurred and her husband was passed out drunk. Convinced, the officer left. She then moved her husband's body to the basement, wrapped him in plastic, then made a crypt of cinder blocks and cement and placed boards over top of it. A welfare check (which turned into a missing person's report) was made on January 21, 2022. Grant told the officer that she had last seen her husband on January 15, 2022. During questioning on January 22, 2022, Grant proceeded to confess to shooting her husband and burying him in cement in the basement of their home and hiding the gun. Autopsy report shows that Franklin was shot 10 times, one occurring in his back, presumably while lying face down on a hard surface. The report also showed blunt force trauma to the face and head and showed facial

jury had reached a verdict. Jury was given the options of Aggravated Murder, Murder, Voluntary Manslaughter and Tampering with Evi-

dence. Heidi L. Grant was found not guilty of aggravated murder and voluntary manslaughter, but was found guilty of Tampering with Evidence and Murder with Gun Specifications.

Sentencing will be set for a later date.

After finishing up in college, I took a job as an urban forester in Chicago to pay off college and save money to get



riences was working for the company that cleaned up after Mr. T's workout. Mr. T was the muscled Hollywood and TV personality with a mohawk haircut from the 80s who starred in Rocky III and the A-Team. He grew up poor in Chicago and then moved to the suburbs after making his fortune. Mr. T decided to chop down trees with an axe on his property for a workout. He didn't realize that the trees were protected by local government, so he not only paid for us to remove the trees, but also very hefty fines.

We now live overseas where there are some bizarre trees. We have a tree called the Dragon Tree whose sap is redbrown and was used to varnish stringed instrument instruments. We have a "well tree." Locals suffered lack of drinkable water. They realized that planting a tree in ravine that had constant heavy fog would catch the moisture on the leaves and they could collect water from the dripping leaves to survive. We have "wind trees" located on mountain cliffs that look like gnarled up bonsai trees believed to be thousands of years old as their slow growth is imperceptible. We also have "colony trees." It doesn't matter the species of tree, but the large rats are smart and know to avoid sewers and buildings where they are more easily trapped and killed. Rats climb the trees and live, breed, and nest above the ground. Newly arrived clueless people (like I was) assume that scurrying sounds right above their heads are birds and not aggressive rats that will even attack humans.

scheduled and no disruptions will take place as the Supreme Court of Ohio has judges ready to stand in cases of absence.

The replacement process has begun with the Paulding County Republican Central Committee reviewing the governor's notes by selecting attorneys from the county applications and nominations. A small committee will be assembled to accept and review application submissions. putting forth their recommendations to the committee. Up to three submissions will be approved and forwarded to the Governor's Office to make the final decisions and appointment.

Michael Wehrkamp will continue to be on the ballot unopposed for this election cycle while the process is being handled. The timeline is not set, but could take several months or more for a replacement to be appointed.

According to Jerry Zielke, Republican Chairman, stated they have begun the process and are working with the state to make this as quick and transparent as possible while filling the vacancy with the most qualified person available. If you are qualified and would like to be nominated for this position, contact Zielke at 260-312-2081 for an appointment.

MILITARY HISTORY IN PAULDING COUNTY

The story of Moses Edward Kerns (alias Edward D. Kerns) has a strange twist and not sure why. Moses was born May 15, 1875 in Indiana. The son of Mathew Allison and Margaret (Grosscross) Kerns. Mathew and Margaret were married February 26, 1868 in Ft. Wayne, Indiana. Mathew was born in 1844, Margaret was born in 1850. Mathew was a Civil War Veteran serving with Company A. 66th Ohio Volunteer Infantry. By 1880, the Kerns family, Mathew, Margaret and four children, had moved to Antwerp. Mathew was a laborer. By 1898, as war was looming with Spain, citizens from Paulding wanted to form a Company of men to serve in the Spanish American War. Company M. 2nd Ohio Volunteer Infantry was formed in Paulding. At the age of 23, Moses Edward Kerns enlisted with Company M. and was mustered into service, May 10, 1898. While the Company was in Georgia, Moses became ill on numerous occasions. He, along with the rest of the Company was mustered out of service, February 10, 1899. On September 18, 1899, Moses married a gal named Sarah Elizabeth Barnhart, also will be known as Lizzie. She

was born April 4, 1880 in Michigan. She was the daughter of George and Margaret (Flickinger) Barnhart. By 1900, the couple were living in Antwerp. Moses was working as a laborer. His illness had prompted him to file for a pension, October 23, 1900. A daughter, Luella Elizabeth, was born January 5, 1903. On March 23, 1908, a son Moses Edward Kerns Jr. was born. On August 28, 1909, Moses Sr. passed away in Antwerp. He was buried in Maumee Cemetery, Antwerp. Old Section, Lot 107, Grave 2. On September 25, 1909, Sarah filed for widows pension. The word, (alias) appears on the pension form. Apparently, Moses went under the name Edward. His military tombstone reads Edward Kerns. By 1910, Sarah, Louella and little Eddie, (as he was called), was living on Perry Street in Antwerp. Sarah worked as a day laborer. Sarah passed away June 22, 1912. She was buried in Maumee Cemetery. Edward's father, Mathew, passed away, in 1914. He was buried in Maumee Cemetery. By 1920, Louella and Edward Jr. moved to River Street to live with their grandmother, Margaret Barnhart. Margaret passed away in 1929. Louella married and had children and lived in the Antwerp area. She passed away in 1980. She and her husband both are buried in Maumee Cemetery. Moses Edward Kerns Jr. registered for World War Two draft. He signed his name as Edward M. Kerns! He was not selected to serve, moved to the state of Oregon. Lived out his days until he died, August 15, 1978. He is buried in Oregon. A poor person doing research to locate someone, has a hair pulling nightmare when folks do not use their true first name.

chances he or she will show up for their court date.

Ohio's Attorney General, Dave Yost, said, "Ohioans will now decide if the safety of the public should be considered by judges when determining the monetary amount of bail. I expect many Ohioans will be shocked to learn that judges are not currently permitted to consider the threat an offender poses to a community when setting financial conditions of bail."

It is ridiculous to think we need a constitutional amendment to clarify the obvious. It should be a no-brainer. Vote yes on Issue 1.

I also believe a yes vote on Issue 2 is a no-brainer. Issue 2 would require that only a citizen of the United States, who is at least 18 years old and has been a registered voter in the state for at least 30 days be eligible to vote in any state or local election in Ohio.

The amendment also prohibits local governments from allowing a person to vote in local elections if they are not legally qualified to vote in state elections.

The amendment changes the language in the Ohio Constitution from "Every citizen of the United States is entitled to vote at all elections" to "Only a citizen of the United States is entitled to vote".

Secretary of State, Frank LaRose, who endorses a yes vote on Issue 2 said, "The right to vote is sacrosanct and fundamental to what citizenship means in America.'

This amendment will close a weakness in Ohio election administration and provide clarity.

Please vote yes on Issue 1 and 2.

on their first possession of the second half when quarterback Owen Berner scored on a four-yard run capping off a four-play drive and a Pilot lead 20-14 with 9:54 remaining in the third.

With the quick Pilot score the Raiders didn't flinch - using a 59-yard scoring drive of their own that would not only produce a touchdown but an extra point that would put the Raiders on top to stay 21-20 with 7:31 showing on the clock. The go-ahead touchdown came on the efforts of Dylan Hildebrand who teamed up with junior QB Kyle Stoller for an eight-yard strike.

Following an Ayersville drive that stalled the Raiders took advantage from their own 42-yard line. Using a mix of rushing and passing plays Stoller guided his troops down the field.
