#### **MILITARY HISTORY IN** PAULDING COUNTY



Irl Vernon Dindot was a young man born July 21, 1893 in Delphos, Ohio. The son of John Jenkins Dindot, born December 2, 1853 in Lancaster, Pennsylvania and Laura (Bayman) Dindot born in 1856. This couple married in

By 1900, the Dindot family, John, Laura and ten children, Irl being the seventh child, were living in Delphos, Ohio. John was a painter. Irl was a school age child. By 1910 the Dindot family, John, Laura and six children, were living in Latty, Ohio. Irl was a farm laborer working on the family farm.

In 1912, Irl joined the Navy. He served four years and made his home in Grover Hill, Ohio. On June 2, 1917, at the East Latty precinct, Irl registered for the draft. Living in Grover Hill, he was a seasonal farmer working for a fella named George E. Starr in Grass Lake, Michigan. Irl was listed as medium height and build, hazel eyes and dark brown hair.

On December 15, 1917, Irl was stationed at Cincinnati, Ohio with the United Staes Navy Reserve Forces. On being called to active duty, December 31, 1917, lrl will be as-

phia. He served with this ship until January 12, 1918. Then sent to serve on the ship, U.S.S. Conestoga and served until November 11, 1918. He was at sea for 331 days. Released from active duty, October 31, 1919. He also served at the Naval Demobilization Station in Pittsburgh, Pennsylvania. Irl was honorably discharged, January 5, 1922. By 1923, Irl had moved back home to Latty, Ohio to

live with his parents and two

brothers. That all changed as

he met a gal named Addle Mae Yoh. The couple was married May 19, 1923 in Van Wert, Ohio by the Rev. Ira Steele, with judge Charles E. Lawhead looking on. The happy couple moved to Washington Township. On January 7, 1925, Irl's father John passed away. He was buried in Middle Creek

Cemetery. By 1930, Irl and

Addie were living in Washing-

ton Township. Addie's mom Alice moved in with them. On February 11, 1933, a son, James Vernon Dindot was born. In 1938, Irl's mother, Laura, passed away and buried in Middle Creek Cemetery. Hard work and bad health caused Irl Vernon Dindot to pass away in Paulding, August 25, 1939. He too, was laid to rest in Middle Creek Cemetery. Addie never remarried and passed away in Columbus, Ohio, December 19, 1972. She was buried with her sailor in Middle Creek. As for their son, James, he graduated from Grover Hill High

from Ohio State University. He joined the National Guard where he attained the rank of Captain. He passed away March 22, 1987 in Conroe, Texas. He was never mar-



This includes the offices of the Mayor, the Clerk-Treasurer, and the five Council seats. The last general election was never held as a cost savings measure due to only unopposed seats. The general election will take place in November of 2023. If more than one candidate for a given office file under the same party, a primary election will take place in May of 2023, which may or may not occur based on candidates who chose to file.

And secondly, to inform residents in the community what this process looks like if they wish to run for office. For any resident within the city limits who feels that they can provide meaningful contribution at the local level to direct and manage community affairs, I would encourage you to consider running for public office. Interested persons should contact the Allen County Election Board for additional guidance. You will need to start this process very early into 2023 to be installed at the start of 2024.

#### FARMING

Like many folks my age I grew up on a farm. Like many folks my age I left the farm. I loved the farm, still do, my dad loved the farm and he was a prosperous farmer. I always felt I had an ideal childhood. The farm was a lot of hard work but it was enjoyable. You enjoyed the distinction of not being a "city kid.' I lived just a couple of miles from Leo, and had cousins my age in Leo. I was a farm boy and they were city boys. They played Little League Baseball and I worked. I did play high school baseball which made up for some of it.

I had asthma from a young age, and it was pretty much decided that I wouldn't be able to farm. As I look back with modern equipment it would not have been that difficult. I took allergy shots from a Fort Wayne doctor at age 12, and it age 16 the asthma just seemed to disappear, and hasn't bothered me as an adult. Those of you that don't know me I am a seasoned citizen, in fact quite well seasoned. Old age is a pain but in some ways it is enjovable. I guess we just have more to remember.

My dad went to Barr Street Market every Saturday and on an egg route every Friday, had a full contingent of chores, and farmed 300 acres, which was a lot in those days. He went to Barr Street Market for years, until the city in their in-

finite wisdom tore the beautiful two block long structure down. Then he went to South Side Market for the rest of his life. The kicker was that the Barr Street property had been given to the city to be used as a farmers market for perpetuity. So much for perpetuity.

I remember picking apples where the Hicksville school stands now. We also picked apples in an orchard just north of Farmer, Ohio, on route 2. My mother fell out of a tree in that orchard and broke her neck, and suffered the remainder of her life from that fall. I remember selling mini pickup loads of apples, and selling many gallons of cider. Still like cider, fresh out of the squeezer.

One of the things that has concerned me my entire life is the amount of good farmland that has been used for commercial purposes. A 1000 acre Amazon warehouse here, a new school there, and the constant succession of new additions. In Grabill we had 100 houses "planted" on a hundred acre Farm because the owner didn't like the people that make up the majority

Years ago, my daughter played Wayne State in Detroit in basketball. I'll never forget the block after block of bombed out factories and buildings. I have also traveled to Central Fort Wayne, and have watched South side Market since a youth. Could some of these blocks have been cleared, for a factory, school, or gated neighborhood?

I guess we are all somewhere overwhelmed by the change in cell phones, self driving cars, or you name it. I guess it'll be a while, before us old duffers see the return of the single class basketball tournament in Indiana, or even one day voting.

#### \$3.6 MILLION COMING **BACK TO AREA CO-OP MEMBERS OVER THE HOLIDAYS VIA CAPITAL** CREDITS

If you are a member of a co-op, make sure to check your electric bill this month! Member-owners of Pauldingbased Paulding Putnam Electric Cooperative (PPEC), Bryan-based North Western Electric Cooperative (NWEC), and Malinta-based Tricounty Rural Electric Cooperative (Tricounty) will see a lower electric bill around the holidays due to capital credits retirements. This month, PPEC is returning \$2.5 million, NWEC is returning \$611,249, and Tricounty is returning \$584,000 to current and former member-owners.

Current eligible co-op member-owners will receive the refund as a credit on their electric bill; former members who have moved off the coop's lines will receive a separate check this month. These capital credits represent the cooperative's margins, or money left over after all expenses have been paid.

As not-for-profit community-focused organizations, co-ops use these margins for investments, such as building or replacing power lines, transformers, and other electric system upgrades to meet member-owners' evolving needs. This helps keep the coop's service reliable.

"PPEC members contribute a portion of the capital necessary to grow the co-op and upgrade electric reliability," stated PPEC President and CEO George Carter. "Eventually, as the co-op is financially able to do so, the board approves the capital be returned, or 'retired' back to those members who contrib-

uted it originally." Capital credits represent each co-op member's owner-

ship — or equity — in his or her cooperative. This member-owned business model is what sets electric co-ops apart from municipals or investorowned utilities.

"Every member gets a piece of the co-op equity pie, so to speak," said Tricounty CEO Brett Perkins. "That's the co-op way, and it's one of the big perks of membership. That's why it's important to keep your contact information and address up to date with us, even after you move off our lines." "We return the money to

member-owners around the holidays because that's when many people need it the most - especially this year with the current economy and challenges," said NWEC President/CEO Darin Thorp.
