Translators get shot too

When was the last time you have been put in a social situation where you felt very uncomfortable? I feel like I get caught in a lot of these situations as I live between the USA and overseas.

When overseas, our American visitors love to engage with the locals and ask questions. Often questions that seem innocent and harmless to us Americans are very offensive in other places around the globe. I learned quickly, as a person put in the middle of these situations as translator, to reword or change the question, and often the answer they receive in return. I call it "flexible translating" to keep the intended good will between everyone and avoid what could become a very tense situation.

There are times I won't translate things. It isn't unusual for American visitors to ask me to translate graffiti they see on city walls.


Though the graffiti is often non-offensive, there can be some graphic stuff too, and it stays untranslated.

As I write, I am back in the States for a short time and realized that translation comes with its risks here in America too. At a continuing education course, a frustrated man came in this morning. He spoke no English and would try to communicate through "Google translate" on his phone. Conversing wasn't working between him and the school administrators. Without thinking and to the administrators' relief, I started translating for them.

However, this was when the problems began. When it was unclear what each was saying to the other, they seemed pretty civil, but once I the translator stepped in and the communication became clear, the temperatures rose. The man ironically, gradually shifted his mounting frustration and intensity at me and not the administrators. In his anger, he couldn't separate the message from the translator. I tried unsuccessfully to extract myself from the conversion that ended with the man stomping out the lobby door as he angrily glared at me - not the school administrators.

Yes, the messenger often gets shot, but there are a lot of translators who come away with just as many bullet wounds.

Paulding County's participation in the Civil War was more that the general public is aware of. Paulding County had the highest percentage of men serve than any county in the State of Ohio. In late 1864, a recruiting officer came to Charloe to recruit men for the war effort, he found three males, an older gentleman, a crippled veteran, and a young boy.



The first company to be organized in the county under a three years' call was Company F. 38th Ohio Volunteer Infantry. Organized in the summer of 1861, mustered out of service July 12, 1865. Company G. 14th Ohio Volunteer Infantry was home only about two weeks from its three months service when it began organizing for a three year term of service. Organizing August 26, 1861, this Company was mustered out of service, July 11, 1865. Company C. and D. 68th Ohio Volunteer Infantry was formed and organized November 25, 1861 and they trained at Camp Latty in Napoleon, Ohio. My Great-Great Grandfather served with Company D. Company I. 100th Ohio Volunteer Infantry that was raised in Antwerp, Ohio in August of 1862. This company was mustered out of service July 1, 1865. Paulding County furnished two companys to serve 100 days. Company A. and H. 132nd Ohio Volunteer Infantry was mustered into service May 2, 1864 and mustered out of service, September 10, 1864. My Great-Great grandfather's two brothers with served Company H.132nd Ohio Volunteer Infantry.





"Oh give me some Mountain Music.". It was Ezra's fault. If anyone was to blame it was Ezra. If it weren't for him this might not have happened. Of course Ezra might have had some help from Maybelle.

Ezra had a slight tremmer in his hands, and was the laughing stock of his classmates. He was the laughing stock of Clinch Mountain, for vou see Clinch Mountain is not a mountain. It is a mountain range inside the Appalachian Mountains. It from Virginia, stretches through Kentucky and into Tennessee.

When Ezra was out of school, he found a job . . . selling fruit trees. A regular Johnny Appleseed. One day he crossed the mountain, selling trees, he came upon a house where a young girl was on the porch playing a guitar and singing. They say it takes 3 seconds to fall in love, but

not this time. Soon Ezra was making trips over Clinch Mountain, but he wasn't al-

ways selling fruit trees. The young man was Ezra Carter, the young lady Maybelle Addington. She and their daughters, Helen, June, and Anita would be one of the first popular Bluegrass Music groups. They would be the first inductees to the Grand Ole Opry Hall of Fame. They got their start when they won a contest held by Victor records.

Records and radios were just beginning to be popular. Now the average household could hear the music which they enjoyed, right in their own home. The Carters sang songs like, "Wildwood Flower.

The Bluegrass story was told in the movie, "Oh Brother Where Art Thou." It began when George Clooney and his men stopped at a remote recording studio in the country, and burst in, "We hear you pay good money for singing into a can." "I ammm ... a man ... of constant sorrow. I've had trouble all my days.

Bluegrass music began in England and came over on the Mayflower. It originated in Scotland, Ireland, and England and came over with the settlers. The setters began moving south, including some of the group from Plymouth Rock. They settled in Carolina, Kentucky, and Tennessee. They took their name from the Bluegrass State. They sang songs of a rugged life, tragedy, and religion, and of course the woes of unrequited love.

June Carter became famous in her own right, when she toured 3 years with Elvis. Elvis was a big fan of Johnny Cash, and when they would go into a restaurant he would play his songs on the jukebox. Elvis would try to sing like Johnny Cash. He would tell June that someday she must meet Johnny. She would catch Elvis on his knees in the bus tuning his guitar to, "Cry, Cry, Cry." Elvis and Johnny were both signed to Sun Records.

Of course the day came when June and Johnny did meet. He told her, "l always wanted to meet you." She said, "I feel like I already know you." It would be 9 years before they married, as they were both married to someone else when they met. They had one child together, Johnny Jr.

Now I am not what you would call a fan of bluegrass music. I like all kinds of music that is good. I like songs that tell a story, in just a few sentences. Check out the Revolutionary War song; "Sweet lips The rifle, The Battle of Kings Mountain." By Grandpa Jones. This morning I just happened to catch a song by The Carter family, which conveys a message;

"You must walk that lonesome highway Nobody else can do it for

Central Ohio – Wildlife District One

In November 2022, State Wildlife Officer Adam Smith, assigned to Logan County, received a call regarding three white-tailed deer found dead near downed power lines. Officer Smith found a 15-point buck, 8-point buck, and doe in the ditch beneath the power lines. After the scene was safe, the deer were examined, and it was determined that they died from electrocution. The Richland Township Fire Department plans to display mounts of the antlered deer at the fire station as a reminder of the dangers of downed power lines. The venison from the three deer was salvaged and given to a local resident.

State Wildlife Officers Chad Grote and Antoinette Freet, assigned to Marion and Licking counties, respectively, contacted a group of campers at Delaware Wildlife Area. One member of the group provided a false identity to the officers. It was later discovered that the individual had felony arrest warrants from several counties. The officers arrested the individual and took them to

During the 2022 whitetailed deer archery hunting season, State Wildlife Officers Michael Budd and Scott Cartwright, assigned to Tuscarawas and Carroll counties, respectively, received a hunting without permission complaint. The officers located a hunter on the property and issued a summons for hunting without permission. The individual was found guilty in Carroll County Municipal Court, sentenced to 30 days in jail, and ordered to pay \$245.

In November 2022, State Wildlife Officer Tom Frank, Mahoning assigned to County, received a call from a frustrated hunter who reported hunter harassment. Officer Frank presented the case to the county prosecutor, who approved charges for hunter harassment. The suspect was issued a summons and ordered to pay \$171 in fines and court costs. During the 2023 whitetailed deer muzzleloader season, hunting State Wildlife Officer Darin Abbott, assigned to Lawrence County, received a complaint about shooting from the road. Officer Abbott determined that one individual was responsible for the complaints. Summonses for hunting with the aid of a motor vehicle and shooting from a public roadway were issued. Charges are pending in Lawrence County.

Southwest Ohio Wildlife District Five

State Wildlife Officer Supervisor Matt Hoehn received information that goose and duck carcasses were dumped in and next to the Miami and Erie Canal. State Wildlife Officer Mark Schemmel, assigned to Auglaize County, and State Wildlife Officer Brad Buening, assigned to Mercer County, located a suspect and determined he was responsible for the illegal dumping. He was issued a summons with a \$400 bond.

State Wildlife Officer Matt Bourne, assigned to Clark County, and State Wildlife Officer Mark Schemmel, assigned Auglaize County, recently worked a booth at the National Fishing Expo in Cincinnati with fish management staff Deb Walters, Mike Porto, and Kelsea Downs. They provided information to the public and promoted the 32nd Wildlife Officer Training Academy.

The Caring & Sharing Food Pantry board reports that they served more people in 2022 than in 2021. This past year, the pantry served an average of 145 households and 345 individuals per month in Paulding County. That is an increase of 65% over the total number of households served in 2021 and a 40% increase of in the number of households served in 2019, before the COVID 19 pandemic.


Eligible people can visit the pantry two times per month and receive three days of food during each visit. So based on the average number of people served, Caring & Sharing provided 12,426 days of food to their neighbors. Of those individuals served in 2022, 20% were children age 17 and younger, and 34% were seniors over age 60.

The mission of the pantry is to eliminate food insecurity in Paulding County by providing food and basic personal care items to those who qualify. Based on 2020 Feeding America data, 12 percent of our county population experiences food insecurity, which is defined as "the consistent lack of food to have a healthy life due to economic circumstances."

The pantry is currently located at 119 South Main Street in Paulding. It operates based on donations of groceries and funds from individuals, churches, organizations and businesses, as well as through the support of Feeding America and the West Ohio Food Bank. The pantry accepts donations of food and groceries when it is open on Wednesdays and Saturdays, 9 a.m. to noon. Financial donations can be sent to P.O. Box 391, Paulding, OH 45879.

Caring & Sharing Food Pantry is also raising money to construct a new 3,900square-foot structure at 318 N. Walnut Street in Paulding. By the end of January 2023, the community has contributed more than 85% of the initial goal of \$525,000. Building Fund donations can be sent in care of the Paulding County Area Foundation at 101 E. Perry Paulding, Street, Ohio 45879.
