## **HERITAGE LIONS 25B PROJECT LINUS**



Deb Heath, Northeast Indiana Chapter Coordinator for Project Linus, gave a very interesting talk before the Heritage Lions last night. She explained how her non-profit group supplies blankets to hospitals, surgical centers, crisis centers, sleep clinics, the foster care program, and for Adoption Day at the Allen County Courthouse every November. Volunteers all over our area contribute new, handmade, washable, and kid-friendly blankets for this effort. Project Linus volunteers inspect each blanket to insure they are free from smoke, chemical odors or pet hair to prevent harm to the child who is given the blanket.


From the Project Linus website (project linus.org), their mission is to "Provide love, a sense of security, warmth and comfort to children who are seriously ill, traumatized, or otherwise in need through the gifts of new handmade blankets and and afghans, lovingly created by volunteer "blanketeers."

Ms. Heath told how the children, and their new siblings, are allowed to choose their own blankets during the annual Adoption Day at the Allen County Courthouse. Each year some 100-135 blankets are given to the adoptees.

At the Grabill Food Bank during Christmas, a blanket is included in each box of food for the children. Parkview Hospital's Pediatric Care section is another frequent recipient of these blankets. And hospitals in Auburn, Huntington and Angola have received blankets for their young patients.

Last year over 2200 Project Linus blankets were distributed throughout our area, and already over 330 have been placed so far this year. Since the local chapter's beginning, some 56,000 blankets have helped comfort children in Northern Indiana. Nationwide the 275+ Project Linus chapters have distributed over nine million blankets in the past 20 years. Drop off bins for new blankets are located at JOANN Fabric and Craft on Coldwater Road, Edwards Sewing Center on Rothman Road, and the New Haven City Hall.

After her talk, the Heritage Lions voted to donate \$200 to Project Linus to help them gather and distribute these blankets for children needing comfort and love. The Heritage Lions motto is "We Serve" and we welcome anyone who wishes to help their local community to contact a Heritage Lion.



## JUST ONE TOMATO PLEASE

There is just not anything better tasting than a big red tomato and bread and butter sandwich. If there is anything I look forward to in summers garden, it is toma-

I have never been a gar-



dener or had a so called green thumb. My grandma could grow big juicy tomatoes and Kentucky Wonder Beans which were about 6 inches long. Many an afternoon was spent sitting on the porch and snapping those beans. After our work was done, we would be treated to a big glass of grandmas sweet iced tea.

A few weeks ago I acquired a small wooden wheelbarrow. My friend, Denny tightened it up and I had to make the decision of where to put it. #### **MILITARY HISTORY IN** PAULDING COUNTY

"As the World Turns", the story of Andrew Carle Jackson

(Part 1)

This was supposed to be a simple article about a man who served in the Civil War. After going down numerous rabbit holes, which turned into uncovering mines, I believe that I have uncovered a very serious oversite. So here it goes.

Andrew Carle Jackson was born October 14, 1842 in Crane, Warren County, Ohio. The son of Benjamin Basil, born February 21, 1821 and Elizabeth Jane "Lizzie" (Champion) Jackson, born in 1823. Eleven children were born with this union, so I am unclear as to what numerical order where Andrew fell. By 1850, the Jackson couple along with daughter Martha and son Andrew were living in Crane Township in Paulding County. Benjamin was a farmer and Andrew helped on the farm. By 1860, the Jackson cou-

provide troops became the calling card for men to enlist. On August 26, 1861, Benjamin and Andrew both answered the call to serve with Company G. 14th Ohio Volunteer Infantry. The 14th Regiment trained in Toledo and was shipped off to war. Benjamin was a private and Andrew was a musician.

On December 15, 1863, Benjamin was promoted to Sergeant. As a father/son duo, they survived fourteen major battles. On May 1, 1865, Andrew was promoted to Principal Musician. On July 11, 1865, both Benjamin and Andrew mustered out of service.

By 1870, Andrew was living in Paulding, working as a printer for a local printing company. He met a gal named, Lucy A. Brown, born October 21, 1847, Marysville, Union County, Ohio. On February 5, 1870, they married in Paulding. On November 19, 1871, a son Jesse Benjamin Jackson was born. Another son, Coe Griffin Jackson was born January 2, 1875. Both were born in Paulding.

By 1880, Andrew, Lucy and the boys were living on Perry Street in Paulding. Andrew still worked as a printer. 1890, nothing had By changed, but the boys were off to college. By 1898, as America was being drawn into war with Spain, Paulding was trying to form a company of men to serve representing Paulding County. Andrew's sons, Jesse and Coe, enlisted in Company M. 2nd Ohio Volunteer Infantry, Spanish American War. They followed the military path of their father and grandfather.

Stay tuned for the remaining story of Andrew's path in *life, it will get very interesting.*

#### LATTA LEADS HOUSE **EFFORT TO INCREASE U.S. NUCLEAR FUEL SECURITY**

WASHINGTON, DC - Today, Congressman Bob Latta (R-OH5) introduced the bicameral Nuclear Fuel Security Act to establish and expand critical U.S. nuclear fuel programs to boost domestic uranium mining, production, enrichment, and conversion capacity.

Latta's bill is the House companion to legislation introduced in the Senate earlier this week by Senators Joe Manchin (D-WV), John Barrasso (R-WY), and Jim Risch

"After leading the world for decades in the development of nuclear energy, the United States has fallen behind its allies and rivals and has seen its competitive edge dimin-

ish," Latta said. "This lack of investment has forced the U.S. to import 90 percent of the uranium fuel used in our nuclear reactors from foreign countries. Overreliance on other nations for nuclear fuel is a threat to our national security and our energy independence. To avoid threats to our nuclear supply chain, we must build up our domestic uranium mining, production, enrichment and conversion, and support nuclear innovation right here at home. The Nuclear Fuel Security Act will set us on the right path to strengthen our nuclear energy capabilities, lower carbon emissions, create new job, spur economic growth, and provide for a safer America."

"It's time for America to ramp up uranium production so we can eliminate our dependence on Russia," Barrasso said. "We are stronger and safer as a nation when our nuclear fuel supply chain starts at home. Our bipartisan legislation will strengthen American energy security. It will ensure our existing reactors and advanced reactors - like TerraPower's Natrium reactor have access to American uranium."

Background on the Nuclear Fuel Security Act:

This legislation would authorize the Secretary of Energy to:

• establish the Nuclear Fuel Security Program to increase the quantity of low-enriched uranium (LEU) and high-assay, low-enriched uranium (HALEU) produced by U.S. nuclear energy companies,

• expand the American Assured Fuel Supply Program to ensure the availability of domestically produced, converted, and enriched uranium in the event of a supply disruption, and

• establish the HALEU for Advanced Nuclear Reactor Demonstration Projects Program to maximize the potential for DOE to meet the needs and schedules of advanced nuclear reactor developers until such time that commercial enrichment and deconversion capability for HALEU exists in the U.S. at a scale sufficient to meet future needs and, where practicable, partner with countries that are allies or partners of the U.S. to meet those needs and schedules until that time.





Great Lakes Traditional Sprints will have a solid presence in NW Ohio in 2023, with 8 non wing races between Fremont, Waynesfield and Limaland! Those races added to the 9 races in Southern Michigan at Butler, Harford and I-96 Speedways will give Ohio and Indiana teams more choices and a solid slate of closer races. The other bonus is the increased GLTS purse at these races to \$9.295, which will pay \$1,500 to win, \$1,000 for 2nd and \$750 for 3rd. We're looking forward to some great non wing racing in the tri-state region!

The blending of Great Lakes Super Sprints and the NRA Sprint Invaders is still a work in progress! Having 39, 360 Winged races in Ohio and Michigan gives full sized wing sprints a significant schedule and be able to stay closer to home. The Ohio races will fall into the South Region and the Michigan races will fall into the North Region, giving us 2 Regional Champions. The team that finishes the highest in combined points of both Regions will be crowned the overall Great Lakes Super Sprints Champion for 2023.

At the monthly Racing Promotion Workshop in Daytona, Rex LeJeune of Attica Raceway Park was selected the 47th Annual Auto Racing Promoter of the Year for Region 3. Locally everyone agrees Rex is very deserving of this award after years of dedication to Attica Raceway Park.

The defending Little 500 winner Tyler Roahrig could make history this spring in the sprint car classic at Anderson Speedway (asphalt track). 


The visiting Archers scored just enough in the final period, bucketing seven markers compared to the Blue Jays' dozen as Antwerp held on for the 43-41 victory.

often wanted to make a list of all the wars that have taken place, but it probably would be impossible. It might even be an infinite list because there would be no end. Looking at history there are several wars that lasted hundreds of years, and there were some that were short. Two Nations that had had an open border, were suddenly at War. The cause of the war was an athletic event, a football game. (Soccer.) A disputed score in a soccer game. Just a game.

The thing that wears on you is that you don't know how long the war is going to last. We know that war finally ends, we just don't know when. 


