When searching for God's will, how do we know we are not leaning toward our own

All of us have a natural bent toward seeking our own will and we need to take proper precautions. Let me give you a three-way check for the guidelines for God's will.

1. PROPER ATTITUDE the proper attitude is being unbiased toward the outcome.

That is tough but necessary. In Luke 22:42 Jesus prayed, "...nevertheless not my will, but thine, be done." The two things that can help us pray that prayer and mean it are the character and the wisdom of God. God is good (Psalm 25:8), and will work things out to our good (Romans 8:28). production equipment and office space established, we met with their team and toured the facility. The enhancements and improvements they have made put new life into the building. We are now working with the Patriot Lines railroad team, and other area economic development directors, to see if there is opportunity to fill the remaining open warehouse space and the potential to grow the facility down the road." stated Copsey.

According to plant manager, Douglas Soper, the facil-



ity that was formerly located in an 80,000 square foot location of the Spangler Candy factory had a lease that was set to expire and not able to renew with business's anticipated growth. The developing company had to look elsewhere. Soper searched all over Northwest Ohio and soon was drawn to the Antwerp area because of the size of the 2004 shuttered Dana plant being offered by Mark Greenwood of North American Reel Company.

Since the deal was made, ALG Health worked overtime to build inventory before they moved; being down for a couple of months while moving heavy equipment could be detrimental for any business if there is no product to ship.

The COVID pandemic provided an opportunity for the business owner to make ALG a front runner in the PPE business, particularly in masks. They started to confront the mask shortages America in the early days of the COVID pandemic, and manufacturers were struggling to meet the increased demand. ALG began production quickly and increased capacity while at the same time meeting the demands set forth by federal and state governments. There are a variety of

masks that are being produced right here in Northwest Ohio, including the Patriot respirator masks and the Patriot foldable masks. Each mask including respirators, have their purpose what they are best suited for. ALG Health serves the healthcare industry from nursing care and assisted living to hospitals and schools. They can negotiate contracts for Group Purchasing Organizations and state departments of health. Their products are entirely manufactured in Ohio from globally sourced materials.

Mr. Soper stated they have nationwide sales with their largest buyers on the east and west coasts. Last year they sold over 21,000,000 pieces. Even with the 2 month shutdown for moving, the company is on track to outpace last year's sales. When asked if they had more than one plant, the answer was, "no". They were intending to, but now they have the space to keep all of the manufacturing and distribution in one location, saving the hassle and expense of multiple locations and regulations.

ALG Health is looking to expand in more ways than just in their machines. They are in talks with the local rail line to add in a line to the building, which should be minimal cost as the line is currently very close to the facility.

Copsey praised the company saying, "ALG Health is yet another positive for Paulding County and the Antwerp community. By bringing a new business and employment opportunities into the county, and filling an empty space in an existing building, this is a win-win."





LAWN CARE FOR THE HOMEOWNER

Weed & Feed Products

Hopefully warmer weather is finally here to stay. The time has come to feed your lawn for the first time if you already haven't done that. You can also get rid of those pesky weeds at the same time. In this article, I'll give you some information about perennial weeds, picking a good weed & feed, and application tips to make your chosen product more effec-

Perennial weeds, such as dandelion, plantain and clover, are present in the lawn all year long. In winter, the plants may wither and disappear, but their root systems are still alive and well. These noxious roots are lurking beneath the surface of your lawn, and waiting for warm spring weather to reappear as eyesores in the lawn. When warm weather (finally) arrives, new leaves begin to grow, and begin their "crowding out" tactics to take over the lawn. Summer annual weeds, such as chickweed, oxalis, spurge and purslane also begin

Control of these pesky weeds is done by applying a post-emergent weed control. Unlike digging or pulling weeds, weed controls get rid of weeds from the roots to help ensure the weeds cannot grow back from root stubs that may be left in the soil. This is not accomplished overnight. Instead, the weeds slowly disappear over a period of a few weeks as the weed control kills the roots. Weed controls come in both liquid and granular form. Whether liquid or granular, the weed control needs to have an opportunity to adhere to the leaves of the plant in order to be effective because the ingredients enter the weed primarily through the surface of the leaves.

For those who prefer a non-granular, fertilizer free post-emergent control for spot treating small areas, liquid controls provide an ideal op-

tion. Some are water-proof in hours. The ready-to-use and concentrate versions are effective for treating a host of broadleaf weeds without harming the lawn. Because the weed control is already in a liquid form, it adheres to the plant and absorbs into the weed more quickly than the granular versions.

The granular forms of the weed controls are typically combined with a grass fertilizer to feed your lawn—hence the name weed & feed. All granular applications should be made on a damp lawn in order to help the weed control adhere to the weed plant. Application after a light rainfall or early morning dew is ideal. Additionally if it's possible, apply the granular weed & feed to a freshly cut lawn. If within 24 hours of mowing, it will help the granules of nutrients and weed control absorb in the fresh cuts on grass and weeds alike. After application, avoid foot traffic on the lawn and hope the weatherman was right in predicting no rainstorms from 24 to 48 hours. The heavy rain and foot traffic with the 24 to 48 hour window could dislodge the granules and make the weed control

less effective. The timing of post-emergent weed control application is important if the lawn is to get the maximum benefit from the product. As a general rule, the application should be made when the weeds are actively growing. Application for the most northern part of the U.S. is recommended in midto late-spring. For our area this means an application should be made sometime in late April or early May when air temperatures are between 60-90 degrees F. Another time for applying weed controls is in the early fall. From mid-September to early October, weeds are actively growing. Weeds are susceptible to the weed controls in the fall because they are naturally

translocating nutrients to their

roots in preparation for winter

dormancy.

MILITARY HISTORY IN PAULDING COUNTY

Cecil Maywood Billman was an Antwerp man who was born November 12, 1897 in Antwerp. The son of Elias Franklin, born May 18, 1868 in Indiana and Cora Burchard (Rumbaugh) Billman, born January 11, 1877 in Ohio. This couple was married, September 29, 1895 in Paulding,

By 1900, Cecil and Cora, along with daughter Madonna Gale, born in 1896 and son Cecil M. they were living in Carryall Township, Elias was a farmer. The family had grown with the addition of Alta 1900, Paul F. 1903, Forrest 1906 and Carl 1908.By 1910, the family was living in Antwerp on Payne Avenue, Elias was a wallpaper hanger.

In 1912, Melvin was born and Rex O. was born in 1916. On May 1, 1917, Cecil joined the National Guard out of Hicksville. He was listed as 5'7", 145 pounds, brown eyes, auburn hair dark and ruddy complexion. He was assigned to Company E. 2nd Ohio National Guard, serving until October 16, 1917. Then was called up to serve in Company L. 146th Infantry U.S. Army. He served with this unit until May 11, 1918. He was stationed overseas and served with 146th Infantry Headquarters.

He served in the Meuse-

Argonne and Ypres-Lys defensive sectors and was promoted to Private First Class, November 16, 1918. He departed from Brest, France March 18, 1919 on the ship, "Maui". Arriving in Hoboken, New Jersey, March 31, 1919. Cecil was Honorably Discharged April By 1920, Cecil was back

home, on Canal Street, living with his parents. He was working as a carpenter on a bridge crew. Cecil met a gal named, Thelma Gretchan Leaman. Born in 1908, the daughter of Harry and Mary Leaman. On December 4, 1926 the couple married in Paulding. By 1930, this couple was living at 224 East Canal Street in Antwerp and Cecil was working at the Antwerp furniture factory as an uphol-A son Max R. was born

April 21, 1929. Another son, Ray M. was born September 30, 1932. He was known as, "Pinky". By 1940, the world going to war. Cecil had to register for the World War Two draft. He did February 14, 1942, but at the age of 44, Cecil was not chosen.

Still working at the Antwerp Parlor Furniture Company Inc., Cecil became ill and was taken to the Veterans Administration Hospital in Dayton where he passed away February 9, 1950. He was buried in Maumee Ceme-

His wife Thelma applied for his Military tombstone, April 9, 1951. Cecil passed on the idea of service and his son, Max, served in the Army during the Korean War and Ray served during the Korean and Vietnam War's.

As for Pinky, I worked with him at Dietrich's in Hicksville in 1984, he was my shipping supervisor. What a guy, quite the joker and always pulling pranks! And I won a few quarter bets with him on weigh ups on loads!

Make sure to space out your feedings. You need a period of at least 6 to 8 weeks between feedings. Otherwise you maybe overfeeding your lawn causing you to mow your lawn more often. If you have broadleaf weeds coming up and you have recently fed your lawn, use a granular or liquid weed control that doesn't have fertilizer to get rid of those

The only times weed controls should not be used is on newly planted grass. Once that new grass has had time to

grow and be mowed at least four times (approximately 20+ days), then you can apply a weed control to the newly seeded area. If you've already applied weed control but need to overseed, it is best to wait one month after your last application. Whether liquid or granular, using a weed control will help ensure your lawn stays weed free in the warmer weather to come!

of them. I know today that most times I will eat meals on a TV tray and sit and watch television while I eat, but unless you were sick or dying, one was ex-

Dinner back then was a festive time with a lot of courses and many liquors, brandies and wine. Plus, you dressed for dinner. Now, remember this was clear back in 1837.



WOODBURN CITY-WIDE TRASH PICK UP

City-wide trash pickup will take place May 20th. Items should be set out May 19th for pickup to occur on May 20th. Take advantage of this semi-annual opportunity to get rid of your garbage!

Please note that electronics, tires, or refrigerators with coolant in them will not be picked up along with potential other items at Waste Management's discretion. Mattresses need to be wrapped in plastic. Typically there are out-of-town personal trucks picking up items a night before Waste Management, should you be inclined to place items at the curb early. Regardless, we ask that as a homeowner/ renter that you promptly retrieve anything remaining after pick-up.

As a friendly reminder from City Hall, please note that properties are expected to be maintained year-round so as to reflect well on our community. This includes but is not limited to: avoidance of debris collecting on property, mowing grass and eliminating weeds prior to your property becoming a nuisance, managing easements where applicable, etc.

We also ask that grass is not blown into the street and if it becomes necessary to do so, that the grass is retrieved after-the-fact, as this clutter can cover and impede storm drains from functioning properly.

There have been complaints about dog feces in

yards as well. The City asks that you clean up after your dog, especially in community spaces and/or other neighbors' yards.

The dumpster at the compost site is not a general use dumpster; it is for city use only. Do not put boat pieces, couches, construction debris, medical refuse or anything else into it. We have installed cameras at this site in an effort to deter this behavior. We appreciate you for doing your part to keep Woodburn looking great!

U.S. HOUSE APPROVES LATTA-BACKED EFFORT TO **HOLD CHINESE SOLAR COMPANIES ACCOUNTABLE** FOR CIRCUMVENTING U.S. TRADE LAWS

The U.S. House of Representatives approved a resolution backed by Congressman Bob Latta (R-OH5) to hold the Chinese Communist Party accountable for circumventing U.S. trade laws and to support American manufacturers and workers.

Latta joined U.S. Reps. Bill Posey (R-FL8), Dan Kildee (D-MI8), Garret Graves (R-LA6), Bill Pascrell (D-NJ9), Terri Sewell (D-AL7), Ro Khanna (D-CA17), Gregory Murphy (R-NC3), Christopher Deluzio (D-PA17), and Claudia Tenney (R-NY24) in introducing the resolution in March of 2023.

"America is a nation of laws, which means it's not within the president's power to pick and choose which laws to enforce even if those laws, go against their own personal political agenda," Latta said. "We must stand up to China's violations of our trade laws and I am proud to see Congress acting in a bipartisan fashion to send a message to President Biden that rushing a green agenda cannot supersede laws that protect American workers and businesses. Our bipartisan joint resolution seeks to roll back this administration's decision to exempt tariffs on solar panels manufactured in

THOUSANDS OF BICYCLE HELMETS GOING TO CHILDREN ACROSS OHIO



Awareness Month. Nearly 10,000 bicycle helmets will be going to children across Ohio this spring thanks to the Put A Lid On It! campaign, a continued partnership between the Ohio Department of Transportation and the American Academy of Pediatrics - Ohio

Partners from nearly 160 law enforcement agencies and community organizations, Safe Routes to School programs, and Safe Communities programs traveled to Columbus to pick up their allotment

Since 2018, nearly 2,000 kids under the age of 18 have been struck by a motor vehicle while biking in Ohio. More than 200 of these crashes resulted in either a life-altering injury or fatality.

Researchers found that nearly three-quarters of all bike-related fatalities would be prevented by a helmet.

"Wearing a helmet can reduce the risk of head injury by 85 percent and severe brain injury by 88 percent," said Ohio AAP CEO Melissa Wervey Arnold. "It's important that kids not only wear a helmet, but that the helmet is the right size and fitted properly."

It's the 13th year for the distribution and 8th year for the partnership between Ohio AAP and ODOT.

"We want to equip our most vulnerable road users who are learning how to ride with everything they might need to be able to continue riding in the future," said ODOT Active Transportation Manager Caitlin Harley.

Motorists should always:

- Slow down and drive at a safe speed Look for people biking
- when turning
 - Changes lanes to pass
 - Put the phone away!
 - In Ohio, bikes are vehicles

and people on bikes have the same roadway rights and responsibilities as other vehi-

Additionally, through ODOT's Safe Routes to School program, ODOT is supporting local governments and school districts with infrastructure enhancements that make it safer for kids to walk and bike to school.

"We know that providing and maintaining sidewalks and paths for kids to travel separated from traffic is critical for reducing conflicts and ultimately eliminating injury and fatalities," Harley said.



FIELD REPORTS FROM **OHIO DIVISION OF** WILDLIFE OFFICERS

Central Ohio - Wildlife

During the 2022 dove hunting season, State Wildlife Officer Josh Elster, assigned to Pickaway County, contacted an individual during a controlled hunt. Officer Elster checked the individual's hunting license and HIP certification and found that the individual did not have a valid controlled hunt permit. Officer Elster determined that the individual's shotgun did not have a plug and the subject was issued a summons for hunting doves with a gun capable of holding more than three shells.

State Wildlife Officers John Coffman and Jade Heizer, assigned to Fayette and Fairfield counties, respectively, investigated a possible white-tailed deer hunting violation. The suspect had purchased a deer permit after the recorded harvest time and game-checked the deer past noon on the day after the harvest. One misdemeanor summons was issued to the hunter for failing to complete the

game check process, and the

Northwest Ohio - Wildlife District Two

During the 2022 whitetailed deer hunting season, State Wildlife Officer Ryan Kennedy, assigned to Hardin County, received a complaint concerning hunting without permission. A landowner had obtained trail camera photographs of a subject hunting. Officer Kennedy determined the identity of the hunter and found that the suspect was hunting without permission and did not have a valid hunting license. The subject was issued two citations for the violations and received a \$350 fine in court. Recently, State Wildlife Of-

ficer Ryan Kennedy, assigned to Hardin County, has been receiving nuisance animal calls from homeowners. The most common issues involve groundhogs burrowing under foundations and porches, raccoons gaining access to attics and chimneys, and squirrels entering roof eaves. Early spring is a good time to inspect your home and other outbuildings for any access points where wildlife may enter. Additionally, the Ohio Division of Wildlife maintains a list of licensed nuisance trappers to assist homeowners in dealing with nuisance wildlife. Visit wildohio.gov to learn

Northeast Ohio - Wildlife District Three

State Wildlife Investigators Kevin Good and Matt Fisher, assigned to Lake Erie, patrolled off the shores of Ashtabula County. The investigators contacted a boat with two individuals fishing and found that neither individual possessed a valid fishing license. Both were issued a summons for unlawfully fishing in Ohio waters of Lake Erie without a valid resident Ohio fishing license. They were found guilty in Ashtabula Municipal Court and each paid \$155 in fines and court

In April, State Wildlife Officers Zach Hillman and Evan Huegel, assigned to Cuyahoga and Ashland counties, respectively, were on patrol at Killbuck Marsh Wildlife Area when they observed a vehicle that appeared to be disabled in a parking lot. The officers spoke with the driver and discovered she had a flat tire. The officers changed her tire and got her back on the road.

Southeast Ohio - Wildlife District Four

In December 2022, State Wildlife Officers Logan Ambrister, assigned to Belmont County, and Jeff Berry, assigned to Muskingum County, received information that people were waterfowl hunting without permission at Senecaville State Fish Hatchery. Both officers responded and contacted three individuals along Wills Creek. All three suspects were issued a summons for hunting without permission. A hooded merganser harvested by one suspect was seized as evidence. Each of the suspects paid \$200 in fines and court costs in Cambridge Municipal Court.

In November 2022, State Wildlife Officer Ted Witham, assigned to Jackson County, received information from a concerned citizen regarding someone spotlighting and shooting white-tailed deer from a vehicle. Officer Witham located the suspect and discovered he had spotlighted and shot at a deer from

Many well-meaning friends will try to console a grieving person with what they feel is good advice, such as: "Time will heal you" or "The first year is the worst" or "You are a strong person." These are usually spoken by friends who have not experienced what has happened to you.

Rose Kennedy, the mother of JFK, is quoted as saying: "It has been said, 'Time heals all wounds.' I do not agree. The wounds remain. In time the mind, protecting its sanity, covers them with scar tissue, and the pain lessens. But it is never gone." While the grieving person may seem to be "normal," missing the lost loved one remains under the surface.

Sometimes a grieving person will be living in a state of denial for months, not really connecting with events going on around him. It may be that only by the second year does the magnitude of the loss really become apparent.

A person who is otherwise thought to be emotionally strong may be inwardly crumbling. Putting up a false front does not shorten the grieving process.

When someone important in your life is taken away by death, your world changes completely. It is important to have understanding support from friends, family, and church at that time. The seminar/support group Grief-Share helps the grieving person understand his tangled emotions and gives hope for eventual healing. This group meets each Saturday morning from ten until noon in the library at the Leo Methodist Church and is open to the community. 

NSCC BOARD OF TRUSTEES APPROVES COLLEGE'S NEW STRATEGIC PLAN

The Northwest State Community College Board of Trustees met in regular session on Friday, April 28 held at Defiance College, Serrick Campus Center. As part of the meeting, the Board approved the College's new 2023-2026 Strategic Plan. The new Strategic Plan will take effect July 1, 2023, to coincide with the College's new academic and fiscal calendars.

STRATEGIC TAKES SHAPE

The College has been working to develop the new Strategic Plan over the past 18 months, holding both internal and external meetings with various stakeholders to discover, and in many cases, reaffirm how NSCC can continue to best serve the community going forward. The College conducted an environmental scan and community listening sessions were held in our sixcounty service area. Dotting sessions with NSCC faculty, staff, learners, and Board members were also done to

ensure all voices were heard.

Another item in the Board meeting was a presentation from Fanning Howey, an Architecture firm from Celina. Fanning Howey is the Architect the College is using to redesign the Archbold Campus 'B' wing, as well as the new Van Wert campus. Renderings were provided for Board consideration, and a good discussion ensued.

The participating 1st Responders and civilians, as the actors, simulated what could happen and how to respond in the event, something like this were to happen.
